



English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 





















Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.











Courses, Curriculum, Instruction:

The high school's courses are structured in a way to push the students to achieve at their highest individual levels. Our vast AP/Dual Enrollment course offerings present students with the opportunity to demonstrate their ability to succeed at the college level, and our elective offerings provide students instruction in a variety of high interest areas. We have developed a five-year curriculum plan to ensure that our offerings continually meet the ever-changing needs of the students. New courses for the 2022-2023 school year include Honors Ecology, which much of the time in this course is spent in the bog and near the dam on our campus. Students study the environment and this local ecosystem. We also added a STEAM Robotics course in the High School, which has a robust enrollment and a possible need for an additional Robotics course in the 23-24 school year. The High School media Center expanded its collection by over 1000 titles and is rebuilding curricular partnerships.

Before and After School Programs:

Both the JH and HS have extended learning opportunities to support the academic and social emotional needs of the students. These programs run from October until late June. We also offer Saturday school. These opportunities are open to all students. There is also opportunities for Mindfulness and Yoga. SBYS offers trips to students on weekends as well as after school activities that work to enhance social skills. SBYS also offer a 6 week summer program with a multitude of offerings to keep youth engaged.



Staff and Professional Learning:

We strive to put teachers in leadership roles in committees enabling them to have a true stake in the decision-making process and to put them in control of their professional development. The SciP committee sponsors various professional development opportunities including PLCs, Book clubs, Ed. Camps, and in-person and virtual trainings. This variety of opportunities allow the staff to share their expertise in a variety of areas with the other members of the district. We infuse professional development opportunities into our faculty meetings. SBMHS (5 year grant) has significantly expanded professional learning opportunities with primary focus on mental health and wellbeing. Offerings are made available to staff a minimum of two times per month.



Postsecondary Information:

All our 10th and 11th grade students take the PSAT during the school year, and we offer SAT prep classes through our Community School. Additionally, we offer the ASVAB and ACCUPLACER tests to provide our students multiple pathways upon graduation. 79 percent of our students continue their education at two or four year colleges, 10 percent of our students continue their educational pursuits through vocational training, and 3 percent of our students enter the military upon graduation. Our graduates from the Class of 2021 are furthering their education at colleges such as Albright University, Boston University, Drexel University, Massachusetts Institute of Technology, New York University, Stockton University and Villanova University.

Our department works closely with the Intervention Team as well as outside agencies to support our students and continues to meet state mandates and the many varied requirements of our special needs students. The Intervention Team integrates the Multi-Tiered Systems of Support into the school to ensure that all students are given the opportunity to be successful. The Twilight Program at Pinelands provides a supportive and flexible alternative for students to complete their academic requirements in a non-traditional setting.



Student Health and Wellness:

School Based Youth Services (SBYS) provides prevention, mental health and wellness programming and services such as parental engagement, prevention/awareness campaigns, evidence based programs, transition programs, employment/job readiness programs, leadership development, recreation/social skills, counseling, information and referrals. A Mental Health Specialist is available for student needs and assessments. SBYS also implements evidence based programs through health classes such as Cope2Thrive and Safe Dates. Strengthening Families, is a program that includes parents as well as youth. Programs/events/initiatives are infused throughout the school community through guest speakers, awareness campaigns and groups. SBMHS has established additional mental health supports for student wellness, and attention is also given to increase diversity, equity, inclusion and belonging by diversifying candidates providing mental health services.
