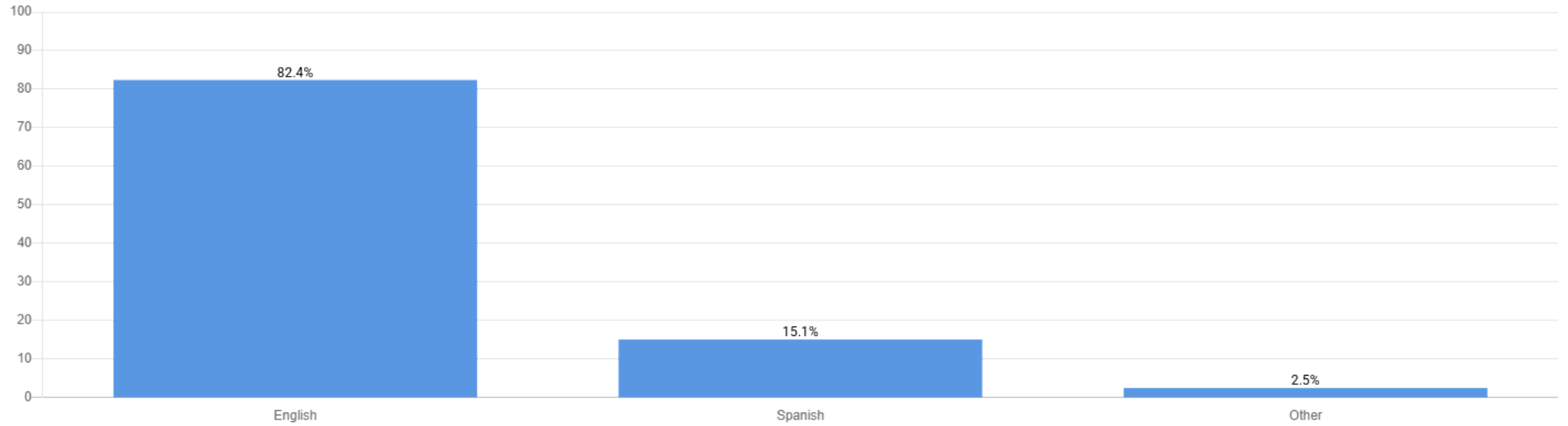

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 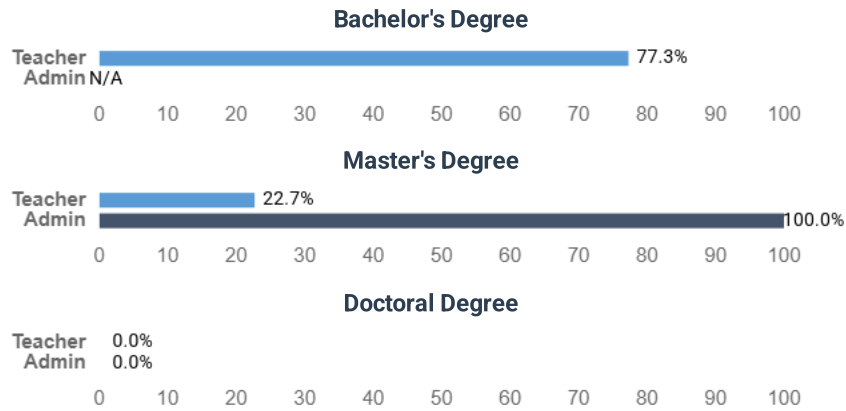

The motto for the Oxycocus Elementary School is "A Great Place to begin". The school houses the district's youngest students (3 and 4 year olds). During the 2023-2024 school year, there were nine general education classes and six special education self-contained classes that mainstream to the general education classes.

Early Childhood Education:

Oxycocus offers full day preschool, five days a week with the hours of 9:00am-3:40pm. 6 PSD classrooms that service our disabled preschool students. Additionally, there are nine PEA classrooms servicing 115 students and 20 ICS/PSD students. Additionally, the district contracts with 3 outside providers, housing 4 classrooms with a total of 60 PEA students. There was a waiting list of over 40 students throughout the school year.



Attendance:

Each month the class with the best overall attendance is recognized at the OXY. Their class picture is taken and posted on X as a way of promoting positive attendance habits districtwide. The school shares positive posters, sayings, and articles related to healthy attendance with families. Wellness checks are made by the school nurse as needed. Phone calls are made and letters sent to parents of students with chronic absenteeism.

Other Information:

The STSD is a choice district. Oxycocus Elementary houses the district's youngest students, 3 and 4 year olds. The district has 15 preschool classes. nine of the classes are for regular education students, with a combination of three and four year old students learning together. There are also six pre-school disabled classes that service our students with special needs. Having the regular education program within the district affords our pre-school disabled classes the opportunity to mainstream students in a peer appropriate environment. Building visitors were limited due to Covid protocols. Staff badges are used. Classrooms are equipped with Chromebook carts and projectors connected to the internet. iPad carts are available as needed. Flexible seating is available in the classrooms. For those children who qualify, they are offered speech therapy, occupational and physical therapy. A PIC, PIRS, school psychologist, learning consultant, and social worker support our school efforts to ensure success for all children. The Blackboard Connect System and the school webpage are used for parental communication. The Principal and district have Twitter and Instagram accounts for instant school highlights. Upon completion of preschool, age appropriate students transfer to the Primary Learning Center.
