









Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.







The New Jersey Department of Education collects data through the Student Safety Data System (SSDS). In addition to the data below, NJDOE is required, under ESSA, to report on the most recent, publicly-available Civil Rights Data Collection (CRDC) data, which can be found on the NJDOE School Performance webpage. Please note that prior to school year 2017-2018, the CRDC and the State collection system, EVVRS, did not collect the same data elements. 

The Raiders are ranked as the #3 in Ocean County according to US News and World Report and #1 in Toms River.

Building level administrators provide weekly professional development opportunities to all staff in our Jersey Mike's Professional Development Room that support our Vision/Mission. The Writing Center is offered to students seeking assistance in written assignments after school. It is staffed by our Advanced Placement senior English students with an English teacher advisor. Our AP students offer daily after school tutoring. Various clubs and organizations meet after school hours. Our Media Center is open daily after school for interested students.

Staff and Professional Learning:

All staff members participate in professional development at a minimum of twenty hours per year but many do much more. Staff members may attend local, regional or national conferences as well as participate in committees, workshops and panels both in and out of the district. Our district regularly plans PD days for staff members either full or half days during the school year. Teachers get together by department and class regularly to openly share ideas and best practices. TRHS East utilizes its Professional Development Room for staff to support collegial collaboration. Administration provides professional development opportunities twice a month centered on topics that administrators views during walkthroughs.



Of the 383 graduating seniors of the class of 2024, approximately 65% went on to post secondary education. We also had 8 students enter the military while others were moving into the workforce right away. We offer a Financial Aid night for parents, as well as a college information night, multiple college fairs and individual meetings with students. Our College and Career Connection Committee provides monthly career and college speakers to present students with various career and post-high school opportunities. Parents can access weekly newsletters, the school Instagram site, and school website for information.

Student Supports and Services:

Based on the needs of the individual student, programs range from mainstreamed to self-contained life skills. Students are able to combine program offerings to meet the least restrictive environment. HSE is a magnet school for many of the district's special needs students, some of whom participate in extended programs beyond the traditional senior year. Our non-classified students receive additional support through 504 plans, IR&S and the mentoring program. Additional help with assignments can be found in the media center after school with our National Honor Society student tutors. We also offer Basic Skills classes and for students performing low on standardized tests.



We participate in the Free/Reduced Federal Lunch program and free breakfast and lunch are offered daily. We have a comprehensive physical education program for all students with state of the art facilities. Our nurses do a screening of each student each year including height, weight and blood pressure. Hearing and vision screenings are offered every other year. As per state graduation requirements, every student is required to pass a physical education course each year consisting of gym class and health.



Parent and Community Involvement:

We encourage positive communication through orientation programs such as Visit the School Night, information sessions, and other focus groups. We have a PTO that meets monthly. A parent portal updated daily is available to check grades and progress reports. We also have a community outreach program that connects with local businesses to provide opportunities to our students including jobs and training. Through this program businesses have also provided funding for programs within the school. There are weekly Principal Newsletters sent out to inform parents of updates and student highlights. Parents are encourage to attend monthly Google Meets with the principal to bring up questions or concerns. HSEast prides itself on being approachable to parents and interested in fostering relationships to better support our students.

Is a Climate Survey Used: Yes; Who is surveyed: Students, Teachers. The school climate survey we use is provided by the district and data is collected yearly. The data from this survey is used by our administration team as well as our teacher, parent and student committees to gauge and improve the climate for the staff and students and to to drive professional development opportunities. Our student and staff surveys show strong growth each year as it relates to student-student, student-teacher, and teacher-administration relationships.



Our air conditioned building was originally constructed in 1979 and has been continuously updated. The school was awarded an EPA Energy Award when originally constructed. The media center contains 2 computers labs with 65 computers and we have two additional computer labs with 60 total computers. All students are given a chromebook to support their learning in school and at home. The school also has a technology lab, a Makerspace with multiple workstations and a 3D printer and a television studio. Our grounds include multiple grass and turf fields. Two ancillary buildings on the grounds contain weight and conditioning classroom spaces. As part of the Referendum project, HSE obtained a new Awning by Door #4. Installation of new univents were installed to support our HVAC system. We recently have replaced all 12 science labs with state of the art equipment and replaced the elevator. Additionally we have new exterior doors, updated HVAC and newly installed AC in the gymnasium.



High School East is patrolled by a School Resource Officer and two School Safety Officers. The main lobby entrance has been redesigned to have a locked vestibule with a security guard who is on duty throughout the school day. High School East is using an additional door where identification needs to be run through our Raptor security system prior to the visitor entering the vestibule. Upgraded security cameras and keyless entry systems have been added to the building. East has a security guard in the parking lot each morning to assist with traffic and student pedestrians. Monthly fire and security drills are conducted following state procedures. HS East takes great pride in our positive working relationship with the local police department.

Technology and STEM:



The district continues to upgrade building access to the internet, cybersecurity protections, wifi, and access to shared computing devices utilizing the Google Suite with accounts for all staff and students. All schools participate in CS Education Week, NJ Makers Day, NJ STEM Week and Digital Learning Day. Staff training is provided by a district Ed Tech Supervisor and building web developers. Tech courses focus on computer applications & programming, problem solving, and the maker mindset. HSE is home to the district STEAM Academy. Internal PD and support is provided by tech teachers and supervisors; and successful grant applications. Upgrades to the WAN backbone enable high speed 1 Gb connections to all locations and 10 Gb between two data centers, with resiliency from potential outages. Firewalls have been upgraded to provide improved cybersecurity.

At East we believe in the importance of showing up, on time, each and every day. We have a school based Attendance Committee that is teacher led and works to assure students are coming to school and addresses students with chronically absent behaviors. Our attendance committee runs various initiatives throughout the school year such as March Madness for Homeroom attendance, "Donut Miss a Day," and celebrates perfect attendance students. The 2023-2024 school year we saw a 5% decrease in the number of students considered chronically absent and a .12 increase in the average daily attendance. Our staff support the initiative by wearing "I show up, I count" t-shirts to school on Mondays. The Attendance Committee uses monthly attendance data to drive initiatives and student/parent meetings.
