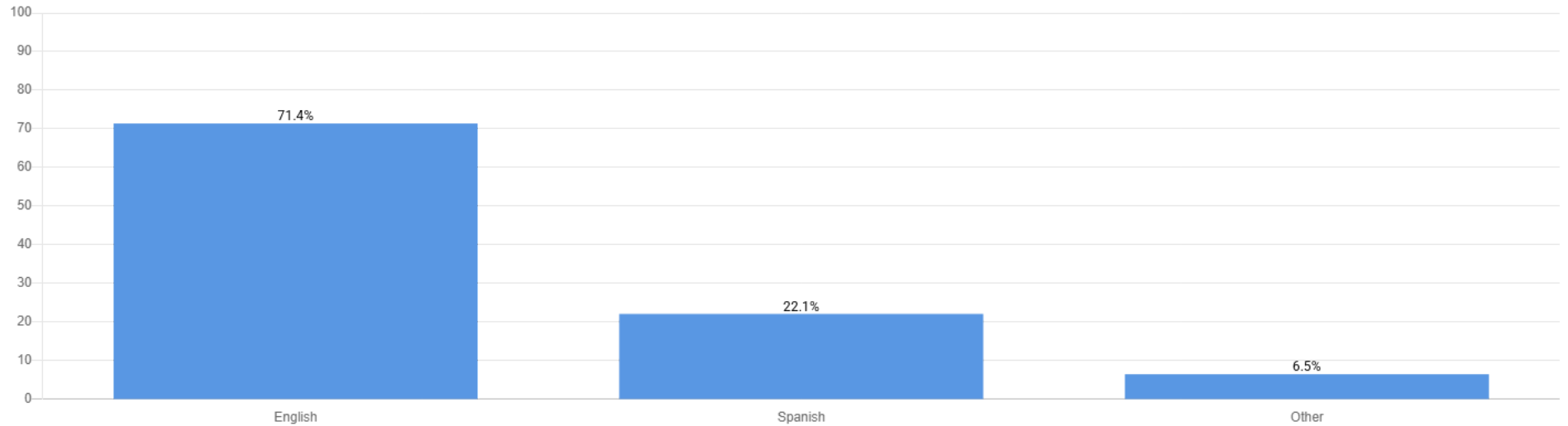

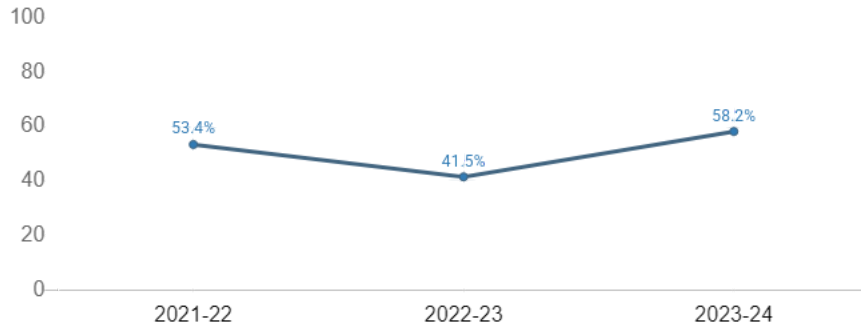

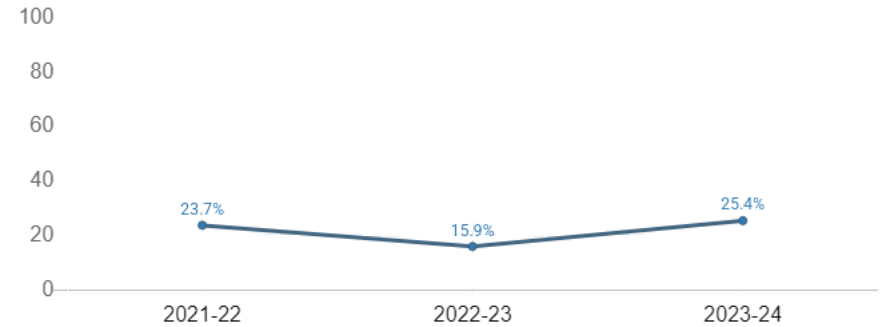
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 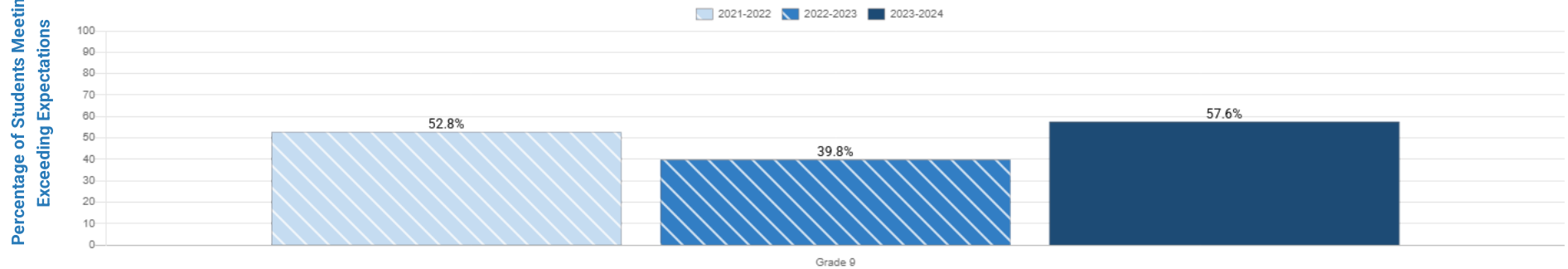

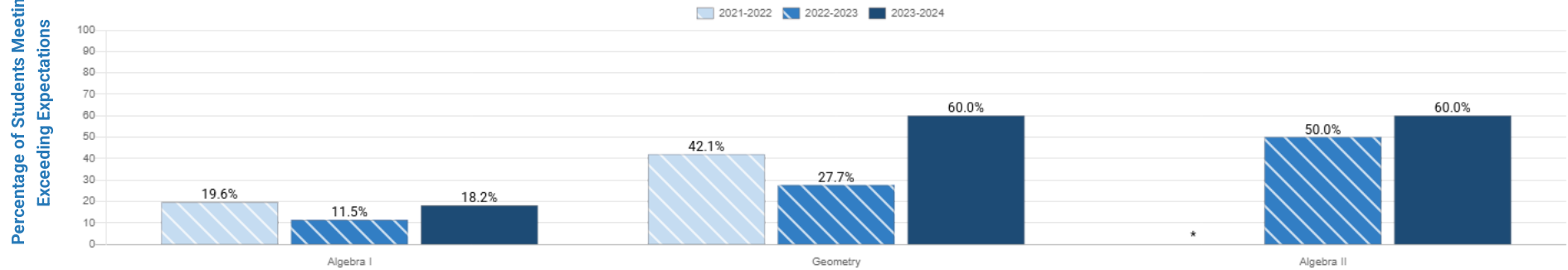

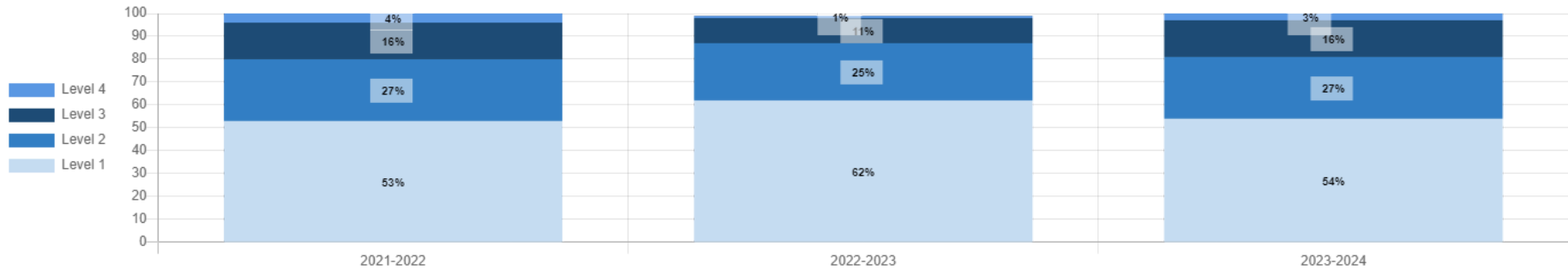

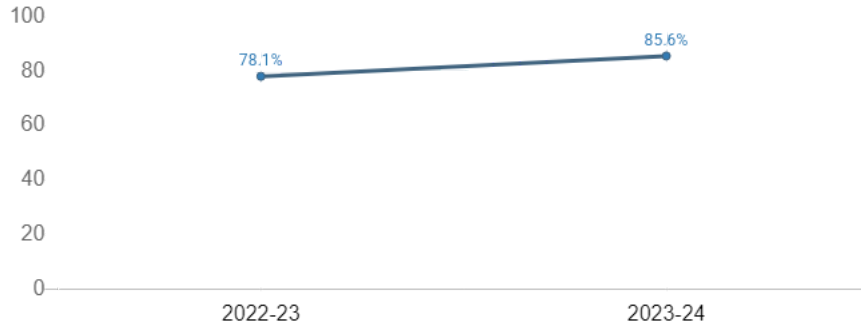

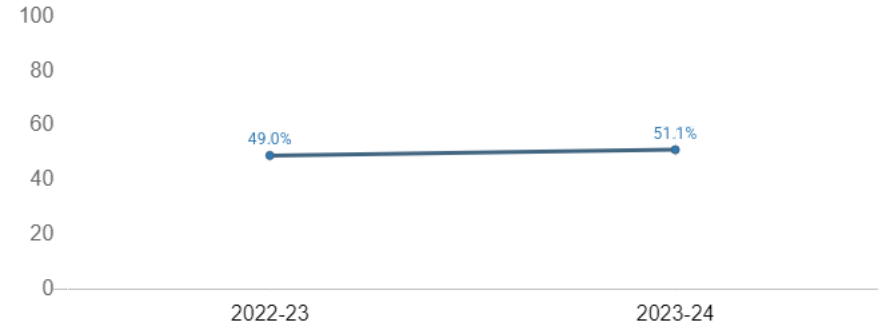

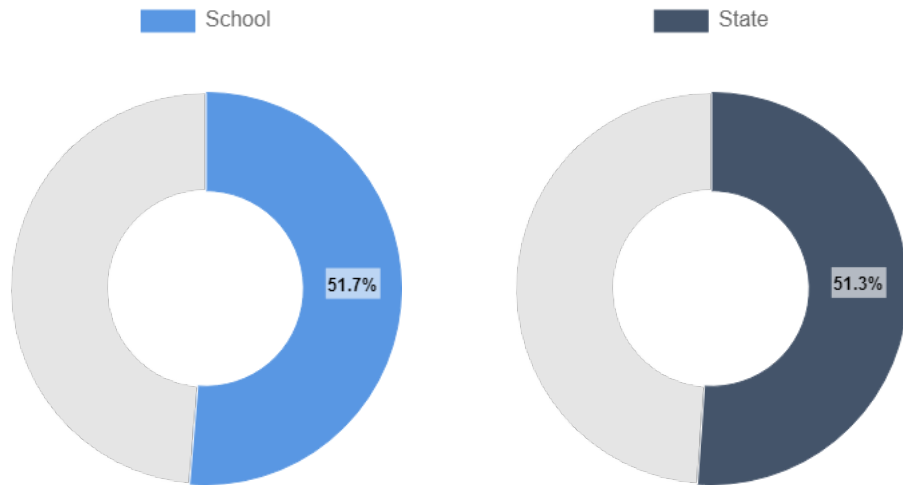

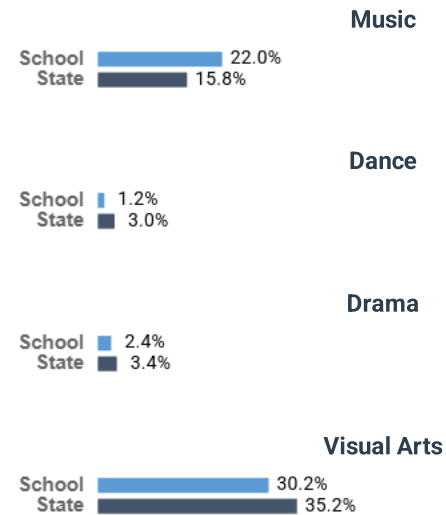

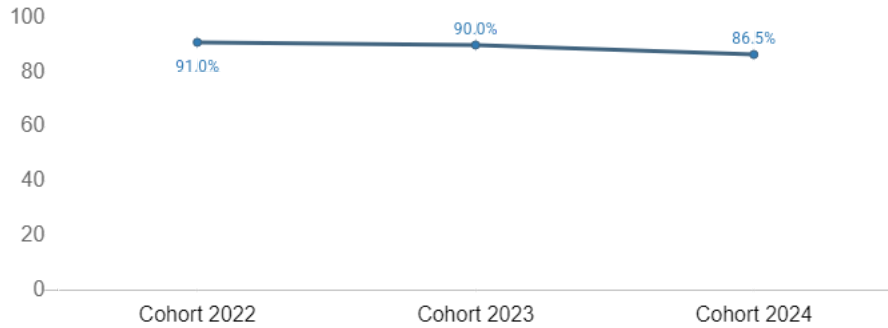

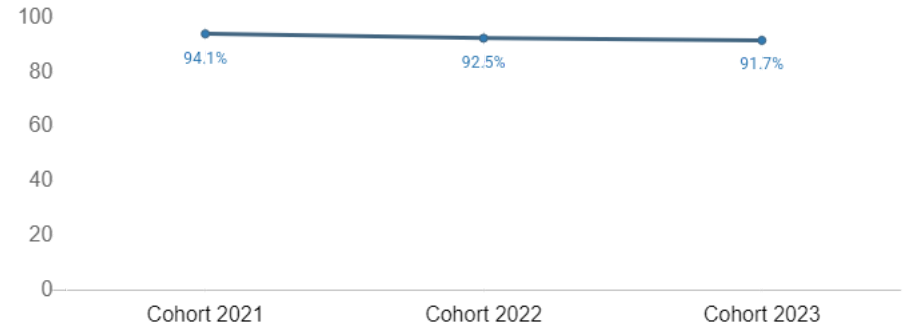

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

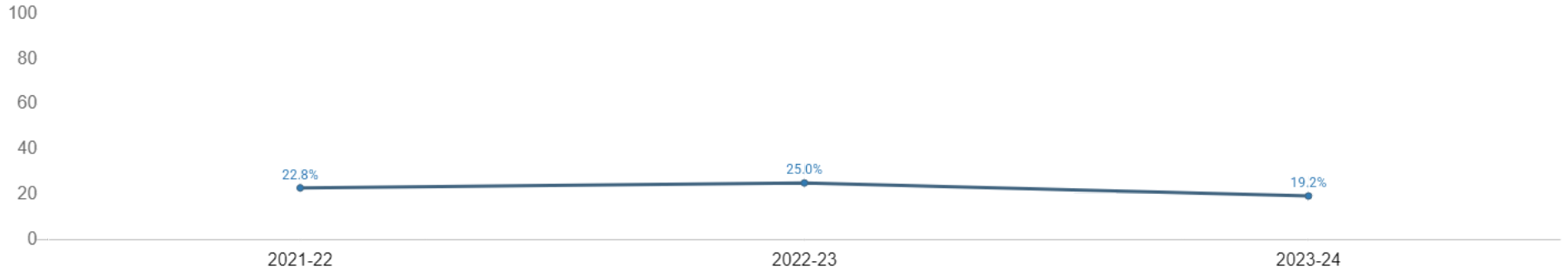

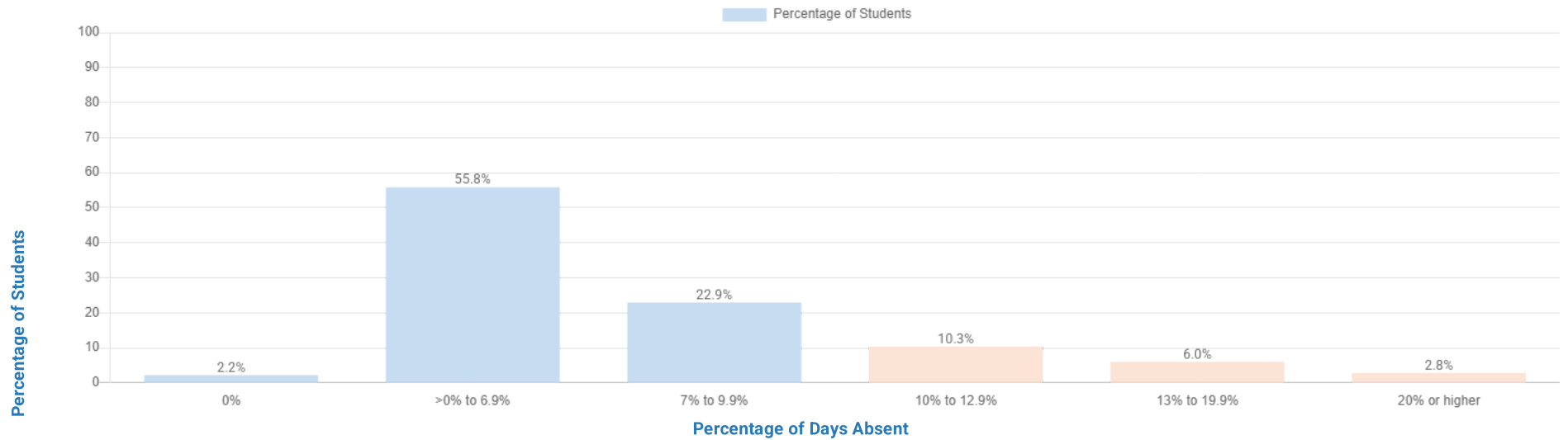

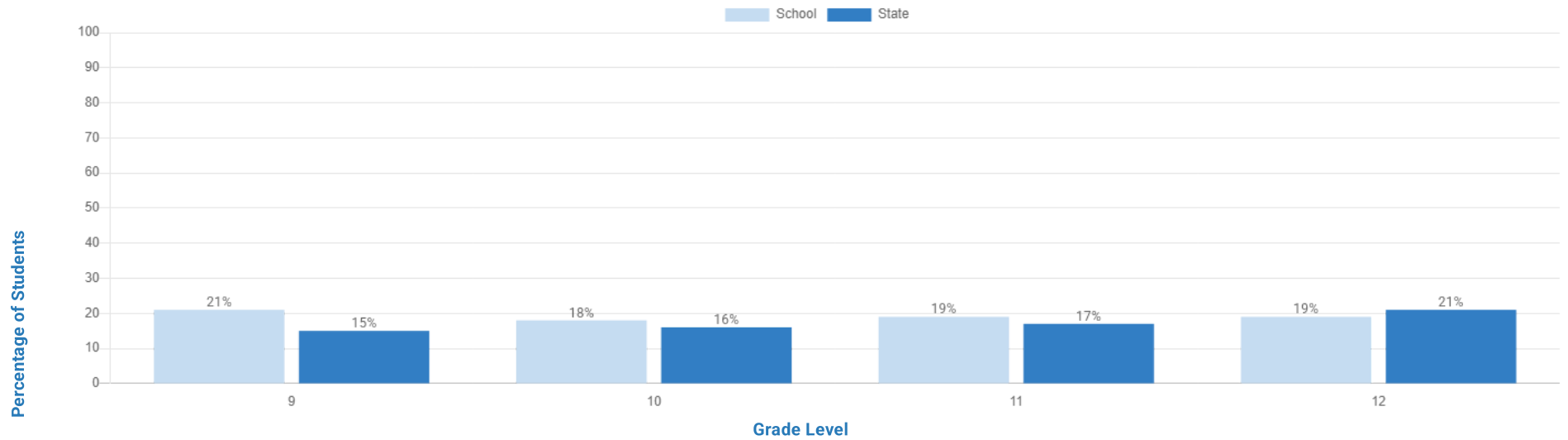

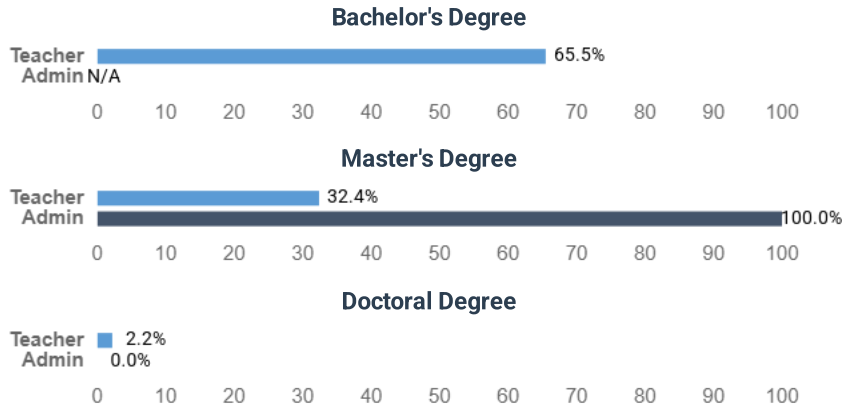

Opened in 1969, Toms River High School North, the largest of eighteen schools in the district, educates nearly 1870 students each day. By encouraging each student to become fully immersed in the school community, we foster academic, social and emotional growth.

Several of our students have been named "National Merit Semi-finalists and Commended Scholars" by the National Merit Foundation.

HSN houses the district Arts Academy and students can apply for one of three strands: Visual, Performing or Digital Arts. A dance room, where students can grow in a professional atmosphere, has been adorned with paintings from our visual art students. Students can participate in learning opportunities in our local community with artists, a sheer benefit to both students and the town in providing a public view of their work. A shared-time vocational program allows students access to an extensive program. Our Community Action and Cooperative Learning Programs afford students a service-related internship or work experience. Through a partnership with OCC, our students can earn dual enrollment credit as a part of the Jump Start Program either on the OCC campus or in our school. Our Authentic Science Programs affords students an opportunity to do live research over their career. Our Political and Legal Education program participates in local and state competitions.

With 32 interscholastic athletic teams we provide students endless opportunities to round out their outstanding high school experience. Our athletes had an outstanding year with Class A South Championships in Track, Football, Soccer, and Basketball. Our Boy's Soccer team was crowned South Jersey Group 4 Sectional Champions. Our Varsity Football program completed a 12-2 season and repeated as Group 5 State Champions. Our team finished the Year ranked as the number one team in New Jersey and our quarterback was named the the NJ ZoneMan Player of the Year for the second time as the best high school football player in the state of New Jersey. Our Boy's and Girl's Track teams competed well in the winter and spring seasons winning Shore Conference and State Championships. To close the year, two mariner female athletes completed and place in the State Meet of Champions. Our boys relay teams captured the Meet of Champions title in both the 4X110 and the 4X400.



Clubs and Activities:

Our Student Services Center, an integral component of our prior Middle States' accreditation, oversees each of our extra-curricular activities through a central, one-stop approach. Over thirty-six interest-specific offerings, along with Performing Arts and Student Government, complement the development of the entire child and provide a complete high school experience. Many of our clubs are community service oriented, which enable the students to become a part of the Toms River community as a whole. We strive to promote diversity through clubs like NSTEP, Anime, LGBTQ, Spanish, and Political Party Club. We have transformed our Military Club into a fully accredited and funded JROTC Academy.

The Writing Center is offered to students seeking assistance in written assignments after school. It is staffed by our Advanced Placement senior English students with an teacher advisor. Our National Honor Society students provides a tutoring service each afternoon. Our peer mentors meet with at risks students to promote positive decision making. TEAM students provide mentorship to Intermediate and Elementary students in our community.



Staff and Professional Learning:

All teaching staff members participate in a minimum of twenty hours of professional development per year. Staff members may attend local, regional or national conferences as well as participate in committees, workshops and panels both in and out of the district. The district of Toms River Regional Schools regularly plans PD days for staff members either full or half days during the school year. Over the past year, staff professional development has focused on SEL and as we are the district ESL magnet, Sheltered English Instruction. The outcome of this approach is designed to help our staff and students see the world through the perspective of others. This will enable us to meet students at their individual levels and ensure success for all.



Postsecondary Information:

Of the 480 graduating seniors of the Class of 2024, 80% went on to post secondary education. Some colleges both in and out of state were Princeton, Harvard, University of Pennsylvania, Lehigh, Yale, Georgetown, Stevens Institute of Technology and Rutgers. We offer parents a Financial Aid night as well as a college information night, college fair and individual meetings with students. We offer the PSAT each October, which is offered for free to all sophomore and juniors.

Student Supports and Services:

Based on the needs of the individual student, programs range from mainstreamed to self-contained life skills. Students are able to combine program offerings to meet the least restrictive environment. Our non-classified students receive additional support through 504 plans, the IR&S process and the mentoring program. Additional help with assignments can be found in the media center after school with our National Honor Society student tutors.



Student Health and Wellness:

TRHSN participates in the Free/Reduced Federal Lunch program and breakfast is offered each morning at two grab and go locations. Our nurses do a screening of each student each year including height, weight and blood pressure. Hearing and vision screenings are offered every other year. As per state graduation requirements, every student is required to pass a physical education course each year consisting of gym class and health. Through a partnership with Effective School Solutions, at risk students are helped through individual and group counseling. Through Ocean Harbor House, targeted at risk females meet weekly through the My Life My Choice Program. Boy's Council sponsored through the Youth Advocacy Program of Ocean County meet weekly with at risk males to discuss anger issues and social/emotional skills. In partnership with the YMCA, social workers work with students both individually and through group therapy.



Parent and Community Involvement:

Parents and guardians play a vital role in implementing our mission and in supporting the success of each child. We encourage positive communication through orientation programs such as Visit the School Night, "Coffee with the Principal," curriculum meetings, guidance information sessions, and other individual focus groups. Through these meetings and parent conferences we can include parents in their child's educational process. We realize the support of parents is critical to each child's success. We have created an SPO (Staff Parent Organization) to further strengthen the home-school bond and open the lines of communication. transition such 8th Grade Parent Night and Art Academy Showcases further involve parents in the workings of our school.

The school administers the NJDOE culture-climate survey and uses the data to drive professional development and to gauge and improve the overall school culture for staff and students. Students are given the opportunity to complete this survey during class time, while the staff participate during professional development days. We use this information to make informed decisions that support an overall positive climate in the school community.



Facilities:

Our main facility was built in 1969. Numerous additions over the years were constructed, the last in 2002. A 2-story wing houses our media center with two computer labs. A 5000 seating capacity arena is used for daytime PE classes, district events and rented for concerts and vendor shows. The main campus is approximately 400,000 square feet in size. Directly adjacent to our main building is a fieldhouse that has long served as a locker room and storage facility for our football and boy's lacrosse programs. The building has undergone a complete renovation. The roof was re-shingled and the interior redesigned to feature a locker room as well as our weightroom facility. This renovation allows the building to be used year round for afterschool athletics as well in addition to serving as a physical education station during the school day. A state of the art Dance Studio provides a home for our Dance Academy.



School Safety:

High School North is patrolled by a School Resource Officer and two School Safety Officers. The main lobby entrance has a security guard who is on duty throughout the school day. Upgraded security cameras and keyless entry systems have been added to the building. North has several security guards in the parking lot each morning to assist with traffic and student pedestrians. Monthly fire and security drills are conducted following state procedures. On the campus of HS North is our Security Department headquarters. This added security at our largest facility assists with ensuring the safety of students, staff, and visitors. HS North takes great pride in our positive working relationship with the local police department.

Technology and STEM:

The district continues to upgrade building access to the internet, cybersecurity protections, WIFI, and access to shared computing devices utilizing the Google Suite with accounts for all staff and students. All schools participate in Computer Science Education Week, NJ Makers Day, NJ STEM Week and Digital Learning Day. Through the use of one to one google devices, our students are able to work in the 21th Century environment. Staff training is provided by a district Ed Tech Supervisor and building web developers. Tech courses focus on computer programming & applications, problem solving and the maker mindset. HS North has a STEAM focus through programming in the Digital Arts Academy. VR and 3D devices have been added to the digital arts curriculum. Enhanced opportunities are provided by successful grant applications. Upgrades to the WAN backbone enable high speed 1 Gb connections to all locations and 10 Gb between two data centers, with resiliency from potential outages.



Attendance:

One of our school goals was focused on improving overall student attendance.
