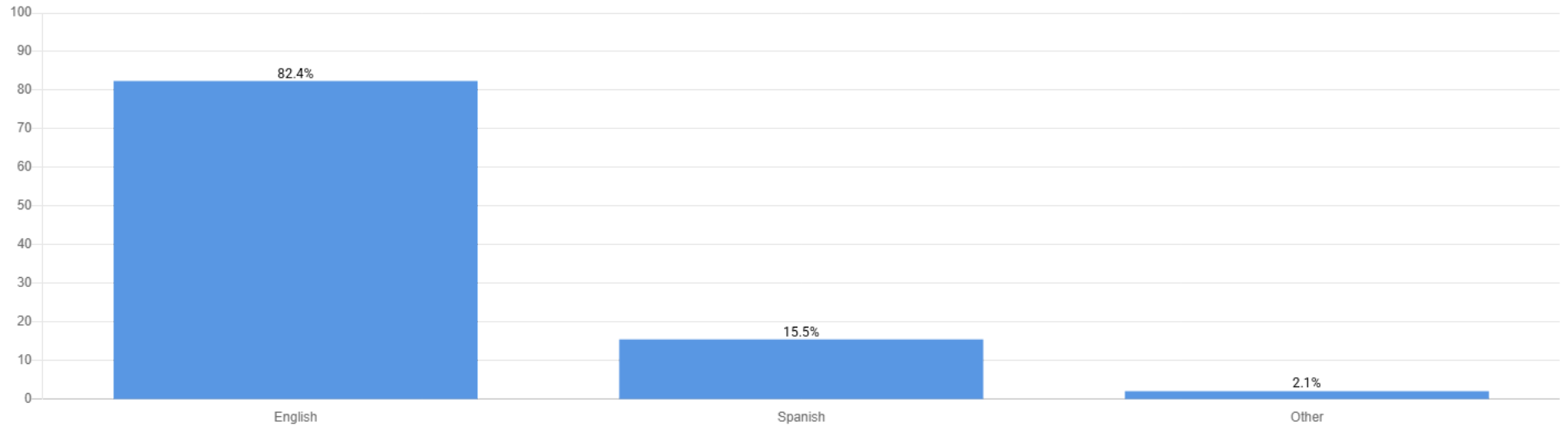

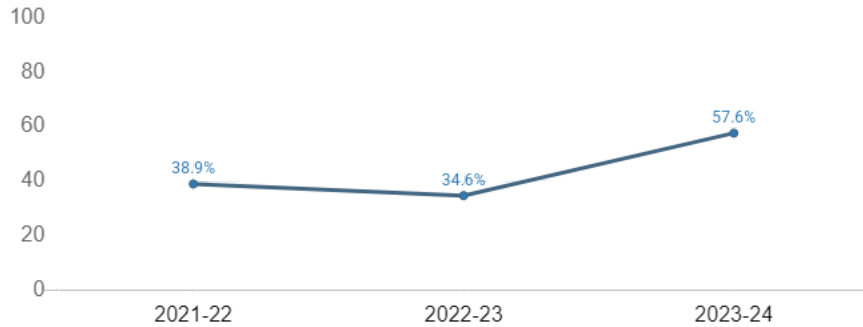

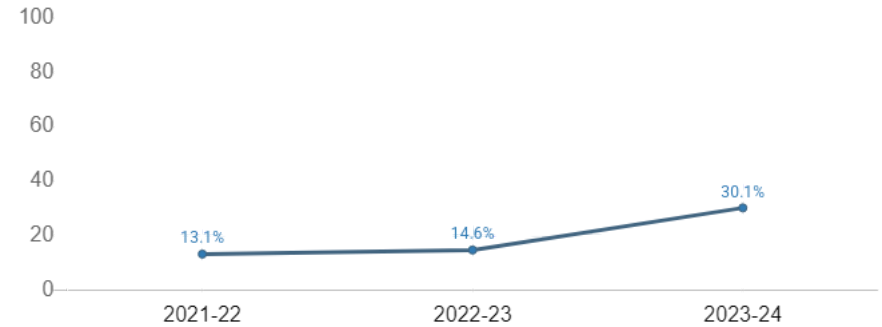
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 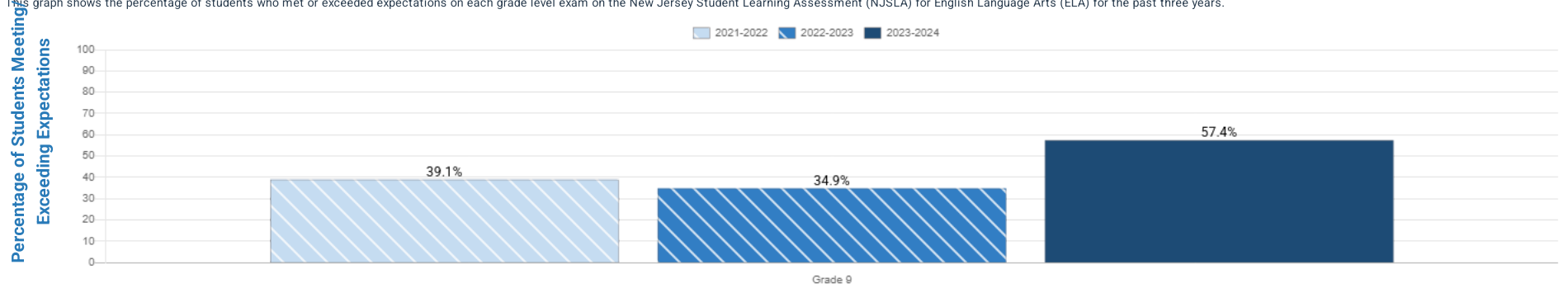

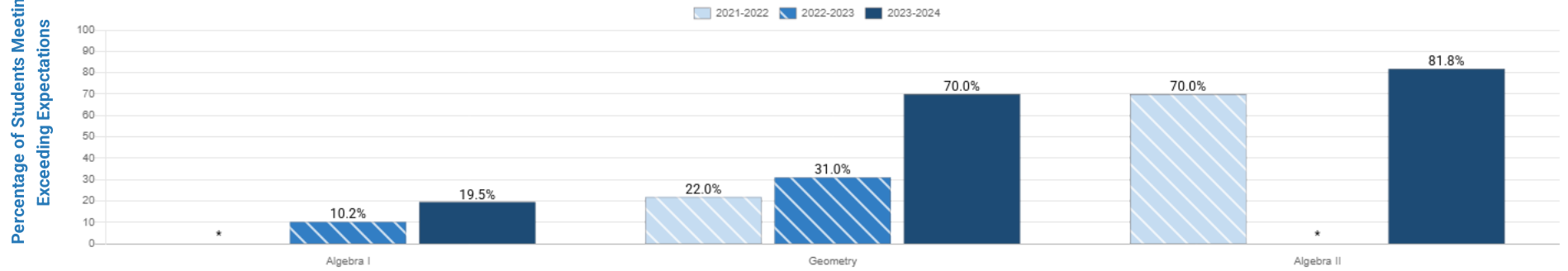

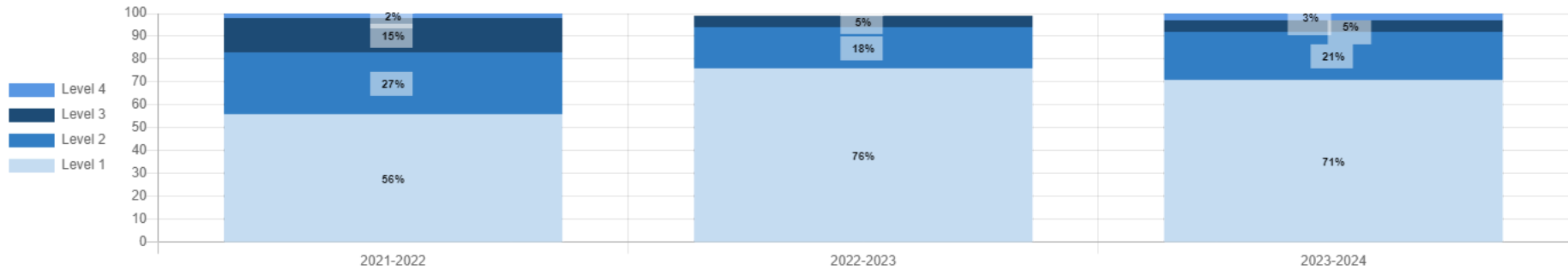

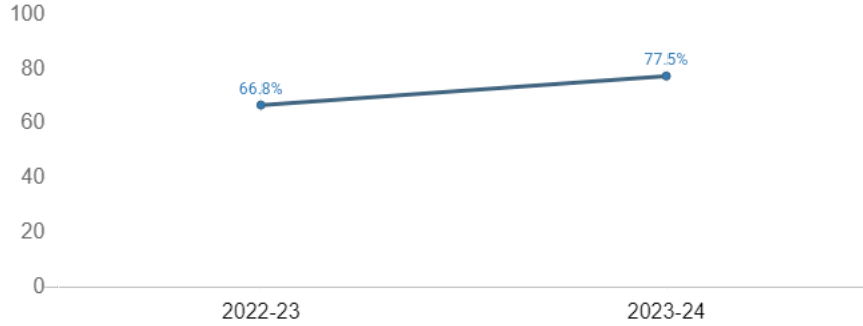

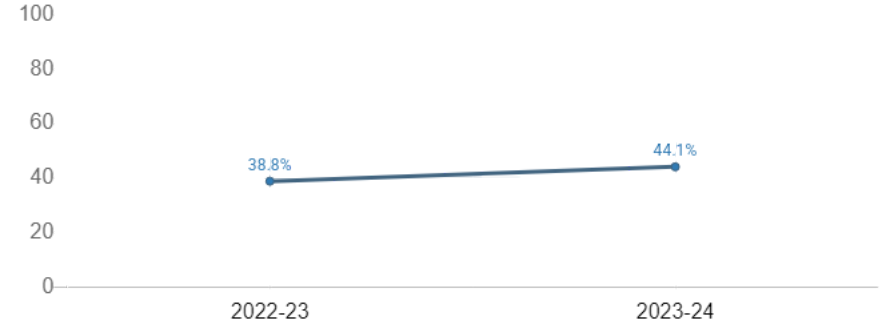

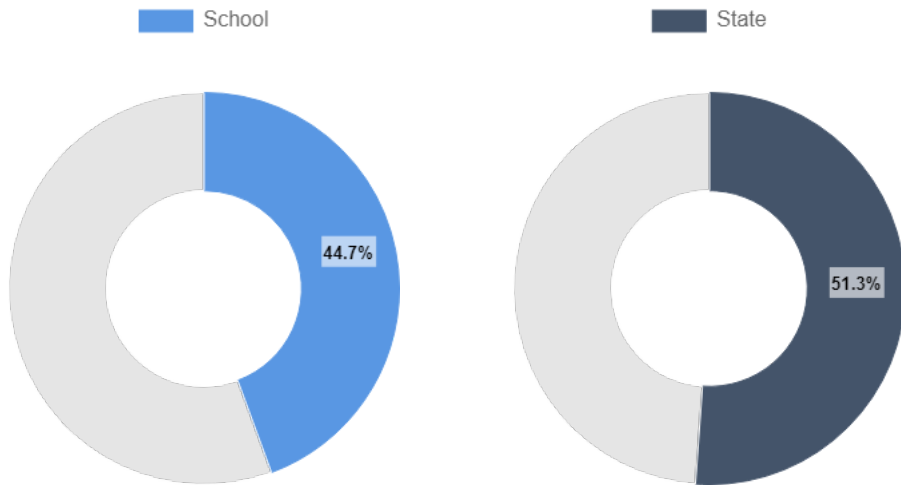

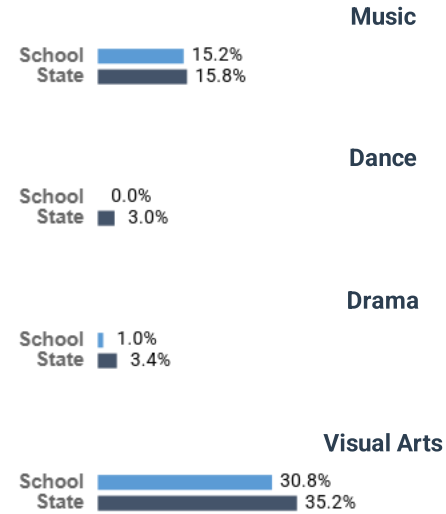

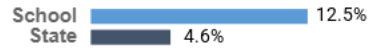

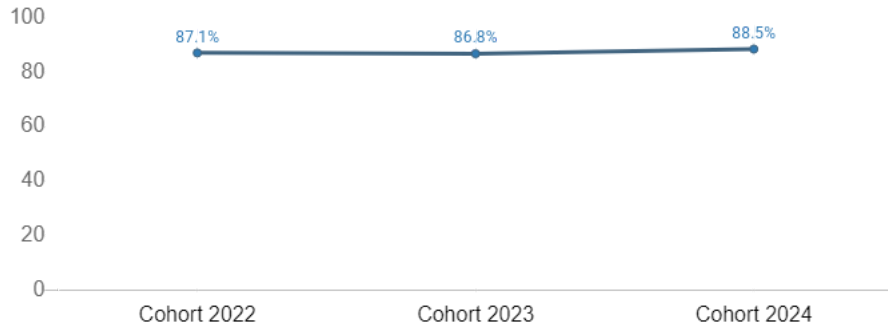

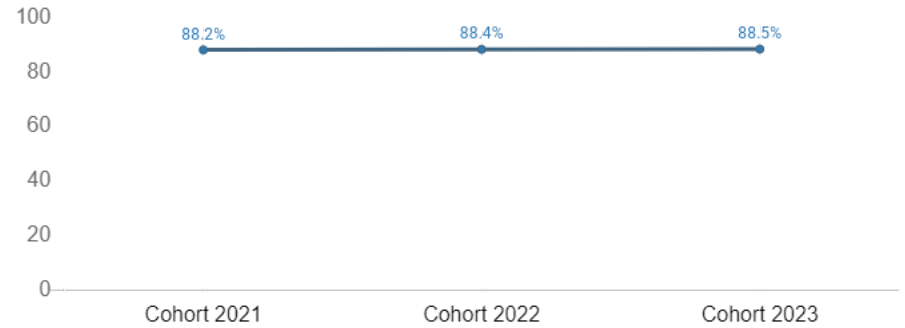

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

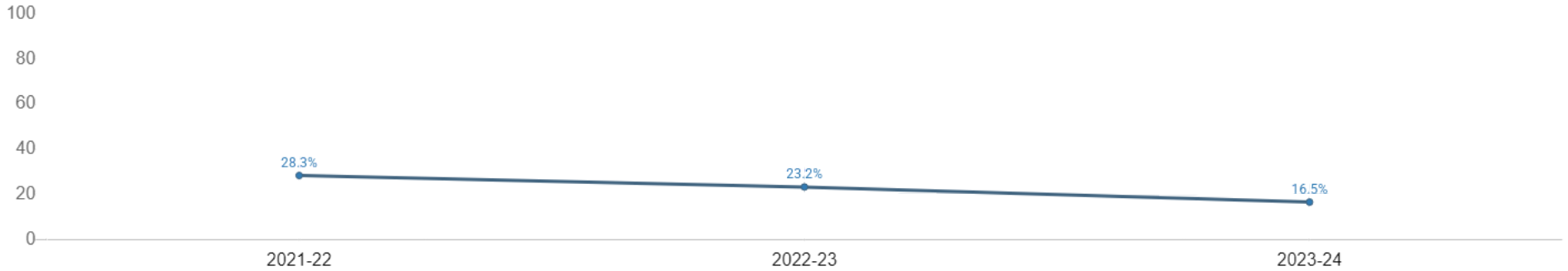

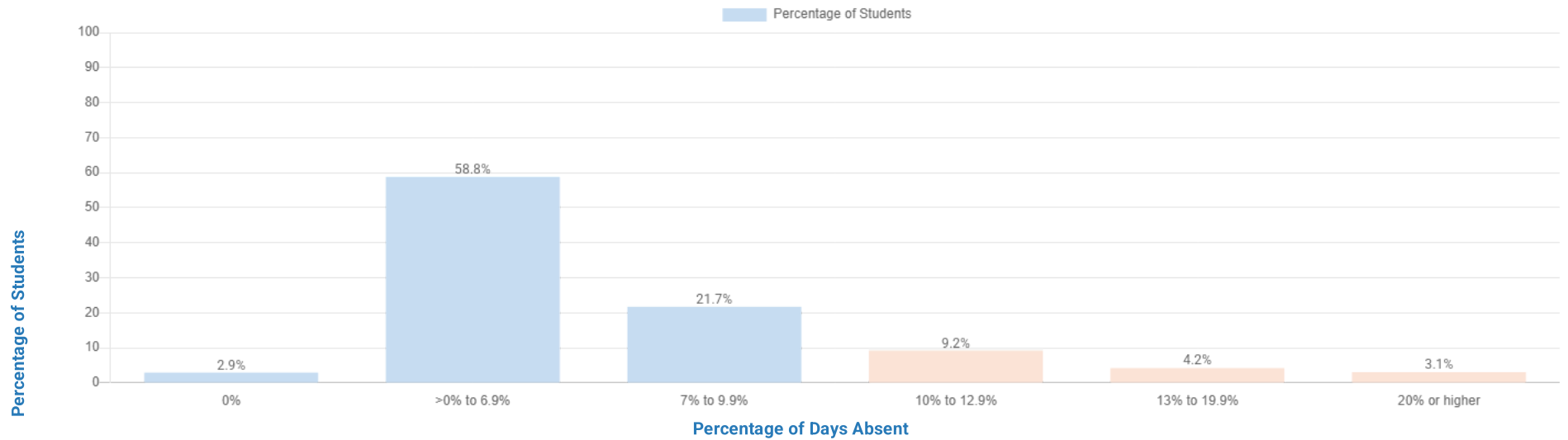

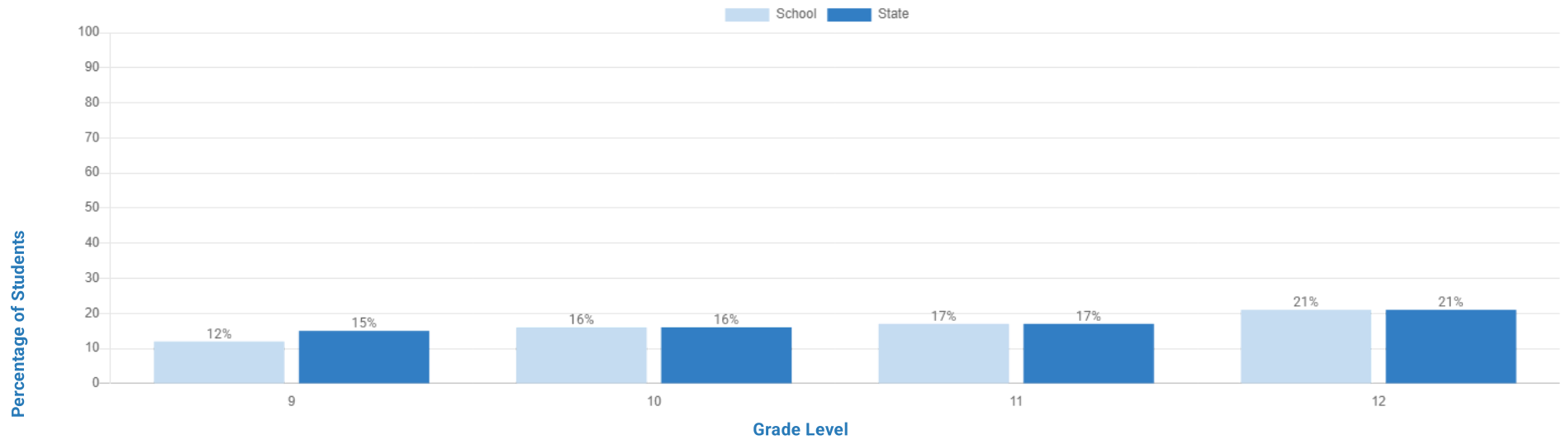

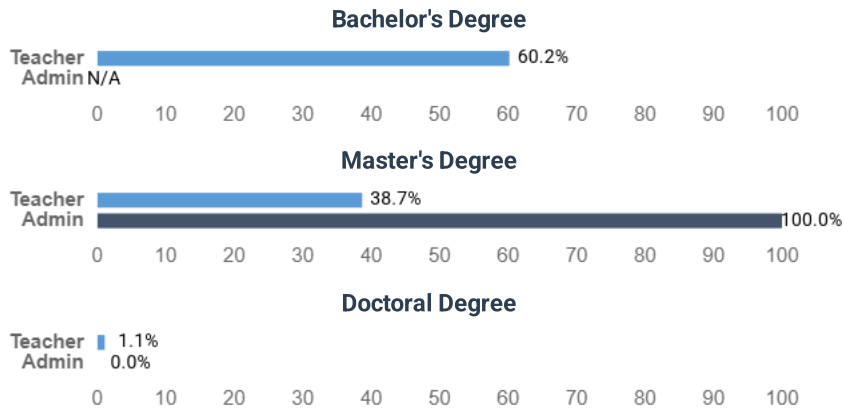

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Staff and Professional Learning:

Professional development has been designed at the building level to meet district goals. During the 2023-2024 school year, our professional development efforts at the building level included: expanding faculty members' capacity to identify and manage the needs of multilingual students, collaborative reestablishment of cultural norms in our building, providing instruction to students that prepares them for future experiences beyond high school, and development of appropriate interventions for students in need based on academic, attendance, and behavior data. Professional development topics are driven by staff and student needs that are identified through multiple measures including but not limited to staff surveys, learning walkthroughs, formal and information observations, PLC discussions, IXL reports for Math and ELA, NJSLA, and NJGPA data, etc.



Postsecondary Information:

73% of graduates are continuing their education at college and/or universities. Guidance meets with all freshman students to develop College Board Accounts, holds annual financial aid information sessions, SAT information sessions, and provides college and career workshops for all students and parents. The 2022-2023 school year had more students (37%) moving on to 4 year schools percentage wise as it was a lower percentage of students moving along to a 2 year school environment (28%).

Student Supports and Services:

Toms River South has a full time Child Study Team that works closely with parents, students, and teachers to ensure IEP's are developed and supported. Students with disabilities work closely with their case manager and guidance counselor throughout the year. Tutoring services are available after school for all students who need additional academic support. Our Intervention and referral service committee meets on a regular basis with parents, teachers, and students to provide modifications.



Student Health and Wellness:

Physical Education and Health classes are delivered in grades 9-12. Students are encouraged to enjoy breakfast and lunch in our cafeteria daily. Our Student Assistance Coordinator works closely with our nursing staff to develop programs that promote healthy lifestyle choices.



Parent and Community Involvement:

High School South has many parent booster clubs that support sports and activities. South parents are also highly involved in our District Special Education Parents Group and District Drug Free and Safe Schools Committee. Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Teachers. The annual school climate survey reports that students and staff feel safe at HS South. The school spirit is a highlight from this survey that shows a true love for the oldest building that is rich with tradition and pride. Staff morale proved to be quantitatively high throughout the building.



Facilities:

HS South is the oldest school within the District. It opened its doors in 1891 and is nestled in the downtown area of Toms River. The school has seen many additions over the years. Students and staff from our SPEAR program continued efforts to clean and repaint all of our hallway walls. Prior referendum projects included such things as a security vestibule, new windows and doors, new univents, installation of an elevator, and most exciting is air conditioning through our building.



School Safety:

High School South is patrolled by a School Resource Officer and two School Safety Officers daily. The main lobby entrance has a security guard who is on duty throughout the school day. Upgraded security cameras and keyless entry systems have been added to the interior and exterior of the building. South has a security guard in the parking lot each morning to assist with traffic and student pedestrians. Monthly fire and security drills are conducted following state procedures. Annual safety procedures are reviewed with all staff at the beginning of the school year and reviewed as needed. HS South takes great pride in our positive working relationship with the local police departments of the towns that send students to our school. School staff is trained in the use of Raptor System Technology, to aid in guest identification and to vet and monitor all visitors who enter the building.

Technology and STEM:

The district continues to upgrade building access to the internet, cybersecurity protections, wifi, and access to shared computing devices utilizing the Google Suite with accounts for all staff and students. All schools participate in Computers Science Education Week, NJ Makers Day, NJ STEM Week and Digital Learning Day. Staff training is provided by a district Ed Tech Supervisor and building web developers. Tech courses focus on computer applications, problem solving, the use of media and the maker mindset. Internal professional development and support is provided by tech teachers and supervisors; and successful grant applications. HS South is home to the School of Entrepreneurship with a business incubator and fabrication lab. Upgrades to the WAN backbone enable high speed 1 Gb connections to all locations and 10 Gb between two data centers, with resiliency from potential outages. Firewalls have been upgraded to provide improved cybersecurity.



Attendance:

One of our school goals was focused on improving overall student attendance and reducing the number of students that were chronically absent. Through our Attendance Committee, we utilized mottos such as "Attendance Matters - Everyday Counts" throughout our school community and distributed fliers to both parents and students to encourage better attendance. Each month, students with perfect or improved attendance had a chance to win a prize which contained a gift card to a local establishment. Monthly challenges, were a great success as they brought attention to attendance and brought the entire school together. Our committee viewed building data and met regularly with our at risk students both individually and as a group. Further interventions, such as parent conferences and the introduction of an attendance contract were implemented for our at-risk students. These efforts produced a significant reduction in daily absences as well as a 10.2% reduction in Chronic absenteeism.
