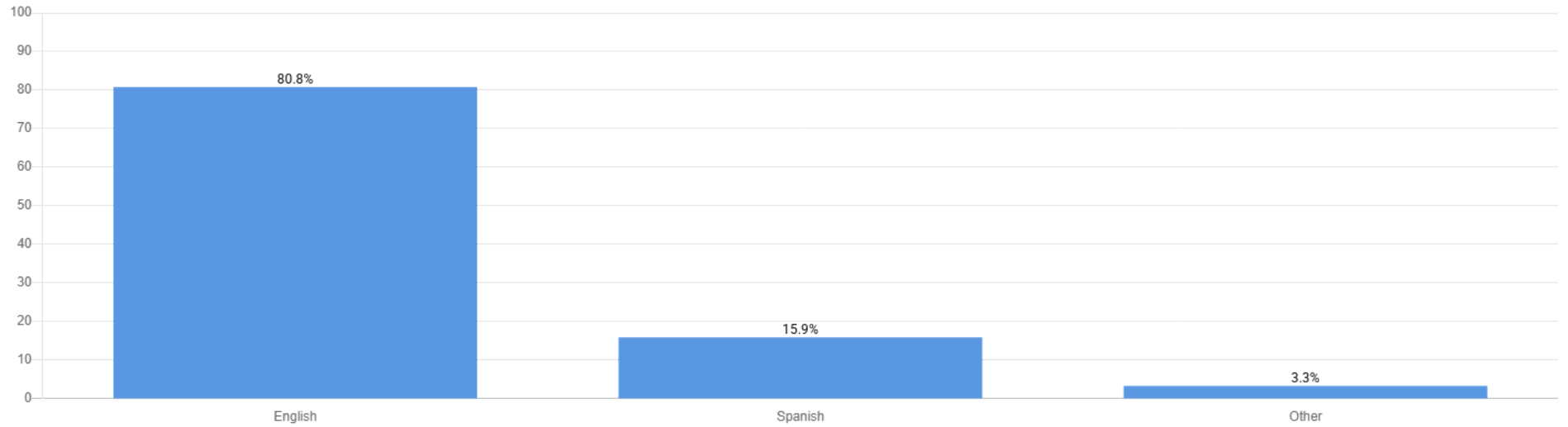

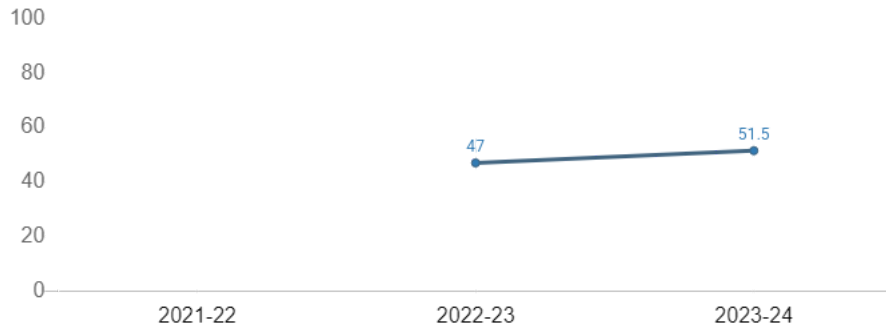

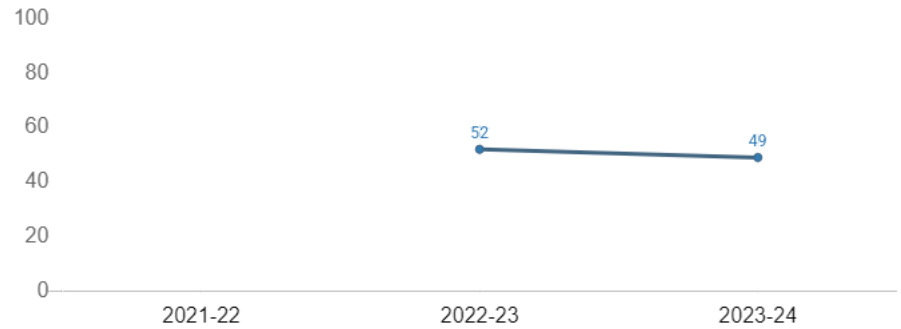

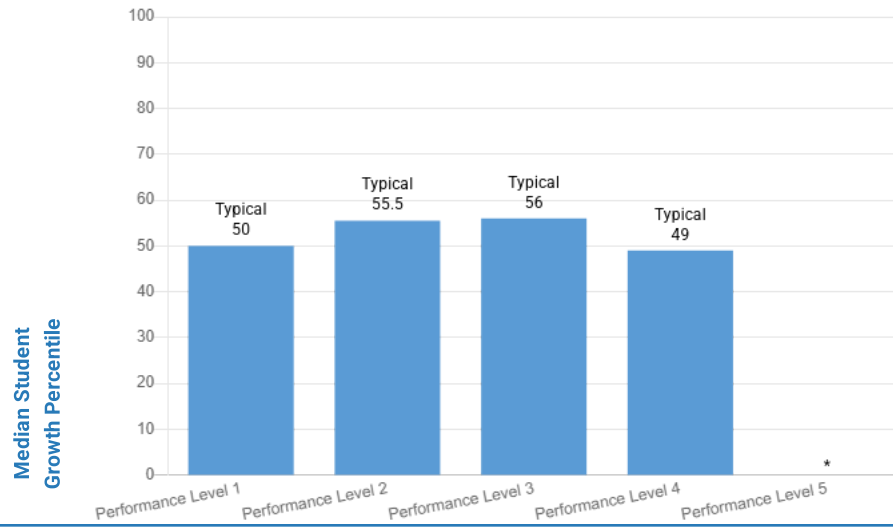

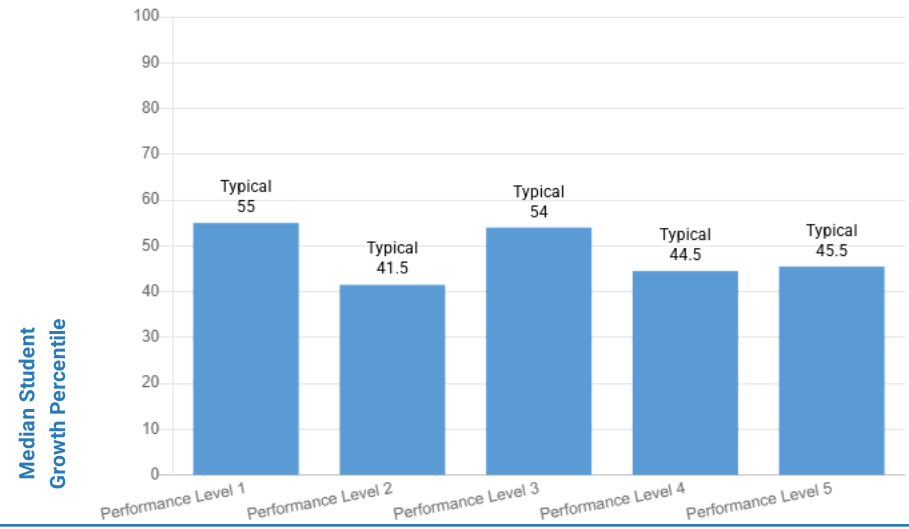

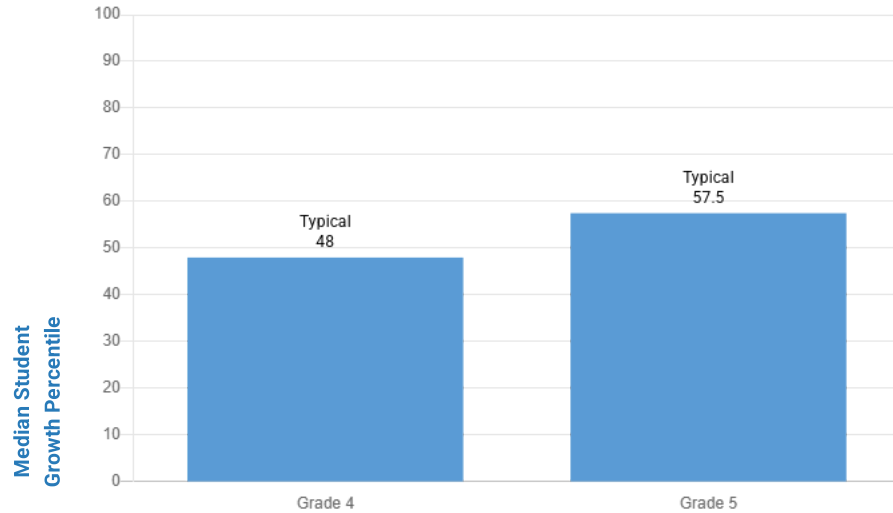

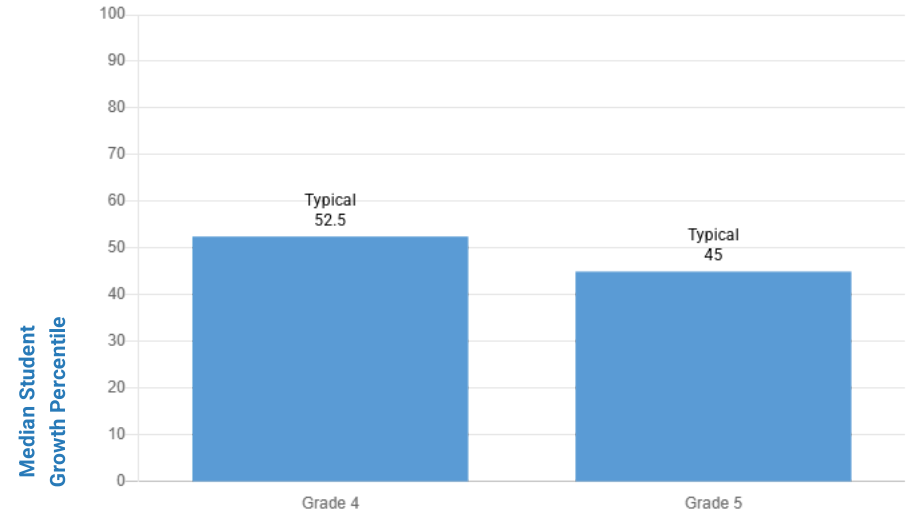

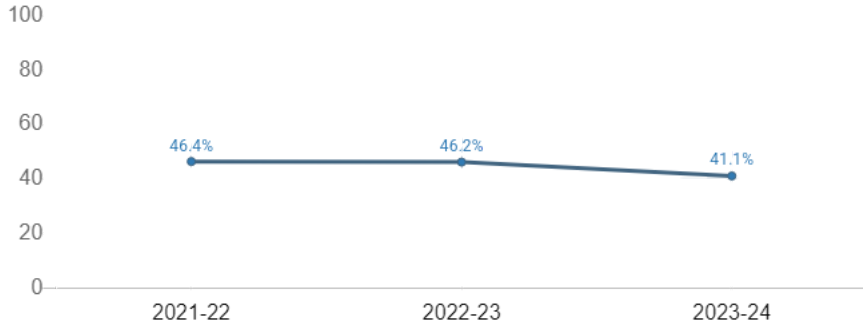

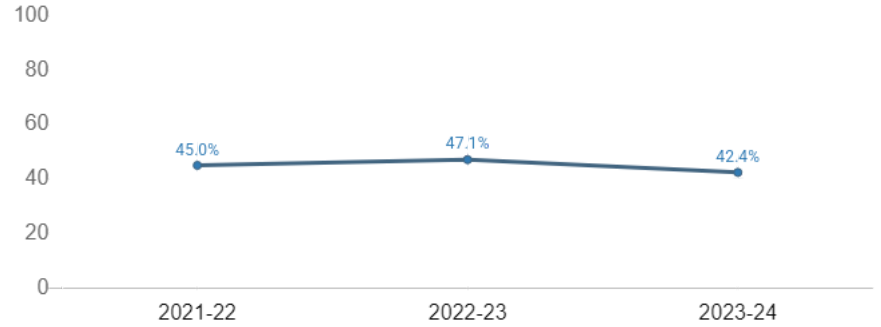
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 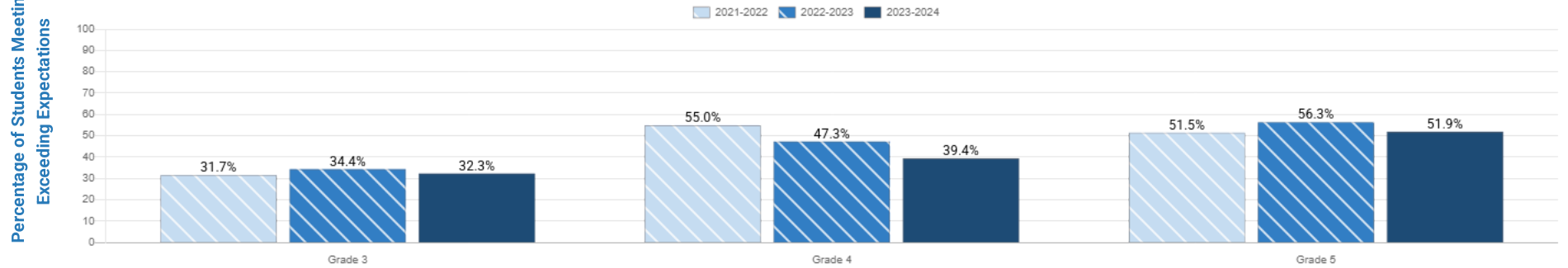

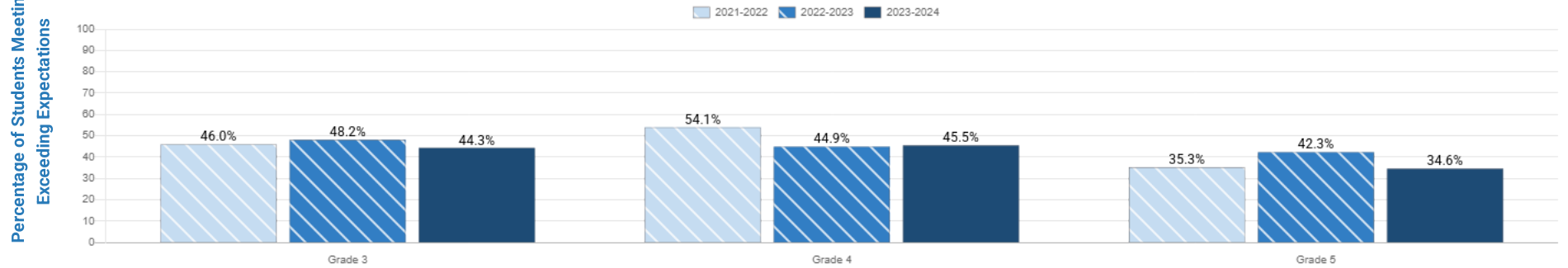

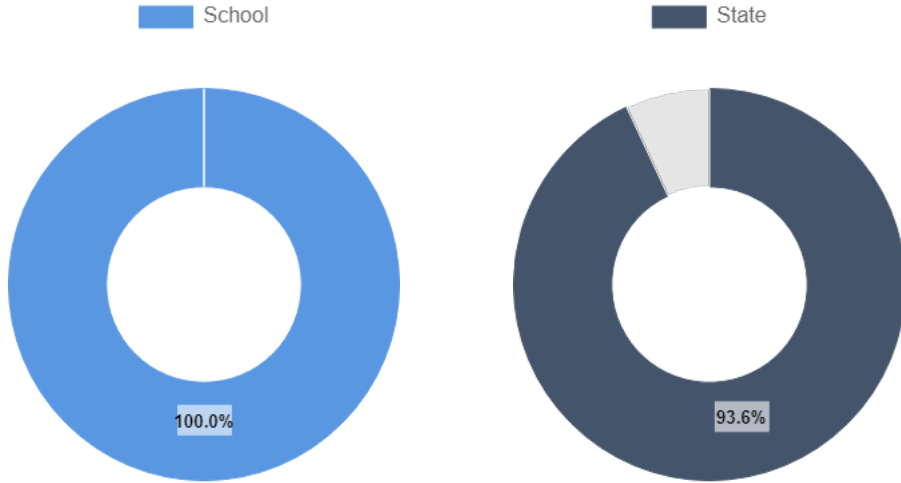

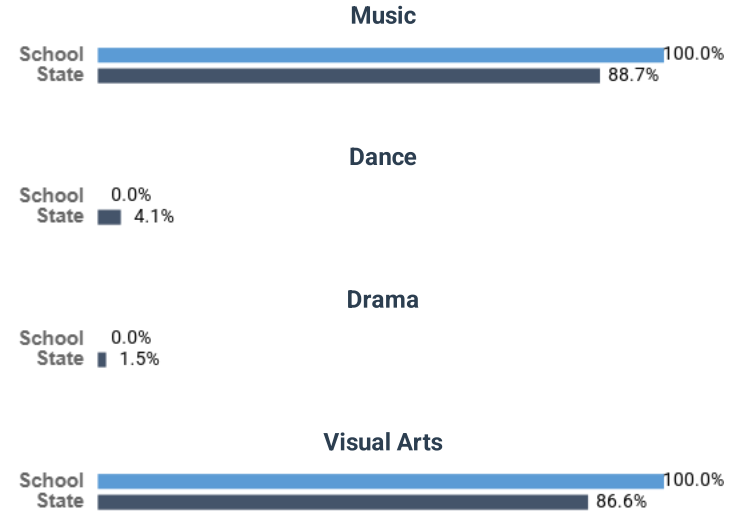

Students enrolled in one or more classes by discipline:



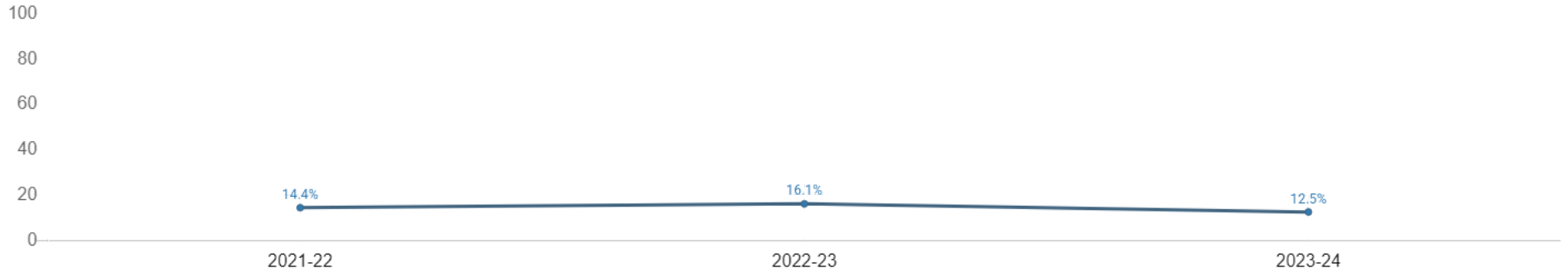

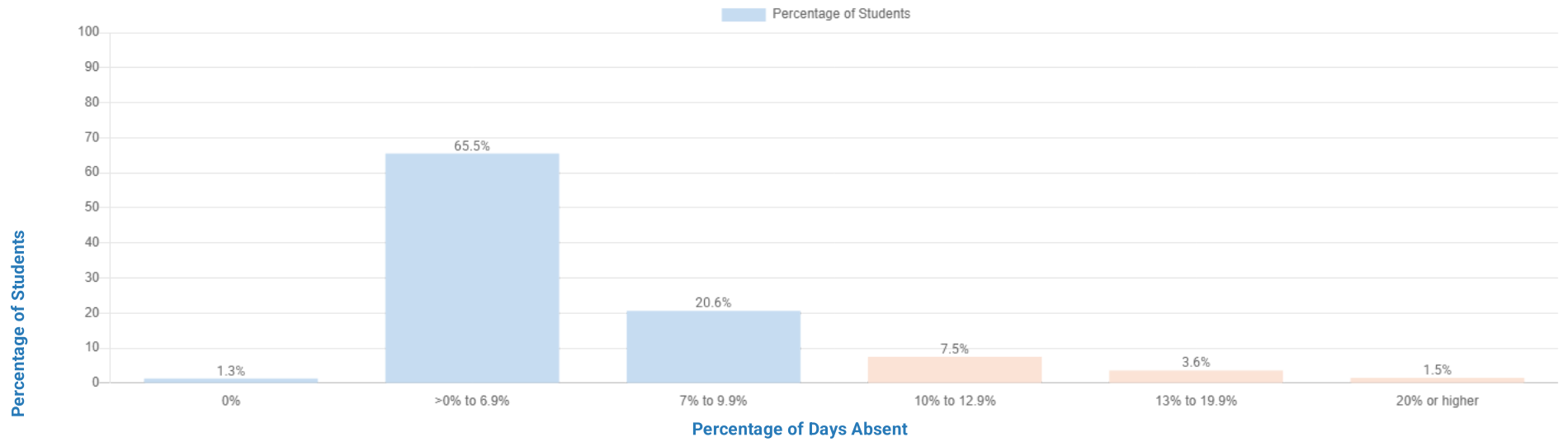

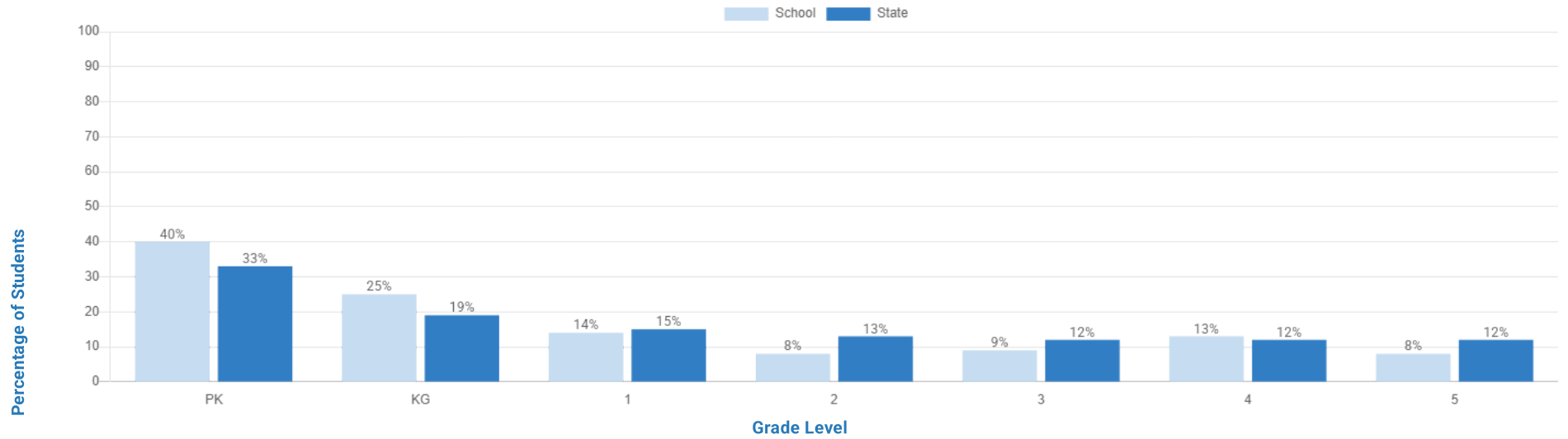

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

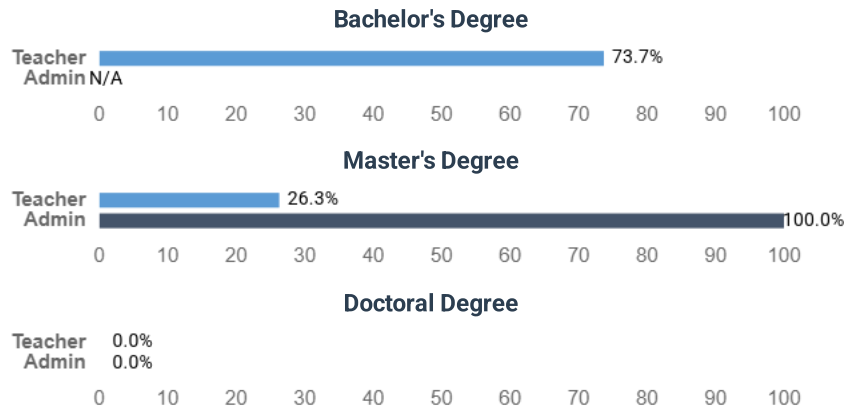

Courses, Curriculum, Instruction:

The New Jersey Student Learning Standards establish high expectations for student learning. Our teachers work hard to implement a curriculum firmly rooted in the standards with strong formative and summative assessments of students' skills. Data is used to plan for whole group and differentiated instruction. Lessons are well rounded that include both skills and concepts, as well as strategic and extended thinking. The integration of the Science of Reading into English Language Arts instruction has yielded improved growth in both reading comprehension and writing.



Clubs and Activities:

During the 2023-24 school year, Cedar Grove Elementary offered full year Band, Orchestra and Chorus lessons to students in grades four and five. These ensemble groups performed winter and spring concerts. Safety Patrol and Peer Leadership program opportunities were available to grade five students. "Girls on the Run," offered to grade five girls, is a fun and evidence-based spring program that inspires girls to build their confidence, kindness and decision making skills A kindergarten through grade five mentorship program was created and facilitated by staff members who volunteer their time to make individual connections with students. Building Committees for the 2023-24 school year included: School Improvement Panel, Culture & Climate, School Safety, Data Team and Parent Advisory Committee.

Staff and Professional Learning:

Our staff regularly participates in district and building level professional development opportunities, with a strong emphasis on collaboration. Professional development decisions are made in collaboration with the School Improvement Panel and the Cedar Grove Elementary School Data team, which consists of a teacher leader from each grade level (K-5).



Student Supports and Services:

Cedar Grove Elementary provides strong Tier One instruction grounded in best practice. Basic skills intervention is offered to students who meet eligibility requirements. During the 2023-24 school year, Cedar Grove Elementary implemented a High Intensity Tutoring Program in mathematics for grades three and four. A robust Intervention and Referral Services Committee meets monthly to support teachers and set individualized goals and interventions for students. Students who require special education services are afforded a continuum of options as required by the Administrative Code. Related services available for eligible students include: Speech and language therapy, occupational therapy, physical therapy, medical services provided by school nurses, behavioral consultations by a BCBA, and counseling services by the school counselor. Clinical counseling is also available through a partnership with the YMCA of Greater Monmouth County.



Student Health and Wellness:

Our school takes a proactive approach to teach our children to be respectful, curious and productive "Proud Patriots." Social-emotional Learning activities are utilized within the context of a child's developmental level to teach children how to interact respectfully and resolve conflicts when they arise. We help our children be sensitive to the needs of others through a variety of methods: Responsive classroom techniques, Sanford Harmony lessons, common K-5 "morning meeting" lessons, and a host of school spirit, PTO and philanthropic activities during the school year.

Cedar Grove Elementary boasts a solid partnership with our PTO, who through their fund raising efforts and tireless commitment, provide our students, staff, and families with fun events throughout the year. Events during the 23-24 school year included a carnival, school dance, assemblies, book fair and a fun run.

Facilities:

Cedar Grove Elementary School is one of twelve elementary schools which comprise the Toms River Regional School District. At Cedar Grove, we educate approximately 800 students in kindergarten through grade five with a professional and support staff of over 90 people. For over fifty years, Cedar Grove Elementary School has served as a family-focused neighborhood school. The recent improvements within the referendum has greatly enhanced our building. The School Beautification Committee is making aesthetic improvements to enhance the learning environment for students, including a mural designed and created by our art teacher and grade five students.

School Safety:

Cedar Grove Elementary is patrolled by our security officers. The main entrance has a remote locked door/video system that is opened only after checking identification of the visitor. Upgraded security cameras have been added to the interior and exterior of the building. A keyless entry point allows staff members to enter our school with the use of a key fob. Monthly fire and security drills are conducted following state procedures. Annual safety procedures are reviewed with all staff at the beginning of the school year and reviewed as needed. Cedar Grove Elementary takes great pride in our positive working relationship with the local police department who meets with staff and students on a regular basis to educate all on current safety concerns.



Technology and STEM:

The district continues to upgrade building access to the internet, cybersecurity protections, wifi, and access to shared computing devices utilizing the Google Suite with accounts for all staff and students. All schools participate in Computers Science Education Week, NJ Makers Day, NJ STEM Week and Digital Learning Day. Staff training is provided by a district Ed Tech Supervisor and building web developers. Tech courses focus on computer applications, problem solving, the use of media and the maker mindset. Internal professional development and support is provided by tech teachers and supervisors; and successful grant applications. Upgrades to the WAN backbone enable high speed 1 Gb connections to all locations and 10 Gb between two data centers, with resiliency from potential outages. Firewalls have been upgraded to provide improved cybersecurity.



Early Childhood Education:

The Early Learning Center encompasses programs for children with special needs. At the Early Learning Center, we educated 201 children ages 3-5. Classrooms include general education/inclusion and preschool autism. The Early Learning Center staff members include teachers, paraprofessionals, secretaries, and related service providers.

During the 2023-24 school year, Cedar Grove Elementary participated in the Toms River Regional Schools Attendance Initiative -- "Every Student Matters, Every Moment Counts." The Culture and Climate team monitored attendance data, oversaw initiatives, measured success and adjusted plans accordingly. Building based attendance initiatives included monthly attendance superheroes with extra recess, weekly staff and student spotlights, and attendance tips highlighted in weekly family newsletters. Classroom based attendance initiatives included daily perfect attendance signs and individual incentives to recognize consistent attendance. Main office staff, building administration and the school counselor all provided individual outreach to students and families in need of additional support. The adoption of school spirit events and activities and the building-based mentorship program increased students connectedness and engagement in school.

Cedar Grove Elementary School recognizes that future academic success depends upon a solid foundation in both reading and math. Within the area of English Language Arts, students benefit from systematic instruction in phonics and rich experiences with complex texts to help them move confidently into the world of written language. Teachers collaborate to share ideas and create lessons in order to implement the language arts program most effectively. Our teacher's efforts produce well rounded readers who respond to story selections of various genres through writing. Rigorous mathematics instruction balances both conceptual and procedural understanding of math. Teachers emphasize everyday applications, meaningful problem solving, reasoning, and mathematical communication. Students focus on mathematical thinking and writing. Teachers challenge students to explain their responses and show how they arrive at their answers. Children must be able to think clearly, understand alternative processes, work cooperatively, and communicate ideas in mathematics, if they are to be successful in life and future careers.
