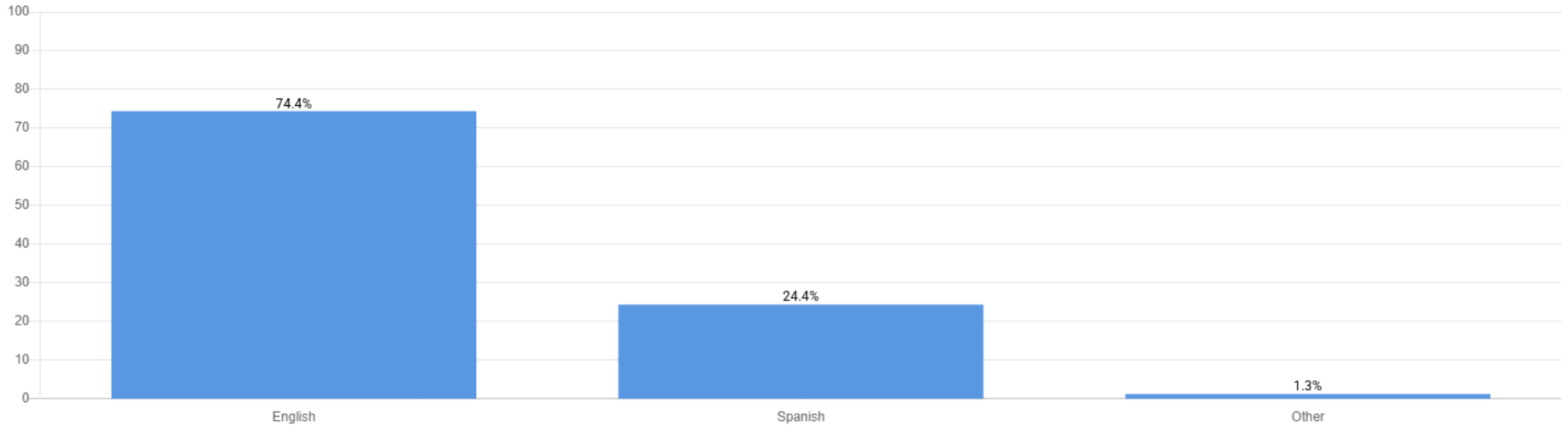

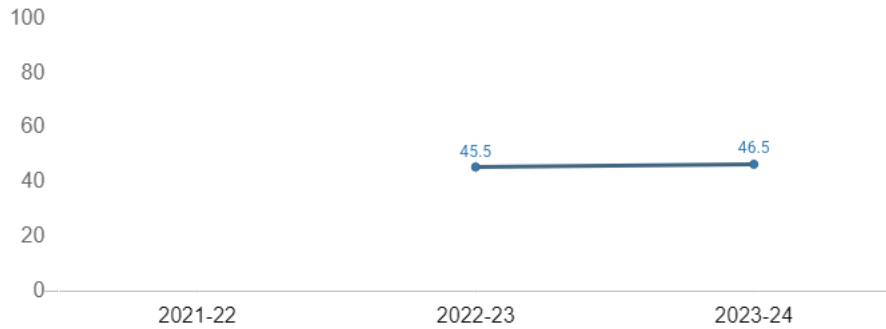

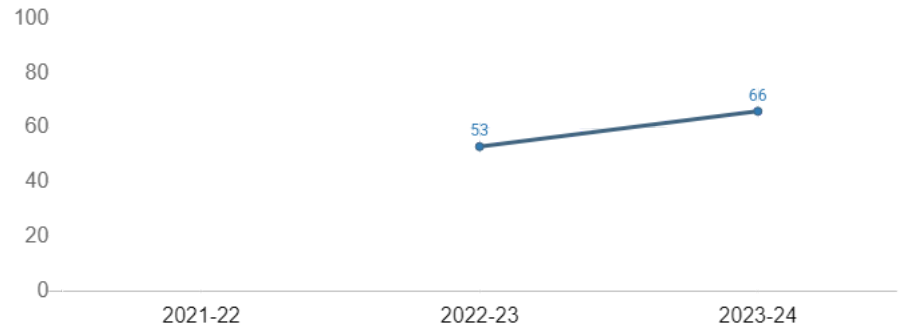

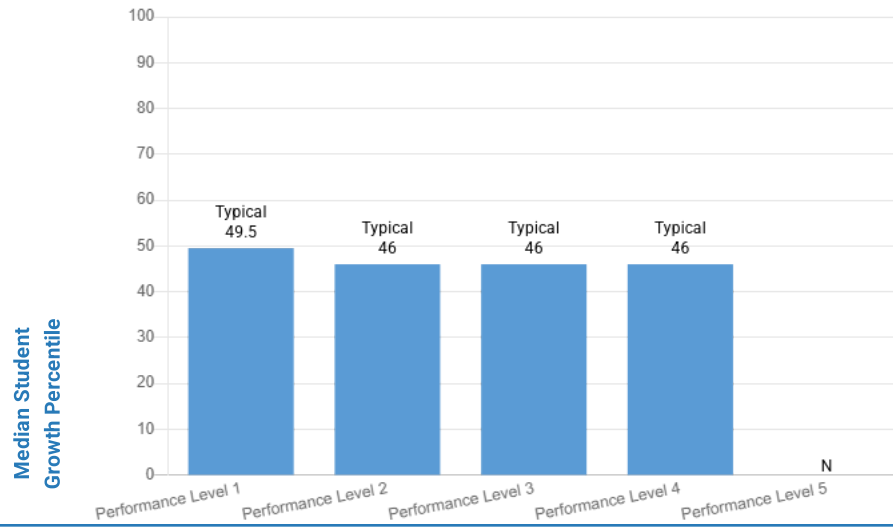

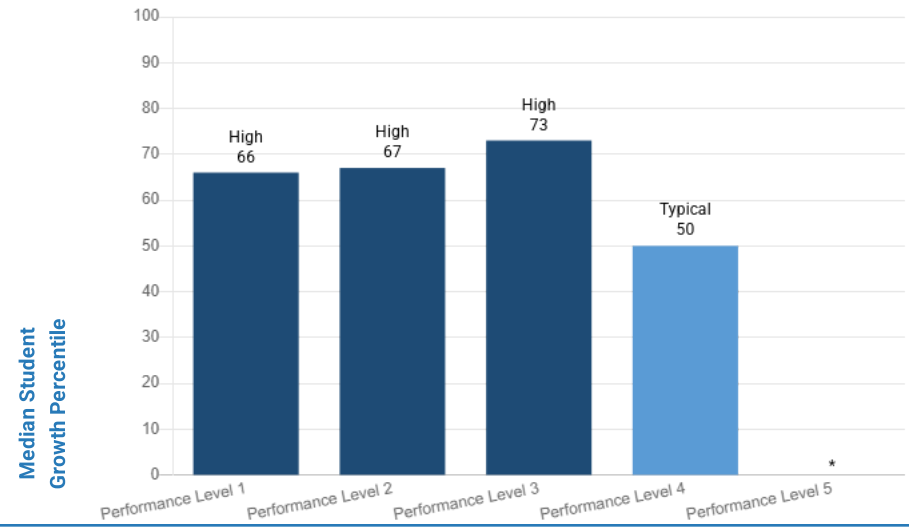

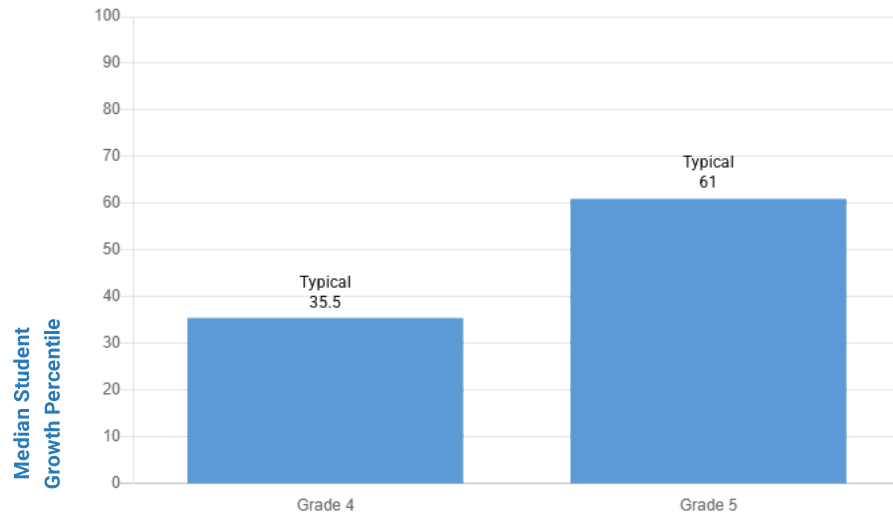

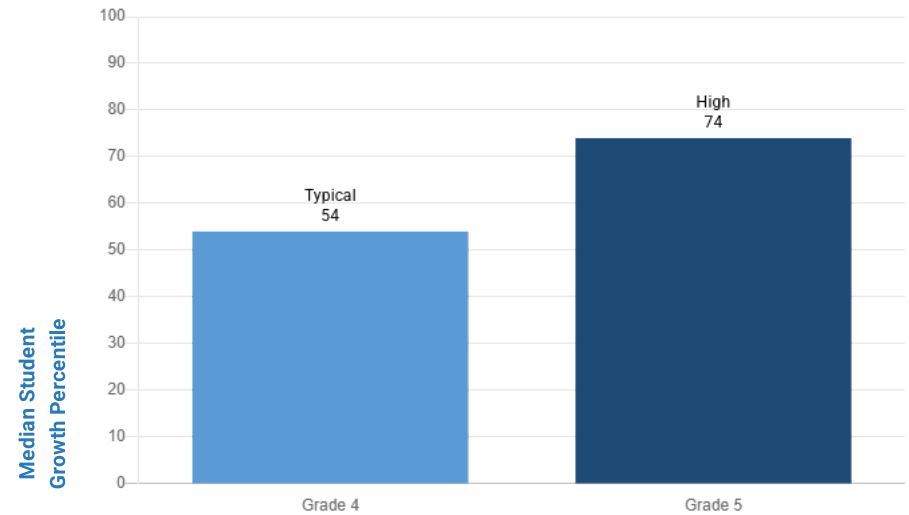

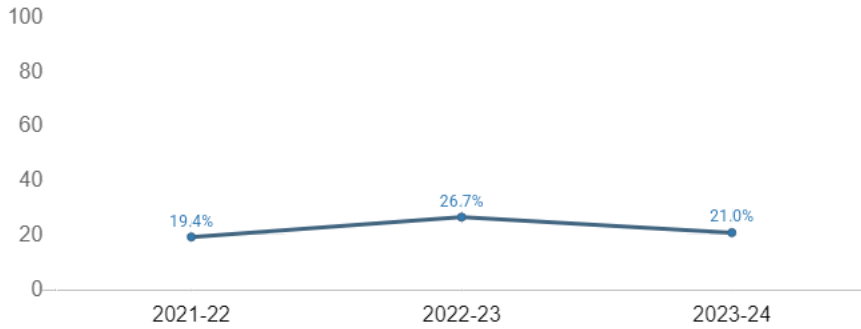

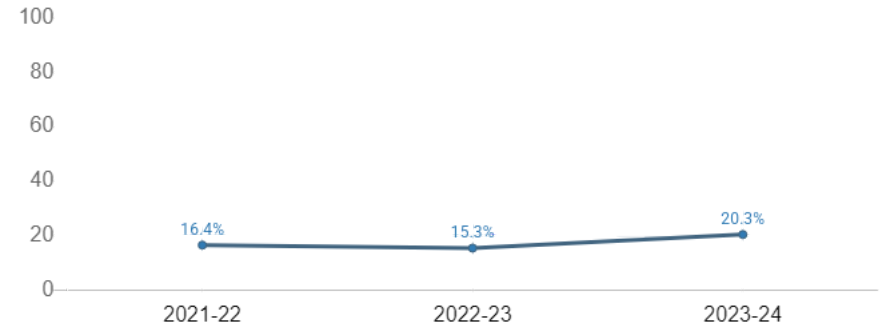
English Language Arts and Mathematics Performance Trends

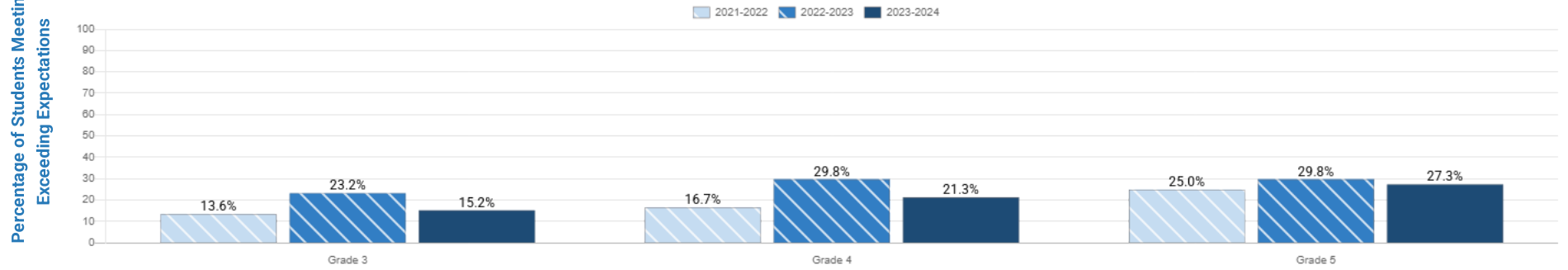

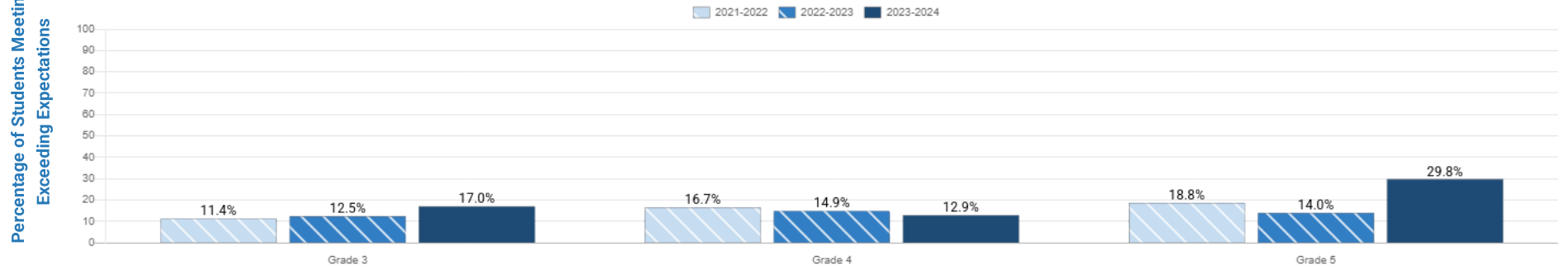

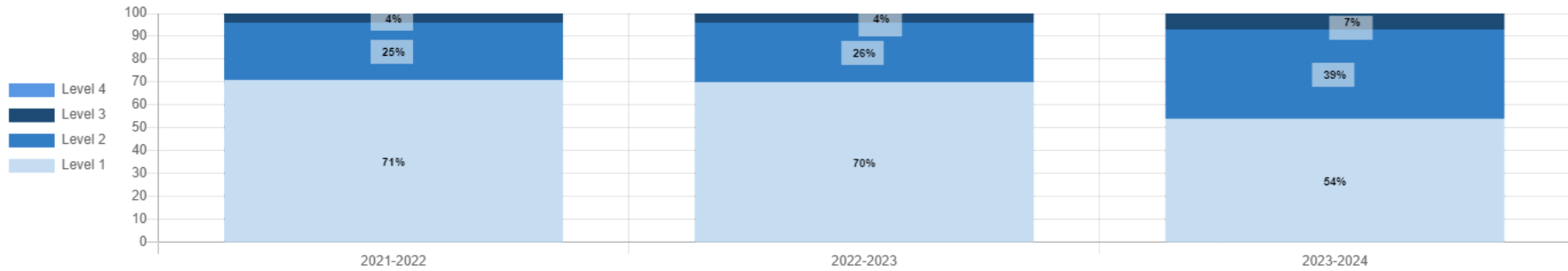

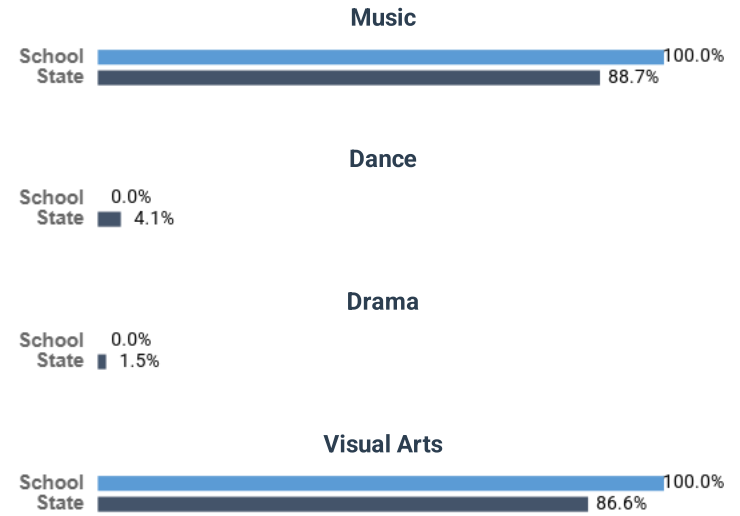

Students enrolled in one or more classes by discipline:



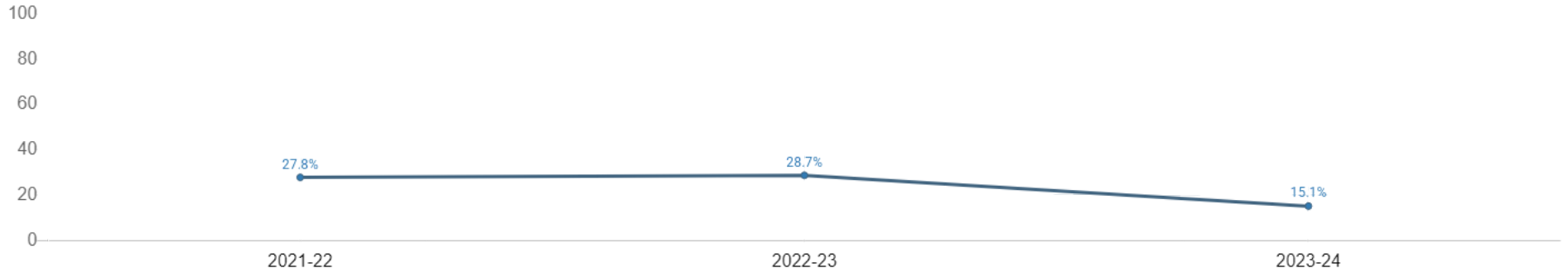

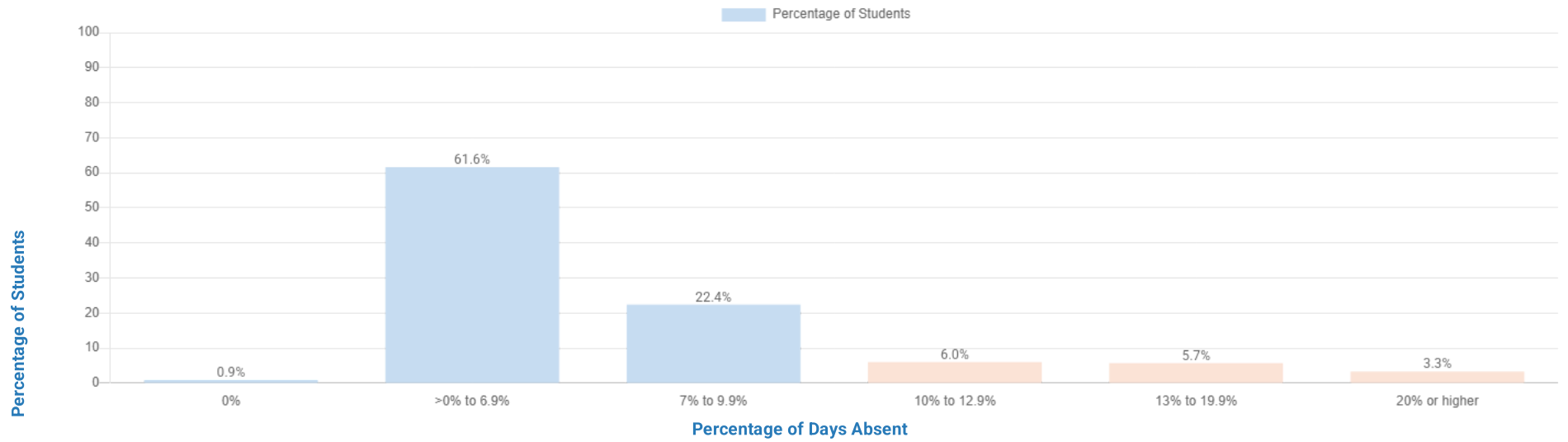

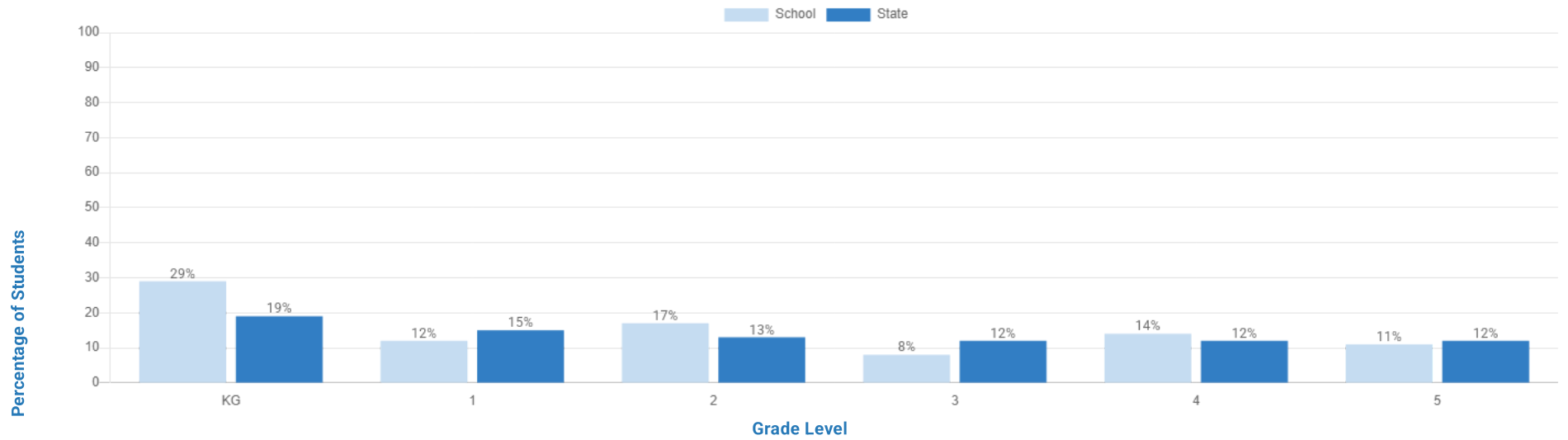

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

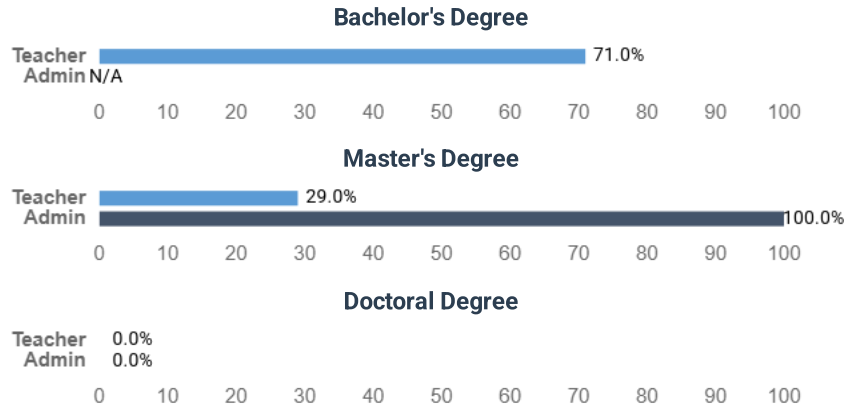

With a heavy focus on relationship building, STRE uses a variety of strategies to facilitate effective communication among teachers and students, including daily, schoolwide morning meetings to address social and emotional needs. A heavy emphasis is placed on community partnerships. STRE works closely with Town Hall, STR Police Department, Manitou Fire Department, and STR EMS, as well as local businesses. Students of the month are recognized monthly at Town Hall. Our First Responders and our PTO work together regularly throughout the year to support the many student/family events scheduled throughout the year.



Awards, Recognition, Accomplishments:

Poschl Awards Ceremony- Students are recognized for academic as well as special area achievements. "Students of the Month" (K-2) are recognized at Borough Hall by the Mayor and Town Council. STAR Students (3-5) are recognized each trimester for academic success in content and special subject areas. Positive behaviors are reinforced daily using "Soar Tickets." At the end of each week, two soar tickets are pulled from each classroom for weekly prizes through PBSIS. In addition, during each schoolwide event, earned collectively by our student body, several big prize items are gifted through a special Soar Ticket drawing. Prizes are supplied through PBSIS fundraising as well as family/community donations. Perfect Attendance Certificates are given out on a monthly basis.

Staff and Professional Learning:

Our staff continues to learn and implement a variety of motivating technology, curriculum content, and instructional strategies, beginning in the summer months and continuing throughout the year. The workshops enhance their proficiency and knowledge in enriching our learning environment and educational programs. Professional Learning Communities, by grade level, are scheduled regularly, providing horizontal articulation and collaboration.



Student Supports and Services:

Our Local Basic Skills Program supports struggling students in language arts. Our Title I Basic Skills Program delivers intense reading/phonics instruction to those students most in need. In Special Education our grade 2/3 and 4/5 LLD classrooms are supported through the Soliday System and Moby Max Programs. The iReady Math Program supports all students in meeting needs at each student's individual level. Our intervention team works together to find strategies to support students/teachers with higher level academic and behavioral needs. WINN (What I Need Now)- focus building foundational skills in number sense- 5 days per/week. Morning meeting 5 days per/week to support character education and social emotional learning.



Student Health and Wellness:

STRE is a Community Eligible Provision (CEP) School. All of our students are offered free breakfast/lunch on a daily basis.

The Mayor visits our school several times a year as well as recognizes "Students of the Month" at Town Hall. Our Staff and PTO hosted our winter holiday event. Our school and community participated in Vest-A -Cop fundraising for our STR PD. STRE staff offered after school Title I family programs for reading and Social/Emotional learning. The South Toms River Police regularly participated in our fire and security drills, as well as working with individual classrooms through our "Connecting with Cops" Program. Ocean County Juvenile Services provides student mentors on a monthly basis. Our school based mentor program with our staff provided support to over 30 students throughout the grade levels. Fall Festival, Someone Special Dance, Book Fairs, and end of the year picnic/field day were special parent/community events.

School Safety:

South Toms River Elementary has a School Resource Officer on campus for the full duration of school hours. The main entrance has a security vestibule to ensure all visitors are safe. All visitors are cleared through "Raptor." Monthly fire and security drills are conducted following state procedures, with regular participation and guidance from the STR Police Department. Annual safety procedures are reviewed with all staff at the beginning of the school year and revisited as needed. South Toms River Elementary takes great pride in our strong working relationship with the South Toms River Police Department who participate in all of our fire/sevurity drills.



Technology and STEM:

The district continues to upgrade building access to the internet, cybersecurity protections, wifi, and access to shared computing devices utilizing the Google Suite with accounts for all staff and students. All schools participated in the Toms River Expo. Upgrades to the WAN backbone enable high speed 1 Gb connections to all locations and 10 Gb between two data centers, with resiliency from potential outages. Firewalls have been upgraded to provide improved cybersecurity.



Attendance:

During the 23-24 school year, STRE reduced chronic absenteeism significantly. This was part of the Toms River Regional "I Show Up, I Count," initiative. Our Attendance Committee met regularly strategizing to raise awareness while our PBSIS Team worked on creating a fun, loving environment. Monthly perfect attendance certificates were given out. Group perfect attendance pictures were on display in the hallway for each month.
