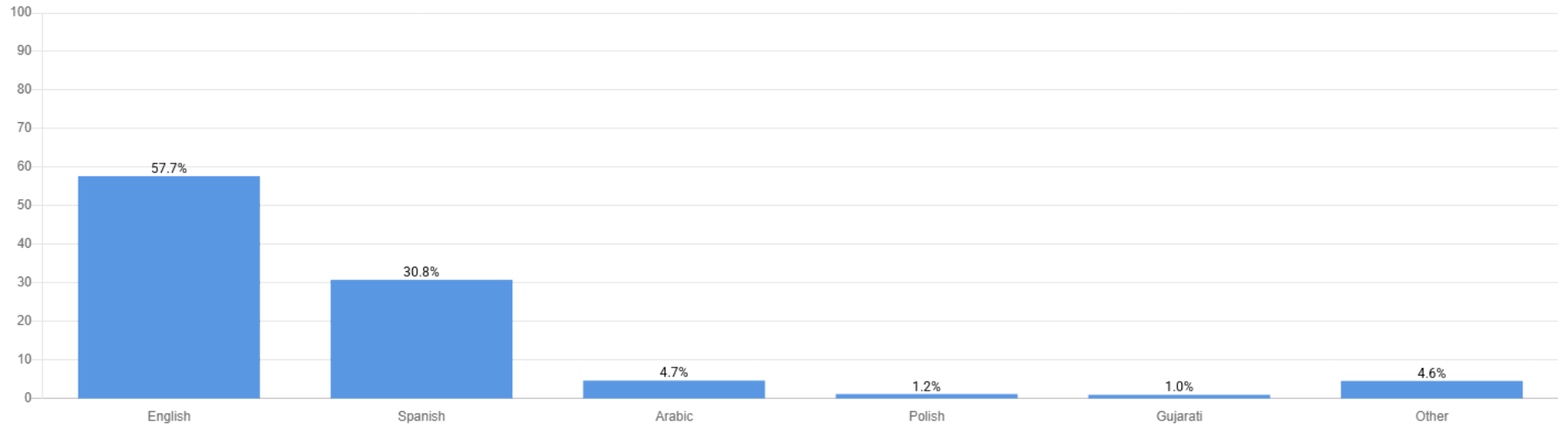

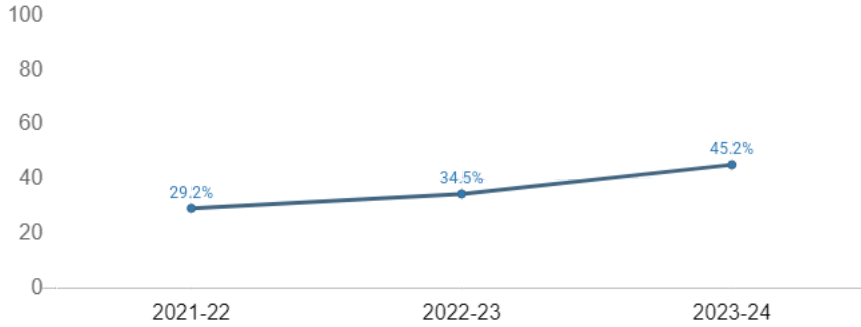

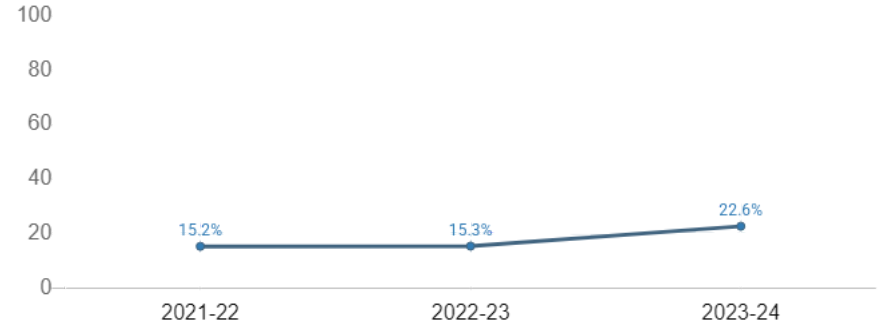
### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 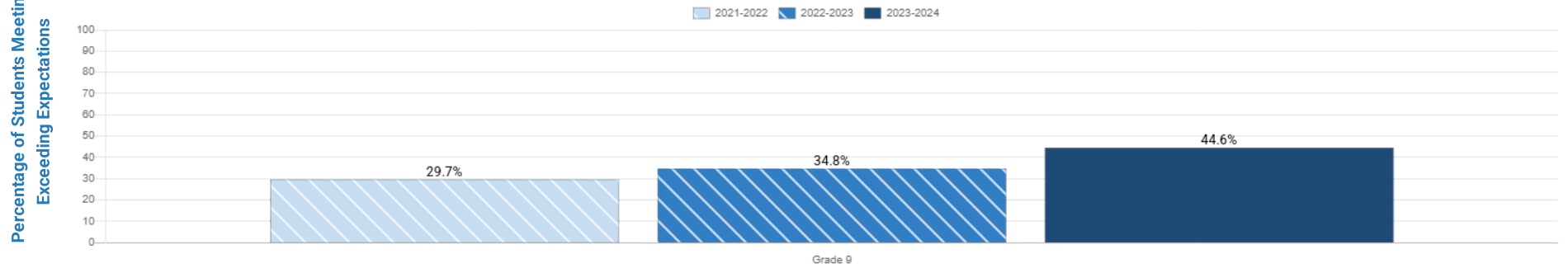

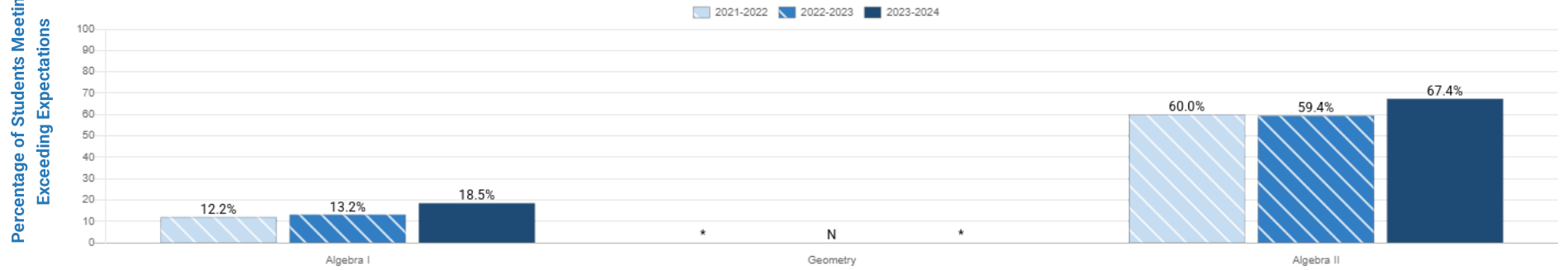

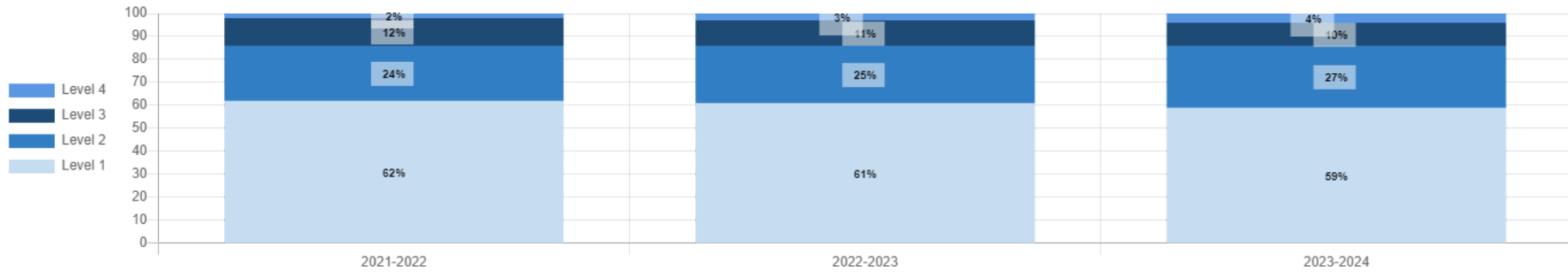

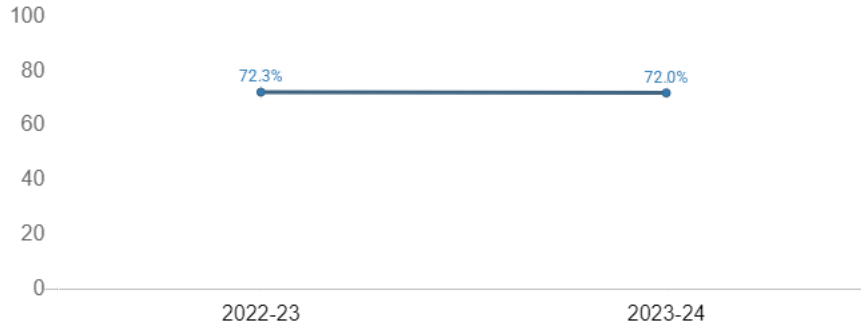

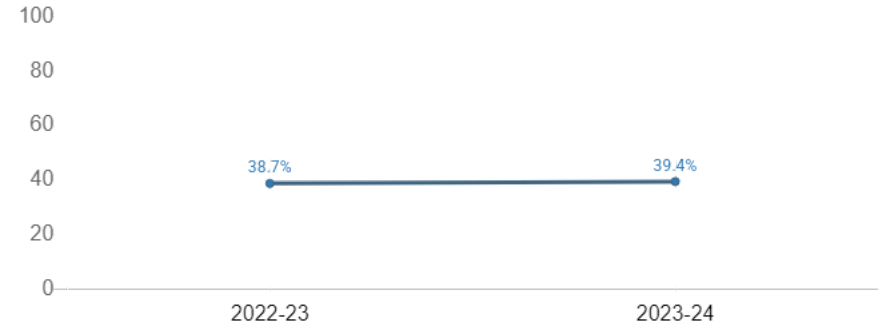

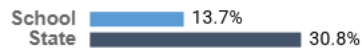

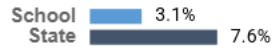

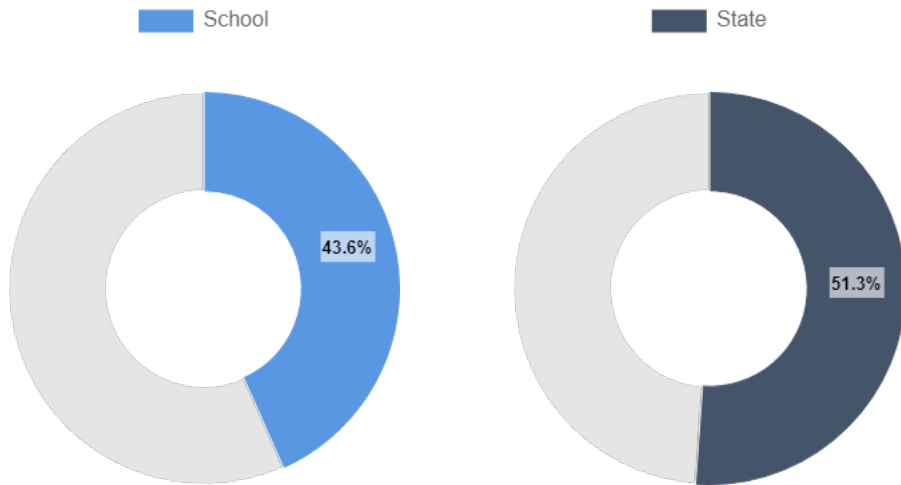

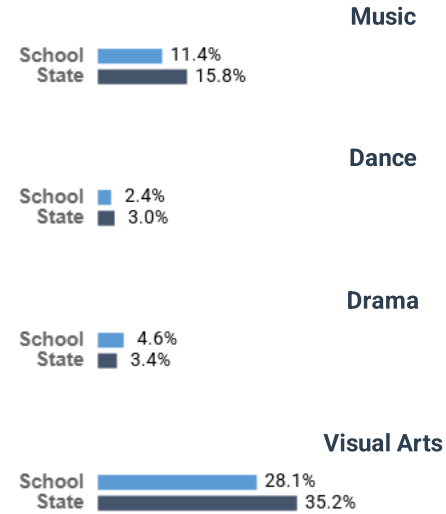

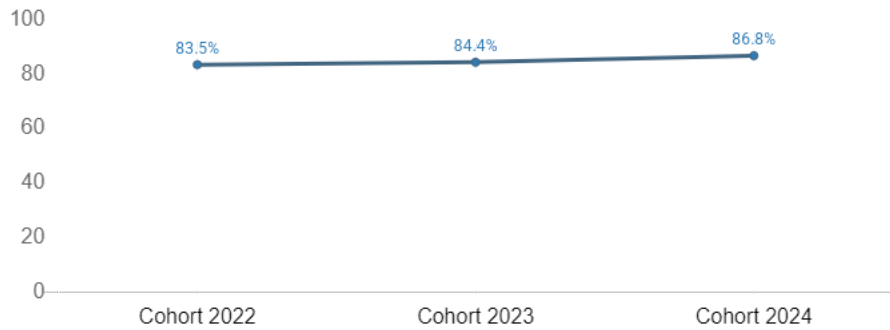

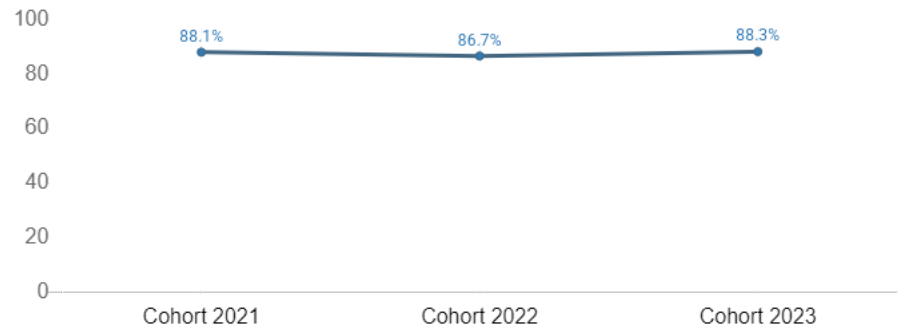

## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

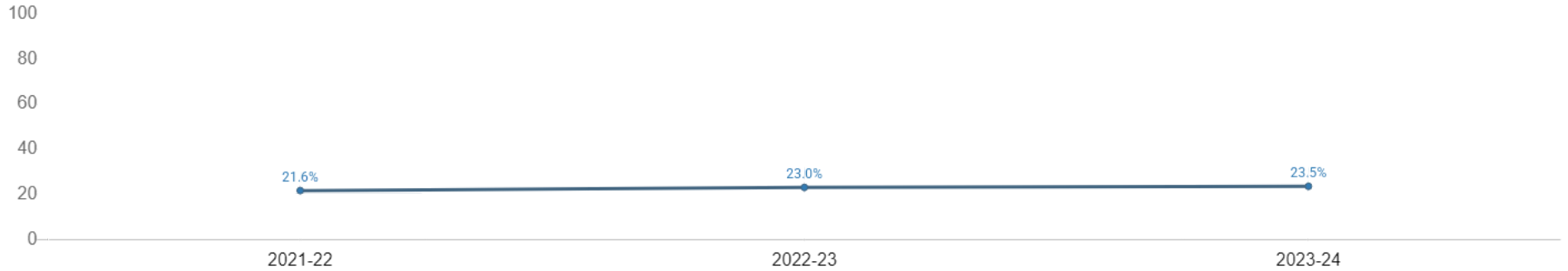

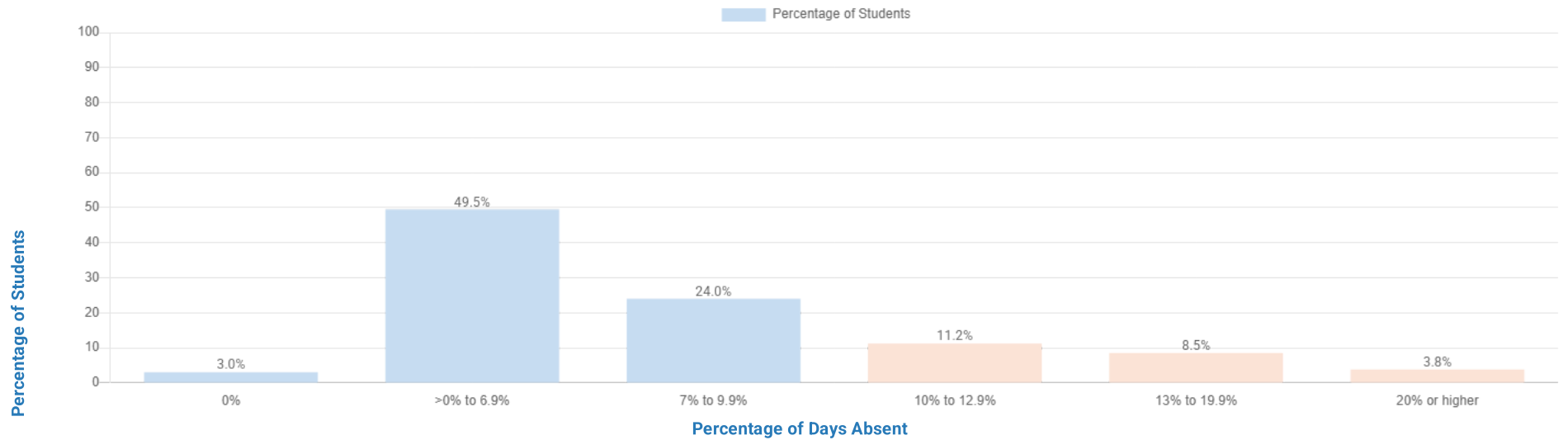

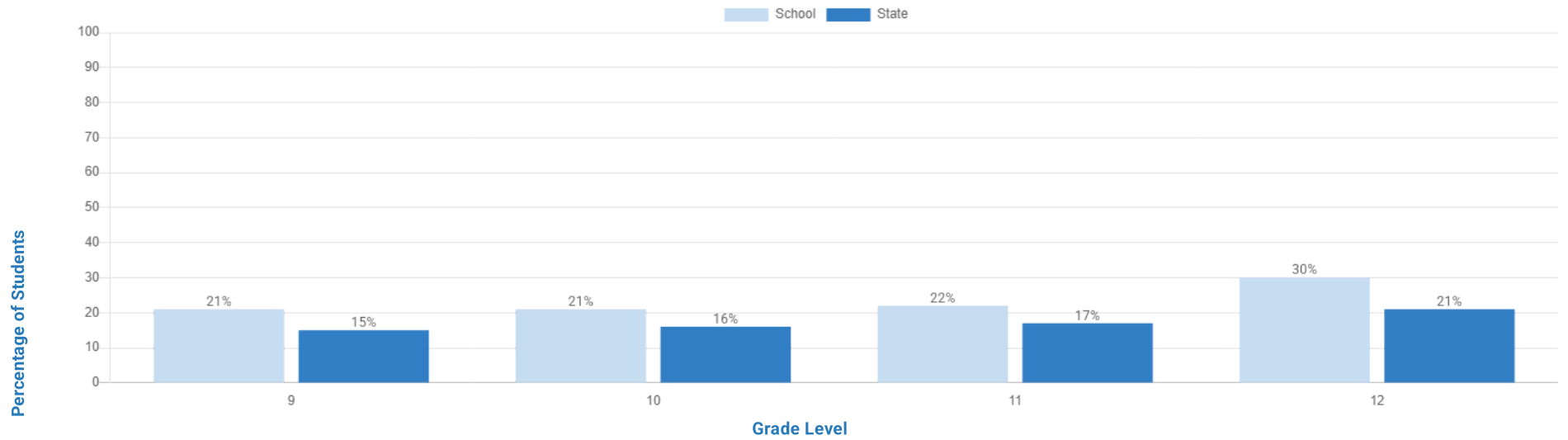

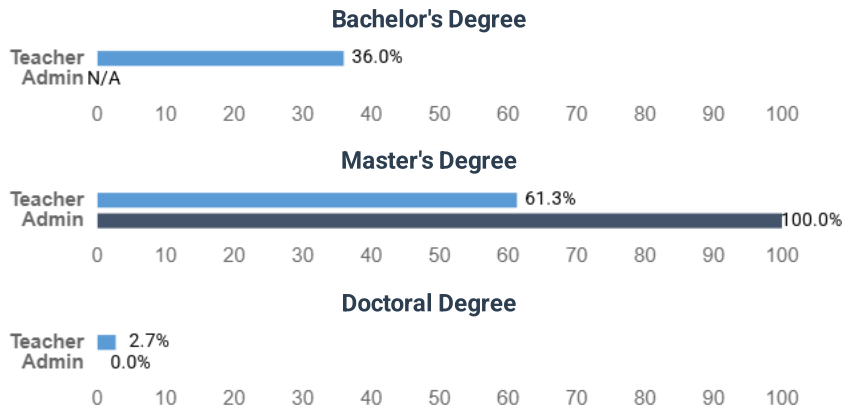

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. ### Mission, Vision, Theme:

Clifton High School is a comprehensive high school accredited by the New Jersey Department of Education, the Quality Single Accountability Continuum, and the Middle States Association. The comprehensive curriculum offers students courses in the curricular areas of college preparatory, occupation/career training and in cooperative work-study programs. Our mission is to develop lifelong learners who can make positive contributions to school, community, and society.



### Awards, Recognition, Accomplishments:

Of our graduates, 80% pursue post-secondary college programs. While in high school, students may complete courses through Montclair State University, William Paterson University, Fairleigh Dickinson University, Felician University, Bergen Community College, and Passaic County Community College. Other students are enrolled in concurrent college credit courses, internships, and co-operative education. The Passaic County Community College and William Paterson University Dual Enrollment programs have students who attend college full time earning 30 college credits, respectively, towards their high school graduation requirements. The Bergen Community College and Passaic County Community College Early College Programs offer students the opportunity to complete an Associate's degree so that as seniors they graduate with the degree and their high school diploma.



### Courses, Curriculum, Instruction:

Clifton High School currently offers 17 AP courses and 20 Honors courses. Basic skills classes in Math and Language Arts and ESL classes are available for students who need additional assistance. Our STEM program is continually expanding with more courses and learning opportunities. Technology is integrated across all curricular areas. The Freshman Mustang Academy incorporates a teaming model of instruction for all 9th graders providing a more intimate learning environment. Clifton High School has also established 3 academies with 16 concentrations including Computer Science, Marketing, Human Services and Early Childhood, Law and Public Safety, Natural Sciences, Robotics Honors, Robotics, Engineering, Health Services, Band, Choir/Vocal, Dance, Drama, Orchestra, Studio Art and TV and Video Production.

Clifton High School participates in over 65 clubs and extracurricular activities that are geared toward ethnic, cultural, social, academic and community service. Many of the activities and extracurricular clubs are nationally accepted programs including the Key Club and several National Honors Societies in Academics, Dance, Science, Music, Art and Drama. In addition, several of the extracurricular activities, such as Academic Decathlon, Mock Trial, Robotics and E-Sports, travel and compete throughout the nation. The Marching Band, Concert Choir, MadCaps singers and Drama Club consistently receive state and national recognition for their exceptional performances. The activities and athletics offered appeal to all high school grade and interest levels and accommodate those from all backgrounds.



### Staff and Professional Learning:

Clifton Public Schools place a strong emphasis on professional learning communities. District wide professional development plans are informed by school level improvement committees (SciPs). Professional Learning Communities meet to deepen teacher understanding of topics such as using data to inform instruction, sharing best practices, evaluating students' progress, and examining content-based benchmarks. As a district, we encourage and support our staff to continue to be lifelong learners.

### Postsecondary Information:

Clifton offers many AP courses as well as part time and full time dual enrollment college programs with Montclair State University, William Paterson University, Fairleigh Dickinson University, Passaic County Community College, and an Associate's Degree option with Bergen Community College. The district offers PSAT testing to all 10th and 11th graders at no cost to students. 66.24% of graduates go onto 4 year colleges, 13% to 2 year colleges and 8% to other post-secondary schools. The class of 2023 earned \$4,668,569.00 in four year scholarships.



### Student Supports and Services:

CHS works in collaboration with the Rutgers University Boggs Center to implement the NJPBIS district wide initiative targeting a multi-tiered system of support for behavior, conduct, and social-emotional wellness that promotes equality for all students. Through multi-tiered systems of support, we create environments that promote safety and encourage success while achieving student goals. The Mustang Academy is a 9th grade program designed to promote positive student behaviors and increase student participation in school while helping them to develop strong personal standards. The pillars represent Responsibility, Respect, Acceptance and Success. Supporting positive behavior, reinforcing social skills, involving students at all levels of the school, equipping teachers with the skills to meet the needs of diverse learners, coordinating programs, and using multi-setting interventions are all examples of recommended practices for promoting a positive school climate.



### Student Health and Wellness:

The Health Education courses for the students of Clifton High School is based on developmentally sound research and accepted topical areas of concern. These concepts prepare students for leading healthy lifestyles. Core topics include the following: understanding social-emotional health and physical wellness, building positive relationships, safety and environment, sexuality, alcohol, tobacco, and other drugs, and life management skills taught at home and in school. The Physical Education courses for the students of CHS provides a necessary component by providing the student with a core of values, attitudes, and beliefs that will awaken and inspire a desire to continue the pursuit of healthy physical conditioning. Physical activity is essential for physical skill development, social-emotional skill development, physical fitness development, and health-related benefits. A well-developed program can improve a student's quality of life and have a positive impact on their wa

Clifton High School works closely with the Home School Association (HSA) to provide funding and opportunities to the students in our building. We meet regularly to discuss the happenings of the building and receive parent feedback and suggestions for improvements, as to the job that is being done. Fundraisers occur through the HSA throughout the school year in an effort to defray the costs of Project Graduation and provide funding for guest speakers, additional equipment and the extras that are requested by staff for their program.



### Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
