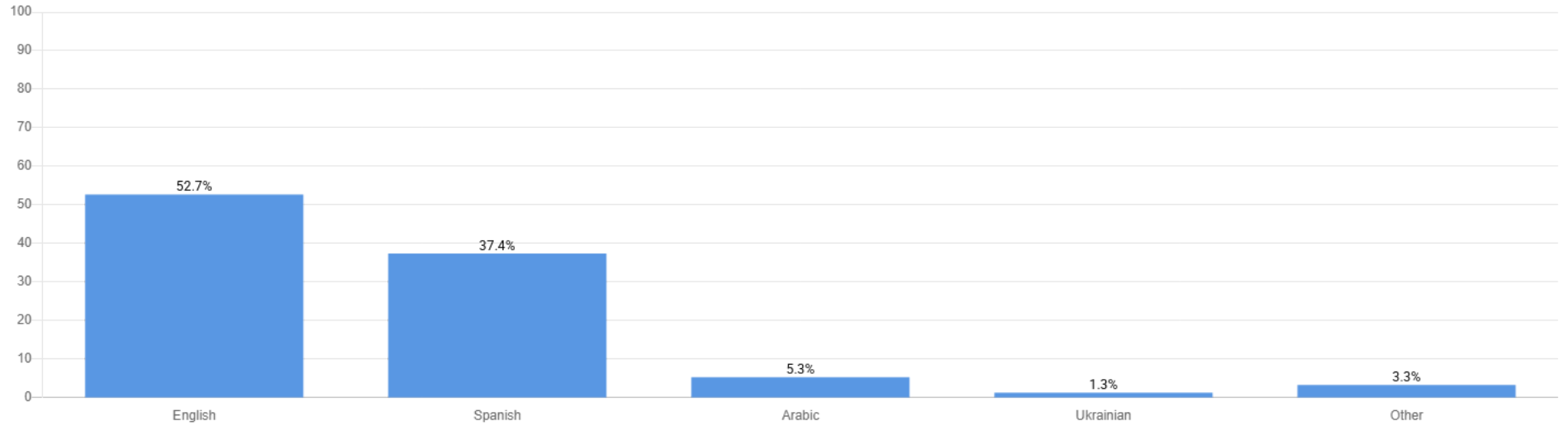

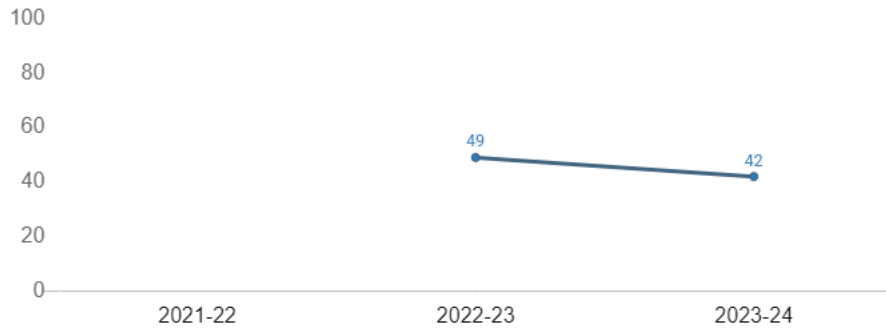

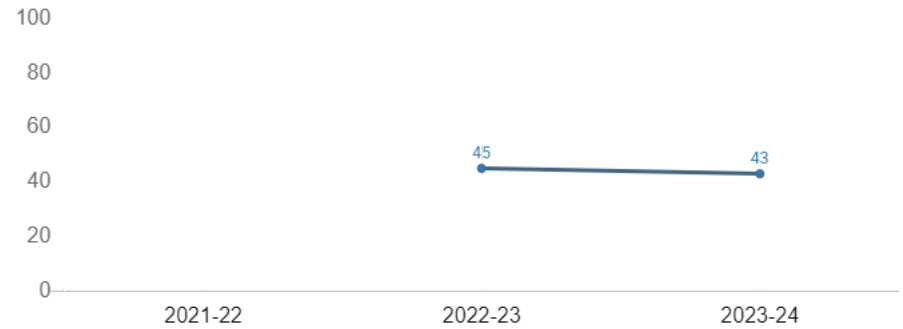

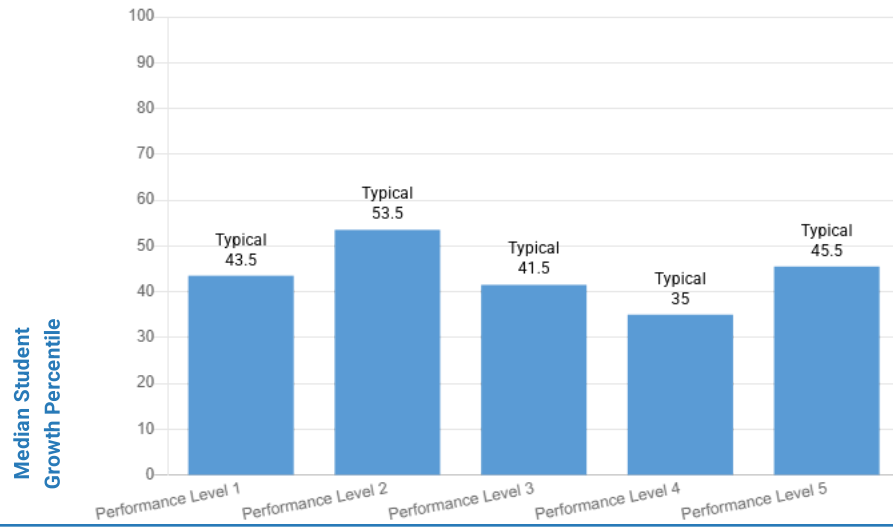

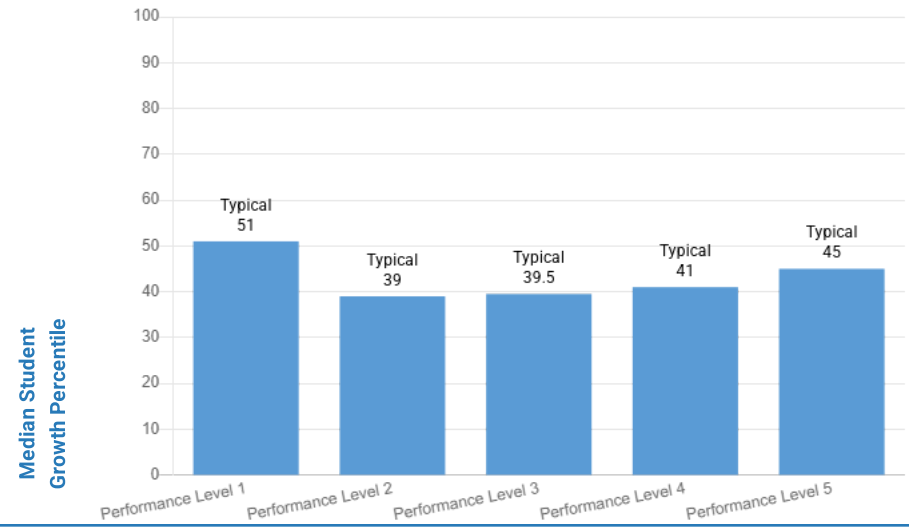

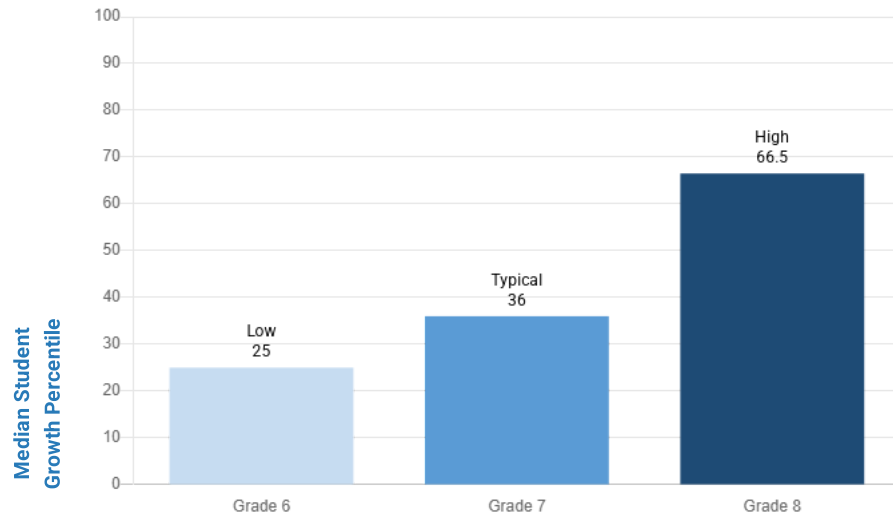

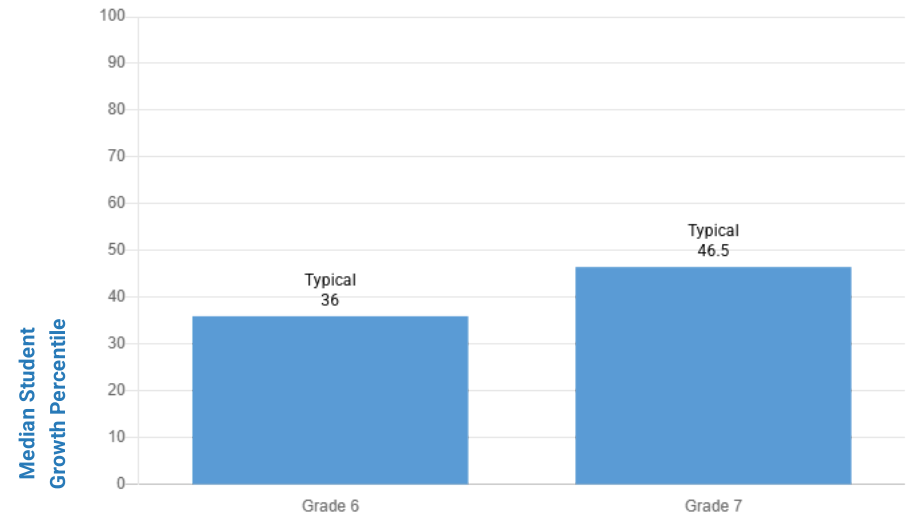

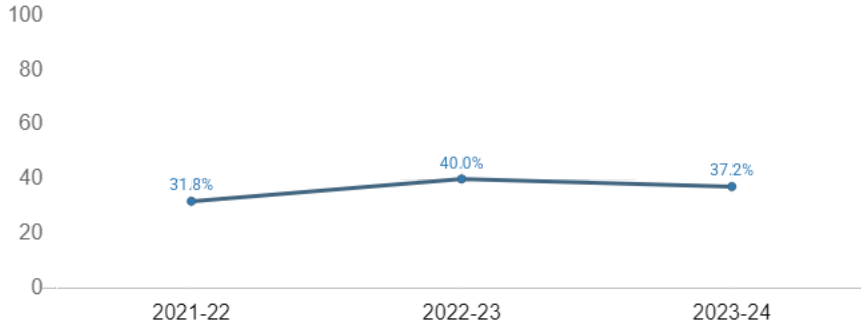

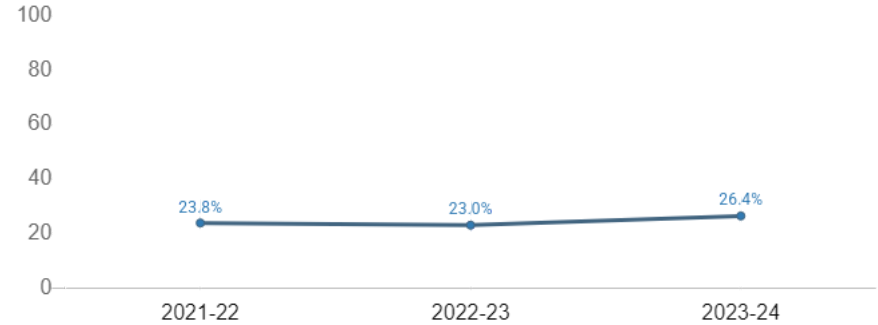
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 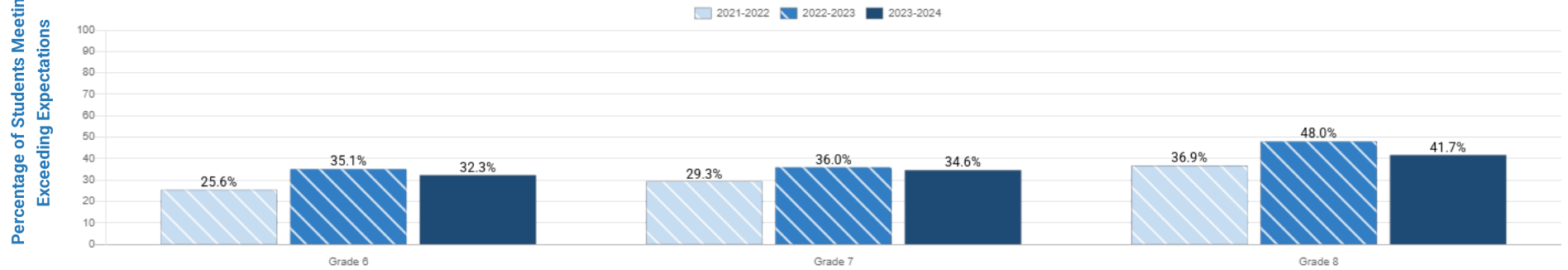

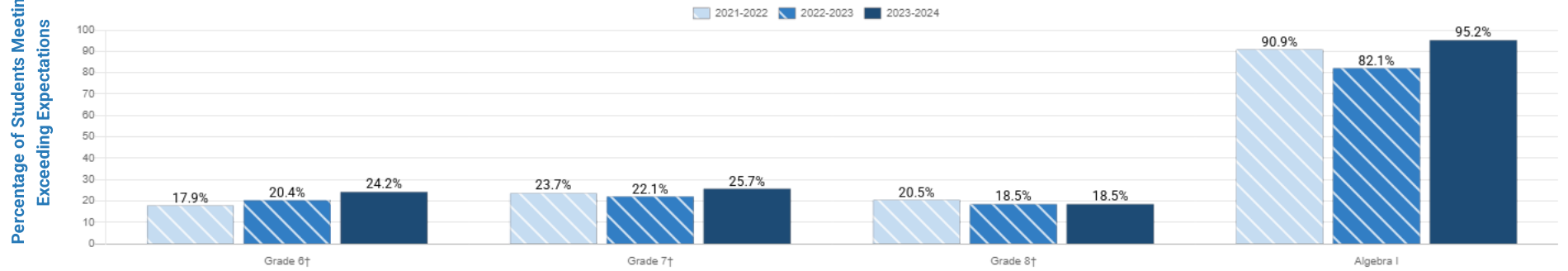

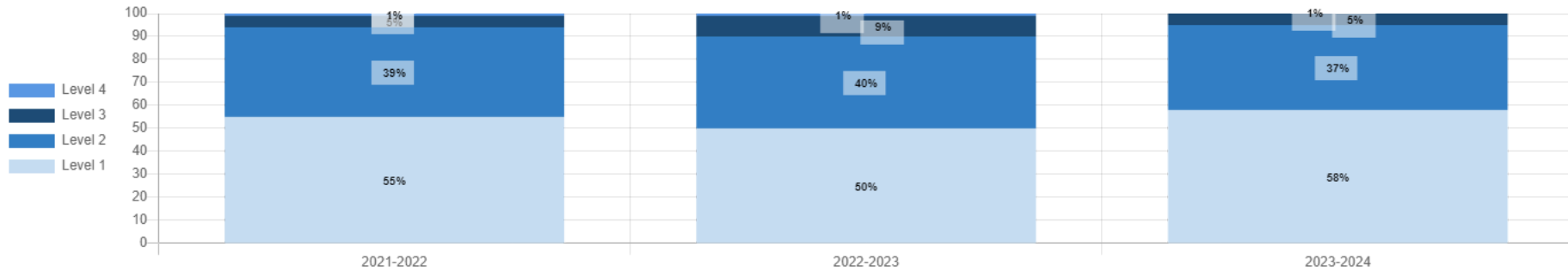

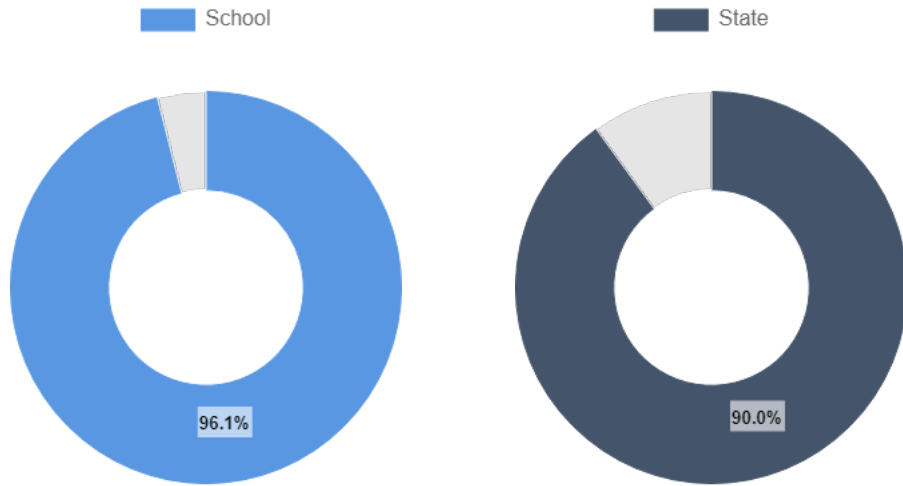

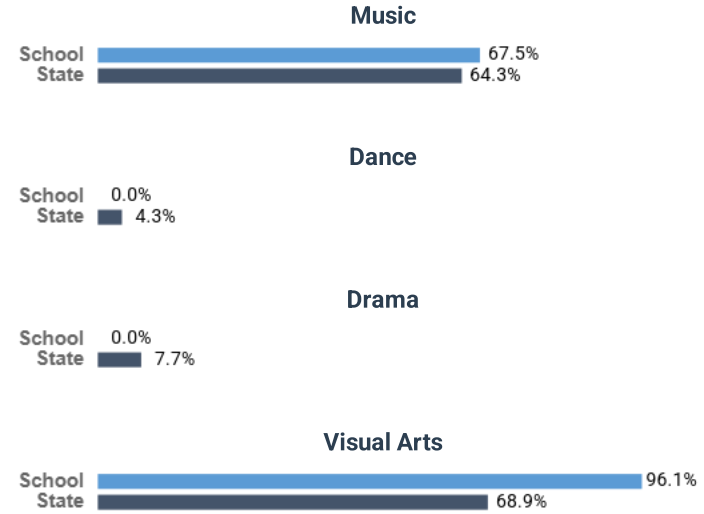

Students enrolled in one or more classes by discipline:



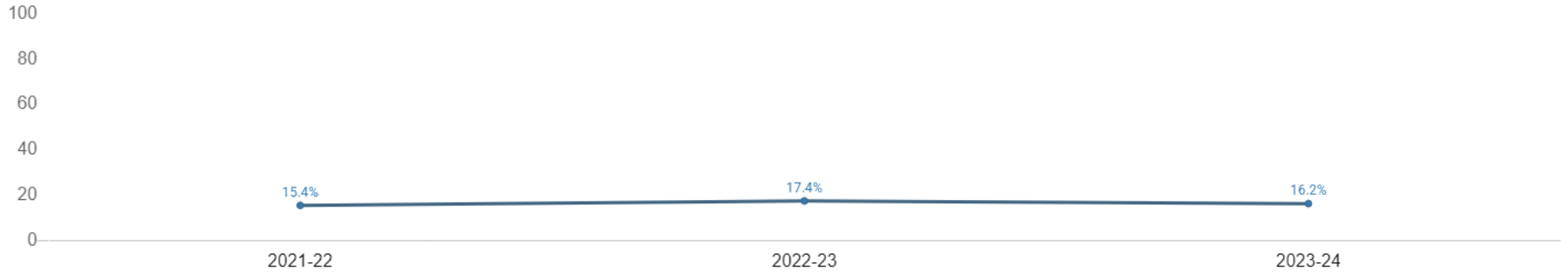

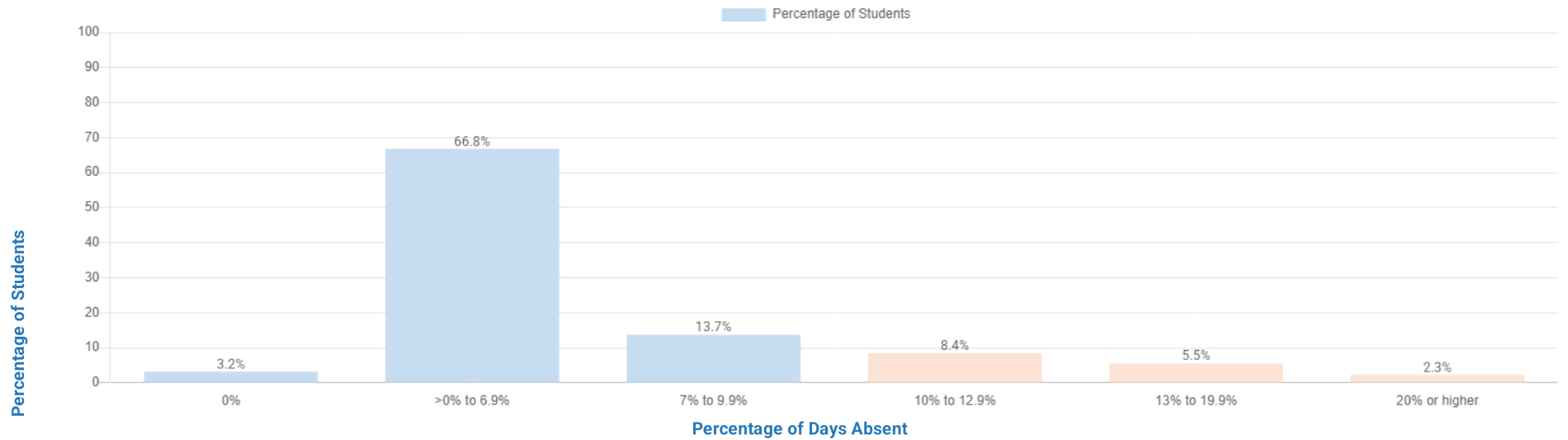

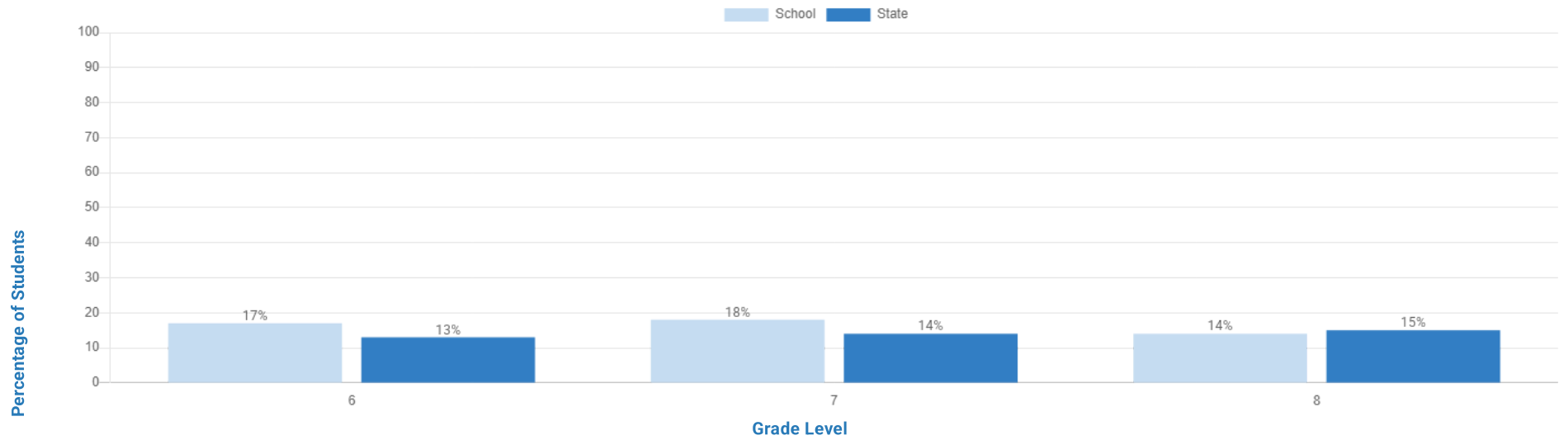

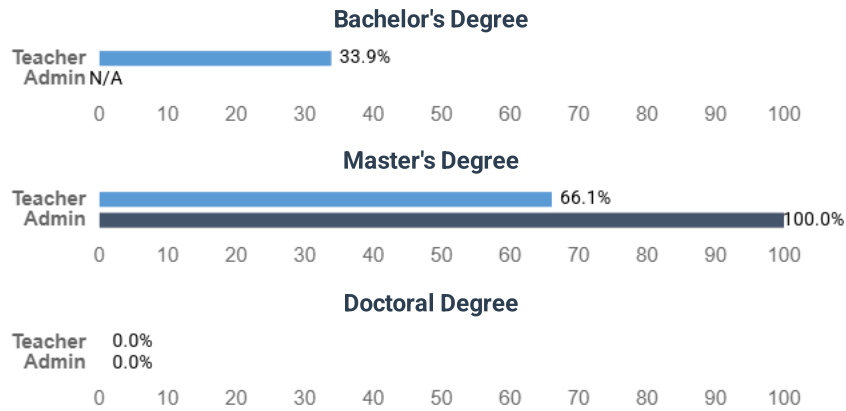

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. In partnership with families and community, our goal is to create relevant learning opportunities for all students - both inside and outside the classroom - that help them develop the knowledge, critical thinking skills, and character necessary to succeed in a technologically advanced world.



Awards, Recognition, Accomplishments:

Christopher Columbus Middle School is proud of our Positive Behavior Support in Schools Program known as CHAMPS. CHAMPS has been recognized by the State of NJ as a Showcase School for 3 consecutive years.



Courses, Curriculum, Instruction:

Programs include academic courses of integrated Language and Literacy, Math, Social Studies, Science and PE/Health supplemented with music, art, world language and technology. Technology is infused into all disciplines to support interactive learning. Each CCMS student has a district provided Chromebook while each classroom has interactive boards and document cameras to facilitate learning. Morning programs have been established for Music and Art. Approximately sixty after school clubs and activities are offered to students throughout the year. Students are supported in the areas of Social Emotional Learning by providing character education lessons and group as well as individual counseling for selected students. Additional learning opportunities are offered by an after school tutoring program and a summer academy. The summer academy is heavily infused with Technology and STEM curricula.

Interscholastic Basketball and Track are offered to students as well as several intramural clubs such as the dance team, volleyball, soccer, football, softball, basketball and track. Participation in organized school sports and intramurals offers students the opportunity to be physically active and has helped to improve students' self-esteem/psychological well-being by increasing their overall physical wellness. While school participation alone may not be sufficient to meet the current physical activity recommendations for adolescents, a solid foundation provided by physical education is important.



Clubs and Activities:

Christopher Columbus celebrates student leadership and success through programs such as the National Junior Honor Society, National Junior Art Society, Student Council, Student Orientation Club, Sidekicks, Student Worker's Club as well as our Positive Behavior Support in Schools Program, CHAMPS, which has been recognized by NJ as Showcase School. Additionally, over 60 before and after school clubs and activities exist that support formal and informal curricula. Extended morning programs are provided to support the arts as well as an After-School Program and Summer Academies which offer additional learning opportunities.



Staff and Professional Learning:

Professional Development plans are created district wide to support the needs of the appropriate content area. These plans are shared through Professional Learning Communities with an emphasis on data to drive instruction, share best practices by participating in lesson studies, create, review and examine content based benchmarks such as asking higher level questions, classroom management as well as many other areas. We continue to value our partnership with William Paterson University by working with a "Professor in Residence." It is important for our staff to continue to be lifelong learners.

Student Supports and Services:

With the help of our universal team, our CHAMPS program has been instrumental in highlighting, reviewing and communicating school wide expectations for our school. These expectations have facilitated the creation of a unified school culture. Students who follow school expectations receive a CHAMPS ticket with praise and the potential of other rewards through weekly drawings. CCMS has been part of the NJPBSIS initiative to implement a multi-tiered system of support for behavior, conduct and social emotional wellness that helps to create environments that encourage success. For the last 2 years the issue of chronic absenteeism has been closely monitored as a secondary tier. With the help of a subcommittee of our universal team, clear procedures were written and followed to target this specific behavior. This year, the secondary tier continues to be explored by targeting specific students who need the additional support in conjunction with the I&RS committee.



Student Health and Wellness:

Students are exposed to concepts related to the promotion of good health and disease prevention to enhance overall student health and wellness. Units of study include the topics of family, peers, culture, media and technology, as well as the skills associated with accessing valid information and products to make informed decisions. Additionally, students are taught to use their interpersonal skills to promote health and wellness by avoiding and reducing health risks by practicing good decision making and goal setting skills.



Parent and Community Involvement:

Our Home and School Association is an active organization of parents and teachers who support student activities throughout the school year. The Home and School works diligently to provide safe learning opportunities where all students feel welcome and supported. Additionally, there are many programs such as math, literacy and diversity nights whose purpose is to bring the parent, student and school together. CCMS also provides many programs through our Parent University to introduce parents to topics such as internet, gang and drug awareness as well as other relevant topics for middle school students and parents.

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
