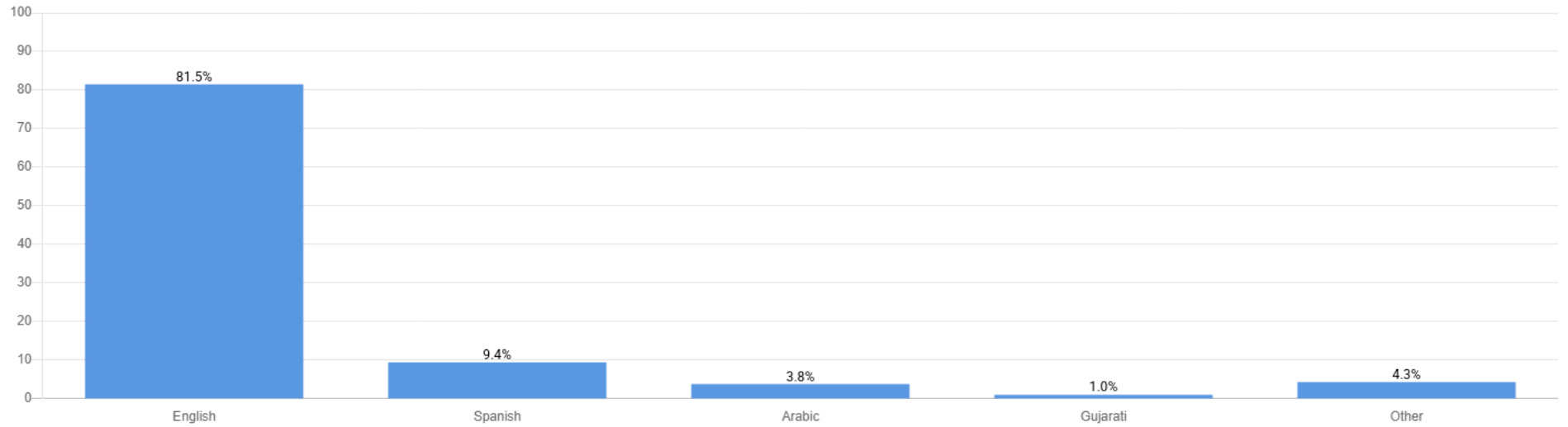

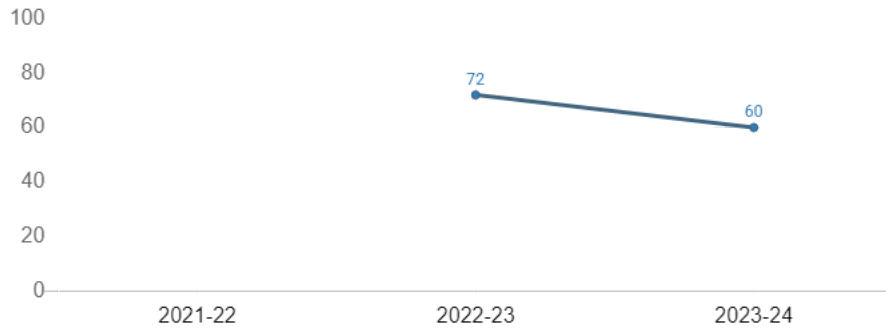

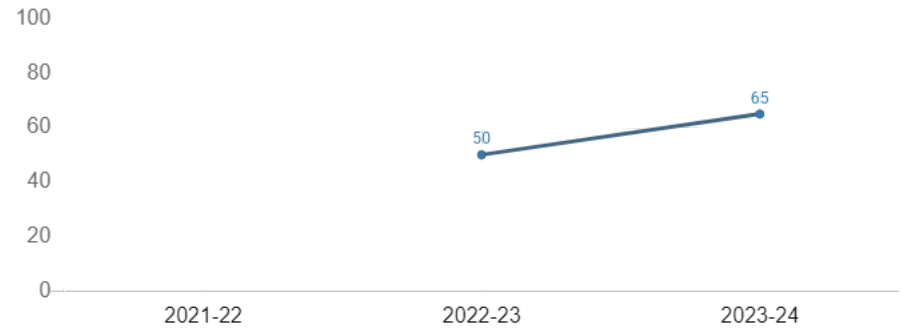

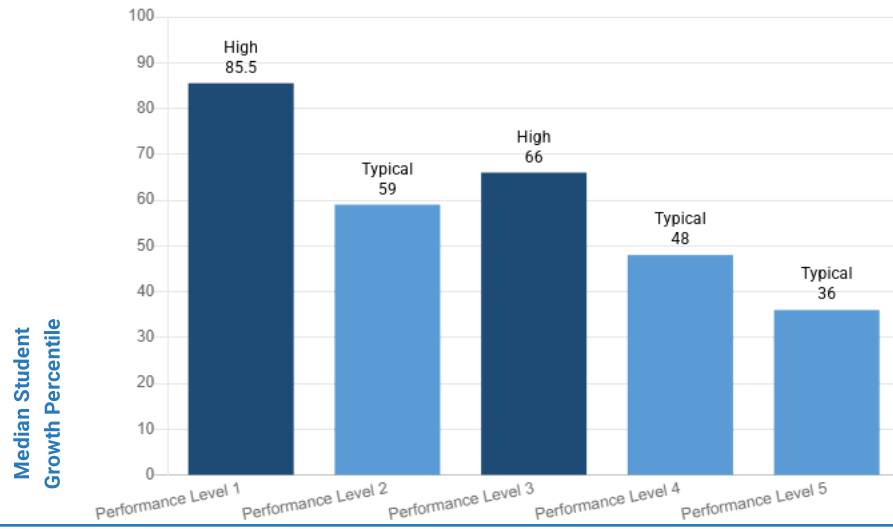

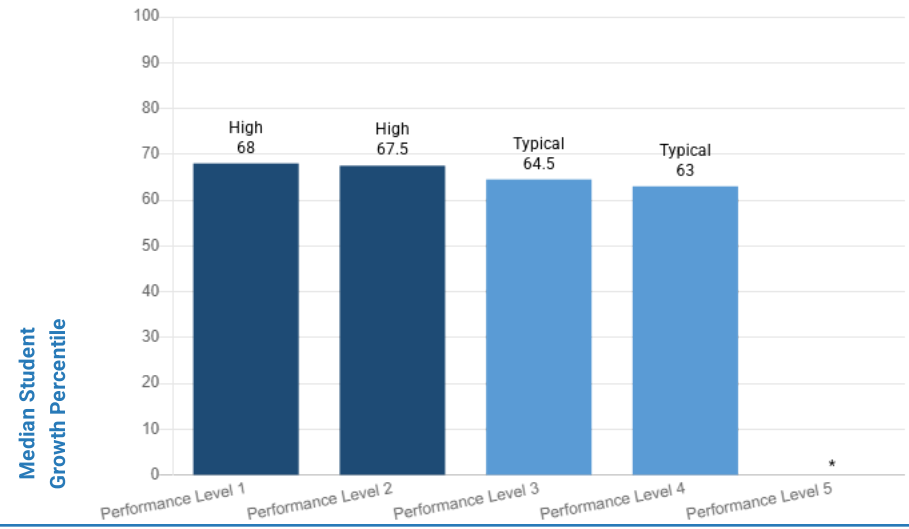

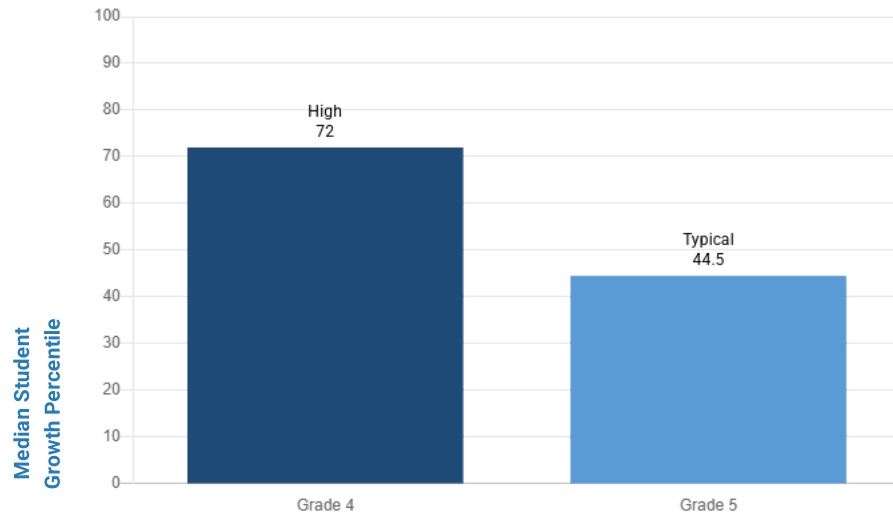

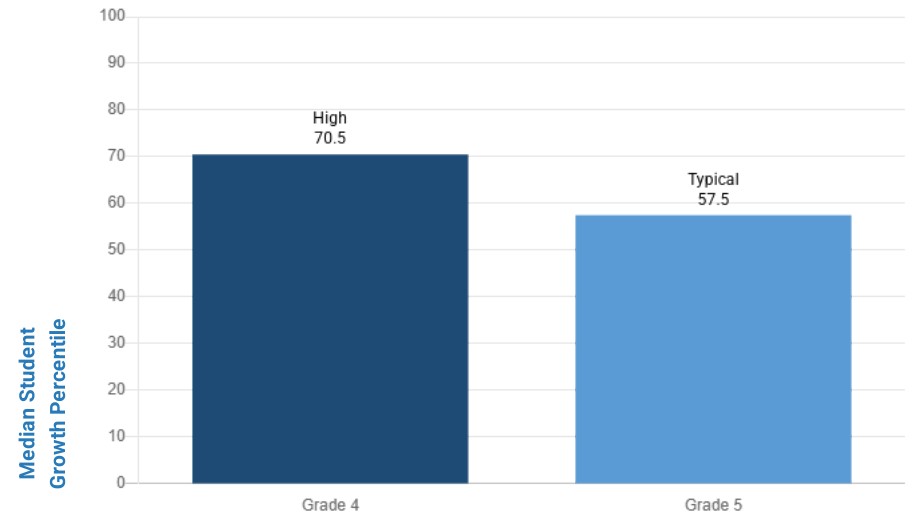

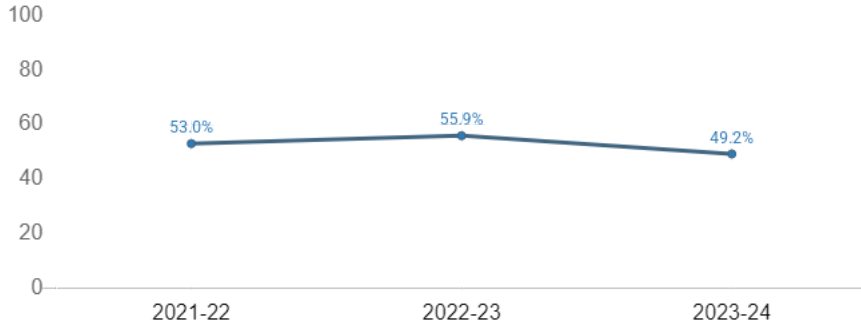

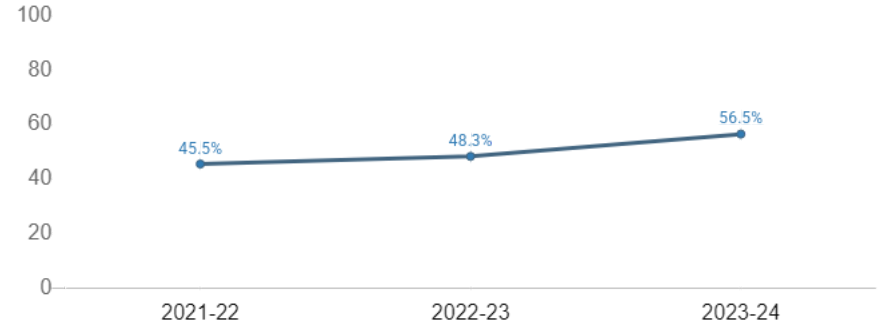
English Language Arts and Mathematics Performance Trends

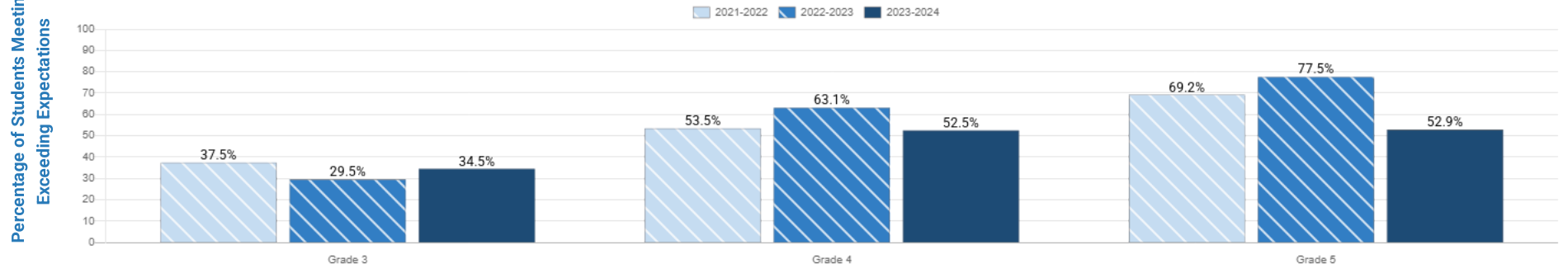

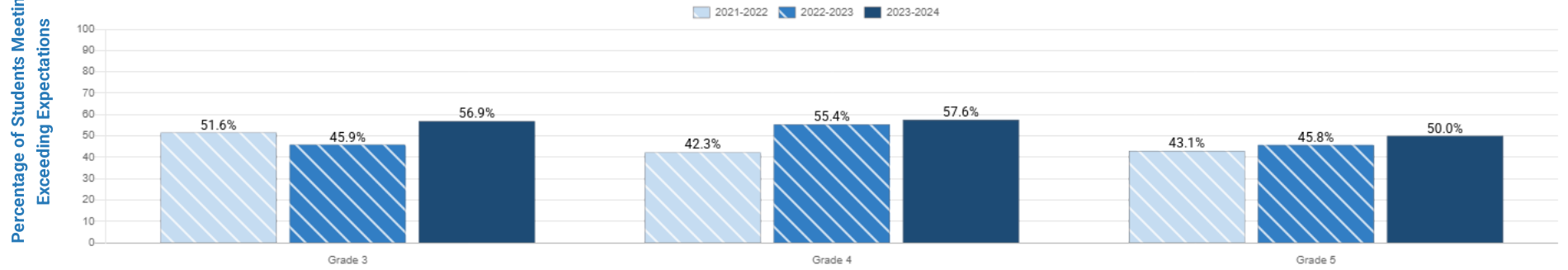

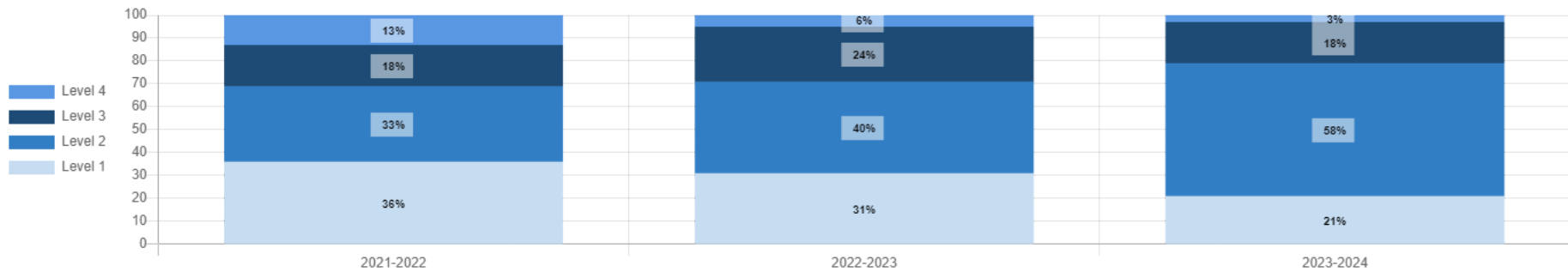

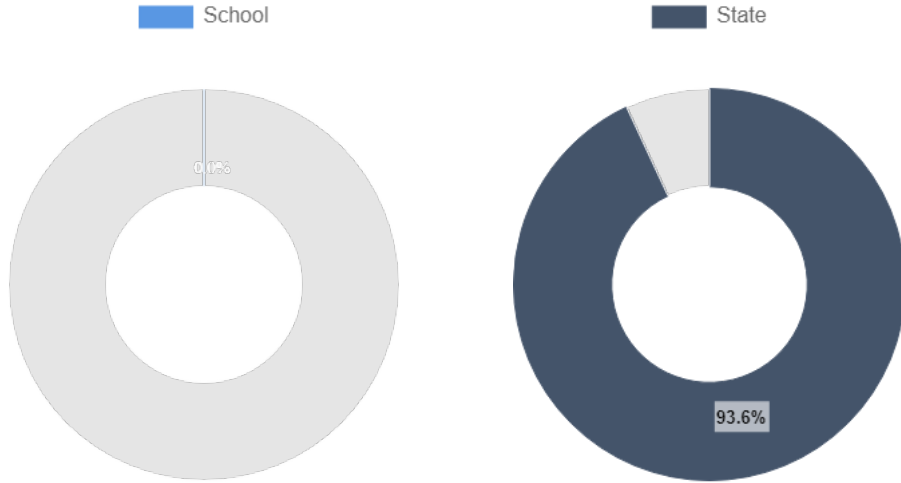

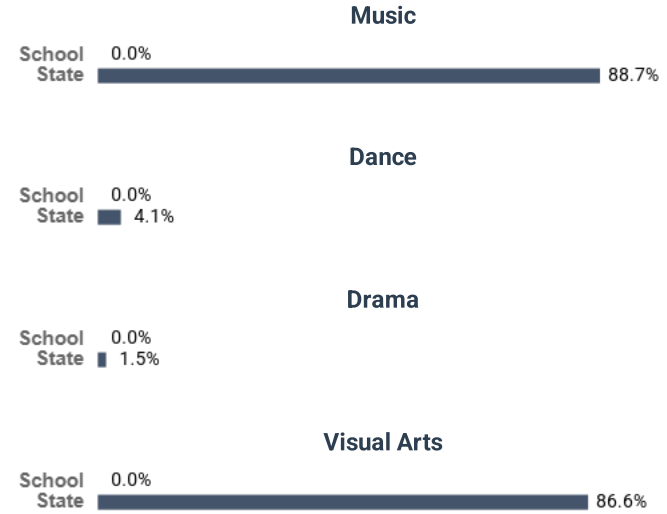

Students enrolled in one or more classes by discipline:



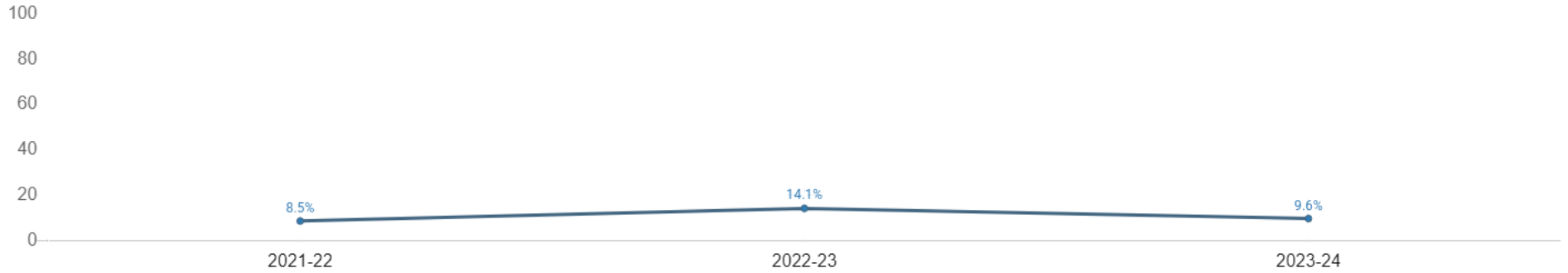

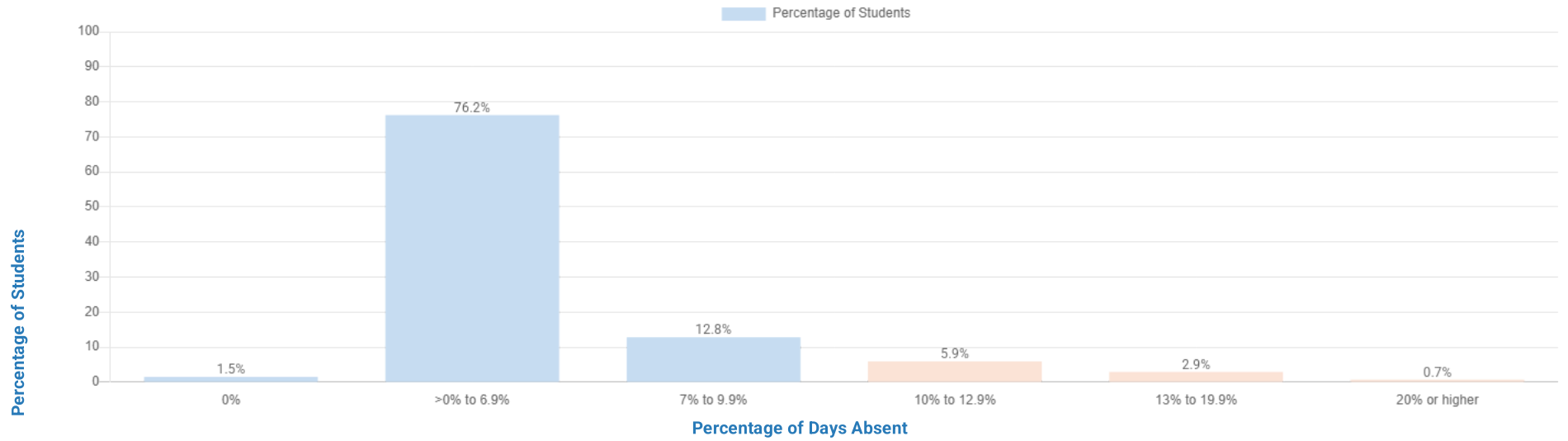

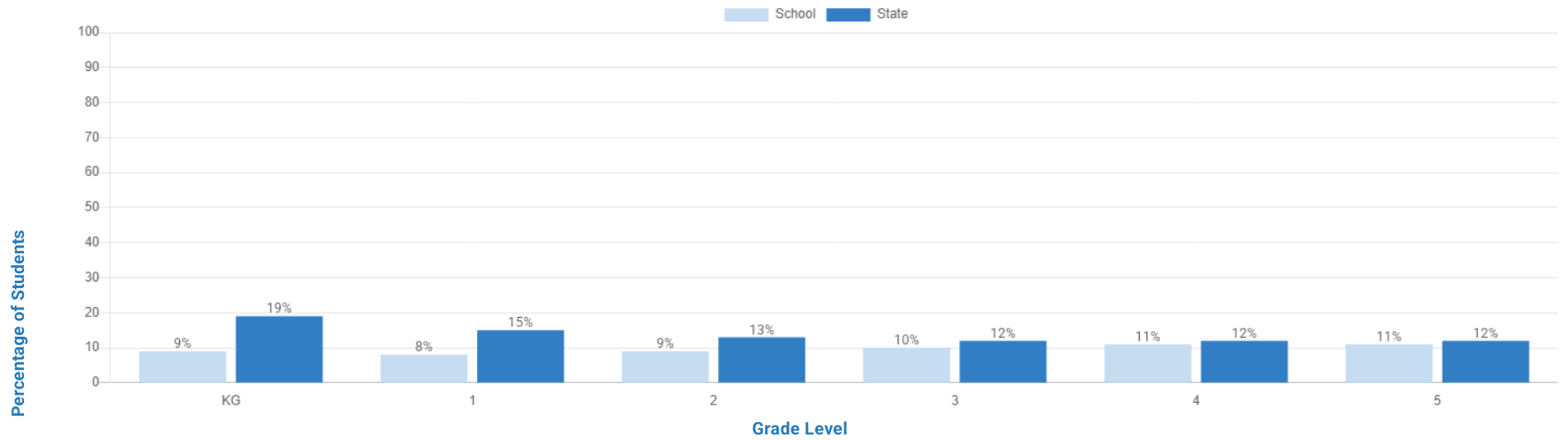

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. 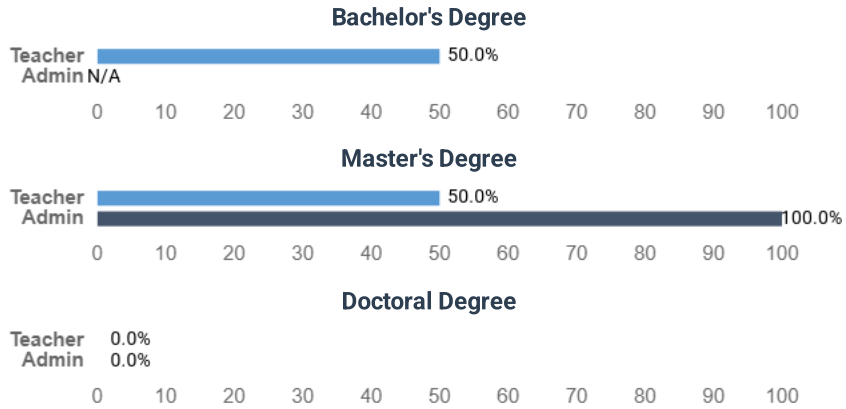

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Teachers implement the enVisions Math Program, a rigorous research-based mathematics curriculum that infuses hands-on activities with inquiry based teaching, small group cooperative learning, and is differentiated for student needs. Additionally, we implement adaptive mathematics web-based programs that align to each student's instructional level in order to enrich, reinforce or remediate their own mathematical understanding. School Two is a literacy-rich environment that nurtures a joyful community of readers. The leveled guided reading system is utilized in each K-2 classroom in an effort to meet students where they are in reading, and encourage them to become fluent readers. We also use Foundations, a multisensory and systematic phonics, spelling and handwriting program to help develop the foundational reading skills for all kindergarten through grade three students.

Sports and Athletics:

Participation in recess and physical education, along with extracurricular activities provided by the Clifton Recreation Center and the Boys and Girls Club, offers opportunities for students in grades K-5 to be physically active. This helps improve students' self-esteem/psychological well-being as well as increase their overall level of physical wellness. Students demonstrate competency in a variety of motor skills and movement patterns to achieve and maintain a healthy level of physical activity and fitness. This allows our K-5 students to recognize the value of physical activity for health, enjoyment and self-expression.



Clubs and Activities:

Our school promotes a love and appreciation of the arts by providing instrumental music (band/strings), vocal music, and visual art opportunities throughout each school day. The breakdown includes the following: a standalone art class all K-5 students receive for 30 minutes once a week, a standalone vocal/general music class of 30 minutes once a week, and instrumental strings/band and chorus rehearsals for any 4th and 5th graders interested, that takes place once a week for 30 minutes. Lastly, theater is embedded in the language arts curriculum and dance is embedded in the physical education curriculum which all K-5 students receive.



Before and After School Programs:

School Two provides both a before and after school day care program in conjunction with the Boys and Girls Club of Clifton. Before care allows for parent drop off from 7:05 AM until the start of the school day at 8:50 AM. Their after school program provides child care from 3:20 PM until 6:00 PM.

Staff and Professional Learning:

Clifton Public Schools have a strong emphasis on Professional Learning Communities. District wide professional development plans are determined by school level improvement committees (SciPs). Professional Learning Communities meet to further each teacher's understanding of a variety of topics including analyzing data to inform instruction, sharing of best practices, assessing student work, and examining content-based benchmarks. All staff members are encouraged and supported as they implement new district initiatives.



Student Supports and Services:

School Two is actively collaborating with the Clifton School District to implement the PBSIS program, focusing on a multi-tiered system of support for behavior, conduct, and social-emotional wellness. PBSIS serves as a foundation for our Tier 1 and Tier 2 interventions, fostering a safe and supportive environment that encourages student success. Our dedicated staff works together to help students reach their goals, and this year, we proudly introduced our first district therapy dog, Chewie, to enhance student behavior plans, counseling, and emotional services. This initiative underscores our commitment to promoting holistic well-being within our school community.



Student Health and Wellness:

Students in grades K-5 are exposed to concepts related to good health and disease prevention to enhance overall health and wellness. These lessons on family, peers, culture, media and technology promote overall health and wellness. Students practice using interpersonal communication skills to enhance health and wellness and learn to reduce health risks by practicing good decision making and goal-setting skills.

Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
