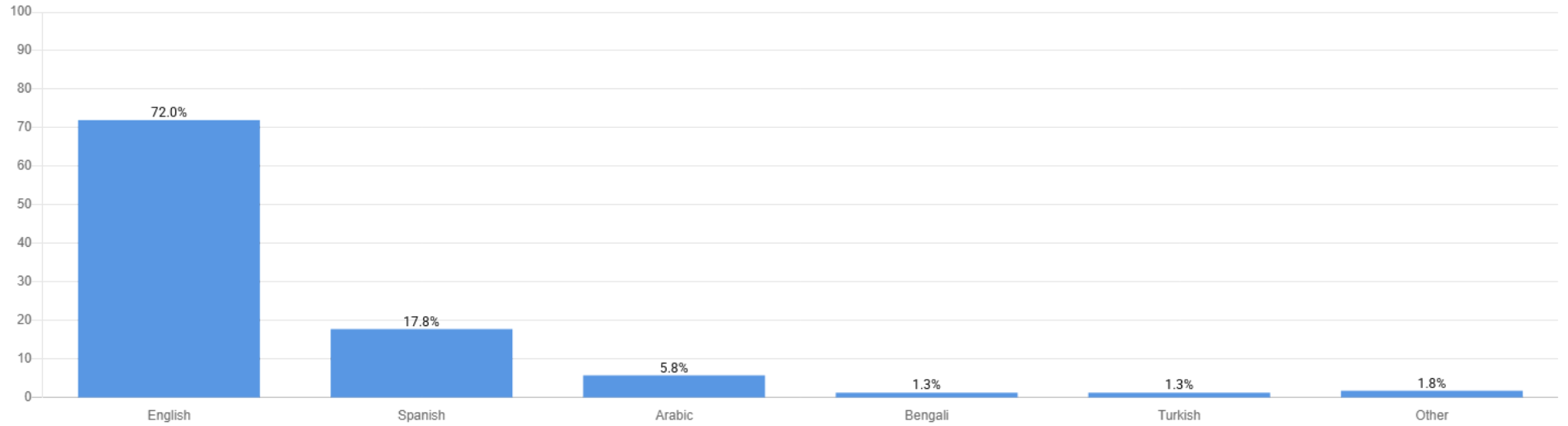

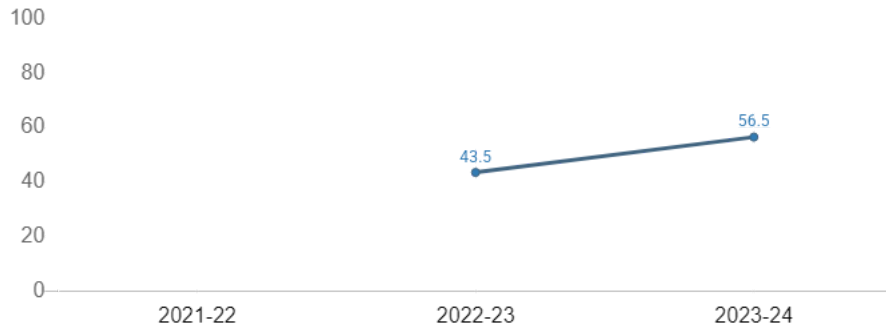

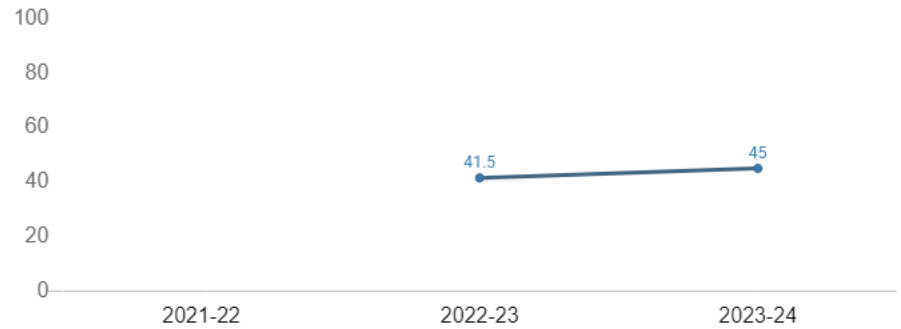

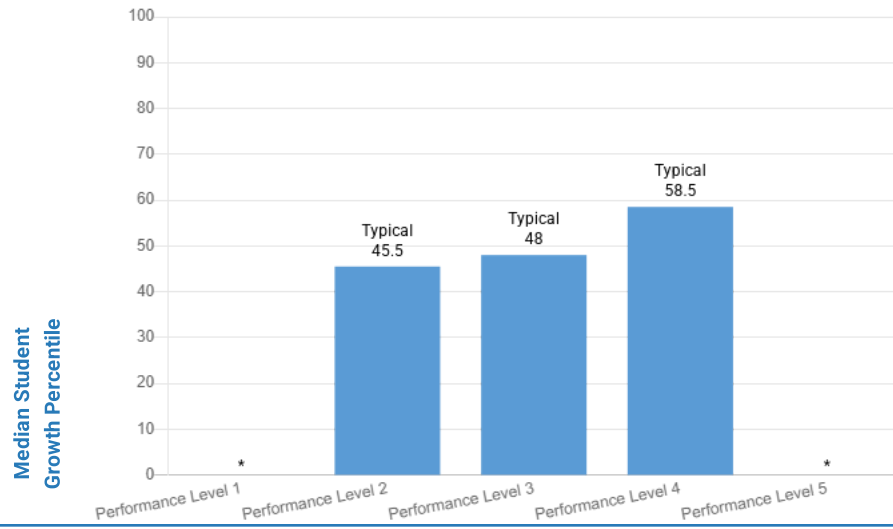

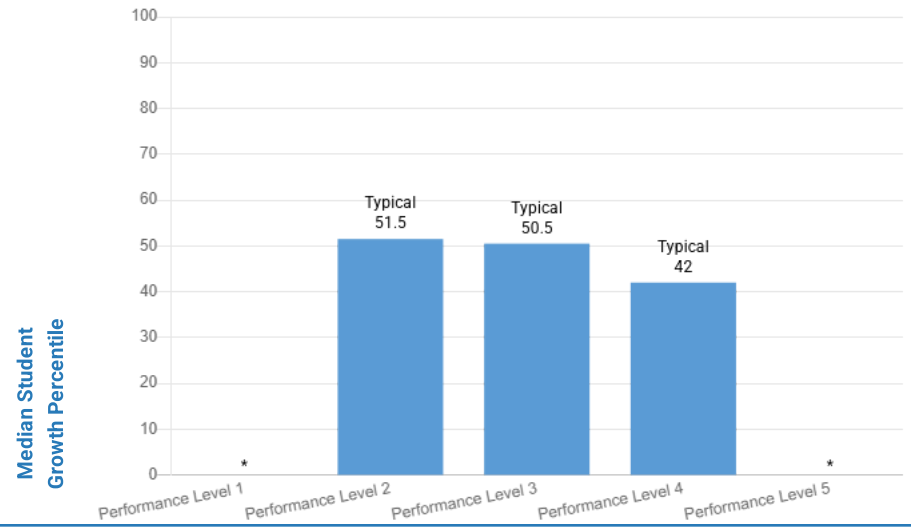

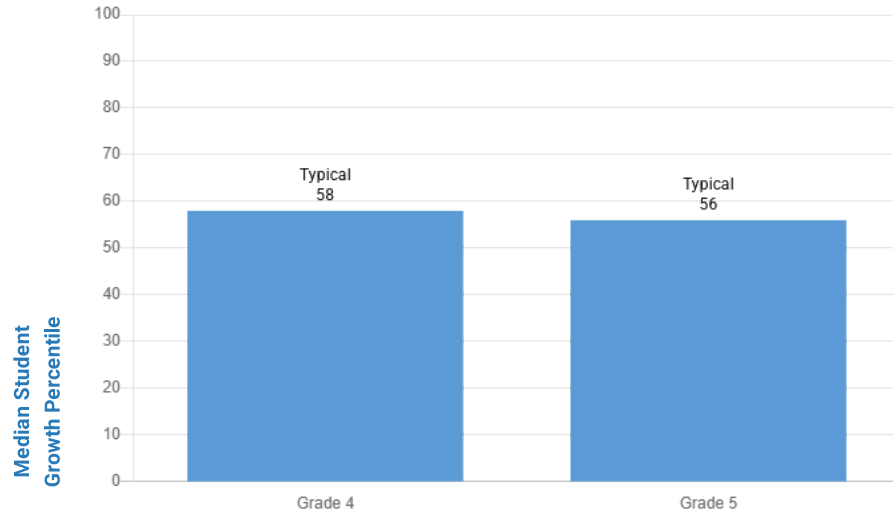

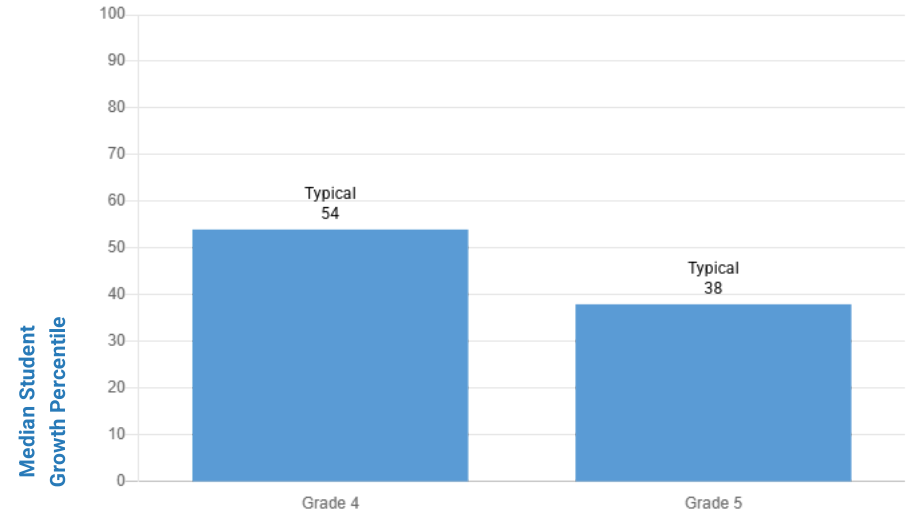

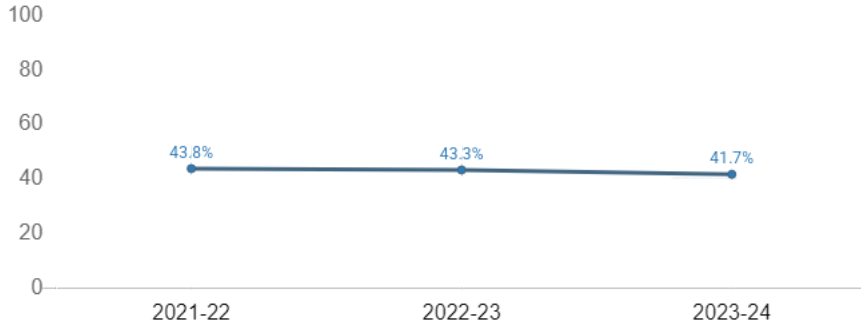

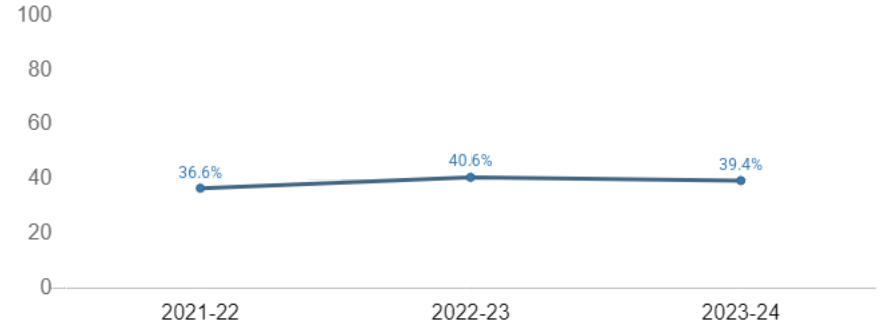
English Language Arts and Mathematics Performance Trends

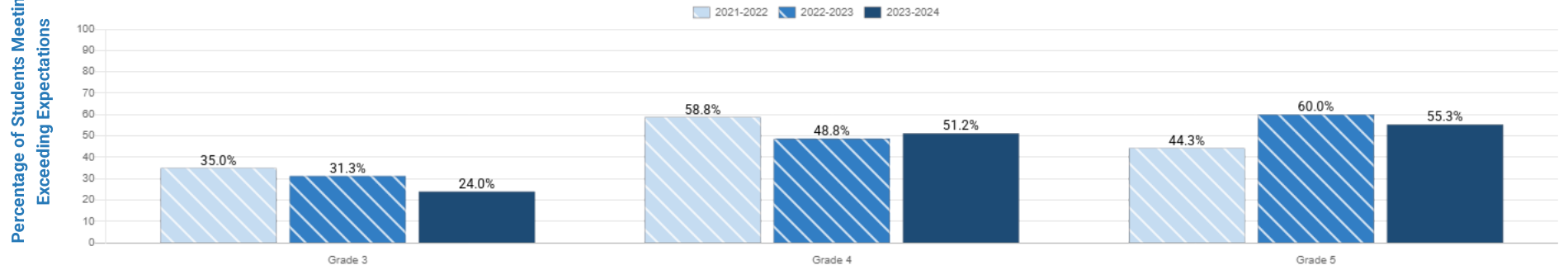

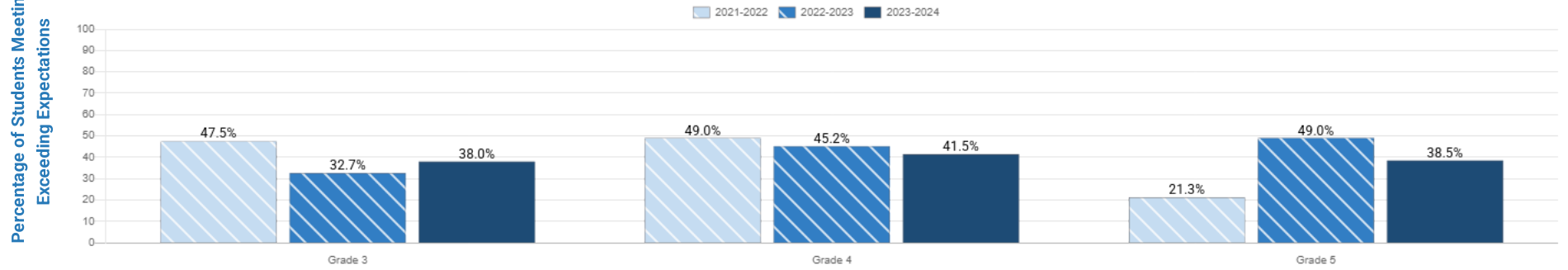

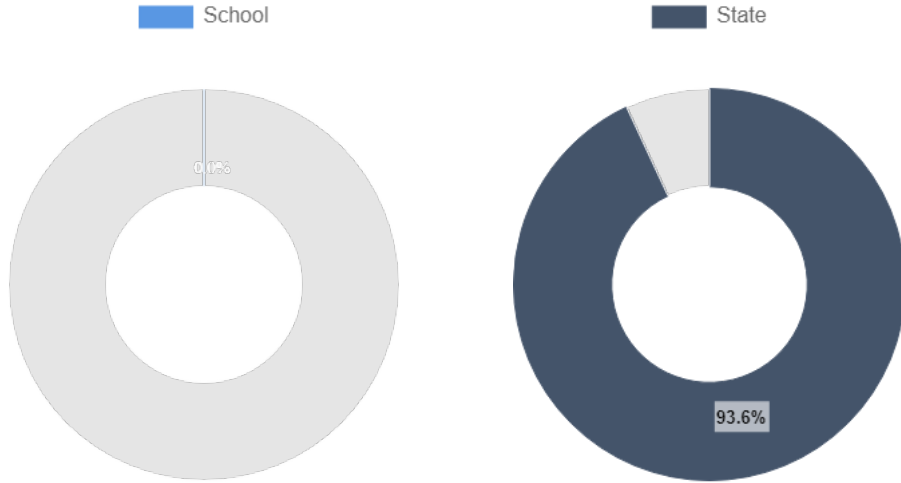

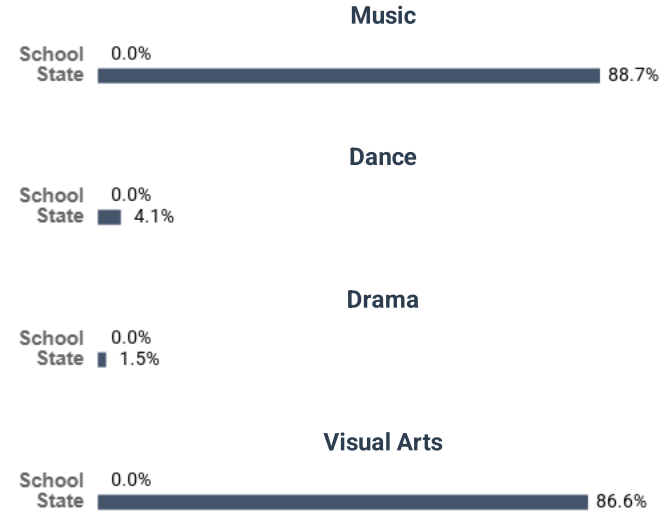

Students enrolled in one or more classes by discipline:



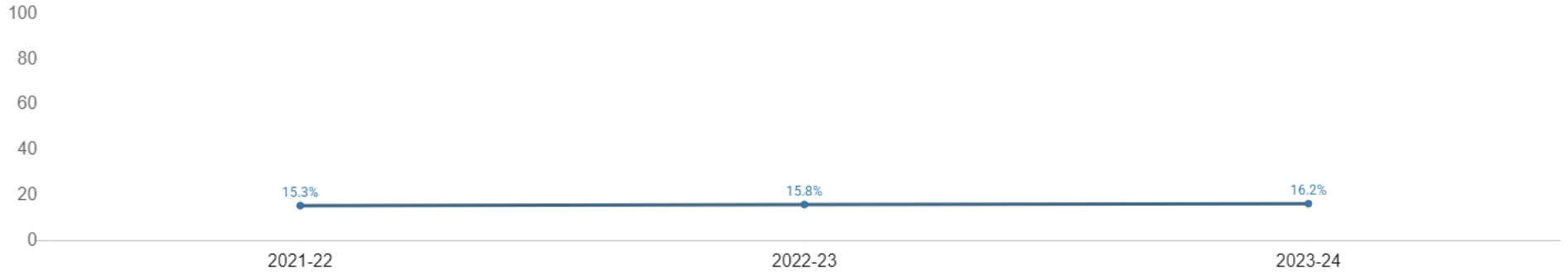

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

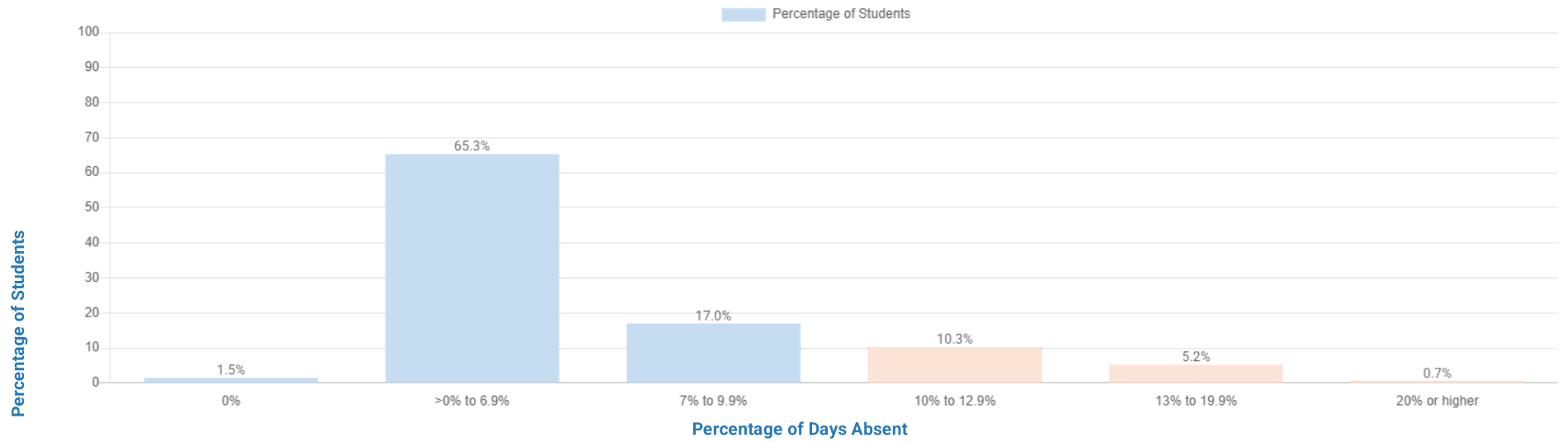

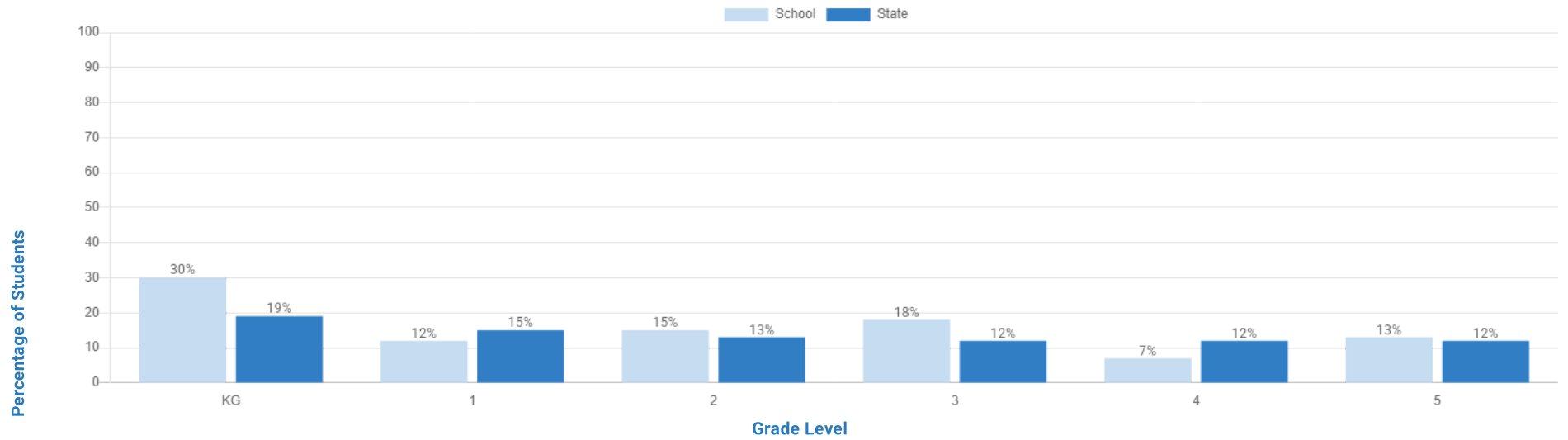

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 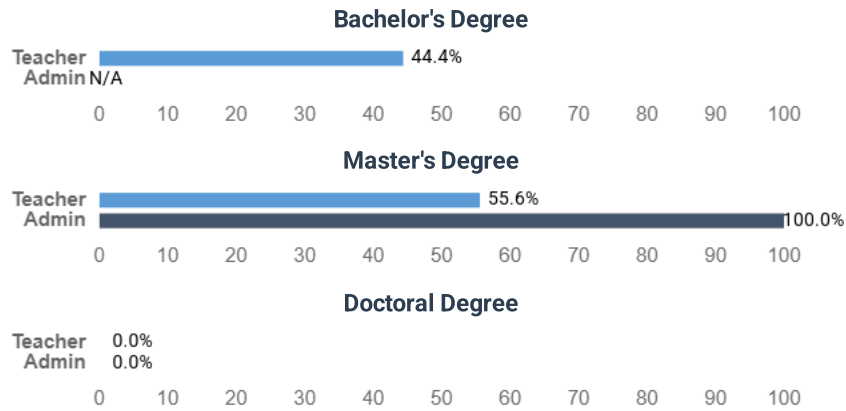

School Three's doors opened to students in 1933, contains 15 classrooms, a gymnasium/lunchroom and a newly renovated 450 seat auditorium that is utilized by the district as well as local theater groups to put on concerts and plays. Our highly effective Positive Behavioral Support in Schools, or P.B.S.I.S program enforces the ideals of being "Safe, Kind and Responsible." These core pillars are embedded throughout our curriculum and daily behavioral expectations.



Courses, Curriculum, Instruction:

Student performance, as measured on student report card grades, NJSLA, STAR Reading assessments, Imagine Math scores all indicate that School Three students are performing at or exceeding expectations. In addition, we work closely with our talented subject area supervisors and coaches to utilize data to drive and enhance our already effective instruction. Our standards-based curriculum is thorough and rigorous, and is constantly evolving to stay up-to-date with the most current educational trends and best practices.

Sports and Athletics:

Participation in physical education provides K-5 students with opportunities to be active, enhancing their self-esteem and overall psychological well-being while improving their physical health. A physically literate individual demonstrates proficiency in various motor skills and movement patterns, using their knowledge to achieve and maintain a healthy level of activity and fitness. This experience helps our K-5 students appreciate the importance of physical health, enjoyment, and self-expression.

Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
