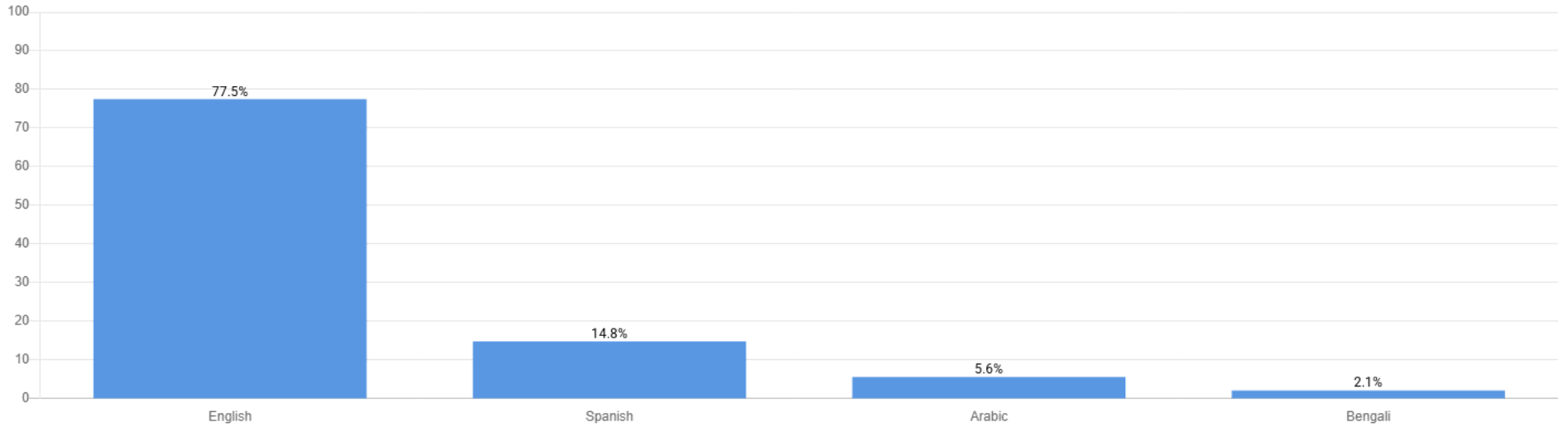

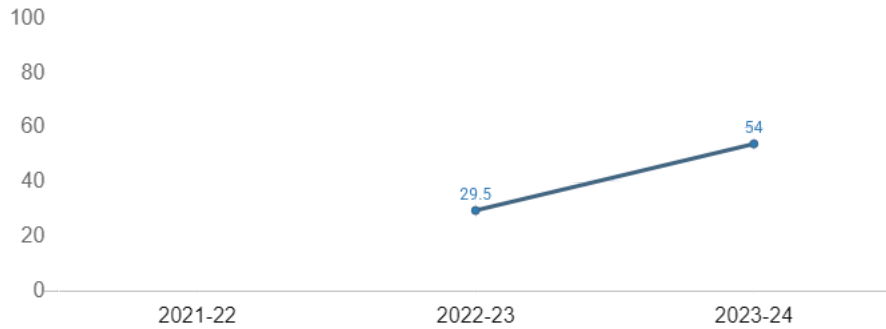

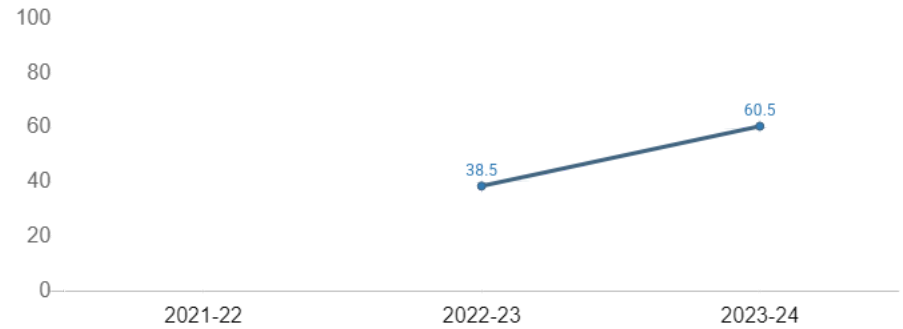

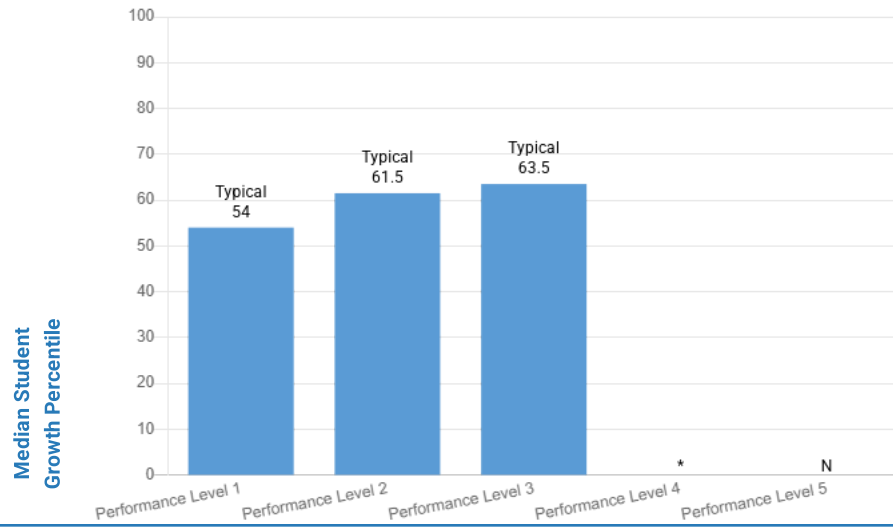

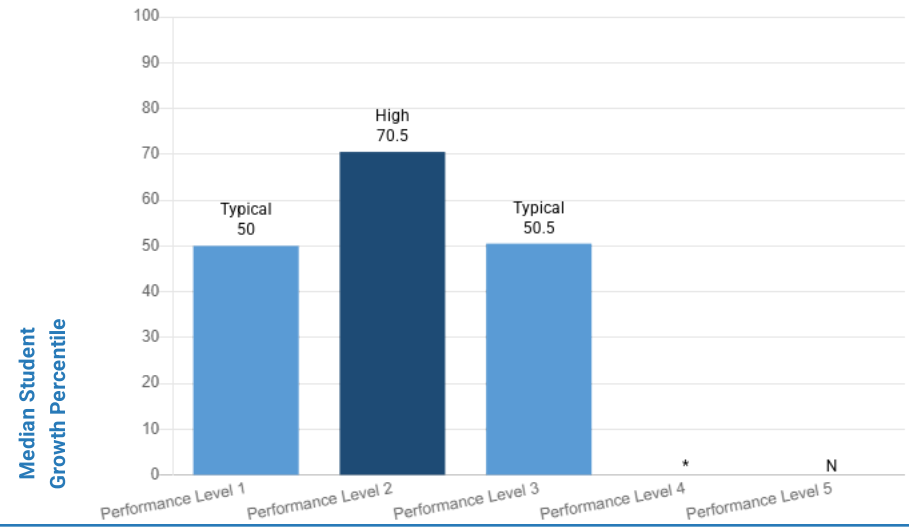

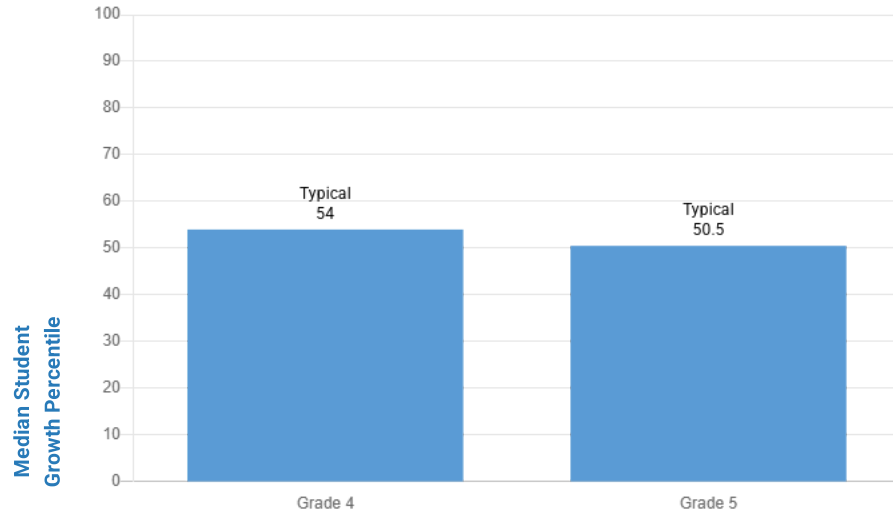

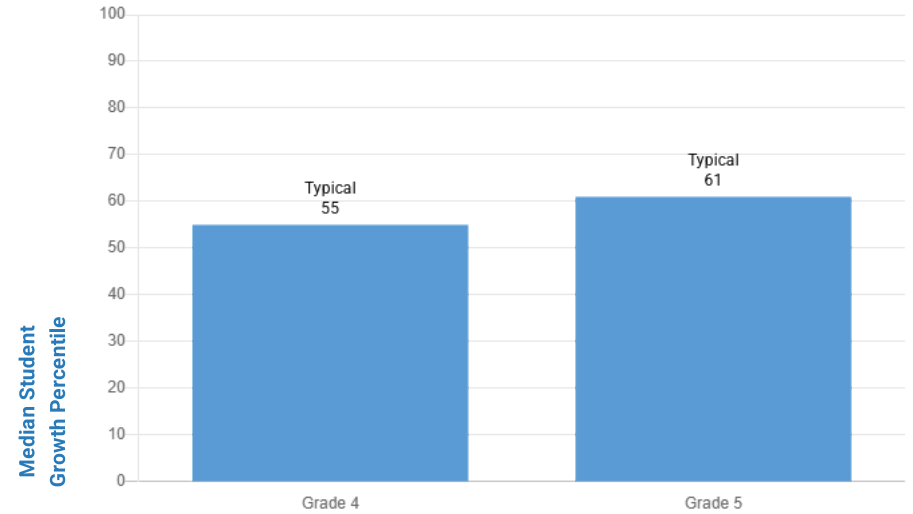

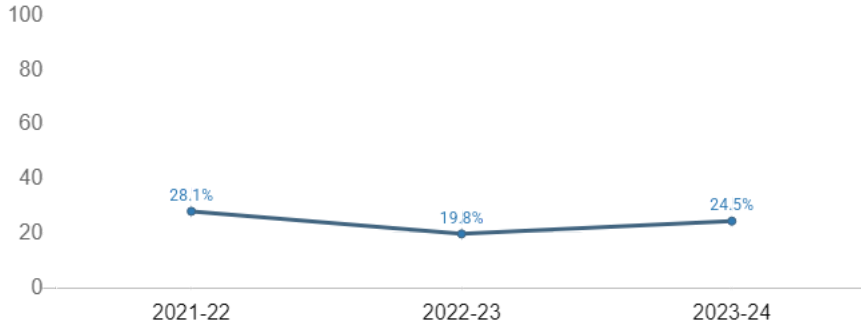

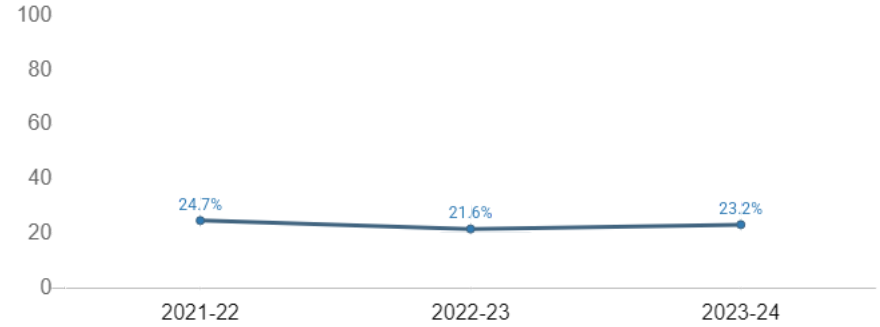
English Language Arts and Mathematics Performance Trends

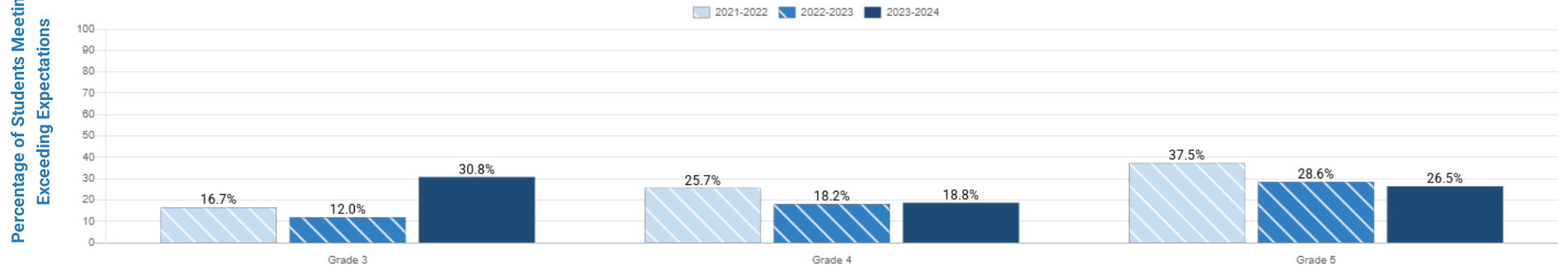

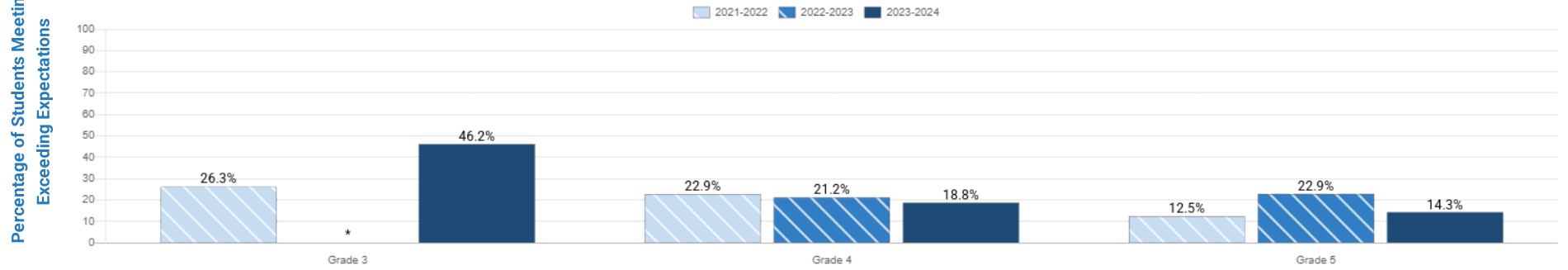

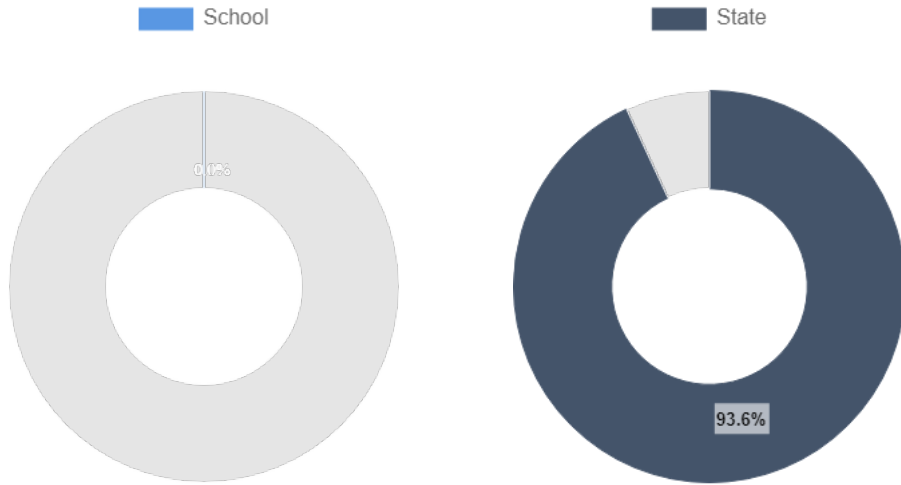

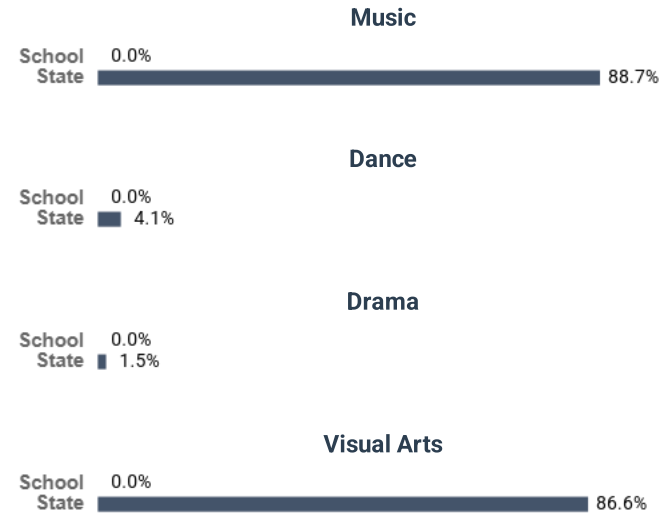

Students enrolled in one or more classes by discipline:



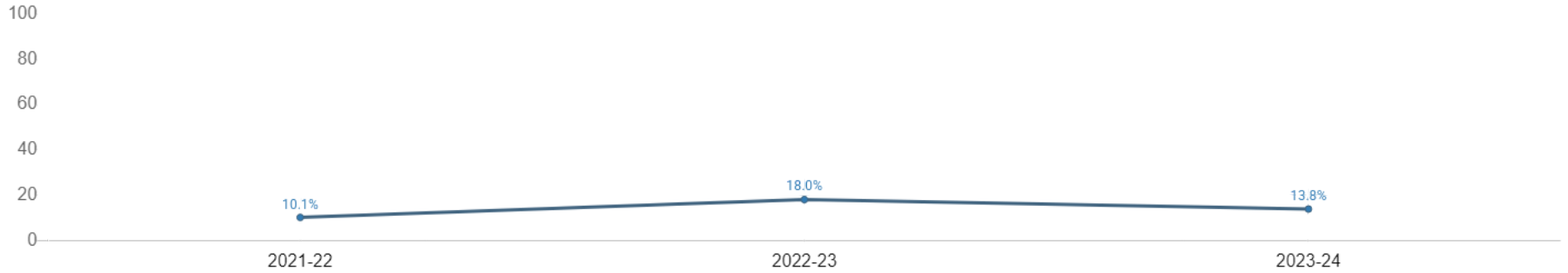

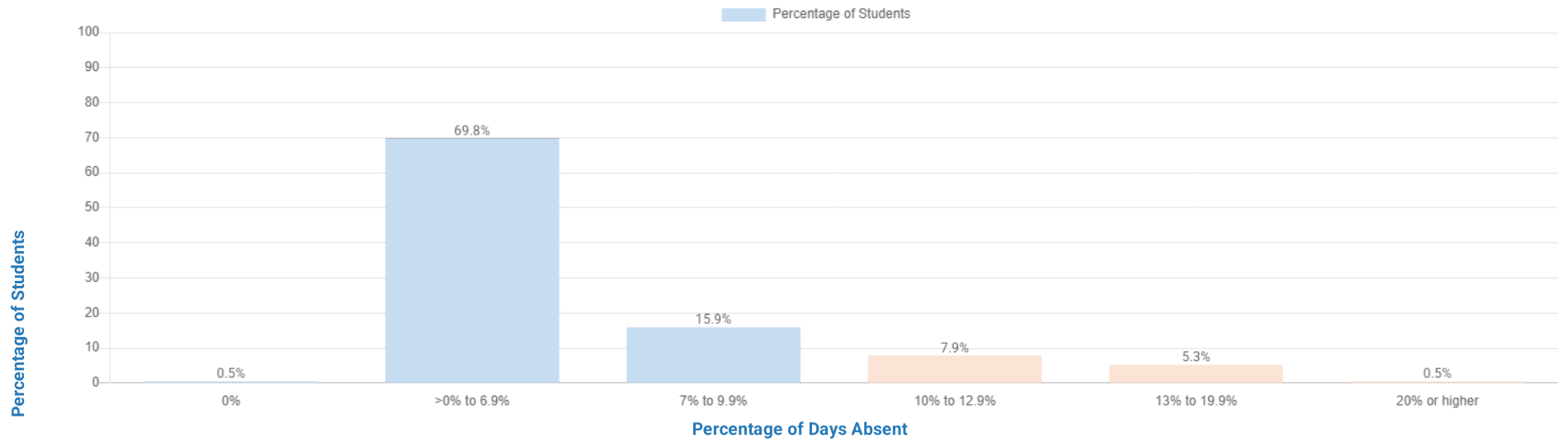

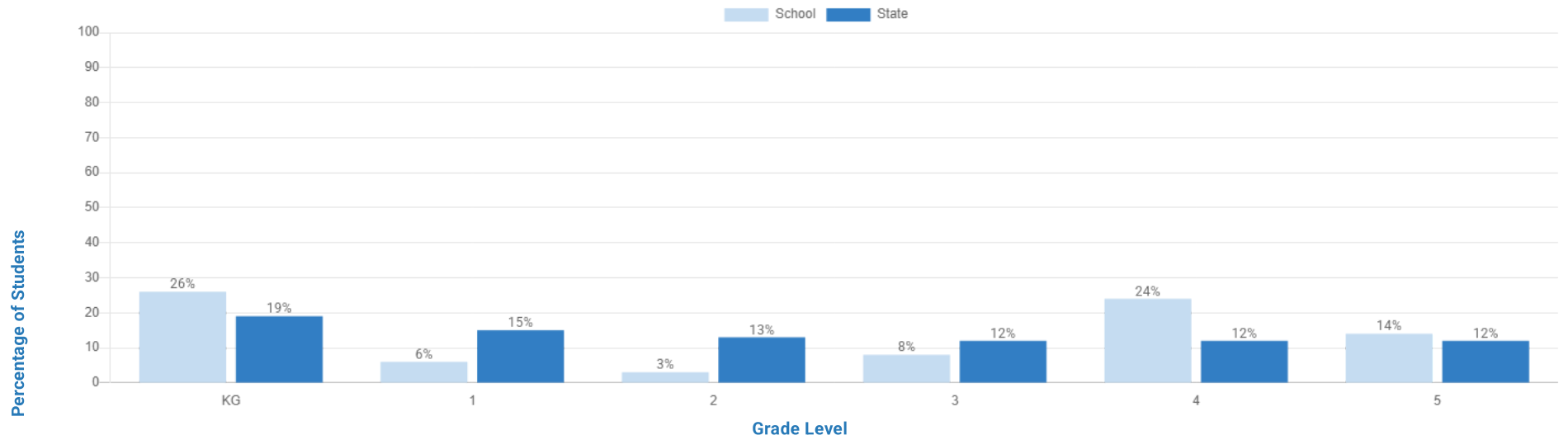

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

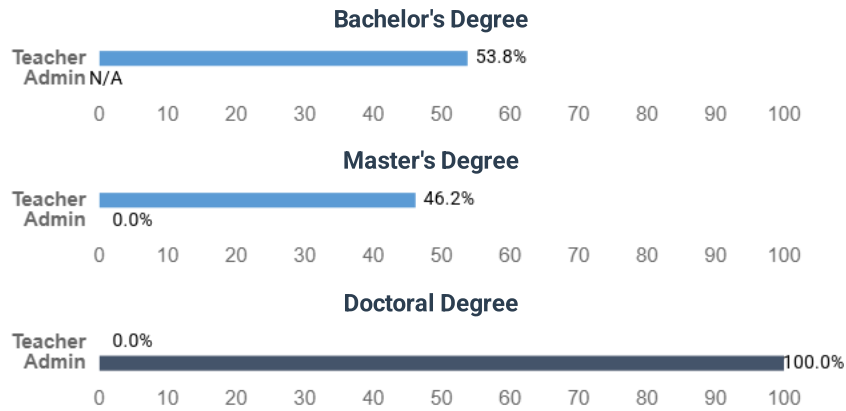

School 4 is proud to host Minds in Motion Program, an after school program funded by the 21st Century Community Learners Program. Students in grades 3-5 have the opportunity to participate in STEM based activities as a hands-on way to improve academic achievement. Academically oriented Family Nights open to all grade levels allow students to cooperatively work with their parents & teachers to learn together in a fun-filled atmosphere. Together, we continue to build a strong network of educational opportunities to serve every student who aspires for a brighter future.



Courses, Curriculum, Instruction:

We offer a comprehensive K-5 New Jersey Student Learning Standards based curriculum. We focus on meeting individual student's needs through differentiated instruction & student choice. We continue to implement a balanced literacy approach. An independent reading motivation and assessment program, Renaissance 360, continues to be used in Grade 2-5 in order to motivate young readers. Wilson Foundations is used in grades K-3 as a reading intervention to enhance students' skills. We continue to implement the Scott Foresman's enVision Program, a research-based mathematics curriculum that cultivates higher order thinking skills while maintaining basic math proficiencies. Imagine Math provides online remediation and practice in a variety of skills. Computer-based resources, such as Accelerated Reader, Raz Kids, and Imagine Math are used daily to enhance core subjects.

Sports and Athletics:

Participation in recess, physical education, Clifton Recreation Center, the Boys and Girls Club and extracurricular activities, offers opportunities for students in grades PK-5 to be physically active. This has proven to help improve students' self-esteem/psychological well-being as well as increasing their overall physical wellness. The physically literate individual demonstrates competency in a variety of motor skills and movement patterns, as well as applying knowledge of skills to achieve and maintain a health-enhancing level of physical activity and fitness. This allows our K-5 students to recognize the value of physical activity for health, enjoyment and self-expression.



Clubs and Activities:

Our school promotes a love and appreciation of the arts by providing instrumental music (band/strings), vocal music, and visual art opportunities throughout each school day. The breakdown includes the following: a standalone art class all K-5 students receive for 30 minutes once a week, a standalone vocal/general music class of 30 minutes once a week, and instrumental strings/band and chorus rehearsals for any 4th and 5th graders interested, that takes place once a week for 30 minutes. Lastly, theater is embedded in the language arts curriculum and dance is embedded in the physical education curriculum which all K-5 students receive.



Before and After School Programs:

School #4 provides an aftercare program in conjunction with the Boys and Girls Club of Clifton beginning immediately after dismissal. Additionally, students in grades 4 and 5 can participate in Minds in Motion, an afterschool program, funded through a 21st Century Learning Grant.

Staff and Professional Learning:

School 4 takes pride in having an enthusiastic and dedicated staff, committed to delivering quality education to all of our students. Here at School 4, you will find an inviting & positive atmosphere with classrooms filled with motivated learners, hallways lined with colorful examples of students' work, and teachers ready to tackle any challenge. We have a strong emphasis on professional learning communities and collaboration. Professional Learning Communities deepen teacher understanding of topics such as, using data to drive instruction, sharing best practice, looking at students' work, and reviewing content-based benchmarks. District wide professional development plans are informed by school level committees (SciPs). We encourage and support our staff to continue to be lifelong learners.



Student Supports and Services:

School 4 has been working in collaboration with the Rutgers University Boggs Center to implement the NJ PBSIS district wide initiative targeting a multi-tiered system of support for behavior, conduct, and social-emotional wellness that promotes equity for all students. "School 4 R.O.A.R." is a school wide program that encourages students to be "Responsible, Organized, Achieve Goals, and Respectful" through positive reinforcement. Our Basic Skills Program supports students learning in both reading and math in grades K-5. BSI provides small group, targeted instruction for a variety of students in each grade level. Our Reading Recovery program supports our young readers in grades 1-3, providing them with extra support in fluency, phonemic awareness, and comprehension skills. Through the multi-tiered systems of support, we create environments that promote safety and encourage success while we work collaboratively to achieve student goals.



Student Health and Wellness:

Students in grades K-5 are exposed to concepts related to health promotion and disease prevention to enhance overall health and wellness. This includes units of family, peers, culture, media, technology as well as instructing them to access valid information and products to enhance overall health and wellness. Students are taught the ability to use interpersonal communication skills to enhance health and wellness and avoid, or reduce health risks, by practicing decision-making and goal-setting skills.

Parent and Community Involvement:

The School 4 Parent Teacher Organization is a nonprofit parent teacher organization (PTO) whose mission is to institute and sustain a close relationship between the parents, teachers, and students by evolving opportunities within the home, school, and community. The PTO provides assistance to teachers with the classroom settings, raises funds for educational materials and experiences, advocates school and family social interactions, and provides an unbiased forum for sharing information on issues that impact our children. It is our belief that the tea effort of a parent teacher organization offers the best possible learning environment for our children. The School 4 PTO proudly plans and organizes monthly family nights to encourage parents, students, and staff to work together to create amazing opportunities for our School 4 students.



Early Childhood Education:

Clifton Public Schools offers 2 preschool program options: preschool for children with special needs and a state-funded preschool program. The free preschool program for children with special needs assists children ages 3 to 5 who have special needs. If eligible, there are inclusive opportunities within the state-funded preschool program. In addition, self-contained classrooms are also available throughout the preschool program. The free full-day, high-quality state-funded preschool program is available on a first-come, first-serve basis for age eligible 3 and 4 year-olds that live in Clifton upon completion of the registration process. With a strong relationship with Head Start and a growing list of private providers, our state-funded preschool program currently consists of 46 fully inclusive classrooms, located in 12 locations throughout the district taught by a certificated preschool teacher with a teaching assistant.



Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
