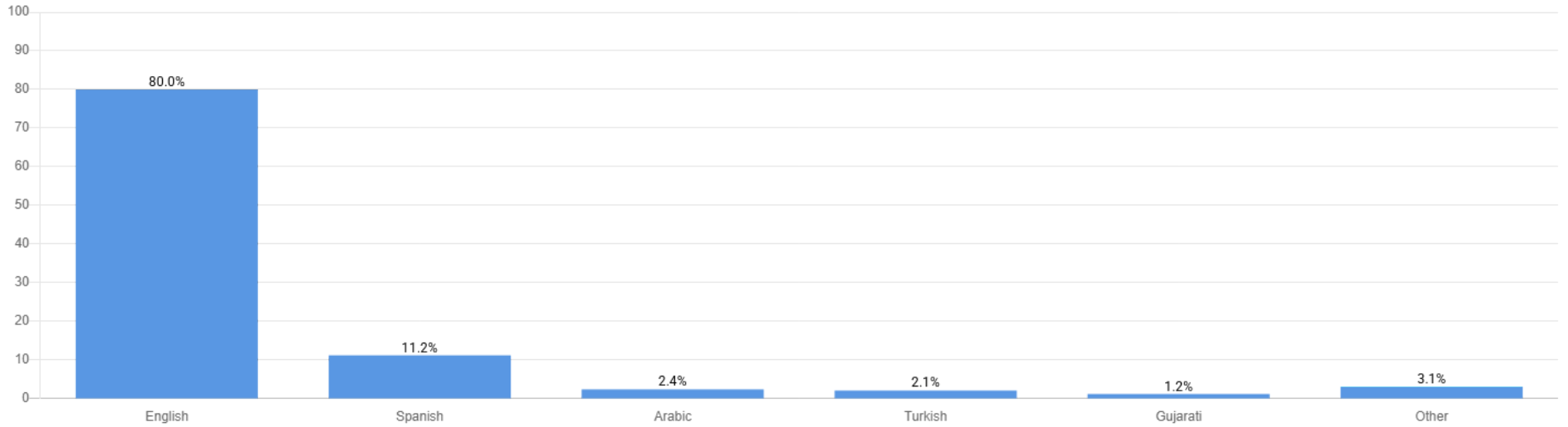

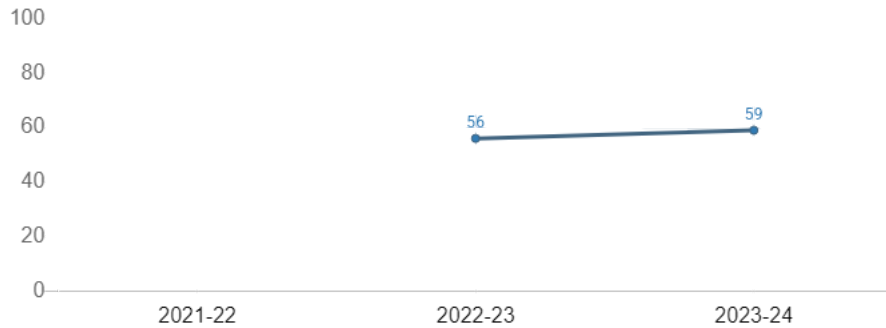

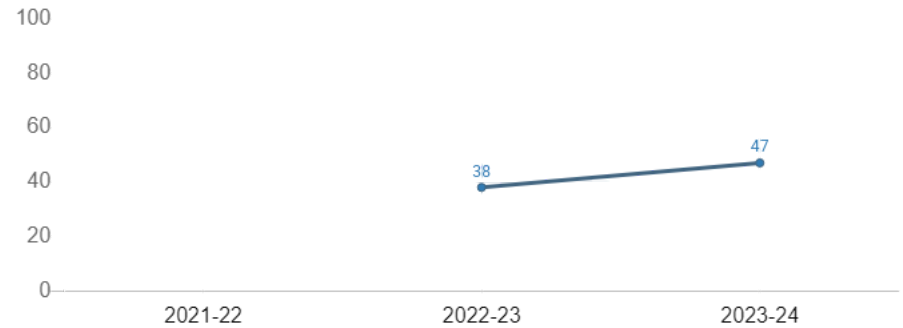

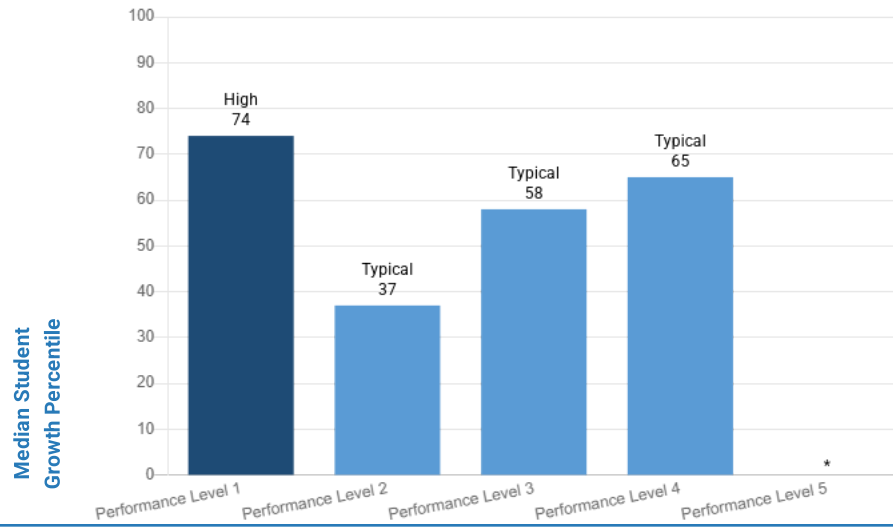

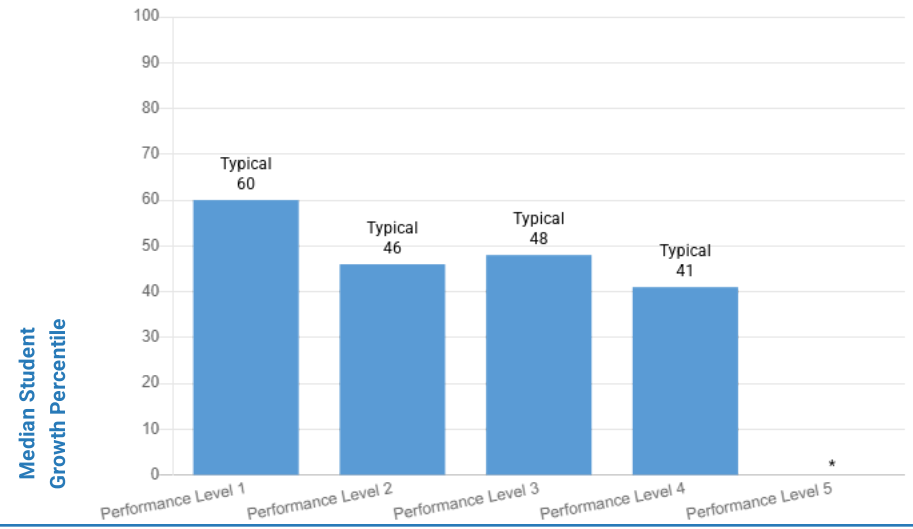

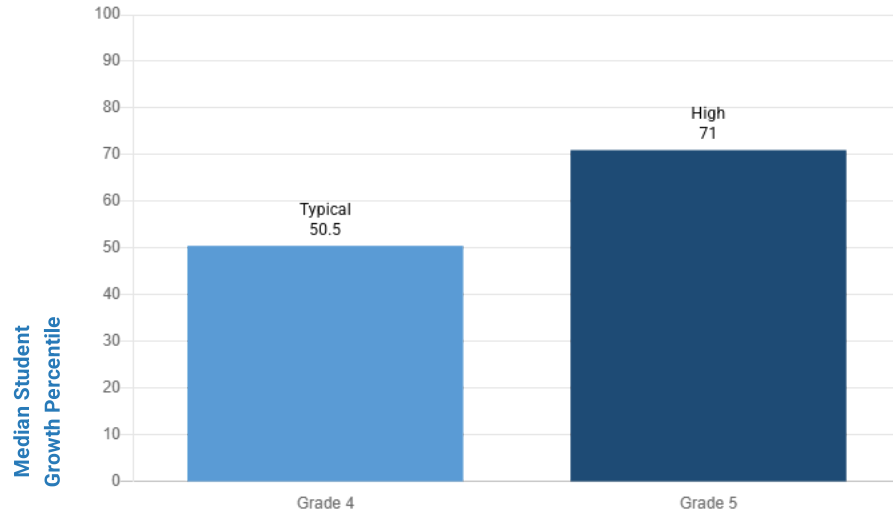

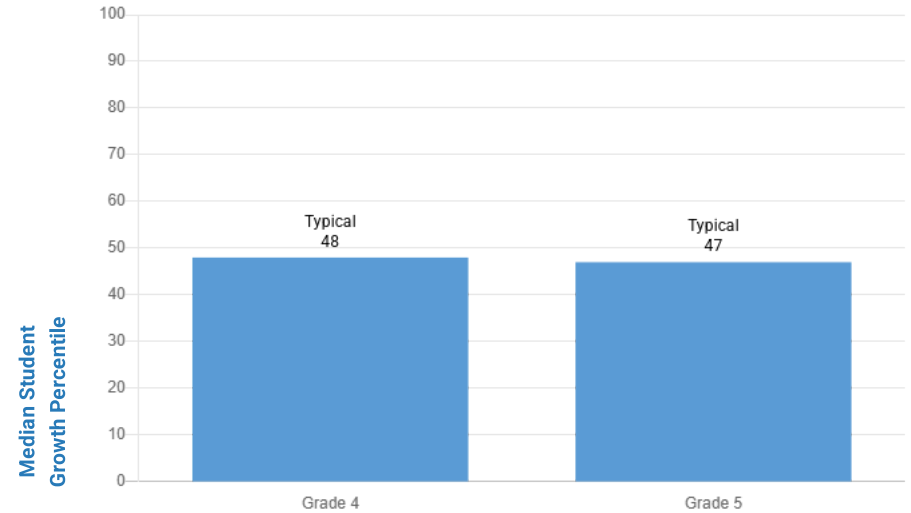

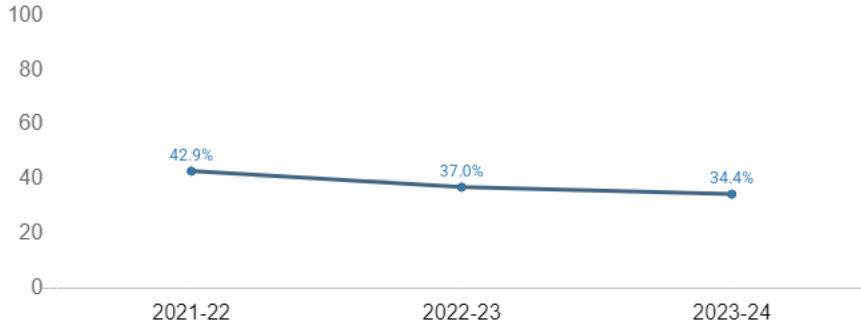

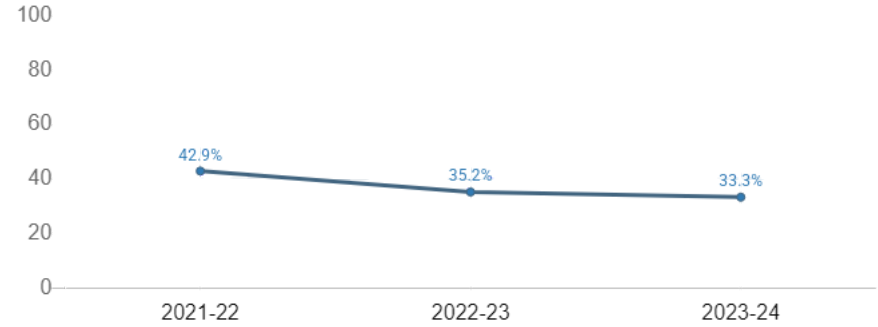
English Language Arts and Mathematics Performance Trends

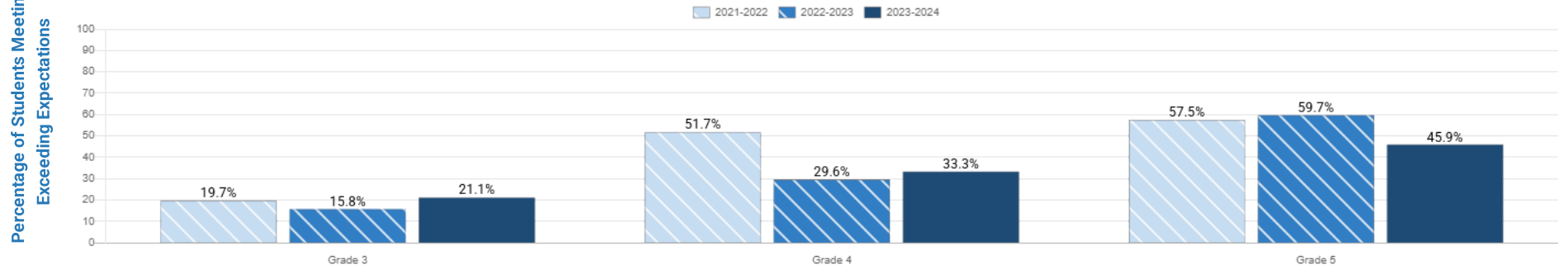

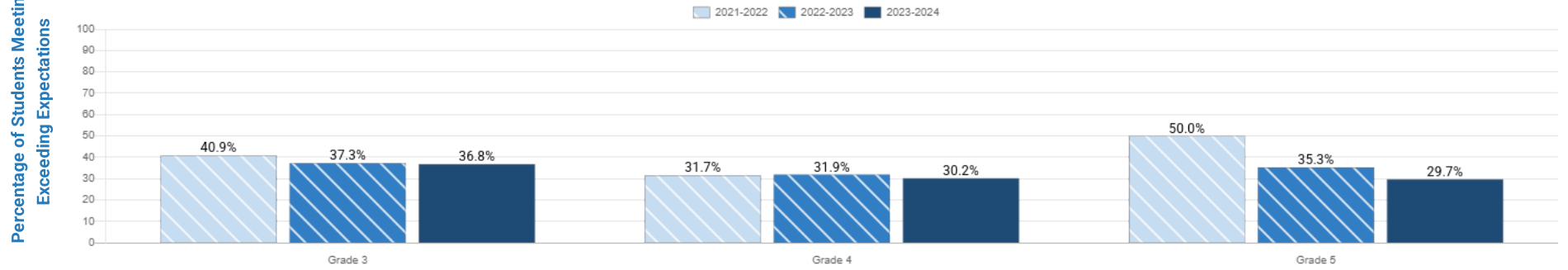

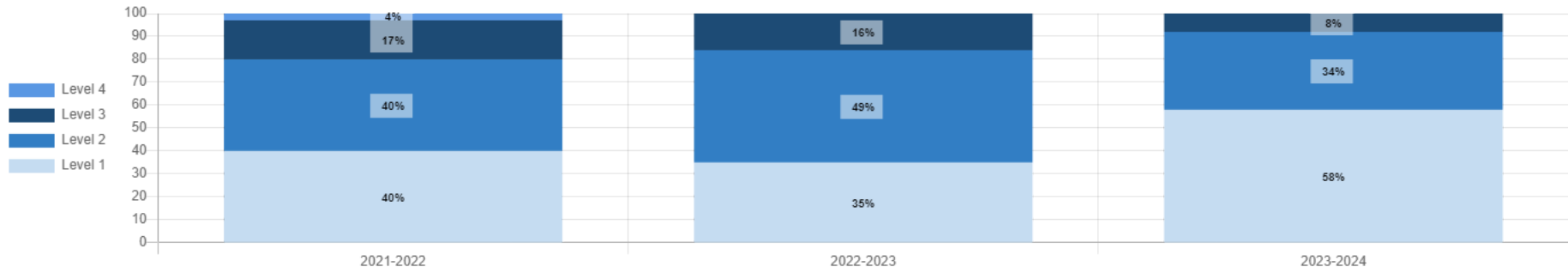

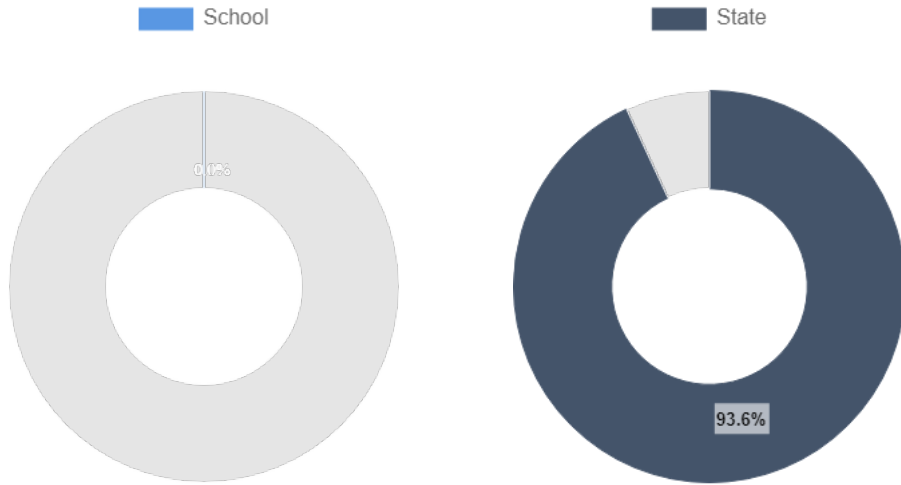

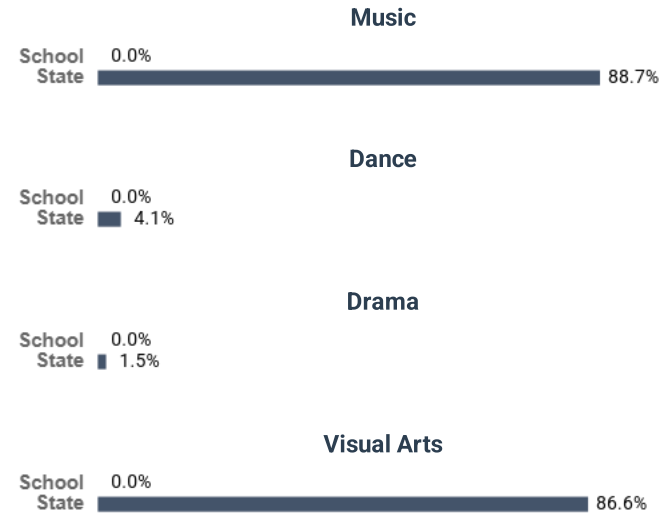

Students enrolled in one or more classes by discipline:



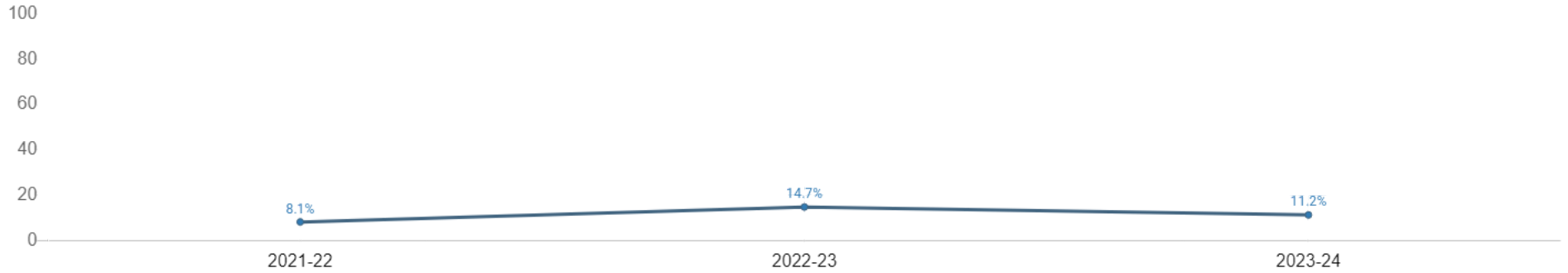

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 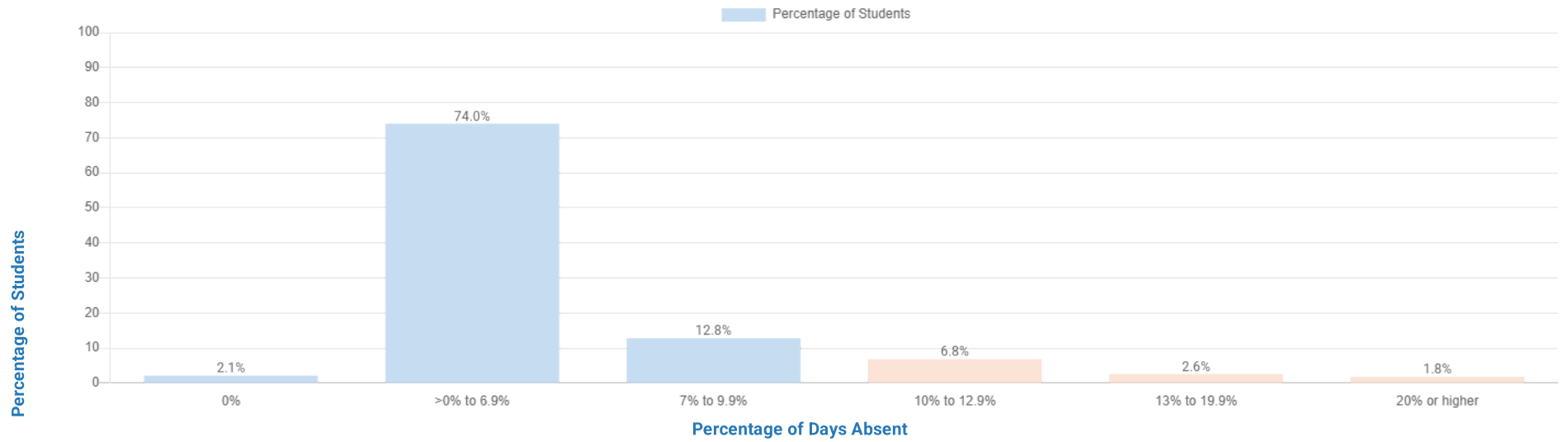

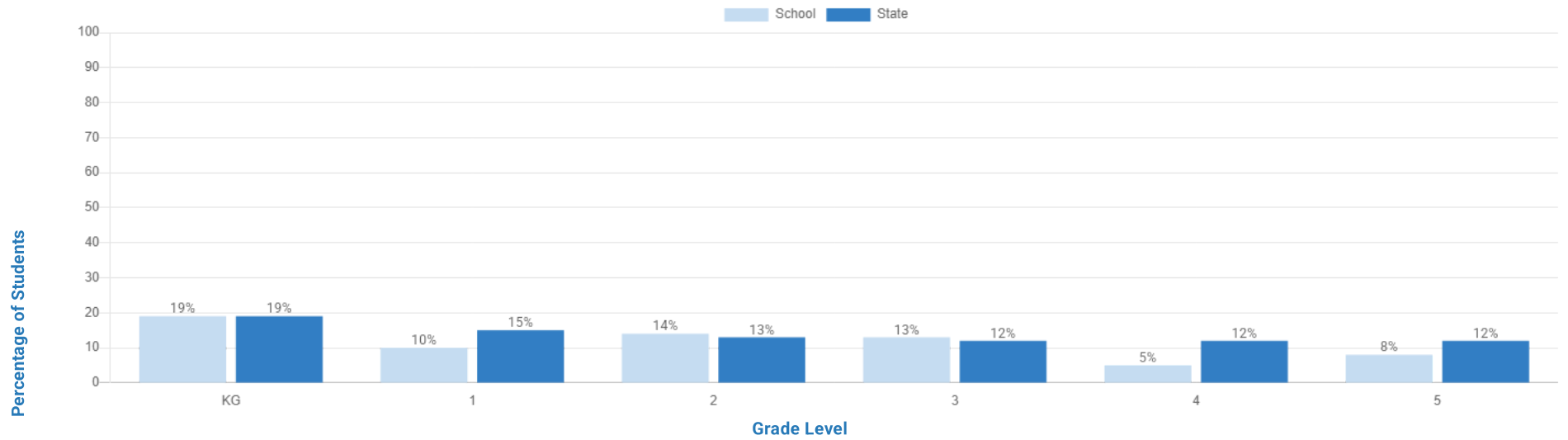

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 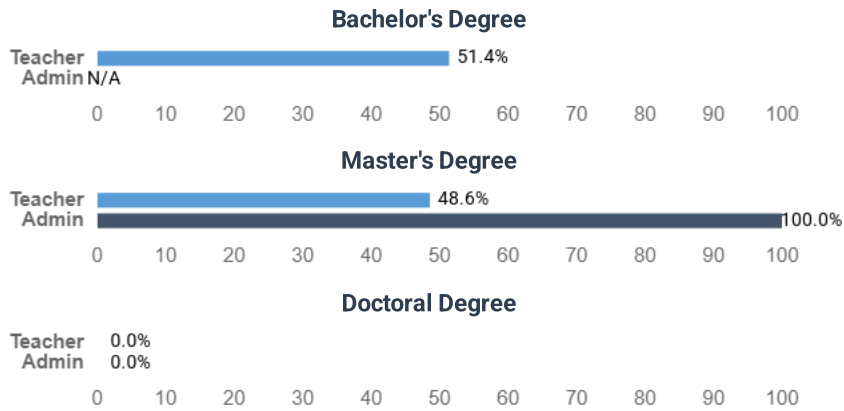

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. We encourage our students to become lifelong learners by promoting self-confidence, responsibility, and teamwork. Our learning community strives to foster mutual respect and acceptance, which is enhanced by a strong partnership between home and school. Awards, Recognition, Accomplishments:

School Five presents the All STAR Award to our students. This award is given to students who have significantly improved in any area of our school-wide expectations. Our school counselors also give monthly awards to students who are aligned with our character education traits. These awards are recognized through our monthly pep rallies. In addition to our school-wide awards, our fifth-grade students are recognized for their academic achievements by earning Honor Roll.



Courses, Curriculum, Instruction:

Teachers implement enVisions Math to promote hands-on activities, inquiry-based teaching, cooperative learning, and differentiation with adaptive programs that enrich, reinforce, or remediate online students' mathematical understanding. By utilizing these varied instructional math programs, we strive to provide each student with an individualized path to achievement. School Five is a literacy-rich environment that nurtures a joyful community of readers. Within a scientifically based balanced reading program, Foundations, multisensory and systematic phonics, spelling, and handwriting program develops the foundational reading skills for all Kindergarten through grade 3 students. Our fourth and fifth grade students continue to enhance either literary skills using our Word Wisdom program and novel unit studies to unlock word meanings and enhance critical thinking strategies.

Sports and Athletics:

Participation in recess, physical education, and extracurricular activities offers opportunities for students in grades K-5 to be physically active. This has proven to help improve students' self-esteem/psychological well-being as well as increase their overall physical wellness. The physically literate individual demonstrates competency in a variety of motor skills and movement patterns, as well as applying knowledge of skills to achieve and maintain a health-enhancing level of physical activity and fitness. This allows our students to recognize the value of physical activity for health, enjoyment, and self-expression.



Clubs and Activities:

Our school promotes a love and appreciation of the arts by providing instrumental music (band/strings), vocal music, and visual art opportunities throughout each school day. The breakdown includes the following: a standalone art class all K-5 students receive for 30 minutes once a week, a standalone vocal/general music class of 30 minutes once a week, and instrumental strings/band and chorus rehearsals for any 4th and 5th graders interested, that takes place once a week for 30 minutes. Lastly, theater is embedded in the language arts curriculum and dance is embedded in the physical education curriculum which all K-5 students receive.

Staff and Professional Learning:

Clifton Public Schools have a strong emphasis on professional learning communities. District wide professional development plans are informed by school level improvement committees (SciPs). Professional Learning Communities meet to deepen teacher understanding of topics such as using data to inform instruction, sharing best practices, looking at students' work, and examining content-based benchmarks. As a district, we encourage and support our staff to continue to be lifelong learners. Our content supervisors in conjunction with our content coaches ensure every staff member has access to professional development that is tailored to meet their individual needs.

School Five continues to work in collaboration with the Rutgers University Boggs Center to implement the New Jersey Positive Behavioral Support In Schools (PBSIS). This district wide initiative includes a multi-tiered system of support for behavior, conduct, and social-emotional wellness that promotes equity for all students. Through these multi-tiered systems of support, we create environments that promote safety and encourage success while we work collaboratively to achieve student goals. Students are taught the ability to use interpersonal communication skills to enhance health and wellness and avoid health risks by practicing decision-making and goal-setting skills.

Parent and Community Involvement:

At School Five, we believe strongly in the importance of maintaining a partnership with parents. We encourage and invite parent involvement in the education of our children. All parents are invited to meet with teachers to discuss student classroom progress, review performance on state tests, and discuss how parents and teachers may work together to meet the needs of each student. We are very fortunate to have a very active, involved, and supportive group of parents that make up the Home and School Association (HASA). Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
