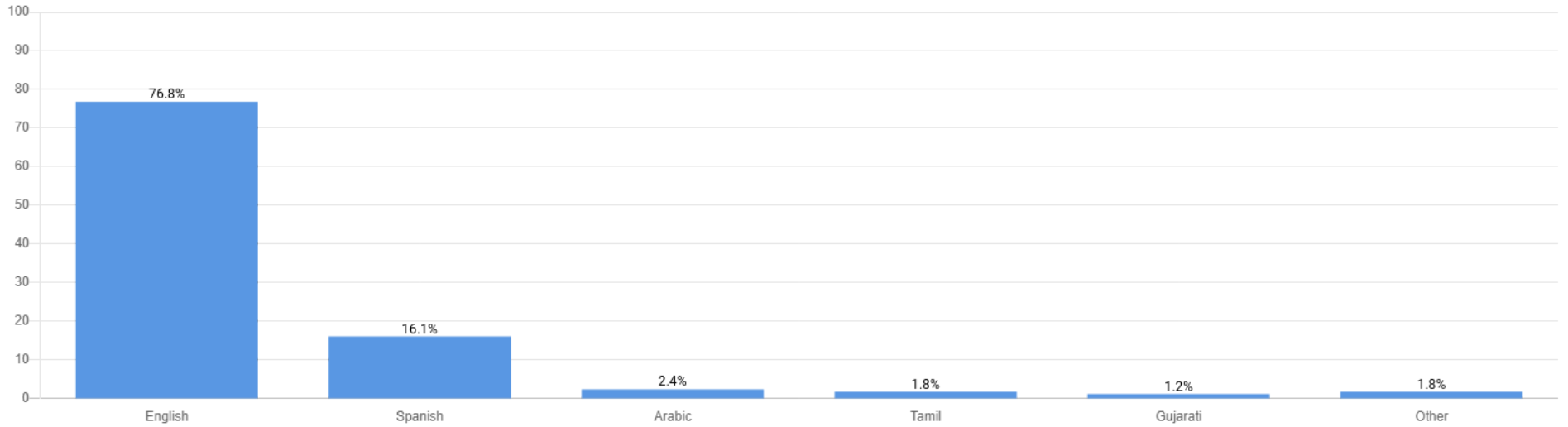

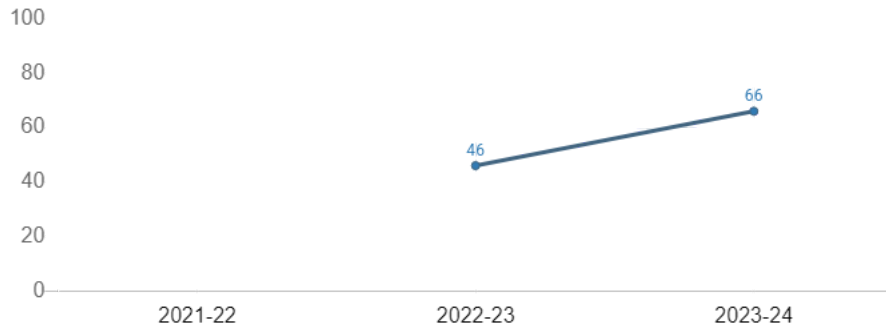

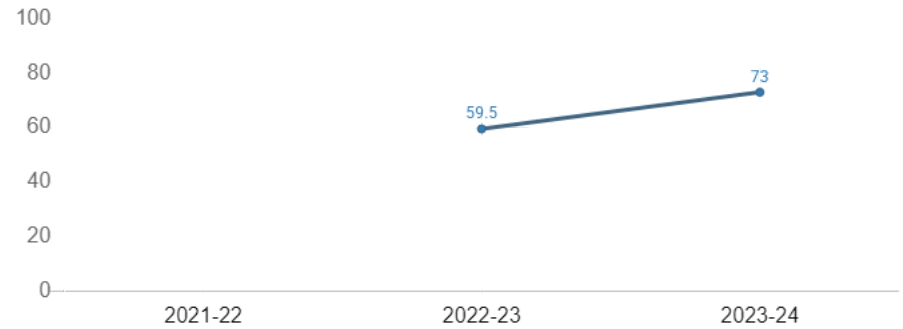

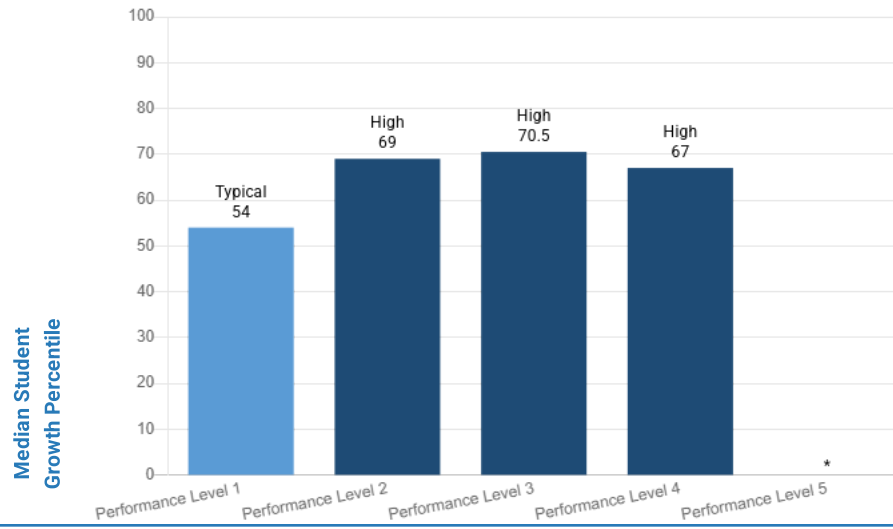

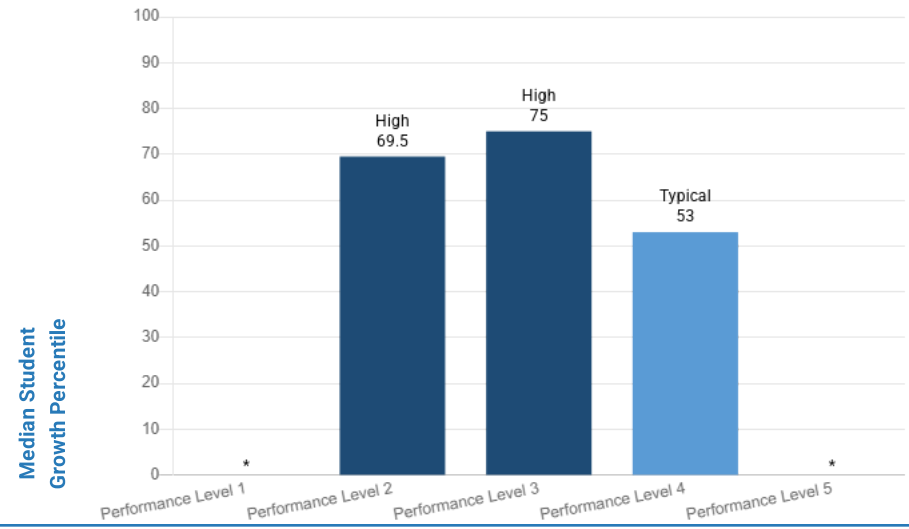

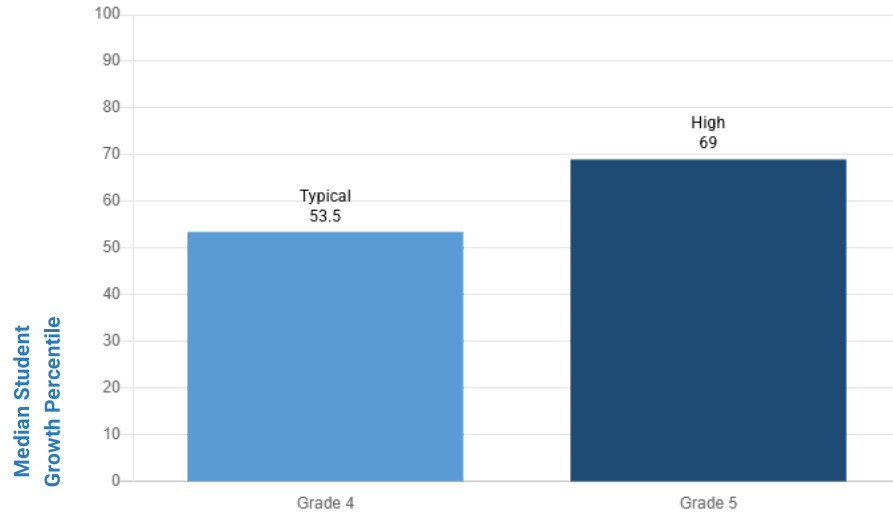

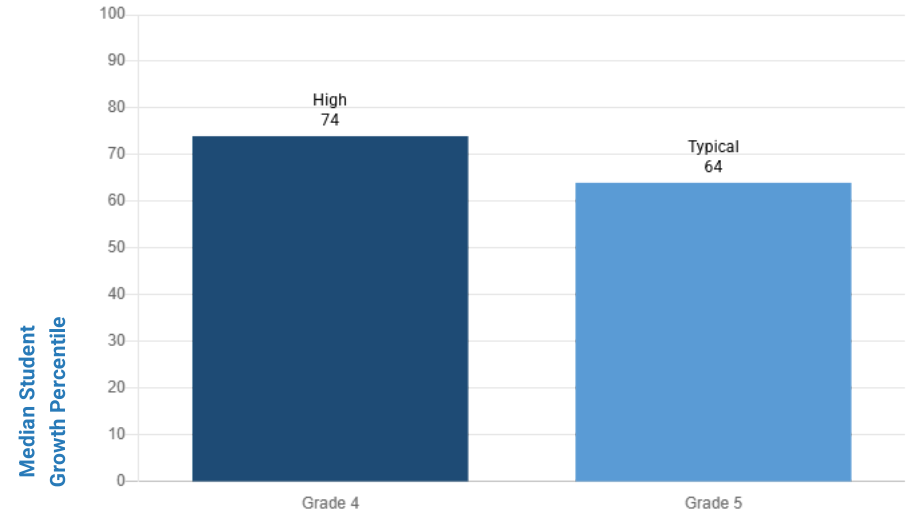

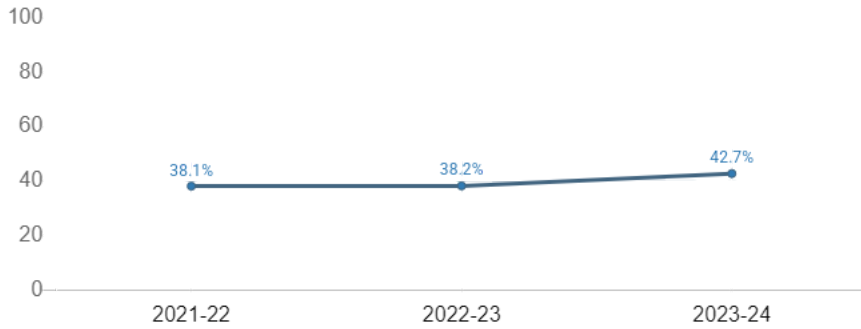

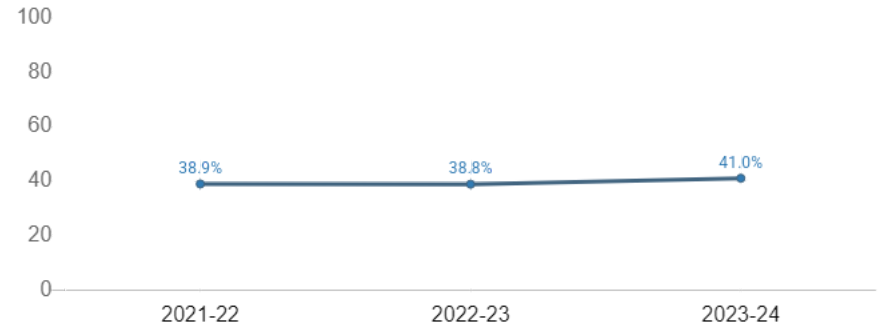
### English Language Arts and Mathematics Performance Trends

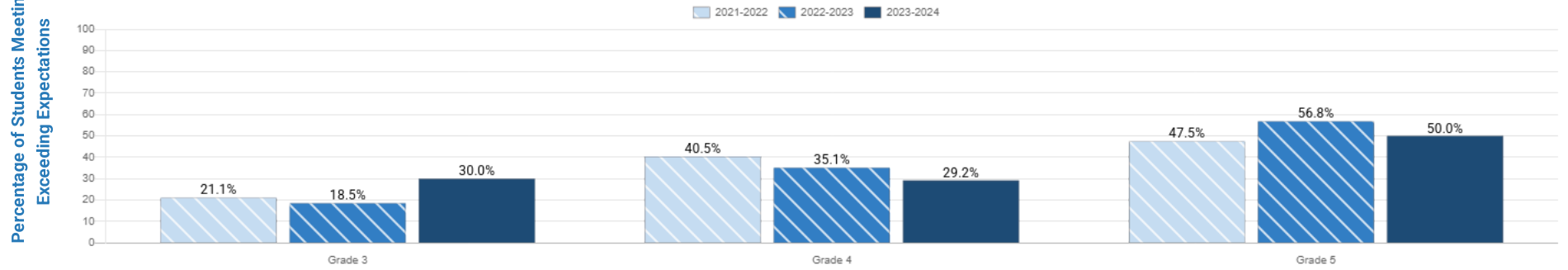

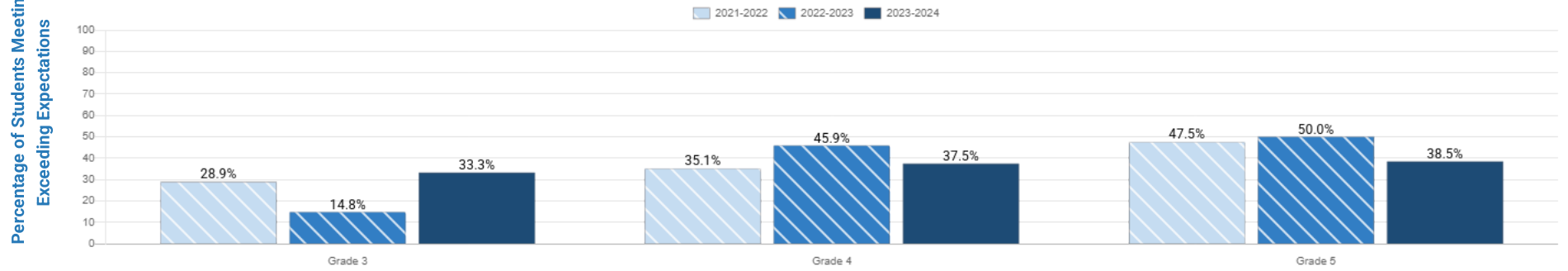

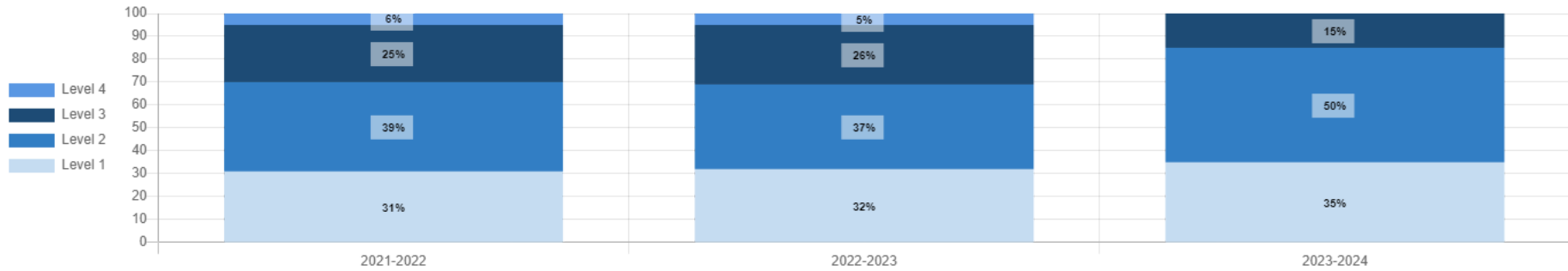

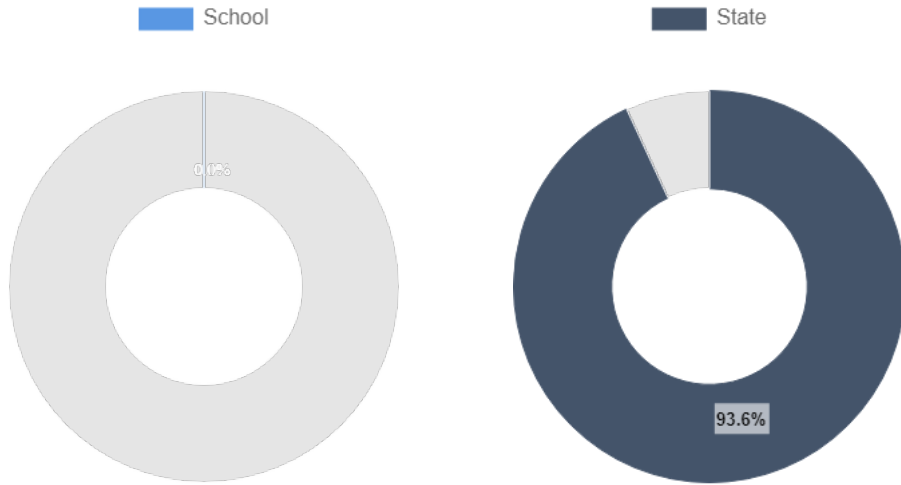

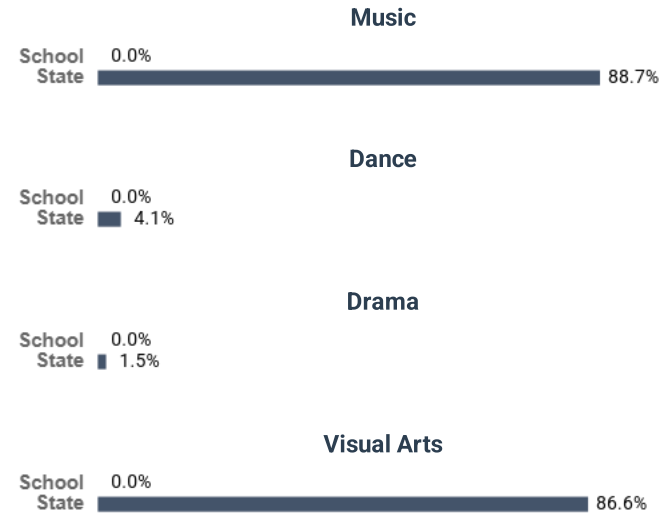

Students enrolled in one or more classes by discipline:



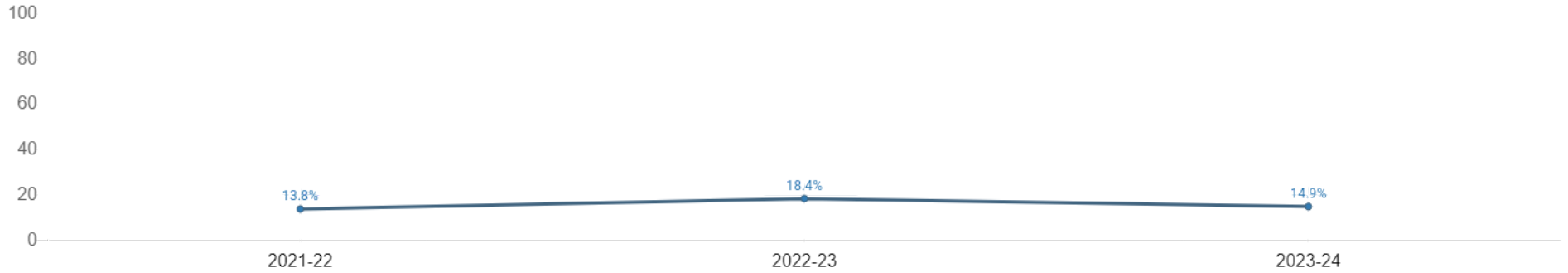

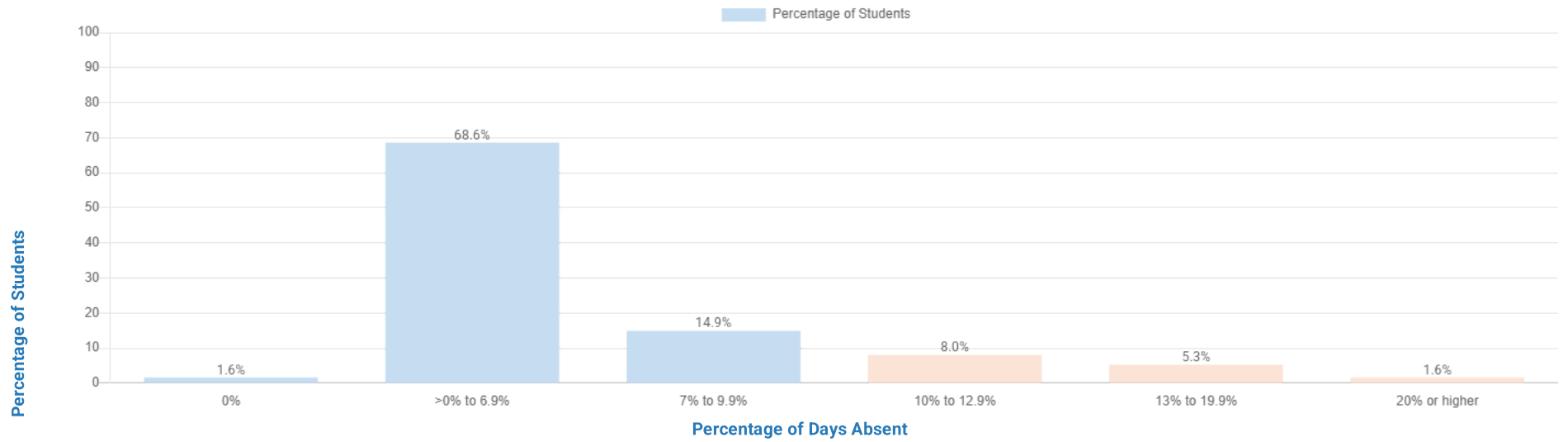

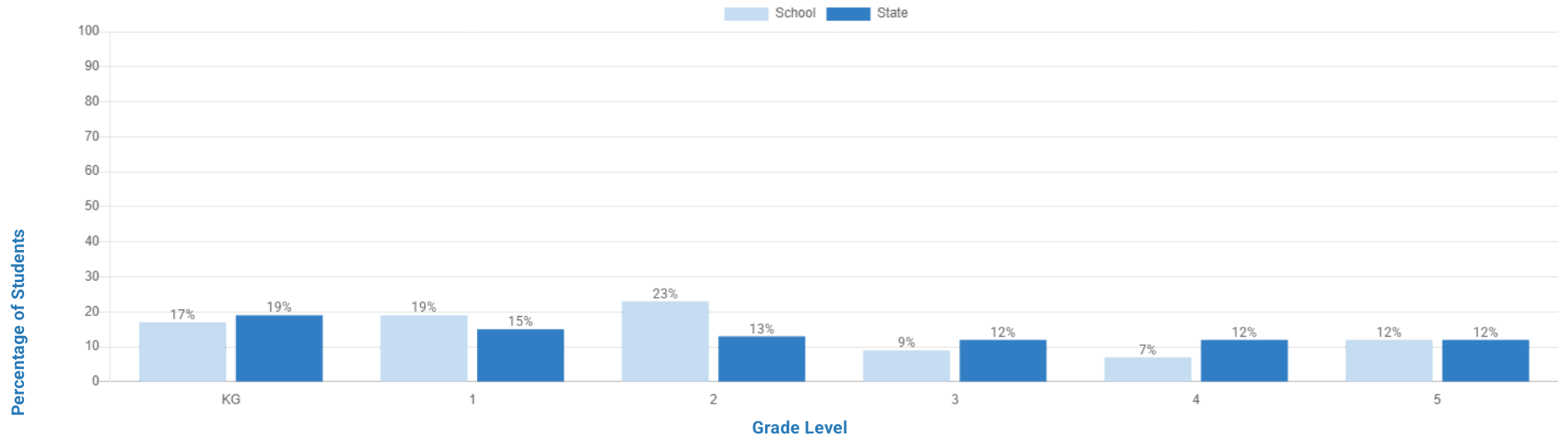

## Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

**Key terms for staff data:**

**Teachers:** All classroom teachers

**Administrators:** Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

**Experience:** Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

### Teachers – Experience

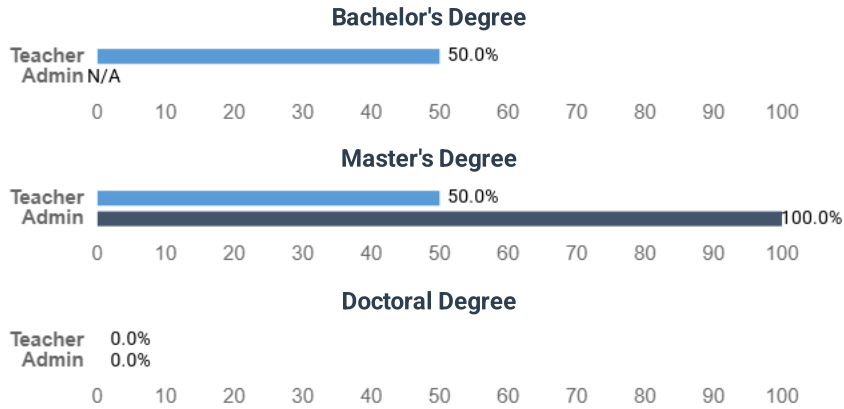

### Mission, Vision, Theme:

School Eight is nestled in the Delawanna section of Clifton and prides itself in providing our one hundred sixty-nine students, at present, with a wide variety of opportunities for success. Over the past few years, average class size has lingered between eighteen to twenty-five students, allowing for individualized instruction and greater teacher-student interaction.

School Eight incorporates the activities for Week of Respect, School Violence Awareness and Red Ribbon Week which encompasses character education and anti-bullying lessons. When the "entire village" works cooperatively to educate children, success is guaranteed! Our school mascot is the dolphin and our slogan which is displayed in front of the building on our sign announces to the community that "School Eight...where The learning is great!"



### Courses, Curriculum, Instruction:

Our curriculum is aligned with and reflects the NJSLs. Teachers implement the enVisions 2.0 Math Program. As part of a balanced literacy initiative, teachers utilize the Houghton Mifflin Journeys Series and Writer's Workshop, in conjunction with the Accelerated Reader, Accelerated Reader 360, STAR Reading and Raz Kids. Reading difficulties are identified as they emerge, providing students in need of support, individualized instruction and strategies for improvement. Foundations, a multisensory and systematic phonics, spelling and handwriting program develops foundational reading skills for all K through grade 3 students. Additionally, this year the district has implemented the myON reading program, which personalizes reading for students by recommending books based on their interests, reading level, and ratings of books they've read. An inquiry based Science program and Social Studies are key areas of our curriculum as well as Our Visual and Performing Arts program.

High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
