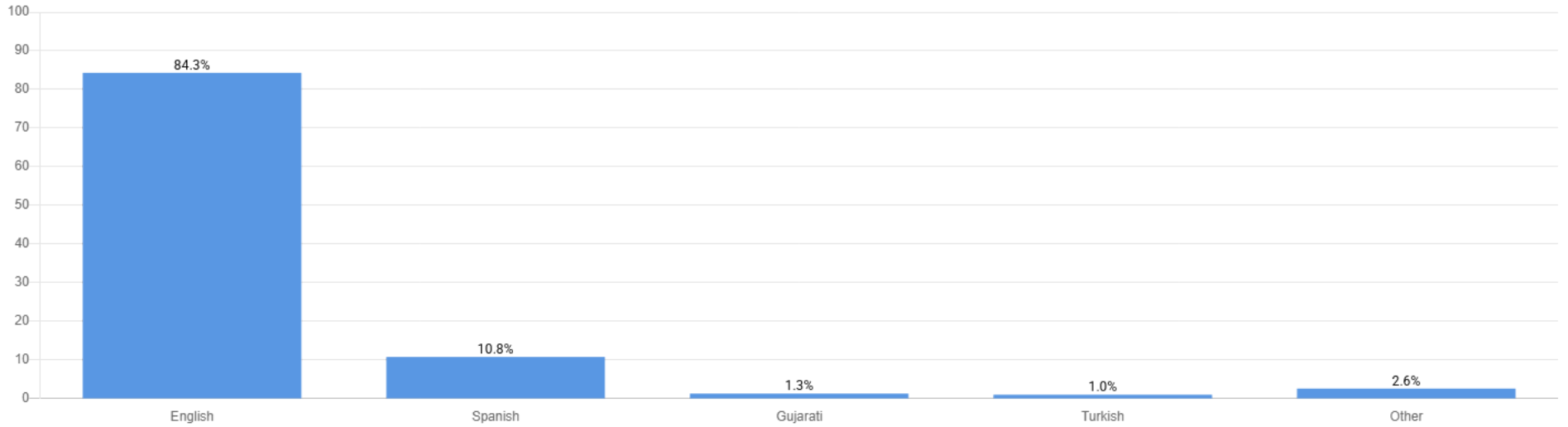

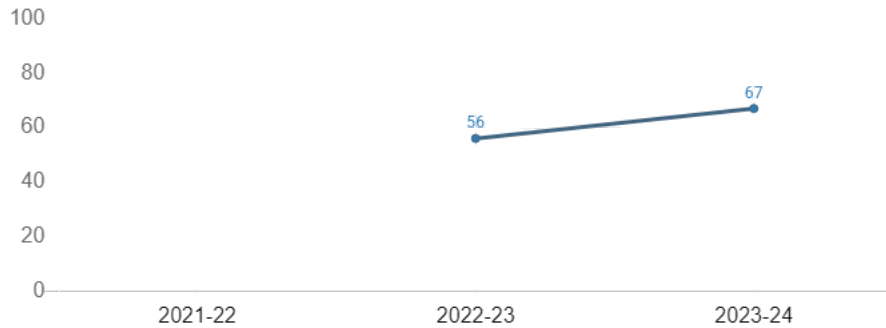

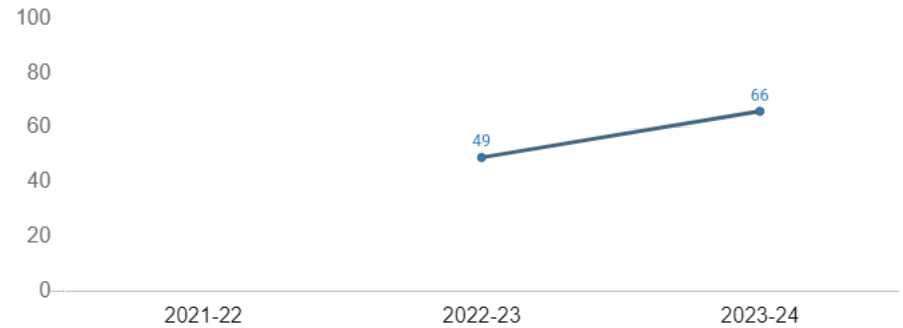

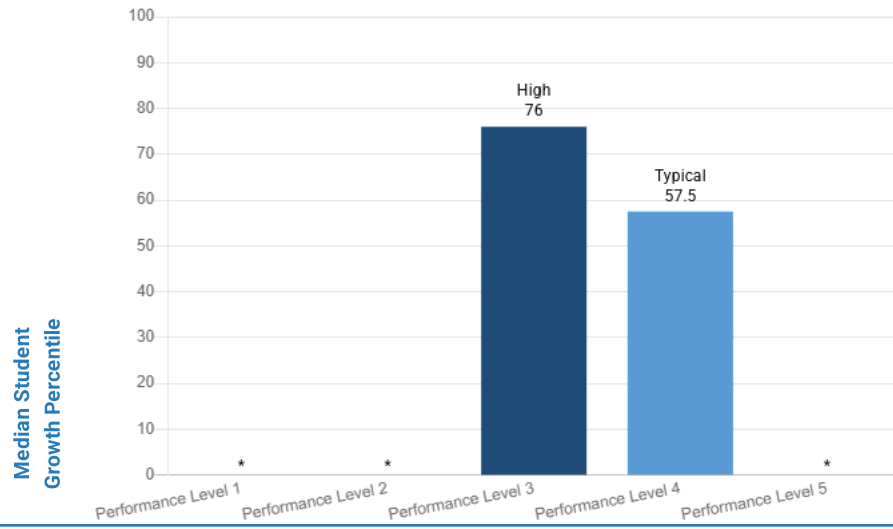

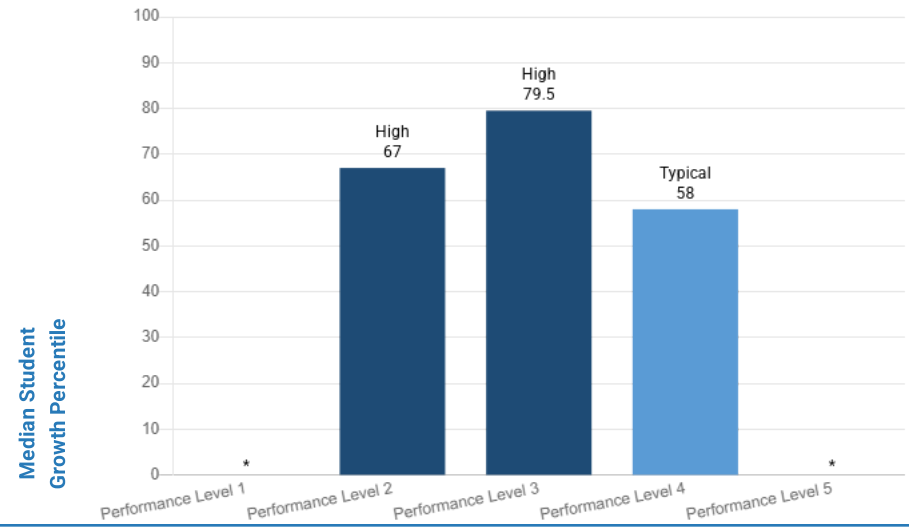

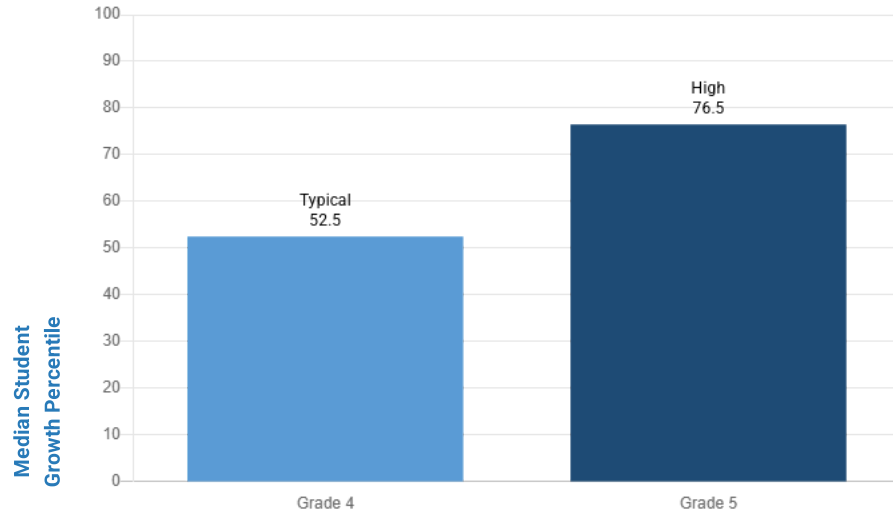

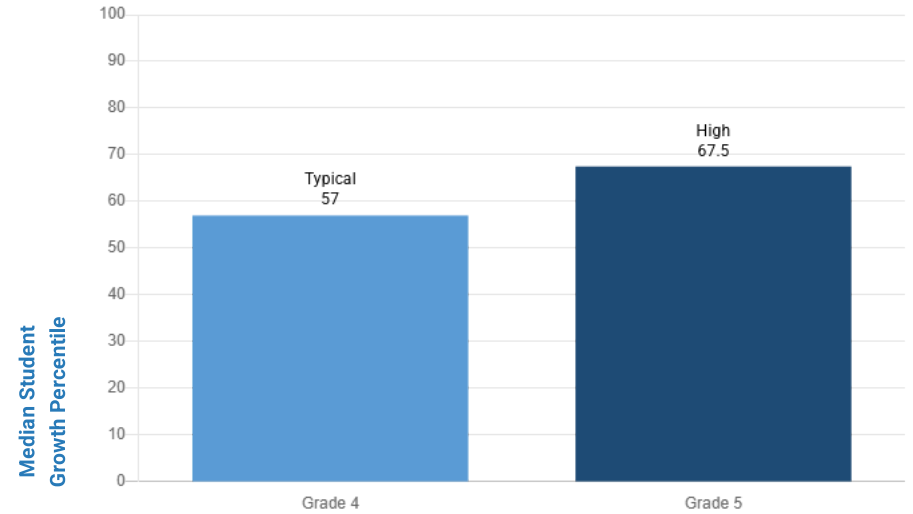

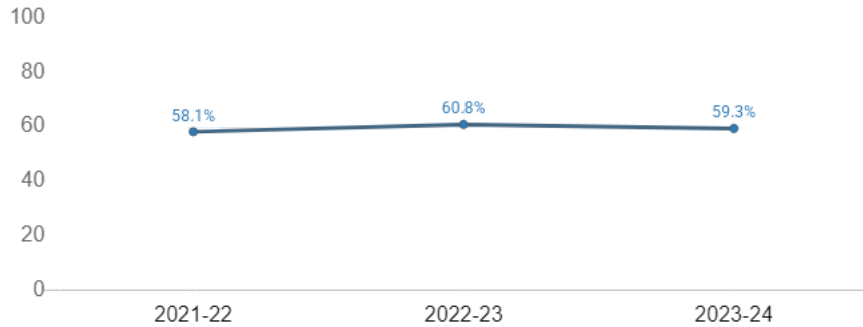

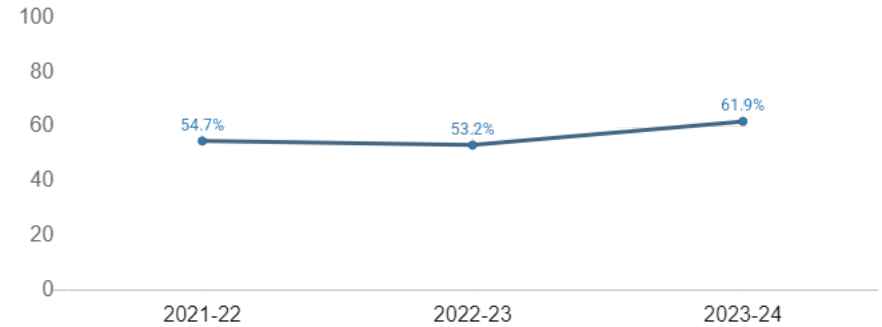
English Language Arts and Mathematics Performance Trends

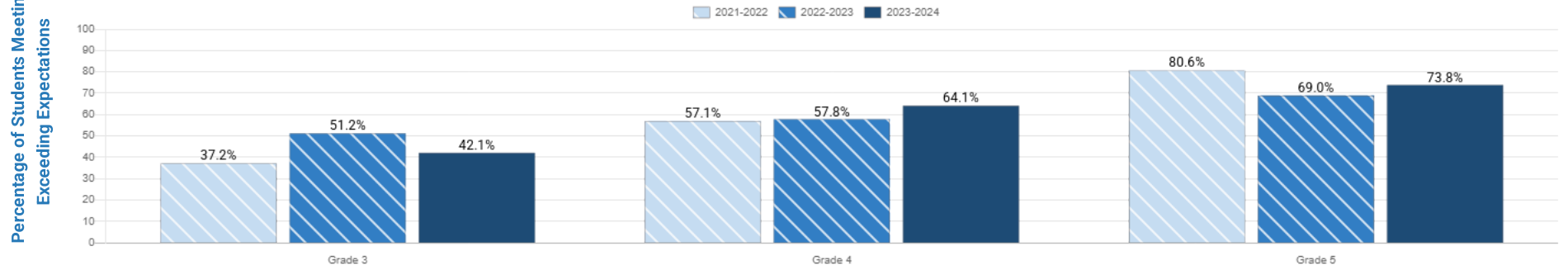

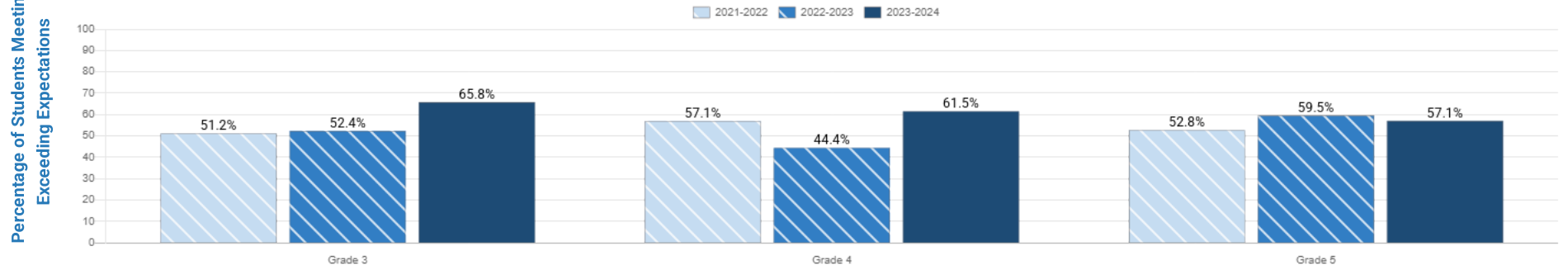

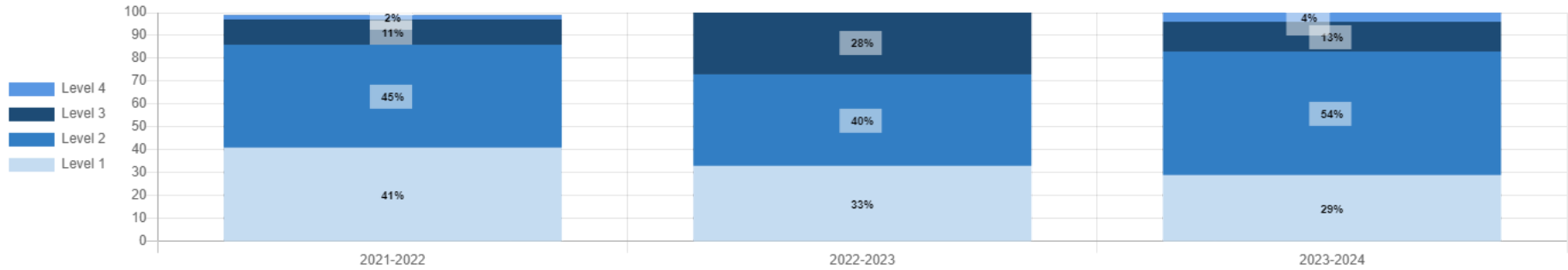

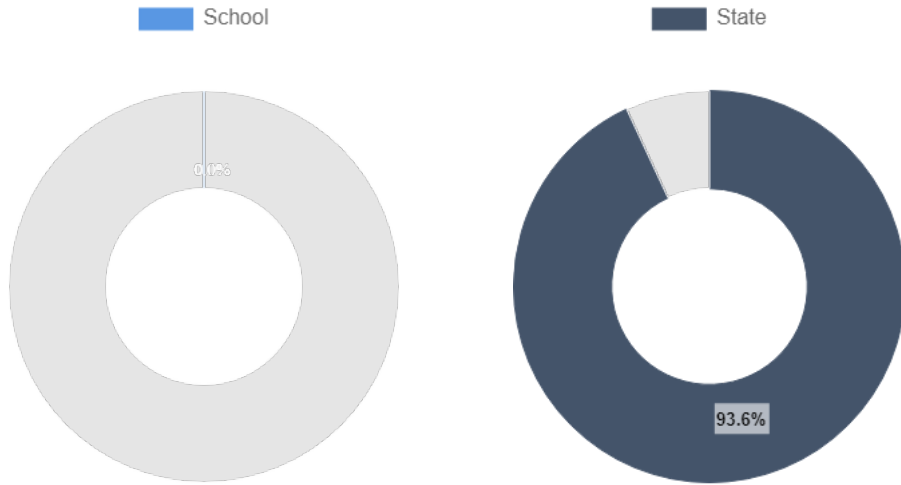

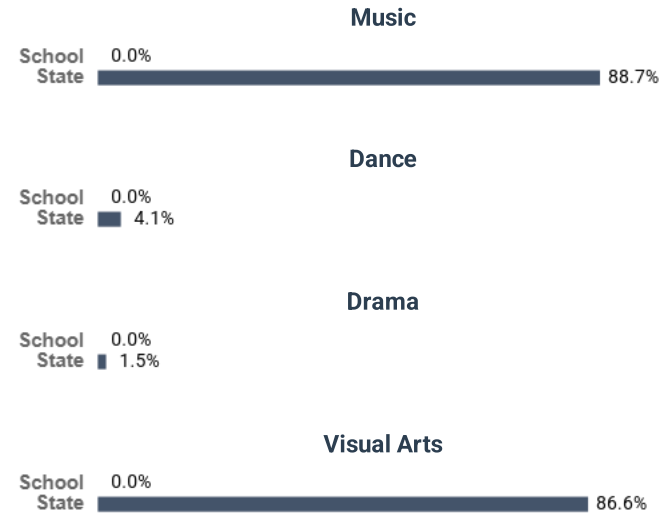

Students enrolled in one or more classes by discipline:



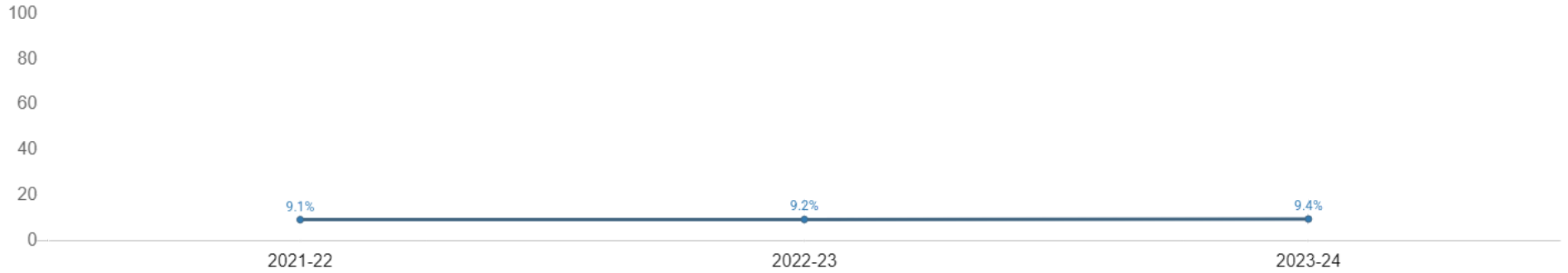

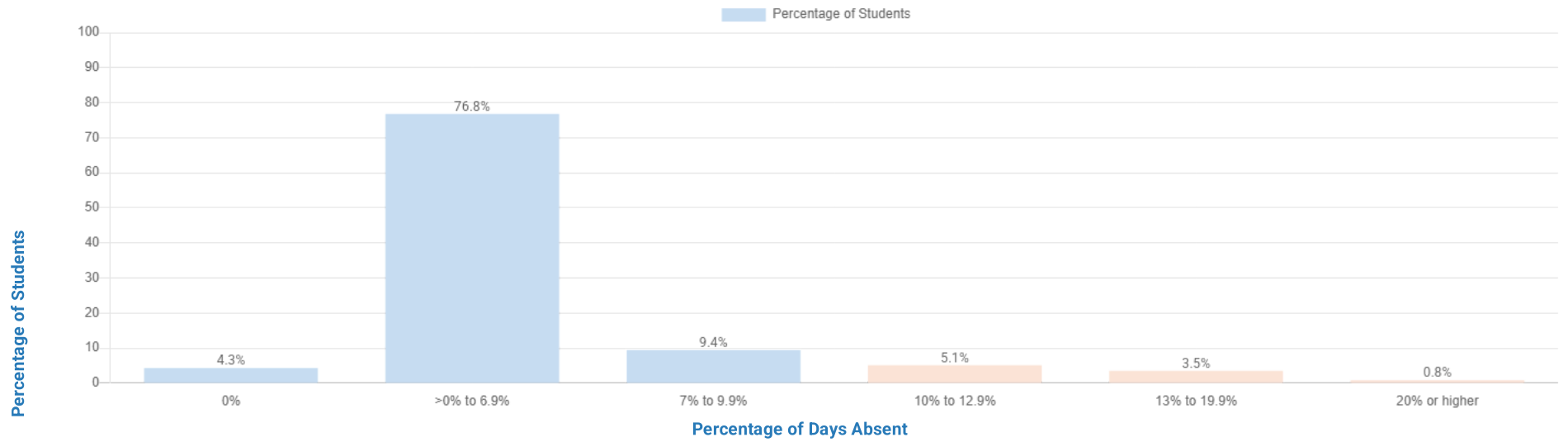

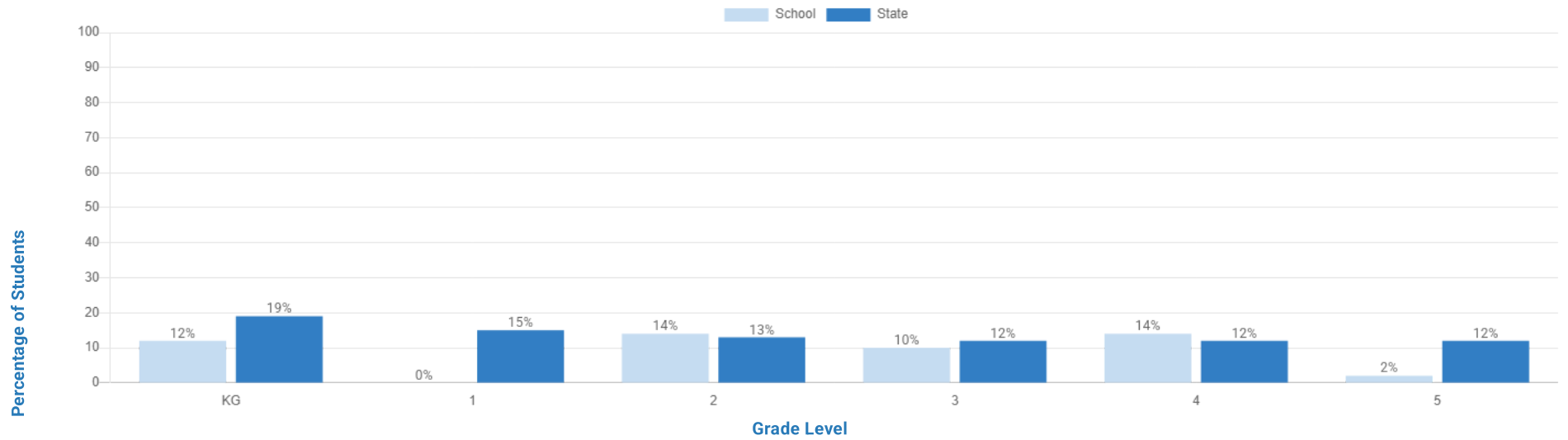

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 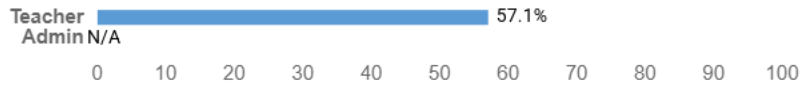

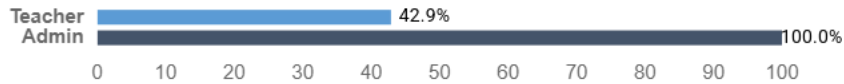

The quality education that students receive at School Nine is a result of a collaborative effort on behalf of the teachers, support staff, parents, and community. Our staff is dedicated to generating a passion for learning and exploration through an intellectually active learning environment designed to promote student choice and hands-on activities. Fostering a community characterized by mutual respect, smart choices, and academic excellence is our goal, as evidenced by our SQUAD UP Program. Students are rewarded with "Buddy Bucks" throughout the day if they are caught being KIND, RESPECTFUL, & RESPONSIBLE.



Courses, Curriculum, Instruction:

Our curriculum is aligned with and reflects the NJSLs. Teachers implement the enVisions 2.0 Math Program, a research-based math curriculum that cultivates higher order thinking skills while developing basic math proficiencies. Additionally, we implement adaptive math web-based programs that align to each student's instructional level in order to enrich, reinforce, or remediate their own math understanding. School 9 is a literacy-rich environment that nurtures a joyful community of readers. The Fountas & Pinnell leveled guided reading system is utilized in each K-2 classroom in an effort to meet students where they are in reading and to lead them forward into becoming fluent readers. Accelerated Reader is used to enhance reading skills in grades 2-5, as students strive to meet individual reading goals each marking period. We also use Foundations, a multisensory and systematic phonics, spelling and handwriting program to develop the foundational reading skills for all K-3 students.

Sports and Athletics:

Participation in recess, physical education, Clifton Recreation Center, the Boys and Girls Club and extracurricular activities, offers opportunities for students in grades preK-5 to be physically active. This has proven to help improve students' self-esteem/psychological well-being as well as increasing overall physical wellness.



Clubs and Activities:

Our school promotes a love and appreciation of the arts by providing instrumental music (band/strings), vocal music, and visual art opportunities throughout each school day. The breakdown includes the following: a standalone art class all K-5 students receive for 30 minutes once a week, a standalone vocal/general music class of 30 minutes once a week, and instrumental strings/band and chorus rehearsals for any 4th and 5th graders interested, that takes place once a week for 30 minutes. Lastly, theater is embedded in the language arts curriculum and dance is embedded in the physical education curriculum which all K-5 students receive.



Before and After School Programs:

School Nine provides both before and after school care for students whose parents choose to participate. This program is supervised by the Boys and Girls Club, with the before care program from 7:05 am to the start of the school day, and after care from 3:30 pm until 6:00 pm.

Staff and Professional Learning:

Clifton Public Schools have a strong emphasis on professional learning communities. District wide professional development plans are determined by school level improvement committees (SclP). Professional Learning Communities meet to further teachers' understanding of topics such as analyzing data to inform instruction, sharing best practices, assessing student work, and examining content-based benchmarks. All staff members are encouraged and supported by administration and district coaches as they implement new district initiatives throughout the year. Our School Collaborative Committee continues to work together in order to provide the best possible learning environment for our students.



Student Supports and Services:

School Nine is in its fifth year working in collaboration with the Rutgers University Boggs Center and continues to implement the PBSIS (Positive Behavior Support in Schools) district-wide initiative. PBSIS is a multi-tiered system of support for behavior, conduct and social-emotional wellness that promotes equity for all students. Through a 4:1 positive to negative correction ratio, students are taught the school wide expectations. Expectations and routines are modeled frequently. These expectations are utilized to reinforce appropriate expected behaviors in any school setting. The multi-tiered systems of support create a school environment that promotes safety and encourages success while we work collaboratively to achieve student goals.



Student Health and Wellness:

Students in grades K-5 are exposed to concepts related to good health and disease prevention to enhance overall health and wellness. These lessons on family, peers, culture, media, and technology promote overall health and wellness. Students practice the ability to use interpersonal communication skills to enhance health and wellness and avoid or reduce health risks by practicing good decision-making and goal-setting skills.

Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
