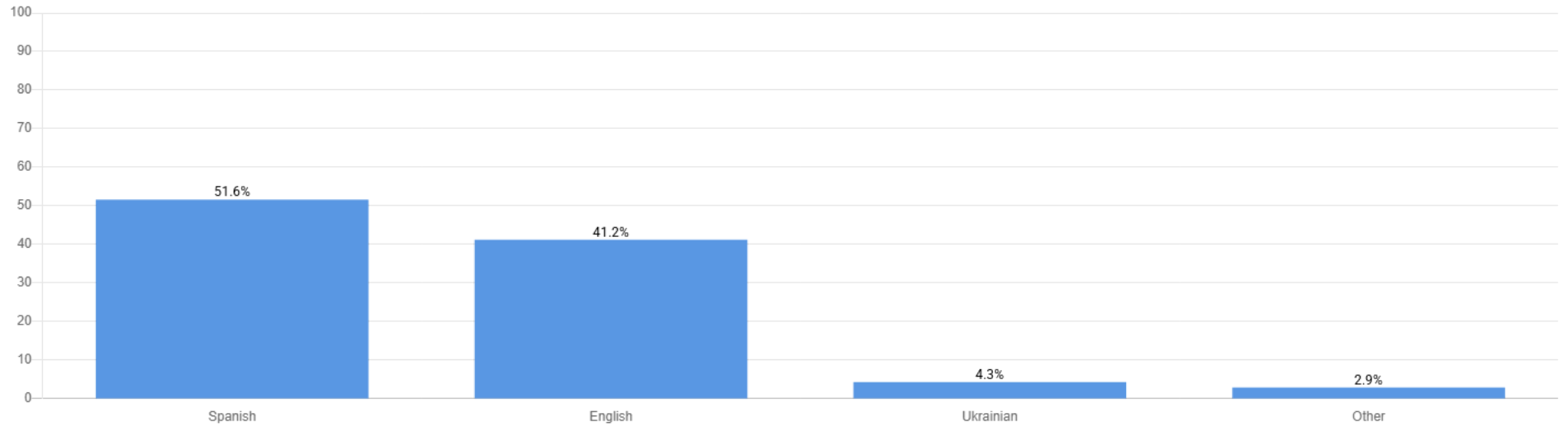

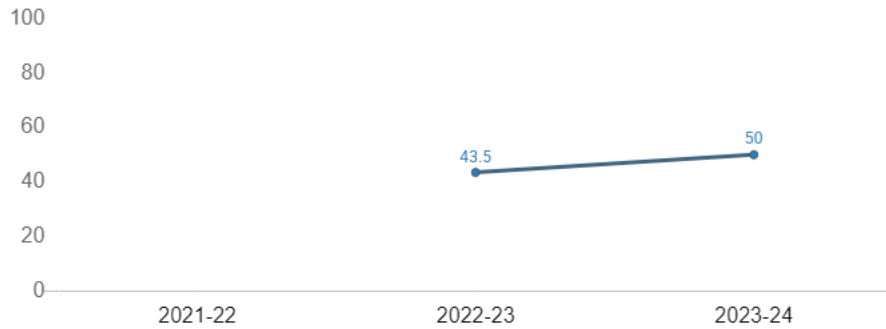

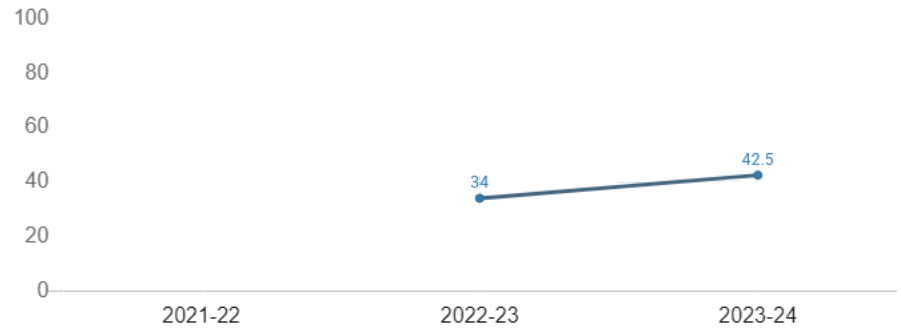

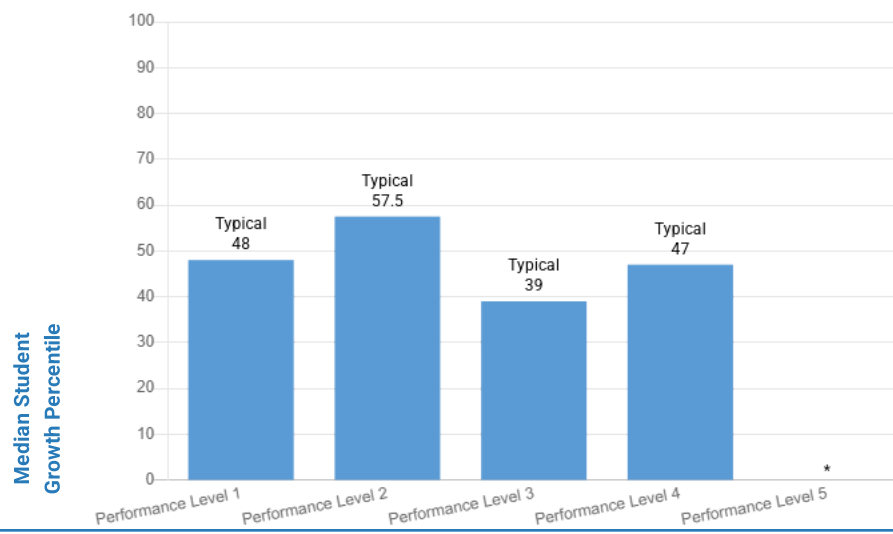

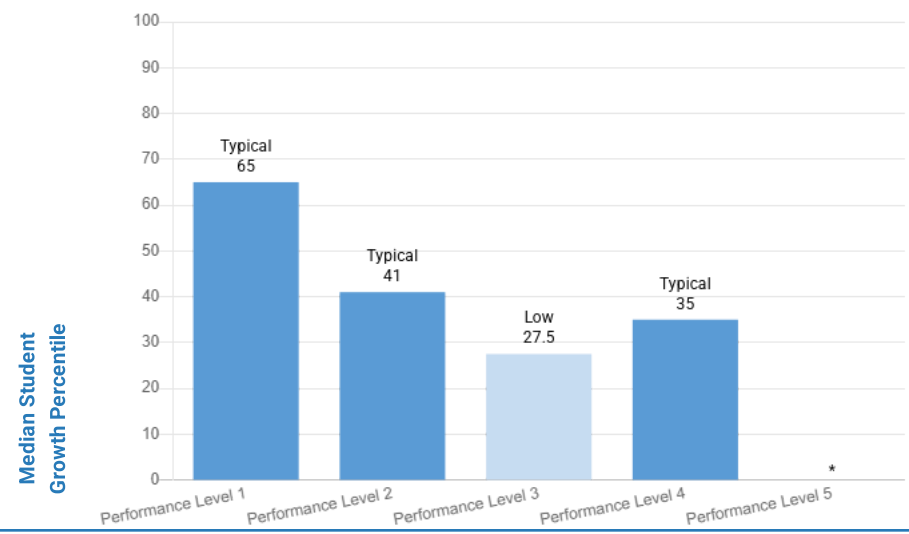

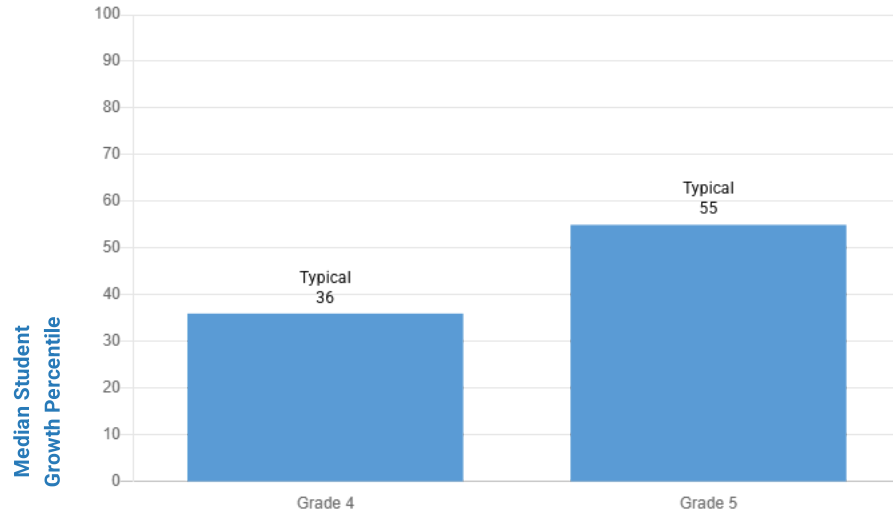

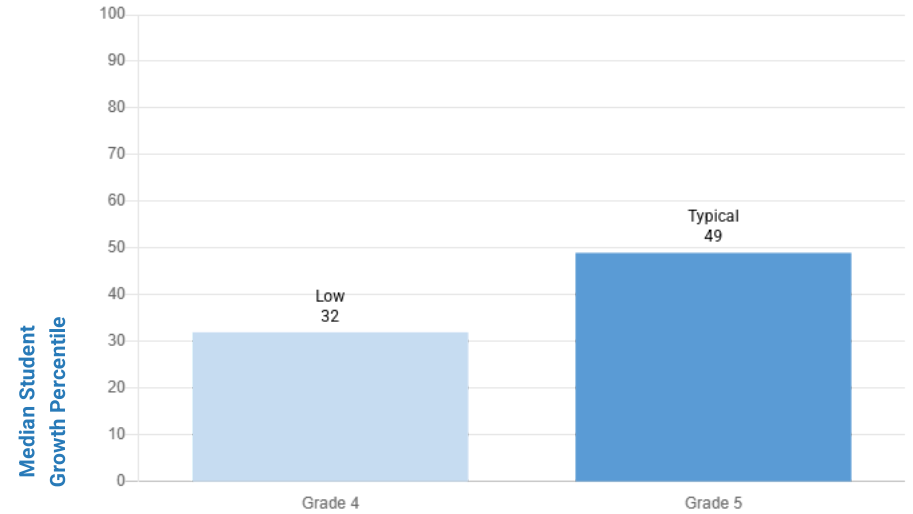

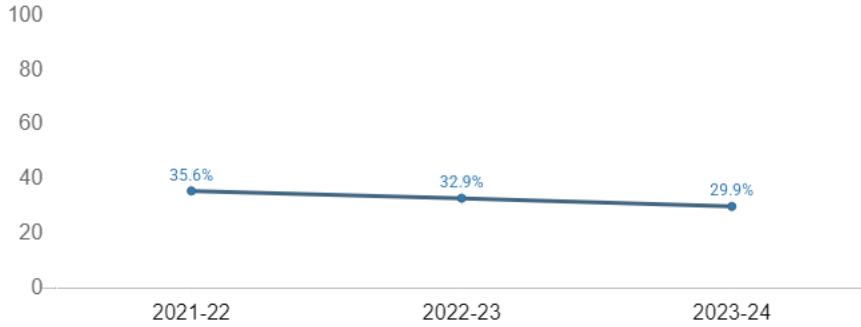

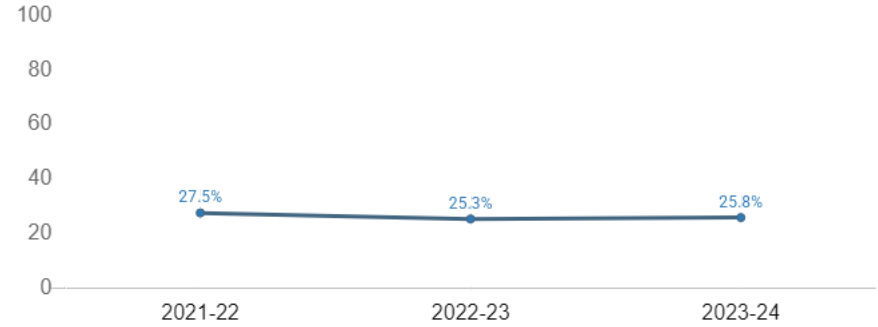
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

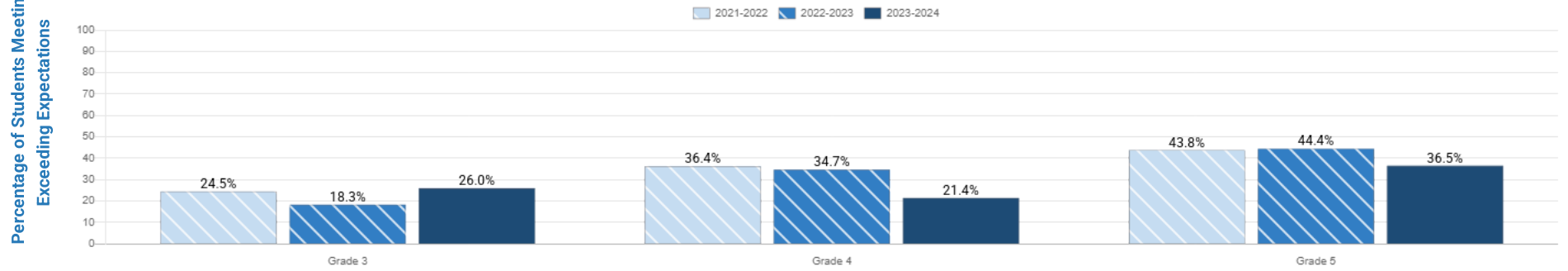

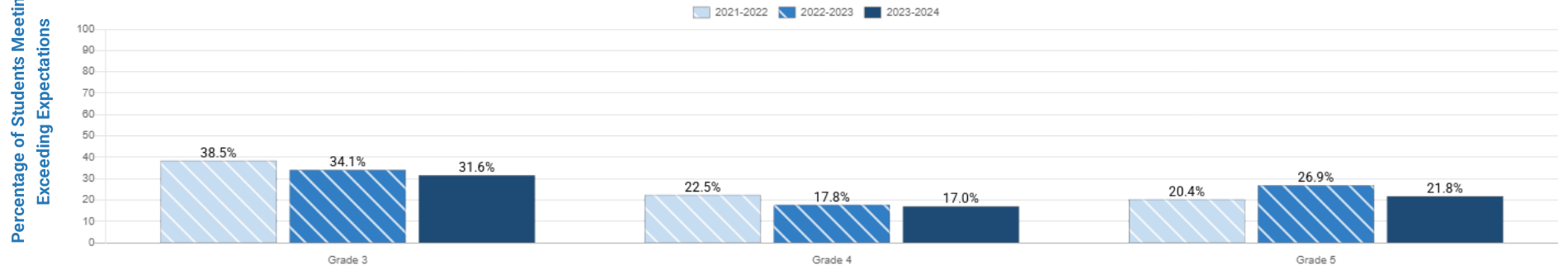

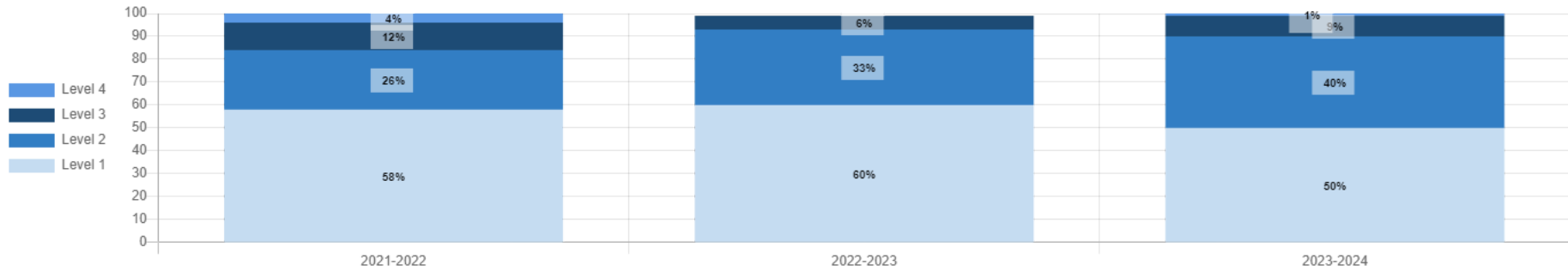

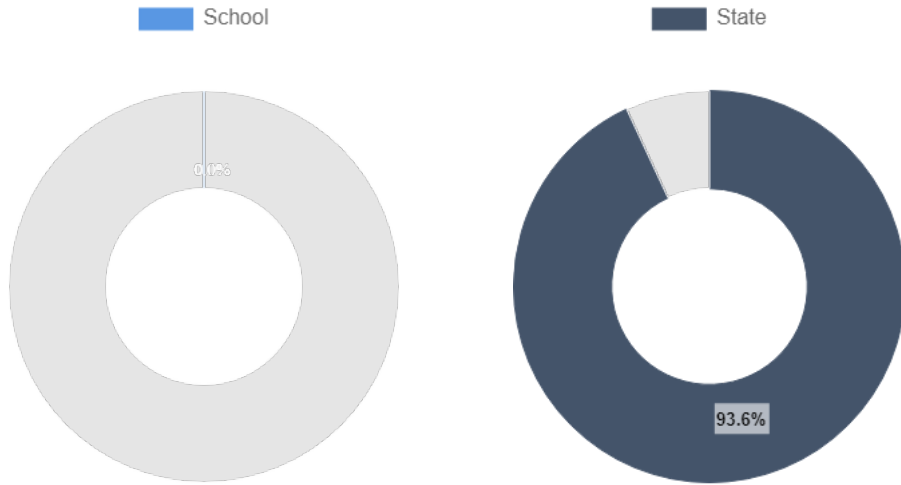

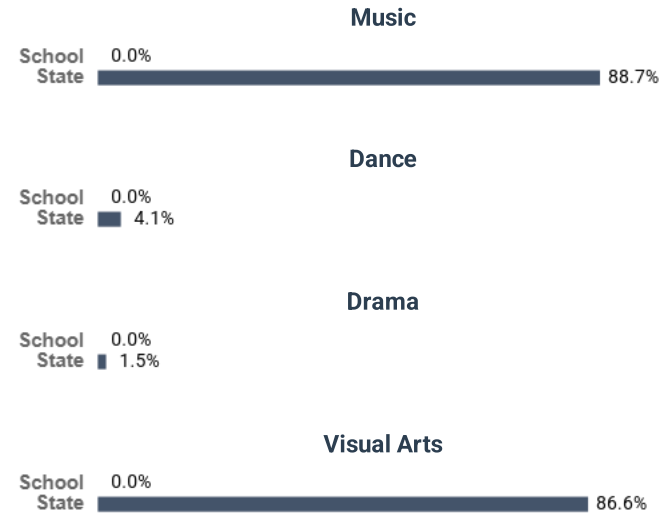

**Students enrolled in one or more classes by discipline:**



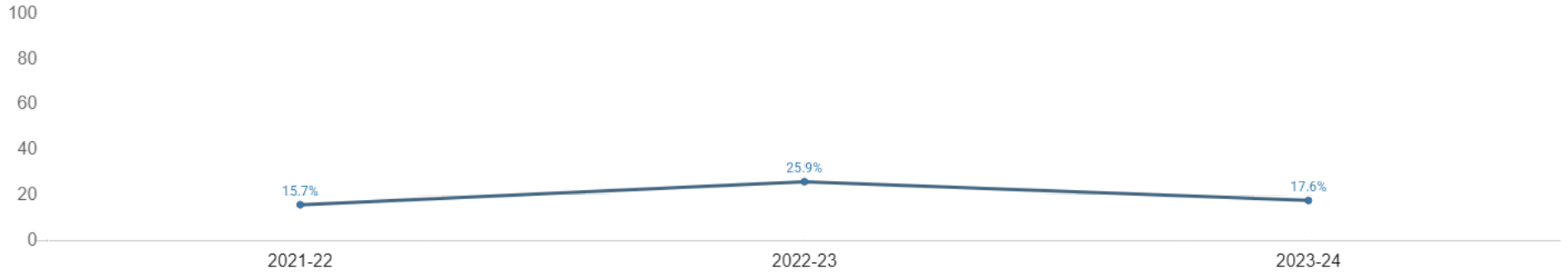

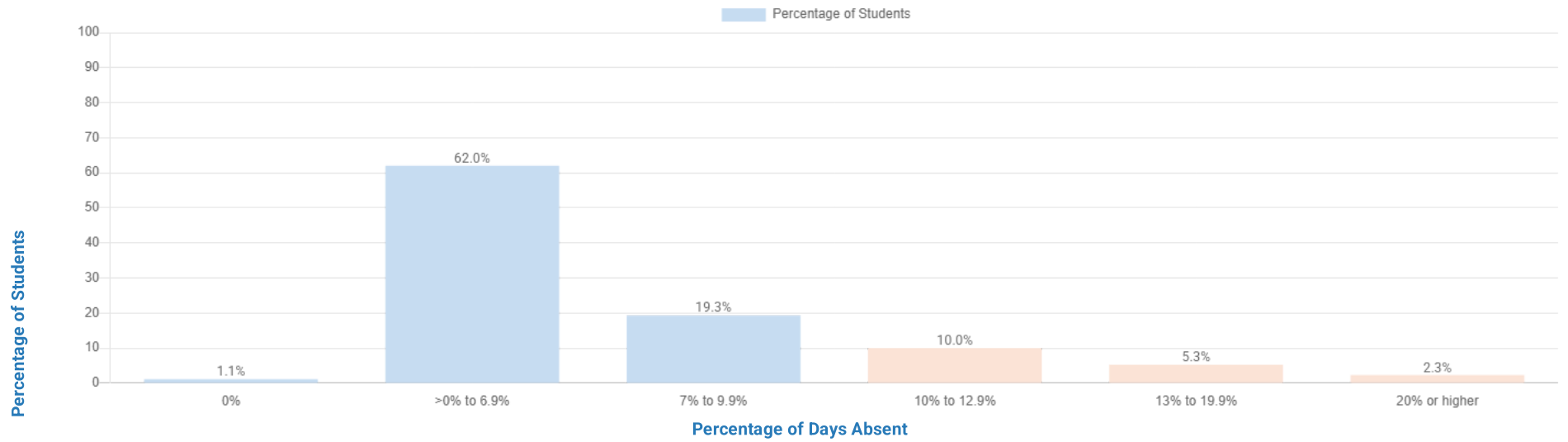

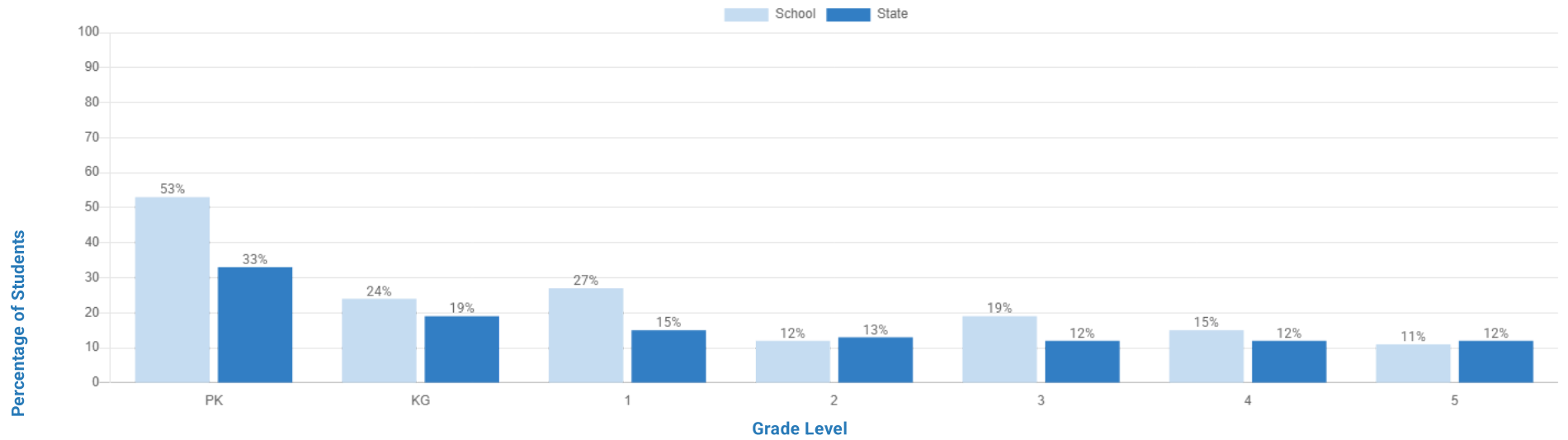

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

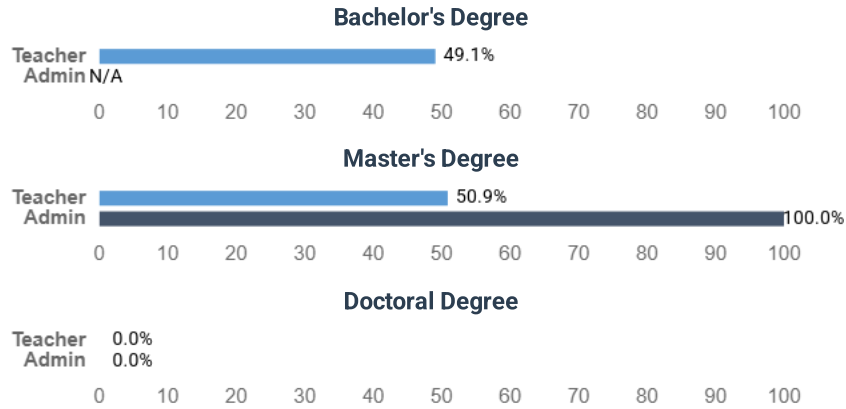

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ### Mission, Vision, Theme:

School Twelve is the largest elementary school in the city of Clifton, N.J. The school serves two campuses. All of our programs have proven to be extremely beneficial for the staff and children. Our students reflect a diverse population. School Twelve has self-contained bilingual classes as well as ESL grades kindergarten through grade five. Our school is comprised of a diverse, multicultural, multilingual community and offers students a variety of positive award programs. School Twelve believes that it is the inherent right of every child enrolled to receive a sound education rooted in equal opportunity and delivered in an environment that ensures physical, mental and emotional security. School Twelve recognizes the importance of promoting early literacy as a foundation for academic success. Through its instructional programs and co- and extra-curricular experiences, students will become independent thinkers, good decision makers and self-supporting productive citizens.



### Awards, Recognition, Accomplishments:

School Twelve has been recognized by the State of New Jersey Department of Education for exiting Focus School Status thus closing the achievement gap three years after having been designated a Focus School. School Twelve was re-awarded a 21st Century Grant for approximately \$500,000.00 a year for an additional five years. The academic centerpiece of the program is STEAM (Science, Technology, Reading, Engineering, Arts and Mathematics). Parent involvement is an important aspect of our School Twelve community and both the Principal and Assistant Principal have an open door policy. Parent concerns are addressed in a timely fashion at all times. School Twelve parents participate in activities available to the children such as grade level Family Math Nights and Family Fun Nights, Family Literacy and all extra-curricular activities are always well attended by the students and parents.



### Courses, Curriculum, Instruction:

Our curriculum is aligned with and reflects the New Jersey Student Learning Standards. Teachers implement the enVisions Math Program, a rigorous research-based mathematics curriculum that promotes hands-on activities; inquiry based teaching, small group cooperative learning, and differentiation. Additionally, we implement adaptive mathematics web-based programs that align to each student's instructional level in order to enrich, reinforce, or remediate their own mathematical understanding. School 12 is a literacy-rich environment that nurtures a joyful community of readers. The Fountas & Pinnell leveled guided reading system is utilized in each K-2 classroom in an effort to meet students where they are in reading and to lead them forward into becoming fluent readers. We also use Foundations, a multisensory and systematic phonics, spelling, and handwriting program to develop the foundational reading skills for all kindergarten through grade three students.

### Sports and Athletics:

Participation in recess, physical education, Clifton Recreation Center, the Boys and Girls Club and extracurricular activities, offers opportunities for students in grades PK-5 to be physically active. This has proven to help improve students' self-esteem/psychological well-being as well as increasing their overall physical wellness. The physically literate individual demonstrates competency in a variety of motor skills and movement patterns, as well as applying knowledge of skills to achieve and maintain a health-enhancing level of physical activity and fitness. This allows our K-5 students to recognize the value of physical activity for health, enjoyment and self-expression.



### Clubs and Activities:

Our school promotes a love and appreciation of the arts by providing instrumental music (band/strings), vocal music, and visual art opportunities throughout each school day. The breakdown includes the following: a standalone art class all K-5 students receive for 30 minutes once a week, a standalone vocal/general music class of 30 minutes once a week, and instrumental strings/band and chorus rehearsals for any 4th and 5th graders interested, that takes place once a week for 30 minutes. Lastly, theater is embedded in the language arts curriculum and dance is embedded in the physical education curriculum which all K-5 students receive.



### Before and After School Programs:

School #12 provides an aftercare program in conjunction with the Boys and Girls Club of Clifton beginning immediately after dismissal. Additionally, students in grades 3, 4 and 5 can participate in Minds in Motion, and afterschool program, funded through a 21st Century Learning Grant.

### Staff and Professional Learning:

Clifton Public Schools have a strong emphasis on professional learning communities and collaboration. District wide professional development plans are informed by school level improvement committees such as school collaborative teams. Professional Learning Communities meet to deepen teacher understanding of topics such as using data to inform instruction, sharing best practices, looking at students' work, and examining content-based benchmarks. As a district, we encourage and support our staff to continue to be lifelong learners.



### Student Supports and Services:

The School 12 PBSIS program is a school-wide positive reinforcement/character education program that encourages students to exhibit good behaviors and show Responsible, Respectful and Resilient actions to help their teams earn tickets throughout the school day. Students review school wide and location expectations in their classroom through posters and videos. Students earn tickets / Dojo points which accumulate to earn prizes. Tickets are also given at lunch by administrator/ lunch duty personnel for cleaning up and following proper lunchroom expectations. We continually give PBSIS updates during morning announcements to encourage the classes to keep earning tickets. We have "pep rally days" as celebrations with different fun academic activities and incorporate messages of being Responsible, Respectful and Resilient.



### Student Health and Wellness:

Our school counselor implemented groups to meet with our students and help our students in the areas of academic, career and social/emotional. The purpose of the social/emotional group is to address personal growth, student achievement and student behavior. In addition, through the social emotional program we want every student to understand and be able to manage their emotions, relationship building, problem solving and decision-making skills. Students through the social emotional program will be able to achieve academically, improve attitudes towards self and others, improve their positive behaviors by decreasing negative behaviors and overall improve school climate.

### Parent and Community Involvement:

School 12 has teamed up with the Clifton Teachers' Association and the HSA to create family engaged activities for the school year. We provide events to promote learning like Family Literacy & Math Nights. At these events, the staff creates activities that parents can do at home with their children. The CTA PRIDE and FAST programs also sponsor events with our families like craft nights, movie nights, vendor fairs and meals with holiday characters. Our HSA is always looking for members to join in on the fun!



### Early Childhood Education:

Clifton Public Schools offers 2 preschool program options: preschool for children with special needs and a state-funded preschool program. The free preschool program for children with special needs assists children ages 3 to 5 who have special needs. If eligible, there are inclusive opportunities within the state-funded preschool program. In addition, self-contained classrooms are also available throughout the preschool program. The free full-day, high-quality state-funded preschool program is available on a first-come, first-serve basis for age eligible 3 and 4 year-olds that live in Clifton upon completion of the registration process. With a strong relationship with Head Start and a growing list of private providers, our state-funded preschool program currently consists of 46 fully inclusive classrooms, located in 12 locations throughout the district taught by a certificated preschool teacher with a teaching assistant.



### Attendance:

The district has strategically funded instructional and behavioral interventions and support, as well as wrap around programs to address learning differences. High dosage tutoring has been implemented where possible and a comprehensive summer school program was offered to at-risk students across the district K through 12 to provide supplemental language arts, math and stem enhanced instruction. With a strong focus on student mental health, nurtured heart training has been expanded to many staff members and counseling and special education services have been expanded. Additional intervention teachers, counselors, social workers and behaviorists have been hired to address behavioral and developmental delays resulting from interrupted education.
