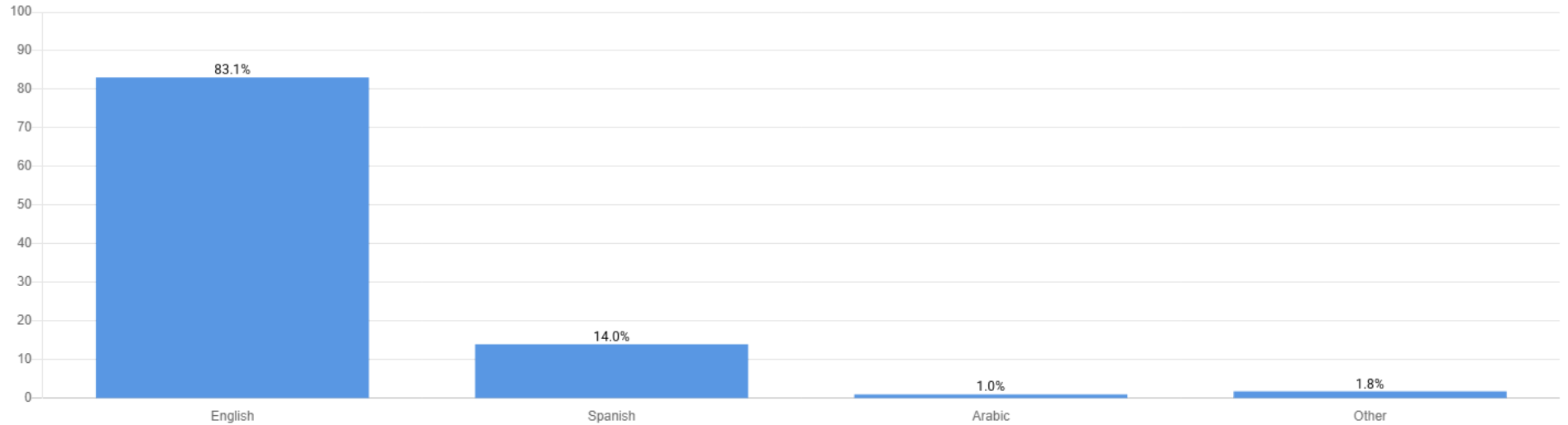

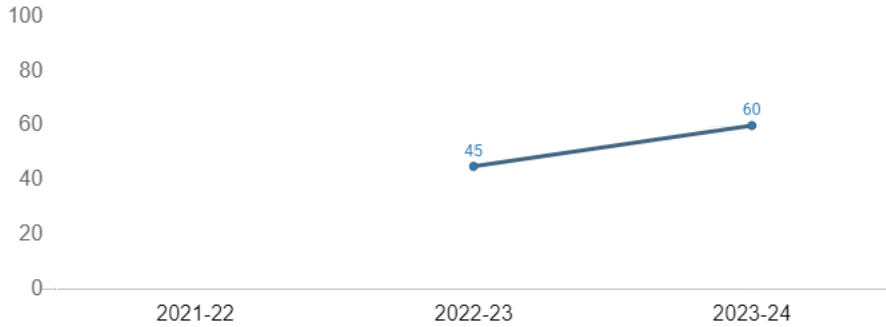

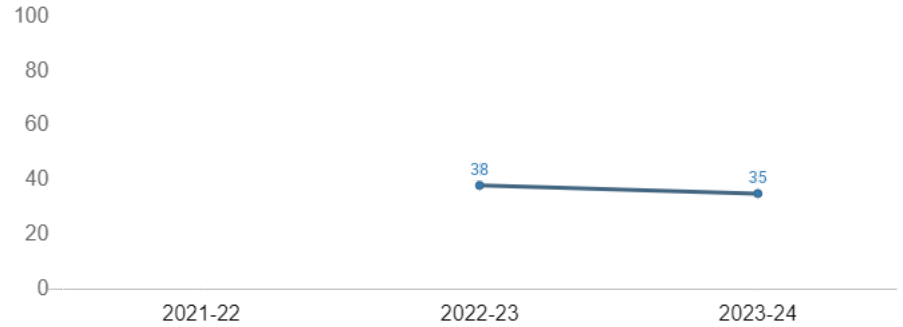

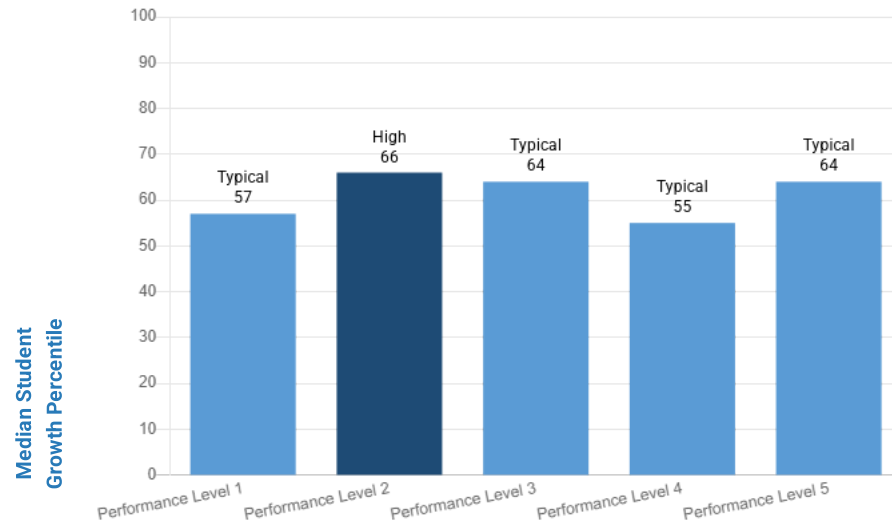

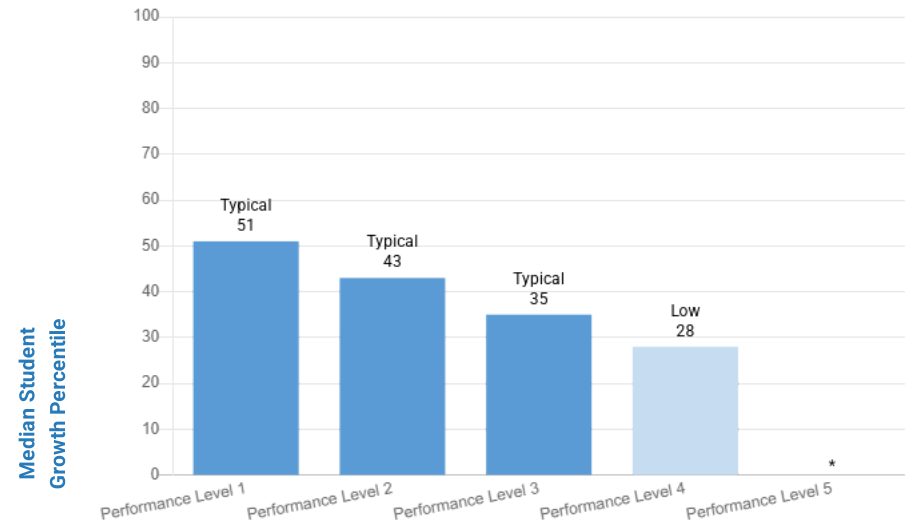

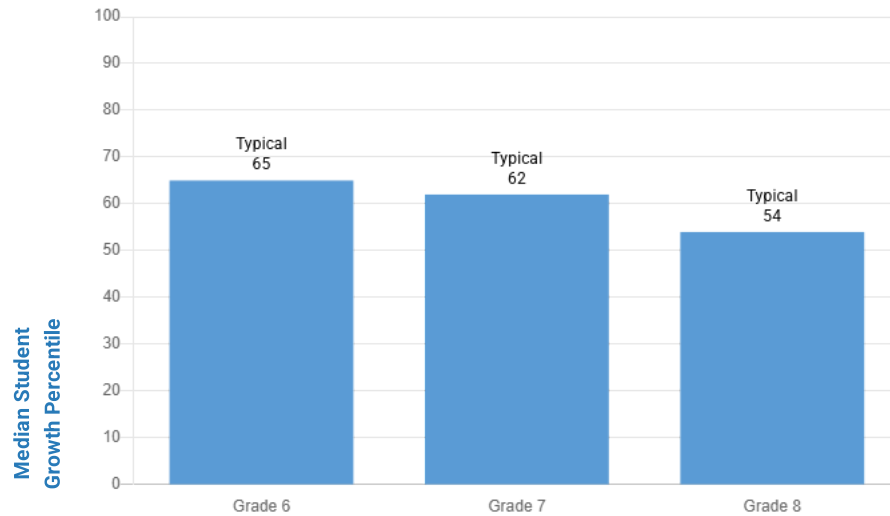

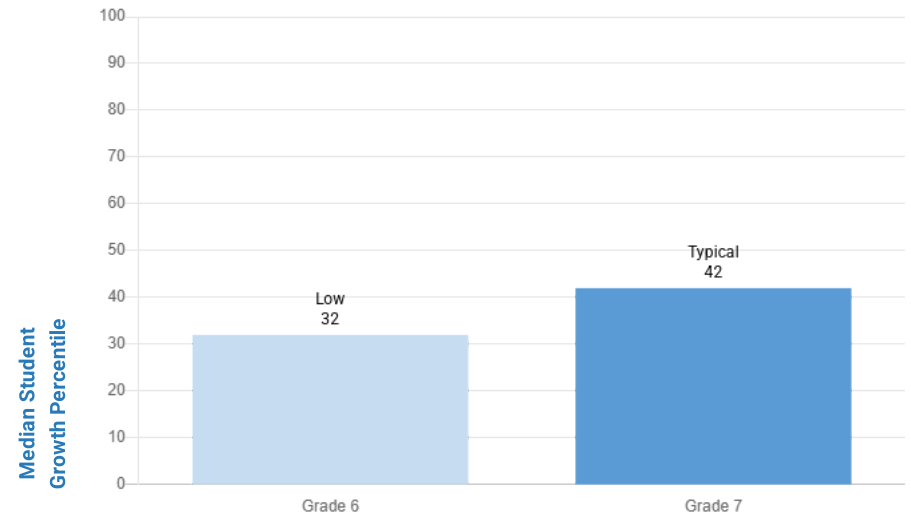

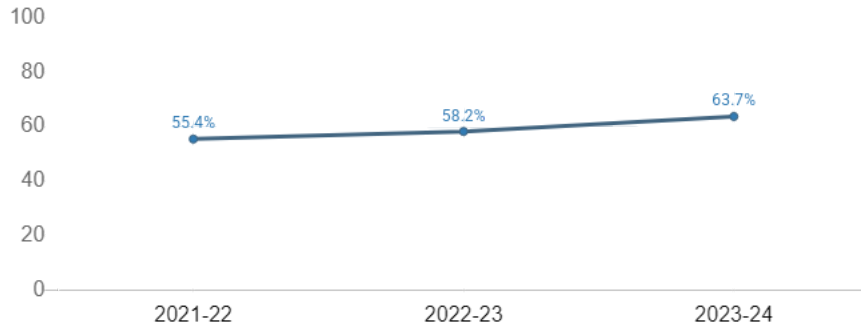

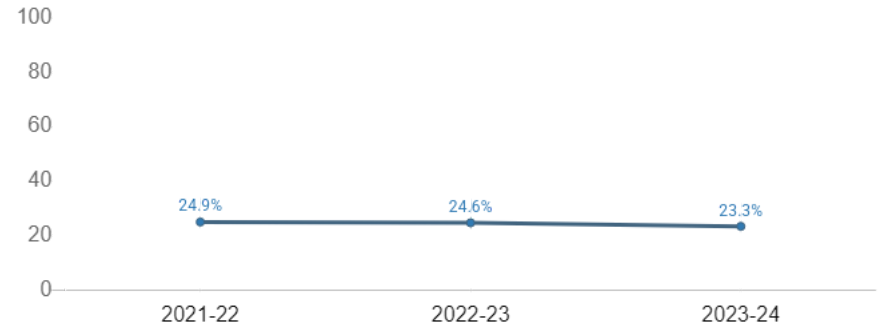
English Language Arts and Mathematics Performance Trends

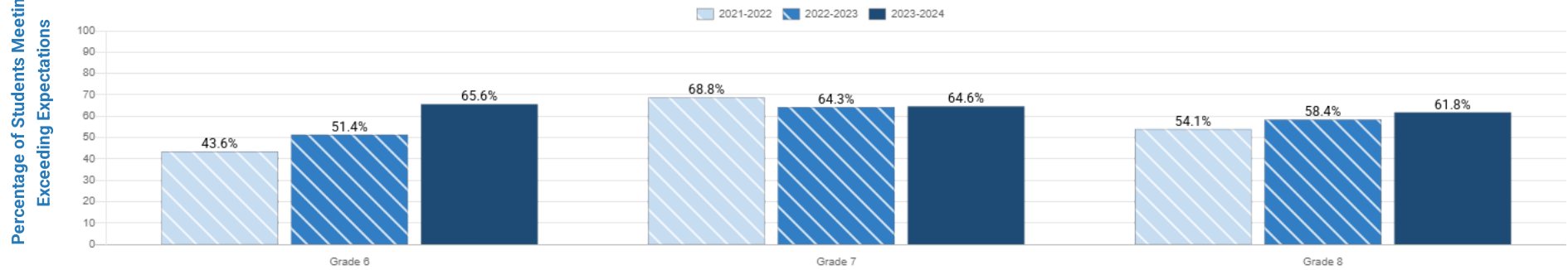

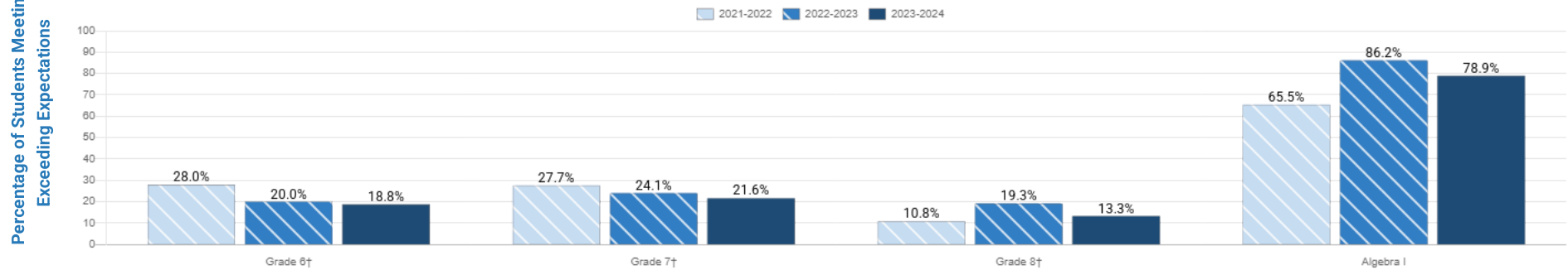

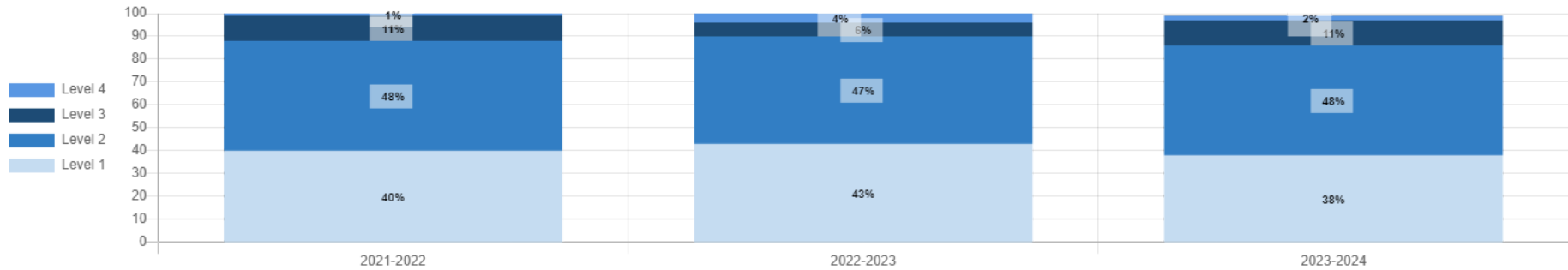

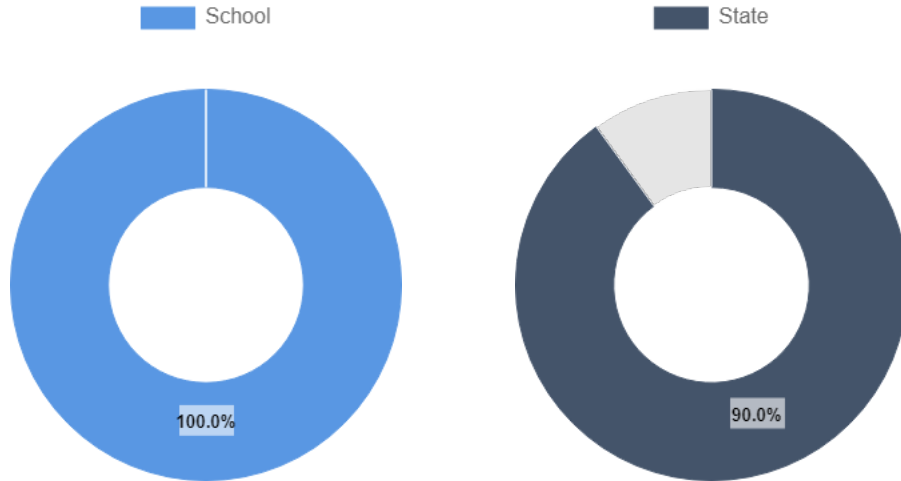

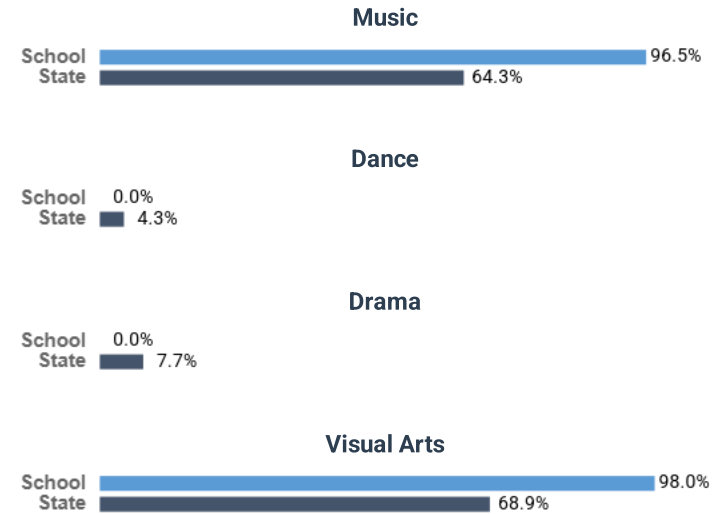

Students enrolled in one or more classes by discipline:



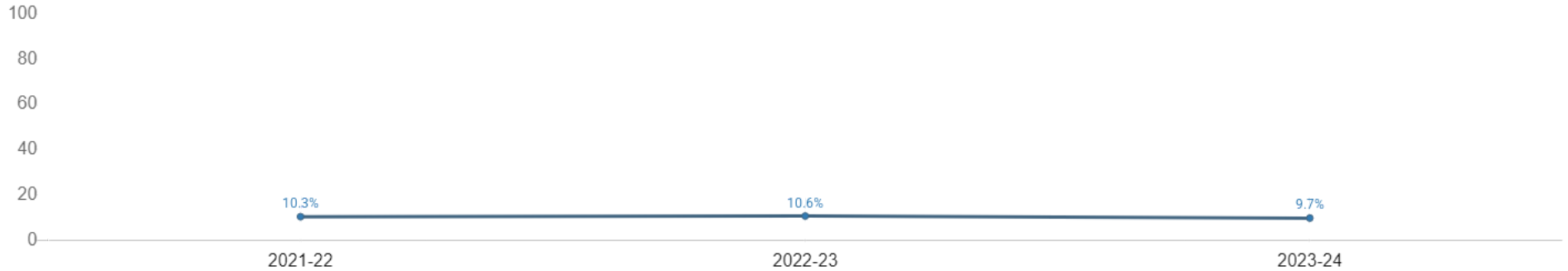

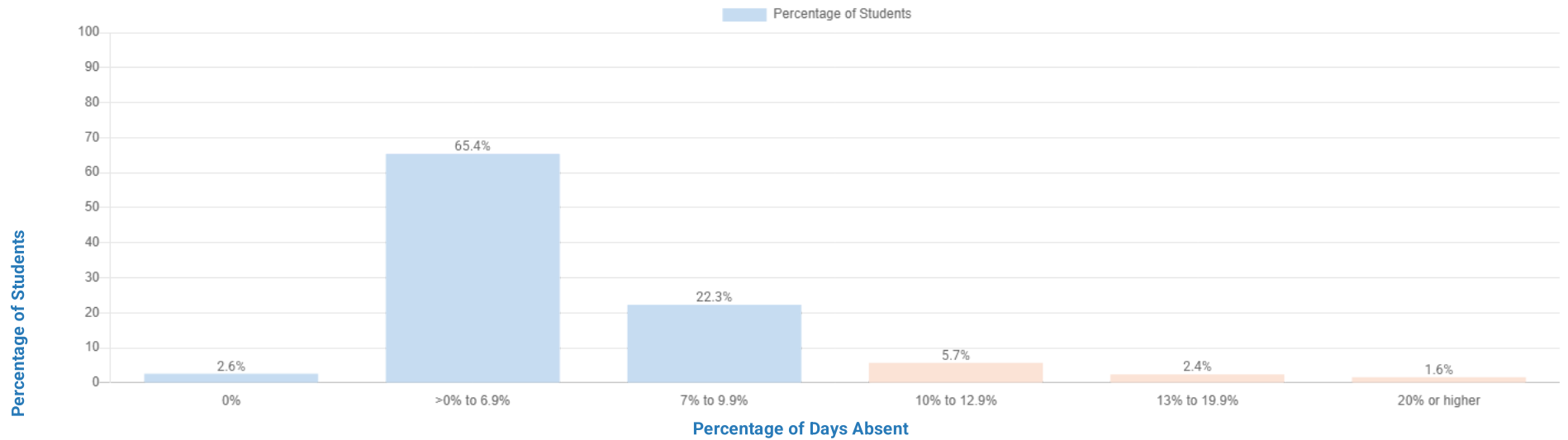

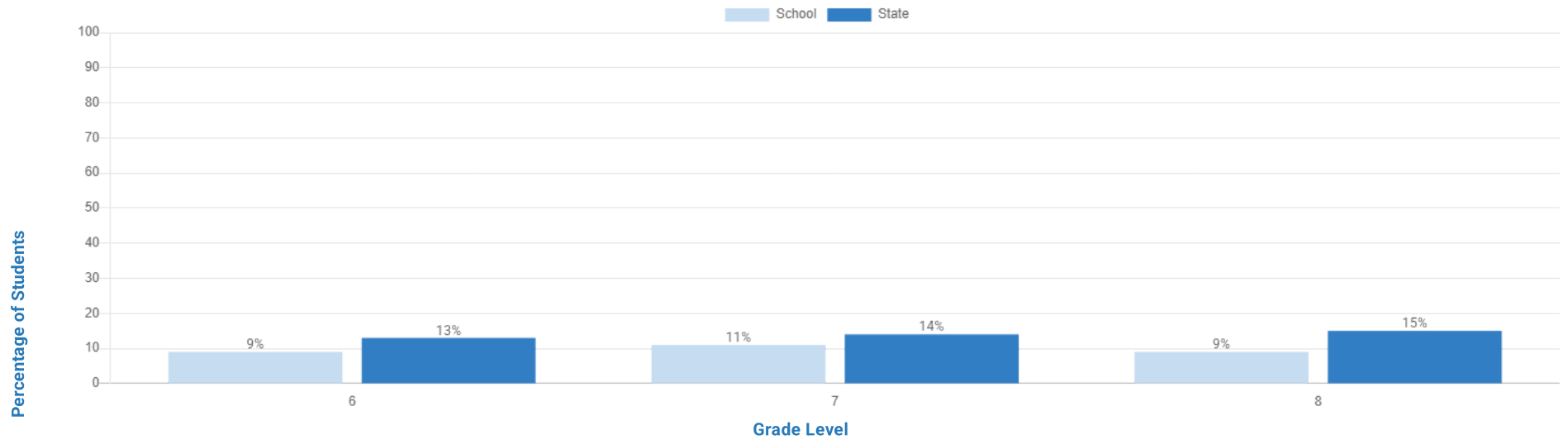

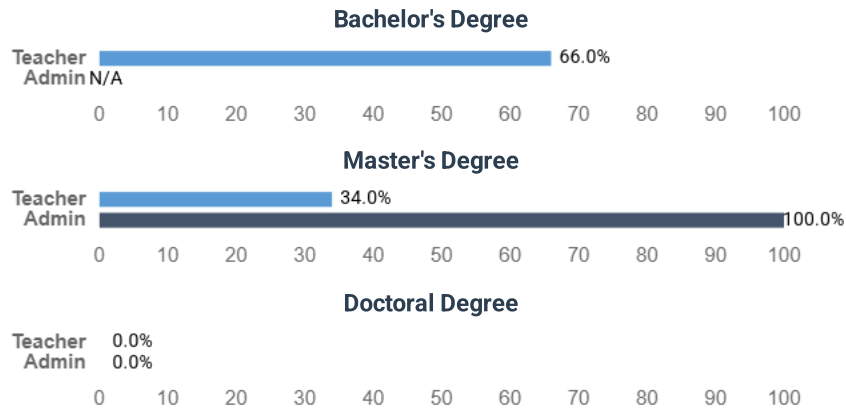

Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

The NJDOE identified schools for ATSI status based on data from the 2022-2023 school year, so schools will not be identified for ATSI status based on data from the 2023-2024 school year. The table below will show the summative score for each student group, but it will not show a cut-off score or indicate that a student group has been identified for ATSI status since it is not an identification year.

Schools will be identified for TSI status based on data from the 2023-2024 school year, since that is required annually. The remaining columns in the table show whether each student group met annual targets or standards for all indicators for the 2023-24 school year. If at least one student group did not meet all targets and also did not meet all targets in the 2022-23 school year, then the school will be identified as requiring TSI.

Facilities:

LMS classrooms include a newly renovated Media Center, two newly renovated science Labs, two computer labs, an art room, a gymnasium and a STEM room with 3-D printers. We have recently update all lockers throughout our hallways as well as our physical education locker rooms. New doors and new windows were recently installed to improve the LMS facilities.

Seventh graders partake in a STEM course where they utilize 3-D printers and learn about the engineering process through a variety of hands on projects. Eighth graders take a STEAM course as a marking period elective.

Other Information:

LMS is currently home to 560 students in grades 6-8 with over 85 full and part-time staff. The day consists of 7, 51 minute classes. Students take Language Arts, Math, Science, Social Studies, Health, and Physical Education. Students have a choice of instrumental, vocal, general music or music technology. Student electives include: World Language, Art, Computers, Media Arts, STEM, STEAM, 21st Century Technology and Careers, and Research and Writing. These courses provide the students with the breadth of educational experiences needed for intellectual growth and for participation in our democratic society. The 6th and 7th grades are organized into two academic teams per grade level which foster collaboration and communication between team members. LMS is a Title I Targeted Assistance School and provides a basic skills program which supports both a push-in and pull-out support models. Students identified with special academic abilities are eligible to participate in our Network Program. Students are provided with educational enrichment experiences, which nurture their special strengths. These activities are in addition to their regular program of instruction. Technology integration is an ongoing point of emphasis at our school. Additionally, classes utilize Google Classroom to enhance learning and promote collaboration.
