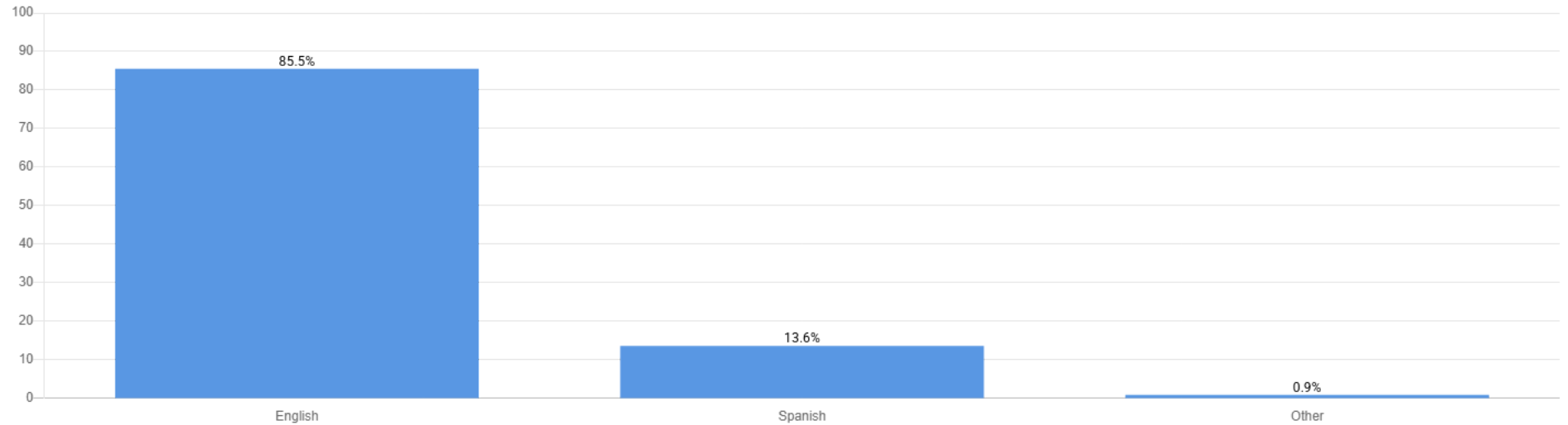

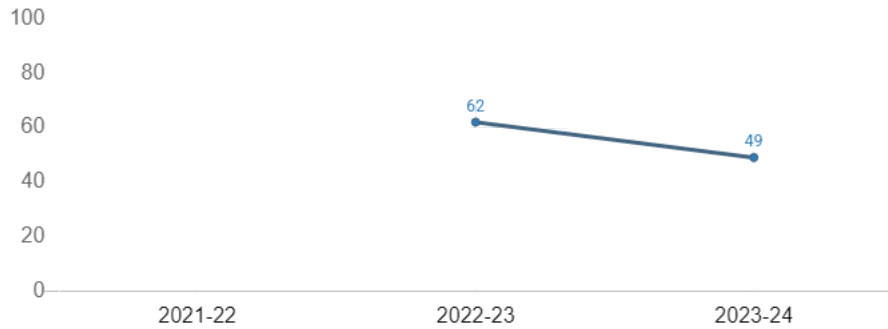

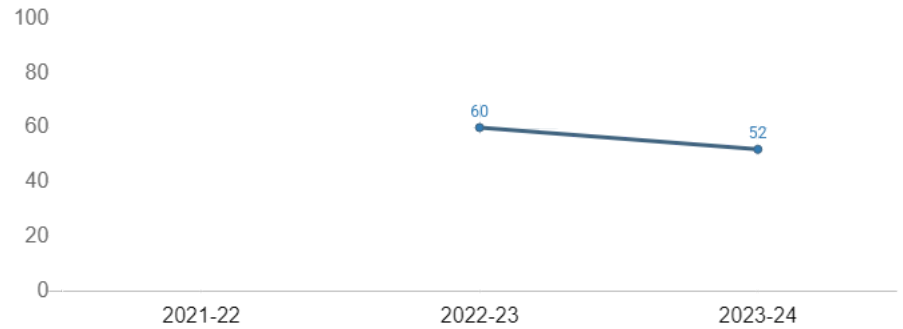

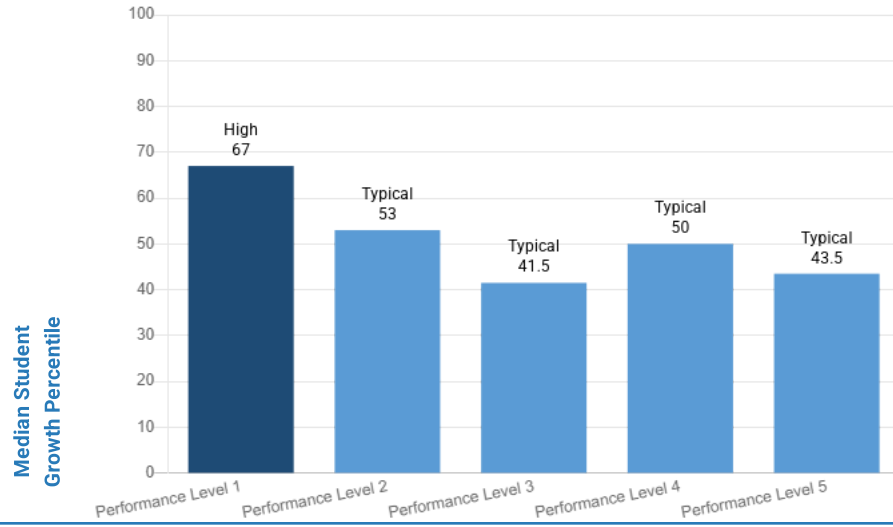

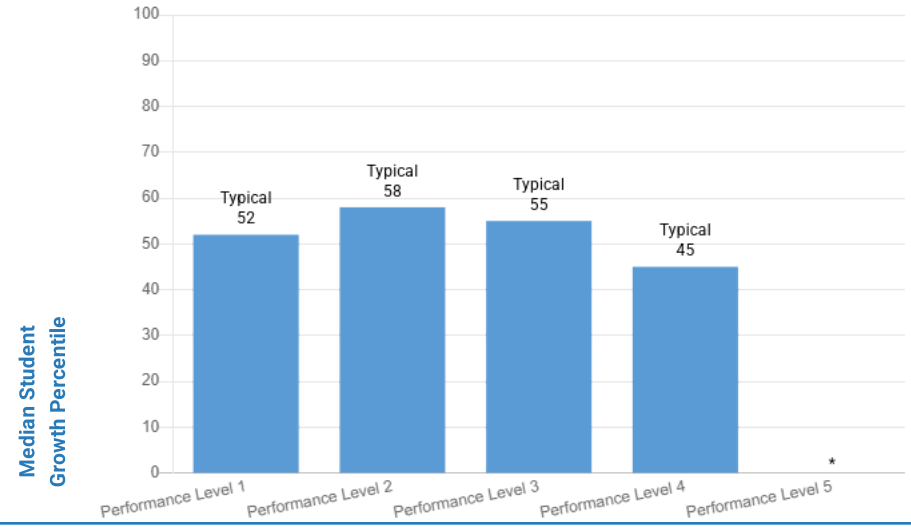

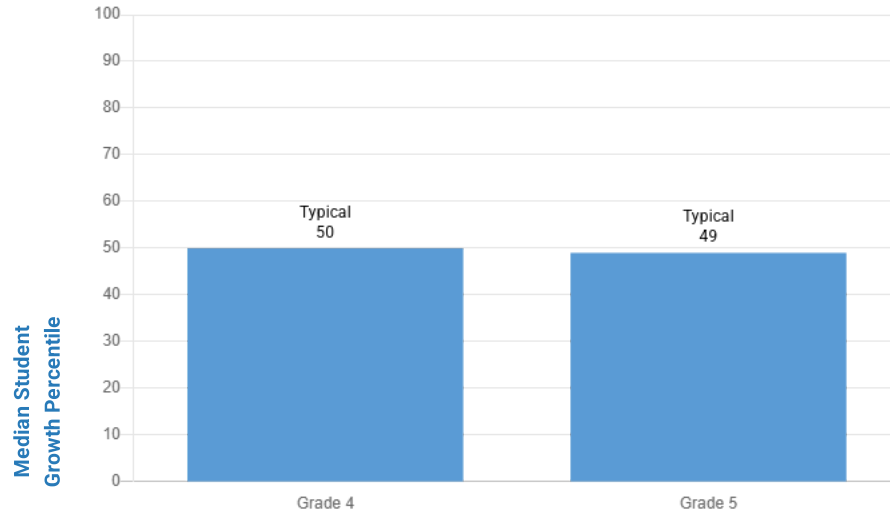

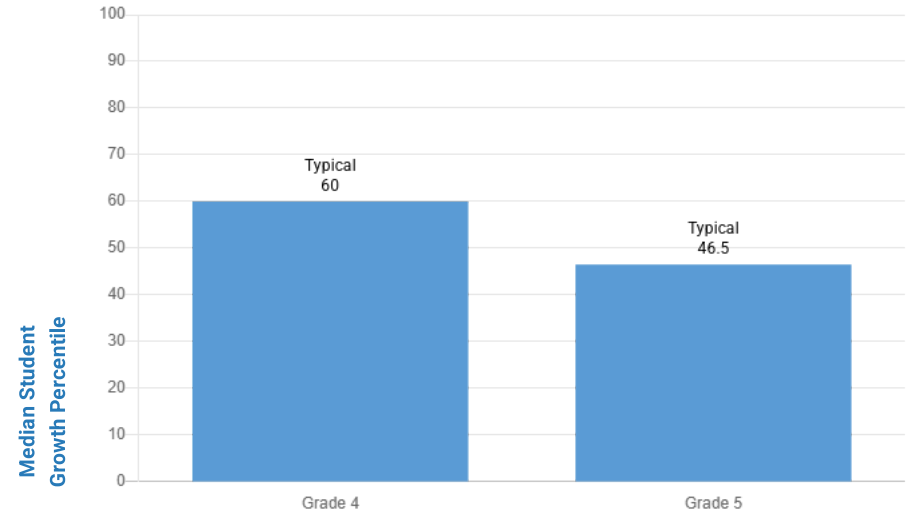

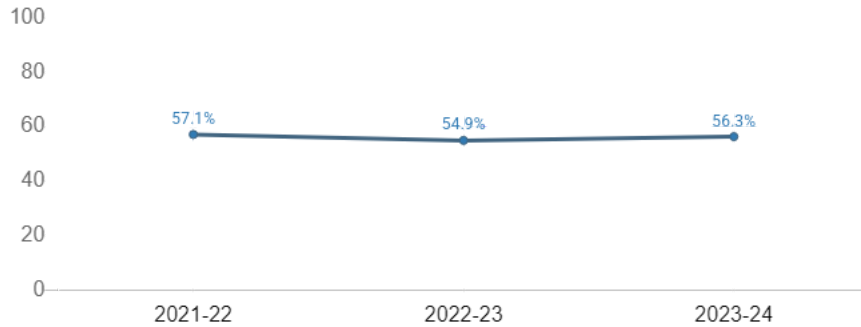

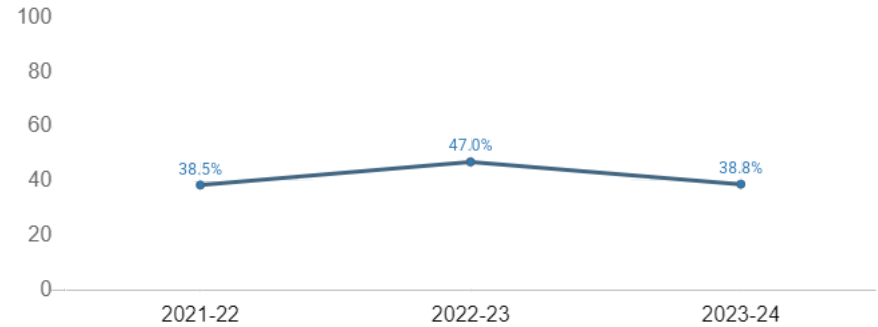
English Language Arts and Mathematics Performance Trends

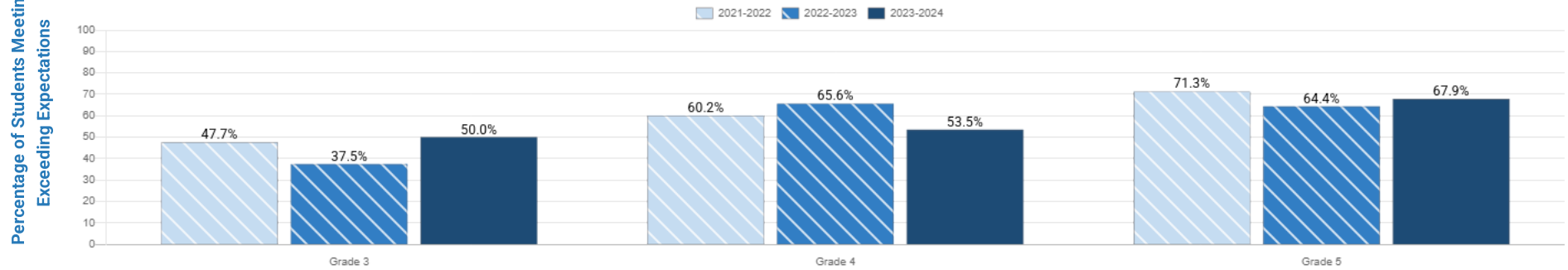

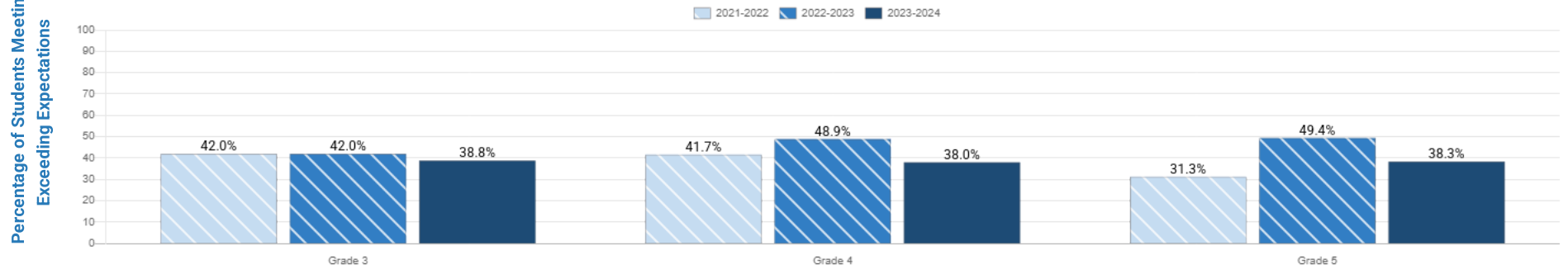

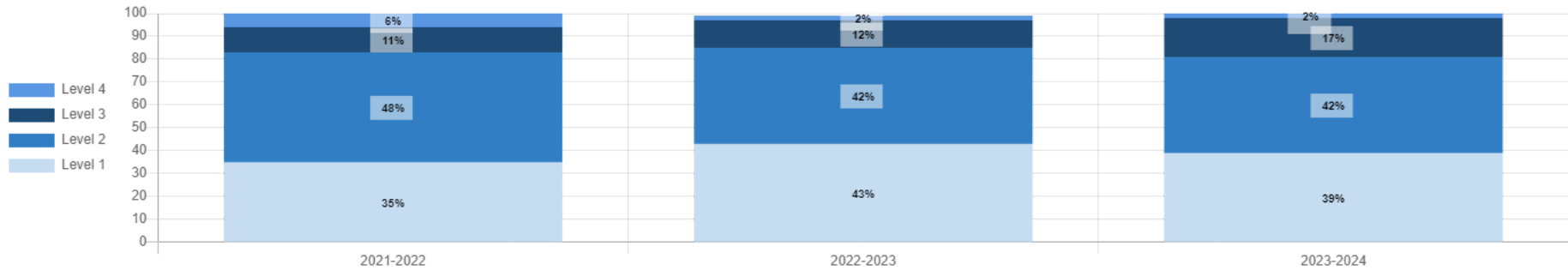

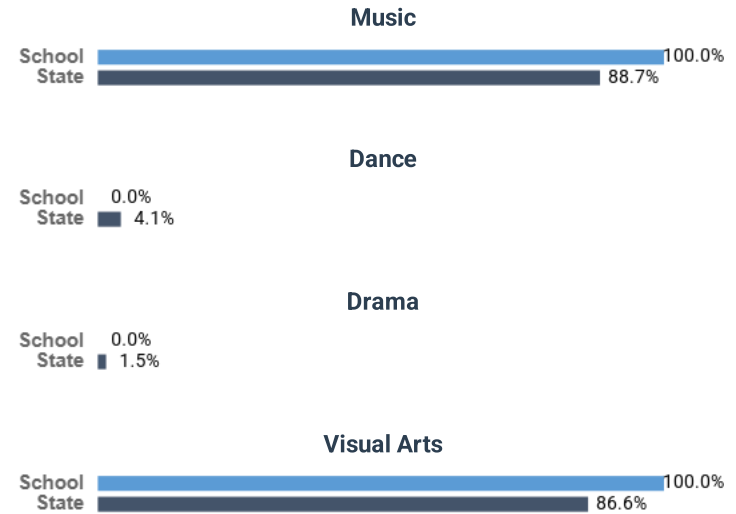

Students enrolled in one or more classes by discipline:



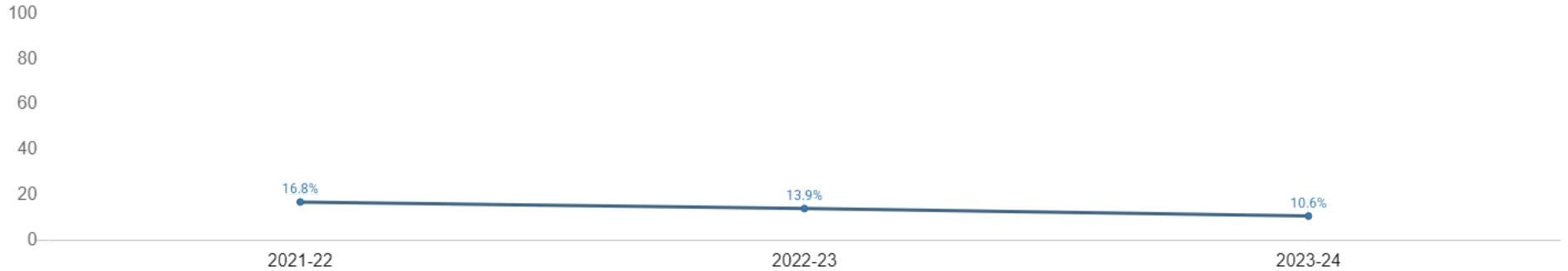

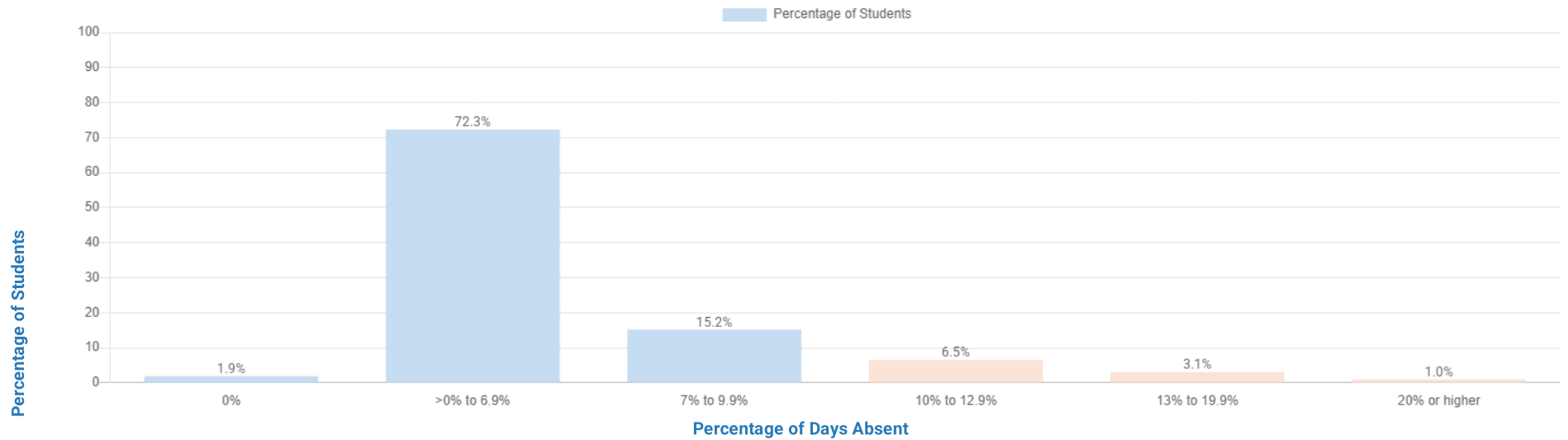

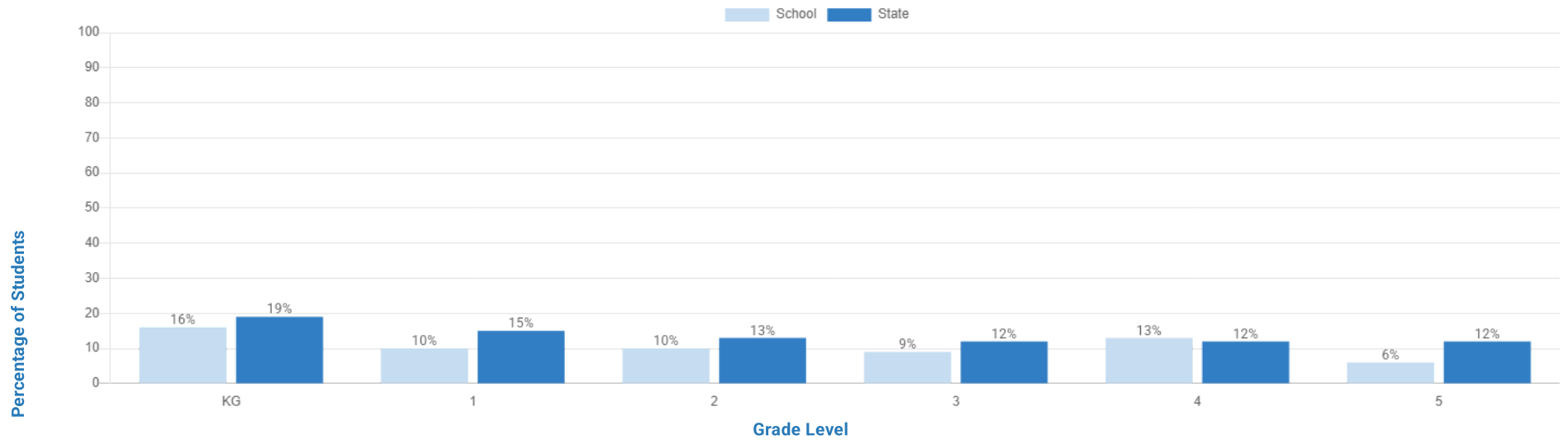

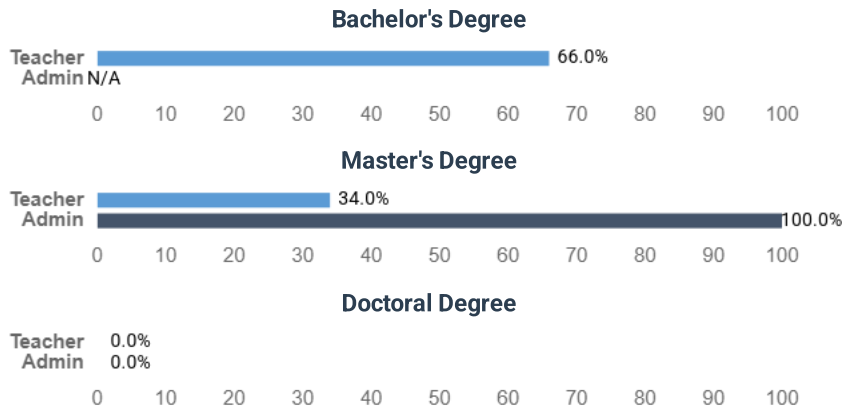

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Student Supports and Services:

Roosevelt School offers remedial instruction, which is provided to those students whose specific learning needs have been identified. These programs include: English Language Learner Support, Speech/Language Therapy, Occupational Therapy, Physical Therapy, Math/Reading/Language Basic Skills/RTI, Resource Room, collaborative teaching, supplementary instruction and the shared services of a Child Study Team.



Student Health and Wellness:

As part of a district-wide initiative, mental health and wellness has been a focus at Roosevelt School. Our guidance department continues to build on initiatives concerning mindfulness into the lives of our staff, students and their families. Through daily lessons, school assemblies, parent workshops and teacher professional development opportunities, strategies aimed at decreasing stress continue to be implemented. Additionally, we continue with a school-wide character building program that focuses on a particular theme each month where students and staff nominate their peers for recognition, rewards and positive reinforcement.



Parent and Community Involvement:

Parental involvement in all aspects of school life is encouraged. Roosevelt has a very active PTO (Parent Teacher Organization). Through a variety of fundraisers, the PTO actively supports and implements a wide range of activities and experiences. The PTO also sponsors all of our educational assemblies and class trips.

School Safety:

Roosevelt school takes appropriate measures to address the safety of our students and staff. All entryways are locked. Staff can access the building only through electronic key fob access. The building is under video surveillance 24 hours a day, seven days a week. Roosevelt School also has an armed security guard on the premises during school hours. In addition, there is a building security committee that meets periodically and works in conjunction with the district level security team to ensure best practices are being followed in the school safety and security realm.



Technology and STEM:

Students in grades K-5 are exposed to an interactive science program that incorporates hands on activities with cross-curricular subject material specifically in Science, Technology, Engineering and Math. In addition, students in grades 2-5 participate weekly in the Research and Exploration course. In this course, students use makerspace materials and STEM strategies to design and create projects. We have also introduced a new science curriculum through the highly interactive Mystery Science program.
