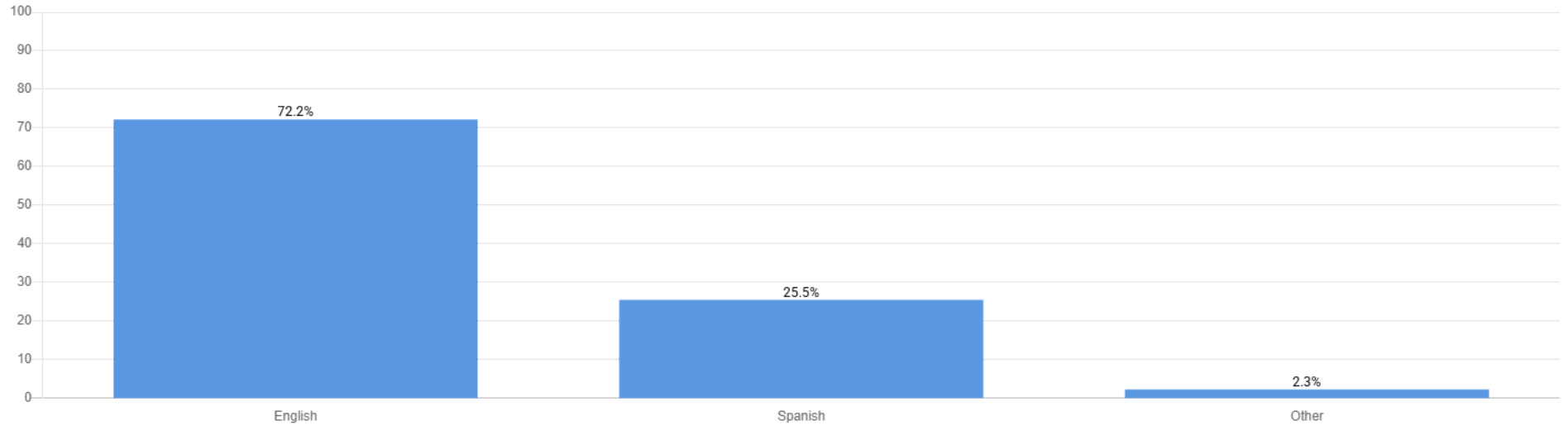

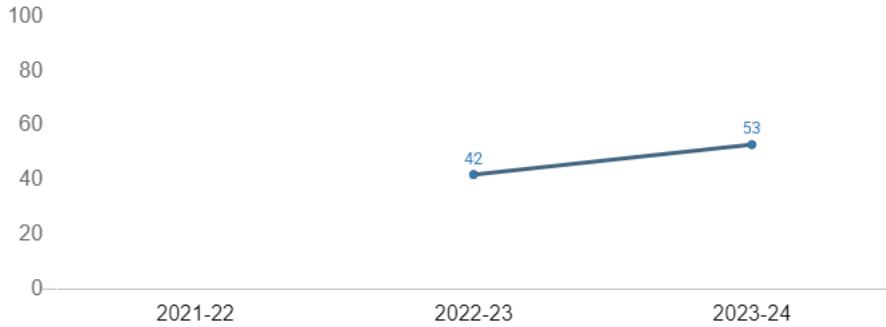

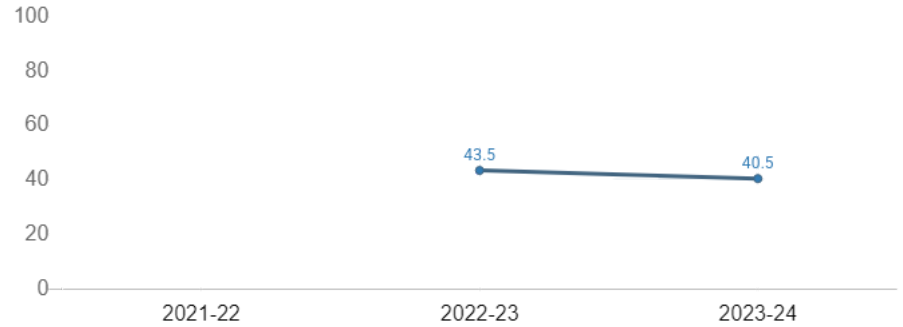

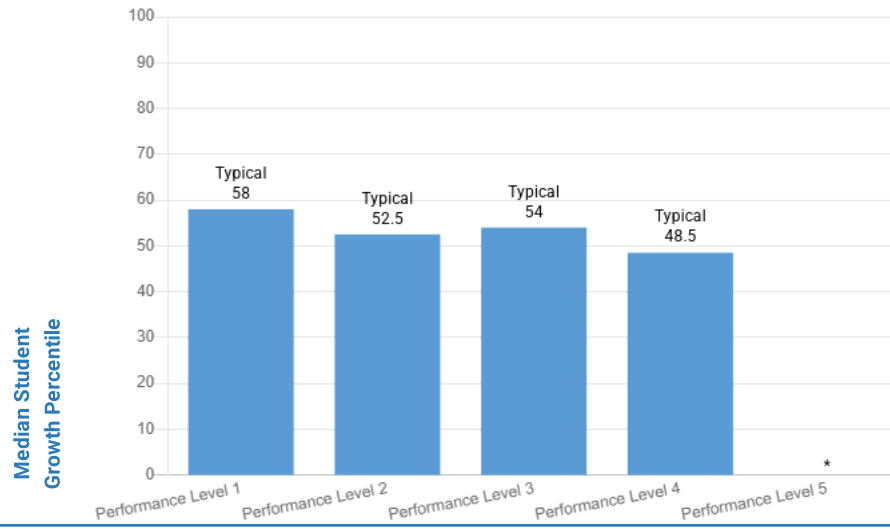

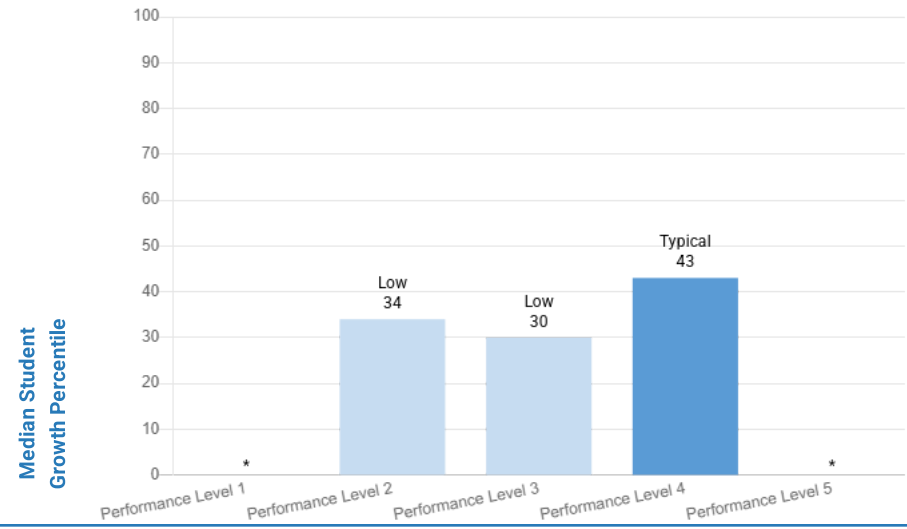

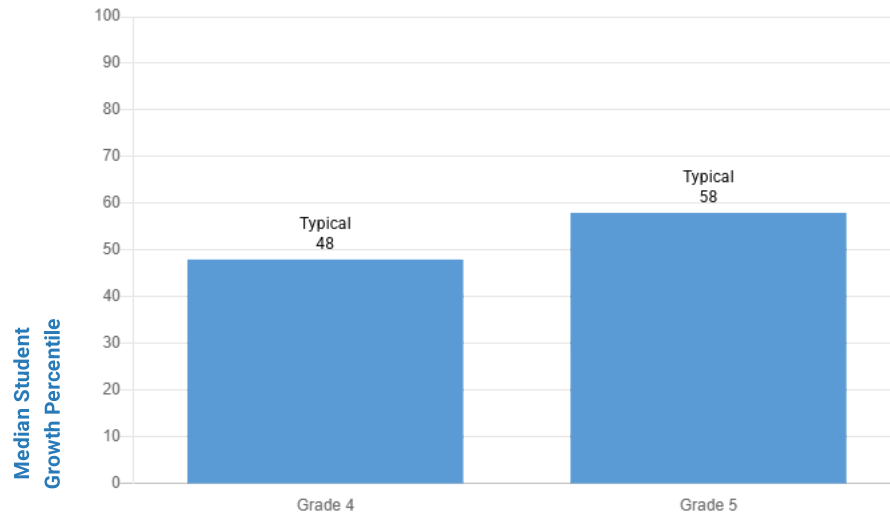

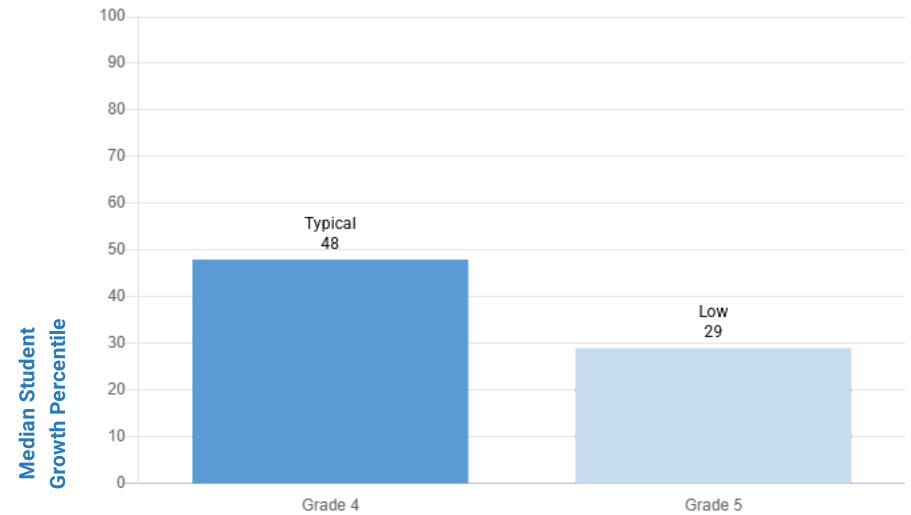

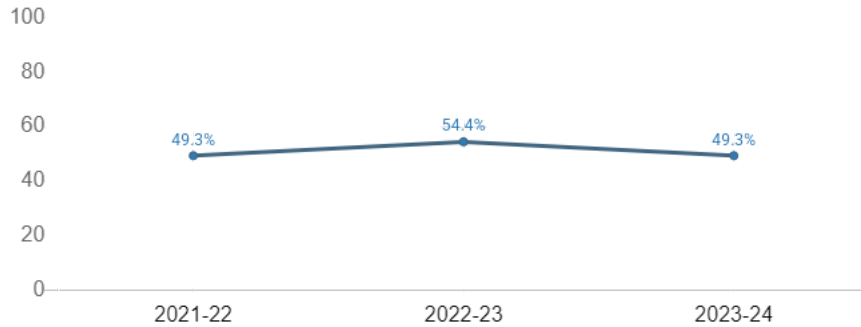

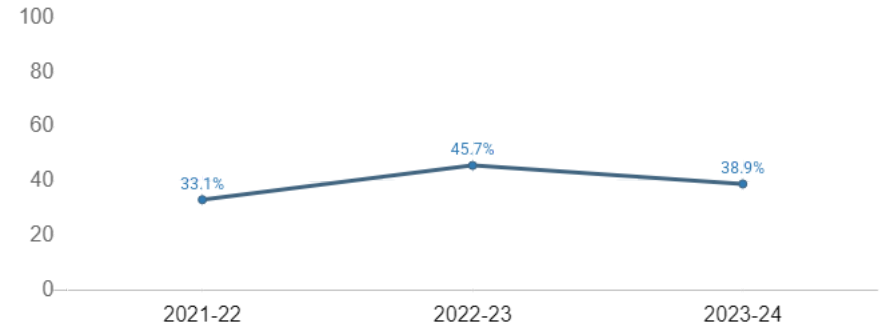
English Language Arts and Mathematics Performance Trends

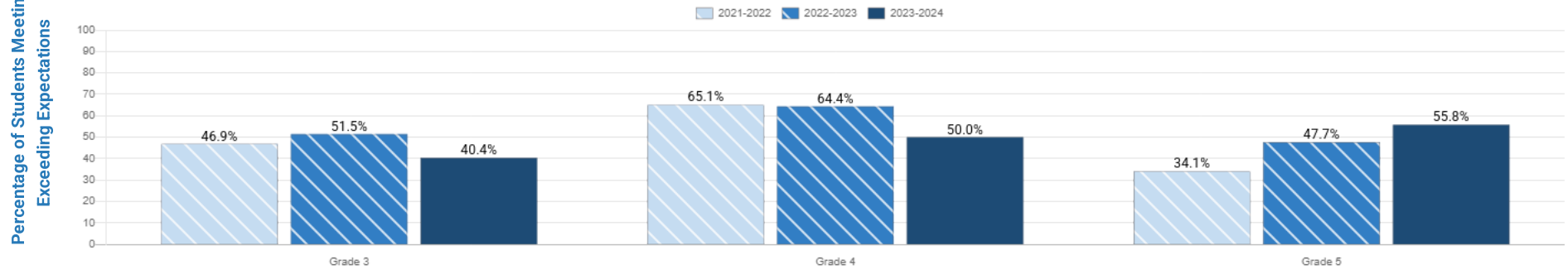

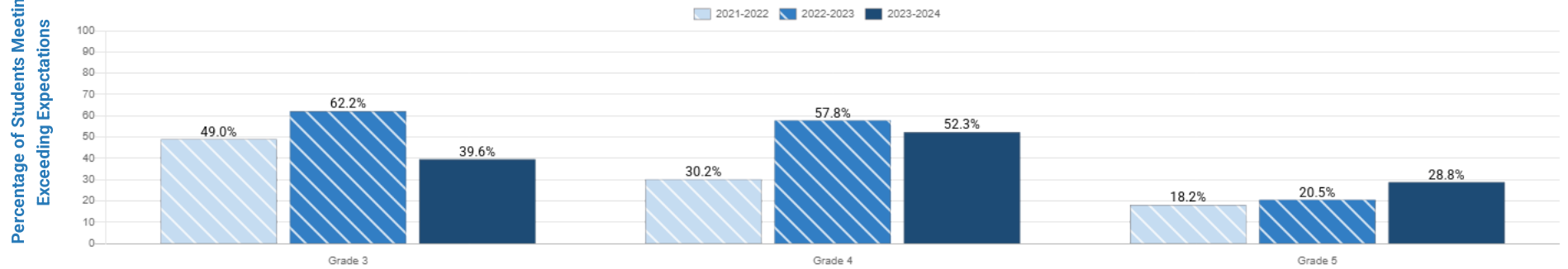

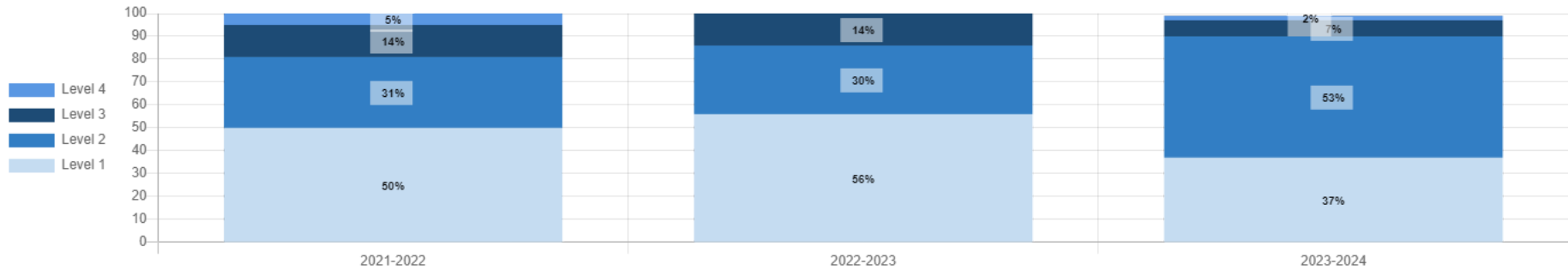

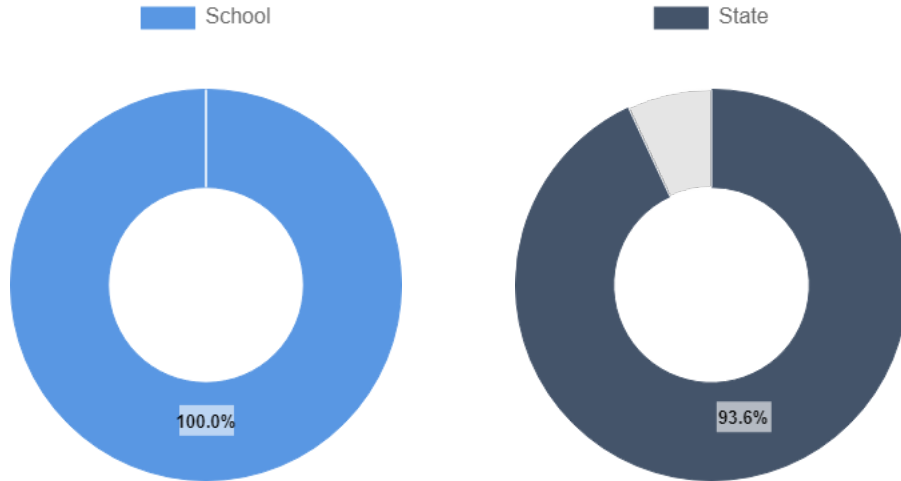

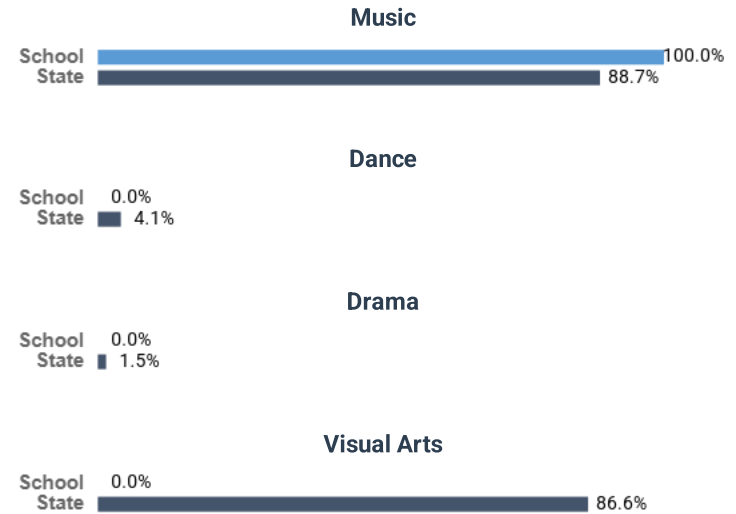

Students enrolled in one or more classes by discipline:



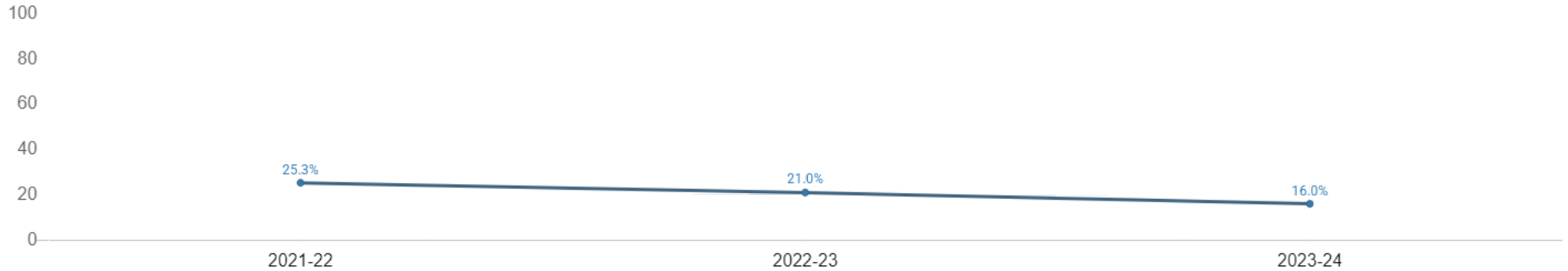

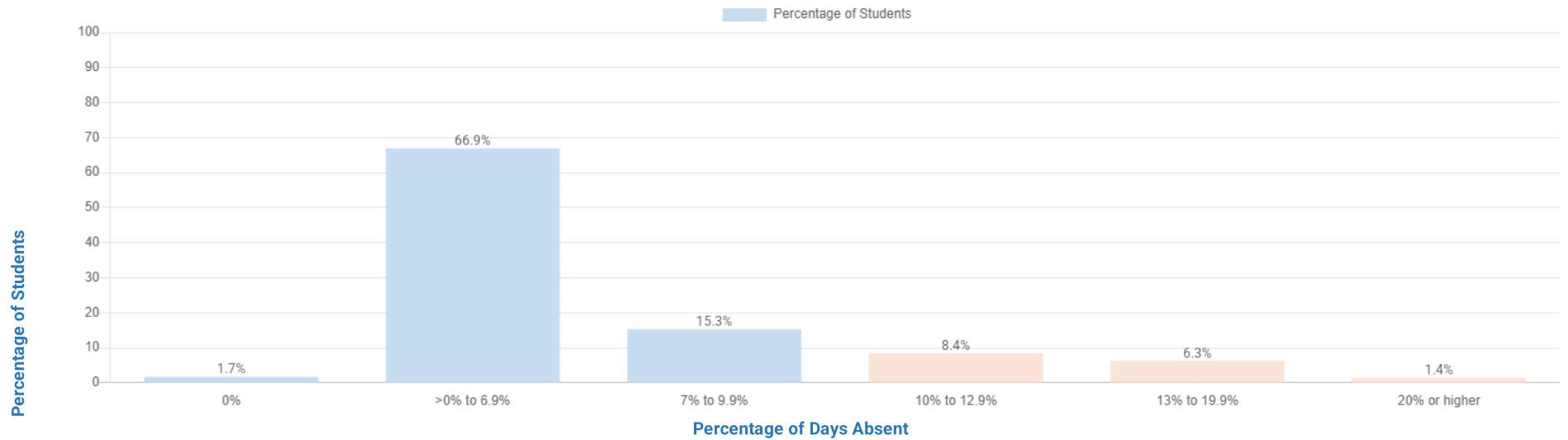

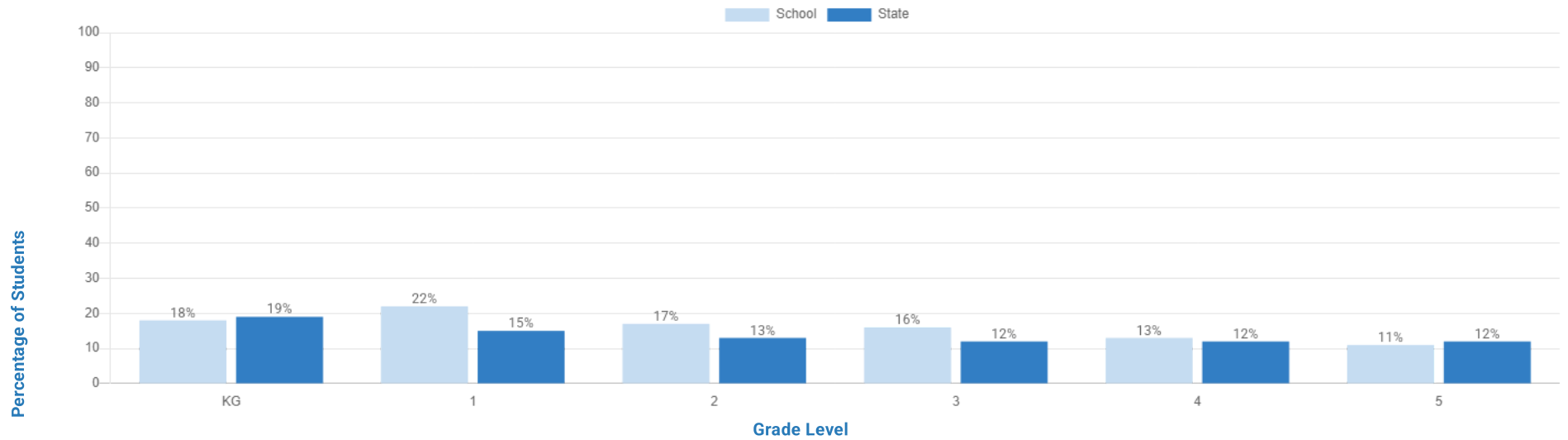

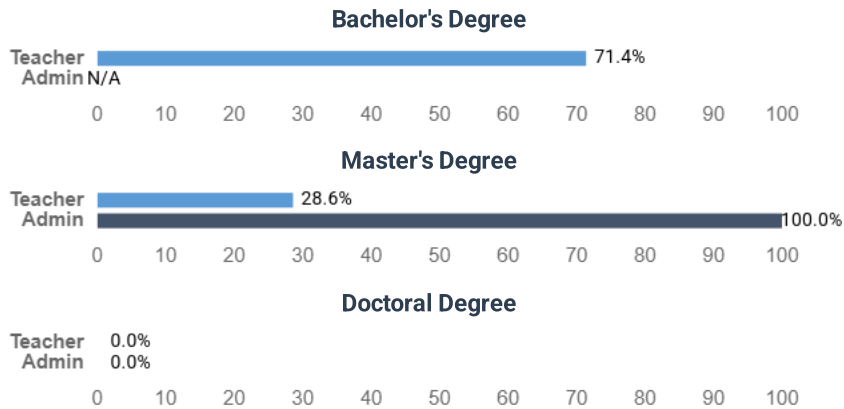

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Teachers attend sessions at Nancy Schultz's Conquer Mathematics learning center.

Washington Elementary School services the district's elementary ARCH Academics/Real Life/Community/Hands-on program for students with developmental and cognitive disabilities. In addition, Adaptive Physical Education, Adaptive Art, Adaptive Computer, and Adaptive STEM classes are offered. English as a Second Language instruction is provided for students whose native language is other than English.
