







Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.



Passaic Public Schools provides a wide variety of services and supports to our students. Students identified as English Language Learners receive a variety of instructional learning supports. Students with disabilities have access to learning support programs and personnel. Students identified as in need of additional academic support receive intervention services and have access to help before and after school.



Passaic Public Schools has uniquely infused data driven Social Emotional Learning Curriculum into the Pre-Kindergarten through 8th grade Health Curriculum and implemented SEL lessons in grades 9-12. This curriculum addresses the emotional, mental health and core competency strengths needed for each scholar's growth and overall well-being. Additionally, many schools have staff professionally trained and have been State recognized for PBSIS work which supports student psychological and physical safety with additional schools who have MTSS teams leading off of a PBSIS model. All district schools have Climate and Culture teams, collaborating to align diverse facets of their school structures to improve sense of student physical safety, psychology safety, student grit, emotional regulation and sense belonging.



Parent and Community Involvement:

Passaic Public Schools encourage all community stakeholders to participate in school and district activities and committees. Parents have access to the PowerSchool parent portal for information about their child's progress and the district works in coordination with the City of Passaic to provide opportunities that enrich the students learning experiences throughout the year. Parents are invited to attend in-person and remote workshops allowing for home-school connections and flexibility for collaboration.
