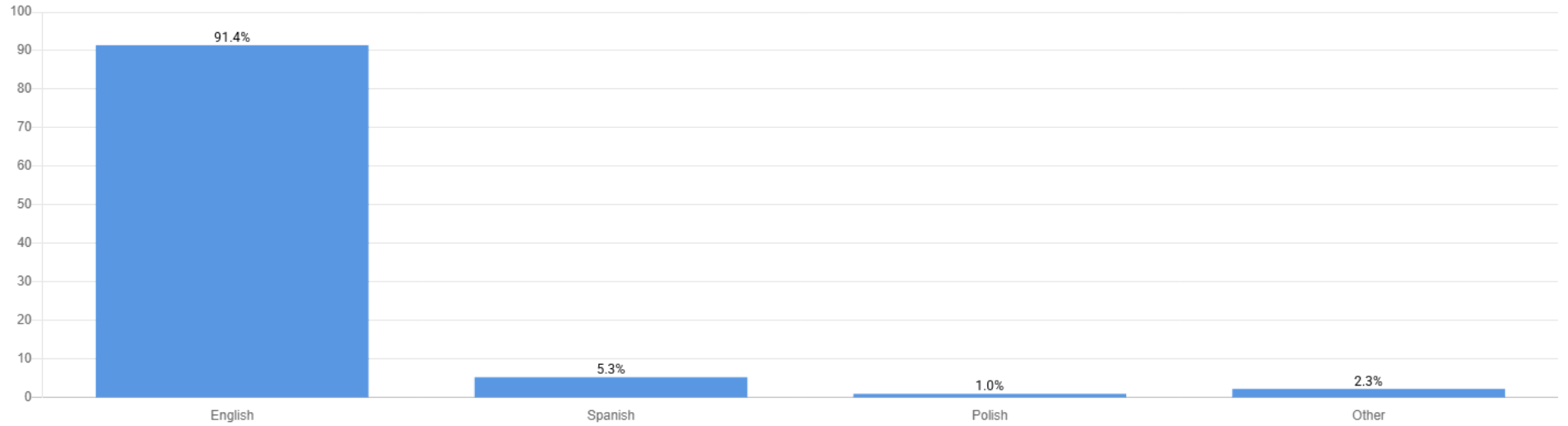

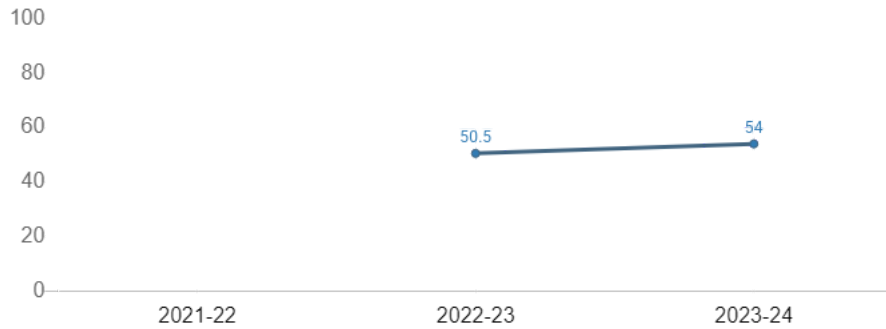

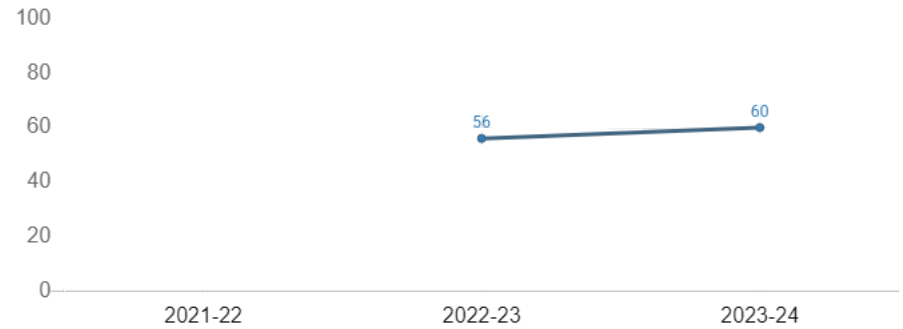

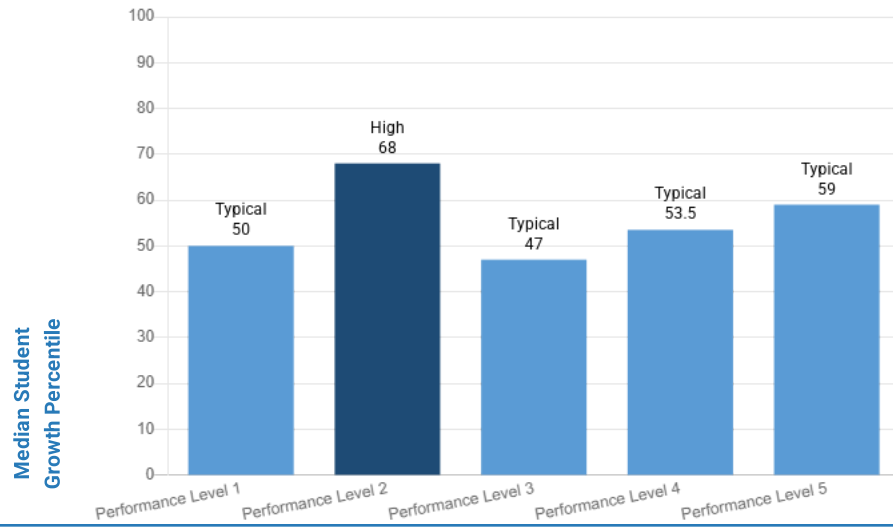

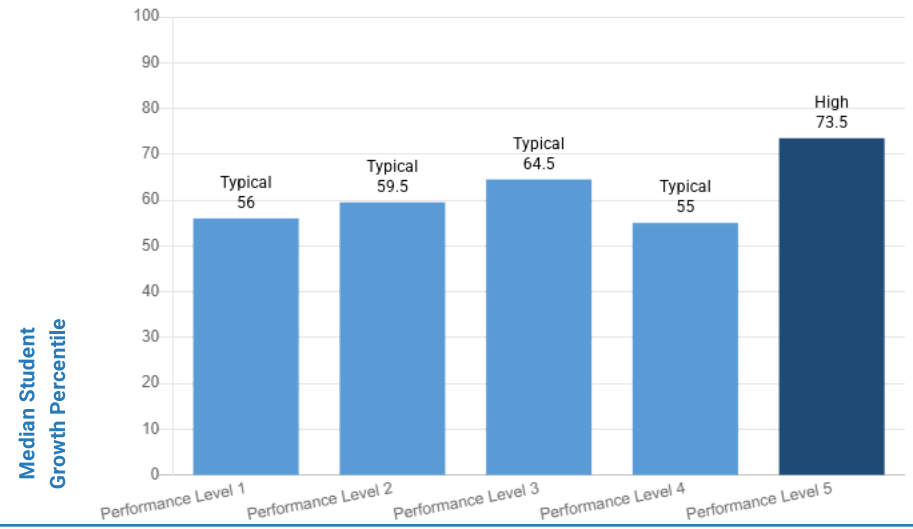

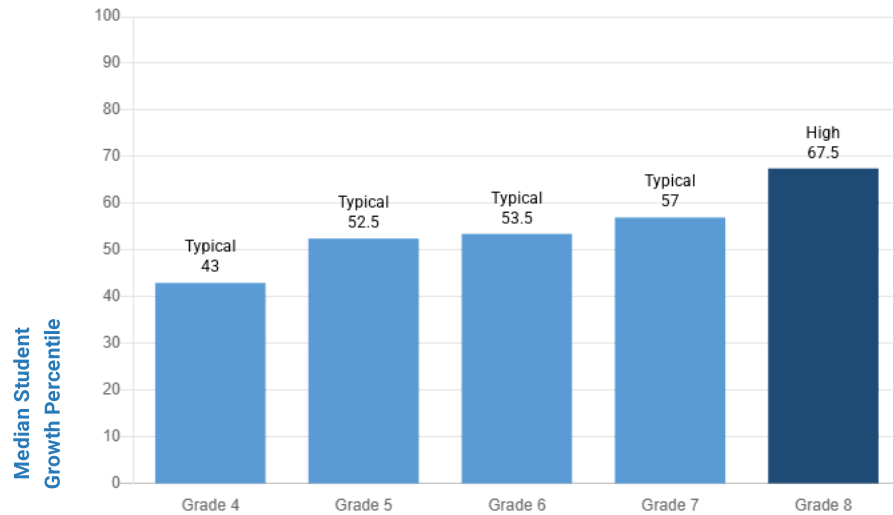

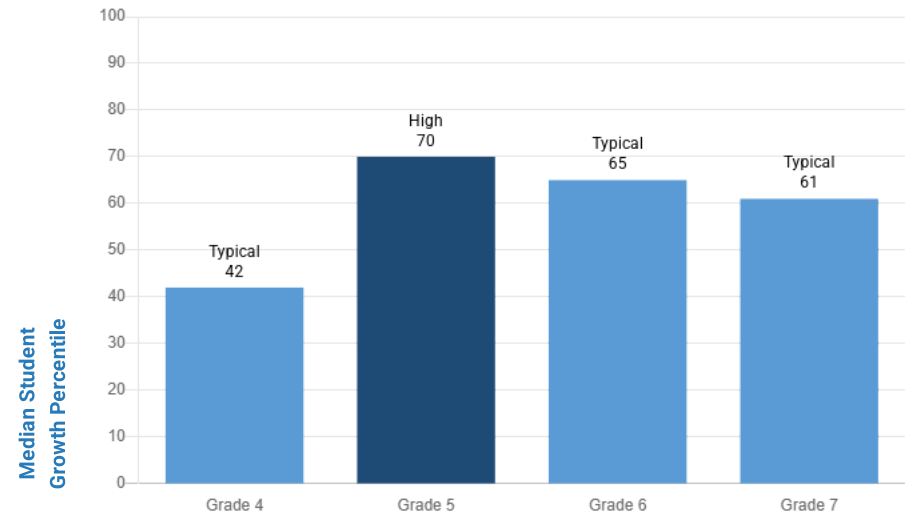

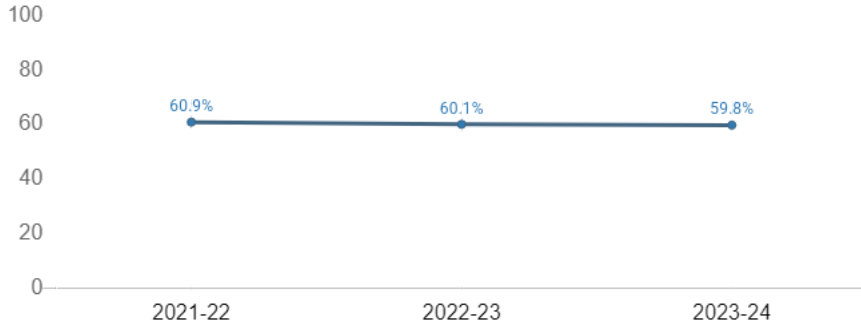

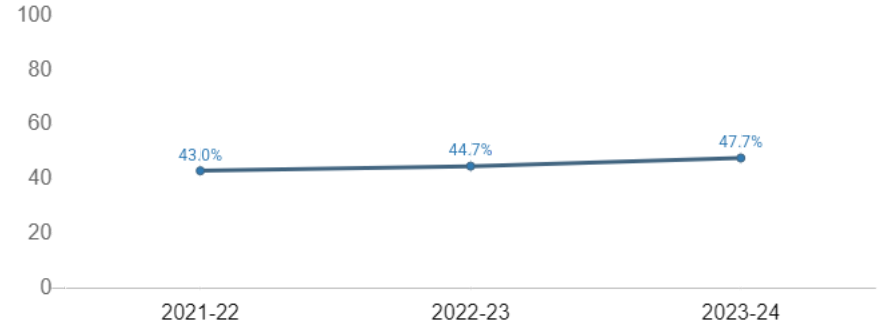
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 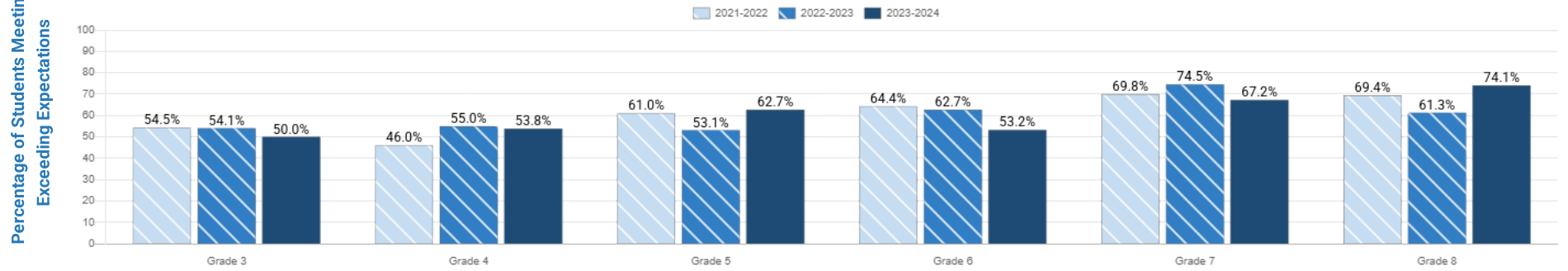

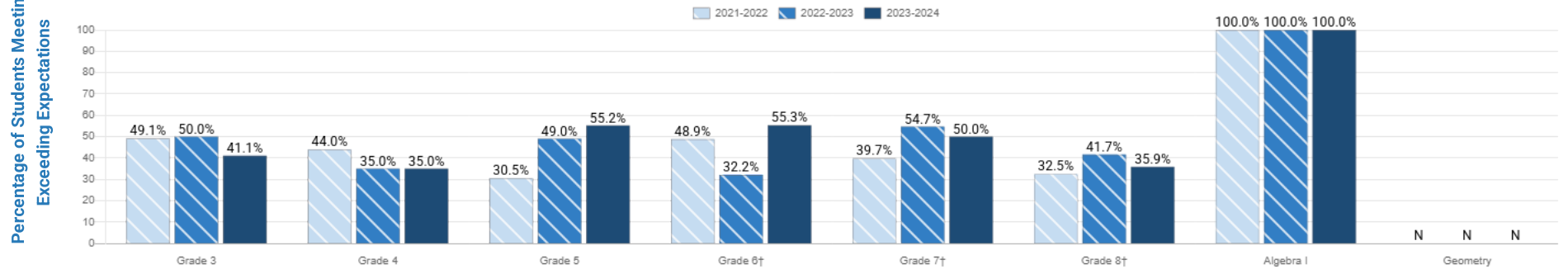

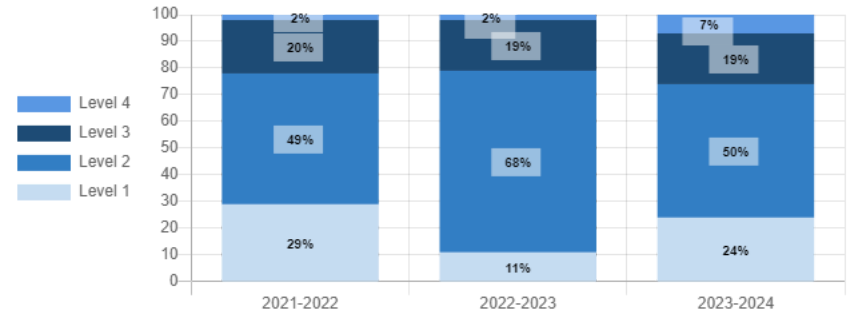

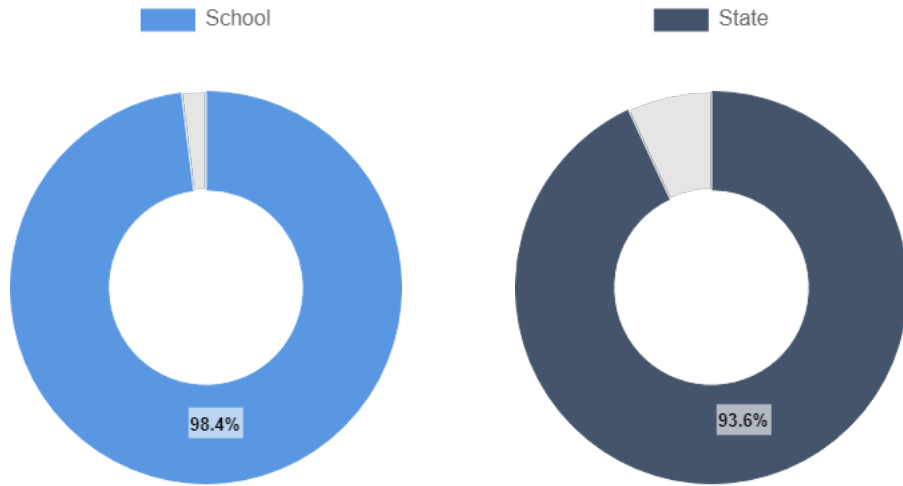

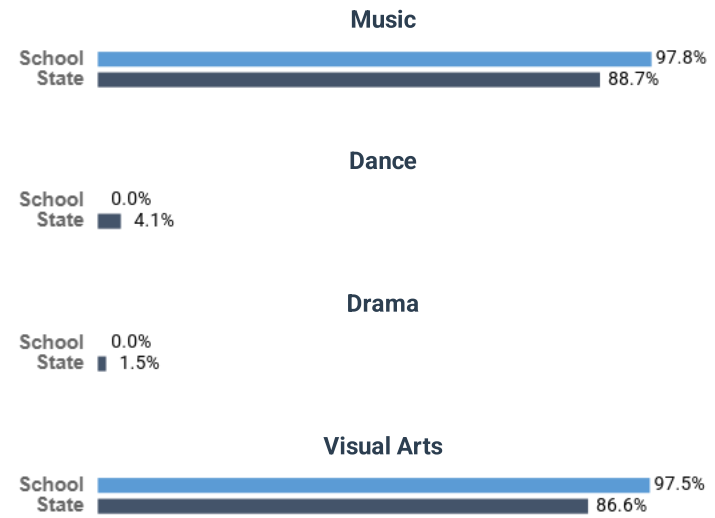

Students enrolled in one or more classes by discipline:



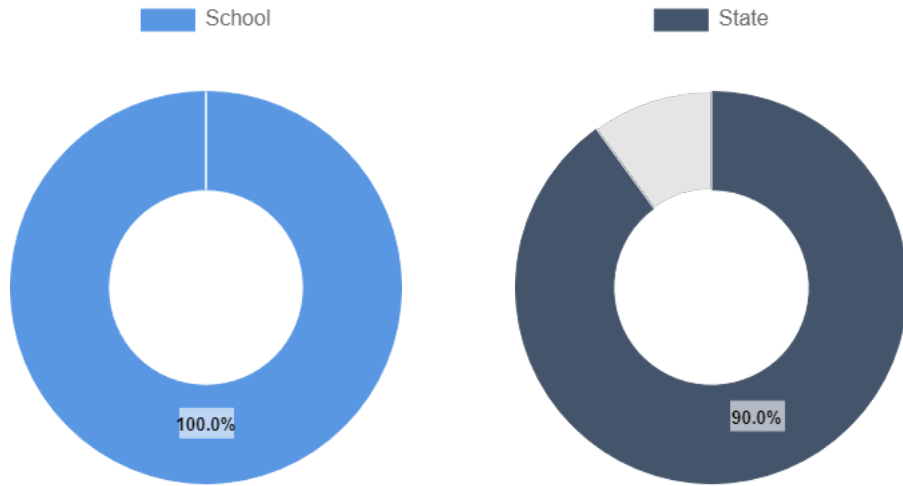

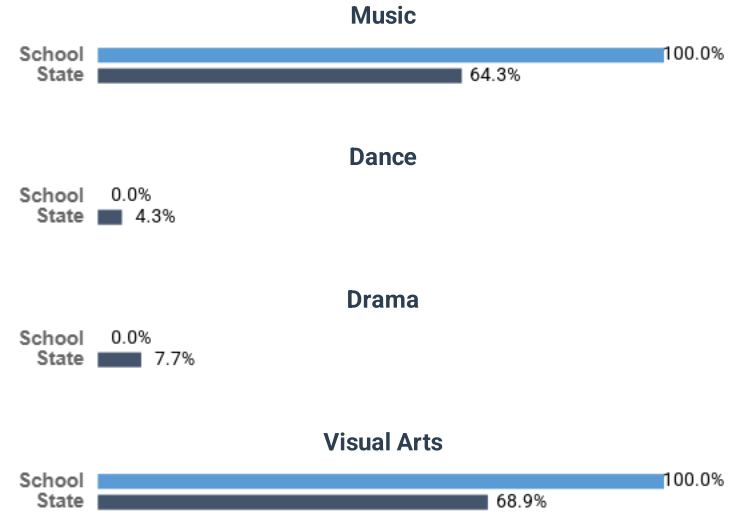

Students enrolled in one or more classes by discipline:



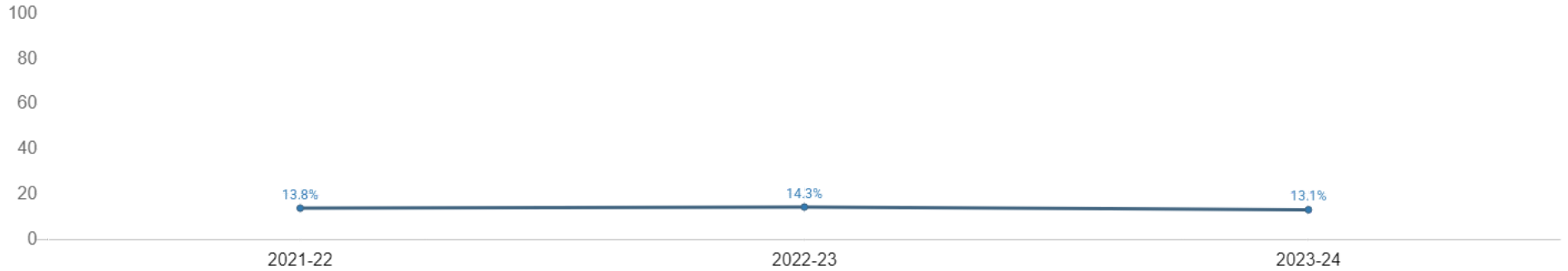

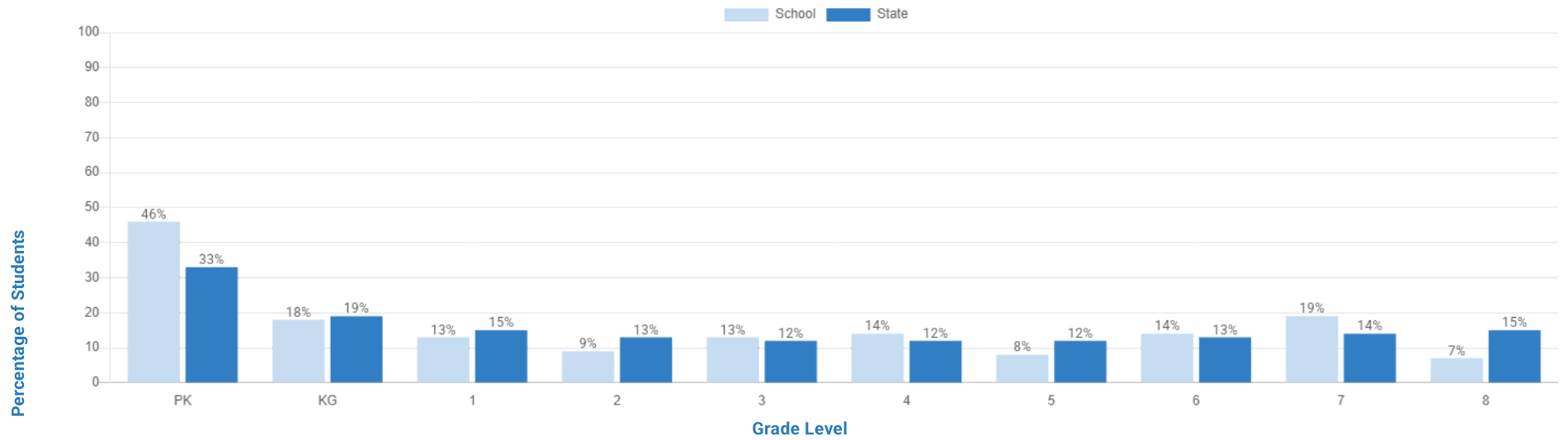

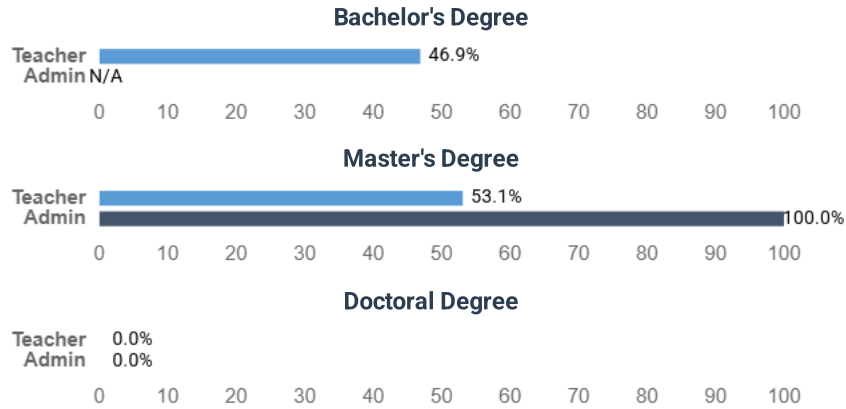

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Each year the Wanaque School recognizes outstanding educators and service professionals who work tirelessly to support teaching and learning through the state's Teacher of the Year program.



Courses, Curriculum, Instruction:

We are continuing to build upon our 1:1 initiative district-wide, and have expanded our infrastructure to allow better access to the internet. Our ELA curriculum is being updated to reflect a cohesive, multi-text approach to literacy instruction for Grades K-8. Students are fully immersed in literacy, as they partake in shared reading and writing experiences, interactive read-alouds, guided reading and writing, phonics instruction, and independent reading and writing. We have also enhanced our mathematics program district-wide with the implementation of iReady, a sophisticated assessment program designed to pinpoint students' strengths and gaps in the area, as well as design a personalized learning path for more targeted instruction. We are in the process of updating our math curriculum to ensure it aligns with the standards and meets the needs of our students. Clubs and Activities:

Students participate in co-curricular arts programs such as chorus and mural. In addition, they experience student government through the Student Council and Mock Trial. The WSPTA funded after-school programs such as STEM, Art, Business, and Intramural Sports. These programs, as well as the Yearbook Club, 8th Grade Club, and Across Ages, provide our students with experiences that complement what they are learning during the school day.



Before and After School Programs:

Academic Support is available to students in grades four through eight. Homework Assistance is available to students in grades two through eight on an as-needed basis. A breakfast program is also available for all of the students beginning at 8:30 a.m. If time is an issue for students, we allow them to utilize the Grab & Go option and eat breakfast in their homerooms.

Ongoing professional learning for our staff is of the utmost importance. We send our educators to workshops and house presenters based on needs. Additionally, our in-house Professional Development Academy offers an array of courses for all staff members and provides learning opportunities on varied topics taught by educators and administrators within the buildings. Per the Department of Education rulings, staff members were provided training on mandated topics throughout the year.

Technology and STEM:

To continue meeting the New Jersey Student Learning Standards, we use an online platform called Mystery Science. It embraces the mission of helping our children stay curious. Students investigate questions instead of simply memorizing scientific terms and facts. They are given the opportunity to explore the questions that bring the facts to life. Every lesson begins with a mystery, a question that captures the students' interests, and offers a hands-on activity to help students explore and understand the facts behind the answer. Teachers can decide to take it a step further and have students participate in an engineering or STEM piece, which consists of students working together to solve a real-world problem, based on the question. STEM is also infused into our current technology program, library, as well as G&T. The students completed units on motion, computer programming, electrical circuits, and robotics.
