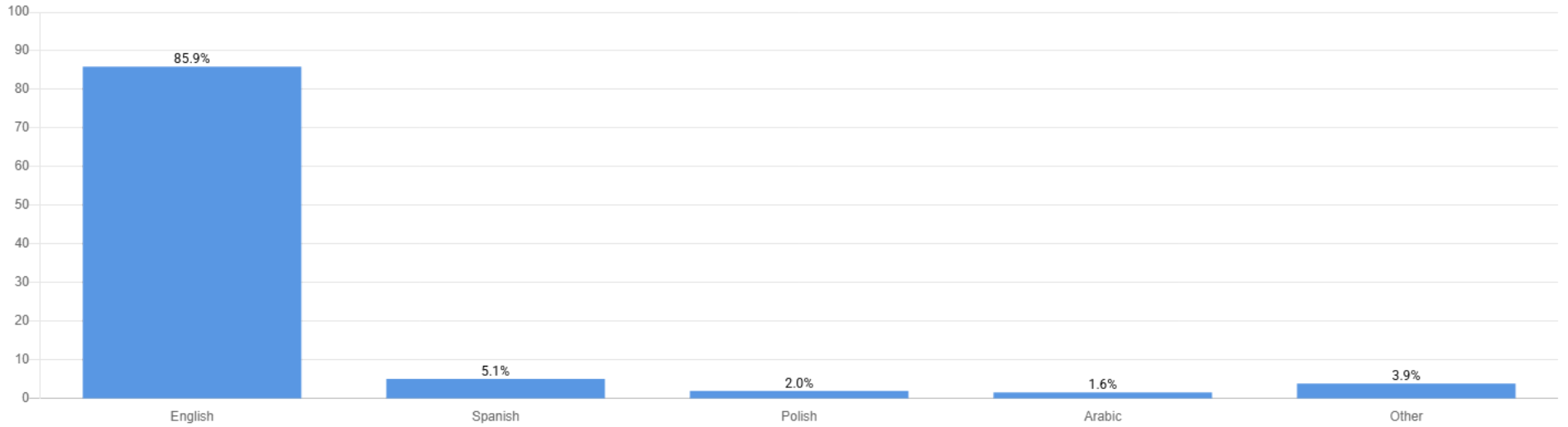

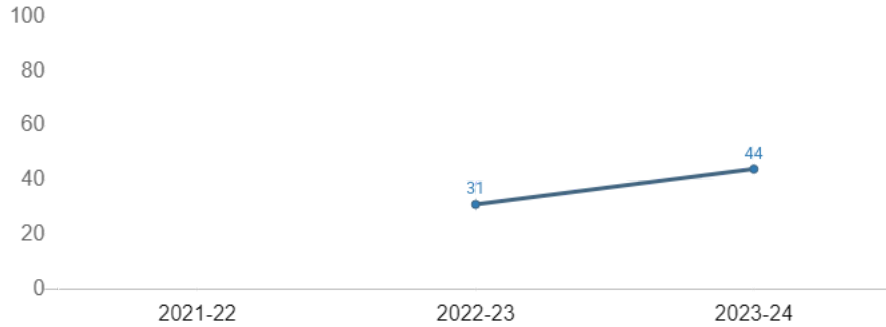

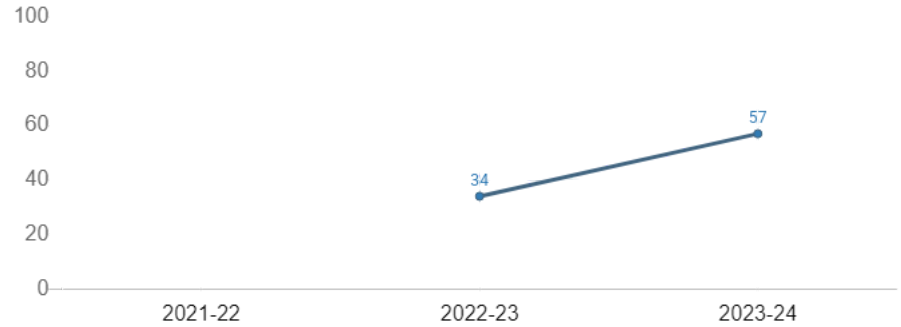

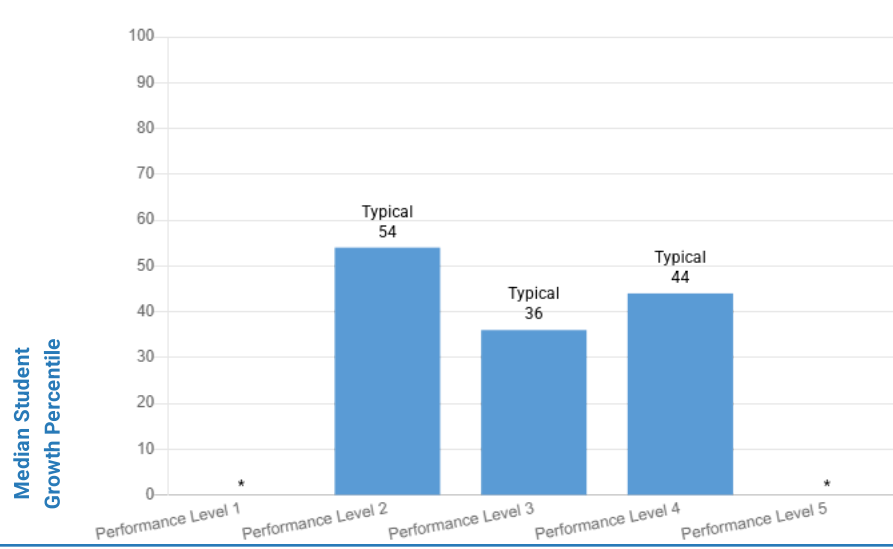

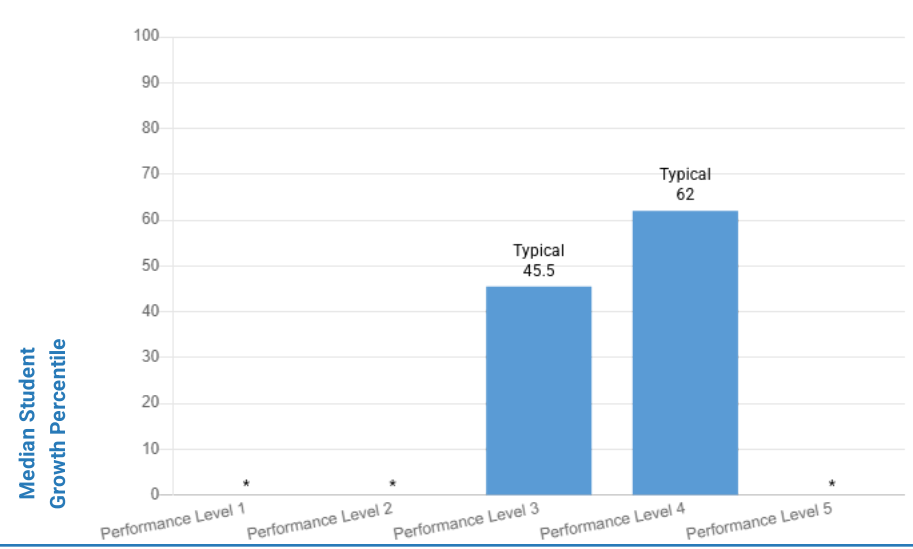

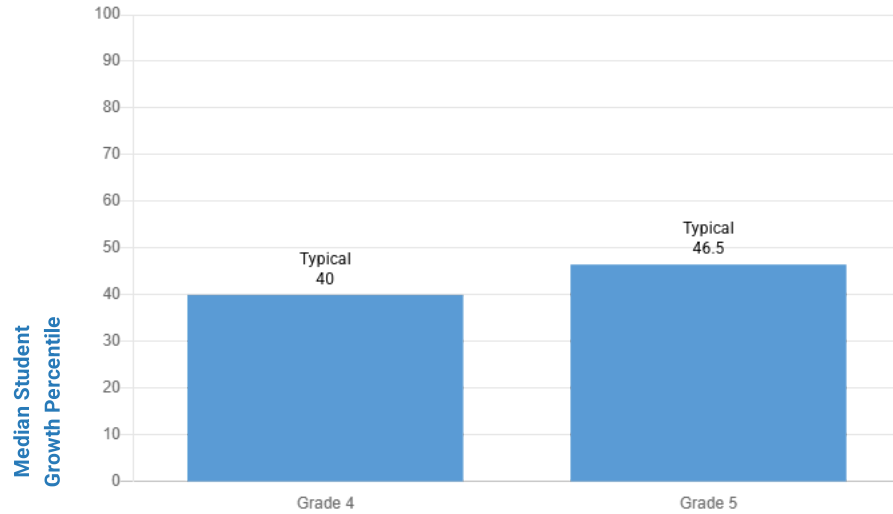

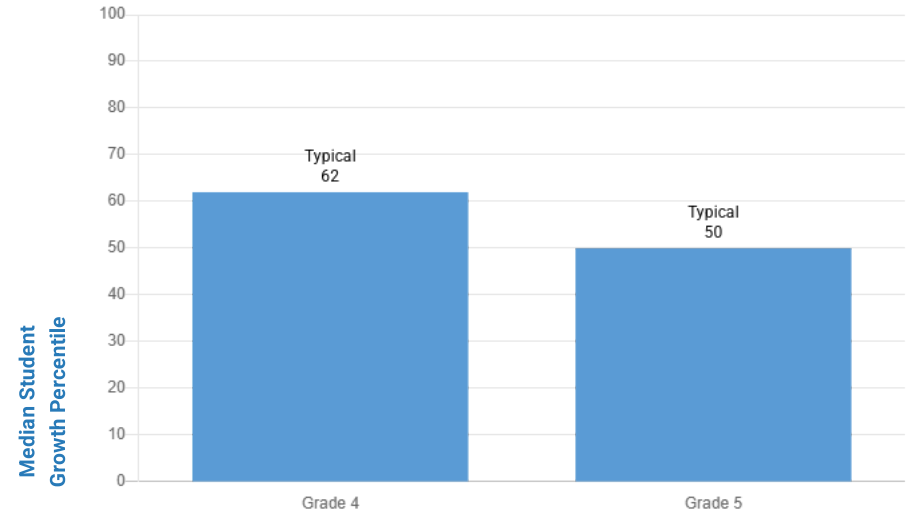

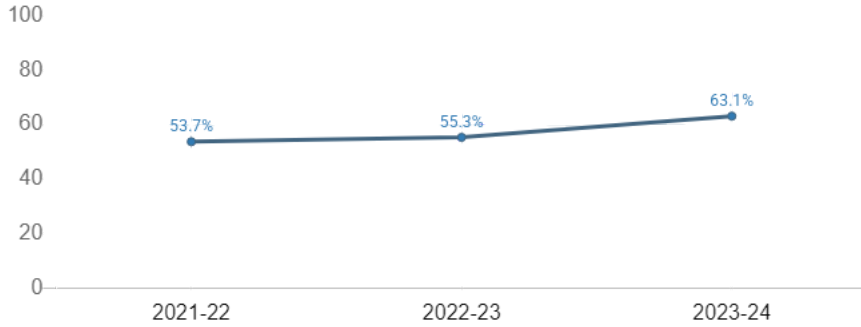

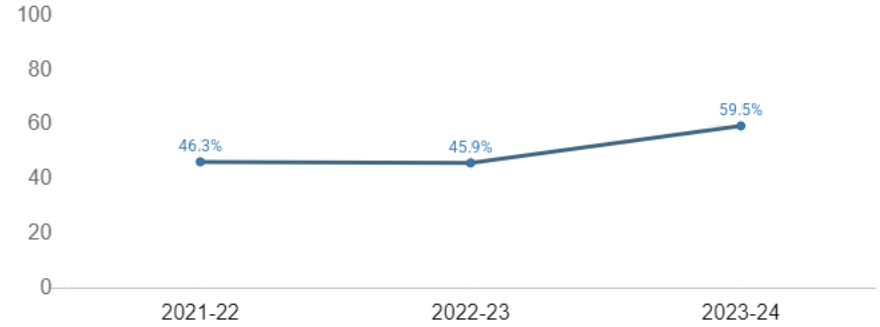
### English Language Arts and Mathematics Performance Trends

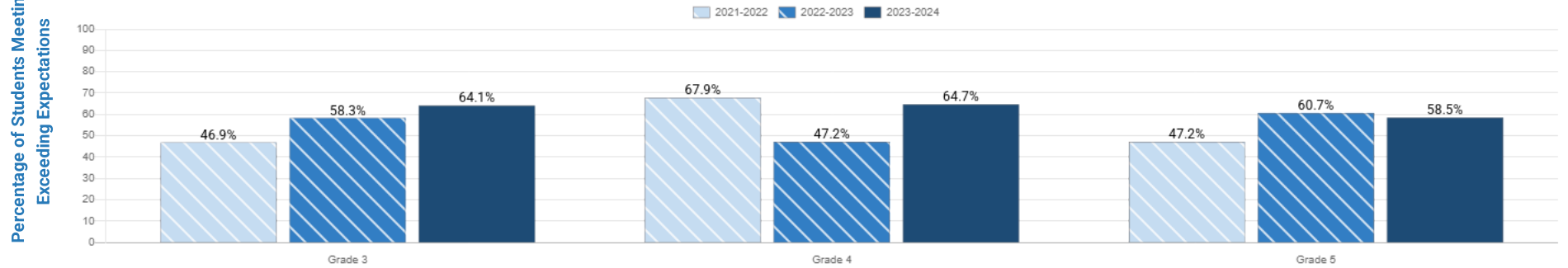

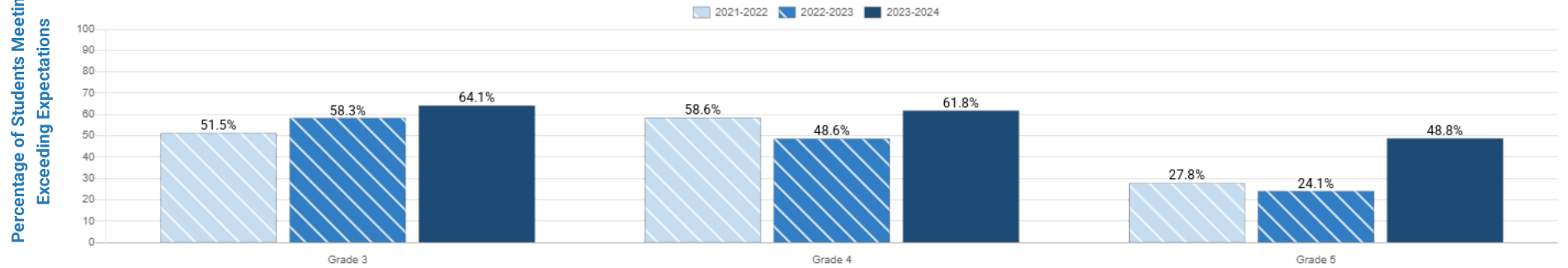

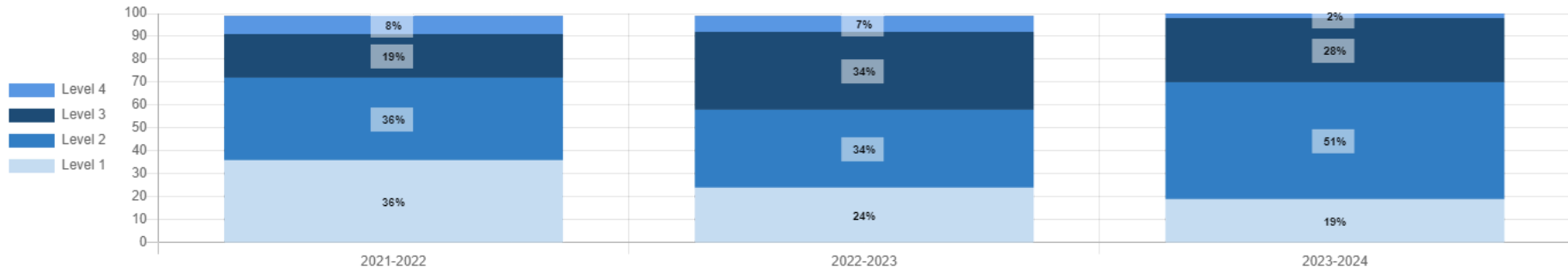

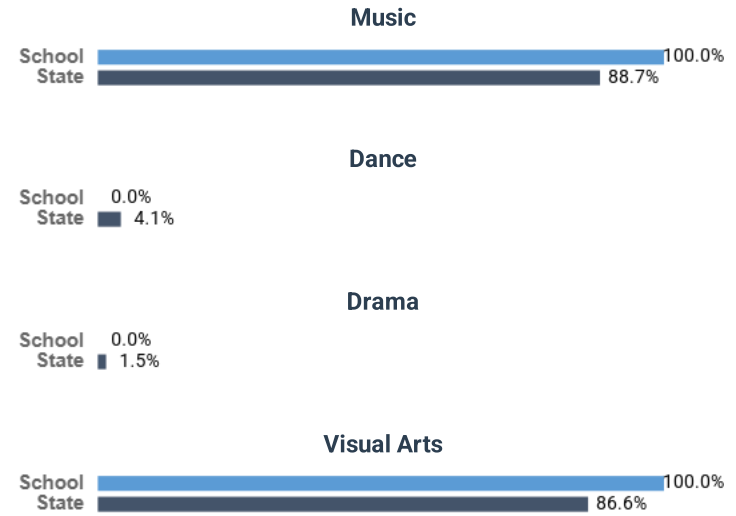

**Students enrolled in one or more classes by discipline:**



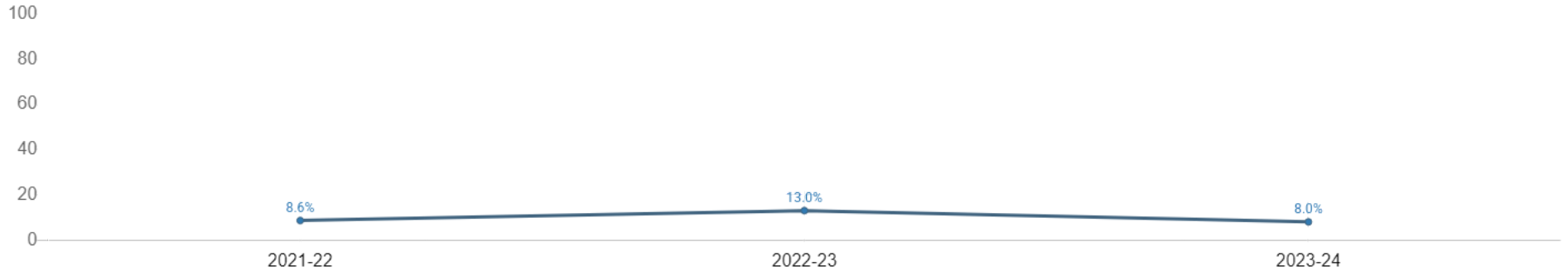

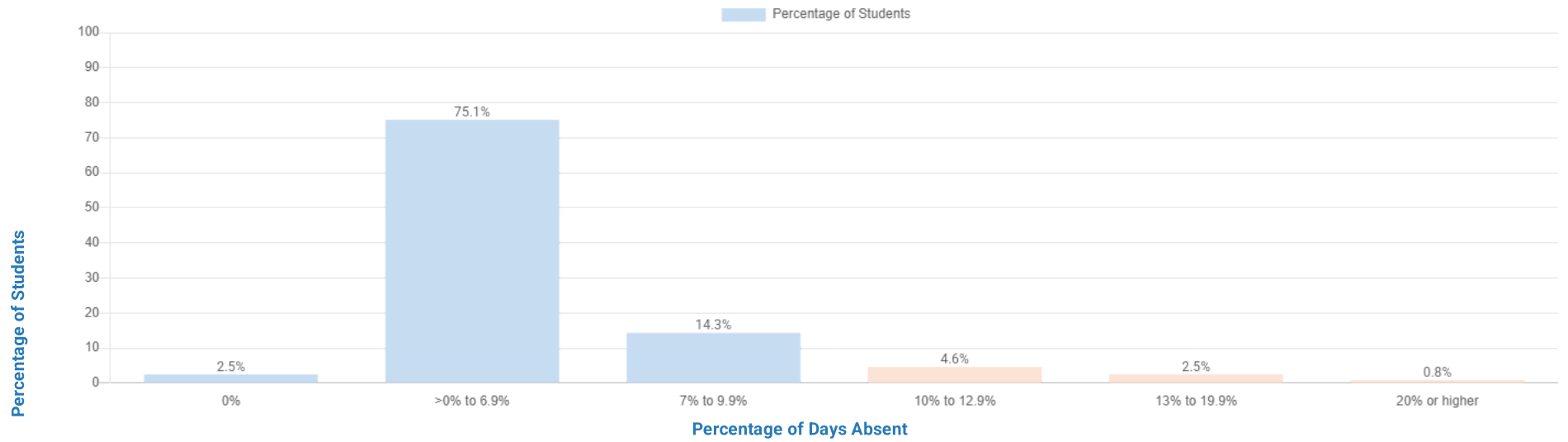

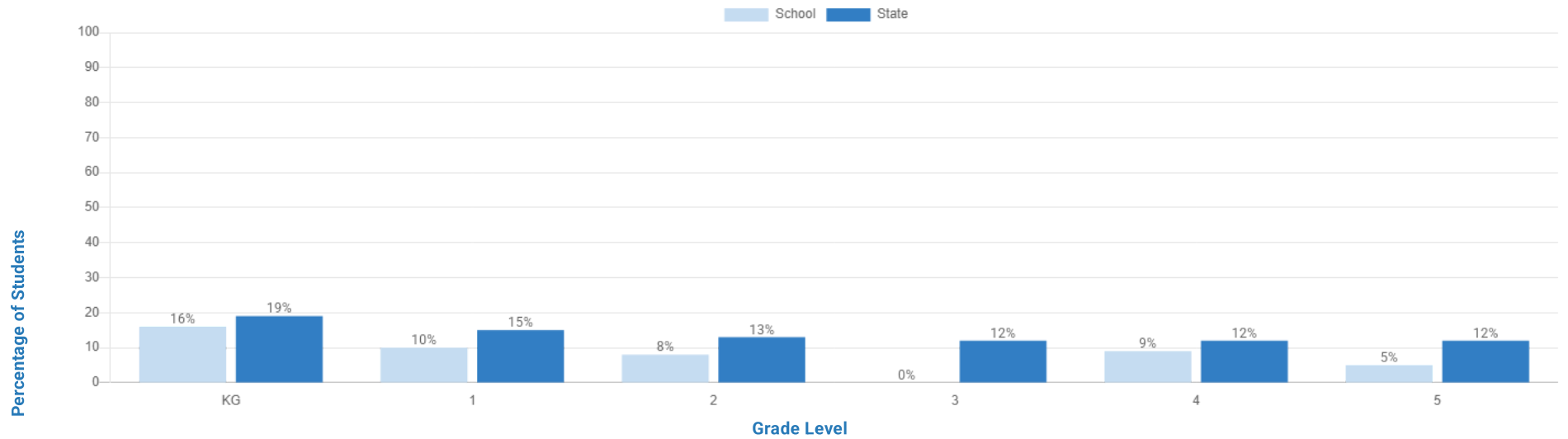

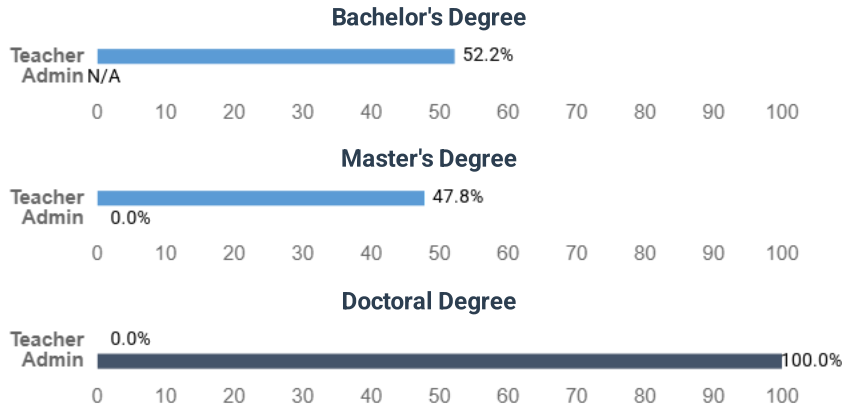

Apshawa School has a full time certified nurse/health educator on staff. This professional provides instruction for all students in all areas of health, establishing a proactive approach to wellness.
