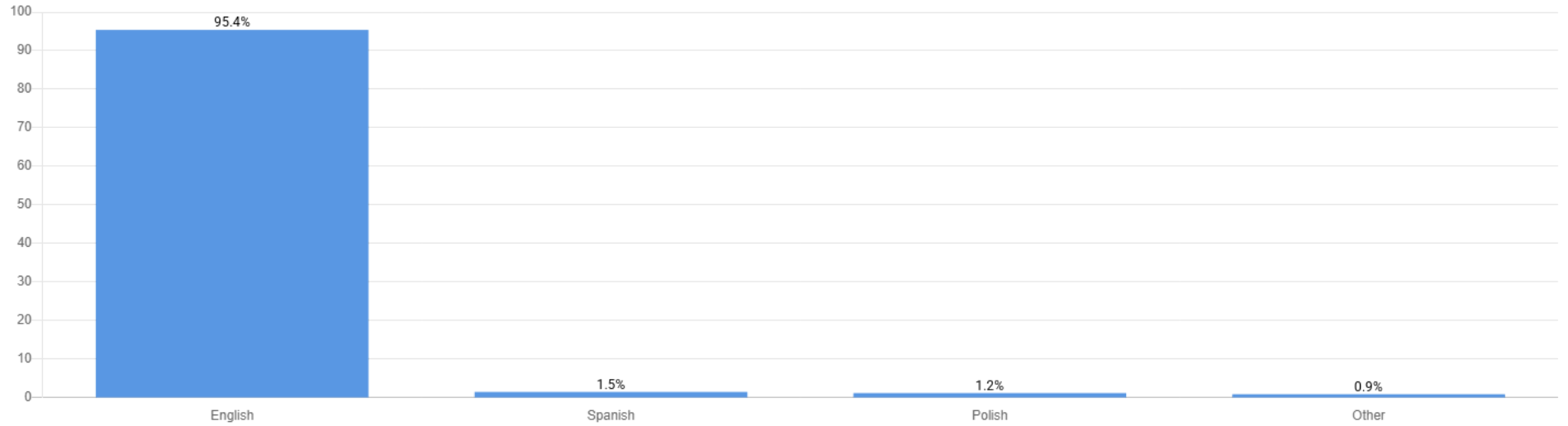

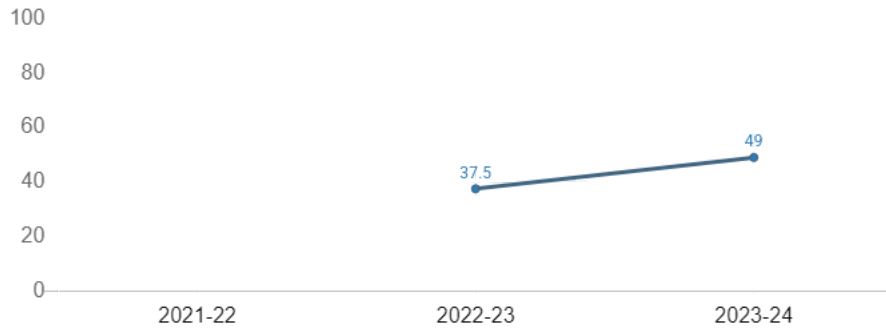

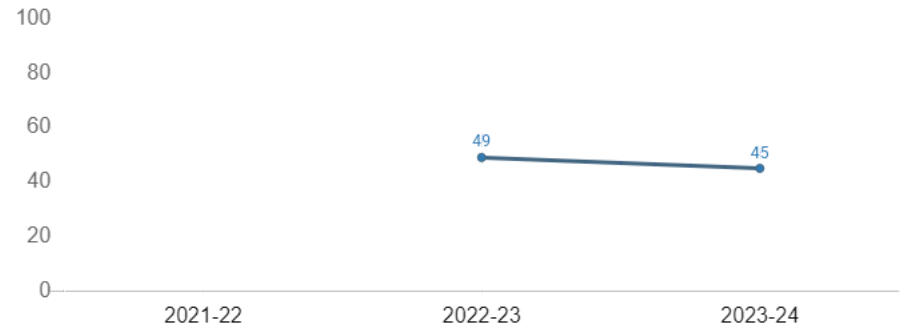

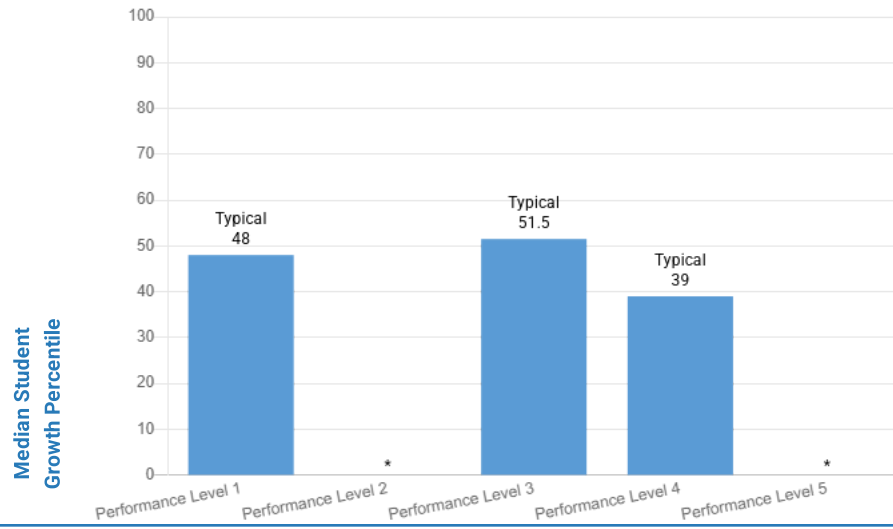

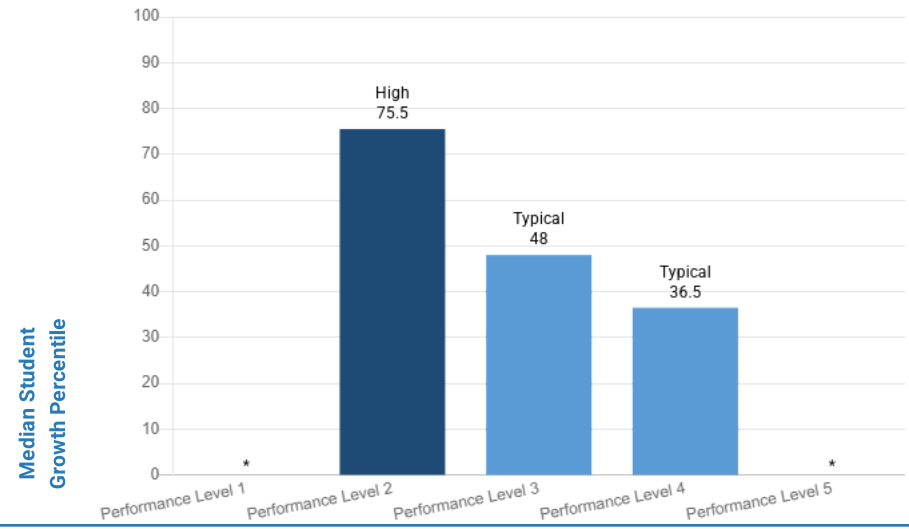

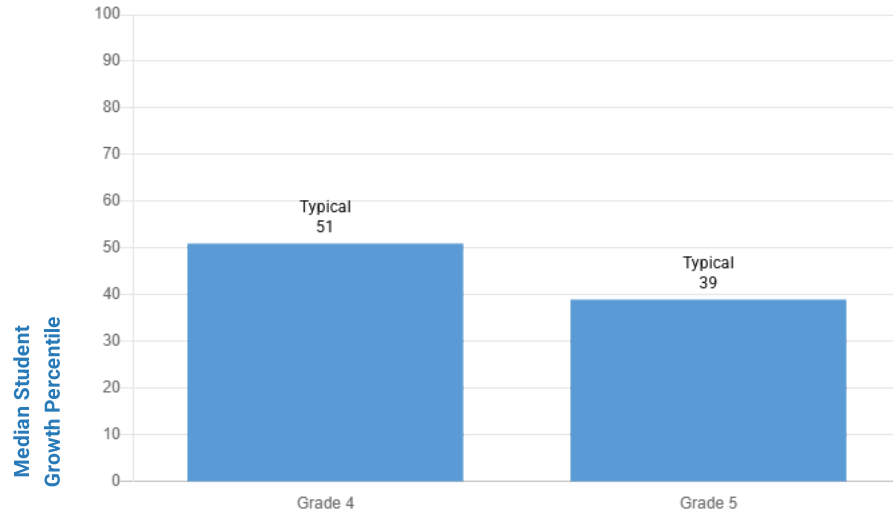

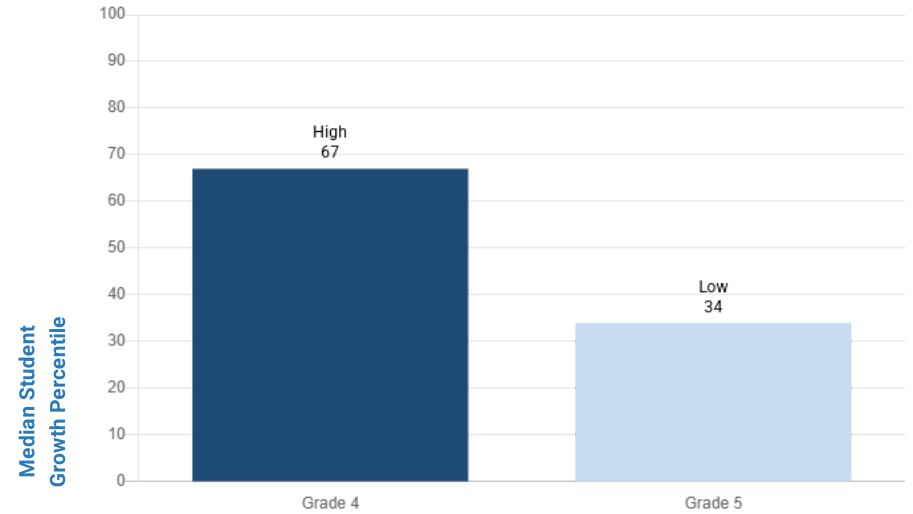

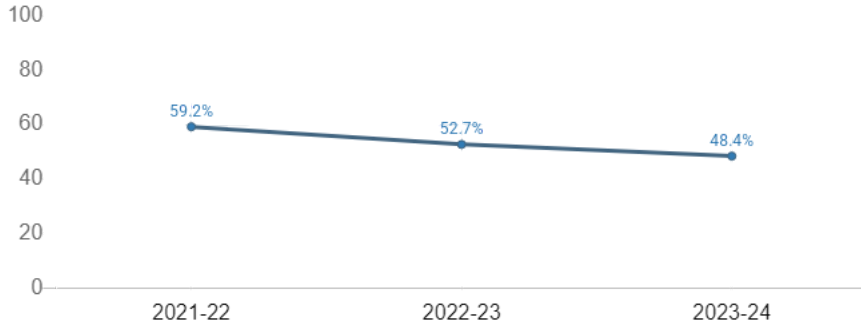

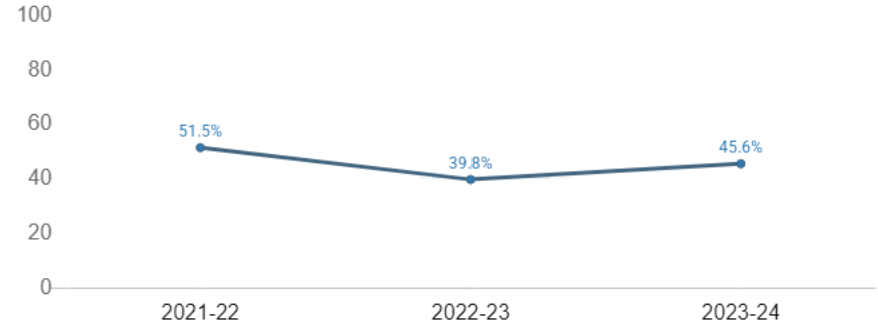
English Language Arts and Mathematics Performance Trends

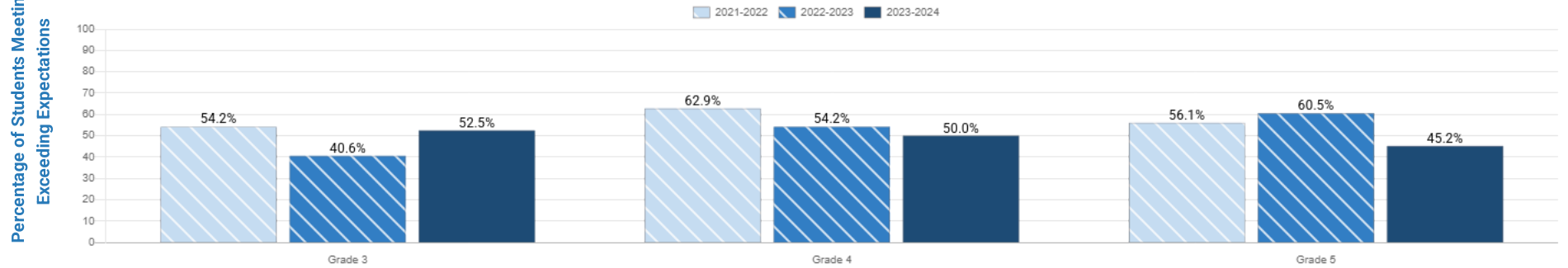

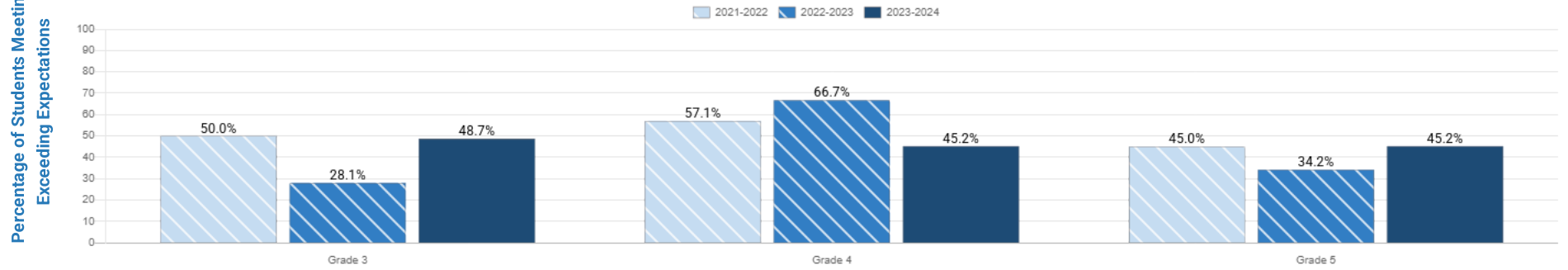

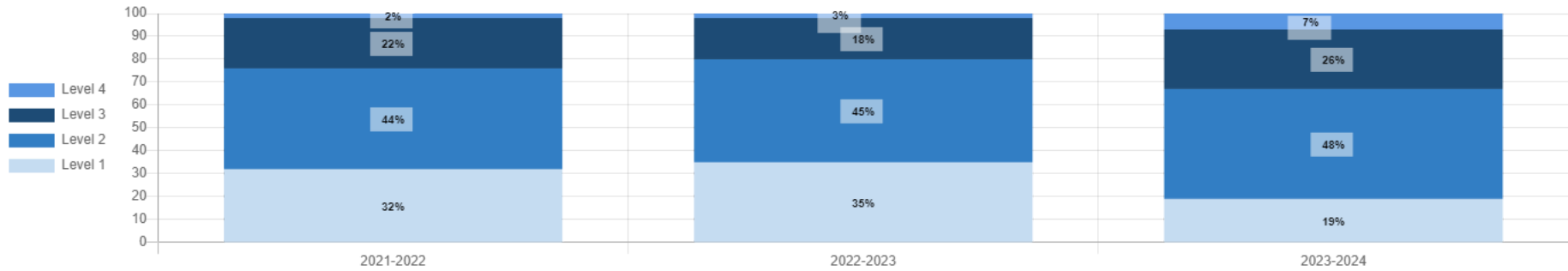

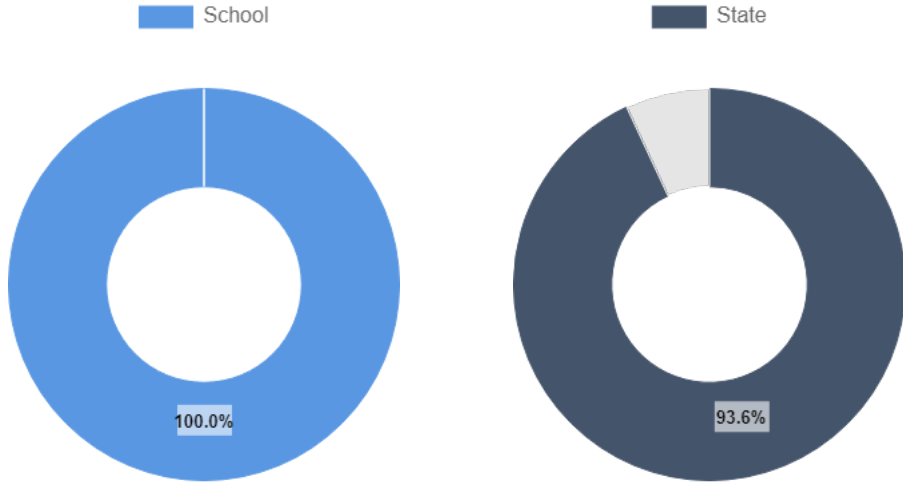

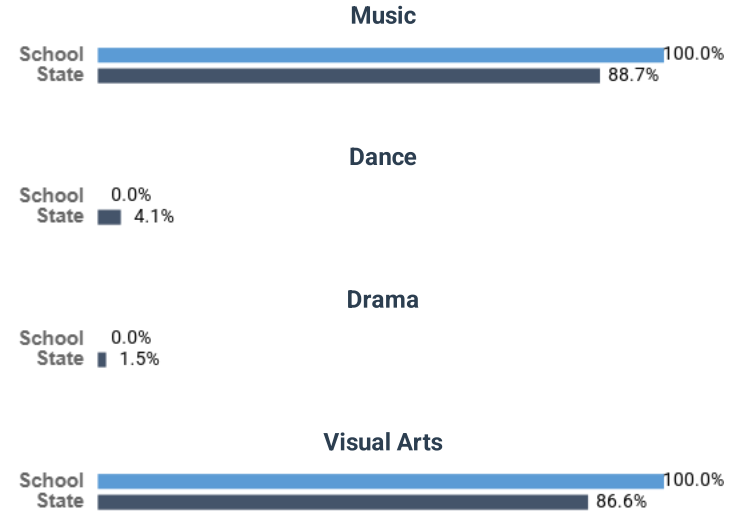

Students enrolled in one or more classes by discipline:



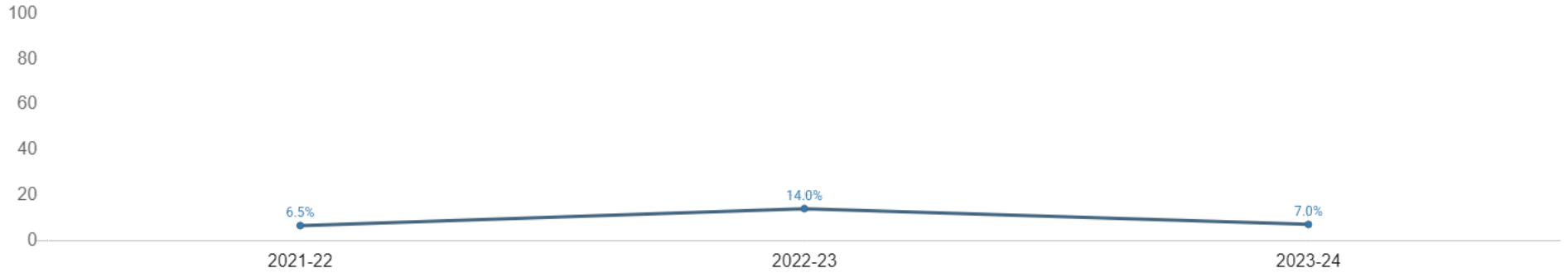

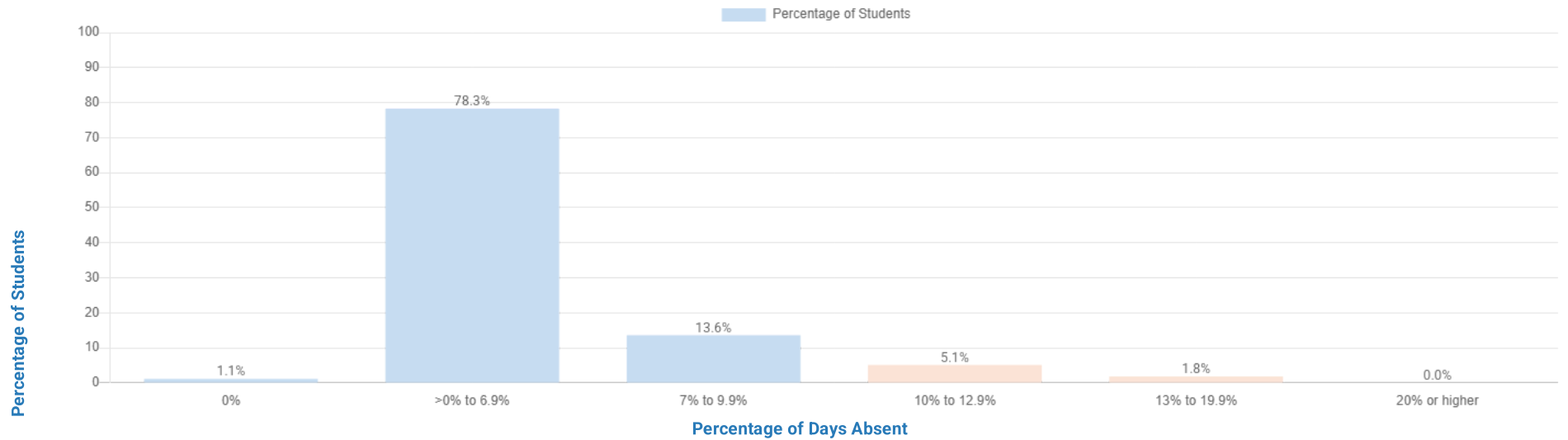

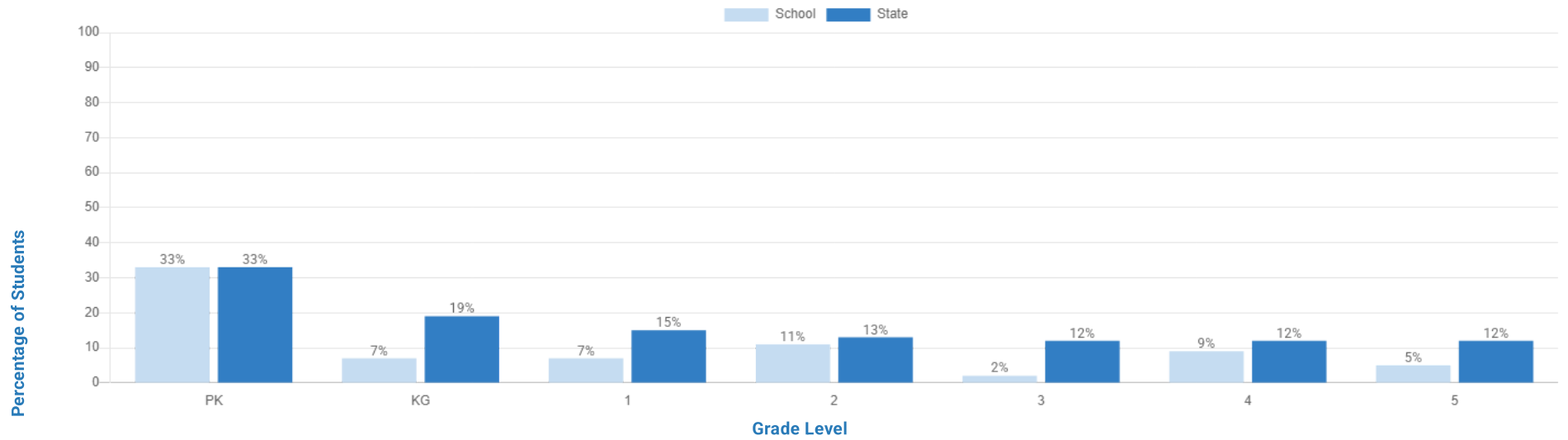

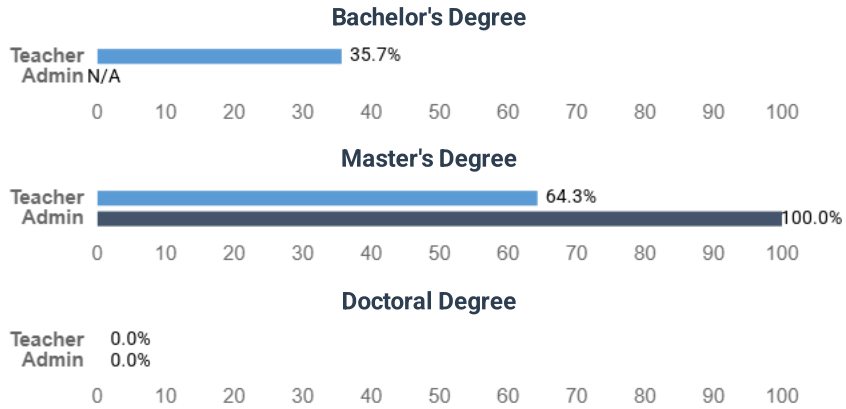

Accountability Summary by Student Group - 2023-24 School Year

Our district-funded Mustang Movers academic intervention club helps students in Gr. 3-5 work toward grade level standards in ELA and Math. One PTO-sponsored club of which we are extremely proud is our TREP\$ entrepreneurial program for students in Gr. 4-5. Other PTO-sponsored clubs include Student Council, Garden Club, Yoga Club, Outdoor Art Club, Storytelling STEM Club, and Battle of the Books.



Before and After School Programs:

The West Milford Public Schools offers a School-Aged Child Care (S.A.C.C.) program that provides before and after school care for working parents. Students complete homework, socialize, and participate in service-learning projects.

Staff and Professional Learning:

Teachers and related staff participate in a wide-range of professional learning opportunities that are provided at the district level and are reflective of our district and school student learning goals. Current initiatives include Eureka Math Training, Conquer Math, iReady Assessment Training, and Social/Emotional Learning.



Student Supports and Services:

MRS offers a variety of student support services to meet the differentiated needs of our students. The MRS reading specialist and Encore teacher support general education students who need additional intervention with literacy or math skills. If students require special education services, MRS has a variety of programs, including 3 resource classrooms, 2 self-contained classroom programs, and 4 special education preschool classrooms. On staff, MRS also has three speech/language specialists, two occupational therapists, one physical therapist, and two behaviorists.



Student Health and Wellness:

Each student at MRS participates in Physical Education and Health classes weekly, as well as having access to a full-time certified teaching nurse. School-level health offices provide services at an individual level and support the community as a whole. The MRS staff also includes a part-time social worker who provides the students with social/emotional support.

The MRS PTO sponsors after-school clubs and activities, hosts activity/family nights, and organizes fundraisers to support the school and other local service organizations.
