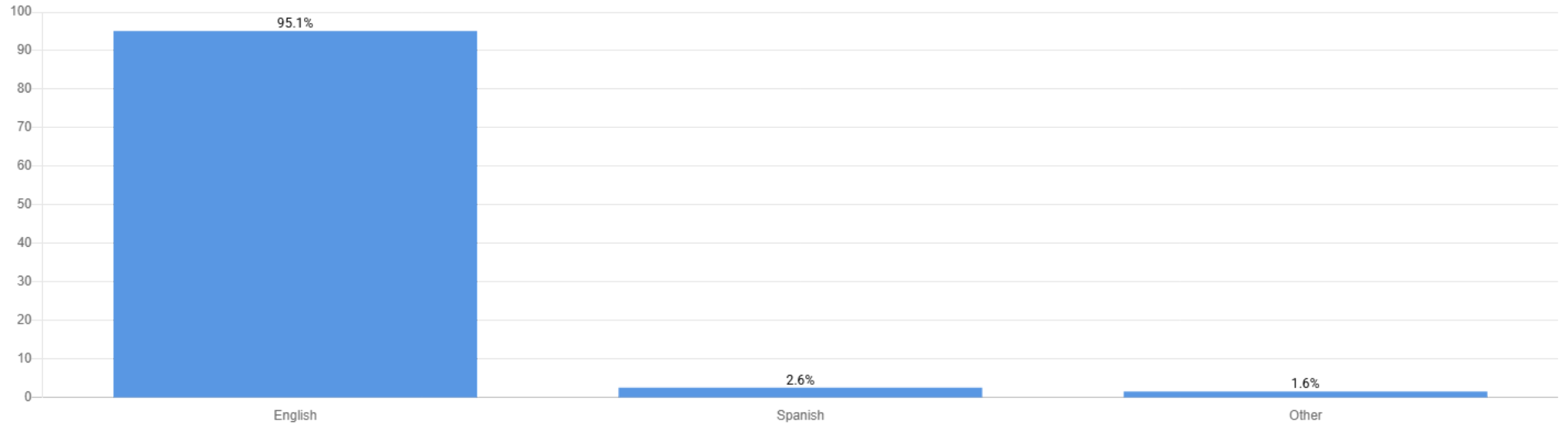

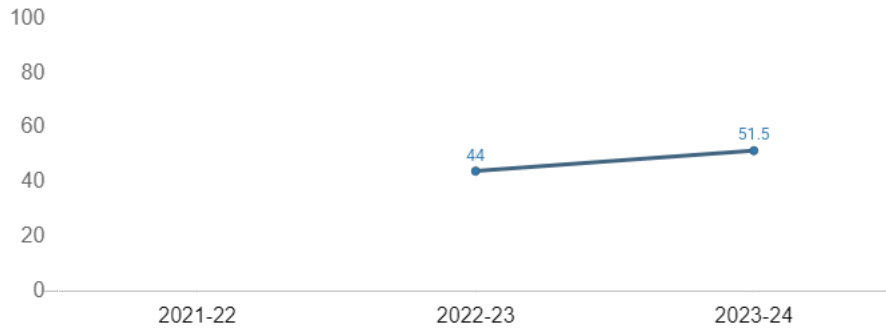

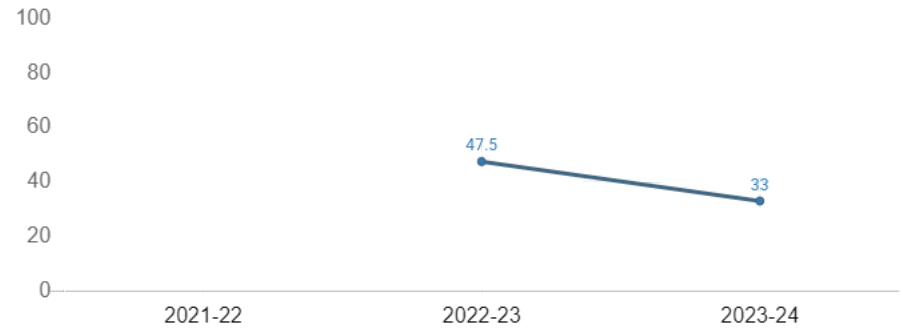

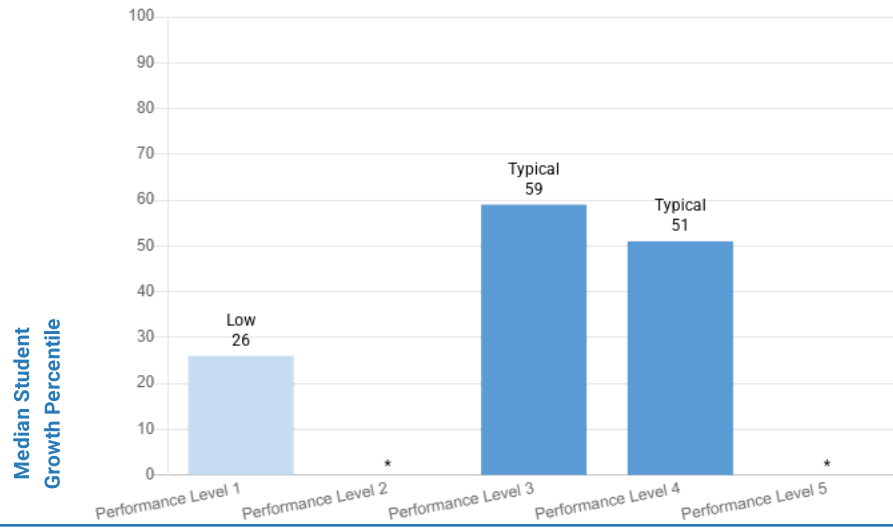

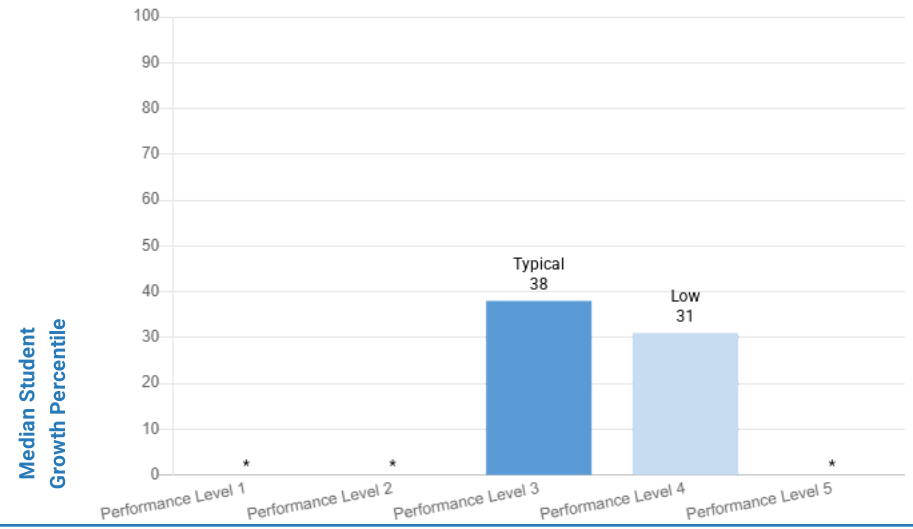

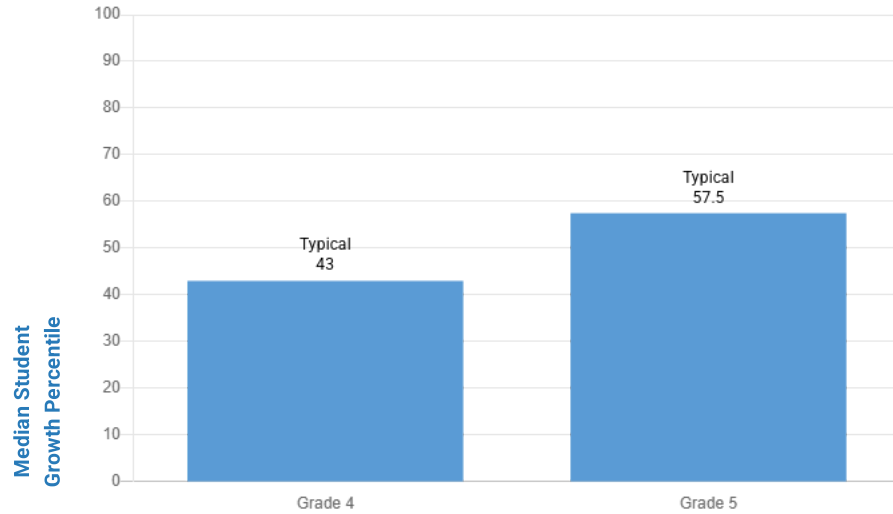

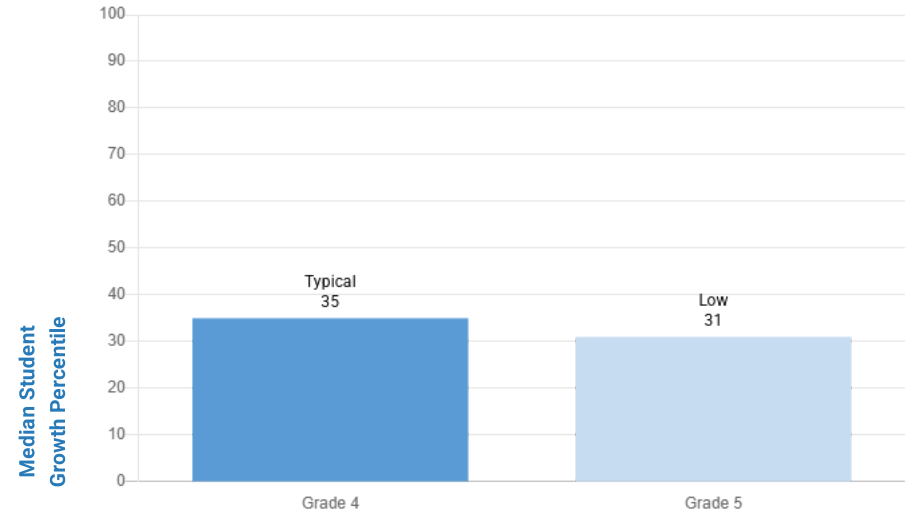

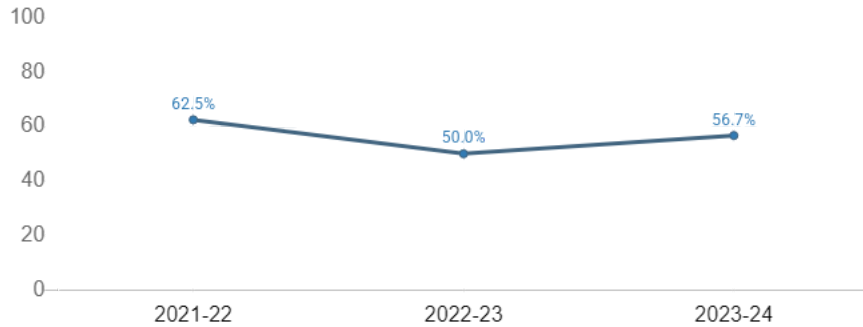

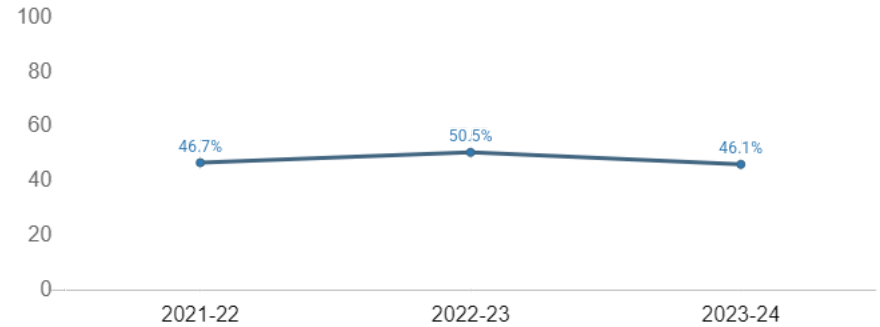
English Language Arts and Mathematics Performance Trends

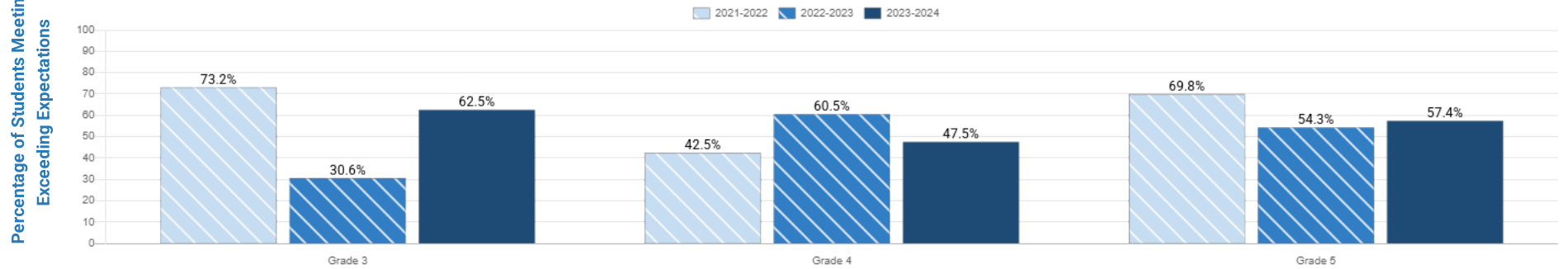

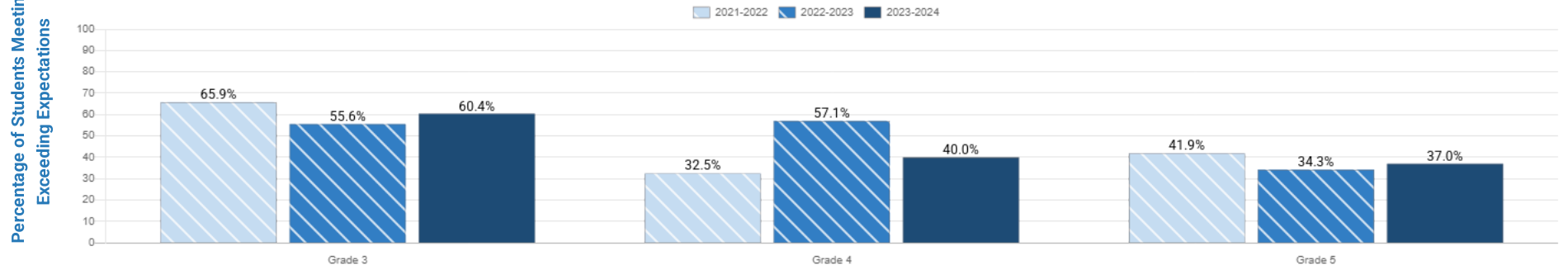

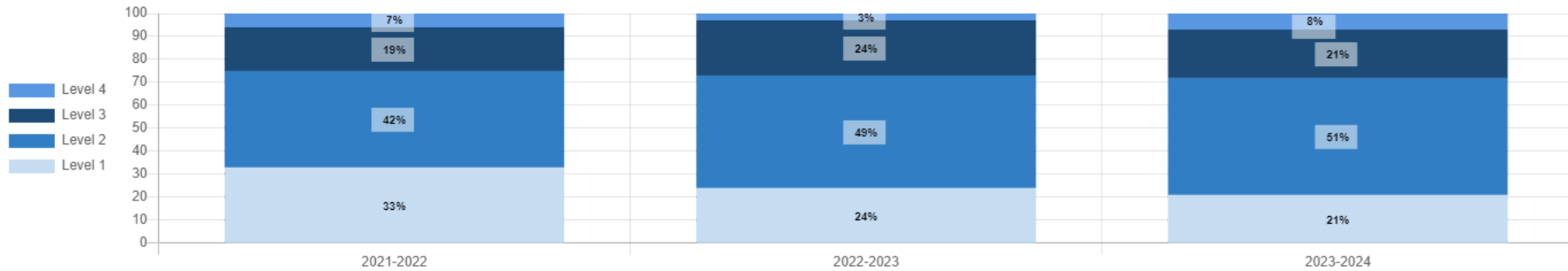

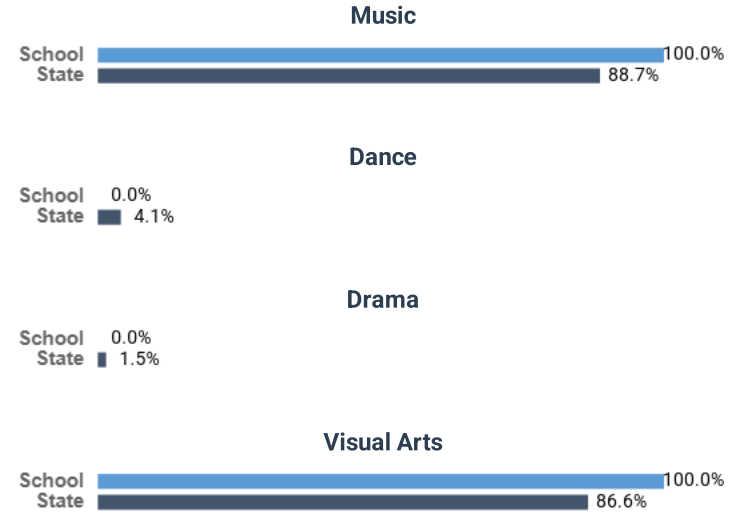

Students enrolled in one or more classes by discipline:



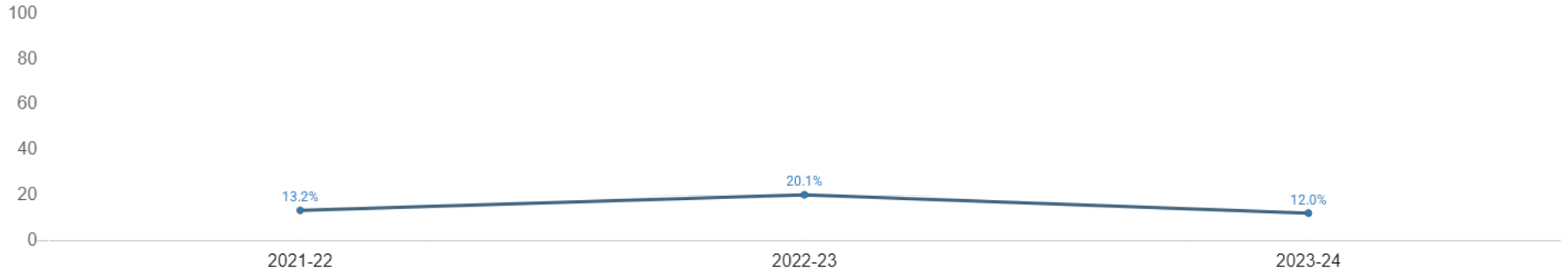
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 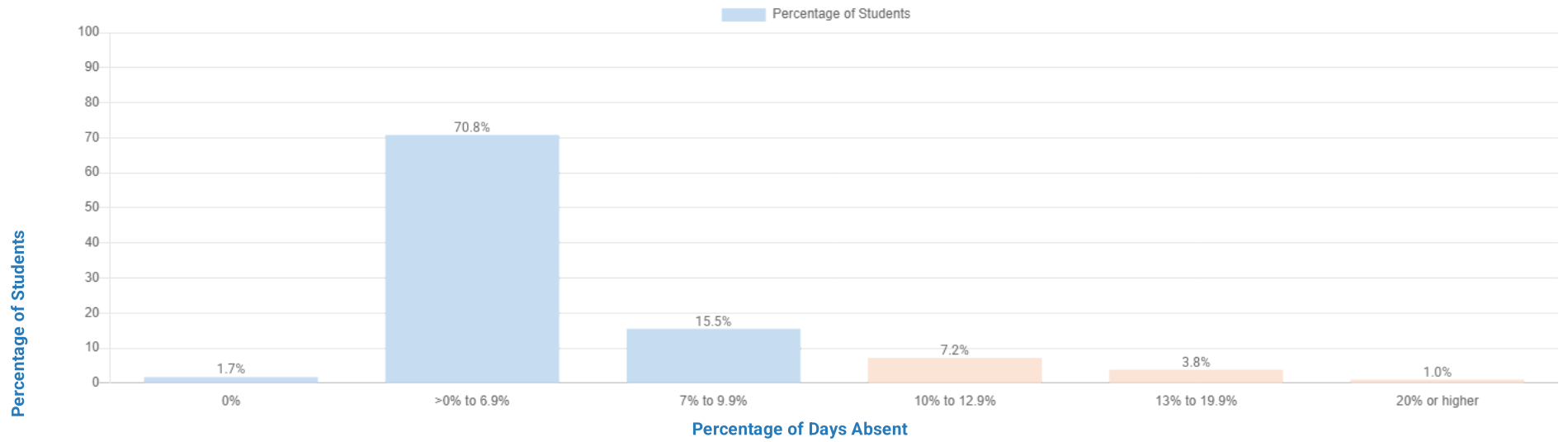

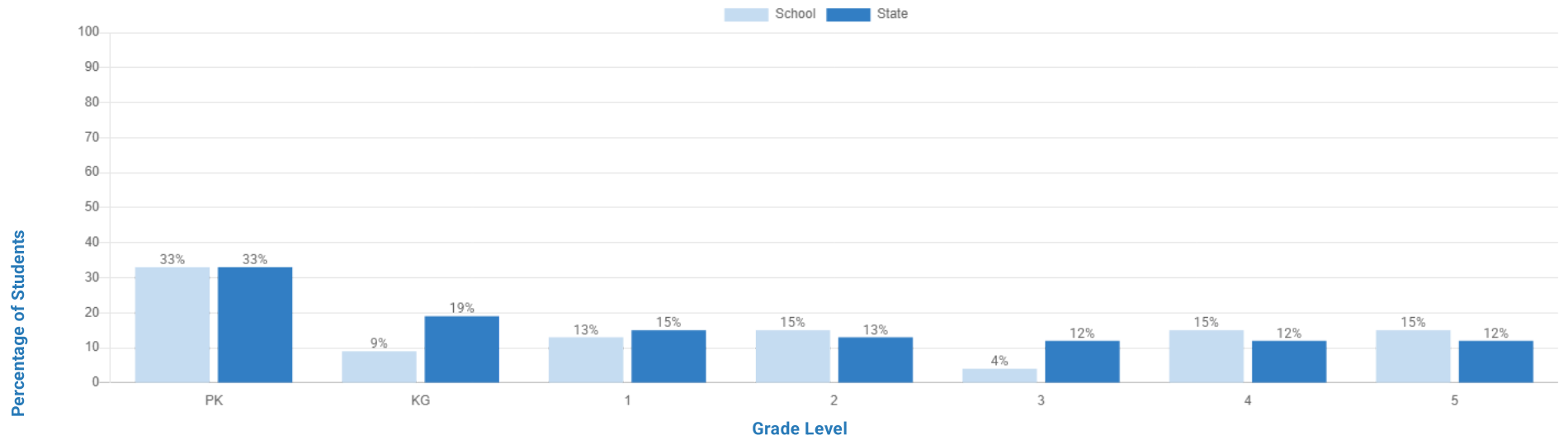

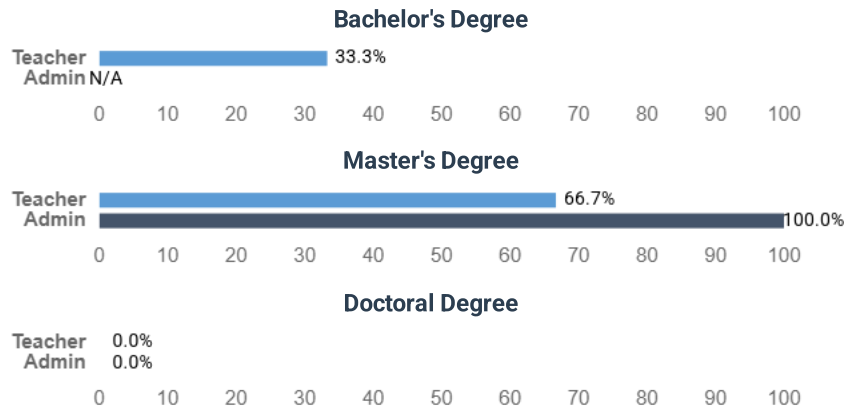

Students in need of academic support are supported by a reading specialist, one Basic Skills (ENCORE) teachers and 3.5 resource teachers. Instrumental music, chorus, and gifted and talented art program are also offered. Our school uses i-Ready to give students periodic diagnostics and provide students with a personalized learning path.



Clubs and Activities:

Clubs are offered through the PTA and various grants to meet the needs of students. Clubs include: Green Team, Running Club, Trep\$, Student Council, Character Ambassador, Mindfulness Club, Kickstart for SEL, School Safeties Program, and Scooter Football. Our district also supports our Eagle Scholars club to offer before and after school academic support for students in need.



Before and After School Programs:

West Milford Public Schools offer a School-Aged Child Care (S.A.C.C) program that provides before and after school care for working parents. Students complete homework, socialize, and participate in service-learning projects. Marshall Hill School PTA also offers opportunities throughout the year for students to join clubs based on interest such as in sports, environmental, and to build school partnership between school and home.

Staff and Professional Learning:

Teachers and related staff participate in a wide-range of professional learning opportunities that are provided at the district level and are reflective of our district and school student learning goals. Programs and trainings of importance are: Conquer Math training for staff to enhance best practices in math instruction, Readers and Writers workshop, Go Math and ST Math, Differentiated Instruction, Meaningful technology integration, Character Education, and school-wide Zones of Regulation implementation.



Student Supports and Services:

Intervention and referral services are designed to assist students who are experiencing learning, behavior, or health difficulties. Social-emotional wellness is also a strong goal at MH. Our school social worker runs group and individual sessions to support student well-being and also pushes into the classrooms for SEL lessons. We also implement a school-wide Zones of Regulation system to help students identify their emotional state and provide tools to help them regulate themselves if they feel disregulated.



Student Health and Wellness:

Each student at Marshall Hill School participates in Physical Education and Health classes weekly as well as having access to a full-time certified teaching school nurse. School level health offices provide services at an individual level and support the community as a whole.
