







Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Staff and Professional Learning:

Salem High School has partnered with 21st Century STEM for math and science professional development as well as Penn Literacy Network for ELA and social studies teachers. Teachers currently teaching IB and AP courses, as well as back-up staff, are trained in AP and IB courses as required by their curriculum. Salem High School also participated in an equity visit with the NJ Network of Superintendents.



Salem High School offers ACT Prep Program and the CollegeWise College Admissions program. This program supports students' acceptance into college.
