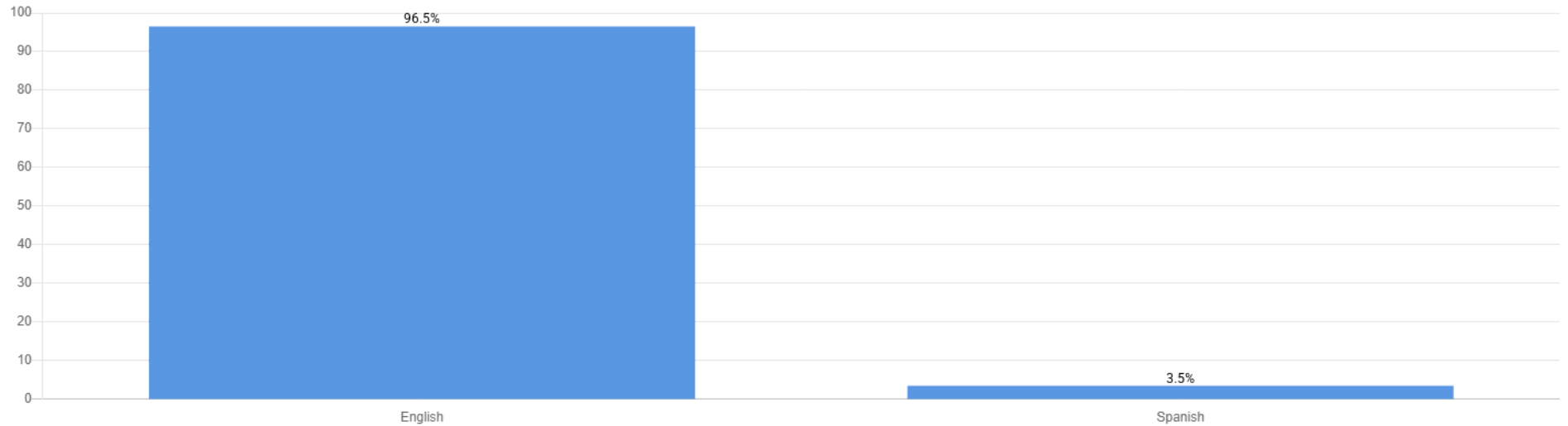

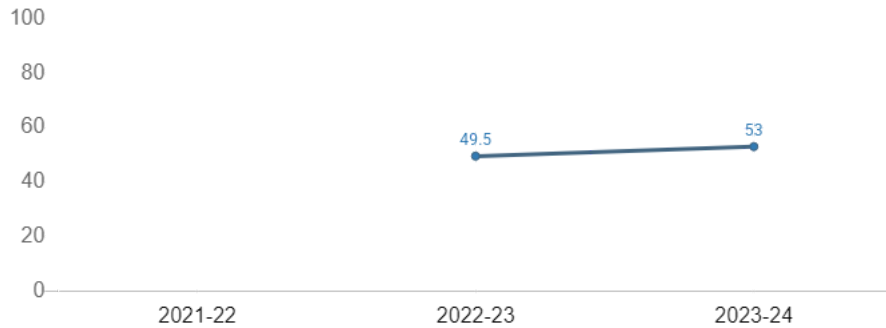

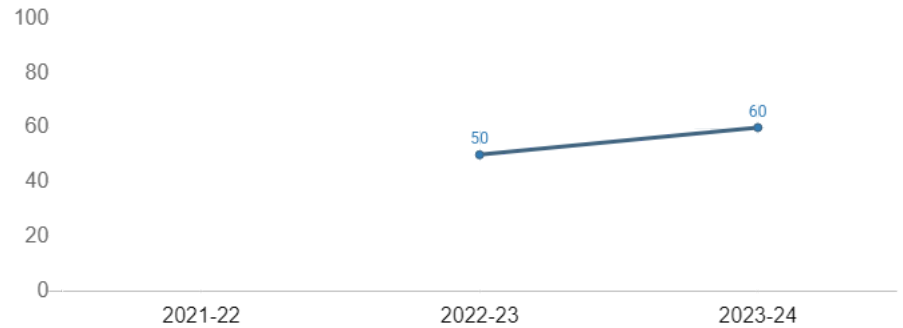

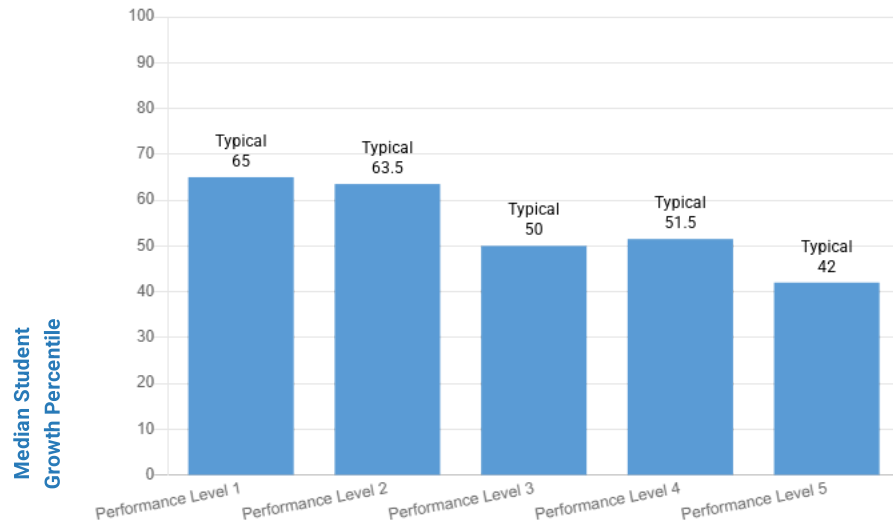

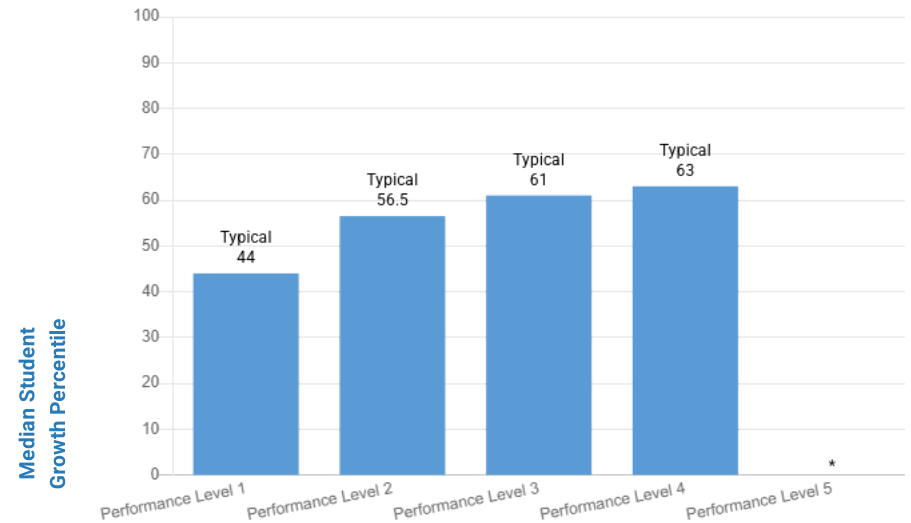

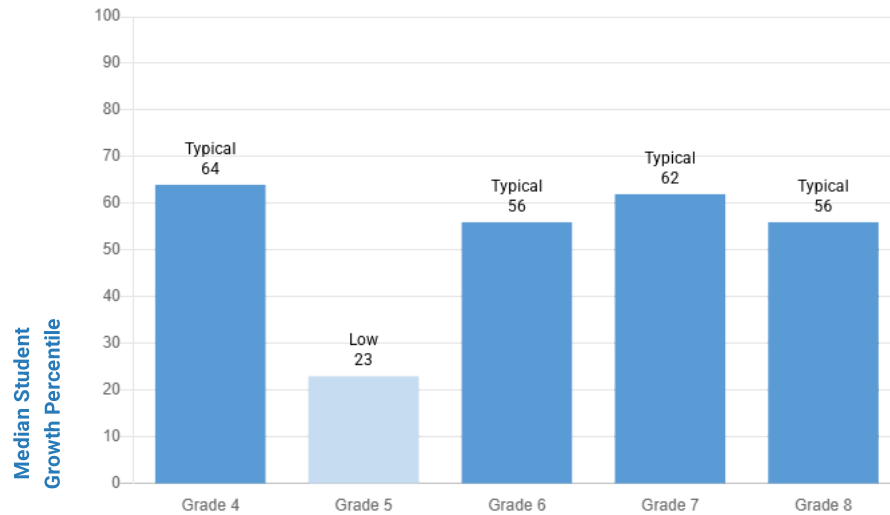

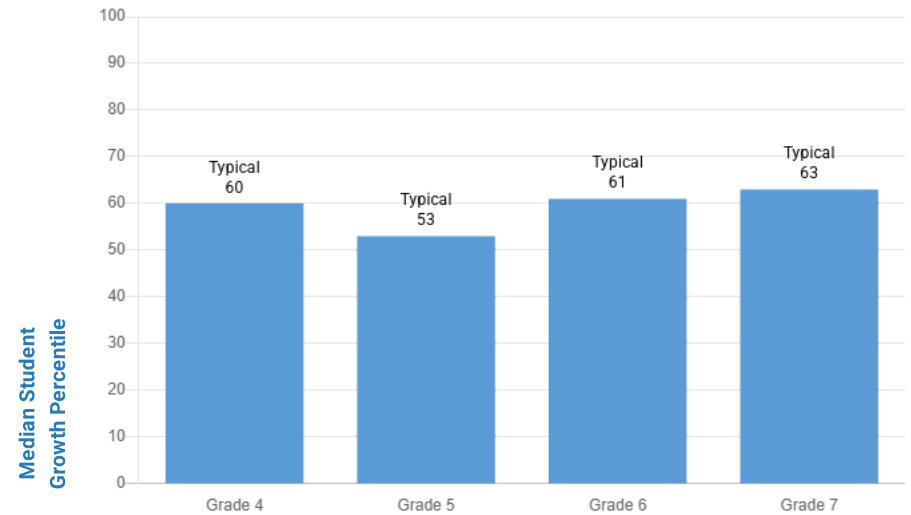

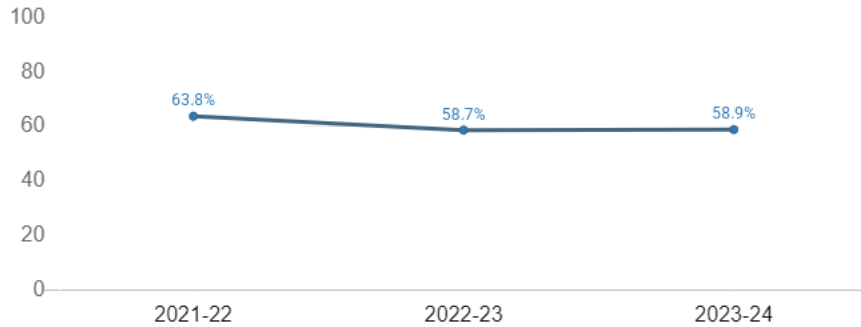

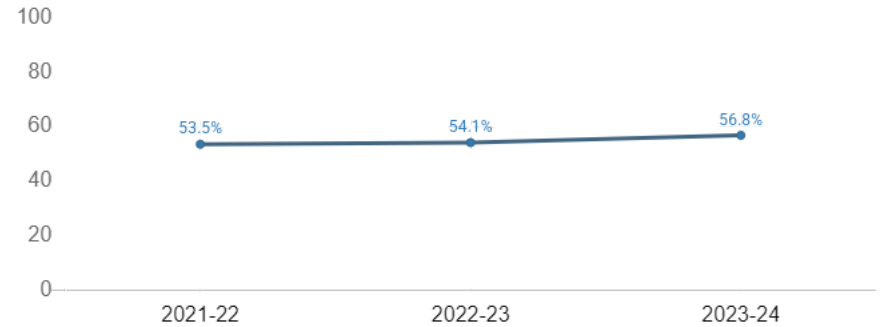
English Language Arts and Mathematics Performance Trends

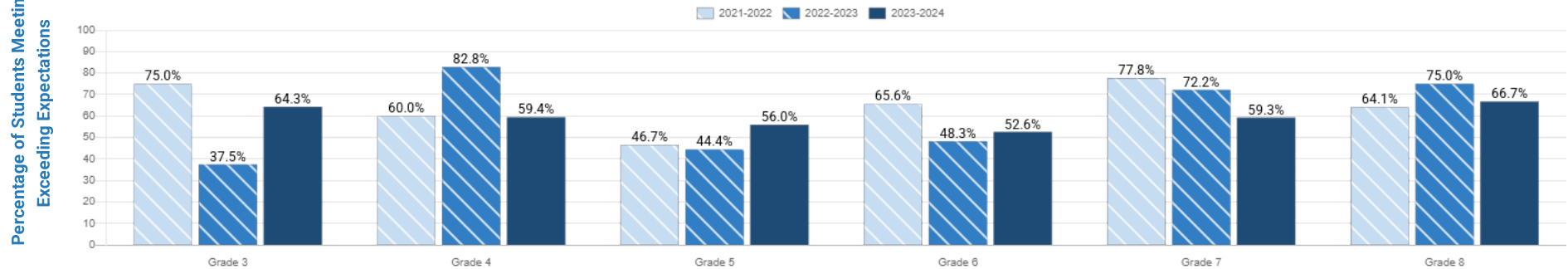

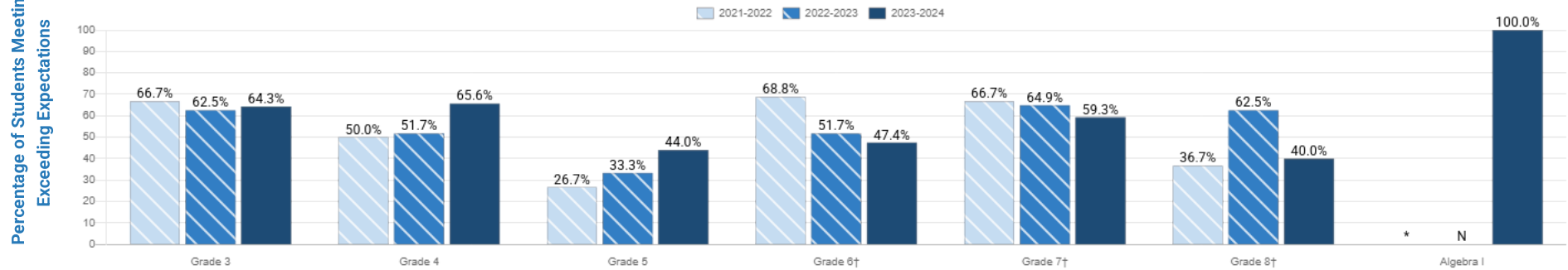

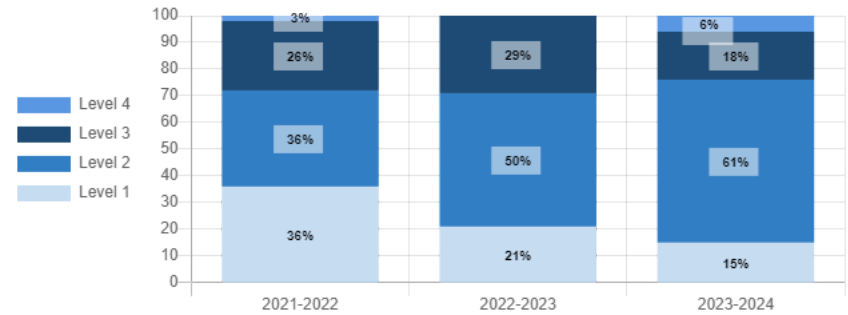

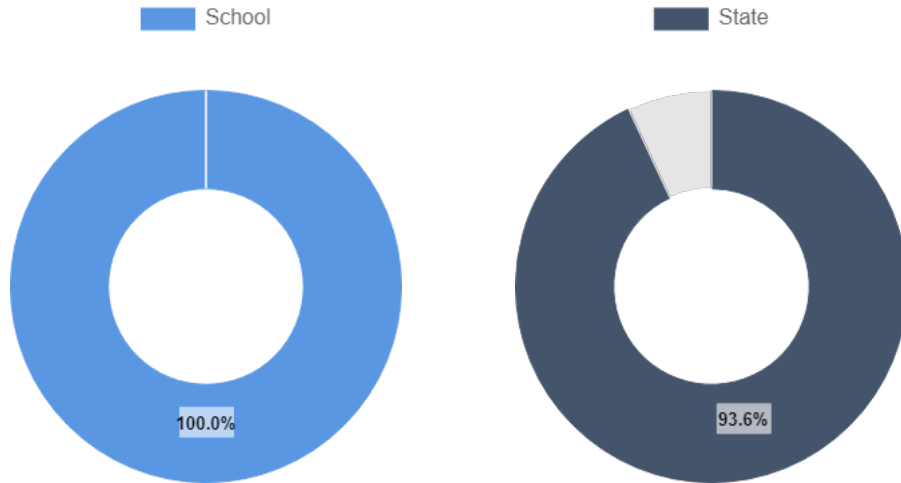

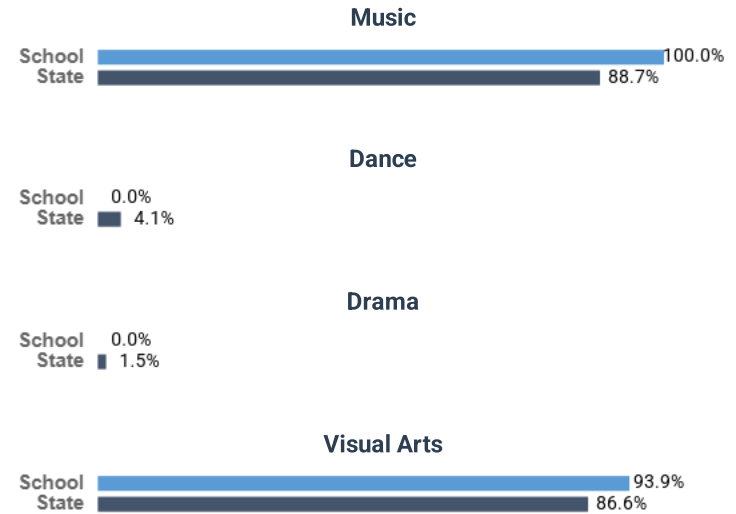

Students enrolled in one or more classes by discipline:



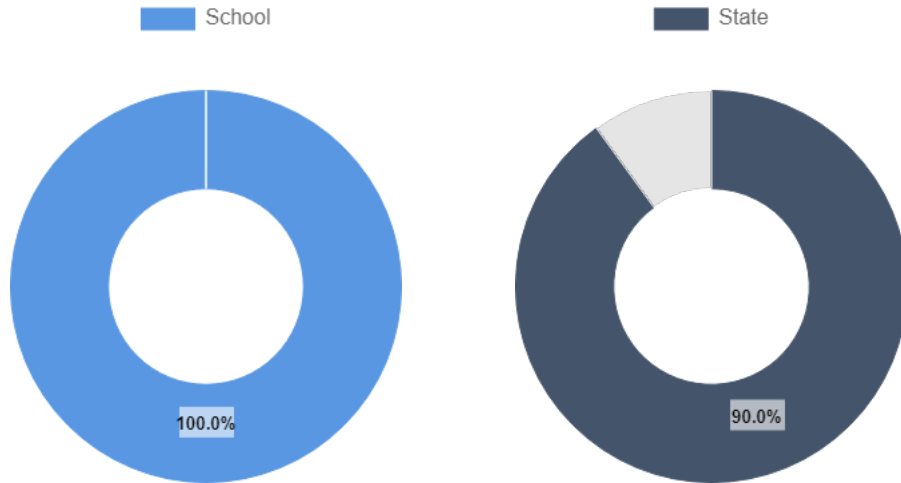

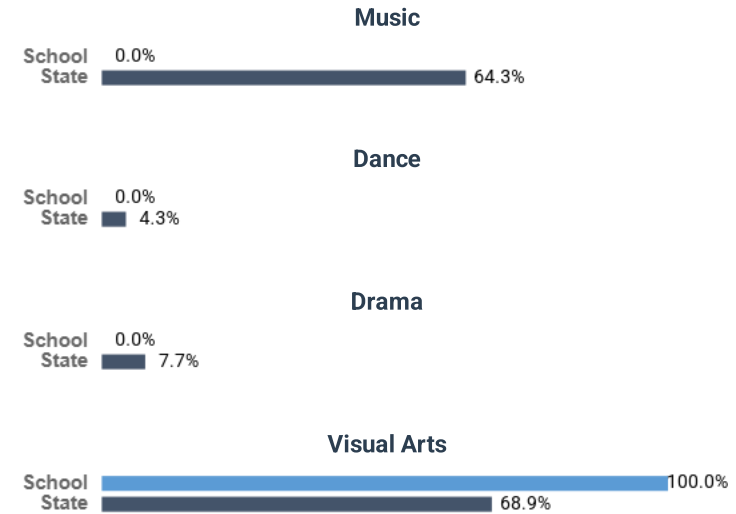

Students enrolled in one or more classes by discipline:



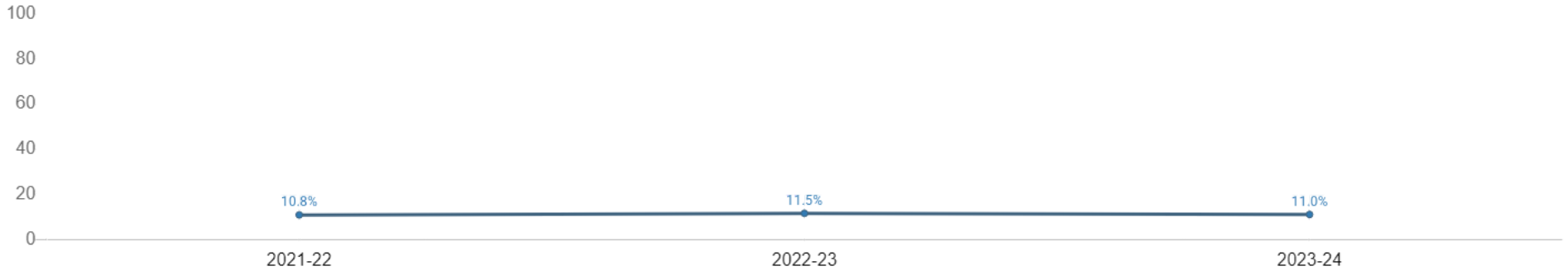

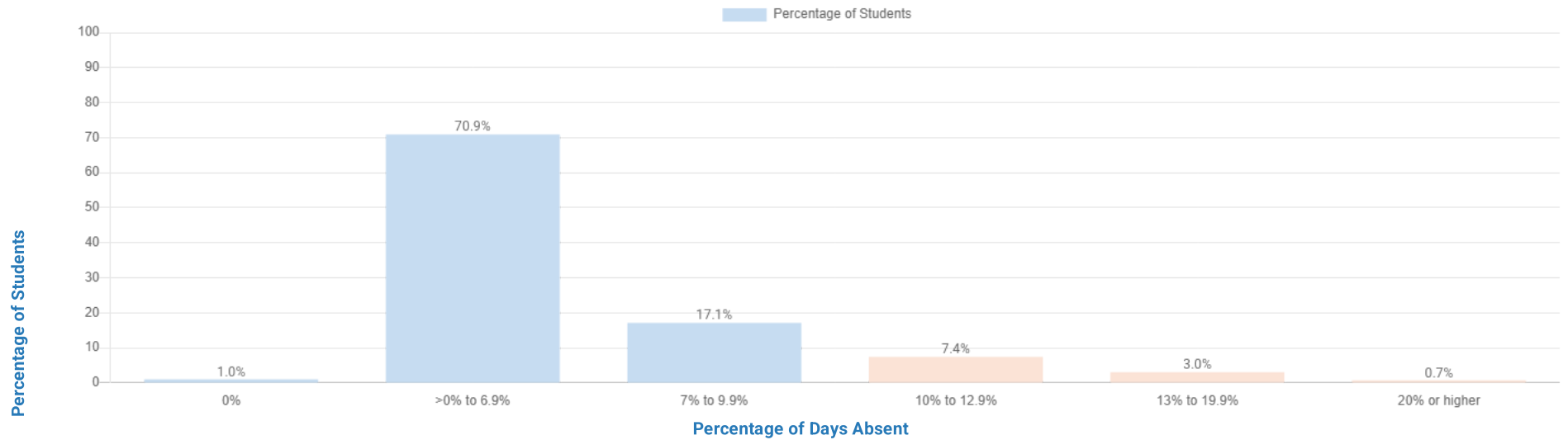

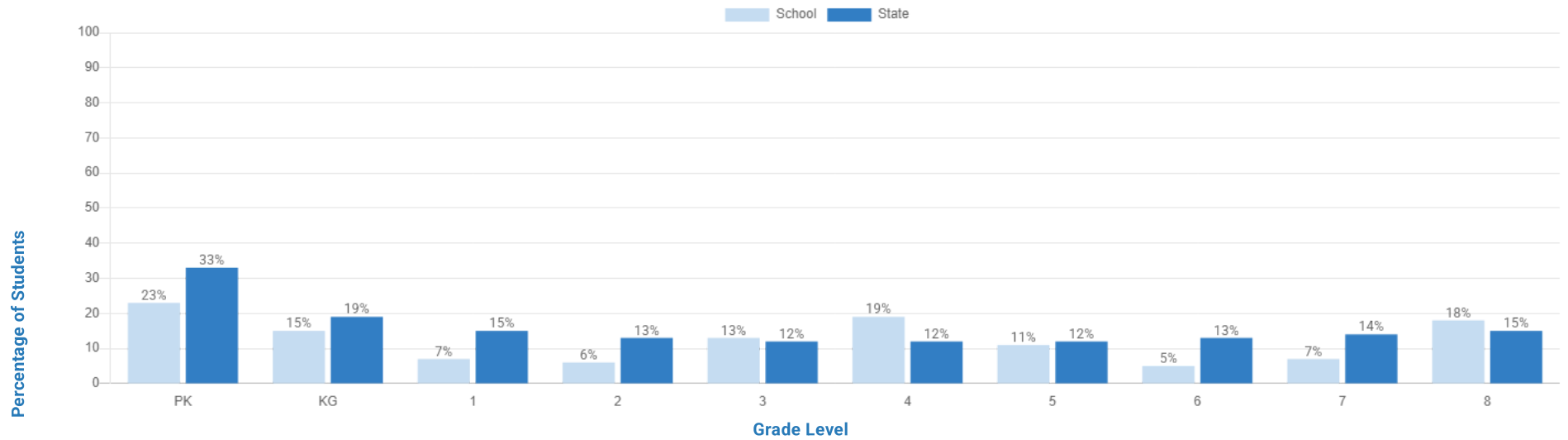

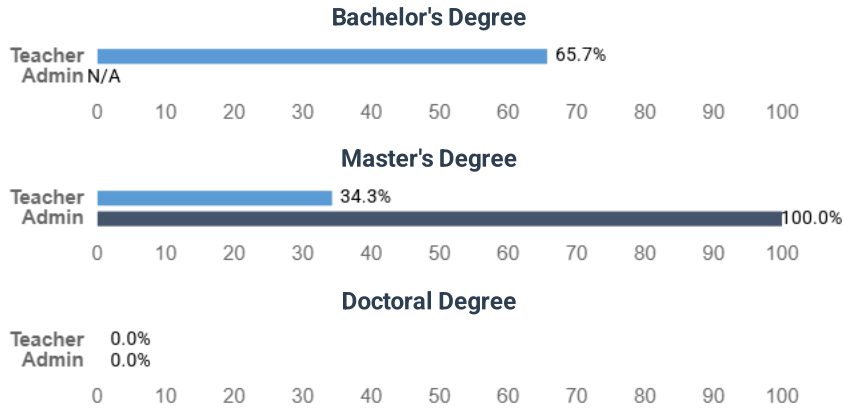

Upper Pittsgrove School offers before and afterschool childcare services to the families of UPS students through a partnership with the YMCA.



Staff and Professional Learning:

Staff are provided with opportunities throughout the year to attend workshops, higher education courses, as well as professional development opportunities. Our district participates in the county-wide in-service allowing for collaboration with their peers in neighboring schools. Instructional coaching in the area of writing is currently part of the professional growth model for K-3 teachers. District wide the focus is on creating inclusive learning environments, unpacking the NJSLs, and continued use of data to drive decisions and instruction. The district provides 4 full day inservice days along with after school professional learning communities where staff analyze different data points for trends that can lead to continuous growth and improvement.



Student Supports and Services:

Upper Pittsgrove School has a Student Assistance Coordinator (SAC) on staff, as well as a fully staffed Child Study Team. The SAC is also a licensed therapist and provides assistance to not only our students, but also our staff members. The district has an I&RS team that uses a Response to Intervention model.

Our full-service school cafeteria offers breakfast and lunch that meets the state required guidelines for nutritious meals.

Upper Pittsgrove School sits on 38 acres in rural Salem County. Surrounded by farms, the original building was built in 1948, with additions and renovations in subsequent years (1962, 1980, 1994). The grounds and facilities are well maintained and have been upgraded for the safety, health, and security of the students, staff, and visitors alike.



School Safety:

The school considers school safety a top priority, and is under constant review for improvements. The school underwent a safety and security audit provided by a representative from the state. The audit provided feedback but no concerns. A full time school safety specialist is on staff to work closely with local law enforcement and the NJSP school resource officer. The school safety specialist attends local safety and security meetings as well as conducts school level meetings with the school security team that evaluates any concerns that may arise.
