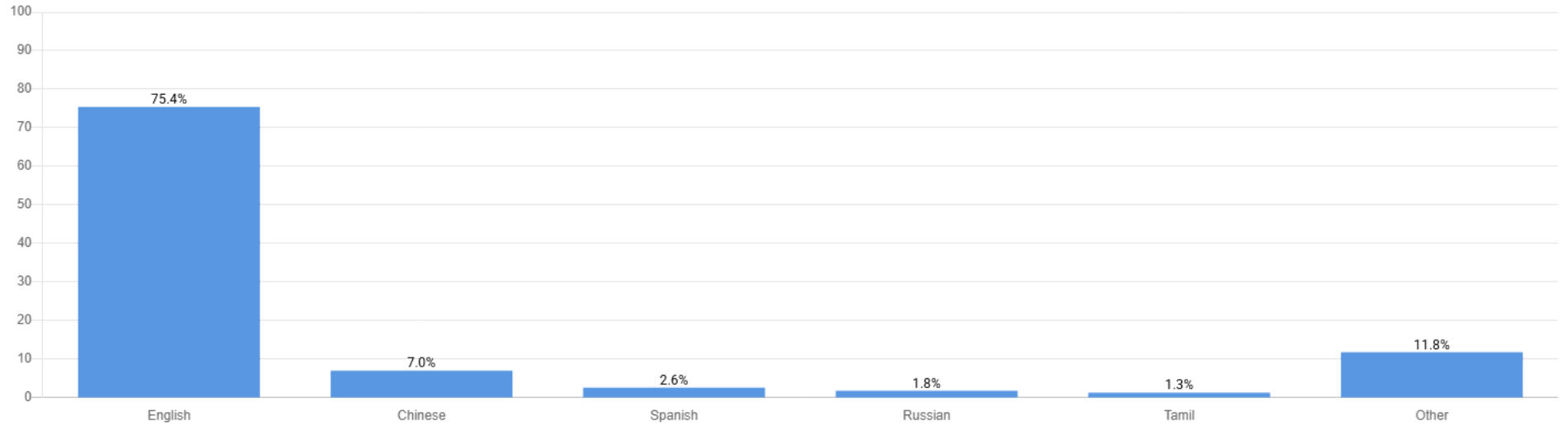

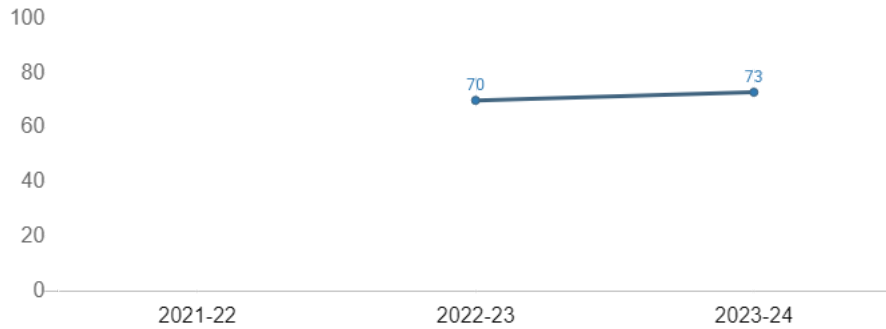

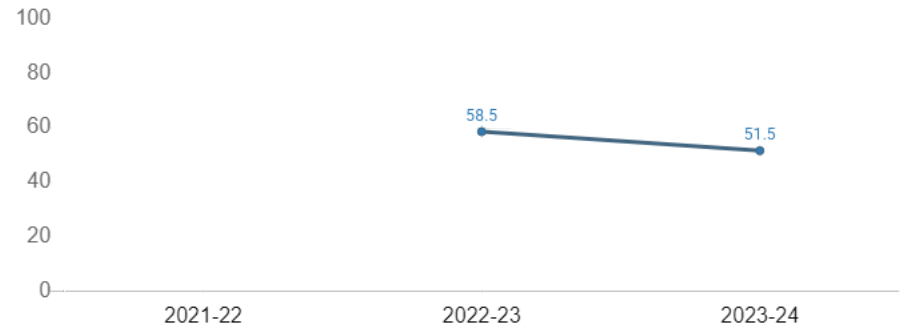

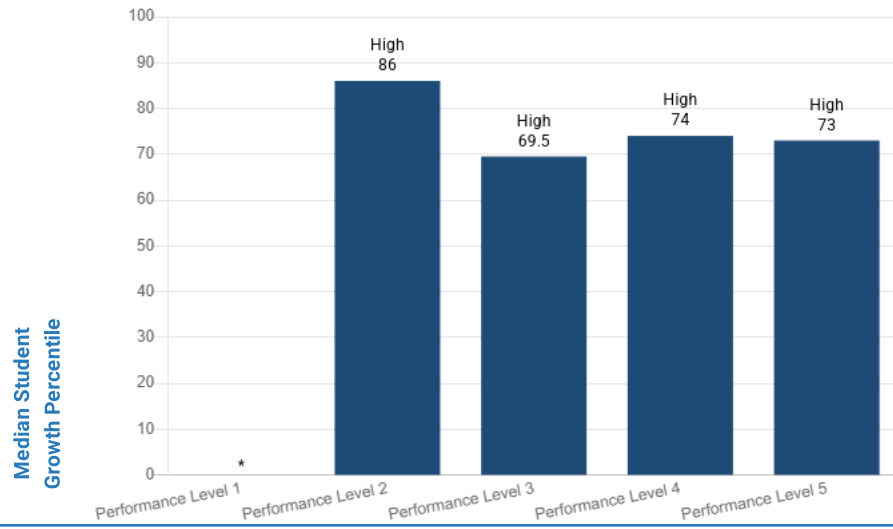

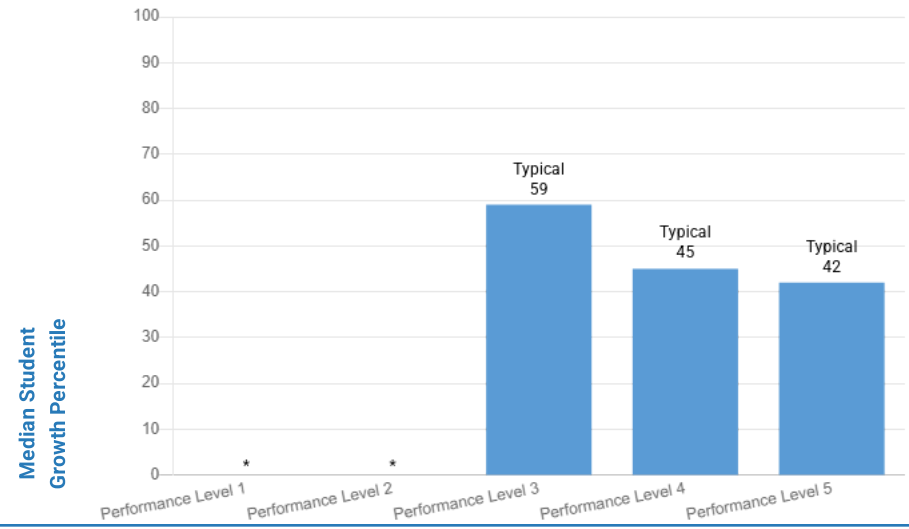

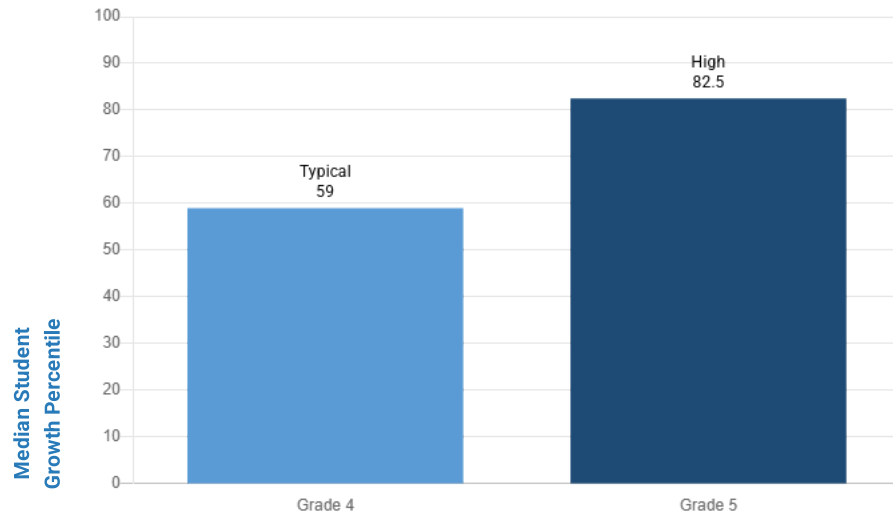

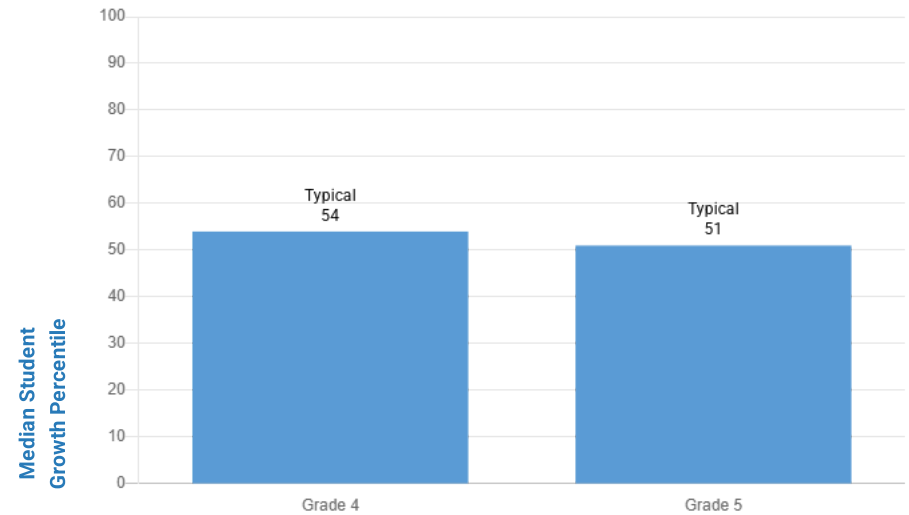

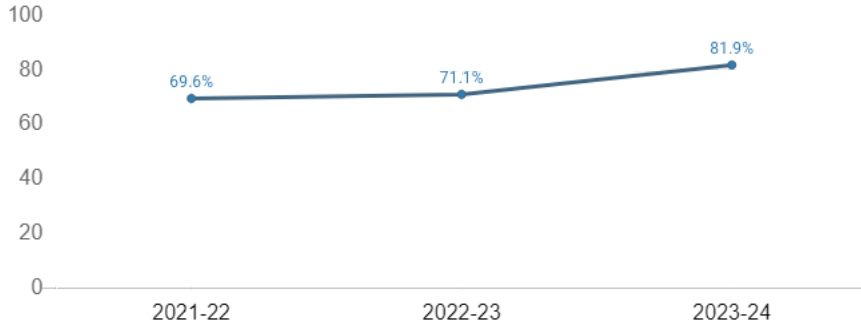

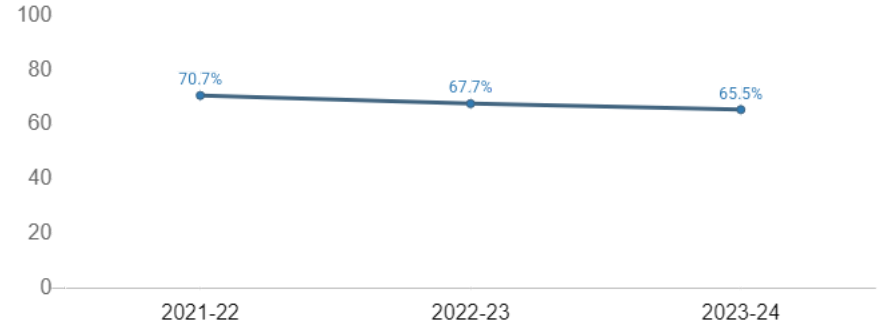
### English Language Arts and Mathematics Performance Trends

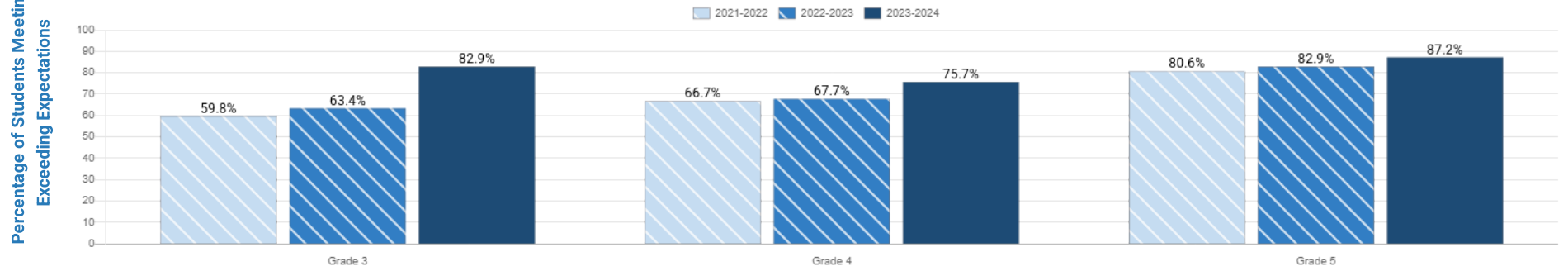

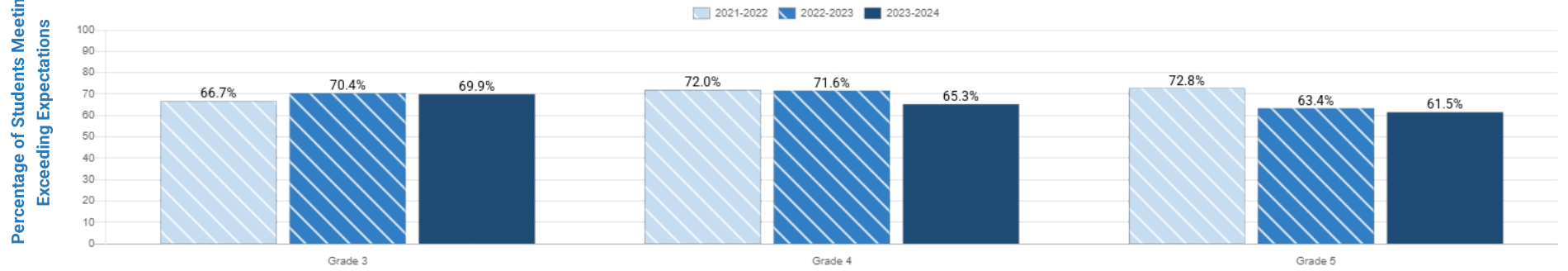

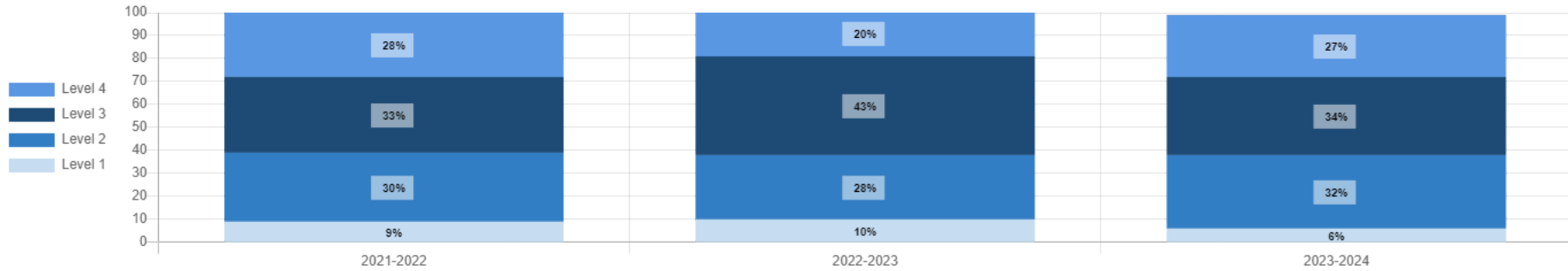

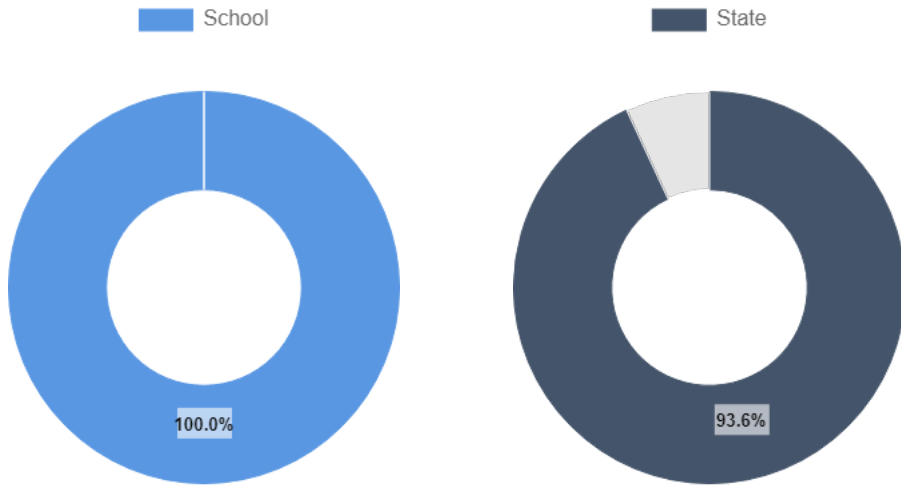

**Students enrolled in one or more classes by discipline:**



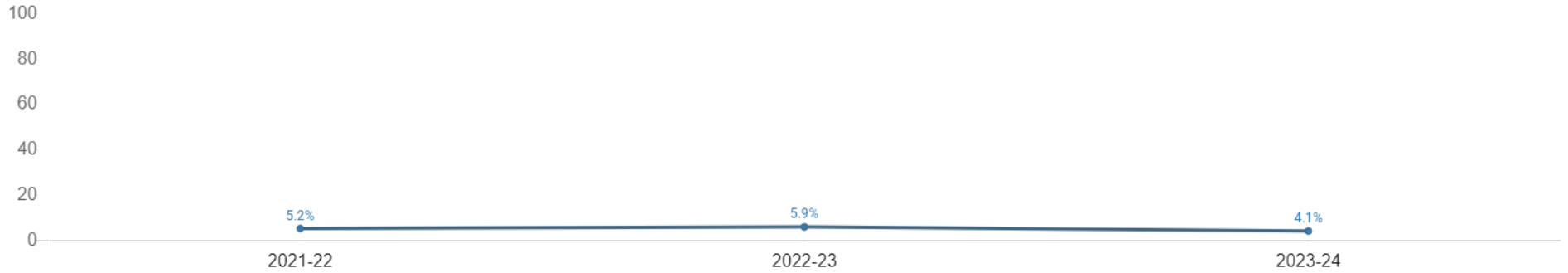

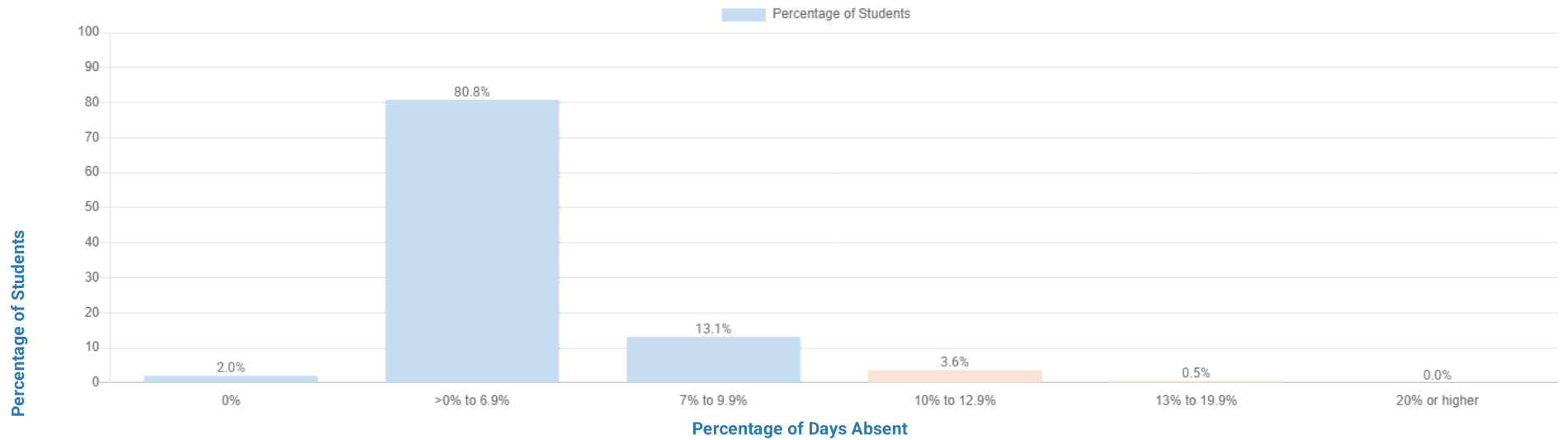

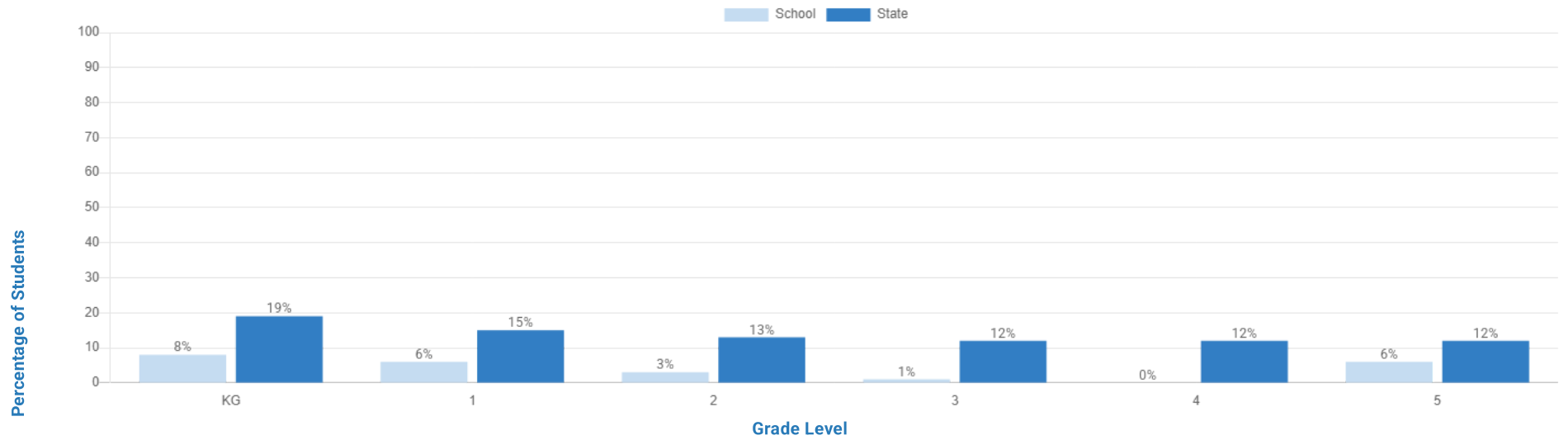

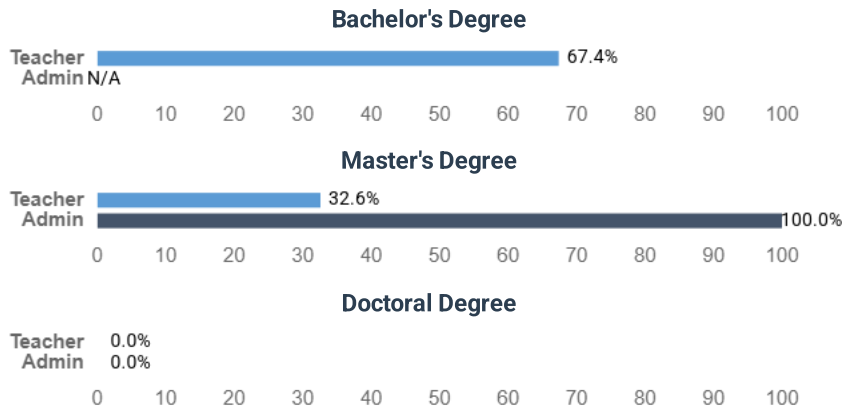

Our educators understand, recognize and address the multiple intelligences, varying learning styles and differing developmental stages of the students. Our literature-based reading program is a balance of shared reading, guided reading and phonetic integration. Our math program is a high interest, hands-on, inquiry-directed approach that complements our district curriculum goals and objectives. All students are exposed to art, music, technology and physical education. It is our intent to provide developmentally appropriate programs with high expectations and opportunities for challenge and enrichment. We embrace the opportunity to nurture and foster values and morals in our students that will result in compassionate individuals



### Sports and Athletics:

Students participate in physical education twice a week to focus on Health and Wellness. Students also participate in recess five days a week and receive Health instruction within their classrooms.
