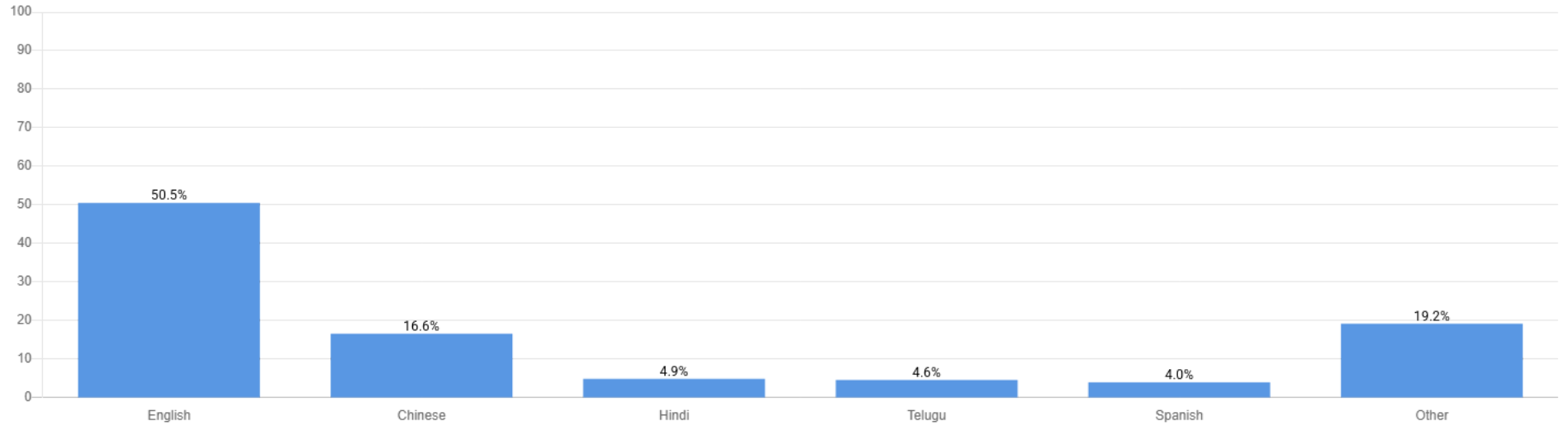

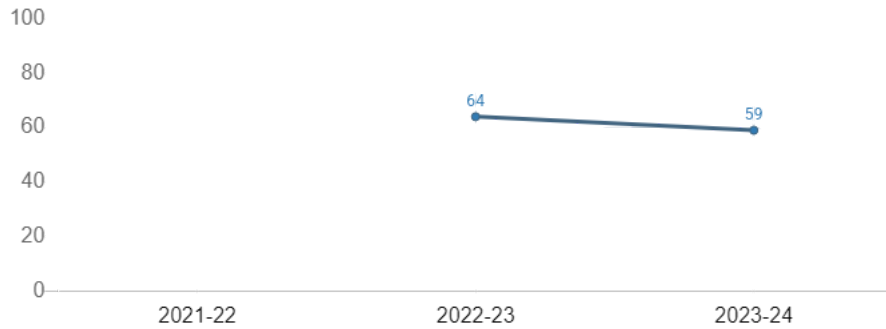

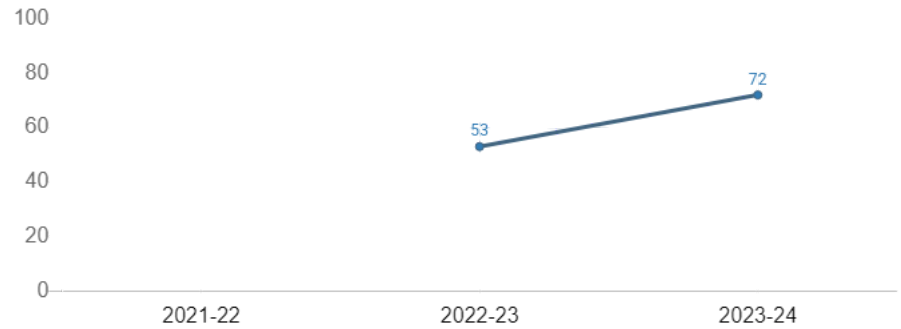

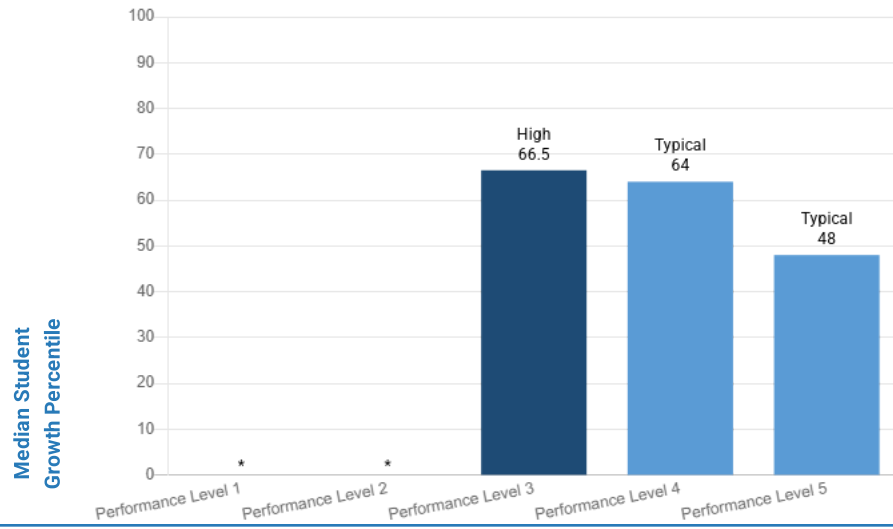

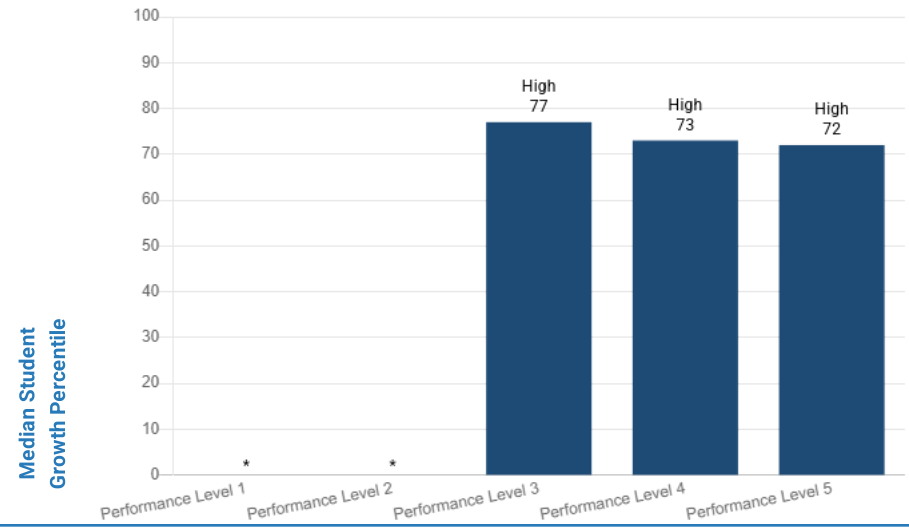

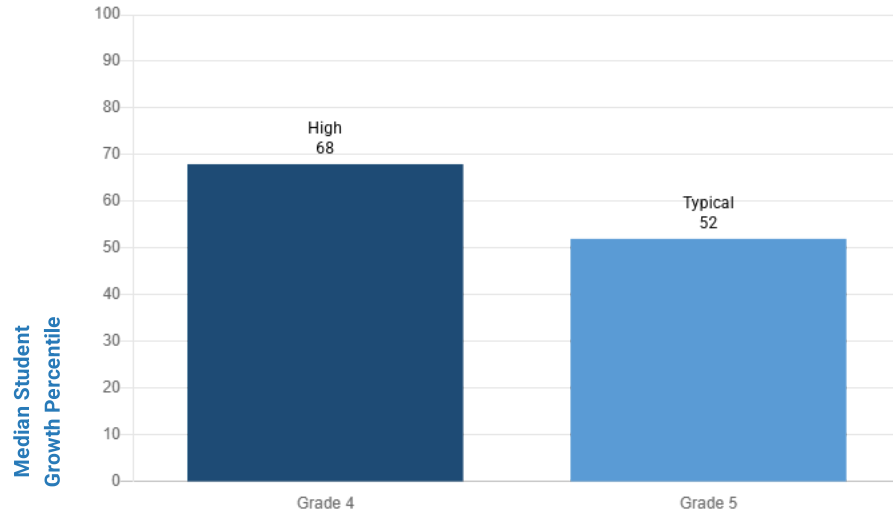

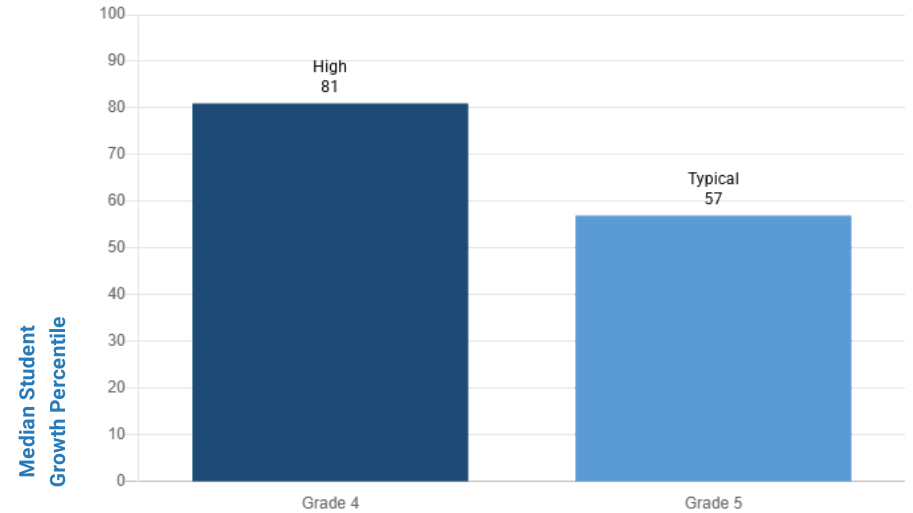

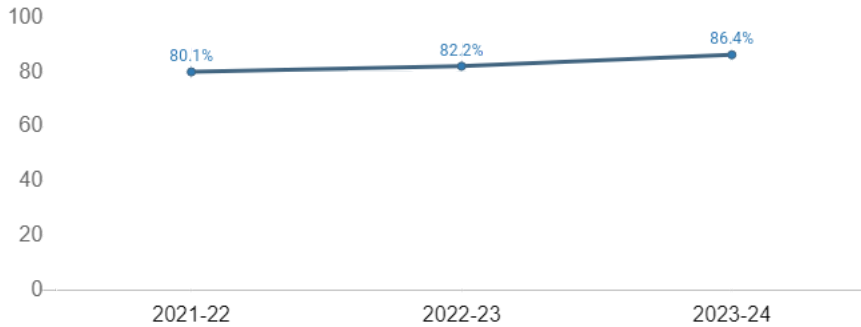

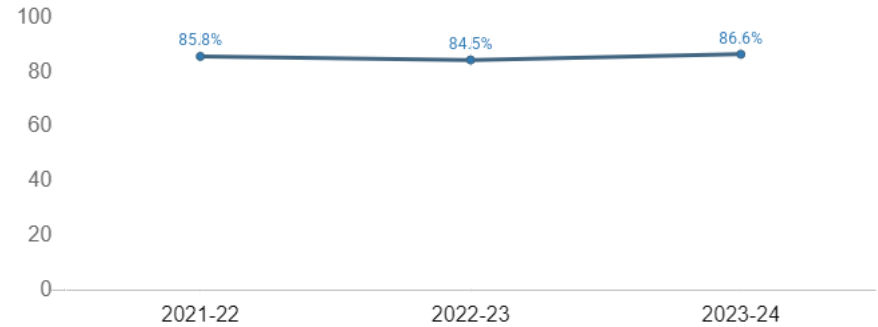
English Language Arts and Mathematics Performance Trends

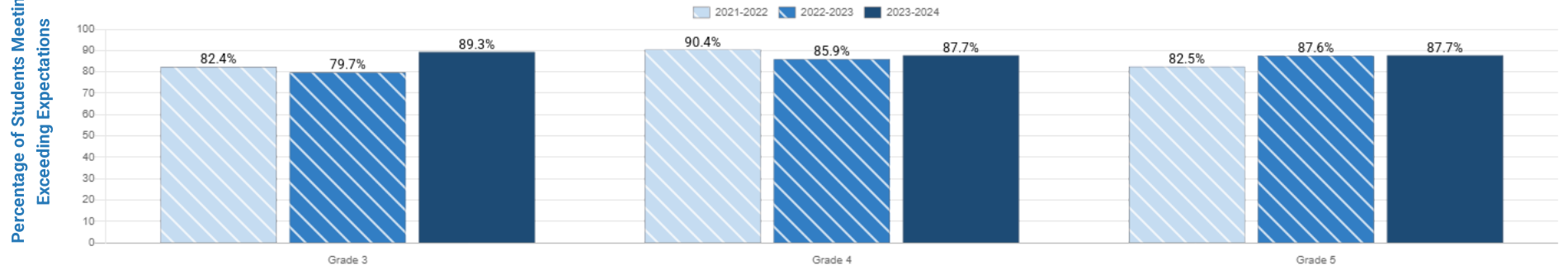

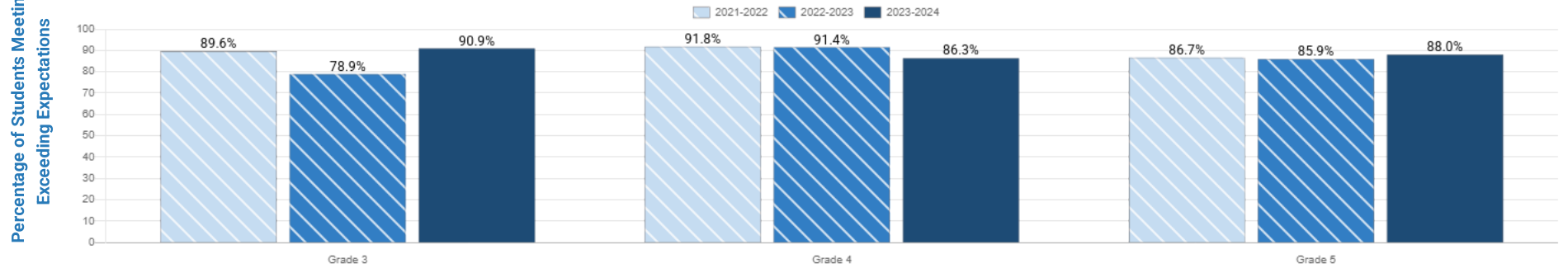

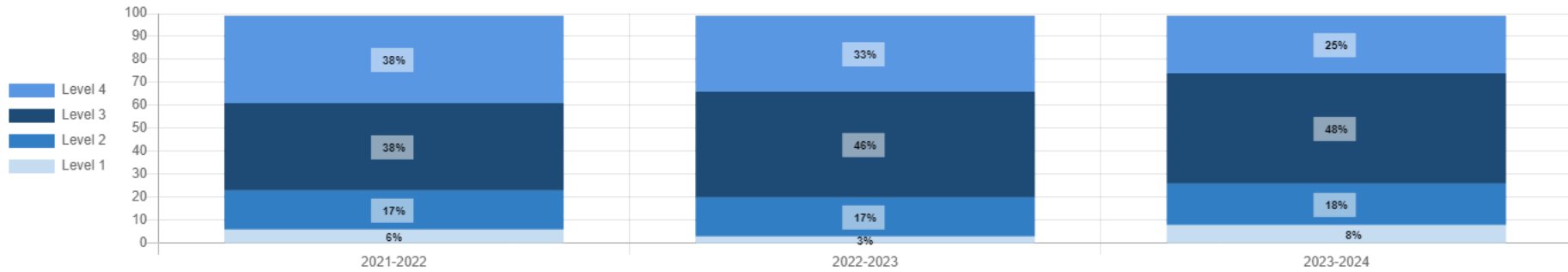

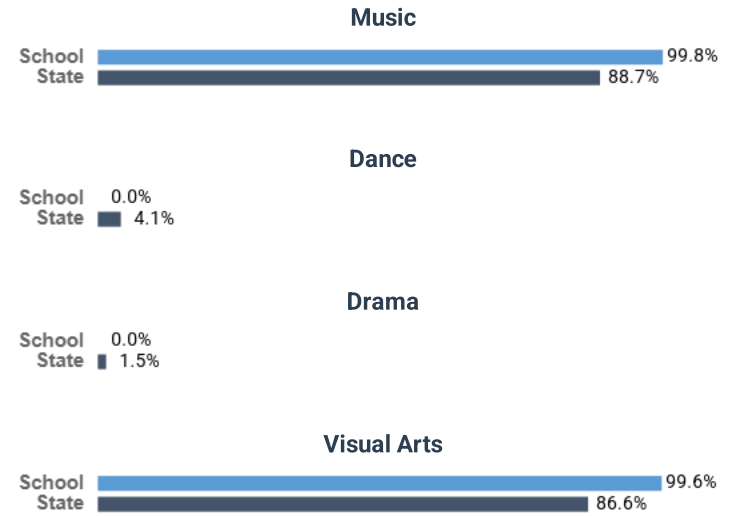

Students enrolled in one or more classes by discipline:



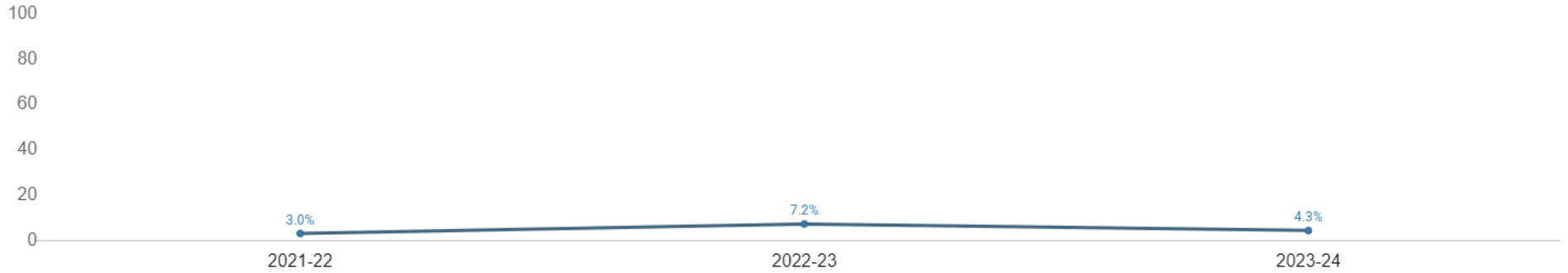

Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

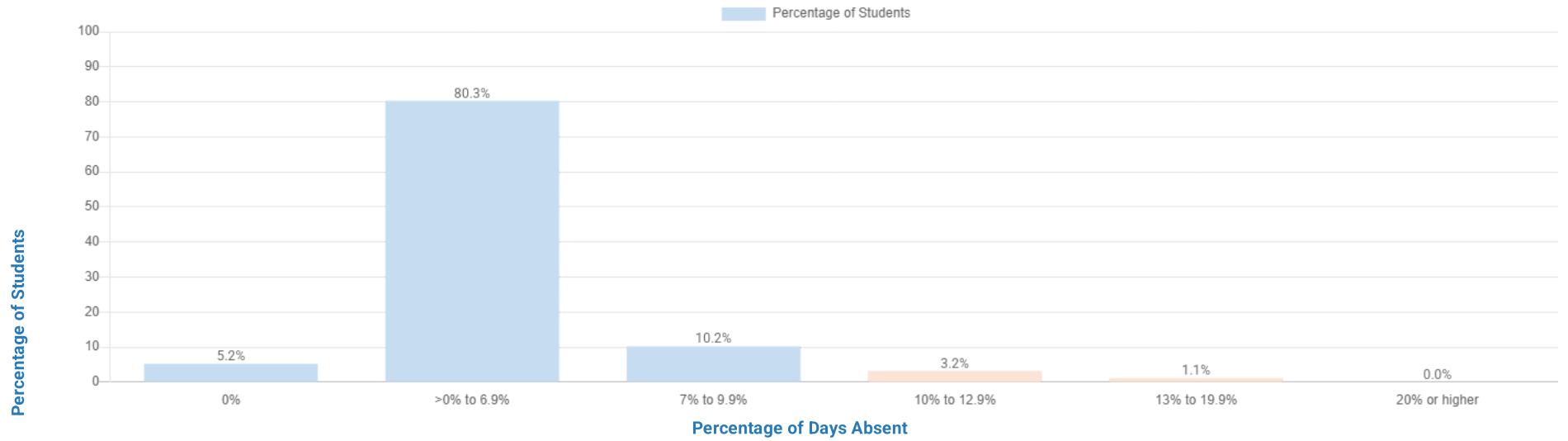

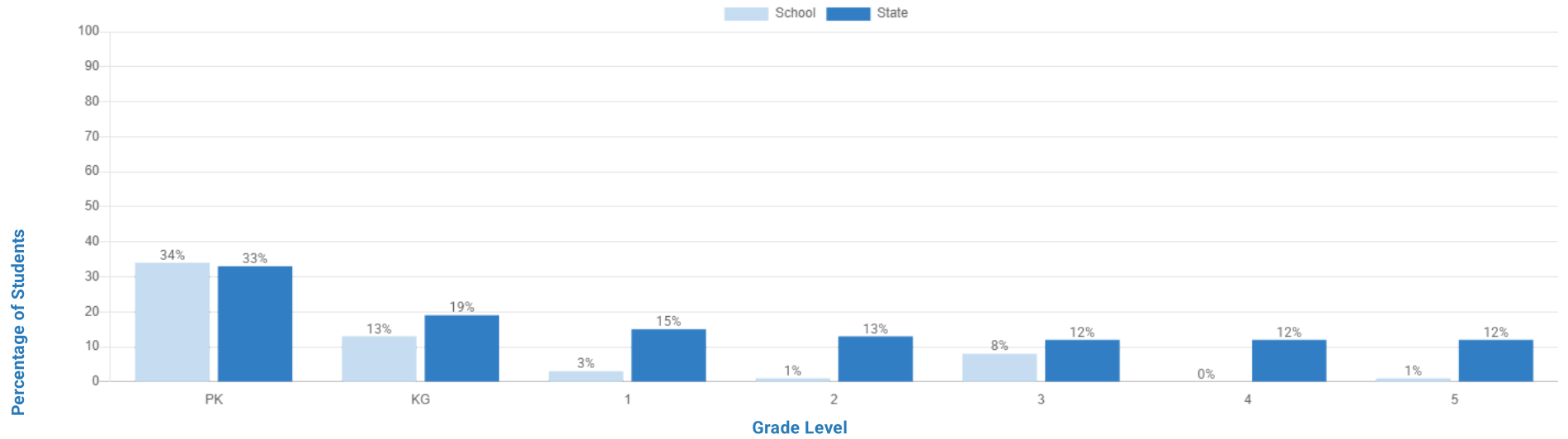

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

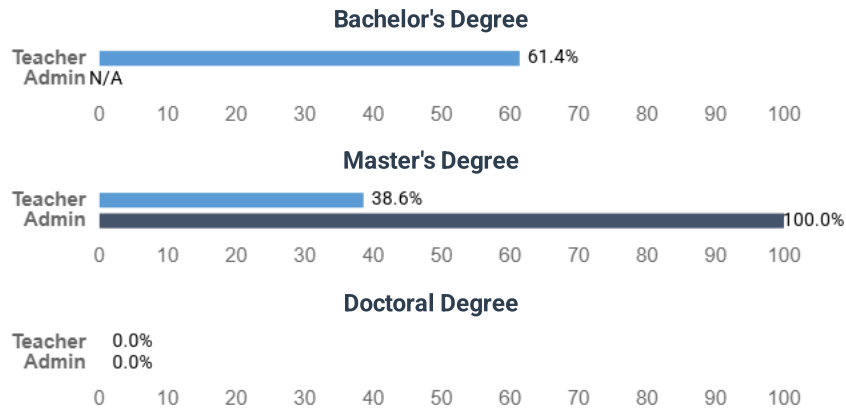

Mount Prospect students participate in physical education twice a week. Students learn about their bodies, the importance of physical activity for their health, and good sportsmanship. MPS offers three seasons of after-school intramural activities for its students.



Clubs and Activities:

Mount Prospect has a student council for its third, fourth, and fifth graders. Music opportunities include band, chorus, and orchestra. Fourth and fifth graders may join our peer mentor program working with special education students. Mount Prospect's Panther PRIDE program focuses on building empathy through social and character skill building. We offer a variety of fall and spring mini unit courses. In conjunction with the Panther Pride, we began a Team Time program where students in all grades were organized into character trait teams that meet monthly to explore these traits and how to apply them in their everyday lives.

Before and After School Programs:

Mount Prospect offers before- and after-school care for its students. This is a subscription service starting at 7:00 a.m. and running until school begins. After-school care begins immediately after school ends and runs until 6:00 p.m. This service is run in-house by teachers, instructional aides, and high school students. Students have snacks, work on homework, play games, and play on the playground under supervision.



Staff and Professional Learning:

Through professional development we provide the necessary resources to integrate diversity, global awareness, and cultural responsiveness in response to our District Equity goal. This professional learning work helps us to examine our curriculum and pedagogical approaches through a social justice and equity lens. Additionally, we continue to engage in refresher content area training across grade-levels. Engaging in developing of high-quality assessments is an ongoing process. As such, we continue to engage in a wide, rich, and systematic conversation about the tenets of high-quality assessments. Faculty members turnkey new strategies and methodologies learned at district in-services.



Student Supports and Services:

Student supports include a school counselor. Mount Prospect has 504 and I&RS committees. Based on need, students access ESL, mathematics and literacy supports, a gifted-and-talented program, and special services including speech, occupational and physical therapies via the child-study team. Grade one students were assessed for dyslexia. Starting in the 17-18 school year, students in need participate in the WIN (What I Need) program, practicing early literacy phonemic awareness and phonics skills.

Student Health and Wellness:

The school counselor works with students, groups, and whole classes for impromptu counseling, and planned lessons on a variety of age appropriate topics. Teachers hold morning meetings to build empathy in students, reduce stress, build resilience, and treat one another respectfully. Monthly whole-school assemblies explore character traits. Students bring daily snacks and can purchase and/or bring a lunch. Families can apply for free/ reduced lunch.



Parent and Community Involvement:

We possess a strong partnership between the school and home. Parents volunteer in the school. The PTO is a highly active organization, which sponsors student programs and assemblies such as International Day, visiting authors and writers in residence. They sponsor community events such as book fairs, family fun days, Field Day, and parent socials. Parents are involved in fundraising activities. The PTO is dedicated to the success of the students and also have representatives on the Parent Advisory Council.

Facilities:

Mount Prospect opened in 1999 and most recently celebrated our 25th anniversary. An addition was built in 2004 to house preschool and K-5 classrooms. All teaching areas contain interactive LCD projectors. There is air conditioning in regular and small-group classrooms, offices, and the library.



School Safety:

Mount Prospect School maintains a school crisis management team that is part of a larger district team. The crisis management team meets monthly and consists of administrators, teachers, and parents. The crisis management team reviews all safety measures in the building, both for the physical plant and procedurally. The school safety team reviews harassment, intimidation, and bullying reports; identifies potential hot spots for bullying; and makes recommendations to administrators for changes to the system.



Technology and STEM:

At MP we are a fully integrated technology district. Through the use of Chromebooks, desktop computers, interactive whiteboards and other devices, students are exposed to a variety of technological skills throughout the curriculum. Our computer and media specialists work with teachers and students to incorporate lessons on digital citizenship, basic operations and mechanics of technology such as operating equipment, keyboarding, hardware and software skills. STEAM activities are integrated in content area lessons. MP hosts an annual STEAM Day in which parents present STEAM activities to students who are able to rotate through four activities. In the evening, 4th & 5th grade students present STEM projects to the community at our annual STEM fair. MPS offers enrichment for all through our Quest and Accelerated Math programs.

Other Information:

Mount Prospect Elementary School is a Kindergarten through fifth grade school currently serving about 500 students. There are 125 faculty and staff members. A typical school day consists of instruction in English language arts, mathematics, and content, (social studies, science, health, Spanish). Spanish is taught in grades 4 and 5. Students have one special-area classes each day: physical education, music, art, computers, and library. Students have lunch, recess, and snack daily. MPS students in grades K-5 have access to Chromebooks. Mount Prospect has a thirty-minute zero period built into its schedule for teachers to hold morning meetings with their classes. During the 19-20 school year, there were three Kindergarten classes and four 1st through 4th grade classes. Fifth grade had five classes. There are six self-contained special education classes and four pre-school classes. Parent communication occurs through email and phone calls, as well as electronic Friday Folder newsletters and monthly teacher newsletters. In addition, teachers utilize websites and a parent portal for report cards and attendance. The school maintains a building website linked to the district and the PTO maintains its own site. MPS conducts monthly school-wide assemblies as an opportunity to bring the entire school population together to focus on character traits, celebrate students' accomplishments, recognize student and staff members' birthdays, and to highlight important awarenesses. Mount Prospect students, primarily the SEL Student Group have taken more and more ownership in conducting these assemblies.
