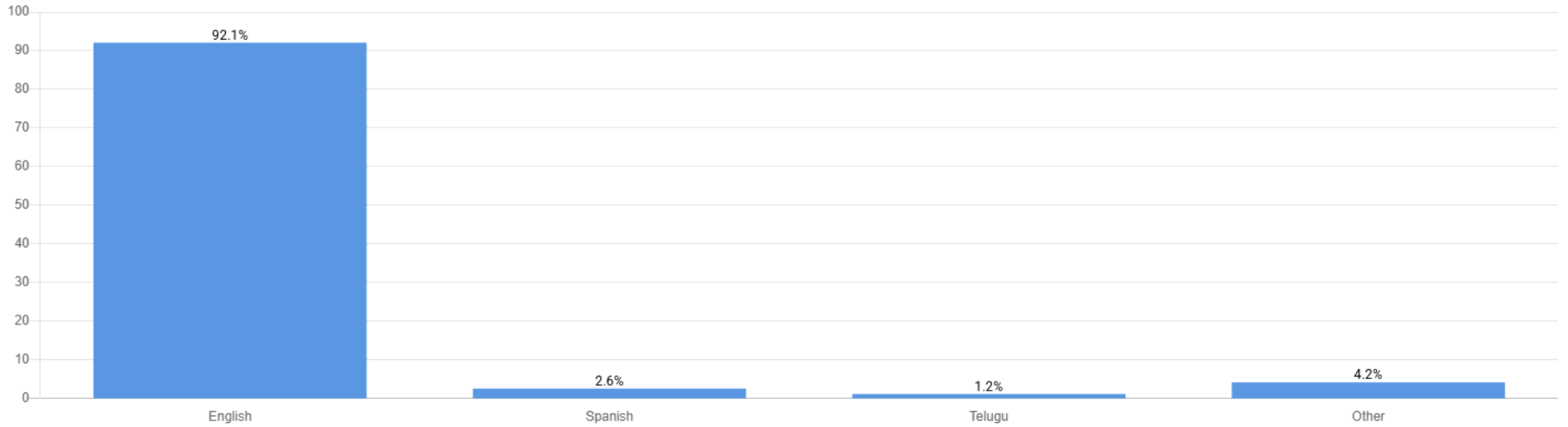

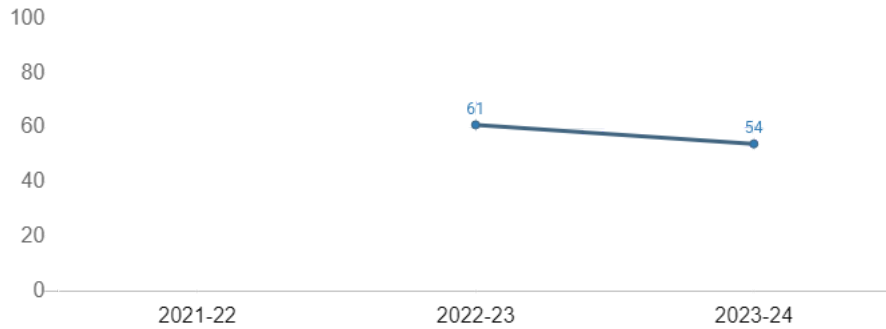

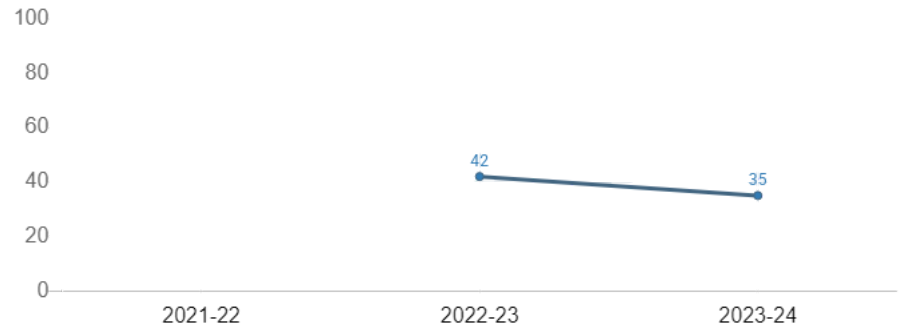

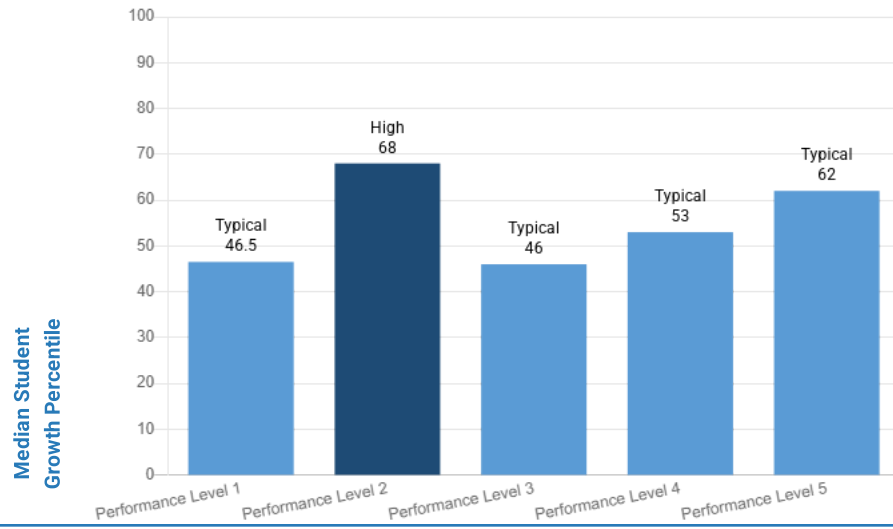

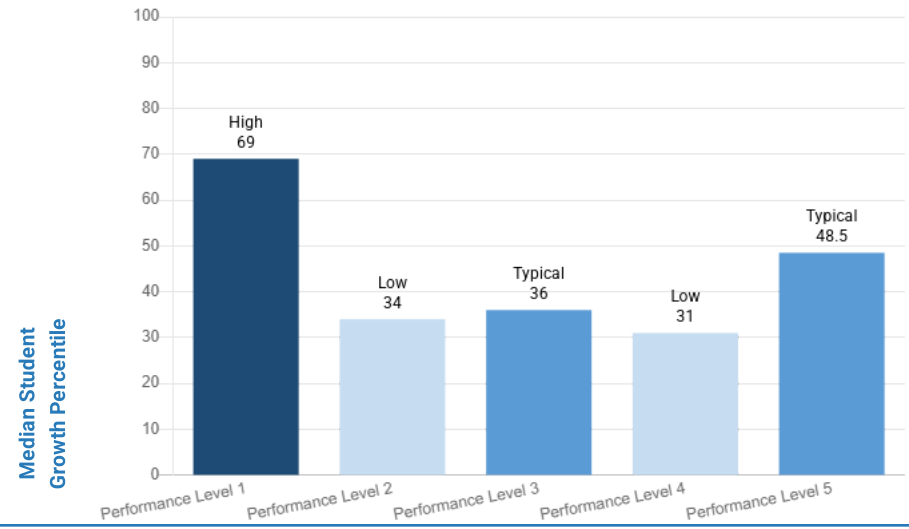

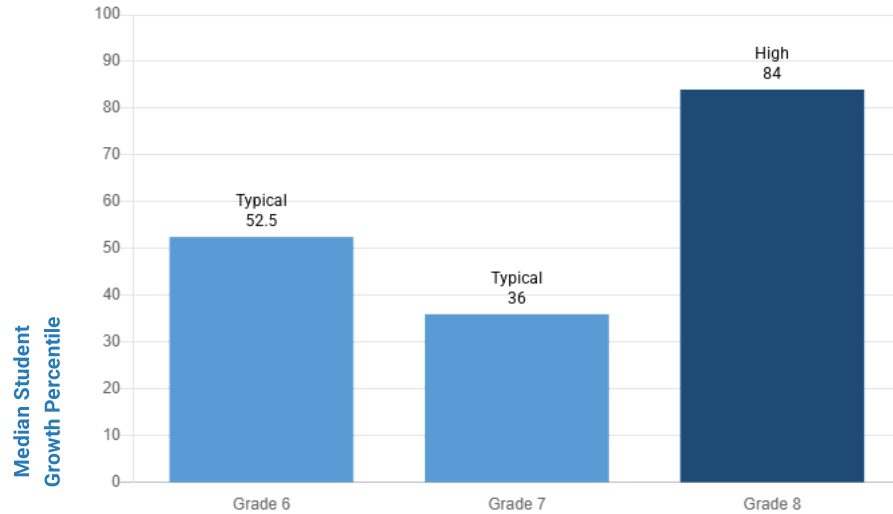

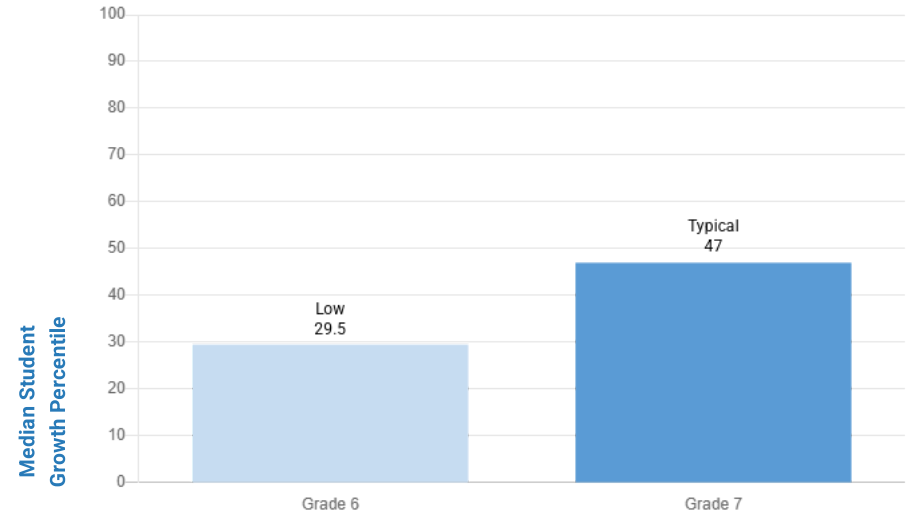

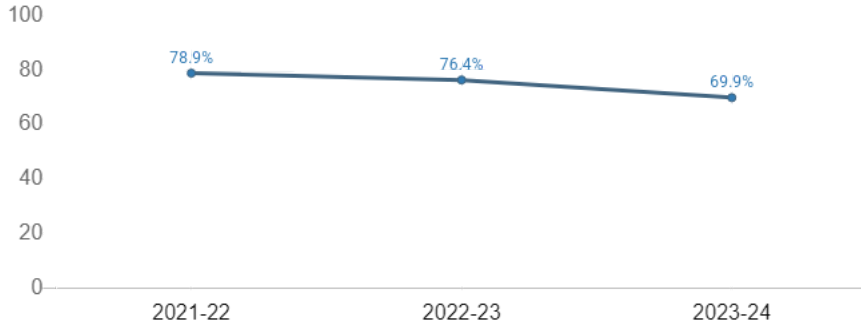

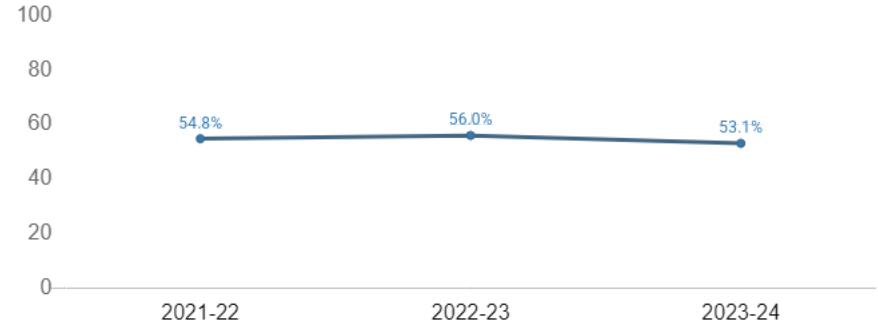
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 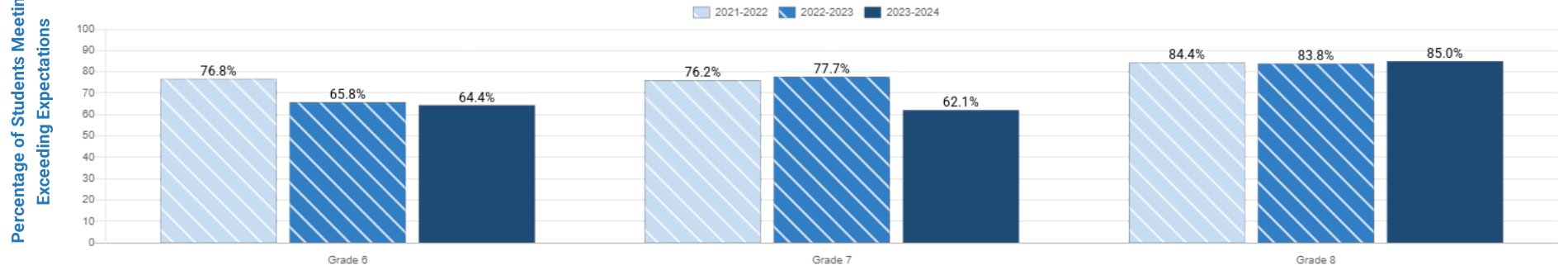

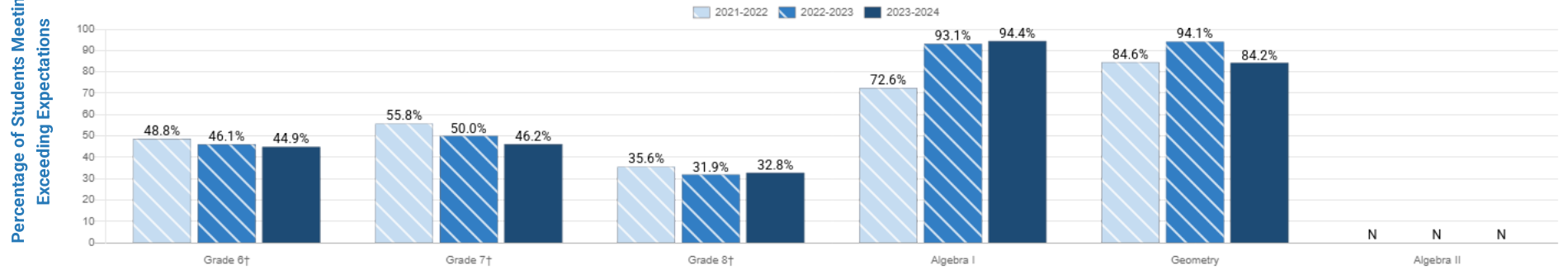

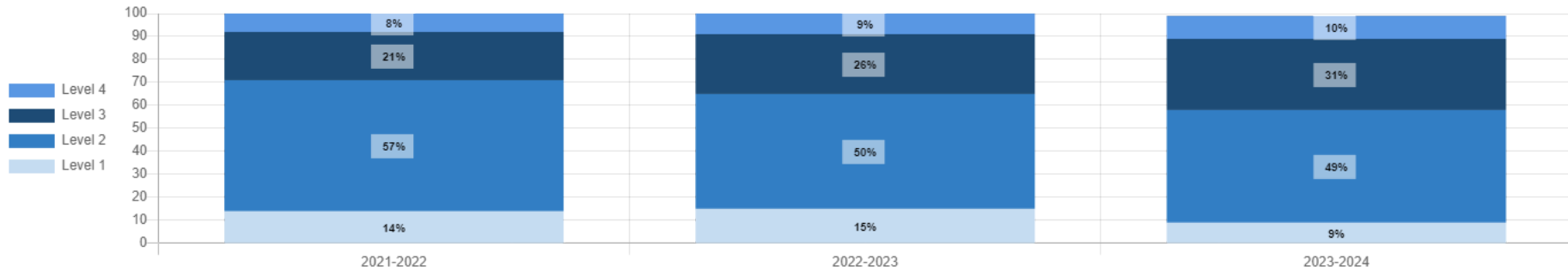

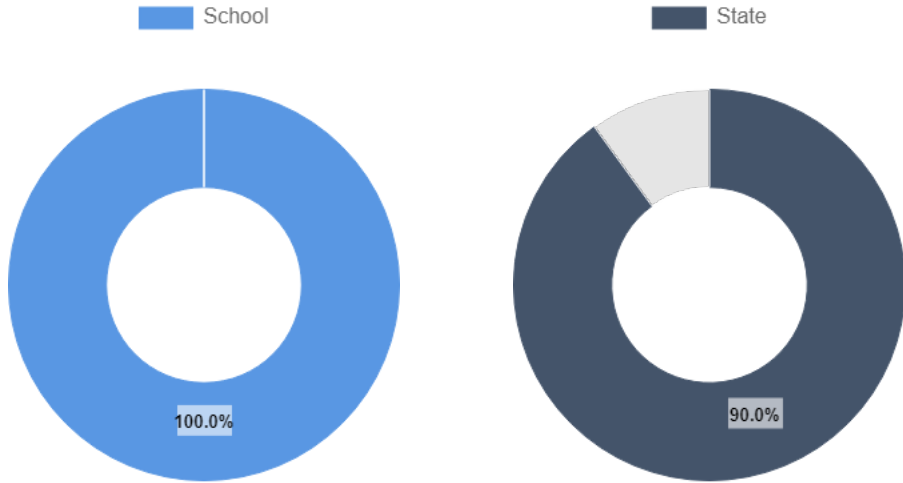

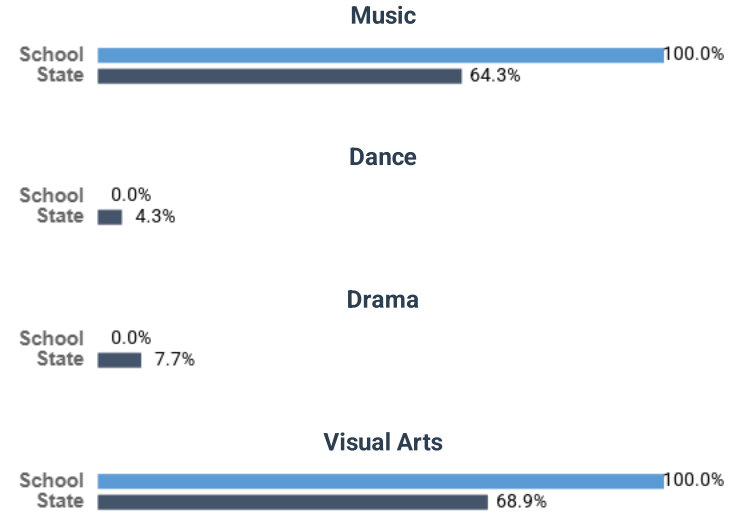

Students enrolled in one or more classes by discipline:



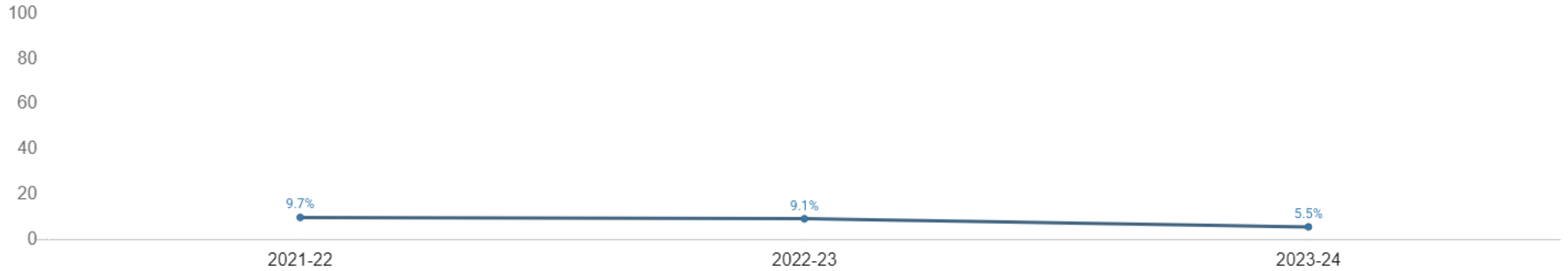

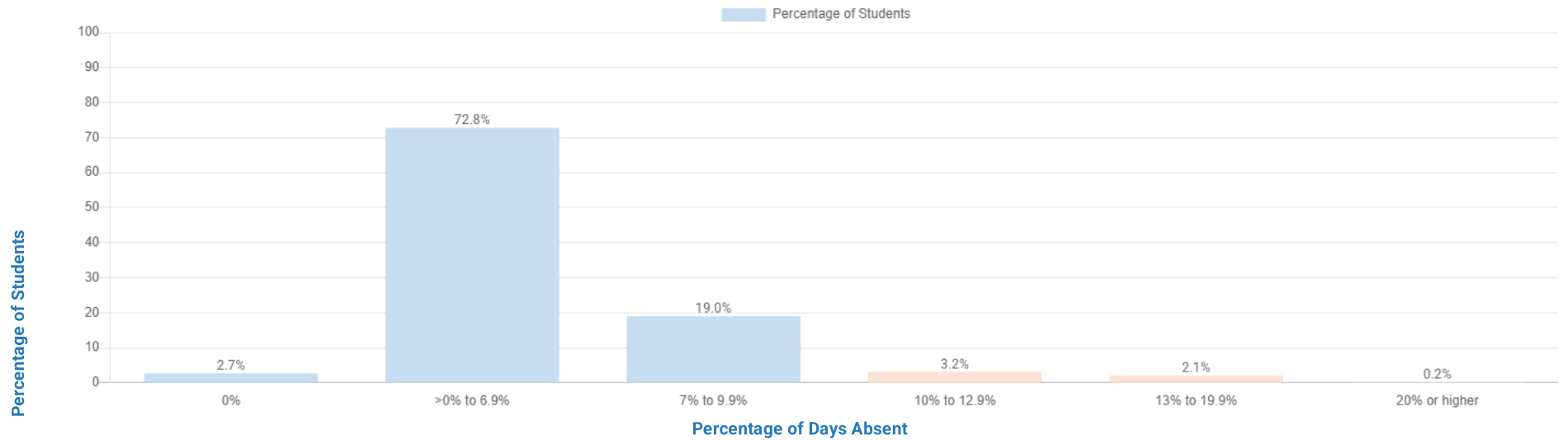

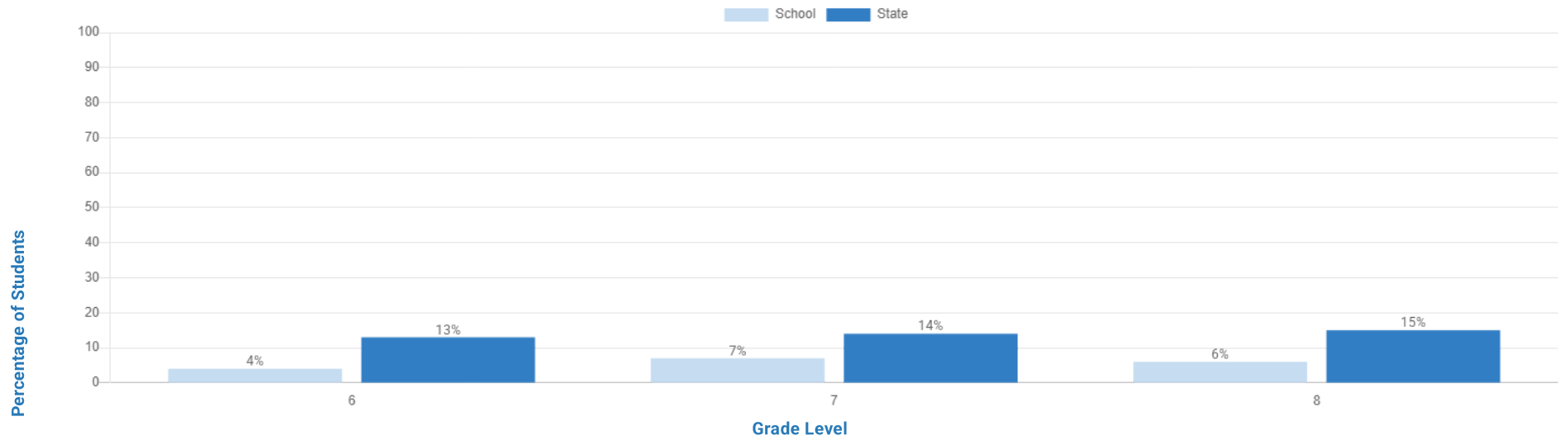

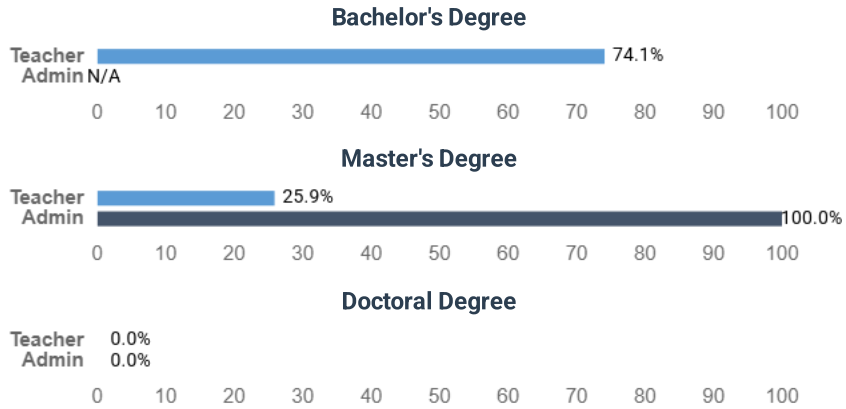

Accountability

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Courses, Curriculum, Instruction:

BCMS courses align with the New Jersey Student Learning State standards. Math classes range from Math 6 (6th grade) to Geometry (8th grade). Students are challenged in all content areas through the use of one-to-one technology, differentiated instruction, and student choice. The school's Gifted and Talented (GATE) program provides classes for identified students and also offers enrichment opportunities to all students.



Sports and Athletics:

The goal is for all of our students to be involved with school outside of the classroom. Sports allow an excellent way to be involved with the school community. In the fall, students can participate in soccer and cross country, which provide great opportunities for building endurance and team spirit. During the winter season, students may participate in wrestling, cheerleading, dance, and basketball, catering to a variety of interests and promoting physical fitness as well as teamwork. When spring arrives, students can engage in baseball, softball, and lacrosse, each fostering skills in strategy, coordination, and collaboration. Many of our athletes excel on the field and in the classroom.



Clubs and Activities:

There are a myriad of choices for students who are interested in extracurricular activities. The school offers Art Club, Ceramic Arts & Techniques, Chamber Orchestra, Drama Club, Vocal and Instrumental Ensembles, Chess Strategies and Tactics Club, Math Counts and Strategic Games. Yearbook and newspaper clubs provide the school with important publications. Leadership opportunities can be found in Student Council and Peer Leadership. Students can explore their interests in Robotics, Science Club, Odyssey of the Mind, Math Counts and the Science Fair Competition.

Before and After School Programs:

Guided Study program which provides our students with time and space to complete school work in a structured environment with certified staff that collaborate with classroom teachers to ensure students have the materials and assignments they need to be successful.



Staff and Professional Learning:

Staff members are encouraged to seek out opportunities for professional learning both within and outside of the District. Teacher Academy courses are sessions that focus on areas of interest for staff that are run by their colleagues, Single session afternoon PD days are utilized as opportunities for staff to connect and learn together. Consultants are also brought in to work with groups of staff members depending on the area(s) of focus in a given year.



Student Supports and Services:

Highly qualified special education staff in each grade level collaborate with parents, teachers, and students to set instructional goals. The school's Child Study Team helps facilitate a strong special education program. The district has two ELL teachers that work in the three schools. All teachers at BCMS follow our school's pyramid of support, which outlines specific interventions to support all learners.

Student Health and Wellness:

The school has a full time nurse that is available to support staff and students. The nurse also arranges for certification in CPR, First Aid and Epi-pen administration. The school has two A.E.D. stations in the building and several portable ones to be used by our athletic teams. BCMS has a comprehensive Health and Physical Education program. Students have one academic quarter of Health, dispersed throughout the school year, and three academic quarters of Physical Education each year.



Parent and Community Involvement:

The school enjoys a very supportive community. The PTO supports the school through mini-grants, book fairs, food drives and other student events. The Branchburg Education Foundation funds grants for special purchases for the school. They have funded trips, new technology, educational materials and assembly programs. Parents have instant information about their child's progress through a parent portal and other electronic communications.



Facilities:

Branchburg Central Middle School was built in 1963 and as student population increased, in 2003 an addition and renovation was done to the building. Our building is positioned across the street from a park that offers the school additional field space. The school has air conditioning which allows for instruction to be uninterrupted during the hot fall and spring days. Additionally, the school is equipped with technology to support student learning.

Other Information:

The 6th-grade program emphasizes CHANGE, with projects that develop self-awareness, foster creativity, and build skills in areas like 3D modeling, video production, and problem-solving. Students explore topics such as currency redesign and the evolution of everyday objects, culminating in events like the Invention Convention and Film Festival to showcase their innovative work. The 7th-grade program focuses on INDIVIDUALITY, helping students explore their interests through projects like TED-ED talks, cursive writing analysis, and historical research. Highlights include creating an "Escape from History" narrative, identifying 7 Wonders of NJ, and producing photography exhibits. These activities enhance critical thinking and creativity, with final projects displayed in collaborative formats like a class website and photo gallery. The 8th-grade program centers on LEADERSHIP and POWER, with activities that develop debate, teamwork, and leadership skills. Students participate in GATE PATHs, which offer flexible opportunities to dive into interests and create authentic projects. These programs foster collaboration, critical thinking, and real-world problem-solving, preparing students for meaningful contributions.
