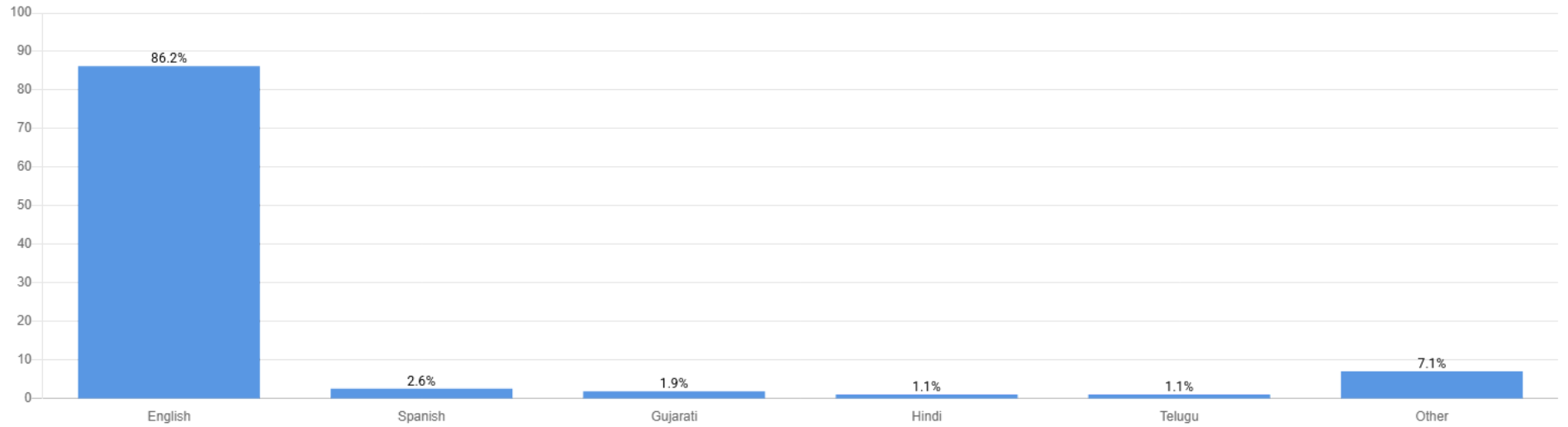

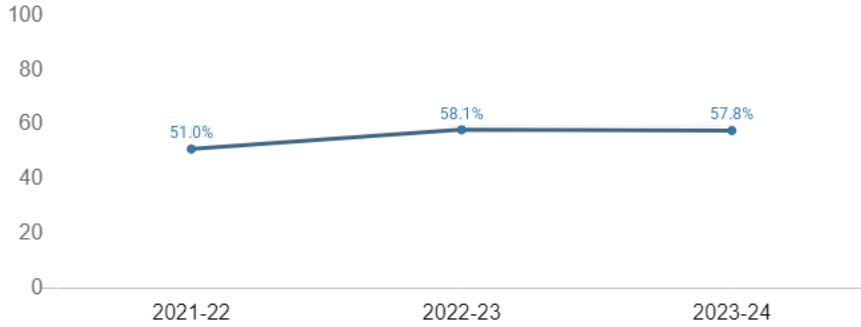

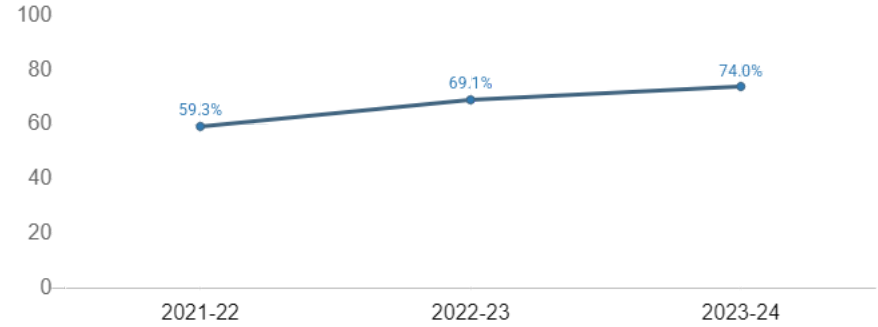
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 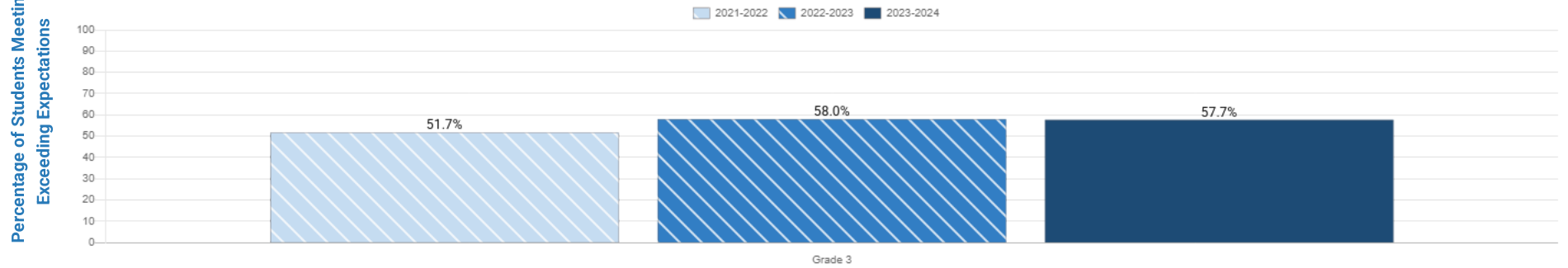

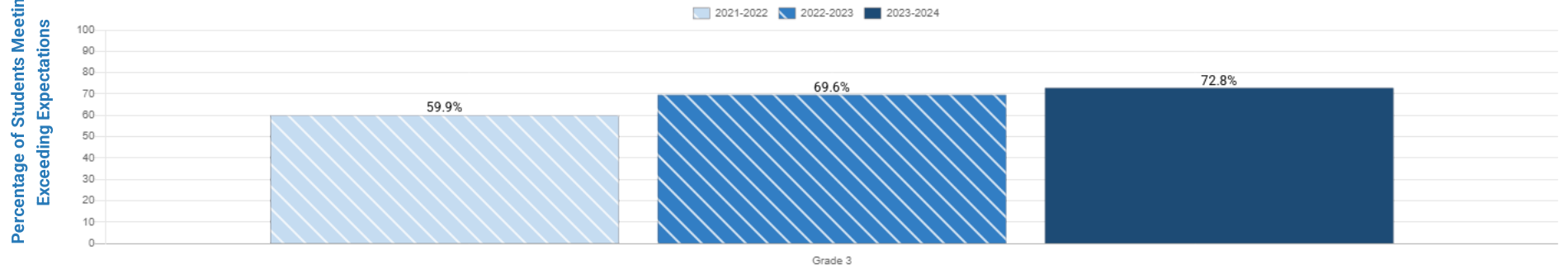

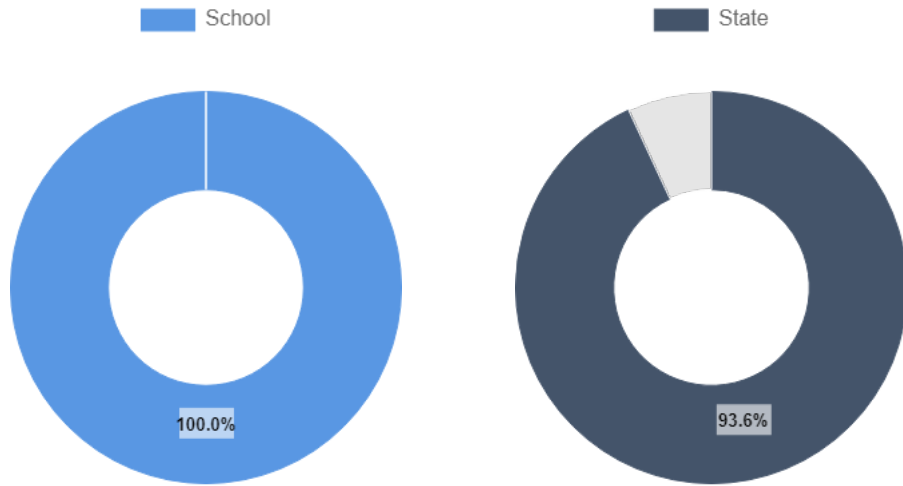

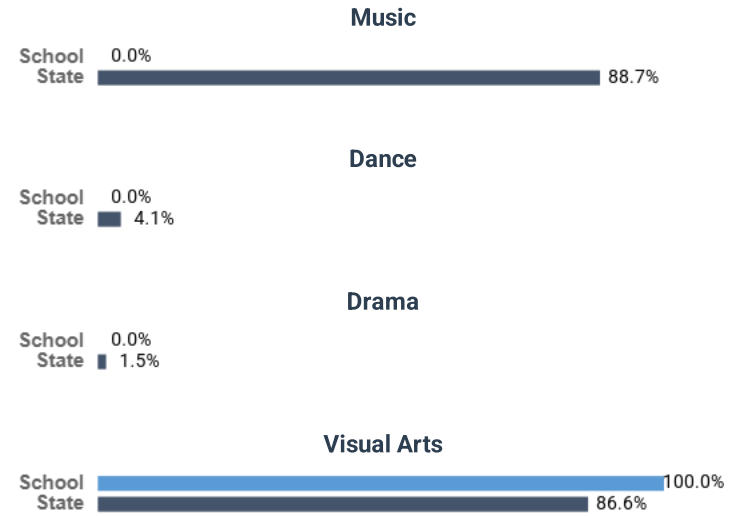

Students enrolled in one or more classes by discipline:



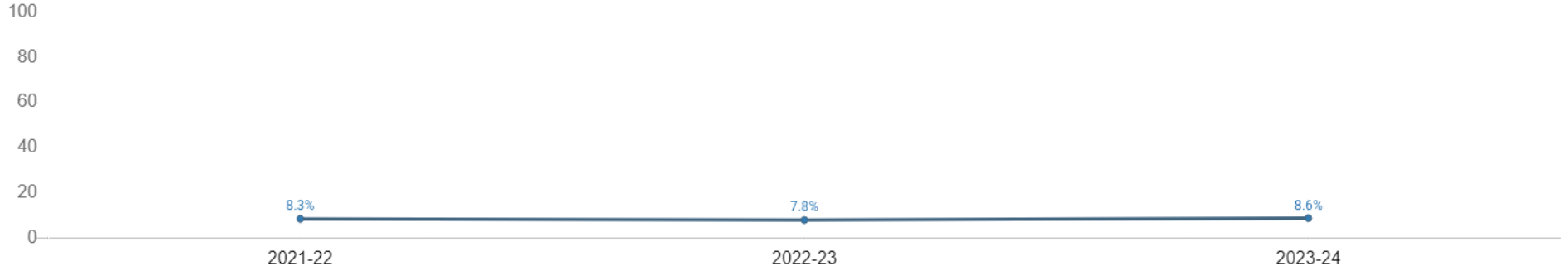
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 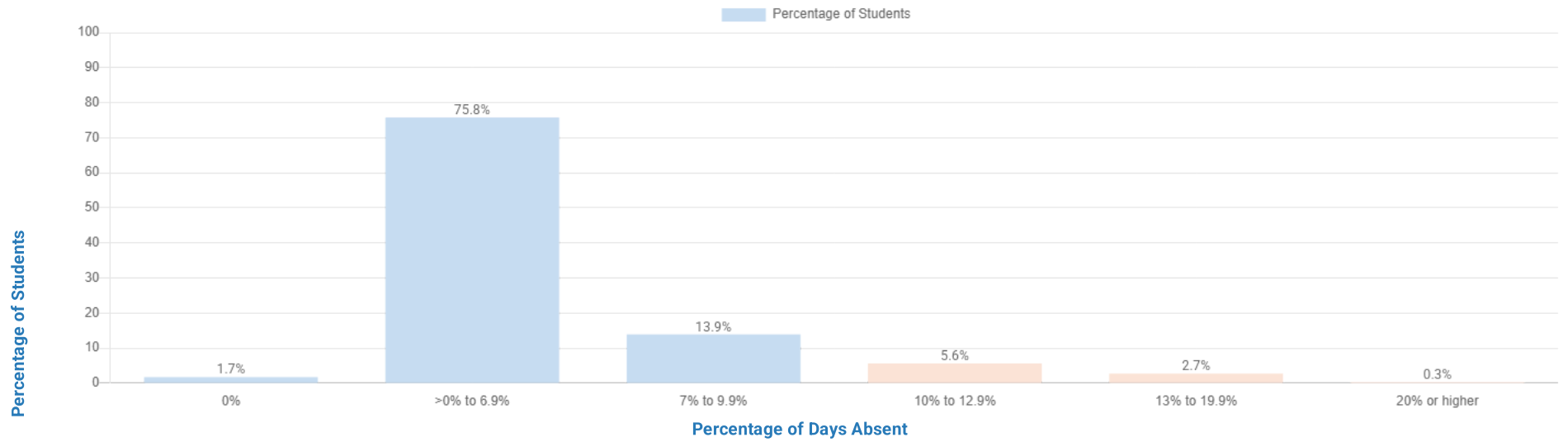

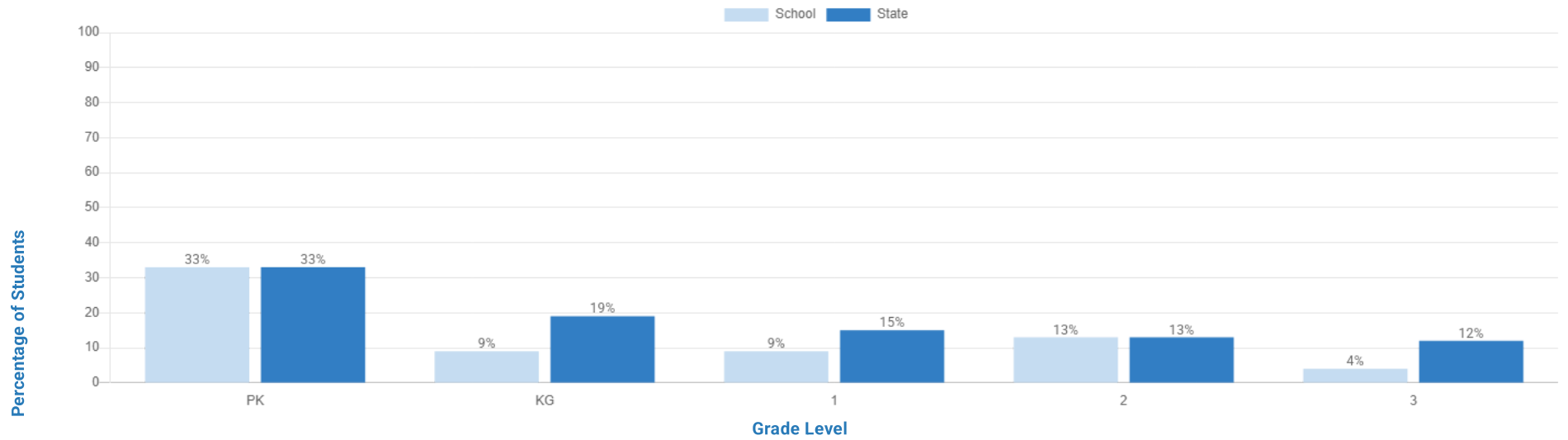

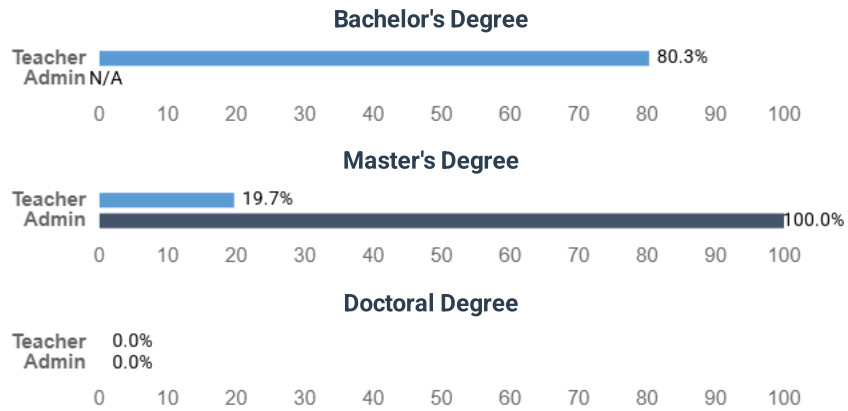

- We integrate technology into our curriculum to enhance learning and engage students in meaningful ways. Each K-3 student is provided with their own Chromebook to support their educational journey.
- Responsive Classroom is used to nurture students' emotional and social development. School Guidance Counselors collaborate with teachers to integrate well-being strategies into the classroom.

The mission of the Branchburg Township Schools District and community is to inspire our children to learn, think, grow and excel in life.

Courses, Curriculum, Instruction:

Students participate in the reading, writing, and math workshop models. This allows teachers to work with small groups of students. A Gifted and Talented program is available to students who qualify in grades 1-3, an extension program for kindergarten students, and a math enrichment program for students as well. Instructional support programs are available to students who are below benchmark in K-3rd grade. All grades have problem-based learning experiences to allow students to make connections to the real-world. Responsive Classroom practices are used to focus on students' social and emotional well-being.



Clubs and Activities:

Our school offers a variety of before and after school clubs that are facilitated by our dedicated staff members. These clubs change each year, giving students the chance to explore new interests, make connections with their peers, and engage with staff in a fun, relaxed setting. Some of our past club offerings have included: STEM Bridges, Creative Building: Lego Engineering and Games, Soccer Skills and Teamwork, Dance and Movement Club, Active Movement and Play, Percussion and Rhythm Through Bucket Drumming, Creative Arts: Drawing Techniques, and Coding Club. In addition to our school-run clubs, we work closely with community organizations to offer additional opportunities for students, such as Girls on the Run, Girl Scouts, and Boy Scouts. For third-grade students, there are also opportunities to volunteer for leadership roles, including being part of our Environmental Club, Safety Patrol, or Peer Leaders where they can take on responsibilities and contribute to the school community.



Before and After School Programs:

Before and after school care is available through a private carrier and offered to students in kindergarten through third grade.

Staff and Professional Learning:

Once during a 6-day cycle, teachers have opportunities to meet as professional learning communities and grade level teams. Literacy and STEM coaches support professional learning to increase student success. Data-driven differentiated instruction, Purposeful Play, phonics instruction, and Responsive Classroom are integrated into instruction on a daily basis.



Student Supports and Services:

General education students, supported through our instructional support program, and Multi-Language Learners receive a combination of push-in and pull-out services depending on need. Students with disabilities receive small group instruction in conjunction with in-class resource services. Any student experiencing challenges with learning, behavior or health concerns is eligible for an Intervention and Referral Services program. Additionally, some students qualify for before and/or after-school tutoring.



Student Health and Wellness:

The school has a full-time nurse to support student health and wellness, one full-time and one part-time guidance counselor to support student emotional well-being as well as a behaviorist. Students participate in recess daily for 30 minutes and physical education classes for 40 minutes twice during each six day cycle. Students receive lessons in health and wellness during their regular homeroom instruction.

Parent and Community Involvement:

Whiton Elementary School is supported through our PTO which provides ongoing support programs throughout the school year. Together, the school and PTO provide students with the annual book fair, and grade level family events. Parent volunteers support the school. The Branchburg Education Foundation also supports the school with grants that allow for various educational events or special school purchases.



Facilities:

Whiton Elementary School was built in 1997 and as student population increased, an addition was later added. The building is surrounded by wooded areas located in a quiet neighborhood. The school has air conditioning which allows for instruction to be uninterrupted during the hot fall and spring days. Our classrooms, technology lab, and media center allow for wireless devices and flexible and choice seating for students.



School Safety:

Whiton Elementary School is equipped with video cameras and locking doors requiring guests to gain access for entrance into the building. The school works closely with representatives from the Branchburg Township Police Department to support the safety and well-being of students and staff. We provide our students with regular practice of emergency procedures. Our procedures regarding these practices are aligned with the expectations of the county and state.

Technology and STEM:

All students receive technology and STEM experiences in their homeroom classes. Students also receive additional technology classes of at least 40 minutes per six day cycle. The majority of classrooms have Smartboards, document cameras and Chromebooks for student use.



Early Childhood Education:

For youngest learners, we offer a half-day integrated pre-school program, and a comprehensive pre-school disabled program. Entrance for regular education students into our integrated pre-school program is done through a lottery system, typically during November/December for the upcoming school year. Transportation is afforded to all students in these programs.

Whiton Elementary School provides students with a well-rounded educational experience where students are able to regularly participate in art, physical education, music, technology, library, and Spanish. Students in grades K-3 are divided into classes and the majority of their instructional time is delivered by classroom teachers. For students in third grade, classes switch for science and social studies instruction. All of our classrooms are provided with technology which includes Smartboards, document cameras, and student devices. Staff ensures that all parents have access to happenings in the classroom via email and other electronic forms of communication. Families are also regularly invited into classrooms to support students in centers, join in reading or writing celebrations, and to celebrate students' birthdays.
