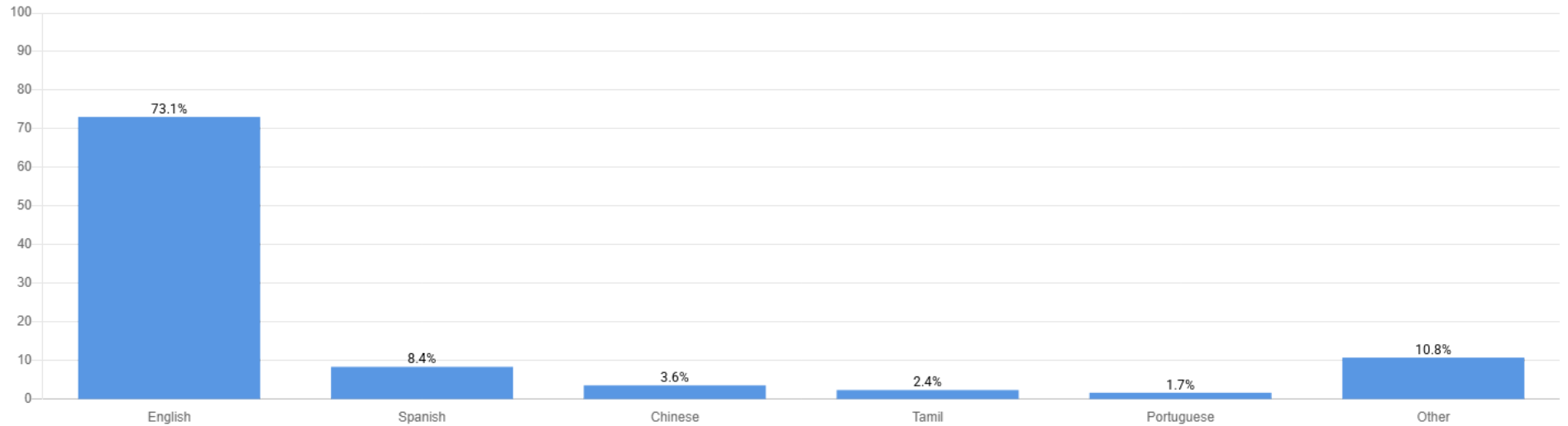

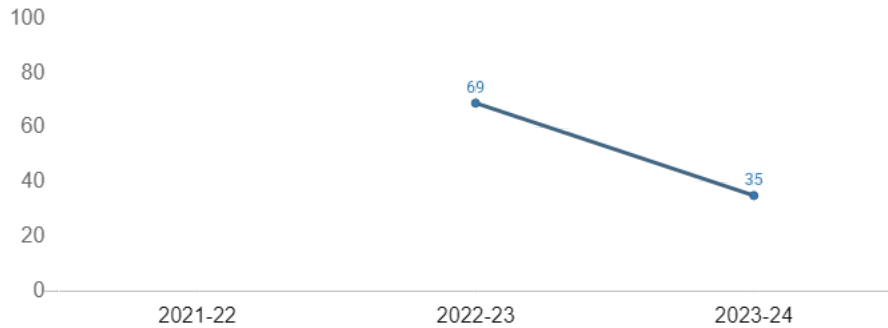

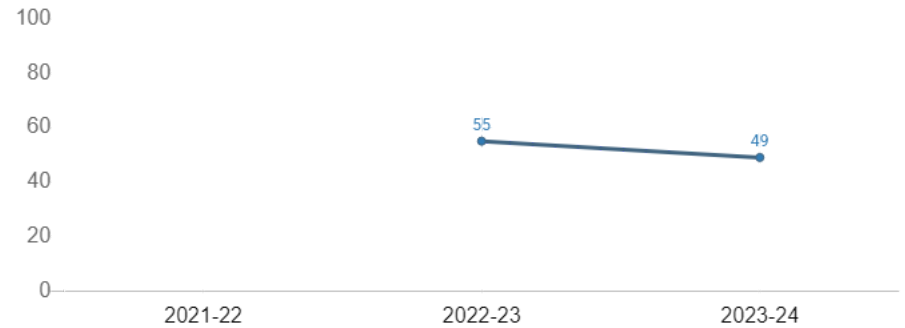

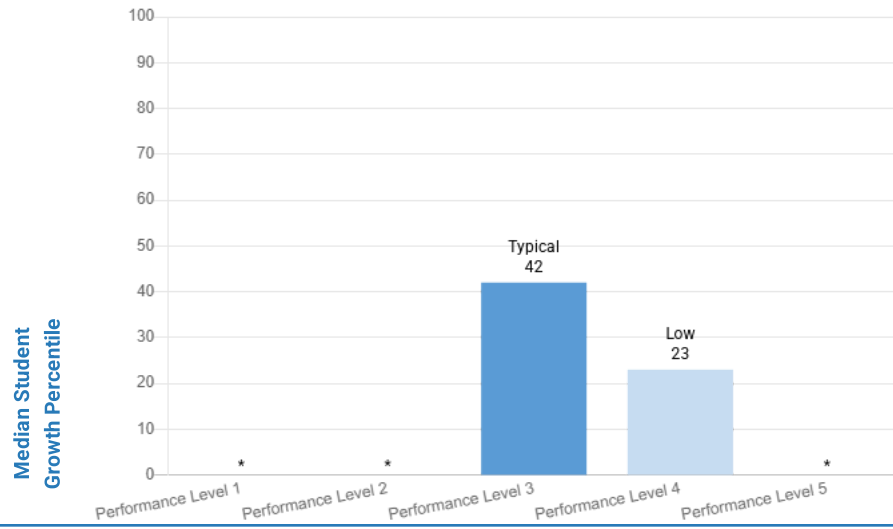

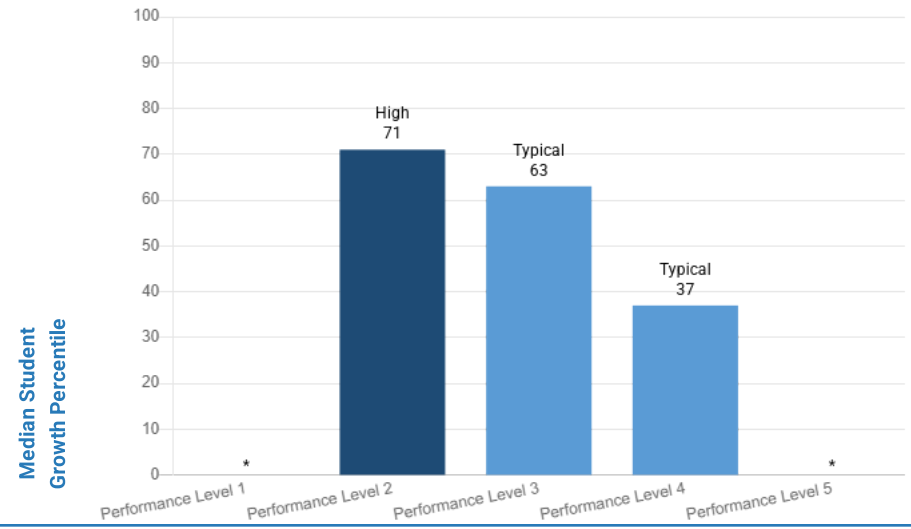

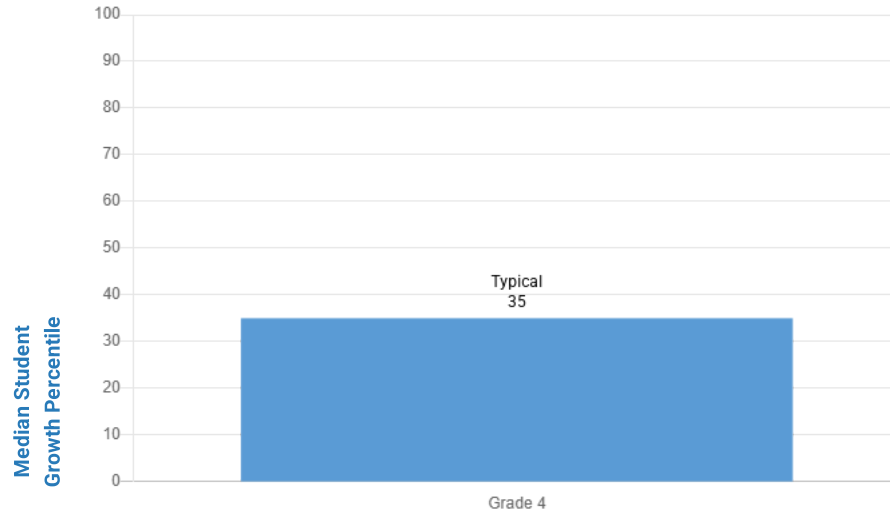

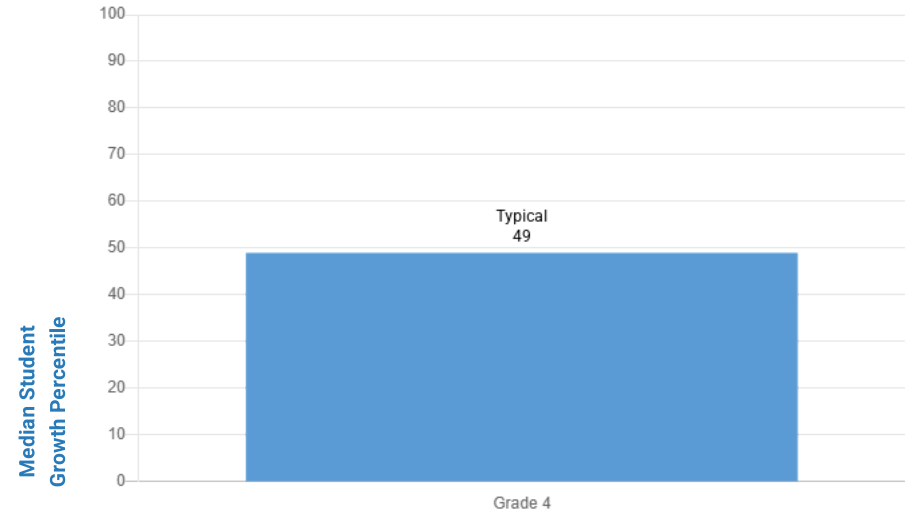

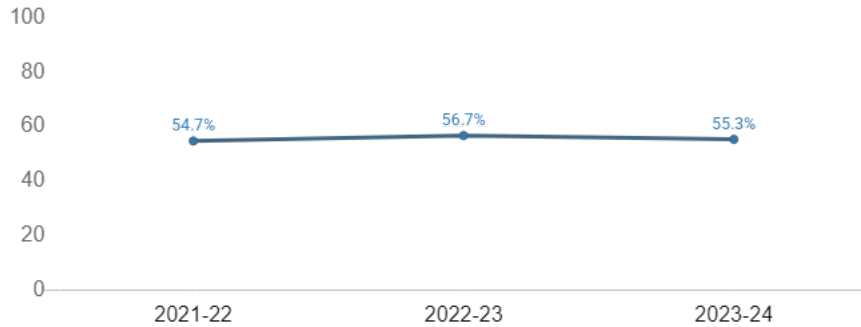

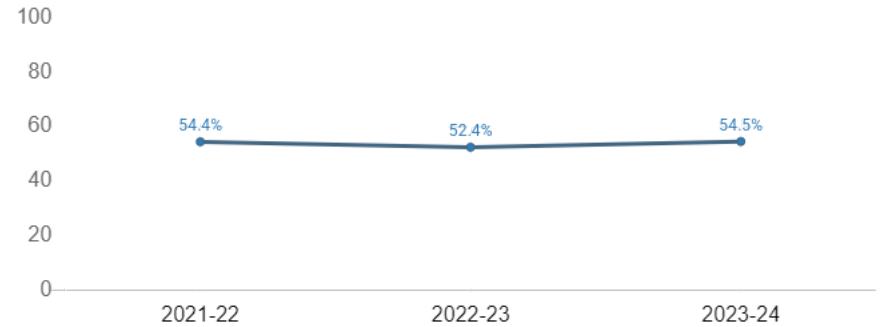
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 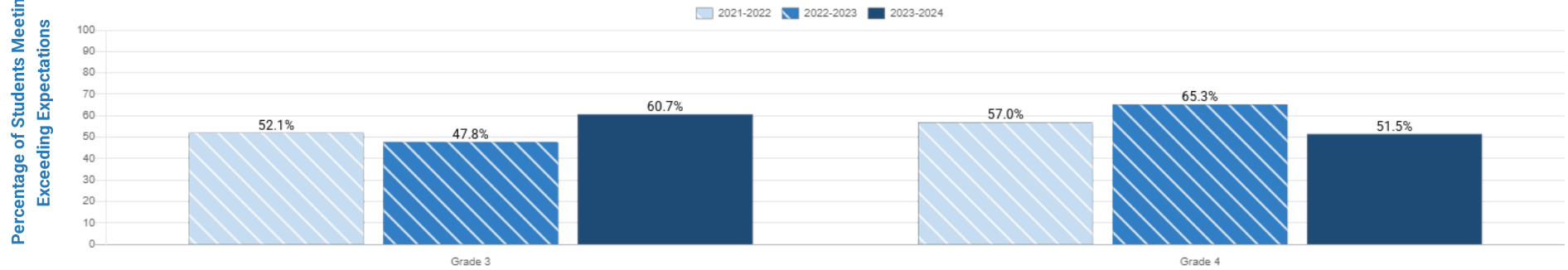

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 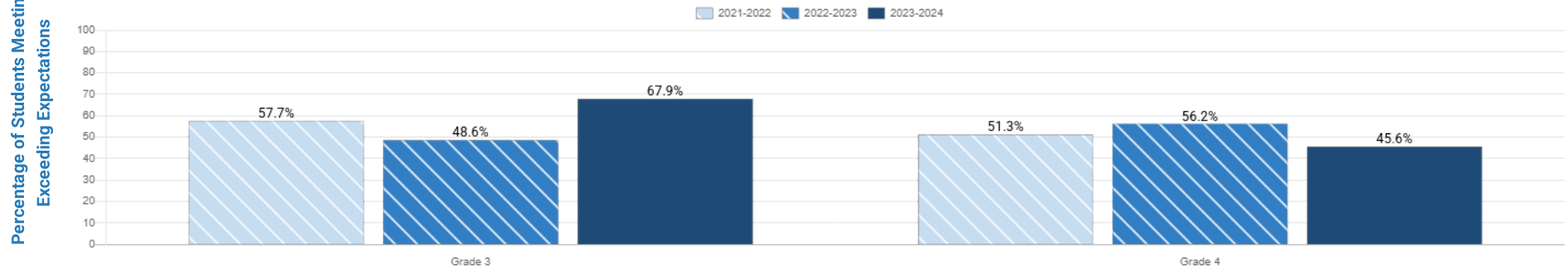

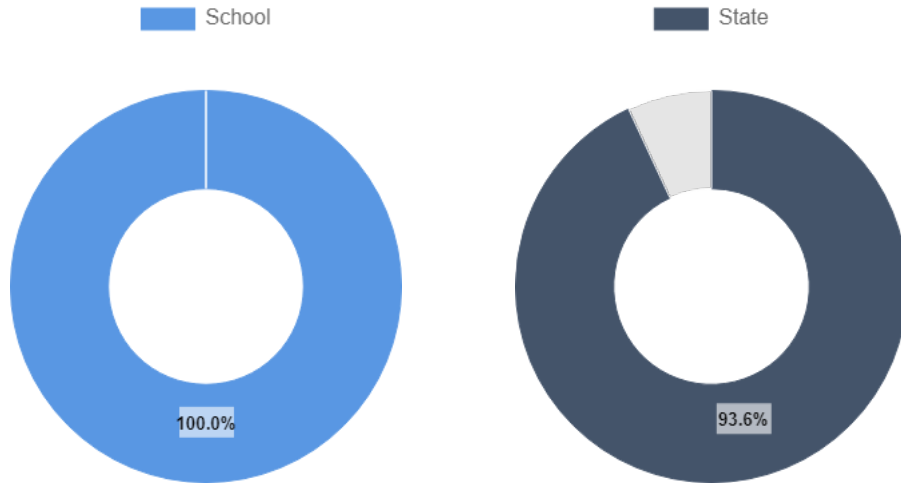

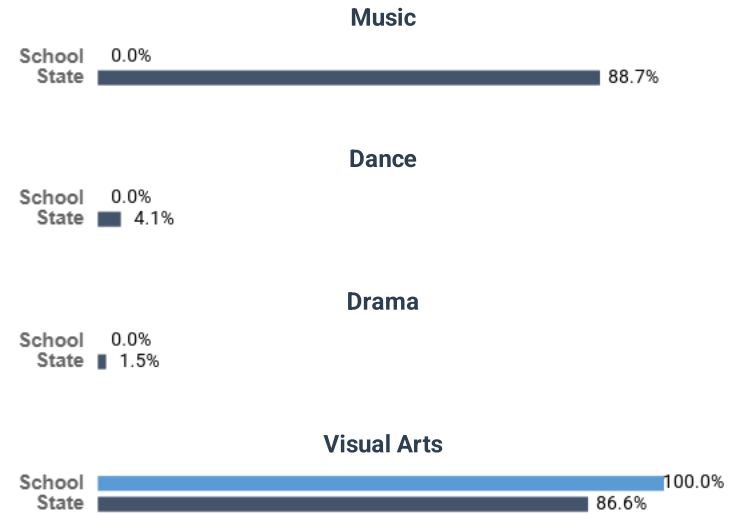

Students enrolled in one or more classes by discipline:



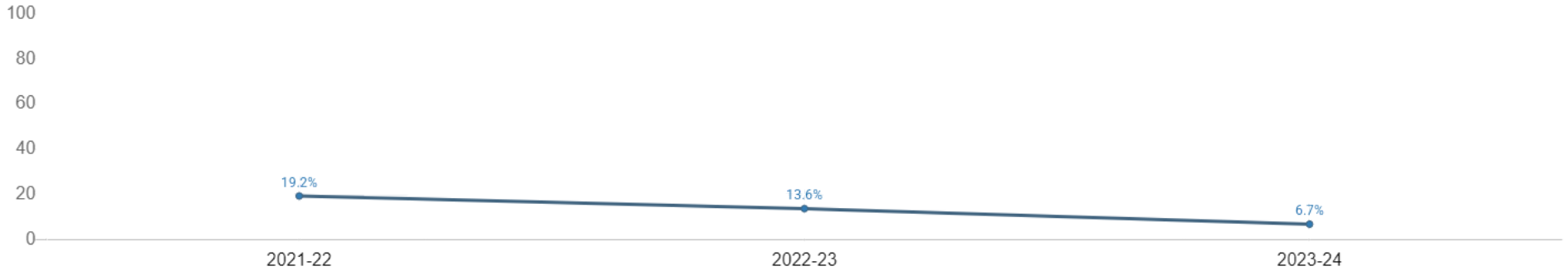

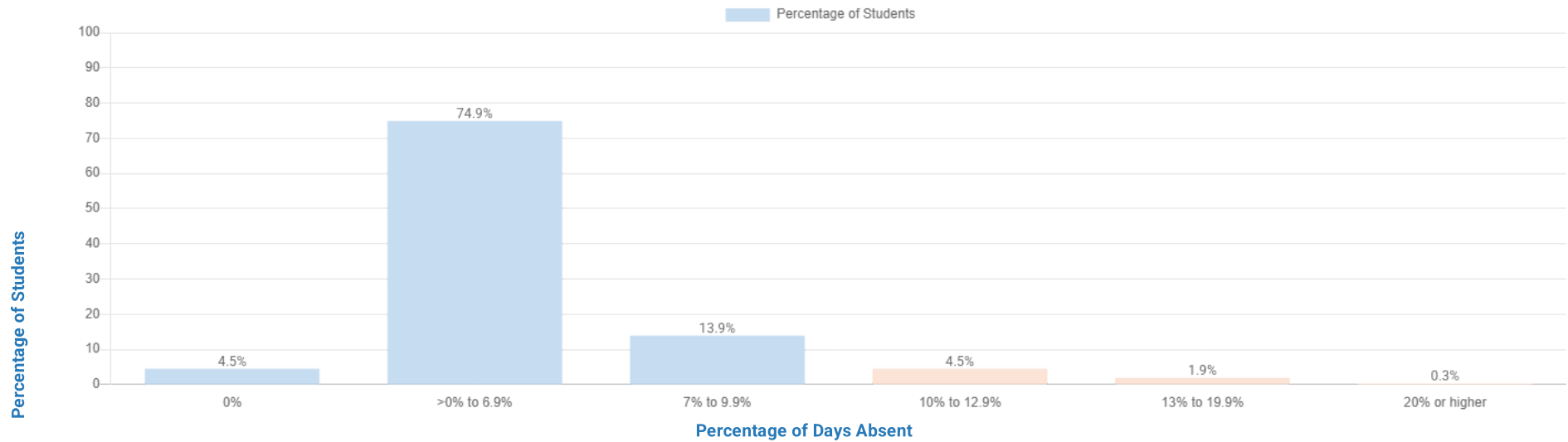

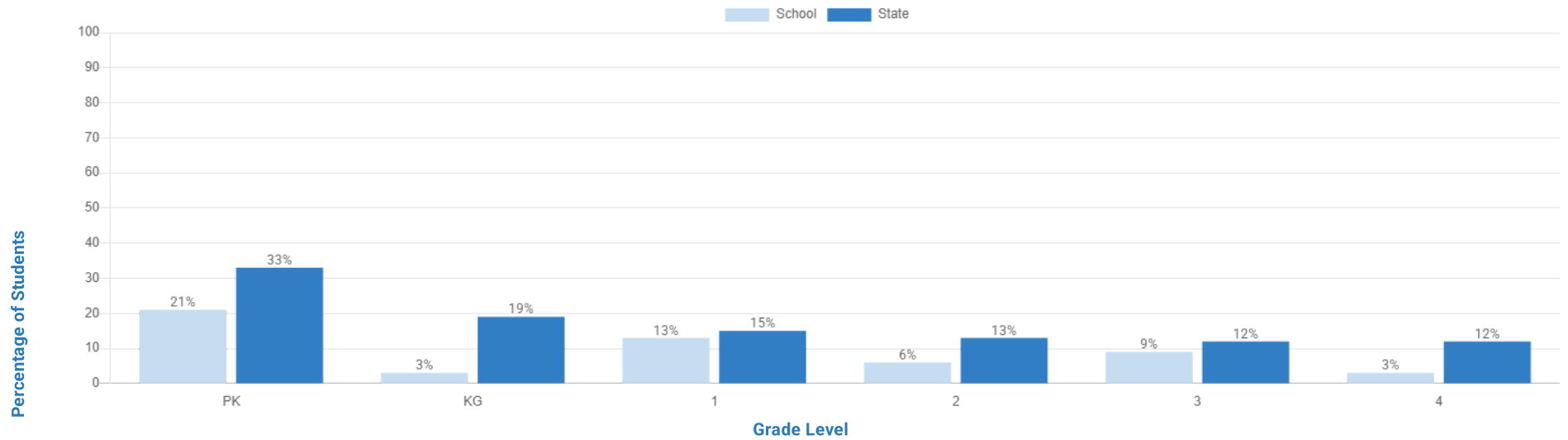

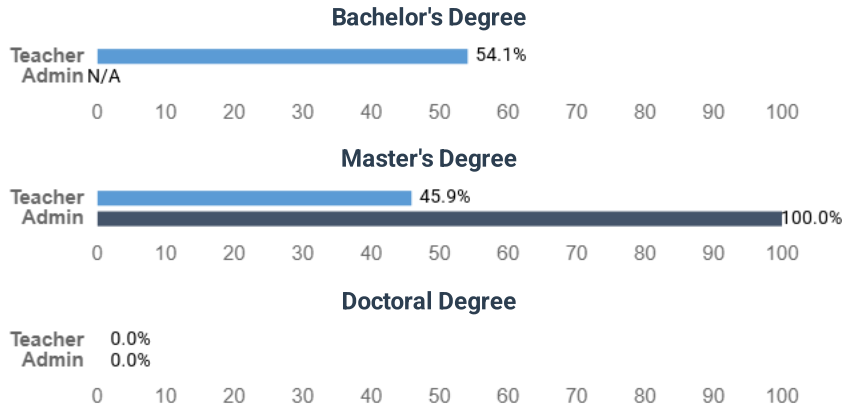

Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

The NJDOE identified schools for ATSI status based on data from the 2022-2023 school year, so schools will not be identified for ATSI status based on data from the 2023-2024 school year. Student Supports and Services:

Green Brook Township Public Schools offers a comprehensive range of student services. This includes a dedicated special education and related services department that fosters inclusion, growth, and independence. Multilingual services are provided to support English Language Learners in their development. The district's basic skills and intervention program targets, supports, and remediates struggling learners. Additionally, the district has adopted a district-wide approach to gifted & talented education, offering pull-out programs for enrichment and special academic track programs for students who excel in English Language Arts and Math.



Parent and Community Involvement:

The school also benefits from the active support of the community. The Green Brook PTO meets monthly to plan and organize events like assemblies and classroom parties, as well as determine how to provide supplies and learning opportunities. Additionally, the Green Brook Education and Athletic Foundation offers grants to the school and operates a Before and After Care program and a summer day camp.



Early Childhood Education:

Irene E. Feldkirchner School has two classrooms devoted to its full-time Integrated Pre-School Program (IPSP). General-education students attend IPSP classes on a tuition basis, and enrollment draws from Green Brook and neighboring communities. IPSP students get an advance start in preparing for the learning that will take place in the traditional grades.
