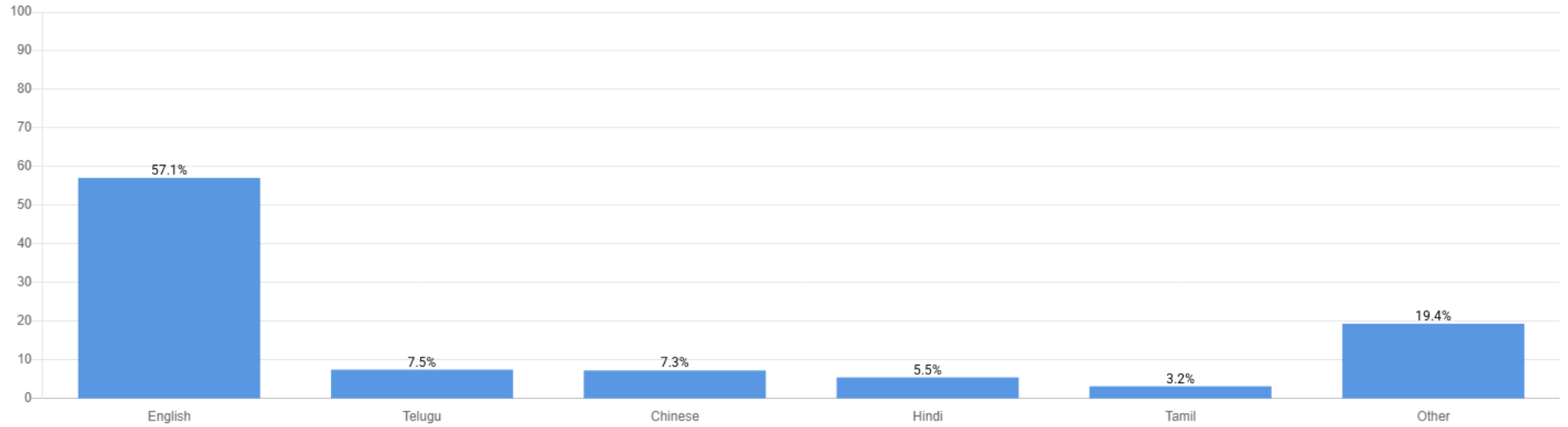

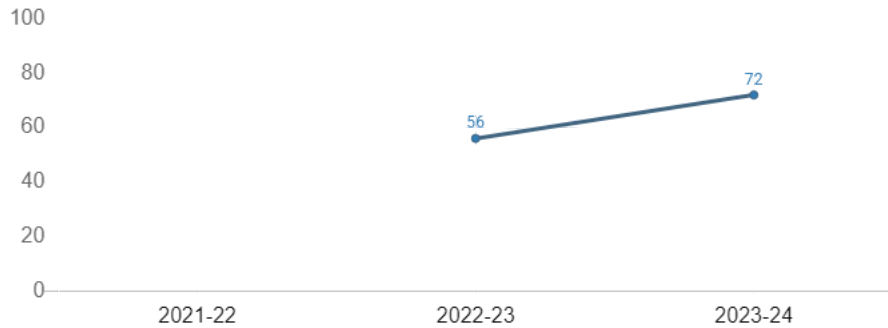

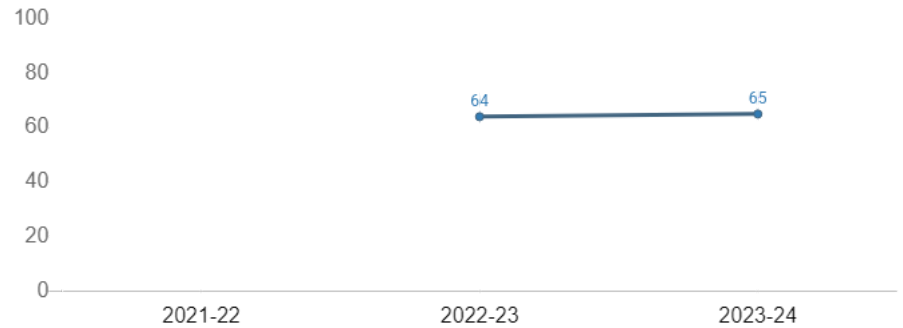

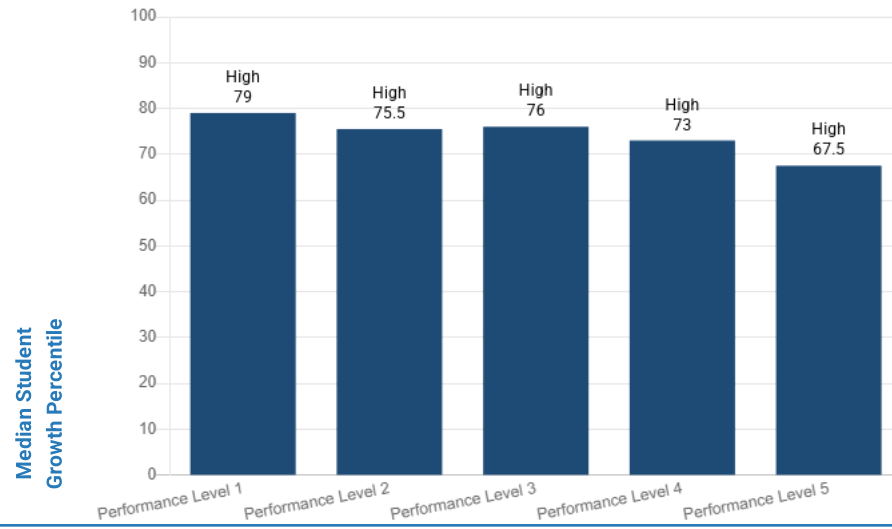

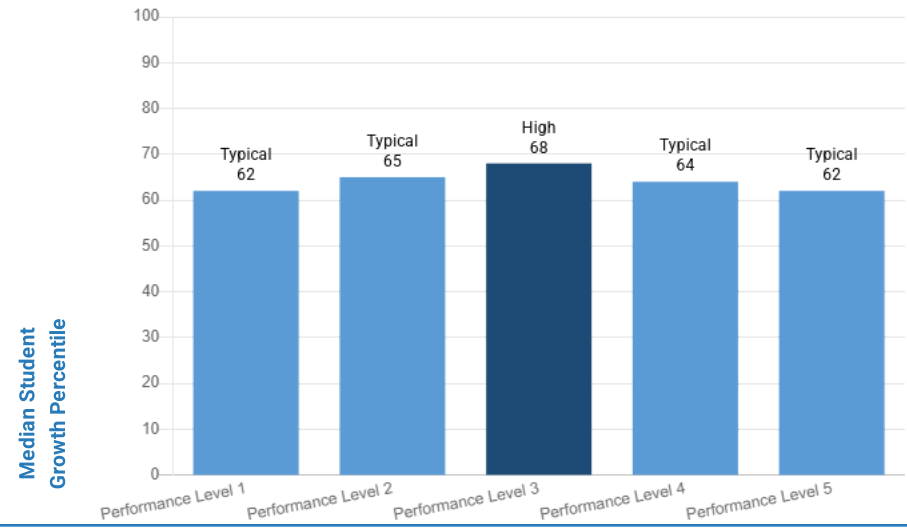

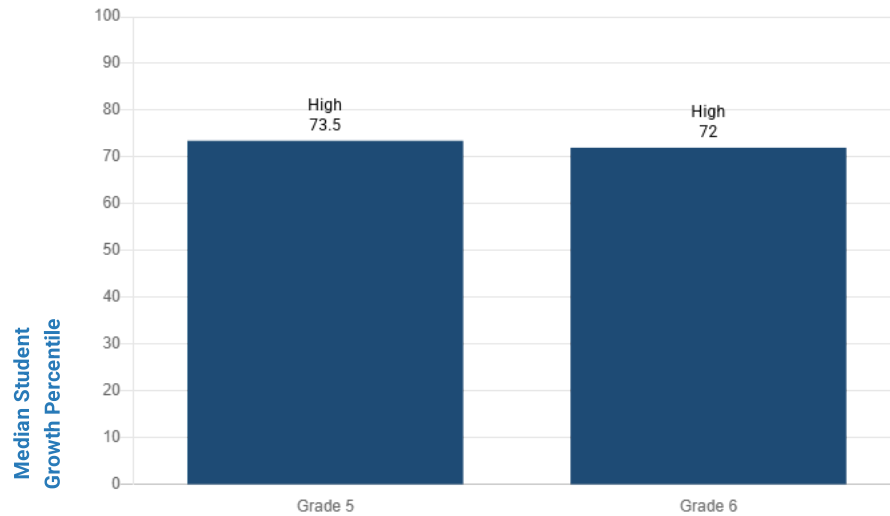

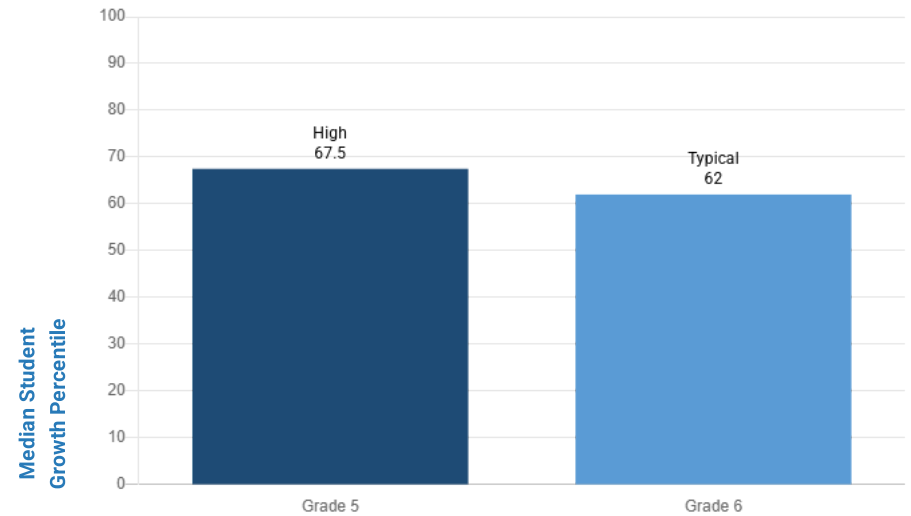

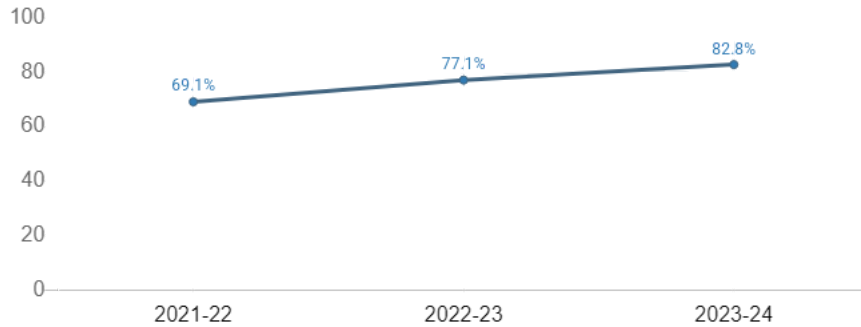

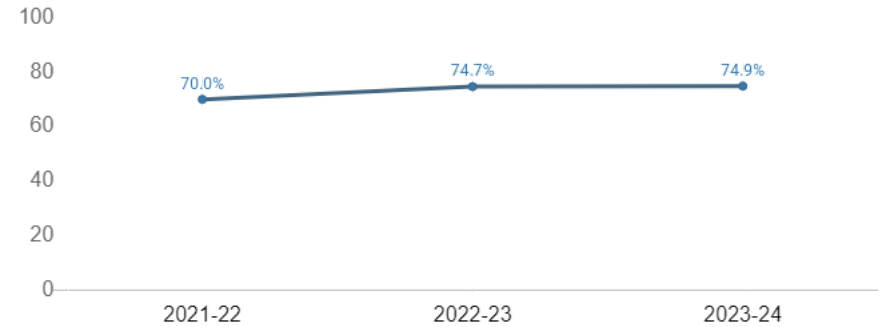
English Language Arts and Mathematics Performance Trends

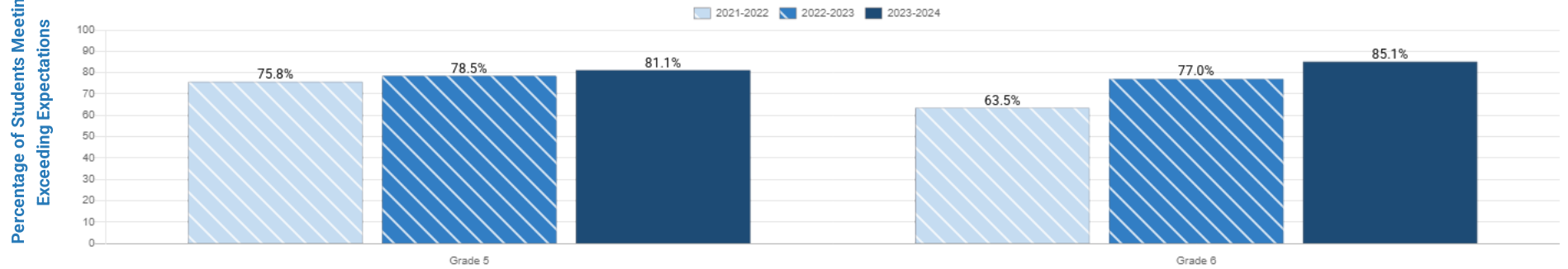

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. 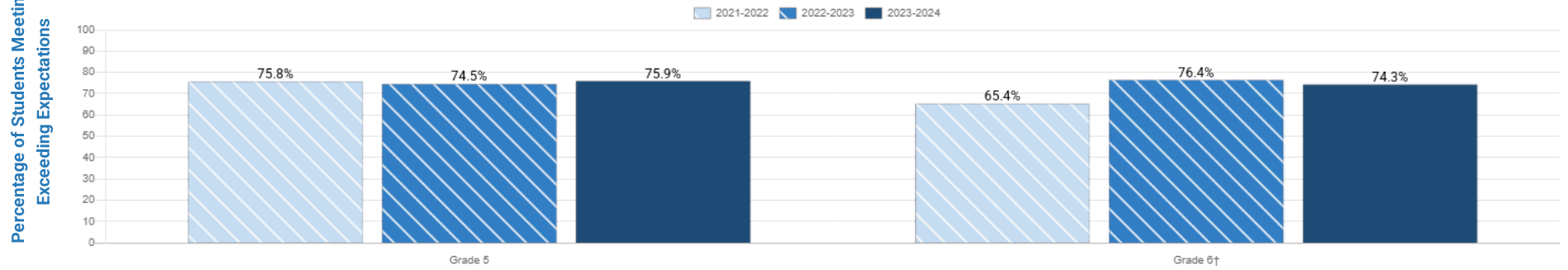

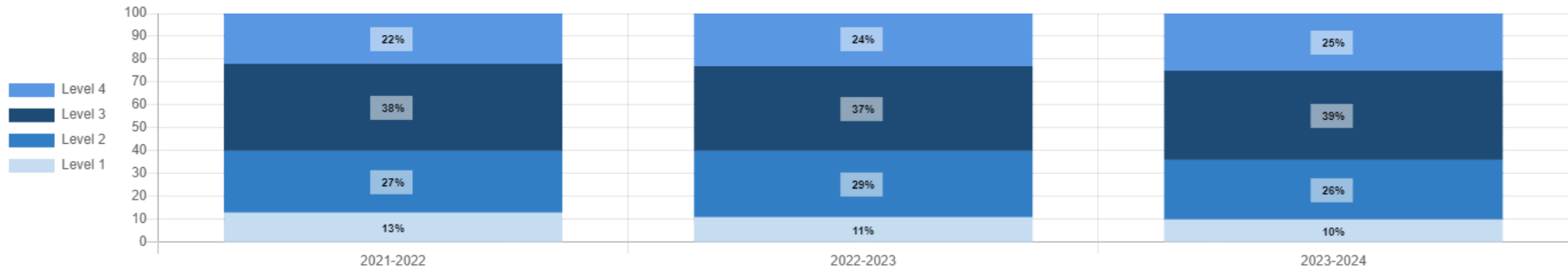

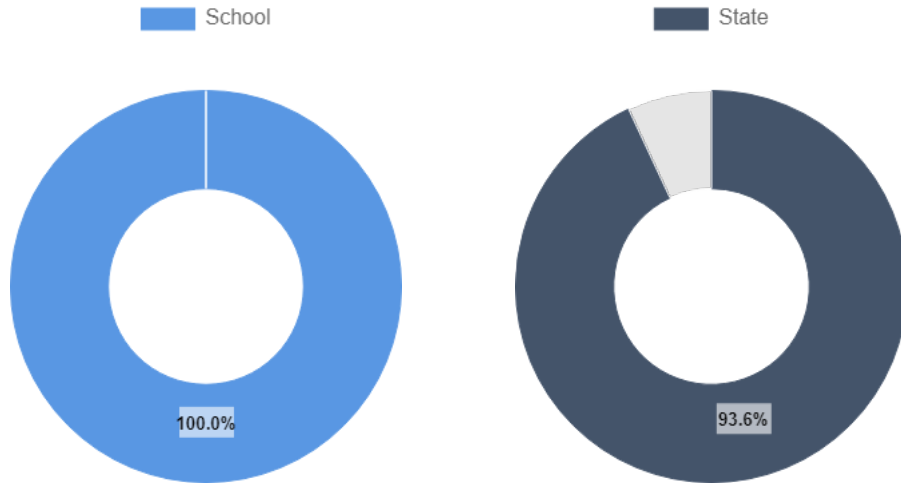

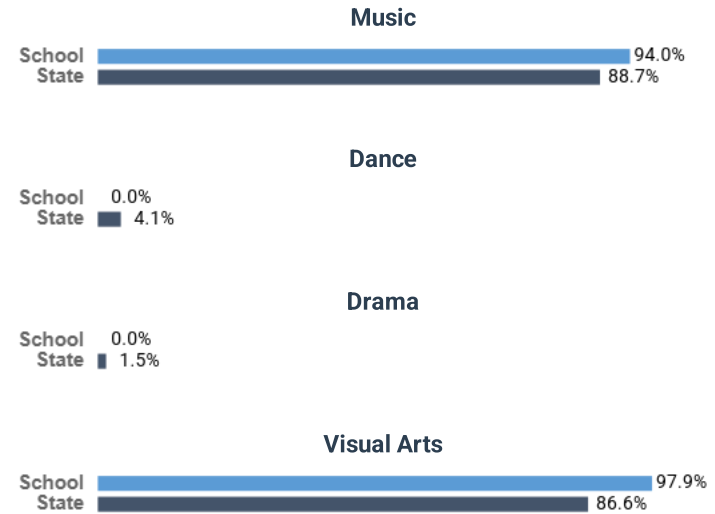

Students enrolled in one or more classes by discipline:



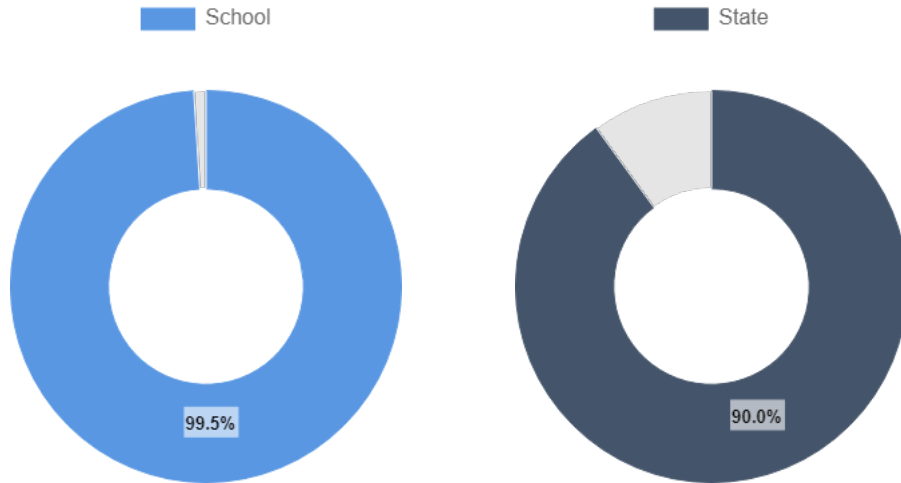

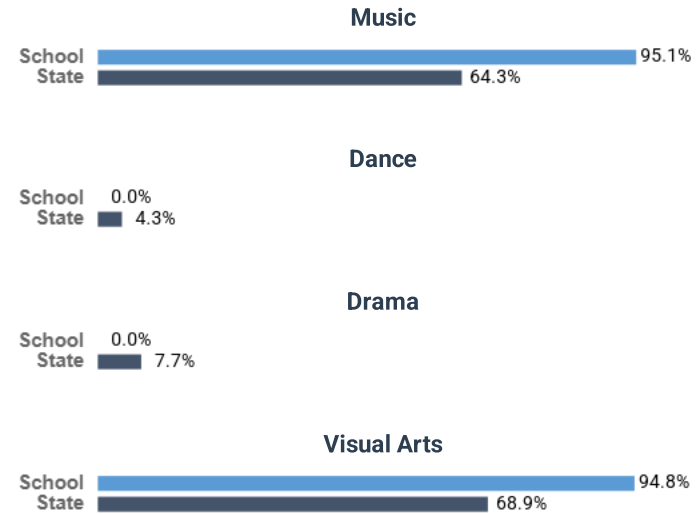

Students enrolled in one or more classes by discipline:



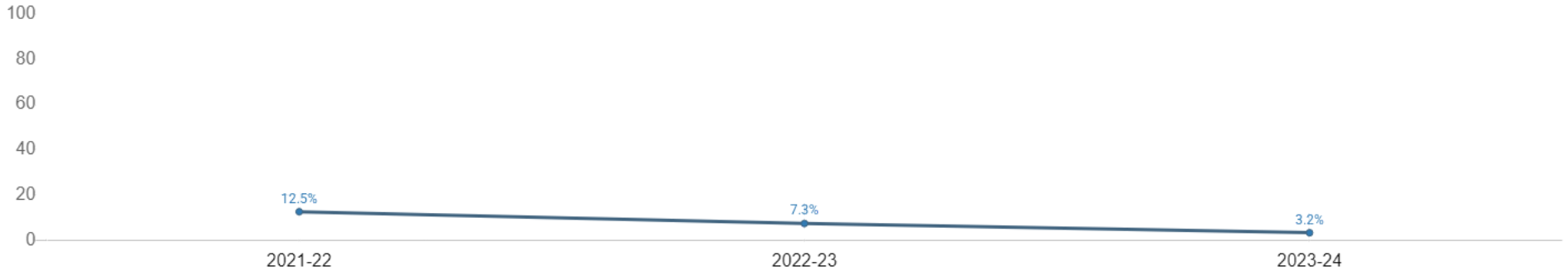

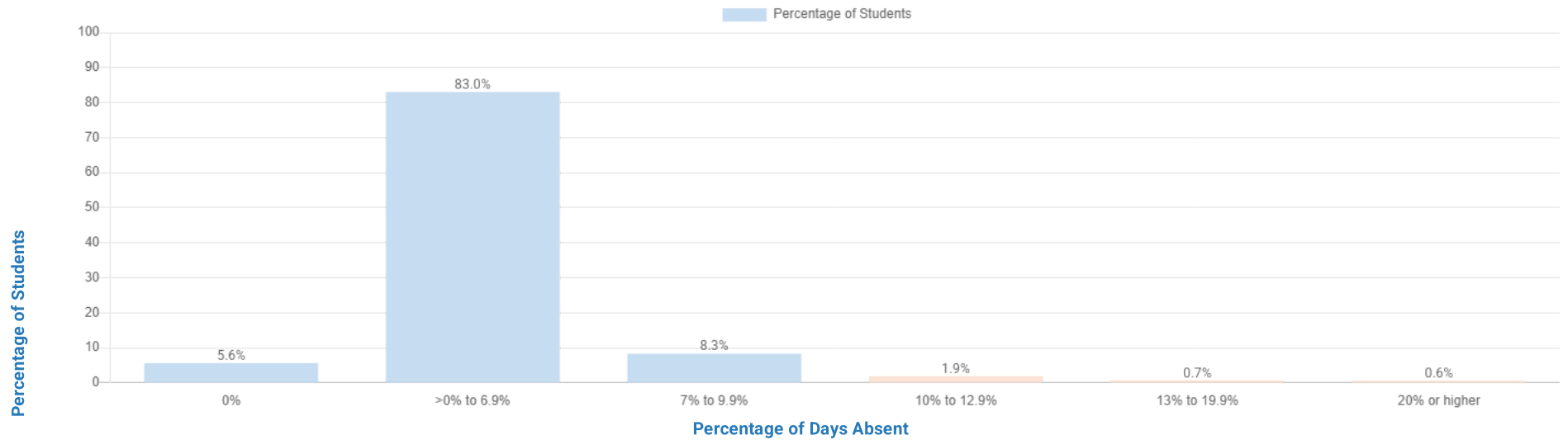

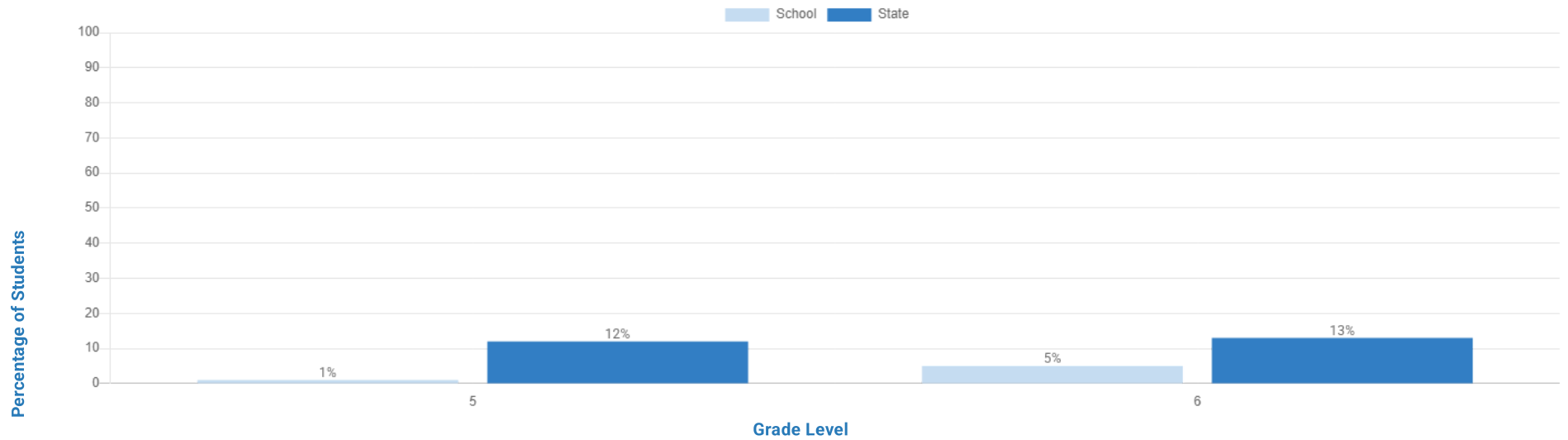

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. If a parent/guardian wishes to have a conference with a teacher, team, guidance counselor or administrator, an appointment can be scheduled at any time during the school year. Formal communication is supported through the parent portal on Genesis, calendar/HW updates and agendas provided by the teacher, and postings on the LMS website. The LMS PTO is a partnership of parents, teachers, and administrators dedicated to supporting our students' education and connecting families throughout our community to our school. Our PTO dedicates itself to designing and managing school and community events. All proceeds raised from these events are geared toward supporting the outstanding learning and instruction offered at LMS.



School Safety:

To provide for student safety, the building is secured throughout the day. Visitors must sign in upon entry and will be stopped at various points throughout the building to check for visitors' passes. Students and staff are trained annually on the Standard Response Protocol for lockouts, lockdowns, evacuations, and shelter-in-place scenarios. Drills in these areas, as well as fire drills, are conducted monthly. The entire school population plays an active role in creating a climate of safety and security.
