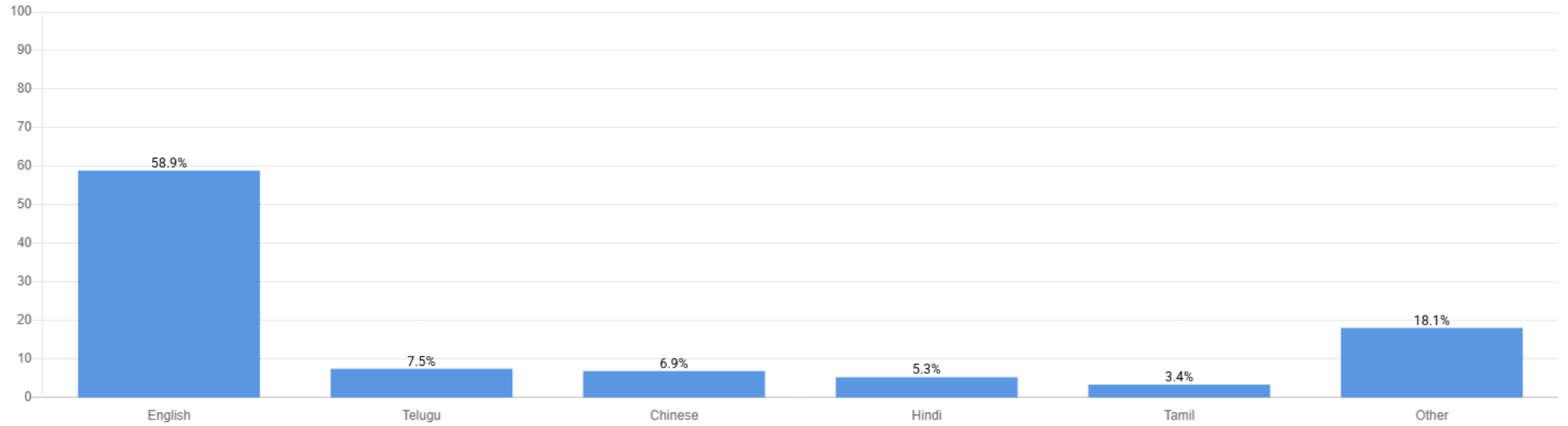

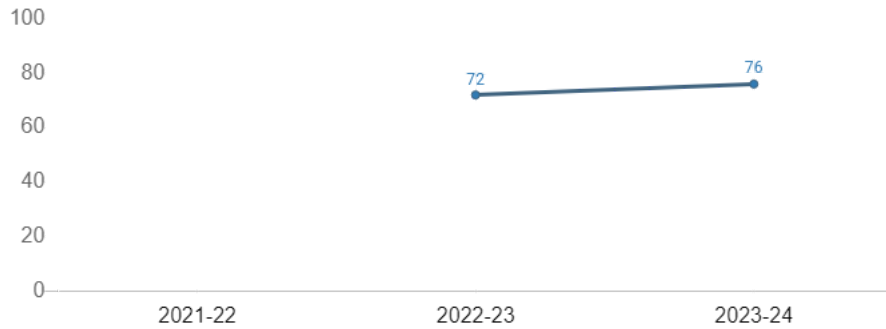

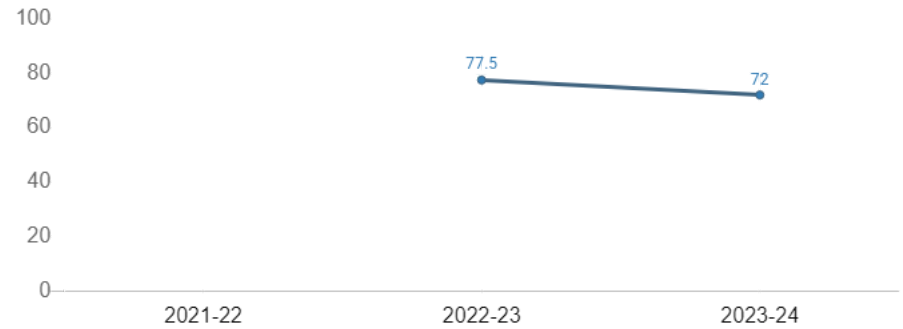

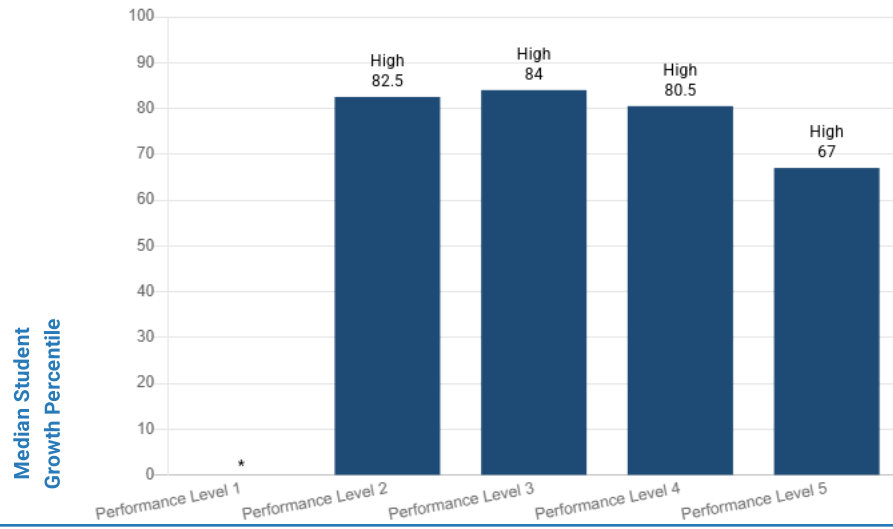

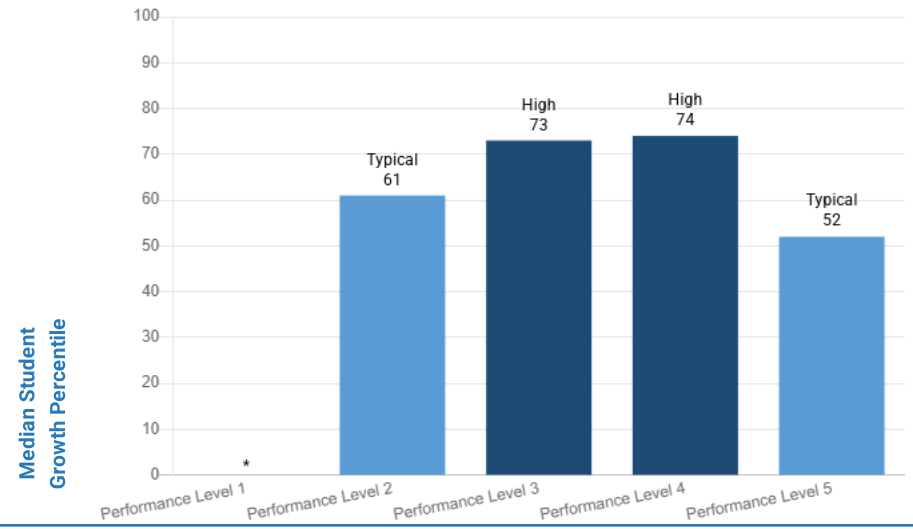

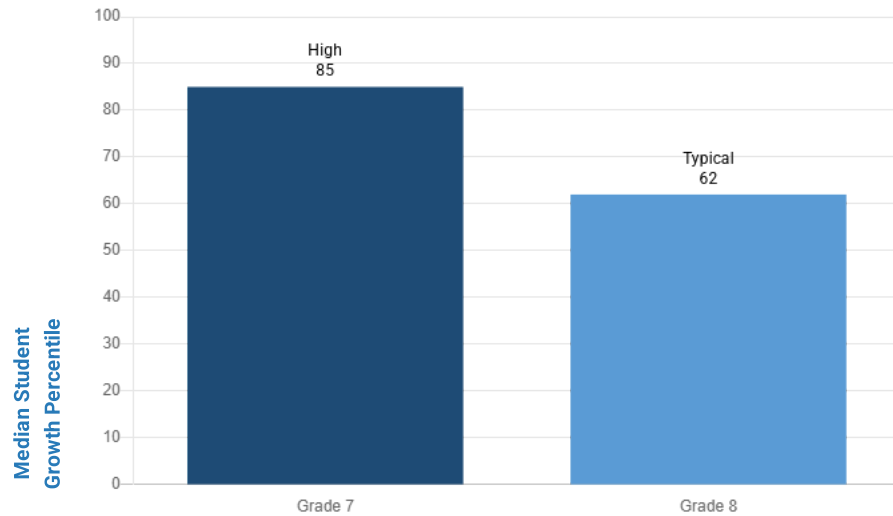

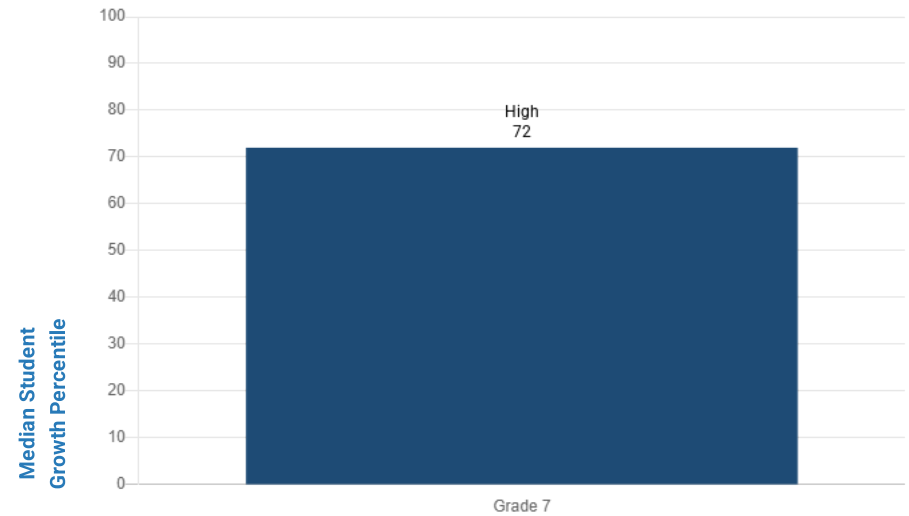

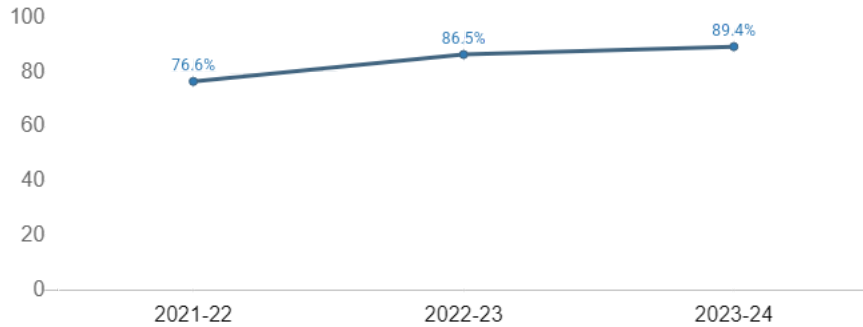

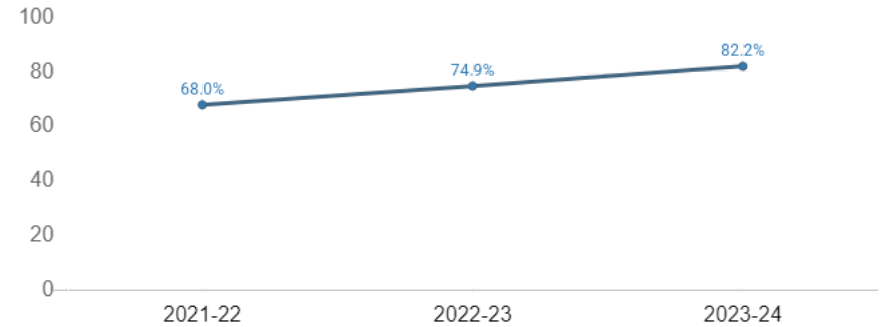
English Language Arts and Mathematics Performance Trends

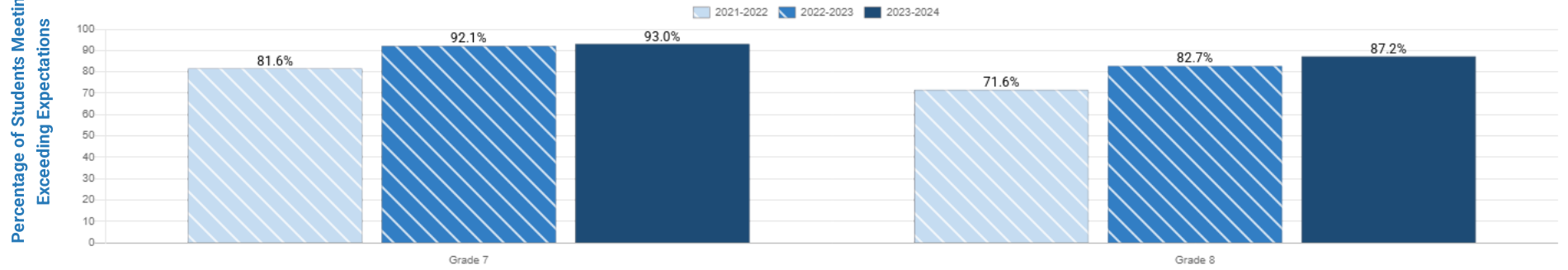

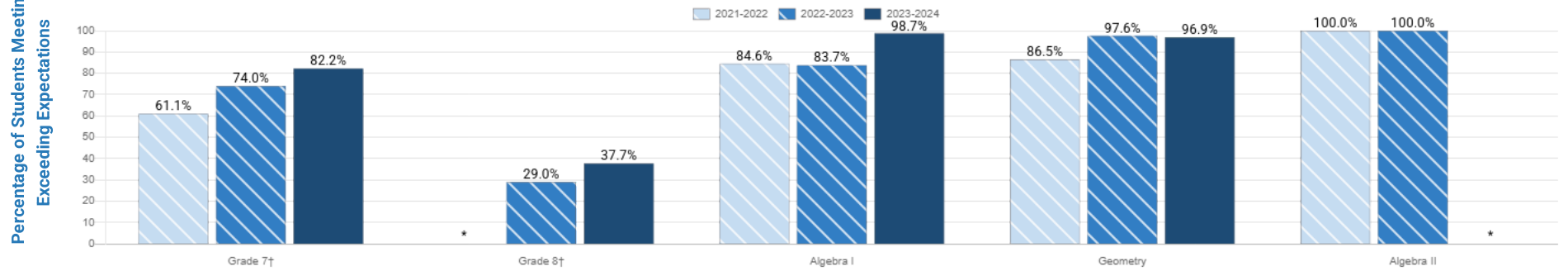

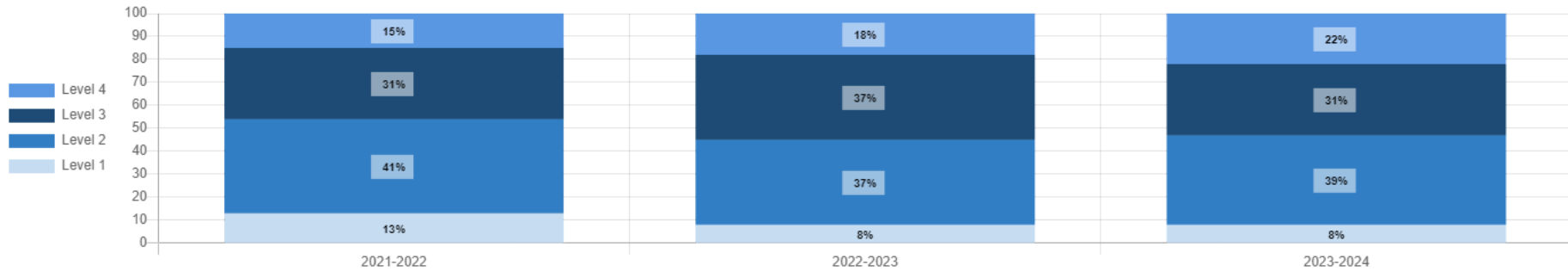

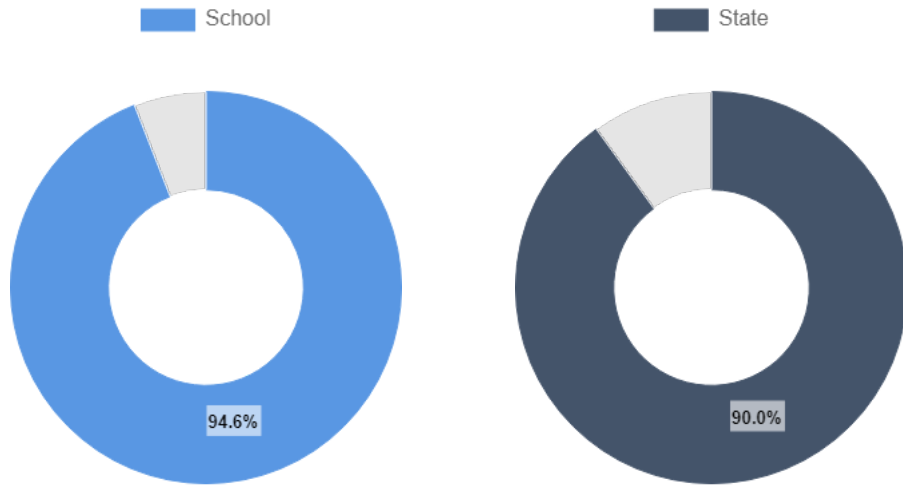

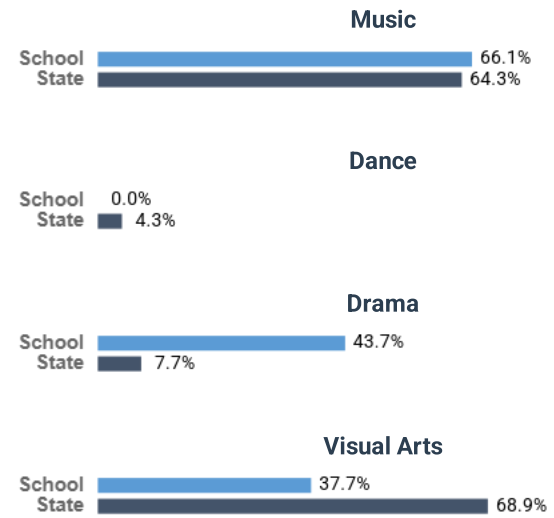

Students enrolled in one or more classes by discipline:



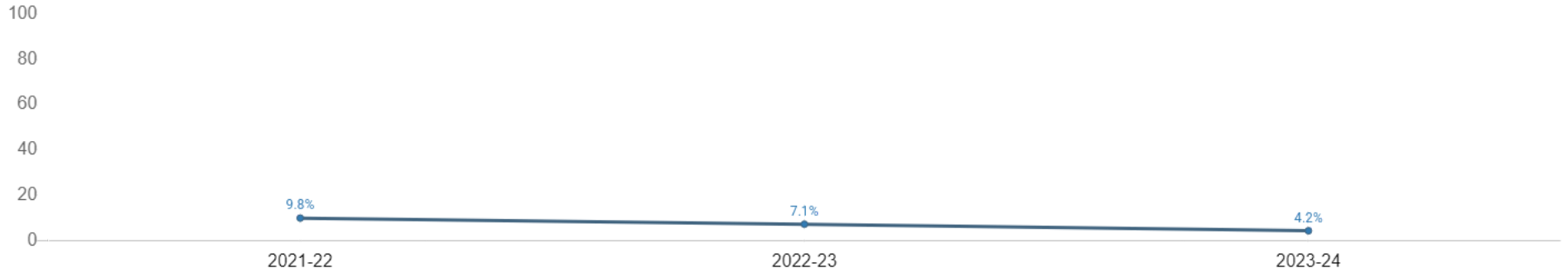

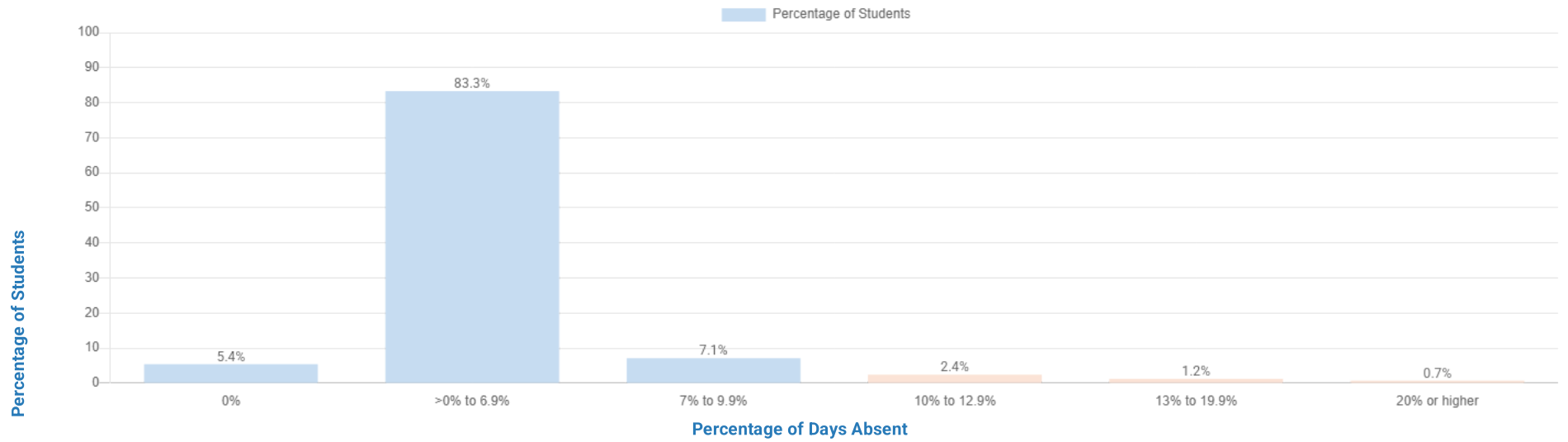

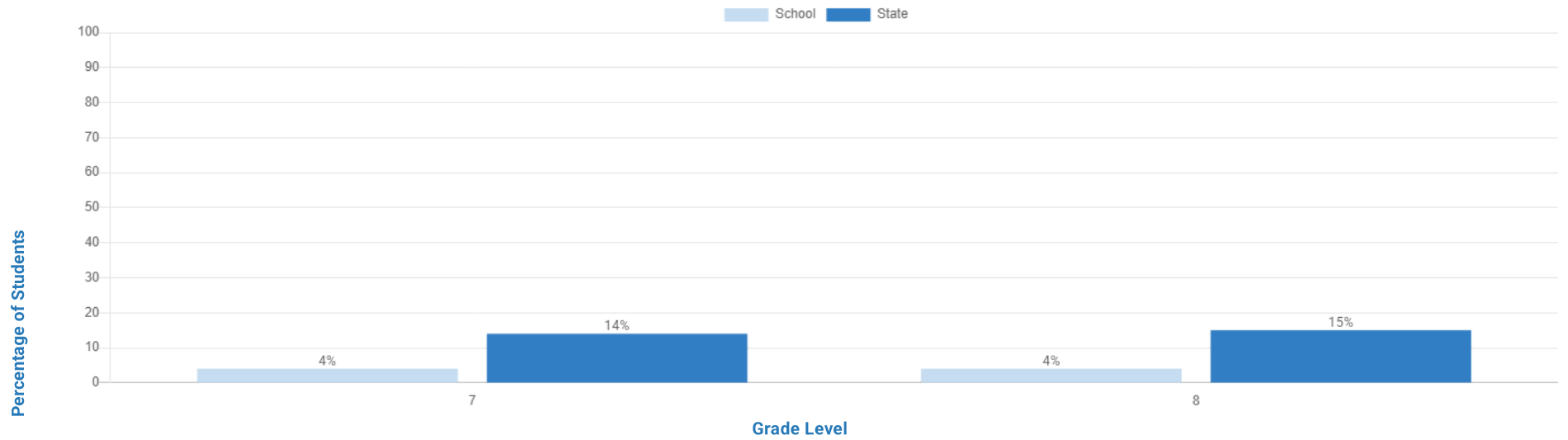

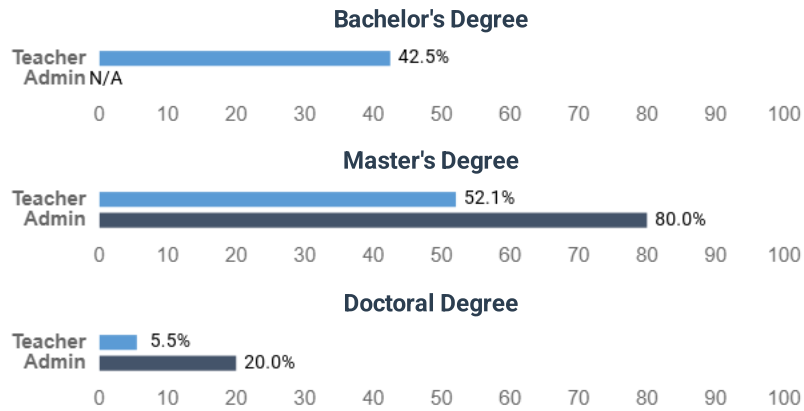

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. School Safety:

To provide for student safety, the building is secured throughout the day. Visitors must sign in upon entry and will be stopped at various points throughout the building to check for visitors' passes. Students and staff are trained annually on the Standard Response Protocol for lockouts, lockdowns, evacuations, and shelter-in-place scenarios. Drills in these areas, as well as fire drills, are conducted monthly. The entire school population plays an active role in creating a climate of safety and security.
