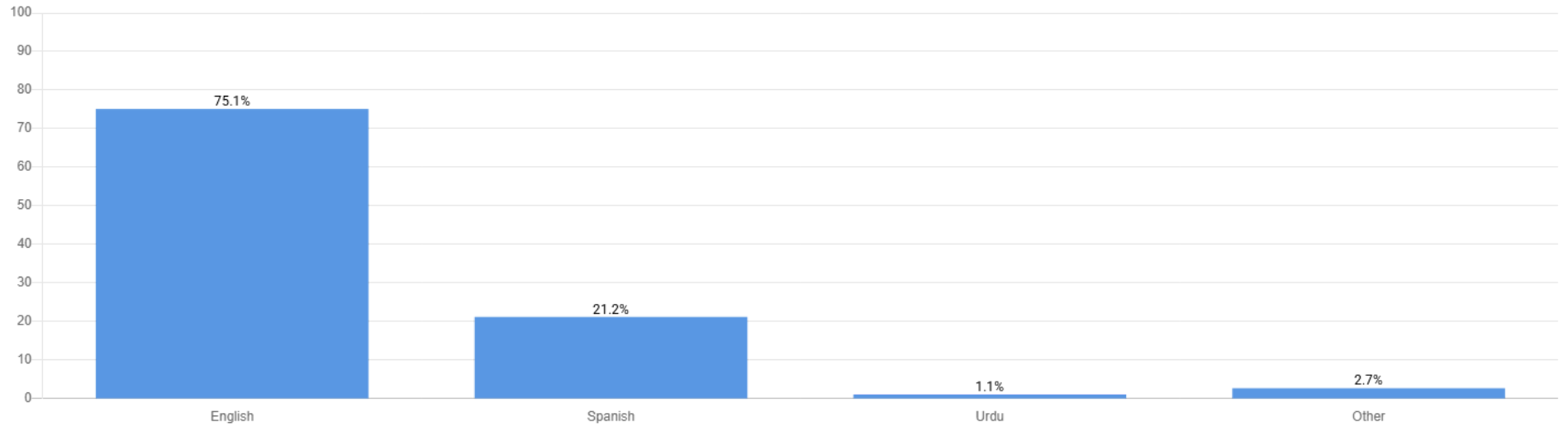

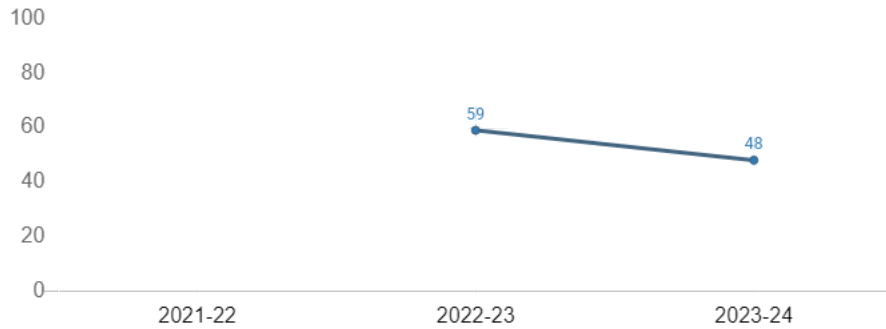

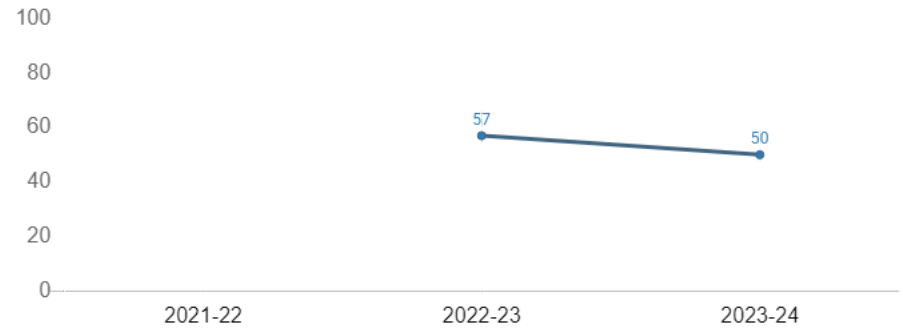

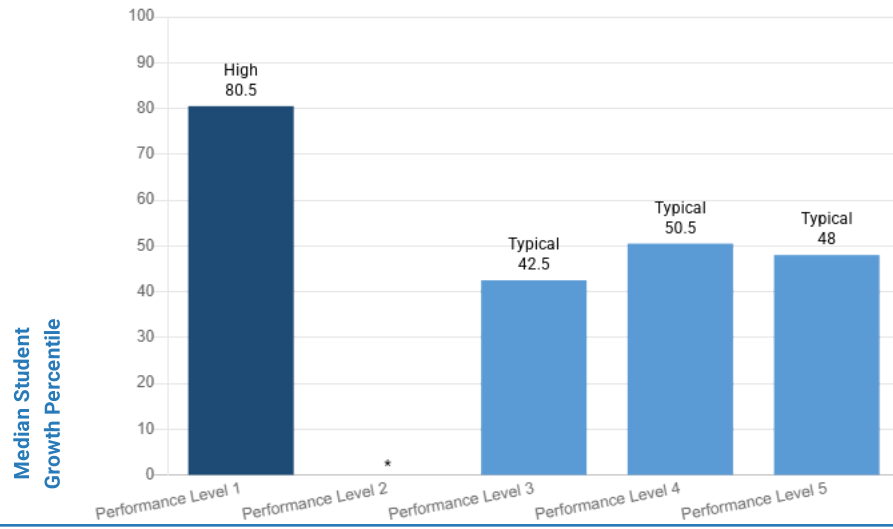

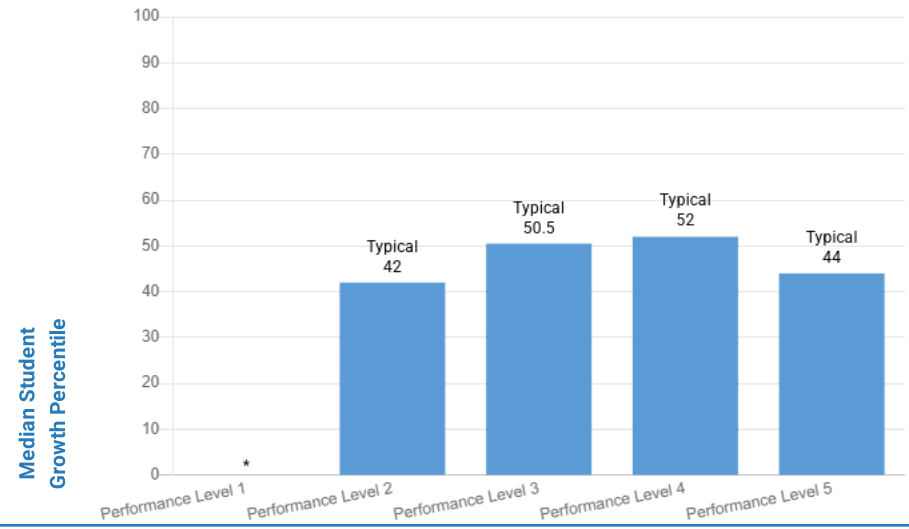

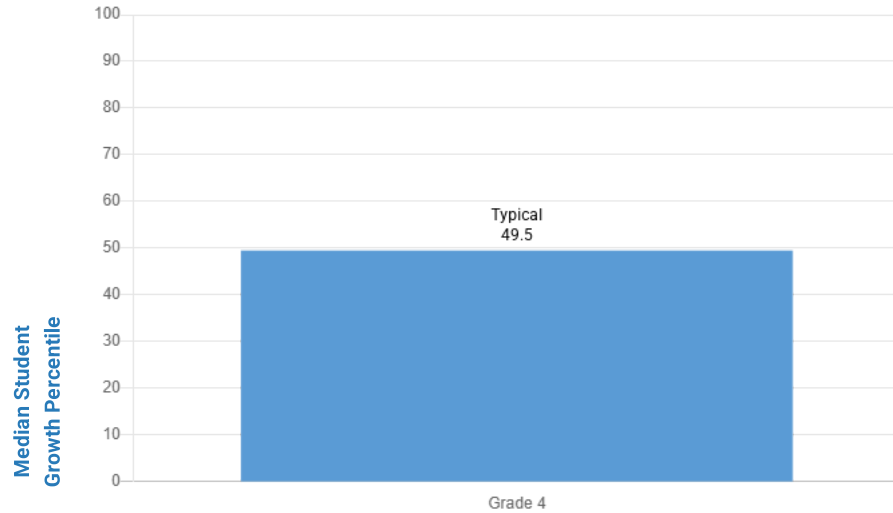

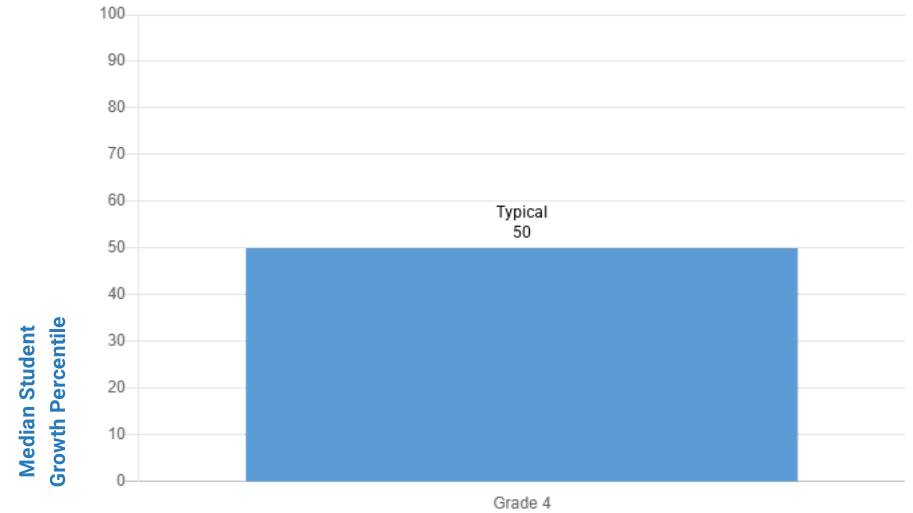

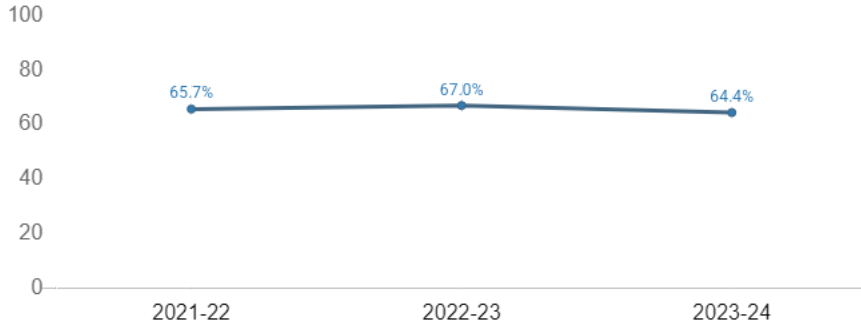

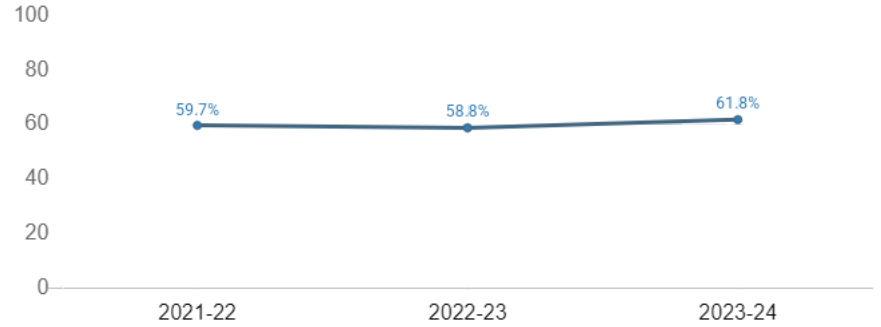
English Language Arts and Mathematics Performance Trends

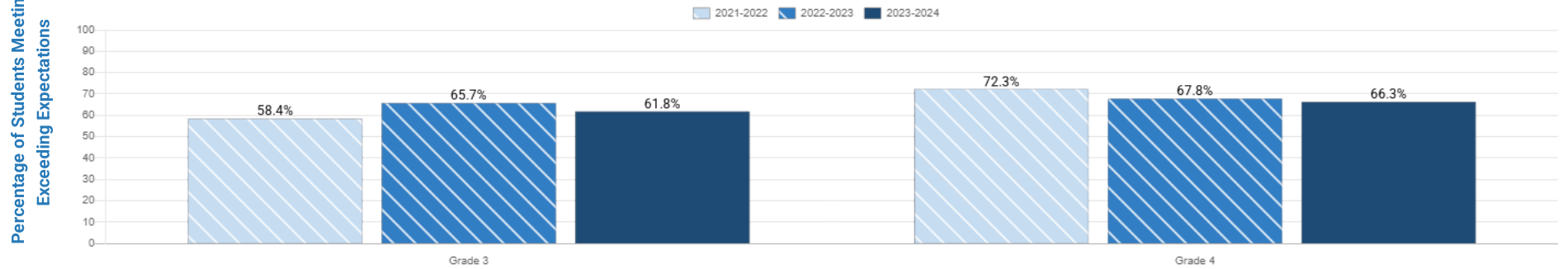

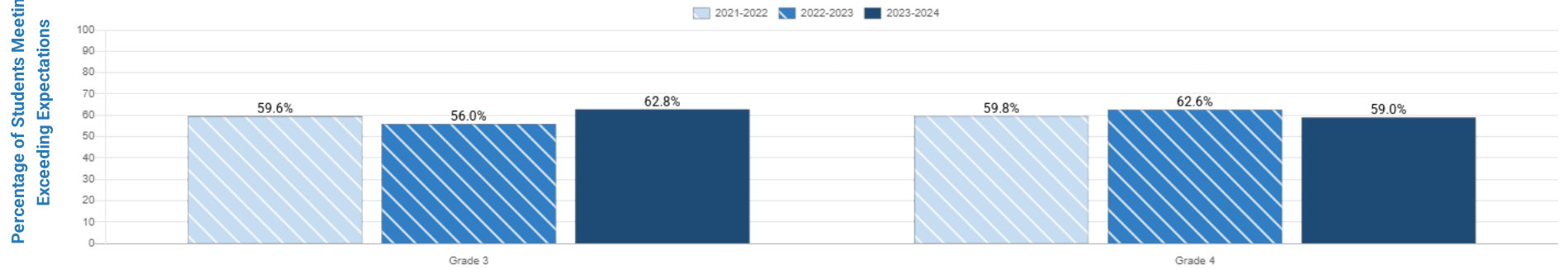

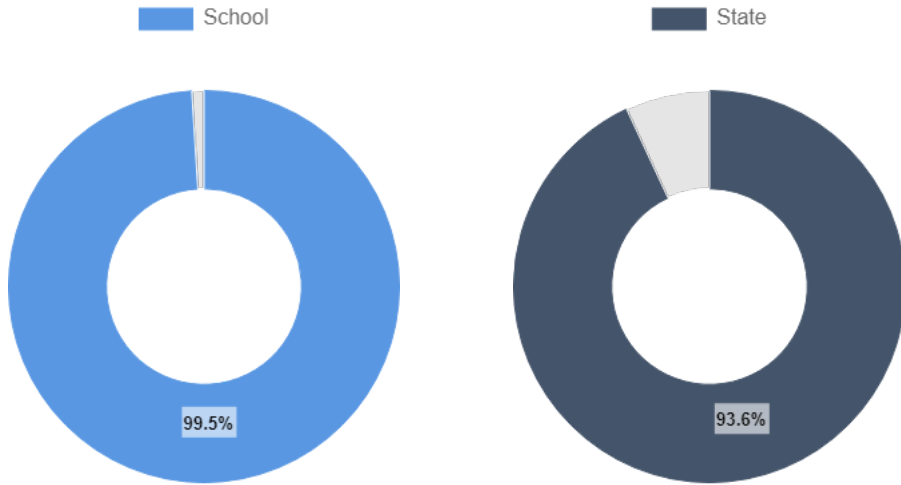

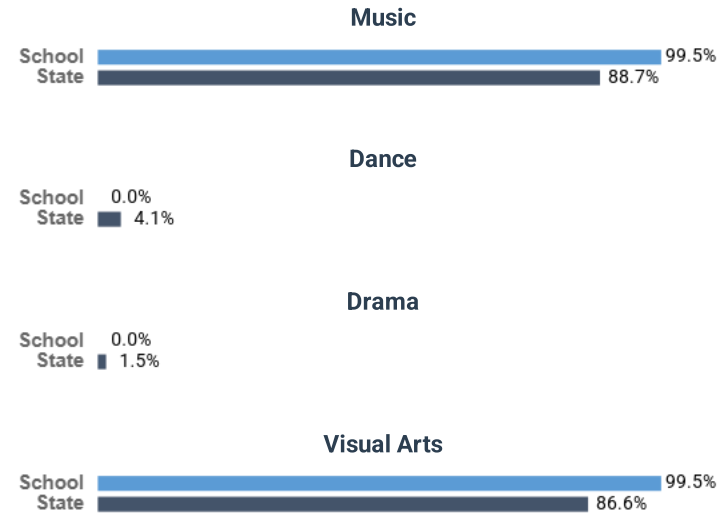

Students enrolled in one or more classes by discipline:



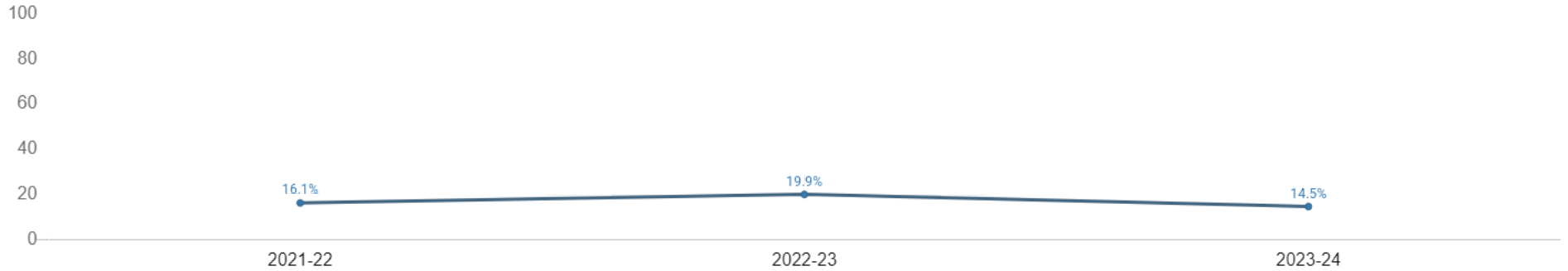

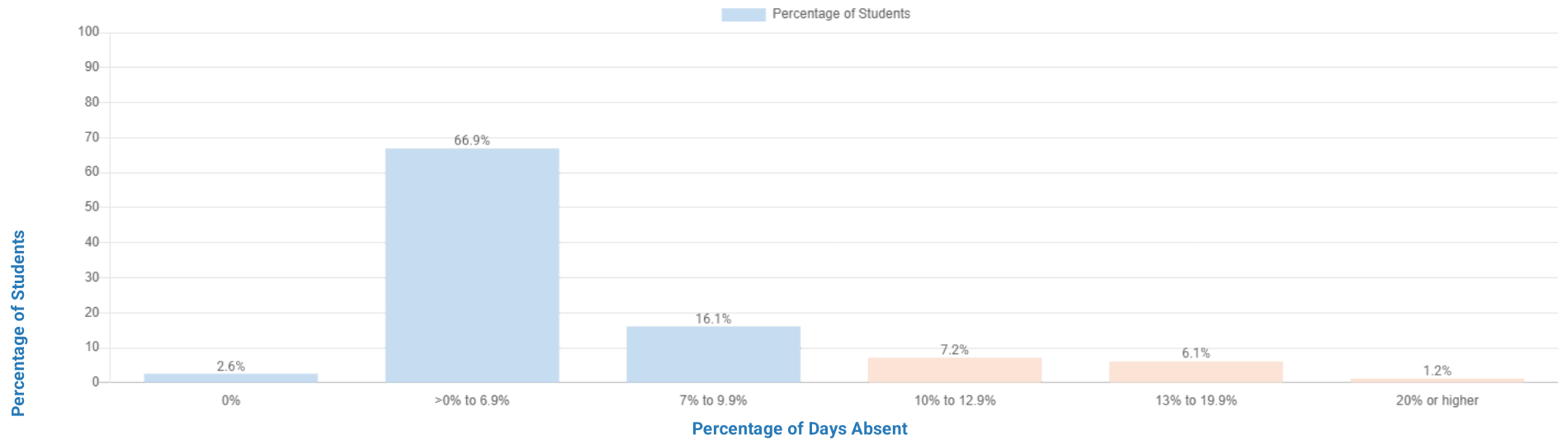

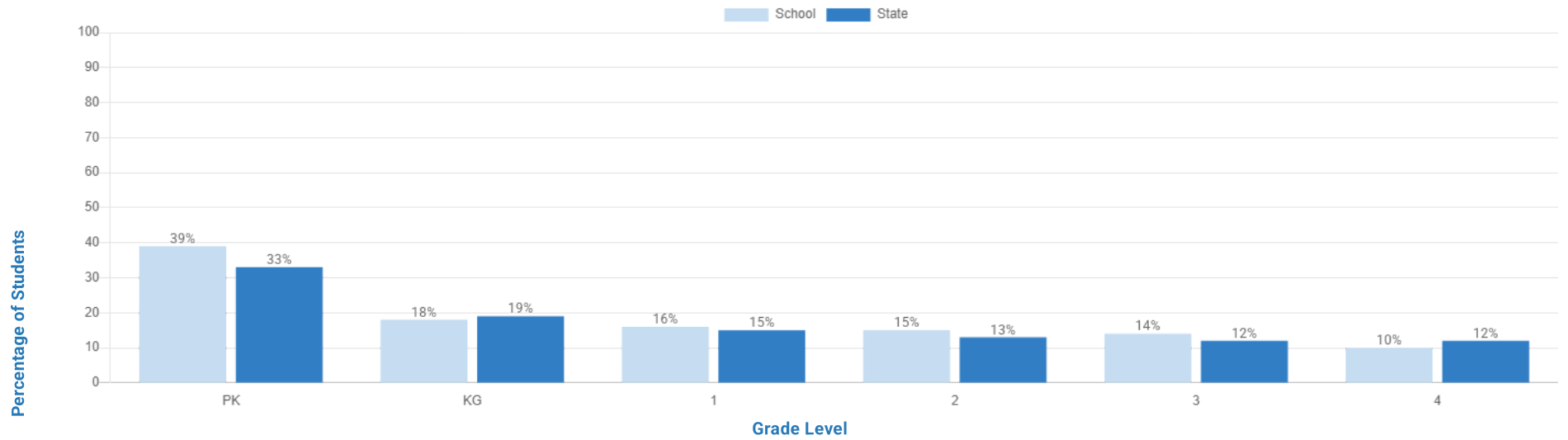

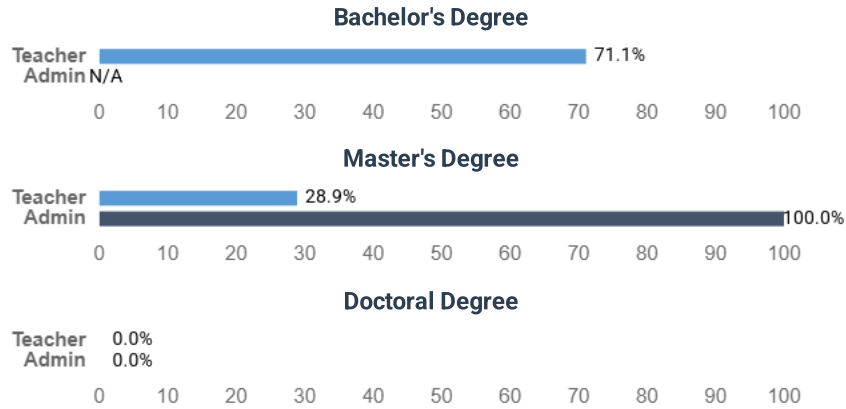

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Bedwell's literacy curriculum incorporates Units of Study Reading and Writing, as well as foundational skills from Foundations. Mini-lessons, shared reading and writing, read-alouds, interactive writing, independent reading and writing, encoding, phonemic awareness, phonological awareness, and academic vocabulary development are essential program components. The i-Ready Mathematics program serves as the basis for mathematics exploration, investigation and instruction. Educators participate in professional learning communities, district professional development institute courses and on site imbedded professional learning for content area subjects.



Student Supports and Services:

Bedwell's Child Study Team is comprised of a full-time School Social Worker and School Psychologist that support special education students via a variety of special education programs. Related services are available to those qualifying students. Multilingual Learners (ML) are supported across the curriculum by a Title 1 instructor and ELL certified staff. An Intervention and Referral Services committee gathers monthly to identify and provide supports to students in the general education setting. Two full-time Reading Specialists and two full-time Math Specialists provide targeted instruction to identified students. A full-time School Counselor delivers school-wide SEL instruction while also meeting with students on an individual and group basis.
