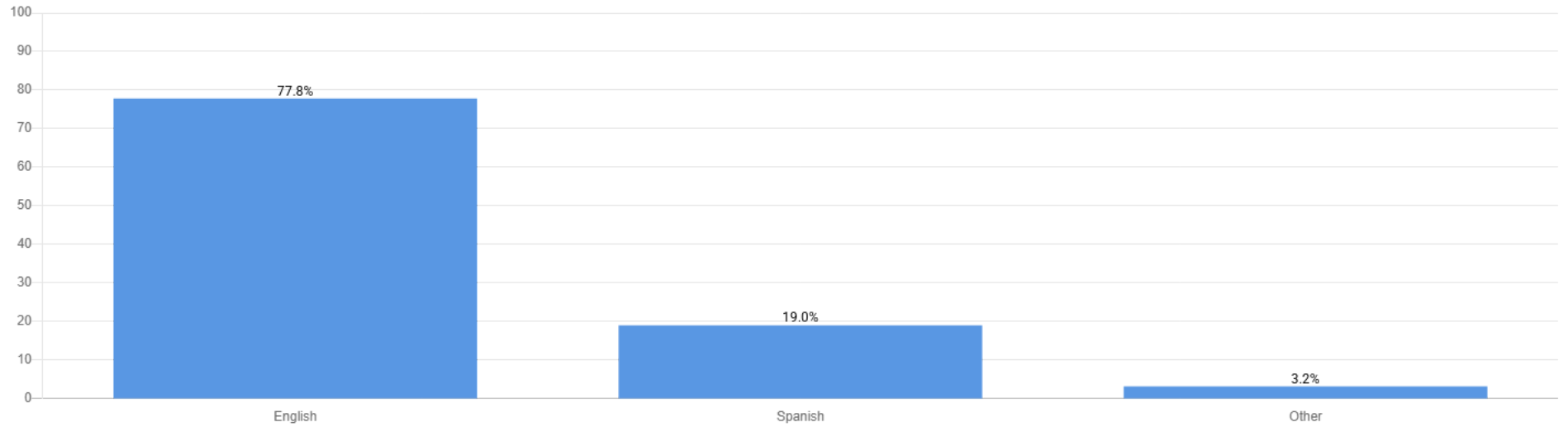

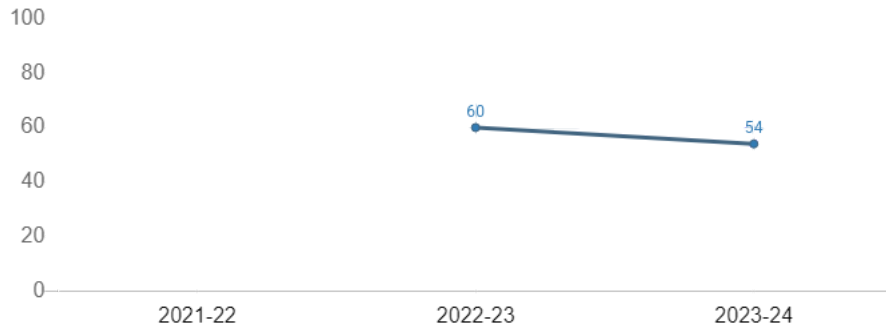

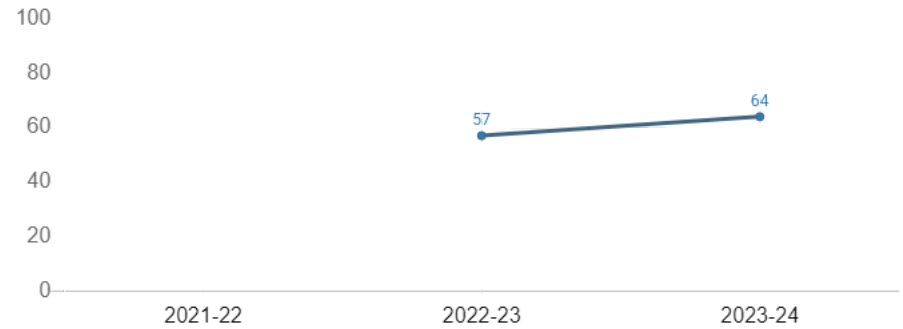

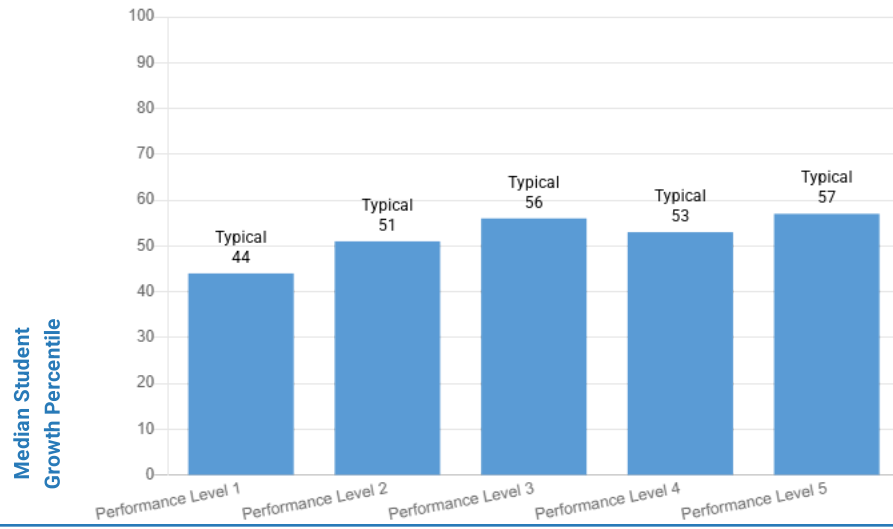

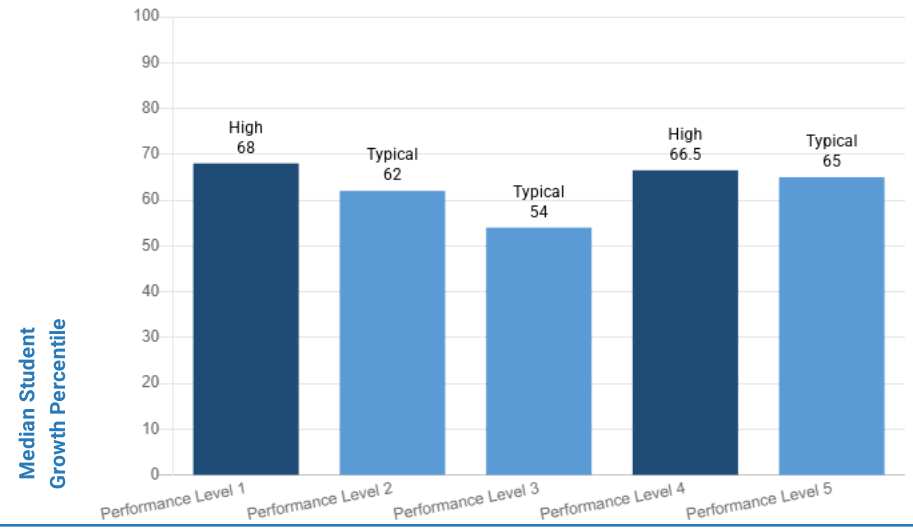

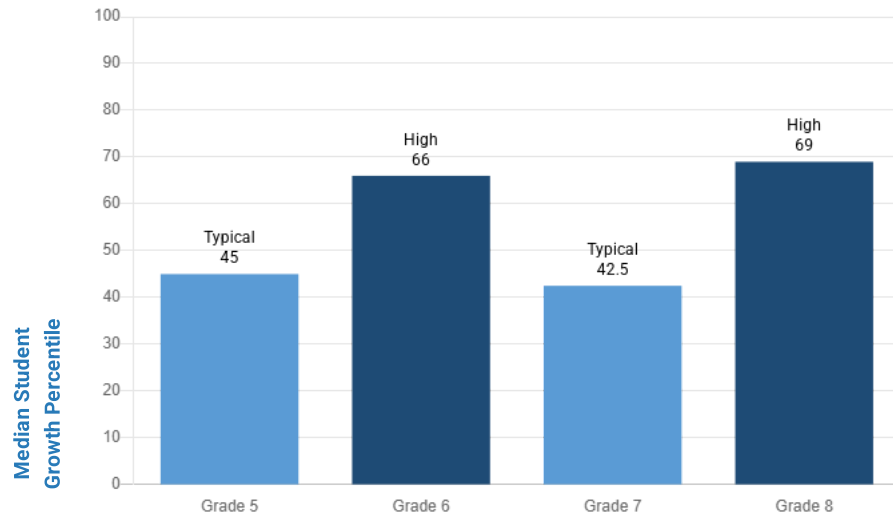

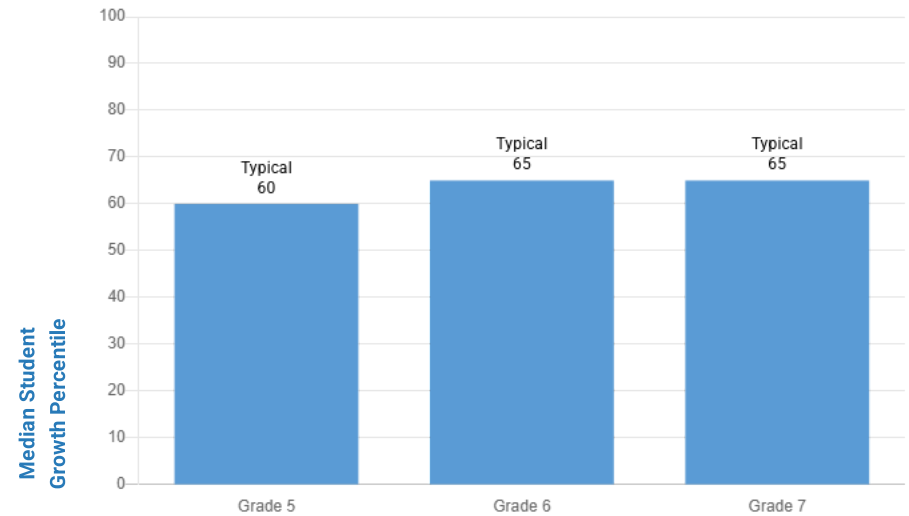

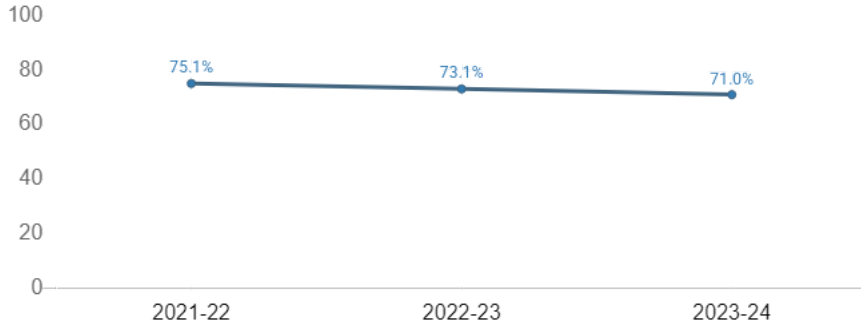

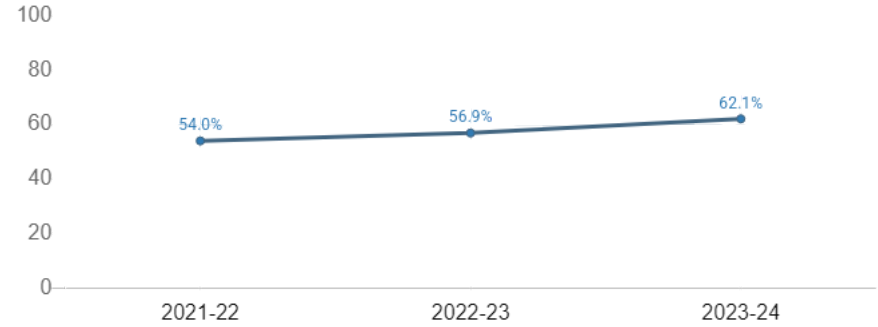
English Language Arts and Mathematics Performance Trends

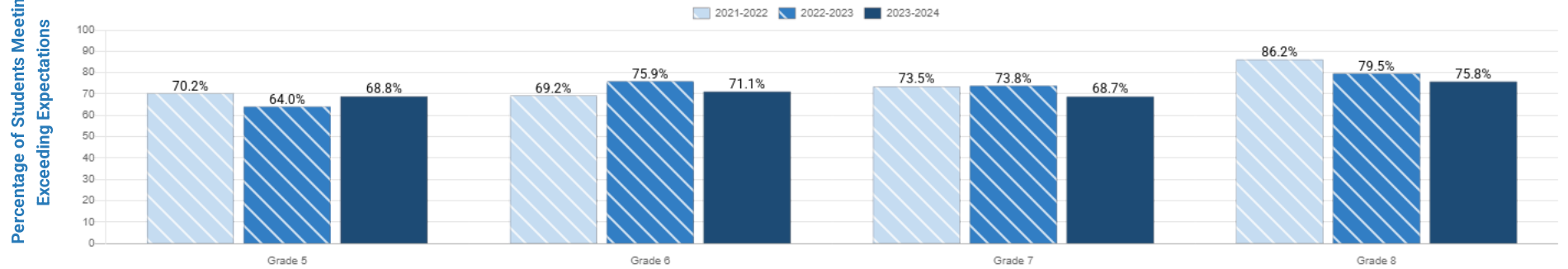

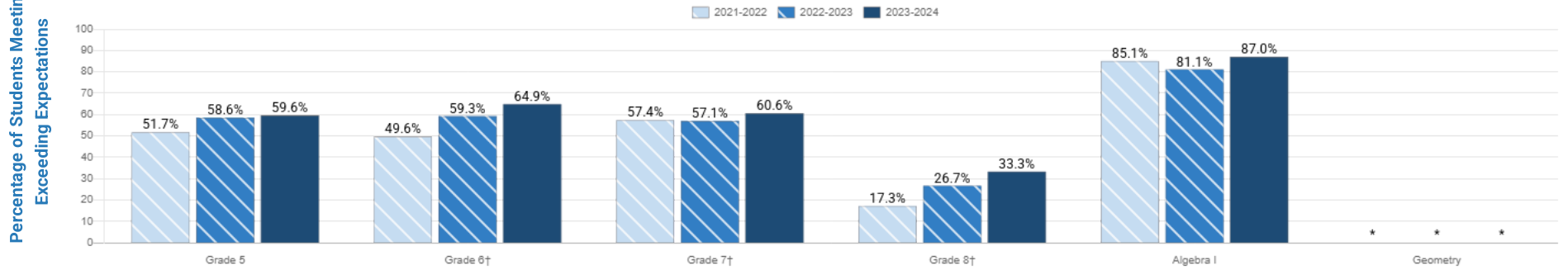

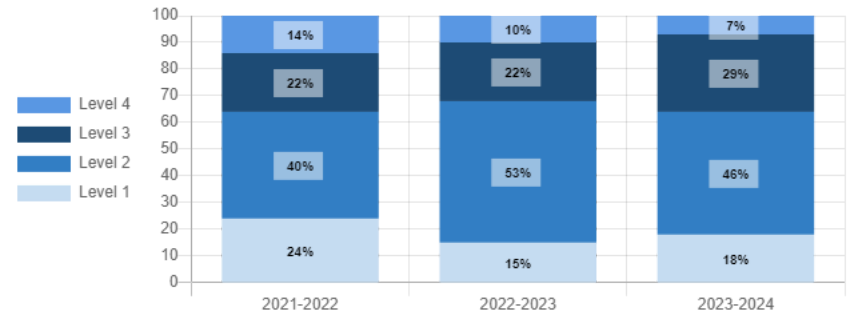

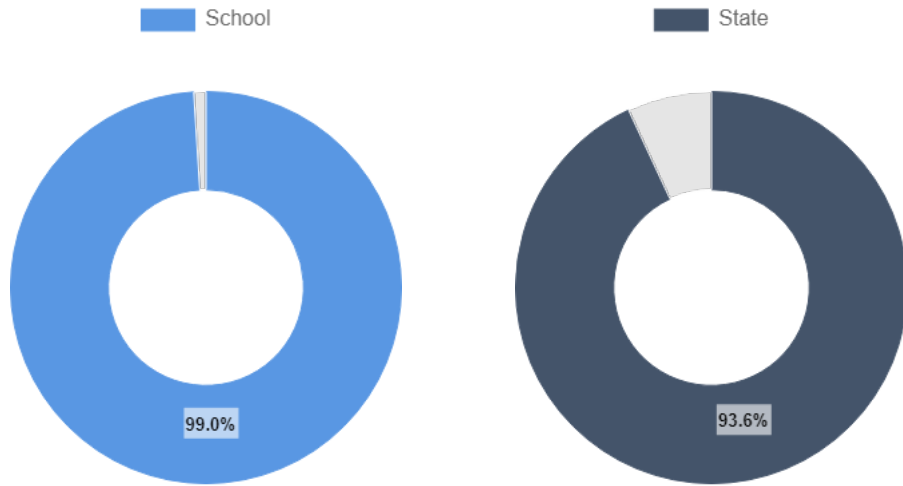

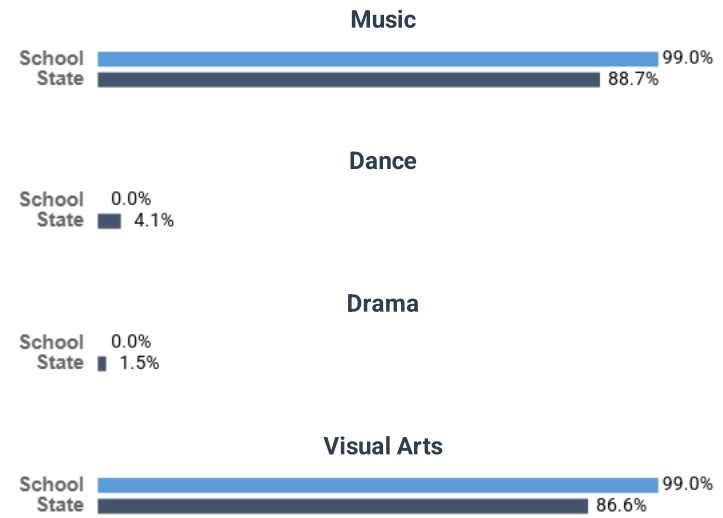

Students enrolled in one or more classes by discipline:



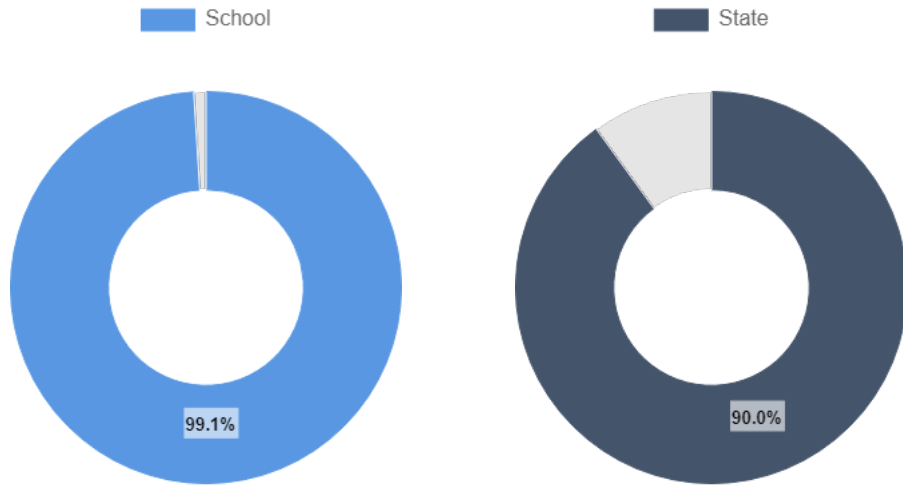

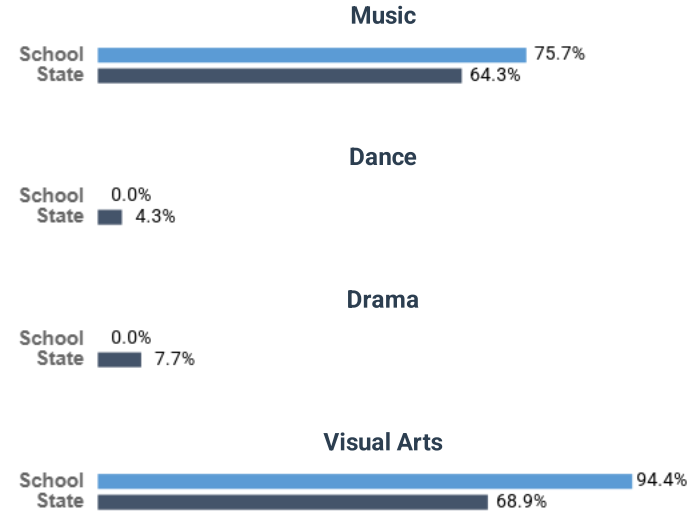

Students enrolled in one or more classes by discipline:



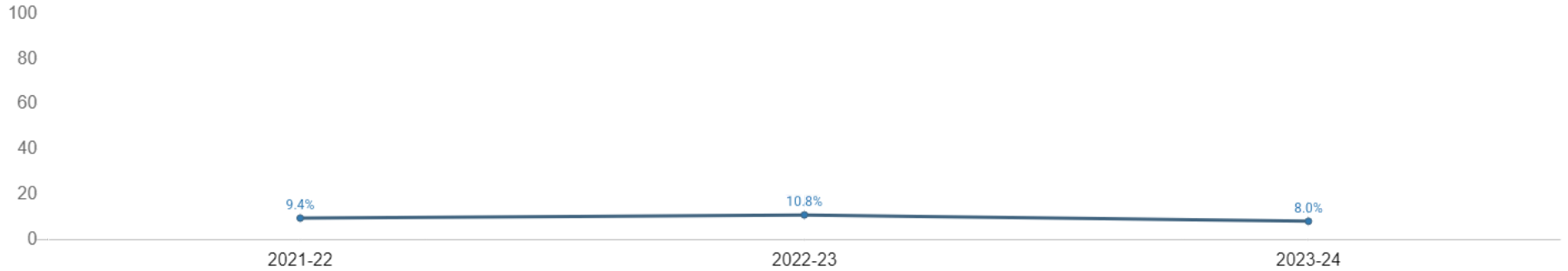

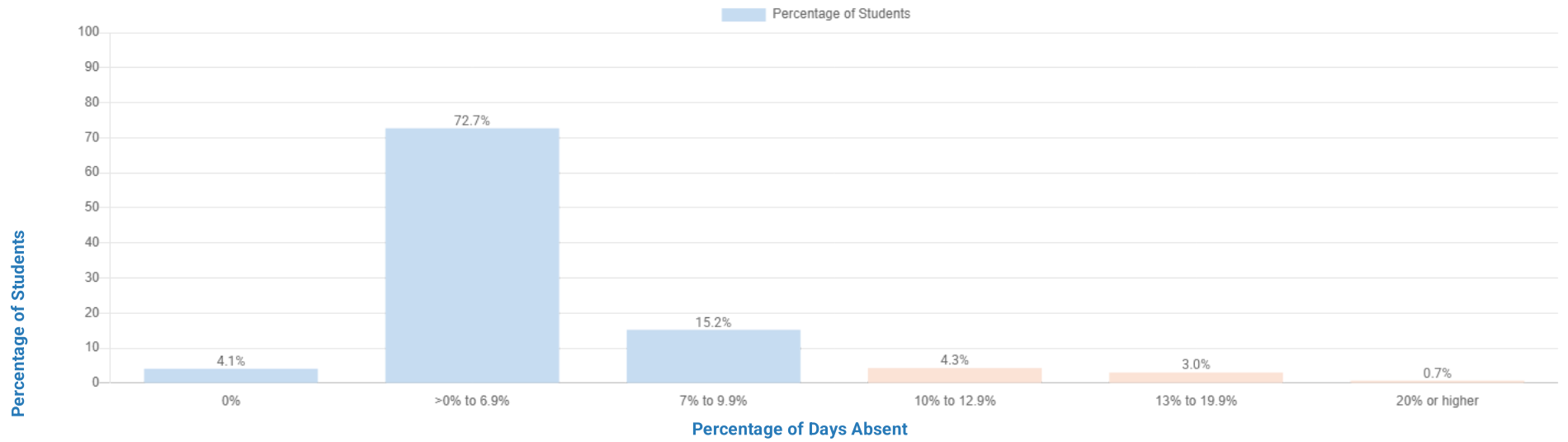

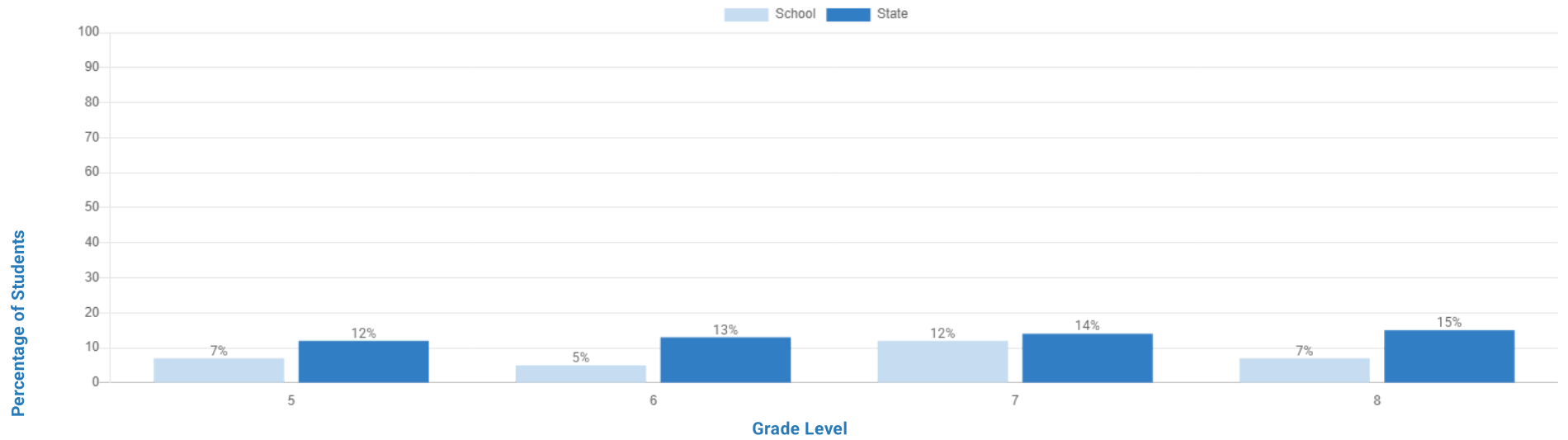

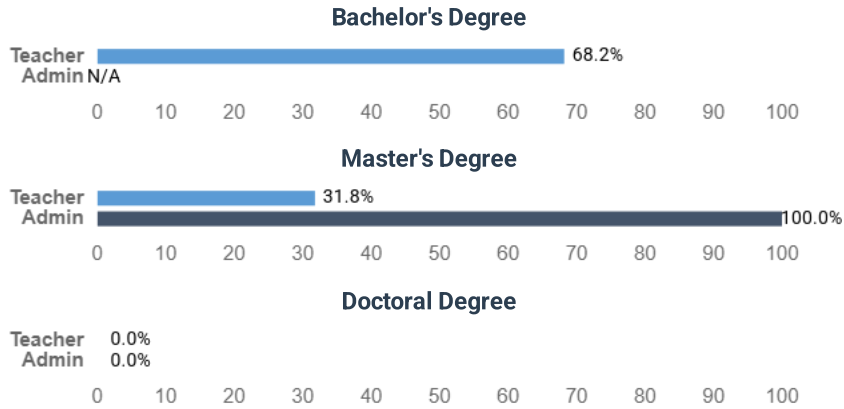

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. BMS had 3 students recognized for excellence in the Patriot's Pen, an essay contest sponsored by the VFW. This school's orchestra, band, and chorus compete in a variety of forums annually and are consistently recognized for their excellence.

Courses, Curriculum, Instruction:

BMS ELA curriculum incorporates Units of Study for Reading and Writing. Curriculum includes Ready Classroom Mathematics (grade 5), Connected Math Project (grades 6-8), Document Based Question (DBQ) Project (Social Studies, 5-8), and FOSS (Full Option Science System). Honors classes are offered in math, language arts, and science in grades 6-8, and approximately 60% of 8th graders are enrolled in Algebra I or Geometry. Daily instruction in a physical education, related arts, and a world language (French, Latin, Spanish) is provided grades 5-8. Current related arts offerings include: computers, technology, digital photography, visual art, music, public speaking, wellness, and digital citizenship.



Sports and Athletics:

Sports Offered: Baseball (Boys), Basketball (Boys & Girls), Cross Country (Boys & Girls), Field Hockey (Girls), Soccer (Boys & Girls), Softball (Girls), Track and Field - Spring (Boys & Girls), Wrestling (Boys)
Sports offered: cross country for boys and girls (5-8), field hockey for girls (6-8), soccer for boys and girls (6-8), basketball for boys and girls (6-8), boys baseball (6-8), girls softball (6-8), wrestling(5-8) and spring track and field for boys and girls (5-8). Almost half of the BMS student population at BMS participate in the sports program during the school year.



Clubs and Activities:

Outside of the school day, BMS offers a variety of extracurricular opportunities to provide both additional academic support and as well as enrichment. The enrichment includes explorations in drama, leadership, art, photography, science, and journalism. The Green Team works to beautify school grounds as well as promote and facilitate environmental awareness. Drama is offered, with musicals produced both in the spring and the fall. Student Council is affiliated with NJASC and participates in state level activities and events. The BMS Robotics team competes at the state level.

Before and After School Programs:

Students have an opportunity to participate in an offsite aftercare program from dismissal to 6PM. Run through the Somerset County YMCA, this program is housed a short walk at the district's elementary school. Students can have a snack, have help with their homework, and play games with peers.



Staff and Professional Learning:

BMS staff meets for professional development numerous times throughout the year, with four full half days and six half days devoted to professional learning. Teachers College staff developers work with in building with language arts teachers five times a year. Consultants support math teachers on an ad hoc basis. The district's Professional Development Institute encourages teachers to support other teachers in professional learning, and all are members of professional learning communities. Teachers may have opportunities to attend out of building conferences with approval from district administration when it supports district initiatives.



Student Supports and Services:

Child Study Team members support special education students with programs that span grades and instructional configurations. Multi Language Learners are supported through flexible programming designed to help them acclimate and grow. The school's Intervention and Referral Services Committee meets monthly. In addition to developing action plans using a tiered MTSS model or referred students, this committee reviews regularly reviews attendance, assessment, and discipline data in an effort address students' needs proactively.

Student Health and Wellness:

All students receive a minimum of 150 minutes of physical education weekly, with most receiving an excess of 200. Health standards are addressed through classroom instruction with certified teachers. Fifth graders participate in a yearlong class surrounding wellness, which addresses mindfulness, conflict-resolution, empathy, and responsibility. All grade levels have access to recess within their scheduled lunch periods, weather permitting. Health and Wellness is a district level initiative.



Parent and Community Involvement:

BMS Home and School Association is an integral part of the school, sponsoring cultural arts, assemblies, and programs. The district education foundation provides funding through their grant process, enabling staff members to dream big. Youth Services Commission and the Somerset Hills Municipal Alliance are also financial supporters of this school. They enable to the school to target character education, afterschool tutoring, and an 8th grade Youth Summit which supports the student transition to high school.



Climate Surveys:

BMS is a member of the School Culture and Climate Initiative (SCCI), an opportunity provided by the partnership of the Center for Human and Social Development at College of St. Elizabeth and the United Way of Northern New Jersey Youth Empowerment Alliance. A student-led climate team, supported by staff, has led to the four house system at BMS. Students and staff participate in student-planned "House Days," activities designed to promote inclusivity and school spirit. A culmination of monthly participation points earned through competitions and challenges, results in the house flag being flown for a month. Facilities:

BMS shares a wooded campus with the district's elementary school. The majority of the building was constructed in the latter part of the twentieth century, with an addition that is about a decade old. BMS boasts a media center, four science rooms, an art room, a chorus room, a music room, a gym, and a multi-purpose cafeteria. All classrooms are air conditioned.



School Safety:

BMS emphasizes school safety through various technological capacities and extensive work with the local police department. The school CERT team trains regularly for crisis situations and works with local law enforcement to prepare for potential school emergencies. The school employs a SLEO III for the safety and well-being of staff and students.



Technology and STEM:

BMS provides each enrolled student with a Chromebook for educational use as part of a district 1-to-1 initiative, in addition to providing interested students with WiFi hotspots to ensure connectivity outside of the classroom. Digital Citizenship is offered as an elective. The BMS Robotics team competes at both Liberty Science Center and TCNJ with age level peers.
