







Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). Note that some teachers may teach in multiple subject areas and may be counted more than once in this table, or they may only be counted in their primary subject area. Technology and STEM:



Somerville High School has been named as a Top STEM HS by Newsweek and has been awarded a grant from the NJDOE to increase our offerings, including AP Computer Science Principles. In addition to a robust Robotics program, technology and STEM programs include: Game Design, Cybersecurity, Project Lead the Way Engineering Program, 21st Century Experience, Computer Programming, and IOS Application Development. In addition, students enrolled in Science, Engineering, and Digital Design courses have been given access to VDI sessions on their Chromebooks so they can access Windows based resources to complete projects beyond class periods. Somerville High School staff and students are provided with Chromebooks allowing them access to digital resources during school, at home, and throughout the summer.

Somerville High School has implemented several strategies that have successfully improved student attendance. These include monthly communication with families to provide updated attendance reports for their child and one-on-one meetings with students who show a pattern of absences. Additionally, regular class meetings are conducted to emphasize the importance of attendance and outline the consequences of exceeding the allowable number of absences.
