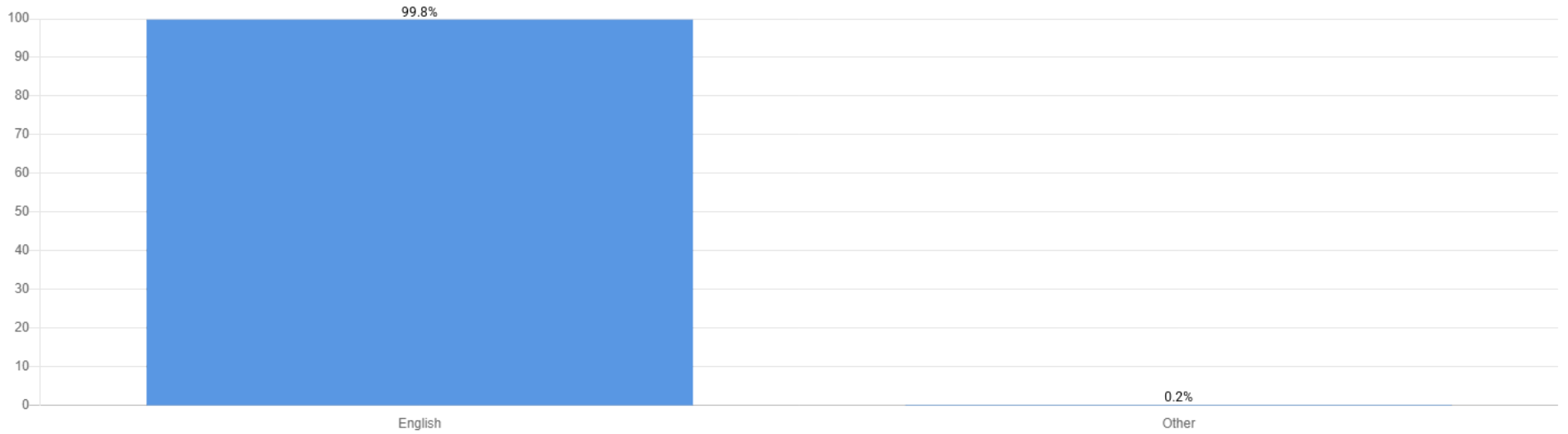

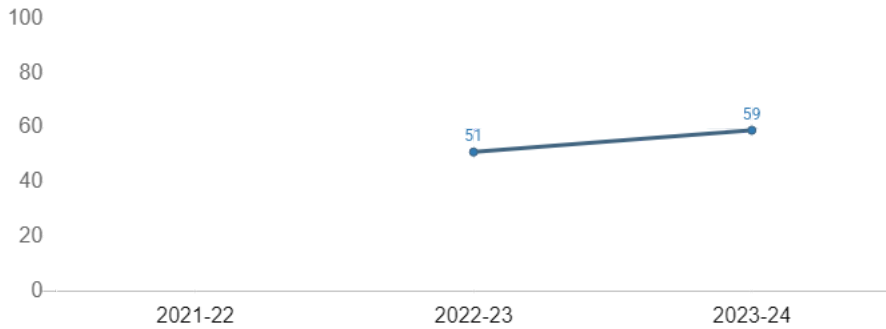

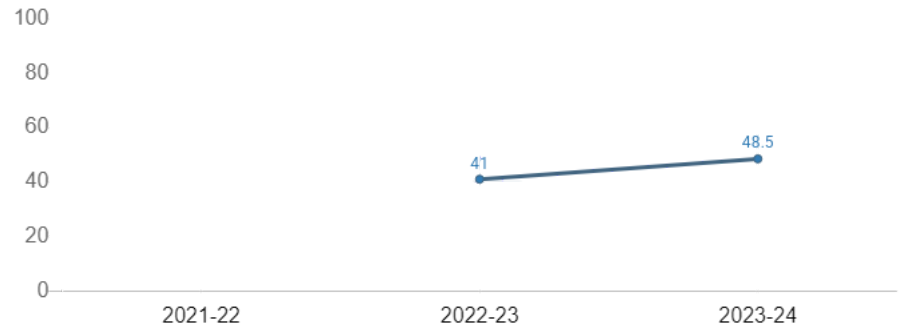

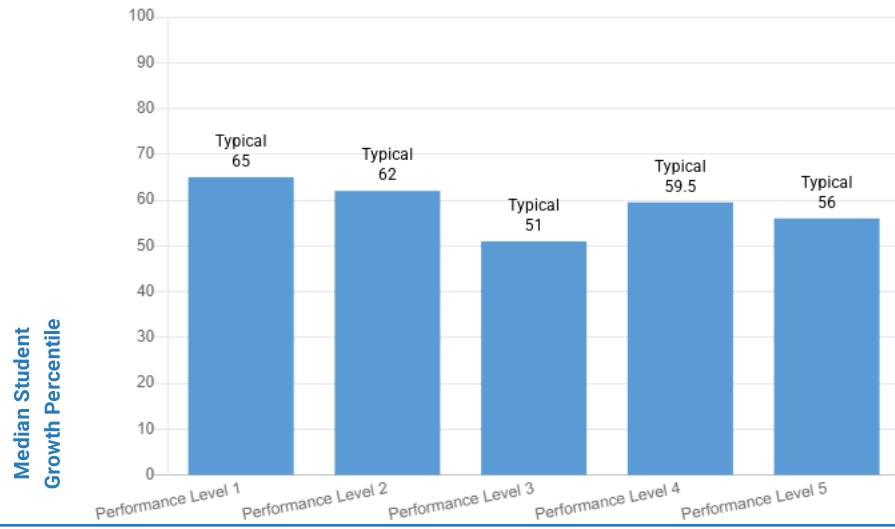

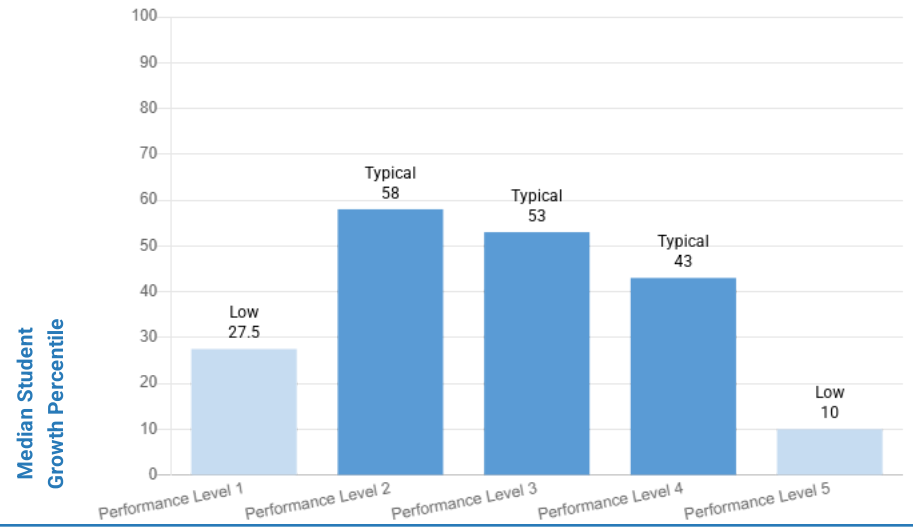

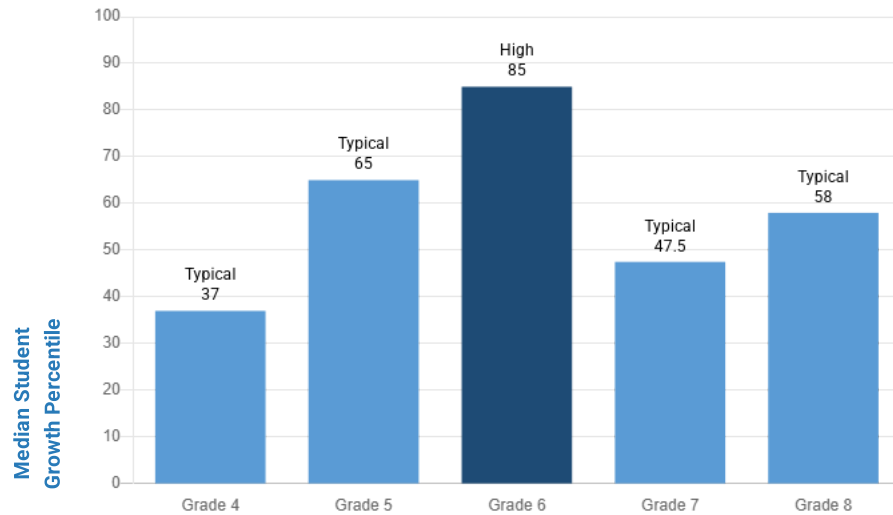

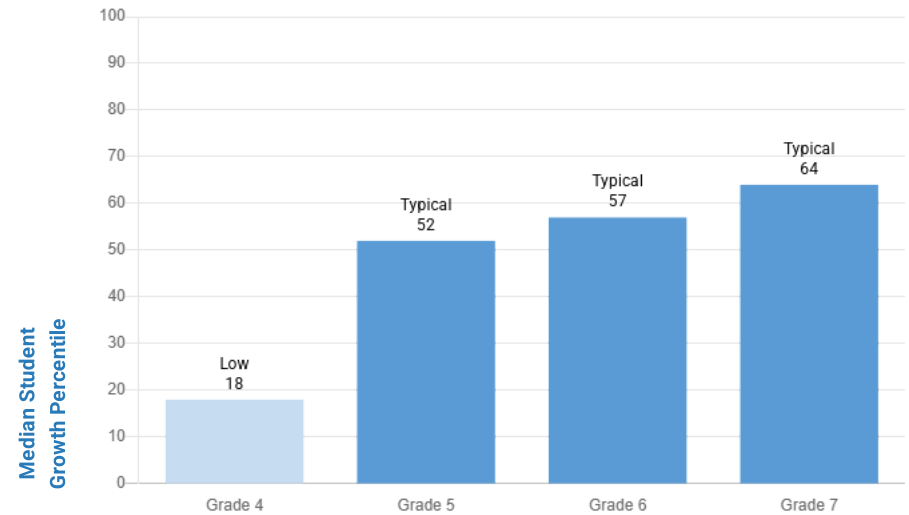

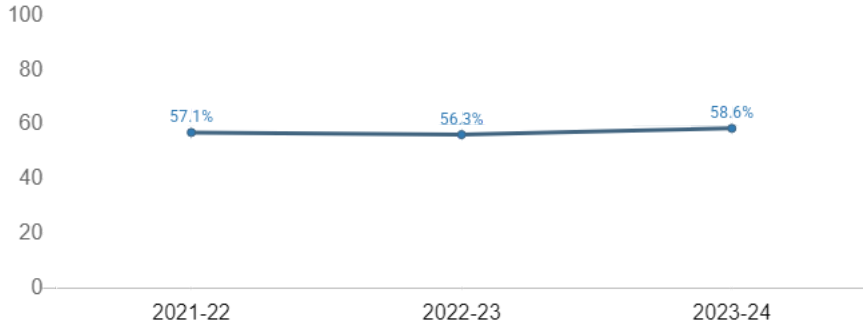

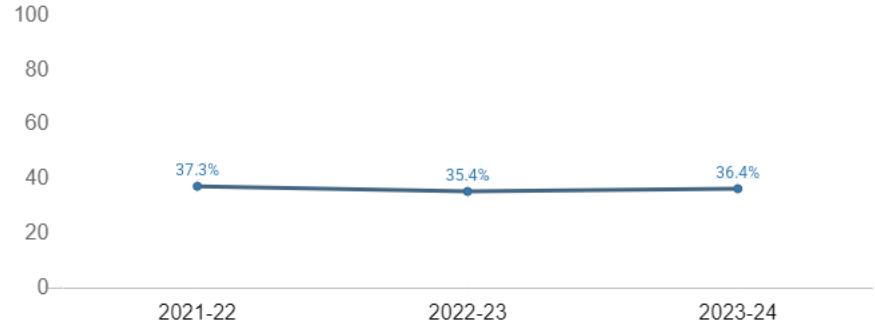
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 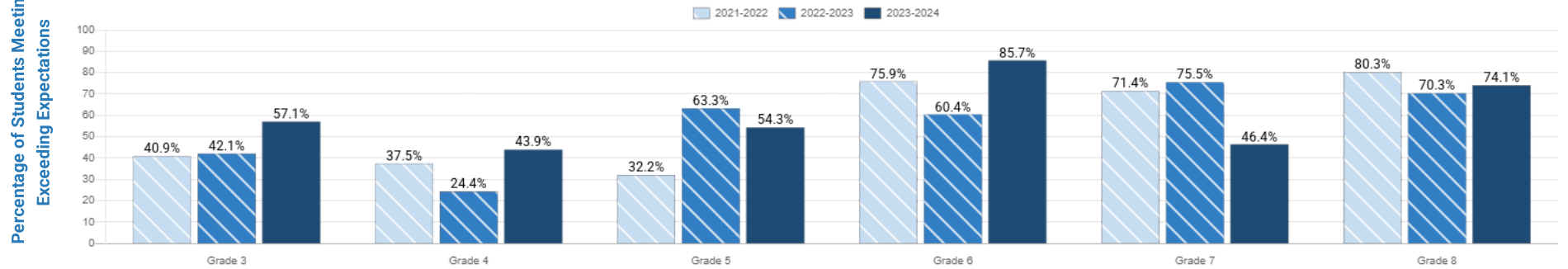

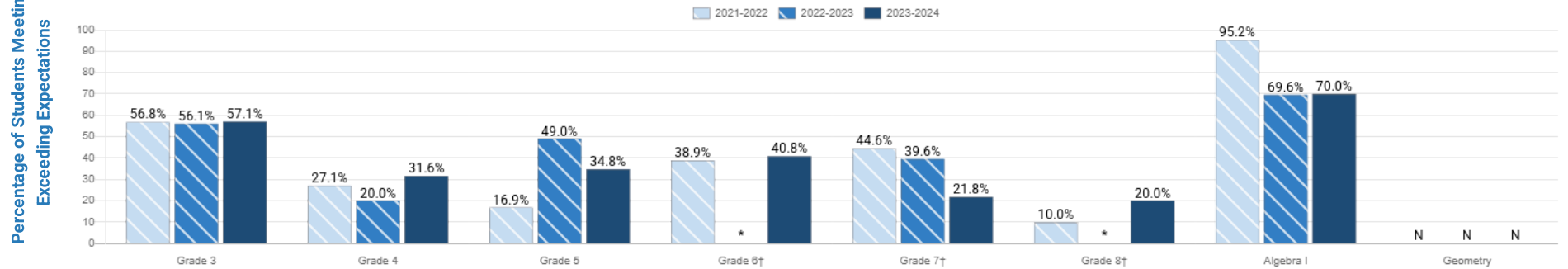

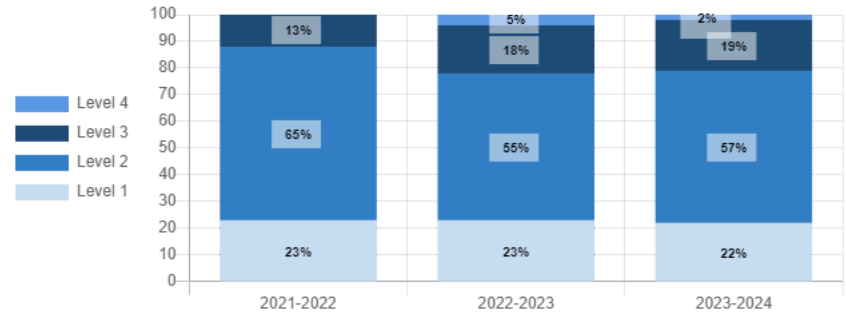

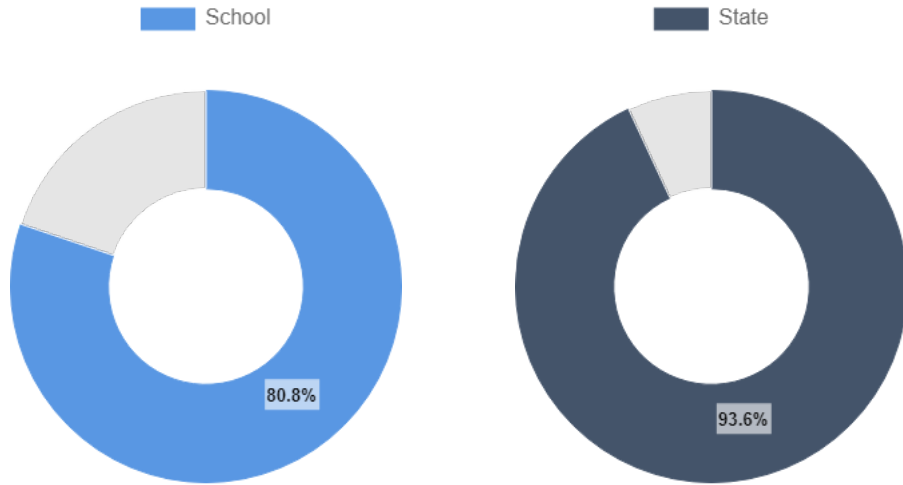

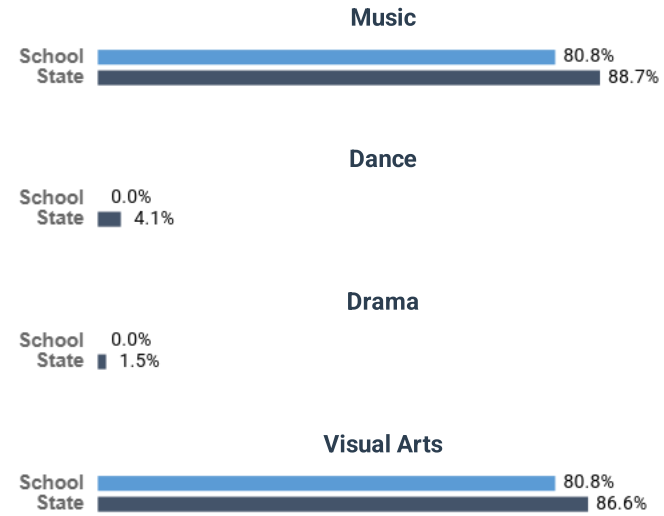

Students enrolled in one or more classes by discipline:



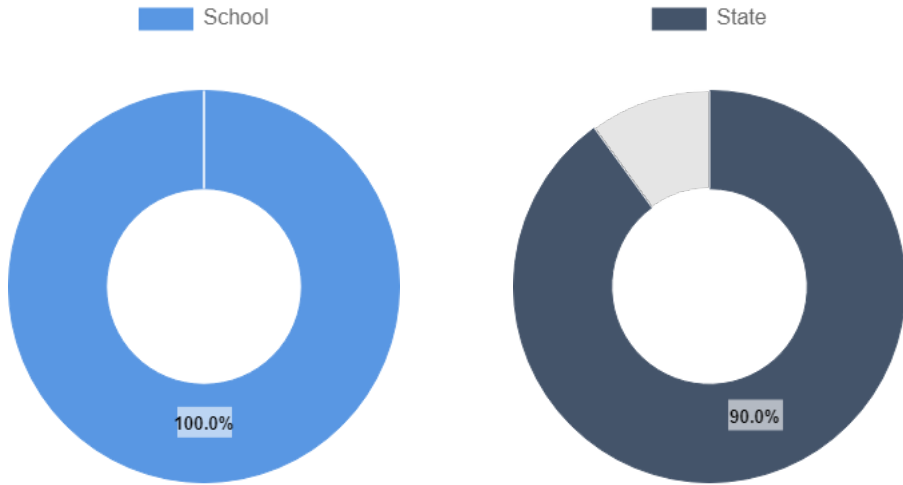

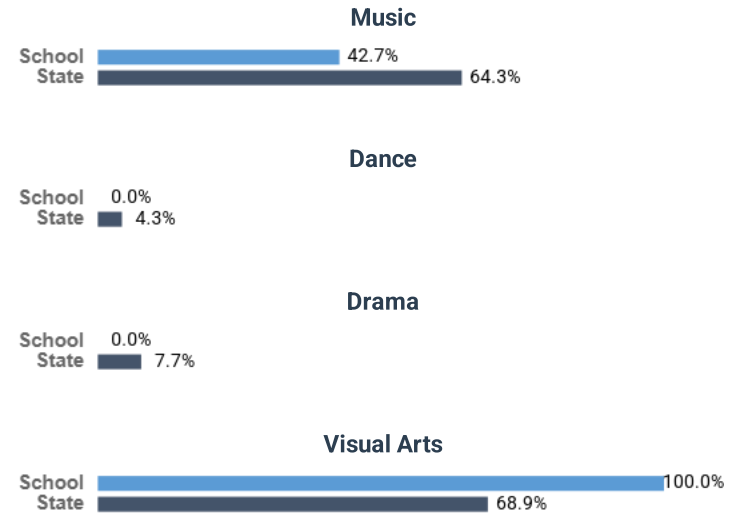

Students enrolled in one or more classes by discipline:



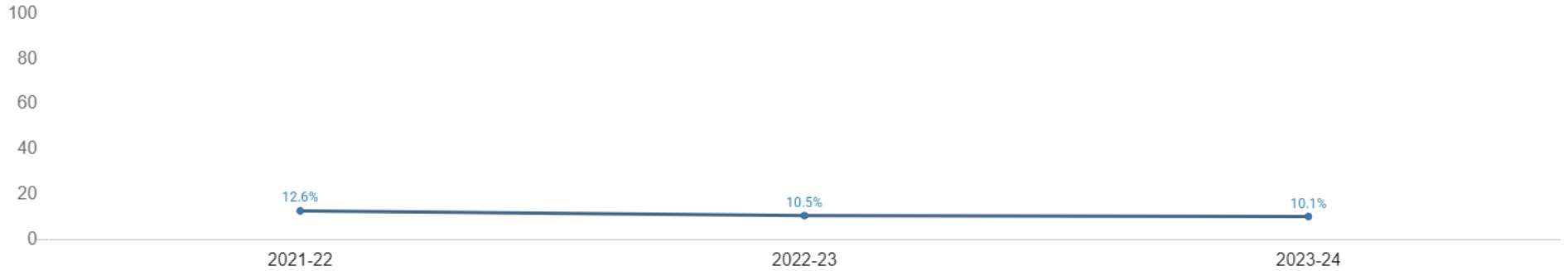

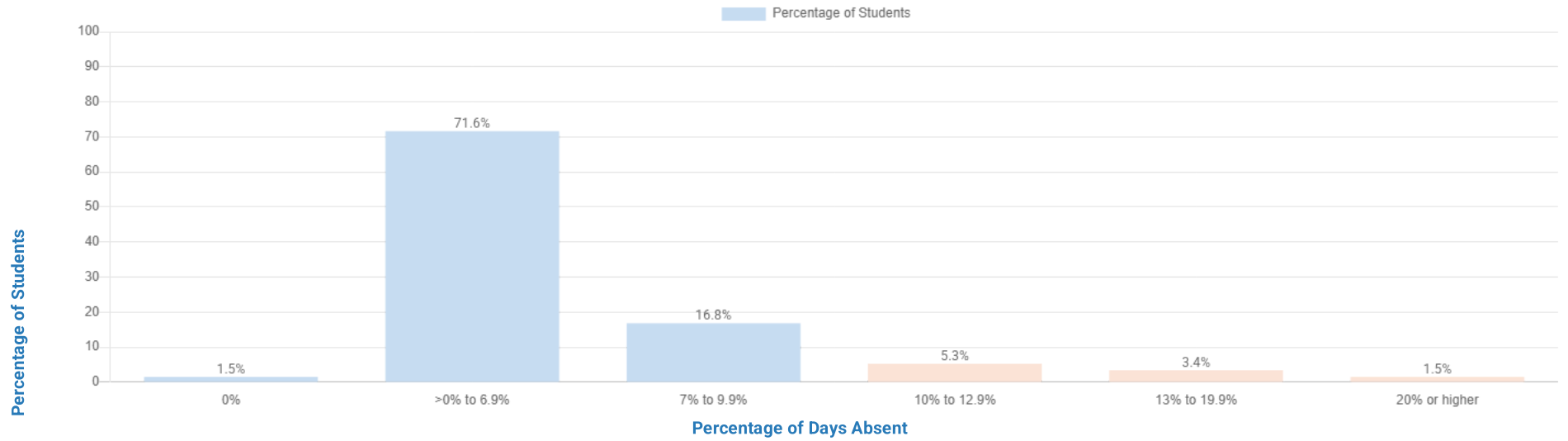

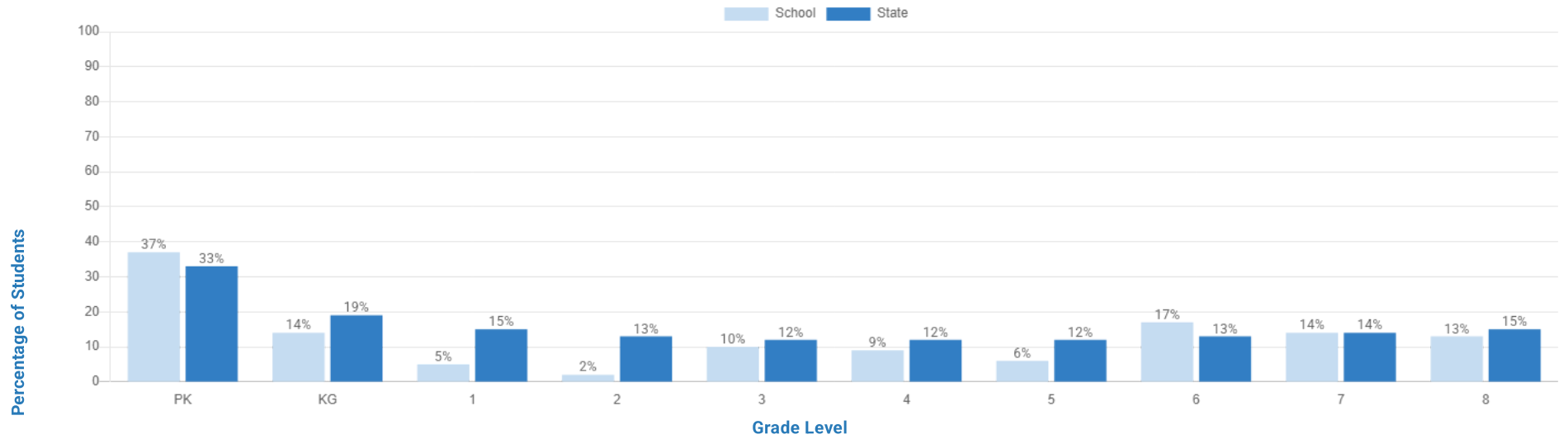

For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 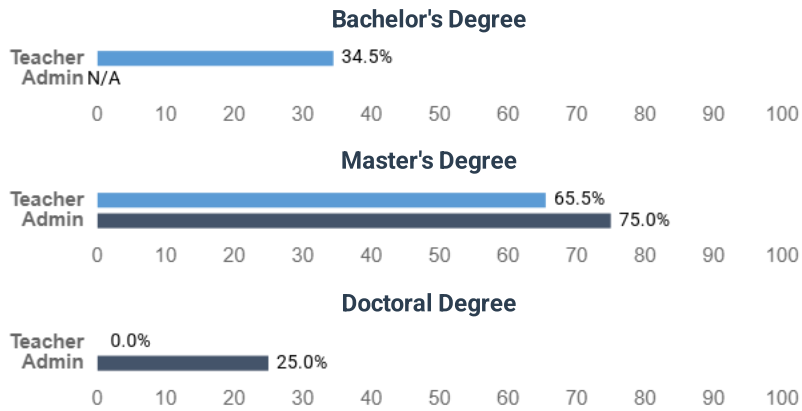

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Our faculty and staff conduct collaborative team meetings with teachers and administration to design and implement interventions and strategies to address students learning, behavior or health needs.

Student Health and Wellness:

Our School Nurse conducts typical health screenings of students throughout the year, as well as training for staff with regard to emergency equipment, diabetes, asthma, epilepsy, communicable disease prevention, infection control and concussions. Implemented with our food service company, our cafeteria staff are alerted for students with allergies and food sensitivities. Frankford offers a Flu Clinic to staff and families annually. We collaborate and partner with community groups to assist needy families with backpacks, school supplies, clothing, food, activities, etc. throughout the school year. We conduct various student assemblies i.e. Dental Health, Fire Safety Week, and other age appropriate programs.



Parent and Community Involvement:

Special Education Parent Advisory Group - Parents and staff collaborate to implement programs/goals that will enhance our school for the benefit of the children's needs. The OnCourse Connect parent portal is readily available for parents to have detailed information on their child's academics and progress towards goals and objectives. We post information regarding local partnerships and organizations to our website and social media channels, as well as in our weekly Bulldog Bulletin broadcast to families and staff. We have a very active PTA and partner with parents on a continual basis. Events such as Back to School Night and Parent Teacher Conference Nights continue to strengthen teacher/parent/student partnerships. Additionally, we host a Title I Parent/Community Information Session at the beginning of the school year.

Facilities:

We are currently working on projects to enhance our roof and sewer systems. Recently, we had new, state of the art boilers installed through the NJ Direct Install program, saving the district over \$700,000. New drainage was recently installed in the parking lots, and we have made many improvements to our building and grounds, including new backstops on our baseball fields.



School Safety:

The safety and security of our schools is our number one priority in order to make sure that we are providing the safest environment possible for our students. We annually update our school security procedures; we annually provide training for our staff; and we work closely with the NJ State Police, Sussex County Sheriff's Department and local fire departments. Security, lock-down, evacuation and/or fire drills are performed on a monthly basis. We employ a full time armed security officer.



Technology and STEM:

All Middle School students are issued their own chromebook at the beginning of the school year. We offer laptops and tablets for students to access, utilize and support their learning. Google has been implemented to serve as a communication and collaboration tool. We are using web-based technologies to guide instruction. IXL, MobyMax, Gizmos Science, Reading A-Z, Brainpop, etc. We have implemented robotics for students to gain initial experience with coding and engineering, and all teachers recently participated in PD related to using Artificial Intelligence in the classroom.

Early Childhood Education:

For a tuition fee, we offer a general education preschool program. This program was created to provide an inclusion opportunity for our Preschool Disabled class. We therefore have a limited number of seats available and often use a lottery system for selection. Children in the district who are age 4 by October 1 of the current school year are eligible to attend this 5 day per week program; 2.5 hour sessions each day.
