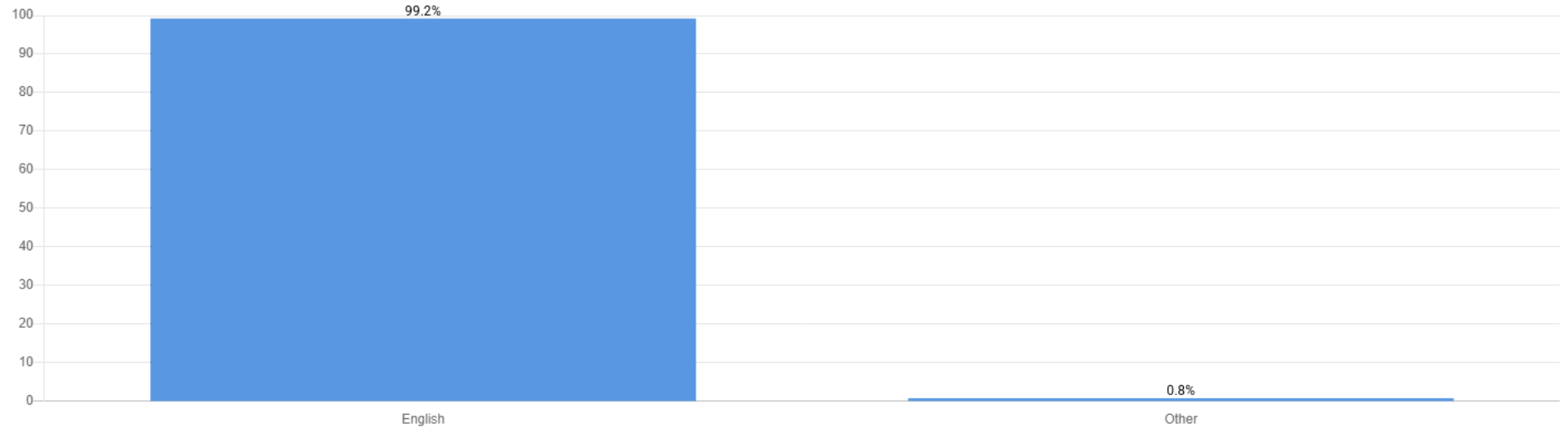

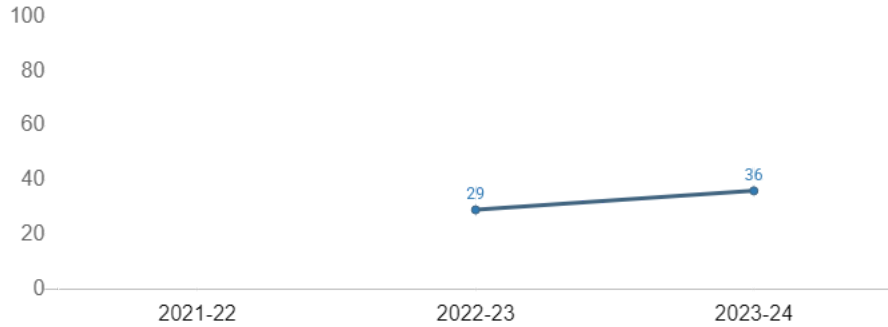

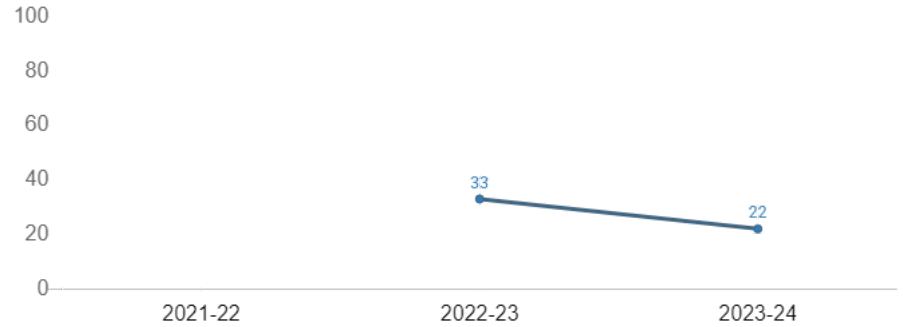

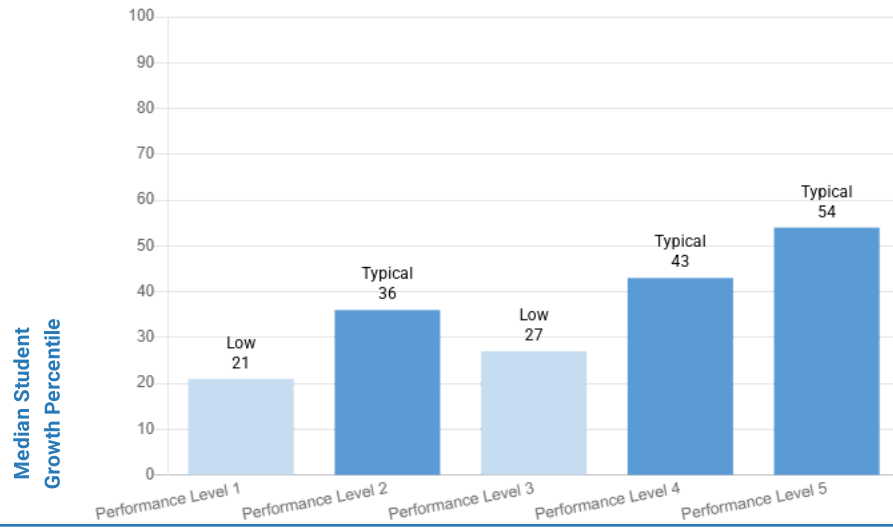

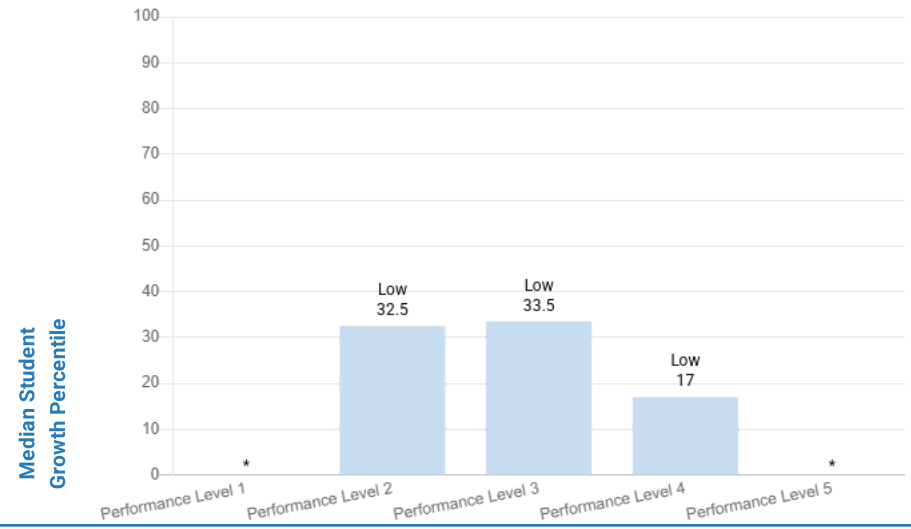

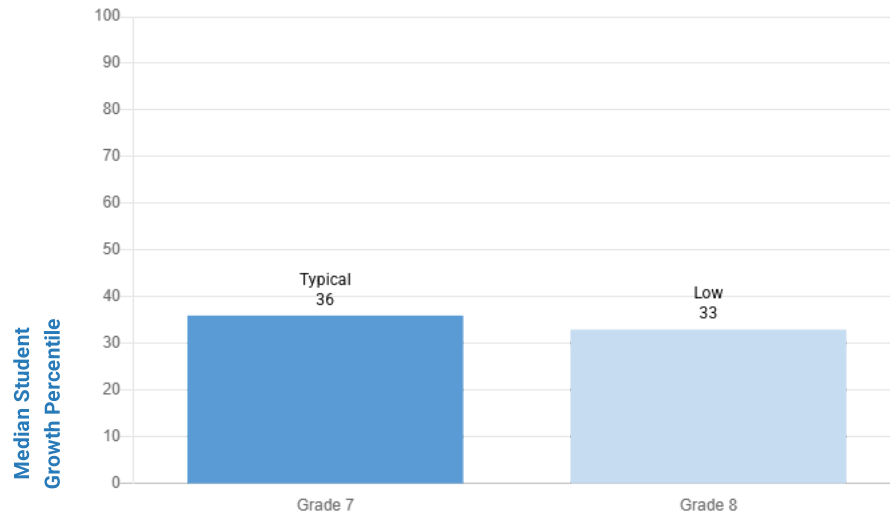

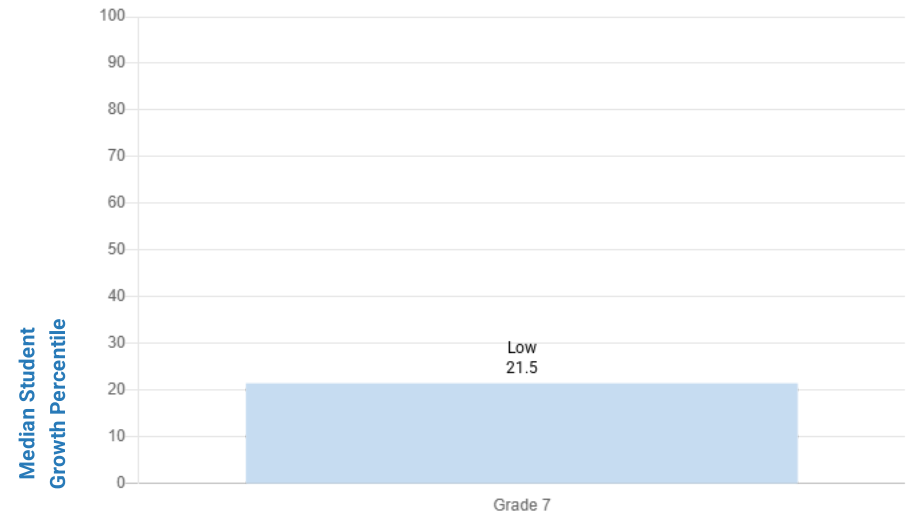

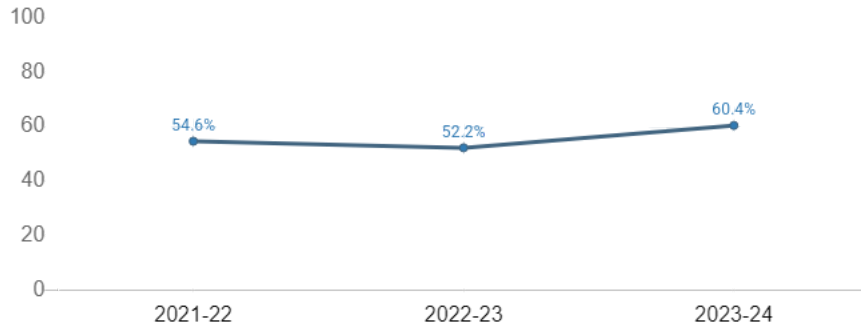

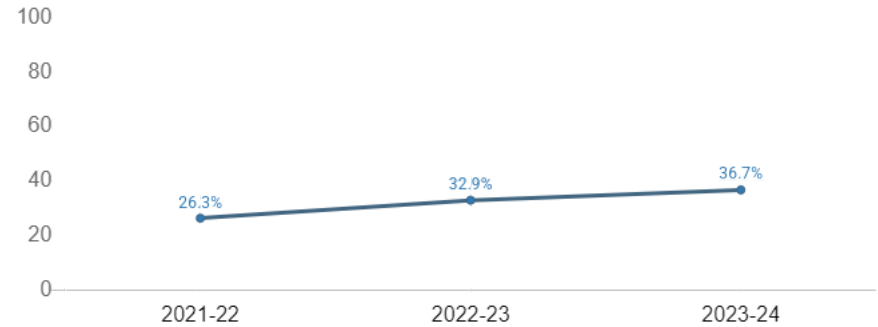
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 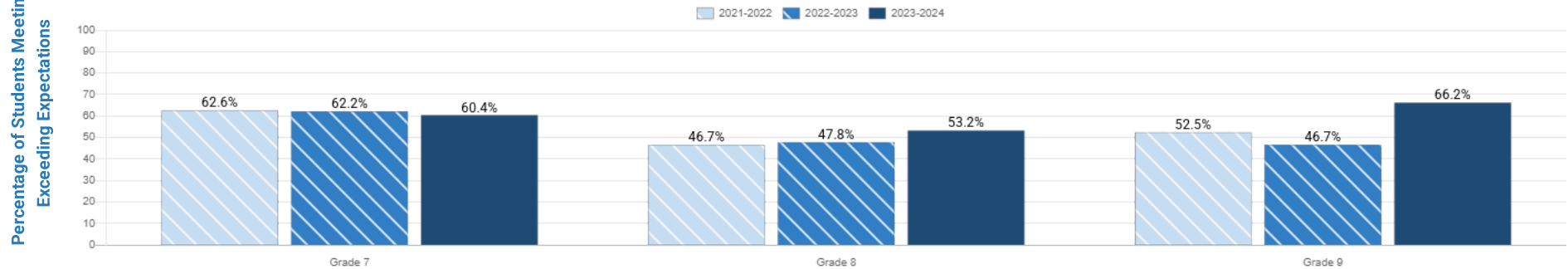

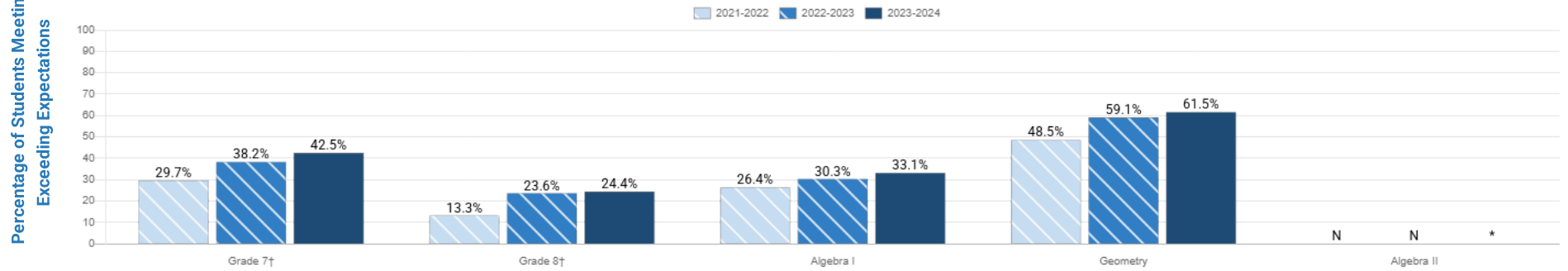

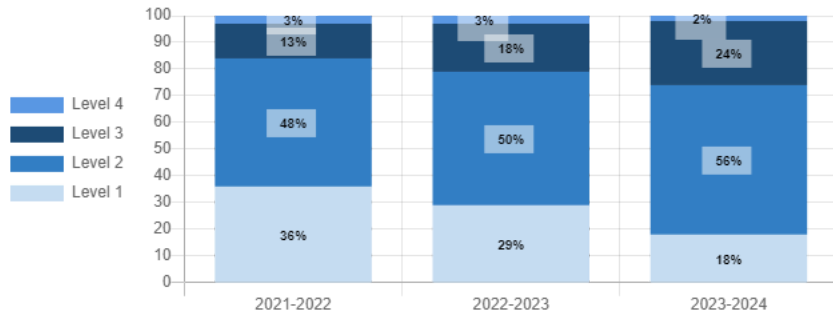

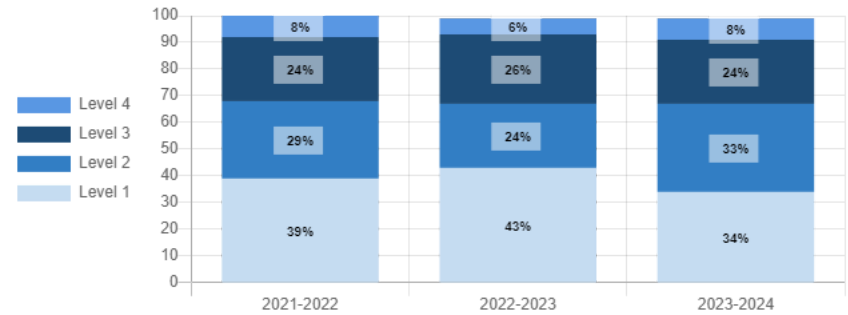
NJSLA Science Assessment: Grade 8 Summary

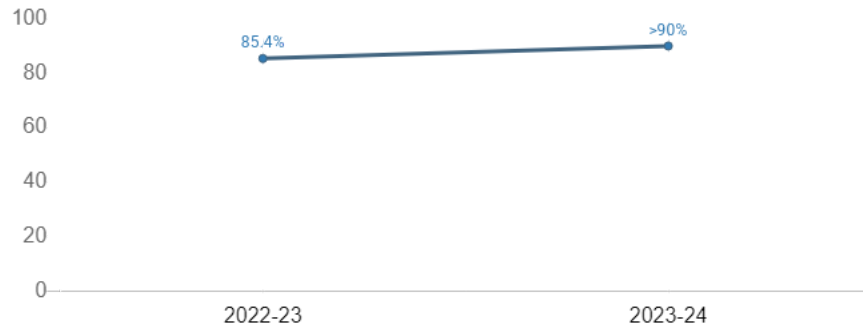

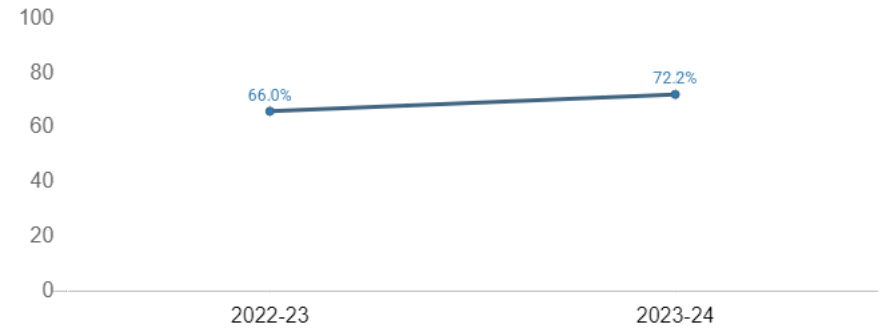

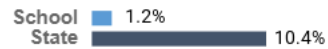
CTE Participants

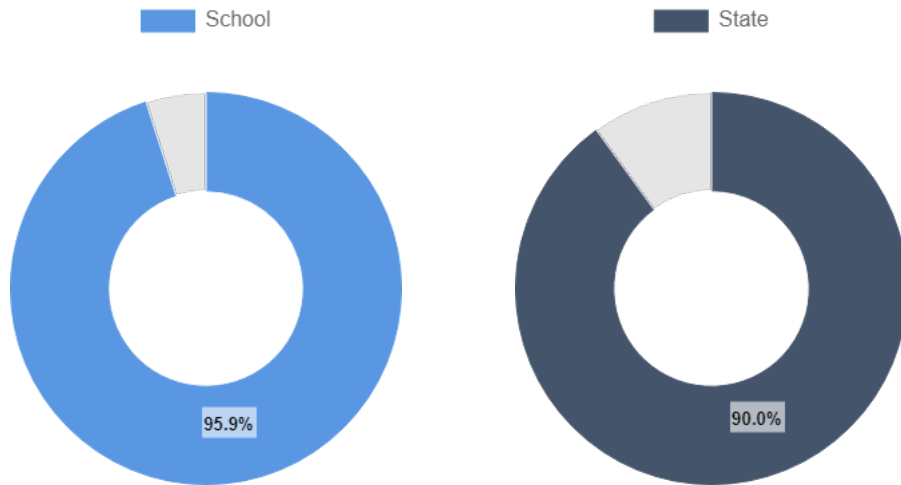

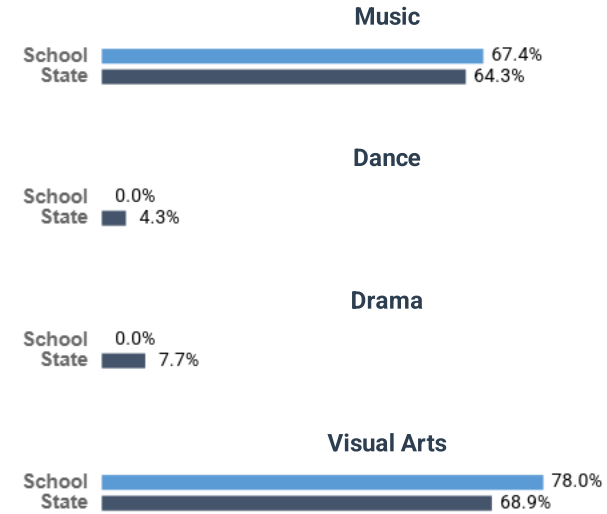

Students enrolled in one or more classes by discipline:



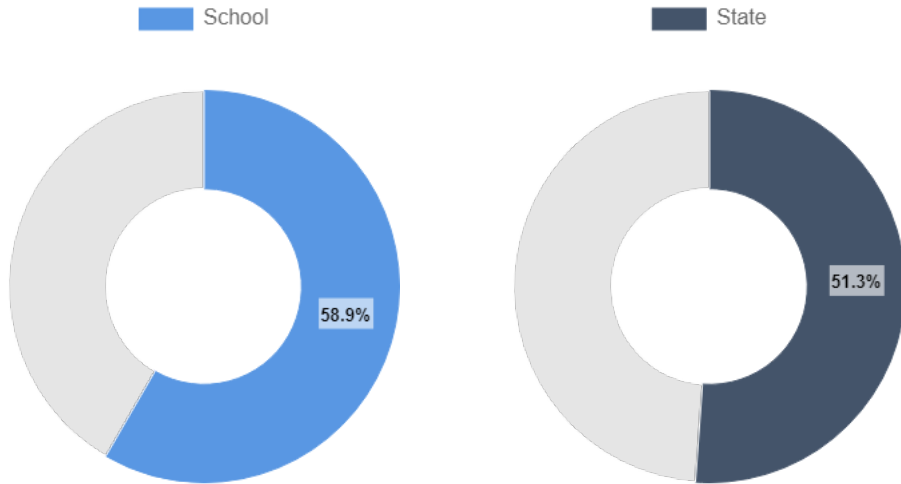

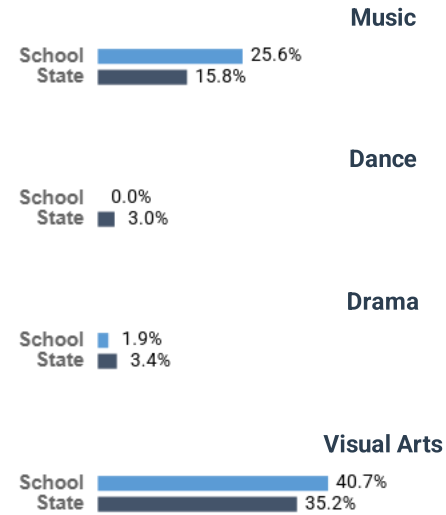

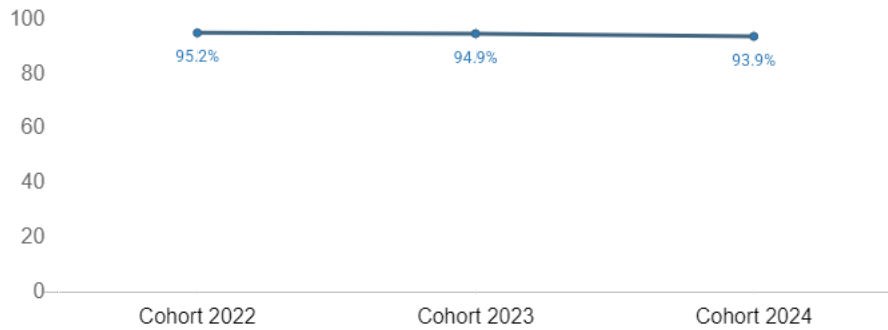

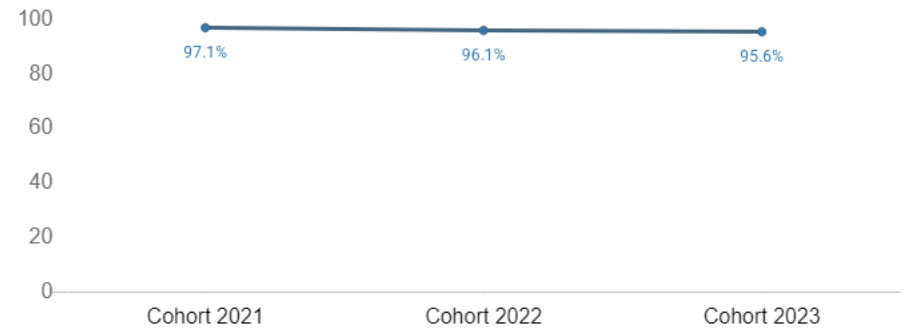

Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modification or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

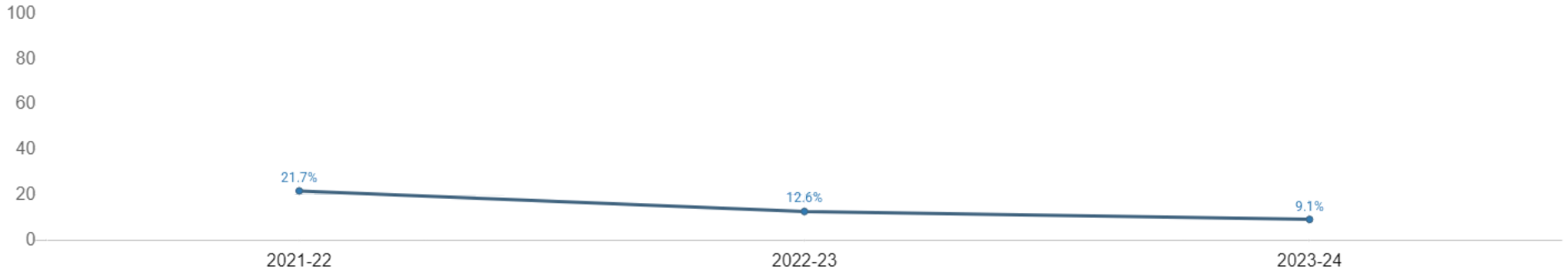

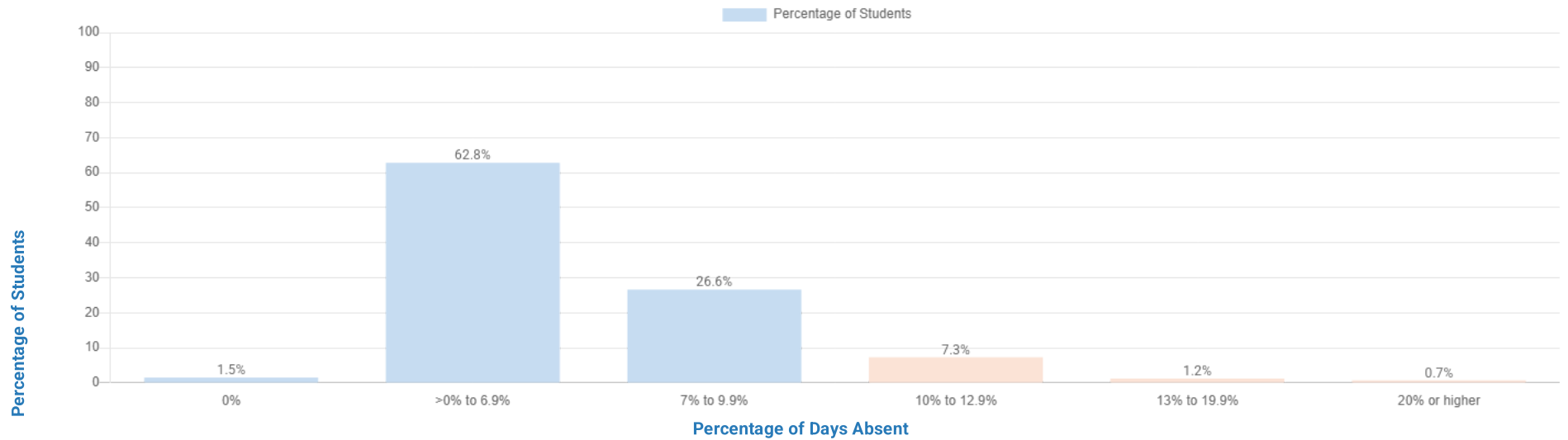

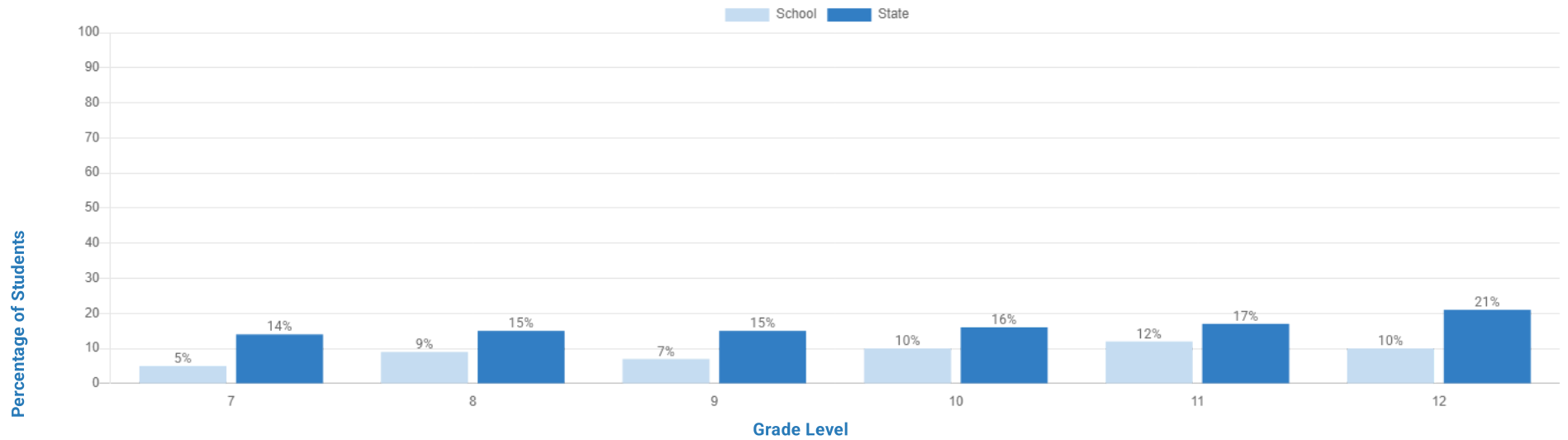

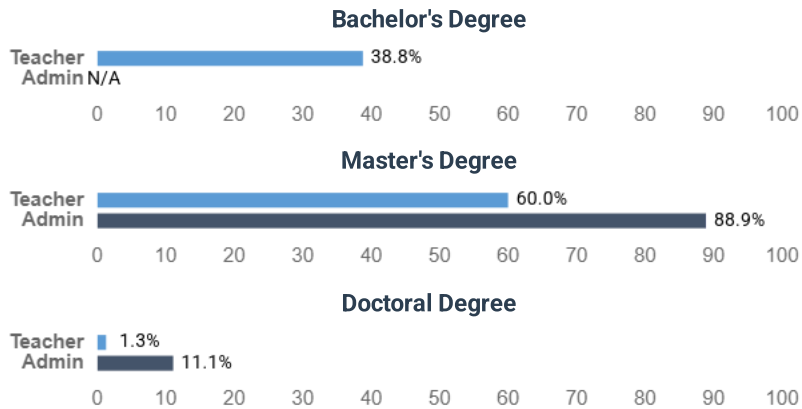

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. The Response to Intervention team determines the needs of the students, develops and implements a plan to target specific areas of need, and monitors academic progress. If necessary, a student can be referred to the Child Study Team for an evaluation. The goal of the Kittatinny Special Education Department is to deliver quality education to students with special needs through a continuum of services in a least restrictive environment. Special services available for students with disabilities include In-Class and Pull-Out Resource; Learning Language Disabilities, Post-Graduate Life Skills, and Extended School Year programs. Community based instruction and structured learning experiences are offered based on IEP goals. The department also runs a Homework Program and Social Skills Clubs to support students after school.



Student Health and Wellness:

Mens' Social Skills Group, Womens' Group and Girls Group. Forty minute Physical Education classes are provided daily to all students. Interact Club assists families in need by providing Thanksgiving dinners. Yna Said Fund helps students that have experienced a life altering trauma or are in need of assistance. Community Awareness Night providing information on topics such as suicide awareness and prevention, autism, alcoholism, and many more. Red Ribbon Week spotlighting drug prevention. Pass It Along does workshops with students with regards to developing pursuing passions and social-emotional learning. KRHS partners with Victory Road Leadership for student leadership training.

Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. Kittatinny's Climate and Culture is one based on respect and understanding of all staff and student body. Students on the JRHI level are involved in monthly Character Ed classes that touch upon topics such as respect. Cross Age is a program where our JRHI and HS students visit our sending districts to discuss relevant topics pertaining to Character Ed. The Golden Rule, Empathy & Compassion, Gratitude and Paying It Forward. We have a very strong Peer Leadership Program where our older HS peers visit JRHI classes each Friday to encourage kindness and respect as well as fostering fellowship and mentorship. This program is a peer to peer teaching model. We offer Men and Women Groups that teach social skills and good decision making. Our School Social worker offers web based seminars pertaining to the following: Diversity, Leadership, Peer Interaction, Positive School Climate, Navigating the world and empowerment. Our Welcome Back Assemblies remind our students of proper school rules.



Facilities:

KRHS was established in September 1975, grades 7-12. A regional school which serves five townships in the Newton, N.J. area of Sussex County: Fredon, Stillwater, Hampton, Sandyston and Walpack. KRHS is a choice school, in a primarily rural area. The fall enrollment is approx. 735 students (approx. 509 are grades 9-12) the current senior class has 146 students. The facility features a library/media center, which focuses on research & collaboration, a STEM room; home to our state-of-the-art robotics classes, an engineering room, woodshop, CAD Design center, art rooms, business centers and a clothing room. The school has a dedicated and auxiliary gymnasium and a JRHI multipurpose room. A weight room & fitness facility is available to serve all of KRHS students. KRHS has an expansive campus, with numerous athletic fields and a regulation track. KRHS has recently invested over \$3 million dollars to upgrade and improve the district wide HVAC systems for a healthy indoor air environment.



School Safety:

KRHS employs one security officer, who is in the building throughout the day. A School Resource Officer from the NJSP is at the school daily. The security officer works after hours, including school sporting events and activities. Multiple staff members monitor the crosswalks, parking lot, door entrances, and cafeteria. Signage identifies different areas of the building, while featuring video surveillance, alarm system, student and staff issued ID cards, two panic alarms, an outside strobe and assigned parking. Visitors are required clearance through Lobby Guard. Our Safety officers & staff constantly assess perimeter security, conduct monthly safety drills and continually assess our security protocols & equipment. Administrators are trained on the bleeding control kits in the building. A closed circuit video surveillance suite serves to protect staff and students and gives the administration and security staff immediate access to all areas of the facility and grounds.

Technology and STEM:

Kittatinny's 1:1 Chromebook initiative and campus wide Wi-Fi access creates a technology rich learning environment. Classrooms are equipped with interactive tools like Promethean, ViewSonic, Smart Boards, Smart TV's, iPads, and Raspberry Pi devices. Adobe Creative Cloud, Python Coding, CAD, Animation, Steam Connections, Engineer systems, Control Technology, Digital Photography/Video, and a dedicated maker space are curriculums that students are encouraged to explore. These curriculums and technologies allow students to engage with real world STEM applications. Kittatinny's STEM courses feature a 90W laser cutter, vinyl cutter, large format printer, and multiple 3D printers. Teachers receive professional development to integrate STEM into lesson plans that create engaging lessons that connect classroom learning to real world skills.



Attendance:

KRHS has utilized available ESSER funds to close gaps in technology, provide students with extra academic support and bring in guest speakers to address topics such as work ethic, communication and social behaviors. While the pandemic has contributed to learning loss across the country, KRHS has utilized LinkIt software to provide additional data to pinpoint areas of improvement. After school remediation programs were also implemented. KRHS has also provided summer programs to supplement instruction in Math and English Language Arts. Grade-level workshops have been run to support mental health and behavioral needs of students. Guest speakers, as well as targeted programs, were introduced at all grade levels to support student mental health.

Other Information:

KRHS is a grades 7-12 choice school that operates on a nine period day. Kittatinny has received many awards in the area of technology. The Board of Education, administration and faculty of the Kittatinny Regional School district have dedicated many hours of resources to the infusion of technology into the everyday curriculum. Kittatinny has invested in a next gen Sophos Firewall, Cloud Managed Meraki wireless access points with advanced security and performance WIFI. Kittatinny provides all students with Chromebooks that are used for academic instruction. Kittatinny operates on a Combination of Microsoft and Google platforms, with half of the computer lab used for instruction to Intro to Python and the AP Computer Science Principles class. In addition to the computer labs, the school features a full computer animation lab, video graphics, design lab, STEAM and robotics lab, journalism lab and two business labs. KRHS has also implemented a College and Career Readiness course in which students explore the vast array of college and career options available to them. We have over 1,000 Chrome devices. We have mobile carts and stationary machines that are available for student and staff use throughout the day. Our Media Center has 3 collaboration rooms that are all equipped with an interactive projector, PC and Chromebox. The Media Center also has a Promethean Active wall presentation area for large presentations. The Media Center also features three large open collaboration tables with a 65 inch display connected to a Chromebox.
