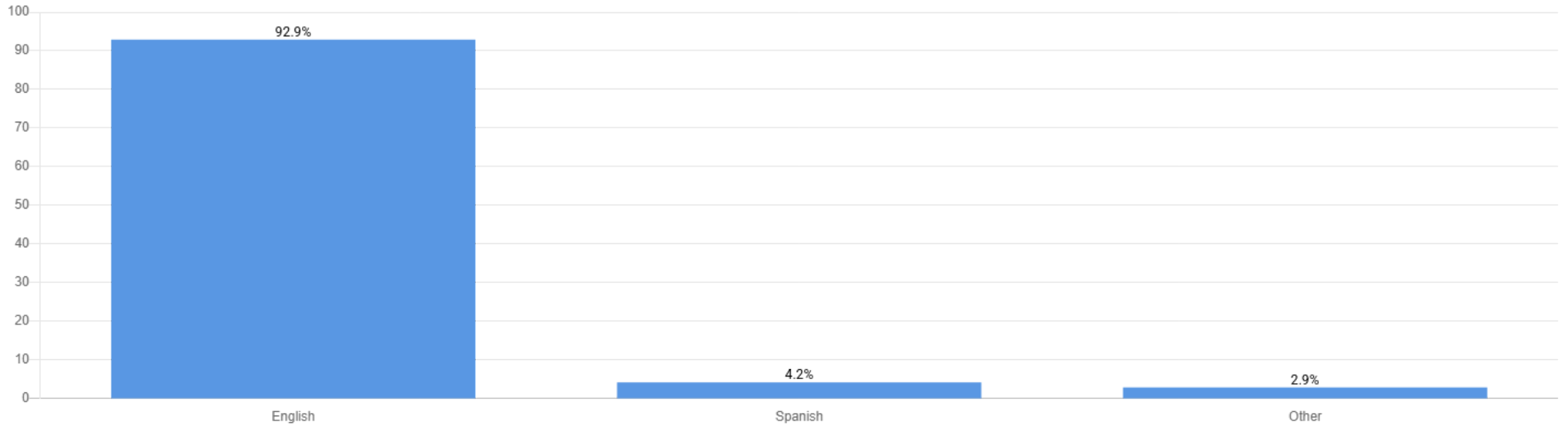

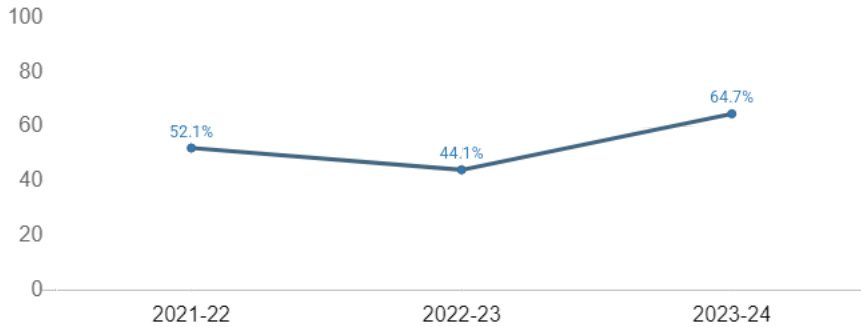

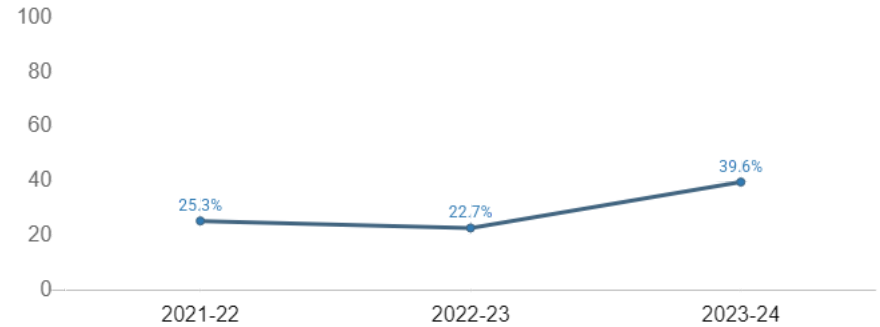
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 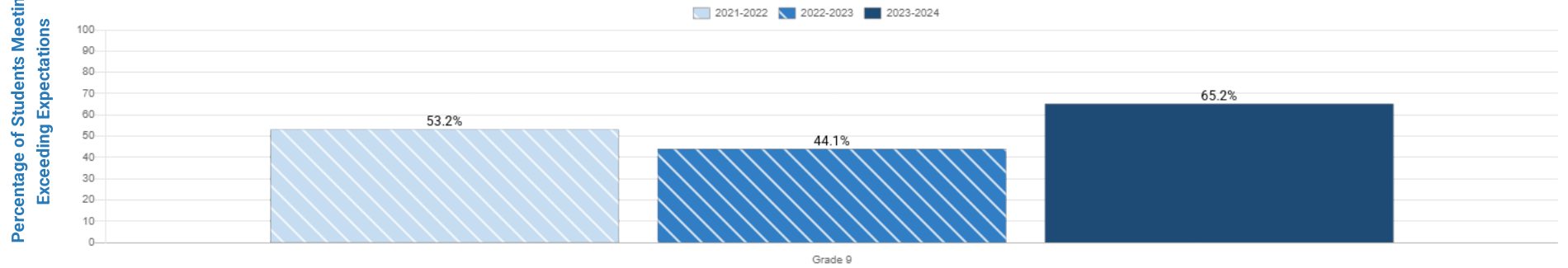

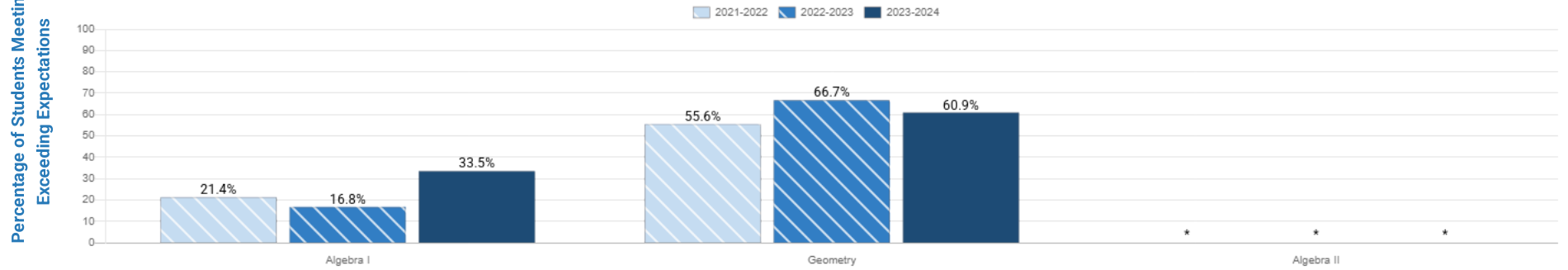

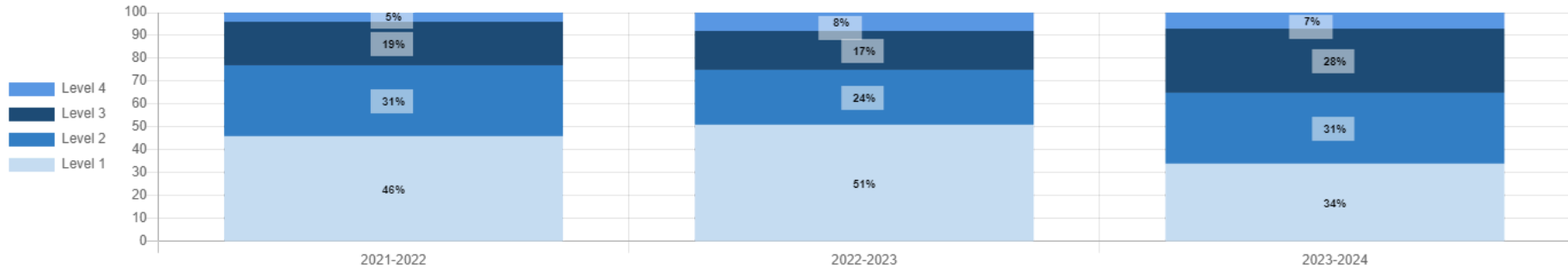

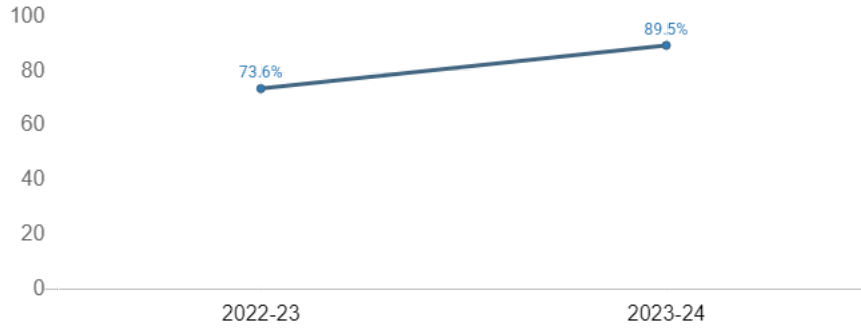

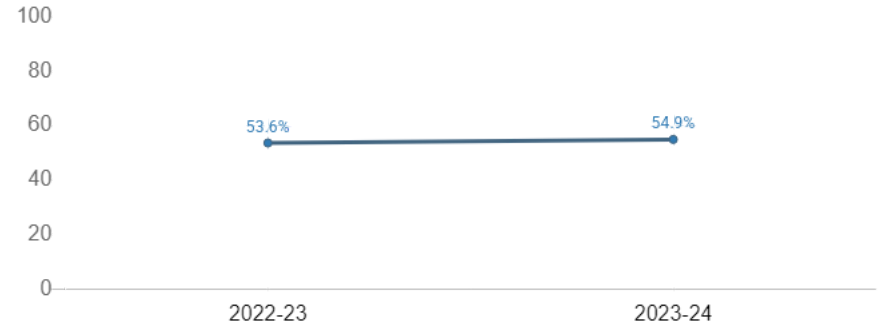

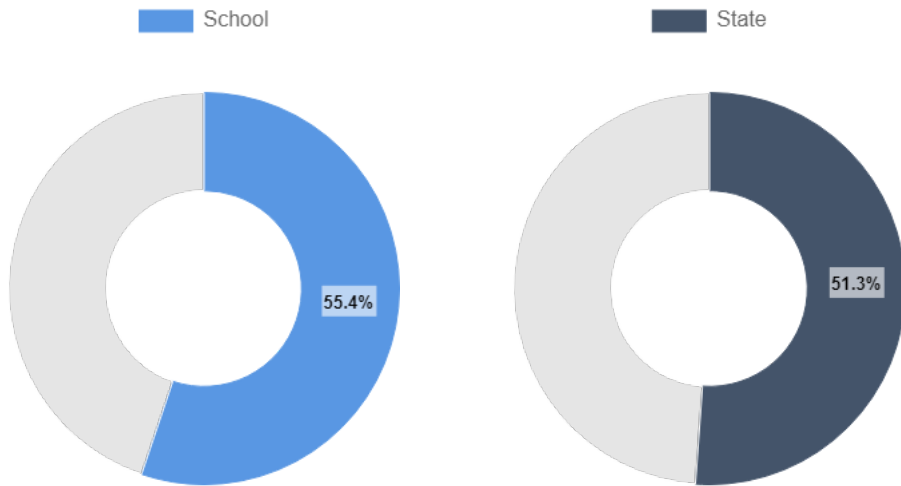

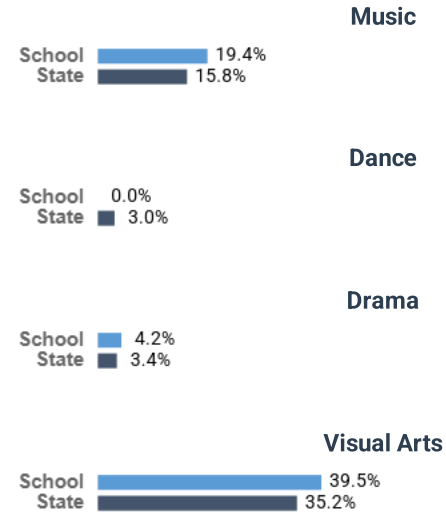

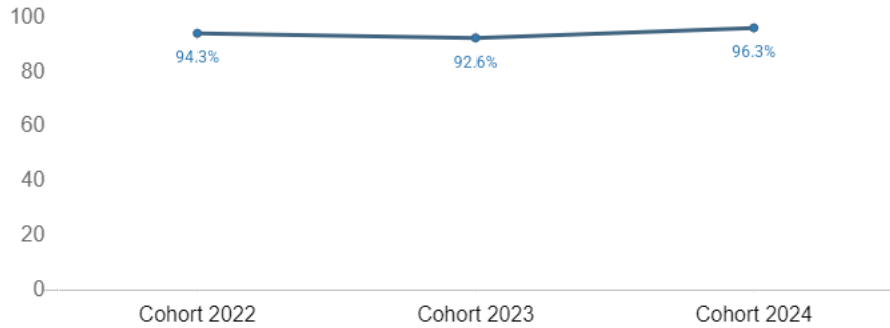

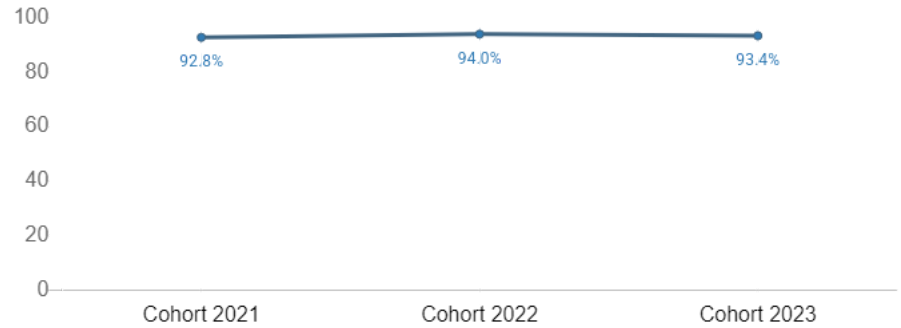

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

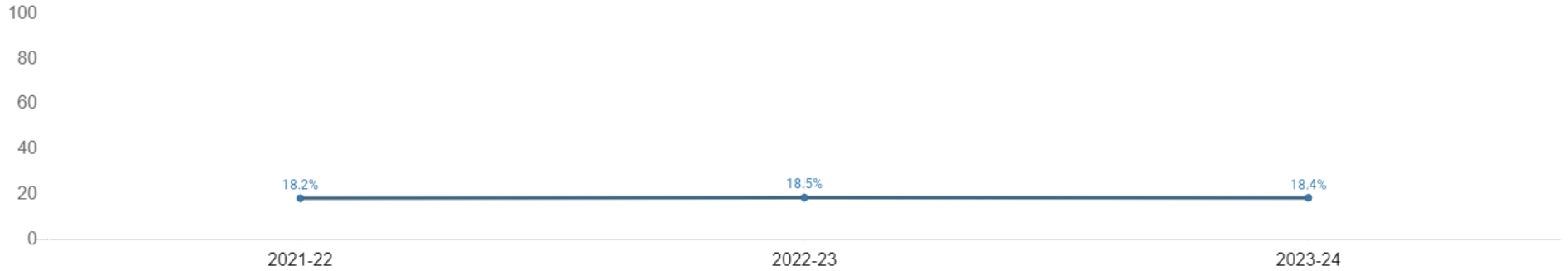

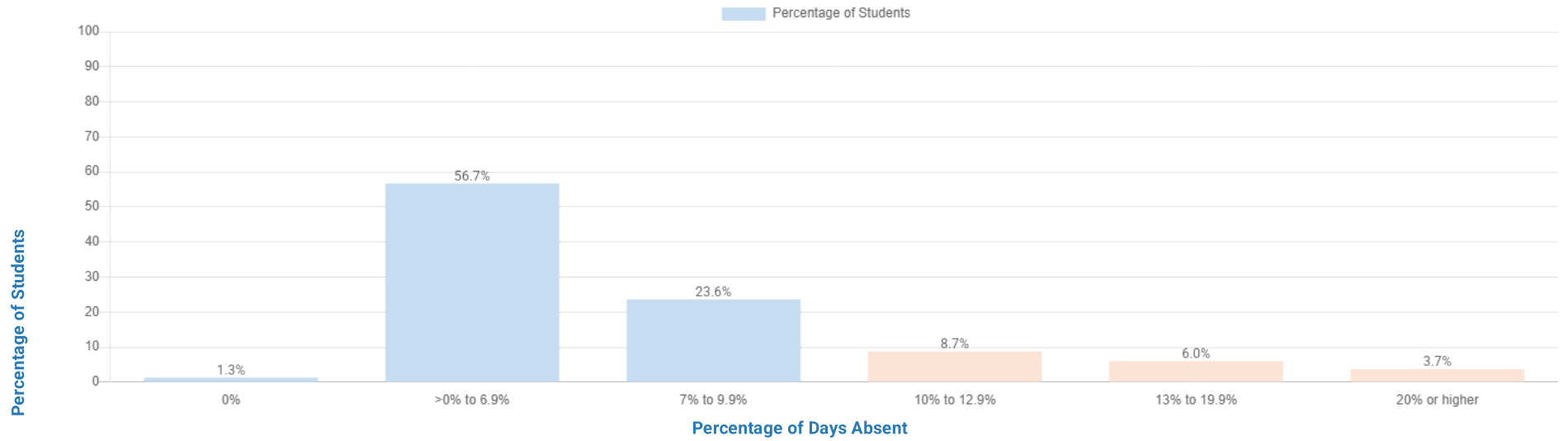

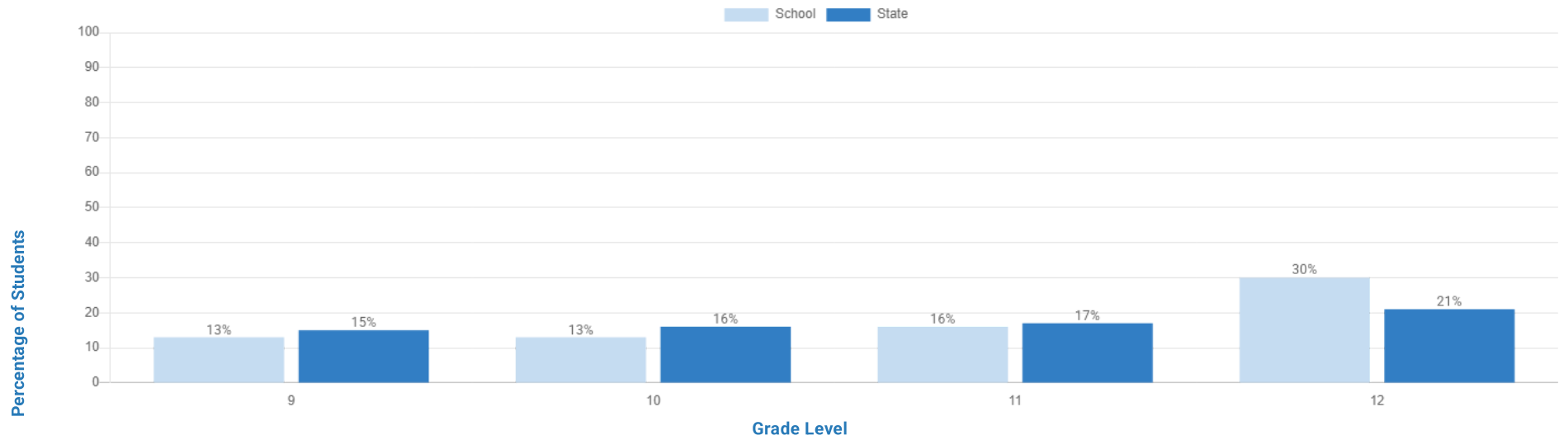

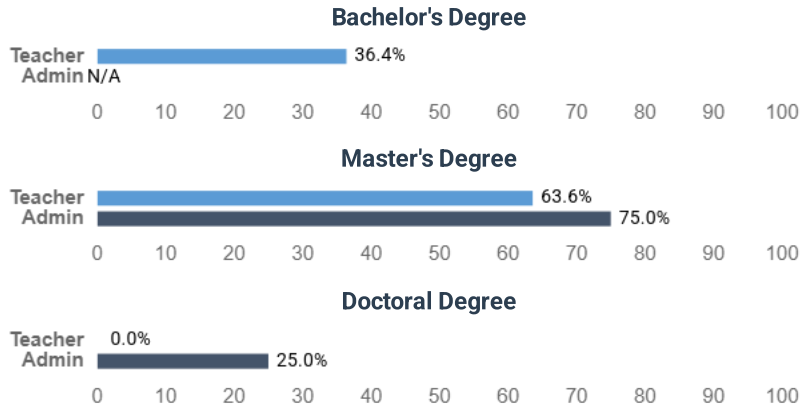

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Vernon Township High School (VTHS) offers multiple concurrent credit courses in partnership with prestigious universities, particularly in Career and Technical Education programs. The standard curricula in Math, Science, Language Arts, and Social Studies provide a wide range of Honors and Advanced Placement opportunities, challenging students to reach their full academic potential. In addition to rigorous academics, VTHS strongly supports the Arts, offering courses in Music, Theater, Graphic Arts, and Fine Arts. Students also have access to specialized programs in World Languages, Engineering, Graphic Design, and Robotics. Partnering colleges include Rutgers University, Sussex County Community College, and Seton Hall University, providing students with opportunities to earn college credits while still in high school.

Locally, Sussex County Community College and County College of Morris remain popular choices. Workforce: 17.9% have secured jobs in fields such as cosmetology, plumbing, HVAC, welding, and coding, showcasing workforce readiness. Trade Schools: 7.7% will attend schools like Lincoln Tech and Universal Technical Institute to gain specialized skills. VTHS has implemented several unique high school programs with the component of additional student support. Our Viking Success Academy provides an alternate setting that satisfies state graduation requirements. The Freshman Academy is a model 9th grade transitional program that provides a nurturing, team approach for students to succeed in their first year of high school. A Trauma-Informed Coordinator oversees student issues and collaborates with the certificated staff members. Outside counselors are provided by YAP (Youth Advocate Programs, Inc.).



Student Health and Wellness:

An annual health screening is provided to students in the Health Office. The school nurse also provides information on free clinics available in the county for students without health insurance. Maschio's food service provides meals that are appropriate to the health and wellness of our students. Nutritional facts help students make reasonable, healthy choices.



Parent and Community Involvement:

Parents/Guardians are encouraged to be part of their child(ren)'s education through involvement in various organizations such as the School Community Association, the Viking Club, Vernon Coalition and Music, Theatre and Instrumental parent/guardian groups. Additionally, parents/guardians are provided with up-to-date information via the ThrillShare Apptegy service, the VTHS Digital Backpack, Freshman Orientation, Back-to-School Night, College Fairs, Parent/Guardian Conferences and the Genesis Parent Portal.

An extensive amount of data from students, staff, parents/guardians, and administration is collected and analyzed to determine school effectiveness. Topics surveyed include school social climate, academic rigor, peer interactions, staff effectiveness and availability, student safety, and parent/guardian involvement.



Facilities:

VTHS was founded in 1974 and will celebrate its 49th year of service to the community. Most recent facility updating included the student center and the student services suite. To align with the new CTE offerings, a Cosmetology Lab and Graphic Design studio were created. The Athletic Department boasts state-of-the-art sports facilities and a newly updated turf field and running track.



School Safety:

The Vernon Police Department has a School Resource Officer assigned to all schools and a Memorandum of Agreement is in place. VTHS has two armed, retired police officers assigned at all times when school is in session. VTHS has a 24-hour camera system which records the interior and exterior of the school and the cameras archive video for 30 days. VTHS has 2 layers of security at their entrances with all doors locked and monitored. Raptor Visitor Management software and hardware is utilized at VTHS to monitor visitor ingress and egress. VTHS conducts a minimum of one fire drill per month and one security drill per month. The security drills consist of the state standard for active shooters, non-fire evacuation, bomb threats, lock down and table top exercises. The Vernon Police attend security drills. In addition, students who intend to drive on the VTHS campus must partake in the Share the Keys program, which is offered in conjunction with the Vernon Police Dept.

Online assessment tools are utilized daily and our CTE programs utilize systems of technology to enhance their instruction. Each classroom also has a BenQ board to enhance the classroom experience.



Attendance:

During the 2023-2024 school year, VTHS planned summer acceleration programs for all students. The VTHS case managers, counselors, teachers and administration worked on assigning students to this programming to keep students on track with graduation requirements. In the 2023-2024 school year, VTHS also brought Rachel's Challenge in to provide students with an educational experience that focuses on self reflection and kindness. The program then led to our FOR Club (Friends of Rachel), where student have continued to thrive in promoting a positive school culture.

Technology plays a vital role in students' daily instruction. The importance of students becoming thoroughly involved in clubs/activities and athletics is also emphasized at VTHS. It is our belief that the combination of academics and extracurricular activities will motivate our students to become and remain resilient lifetime learners. Open lines of communication are a critical component, thus all faculty/staff members are provided with a weekly Monday Memo to ensure everyone is kept informed about upcoming events. Parents/Guardians also receive monthly communications, monthly Save the Date newsletters via the ThrillShare Apptegy System. This message is also shared with the students and the staff. A monthly message from the VTHS administration provides the opportunity for the school and community to build strong relationships for the benefit of all students.
