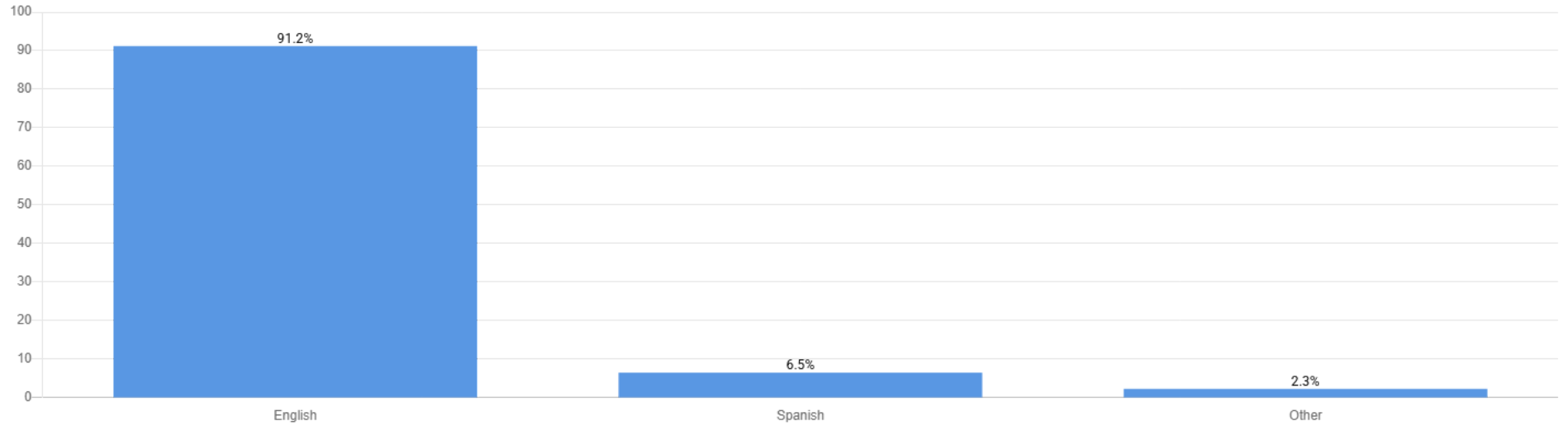

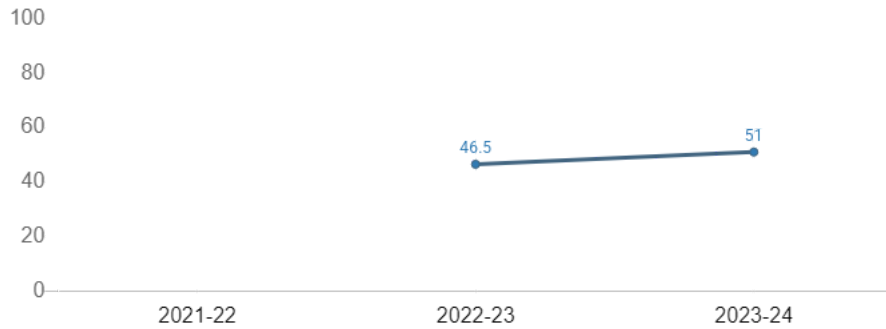

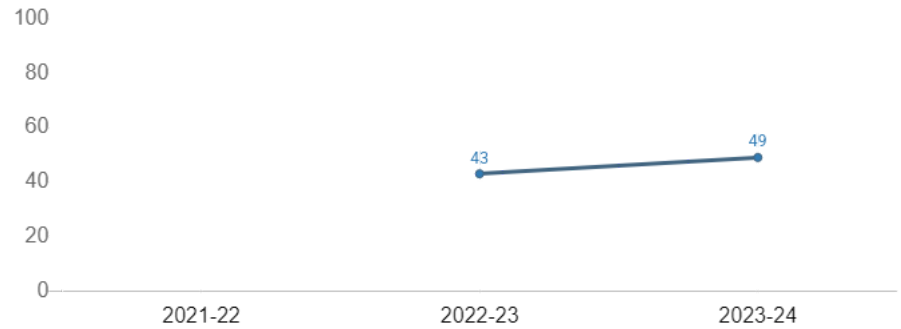

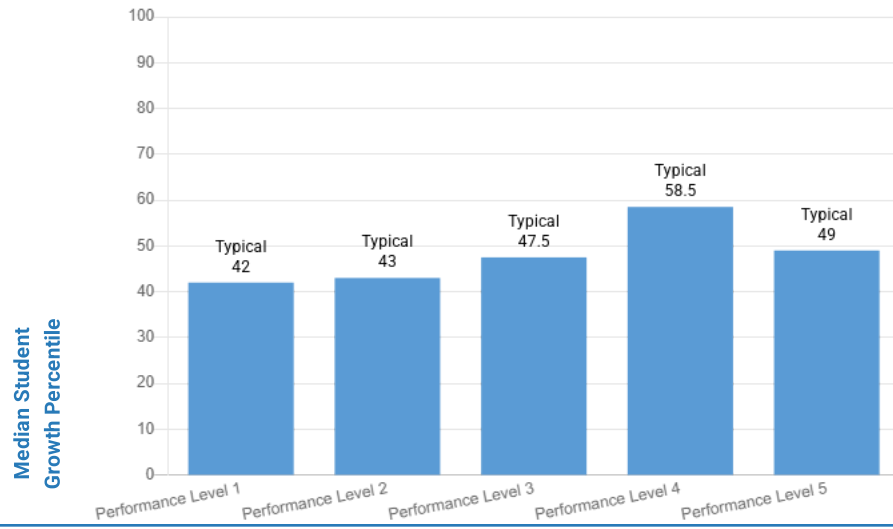

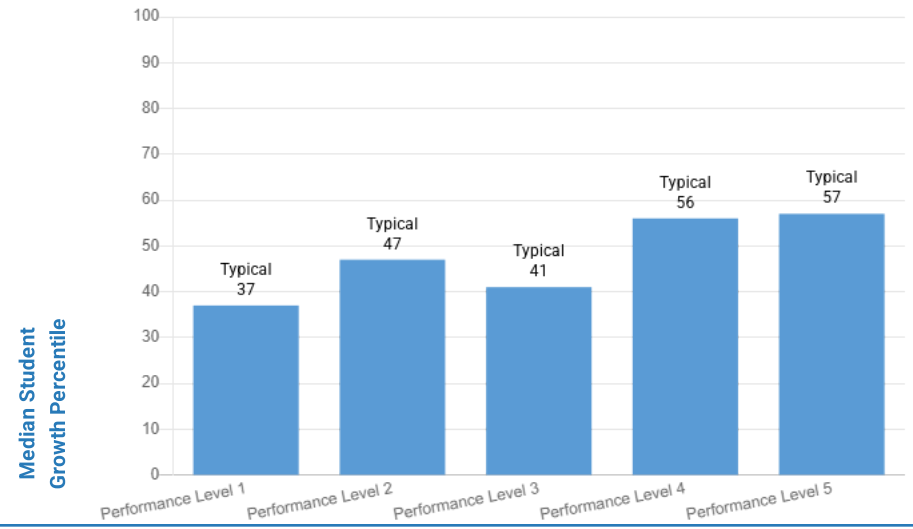

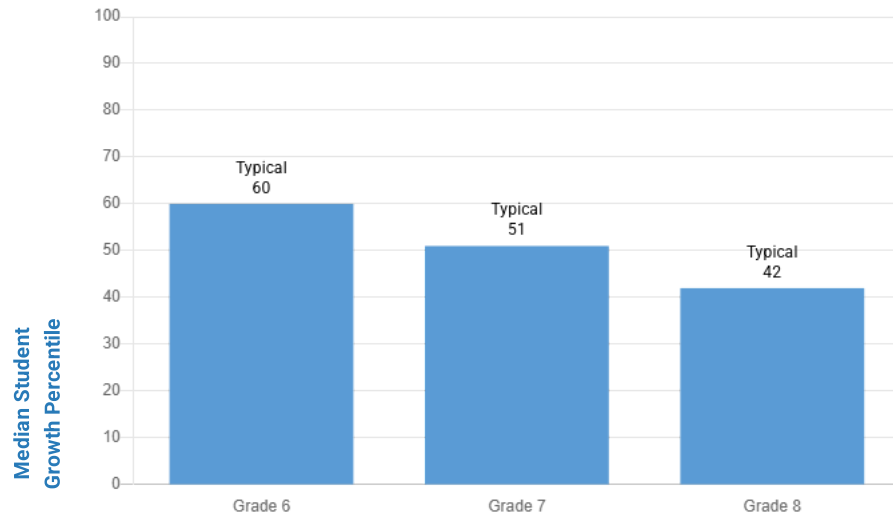

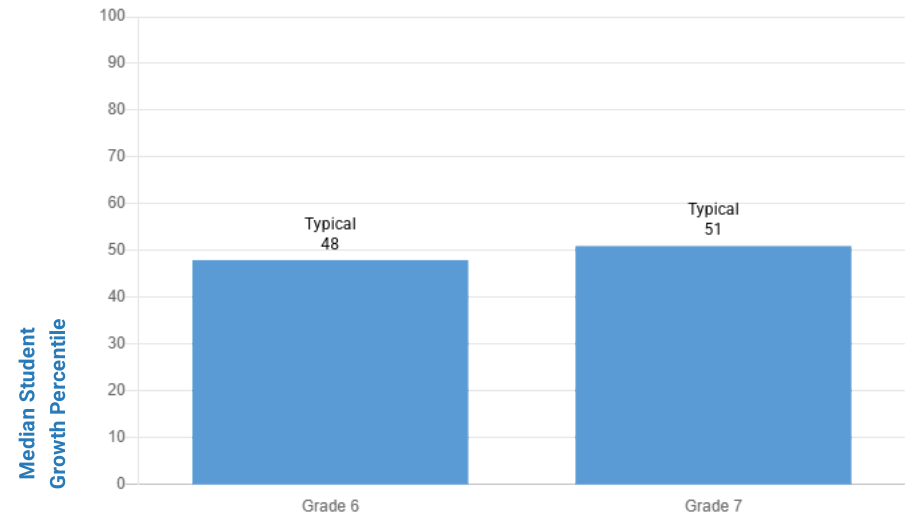

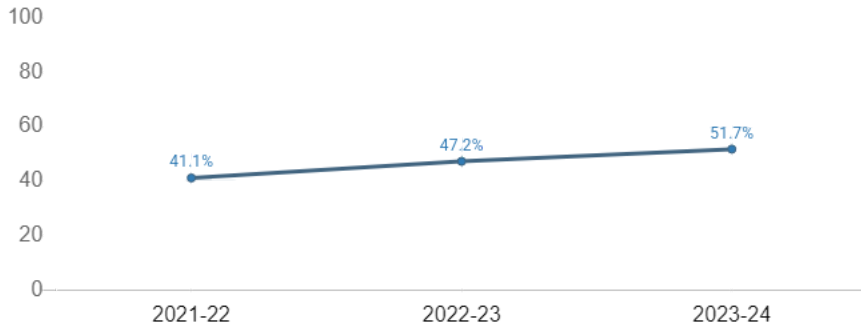

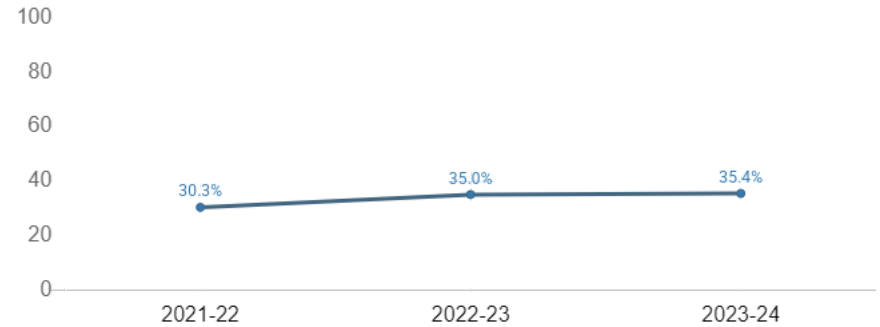
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 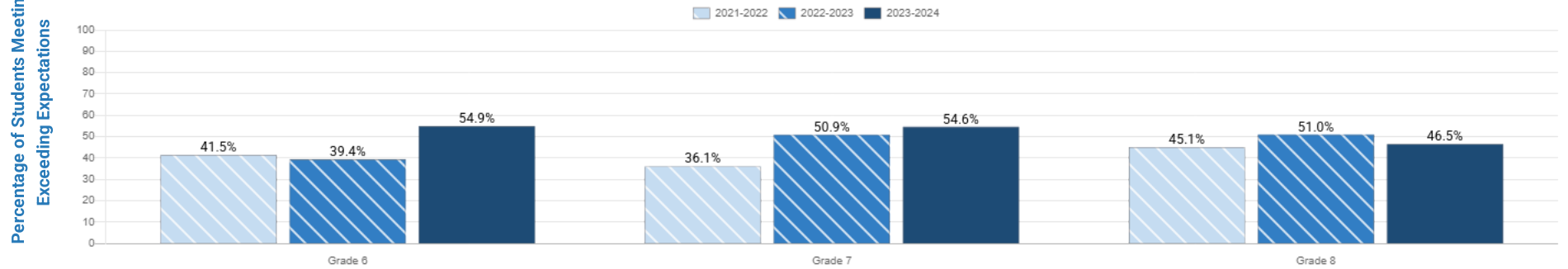

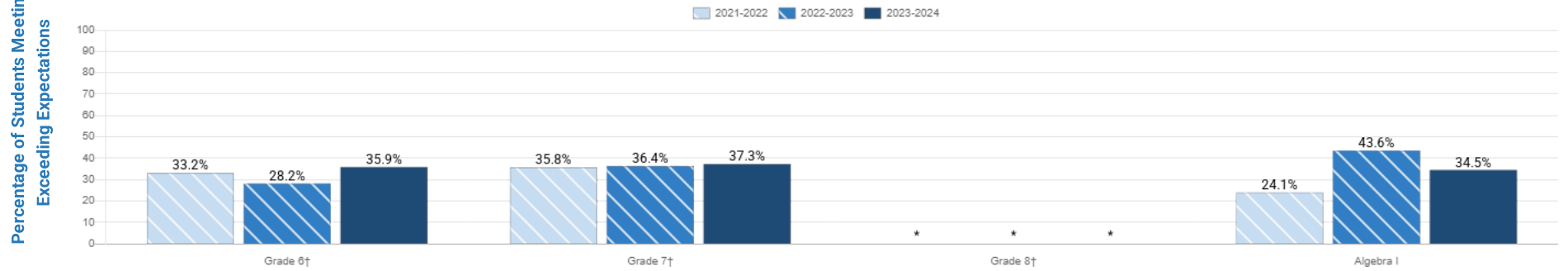

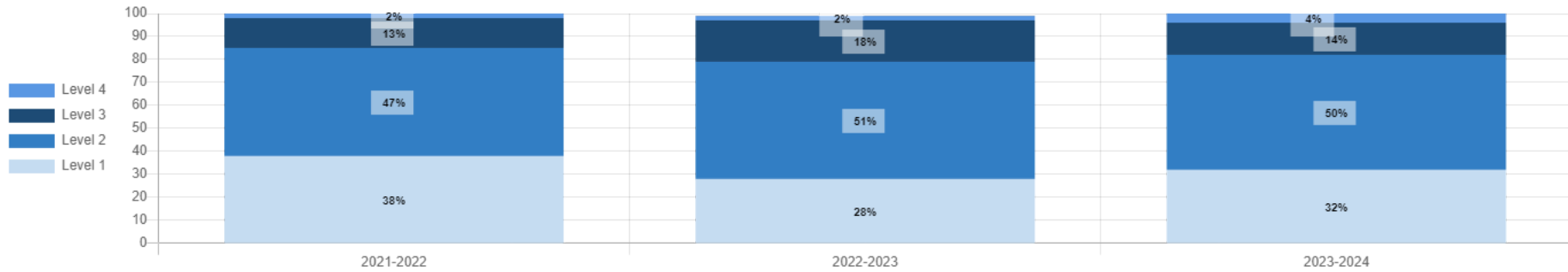

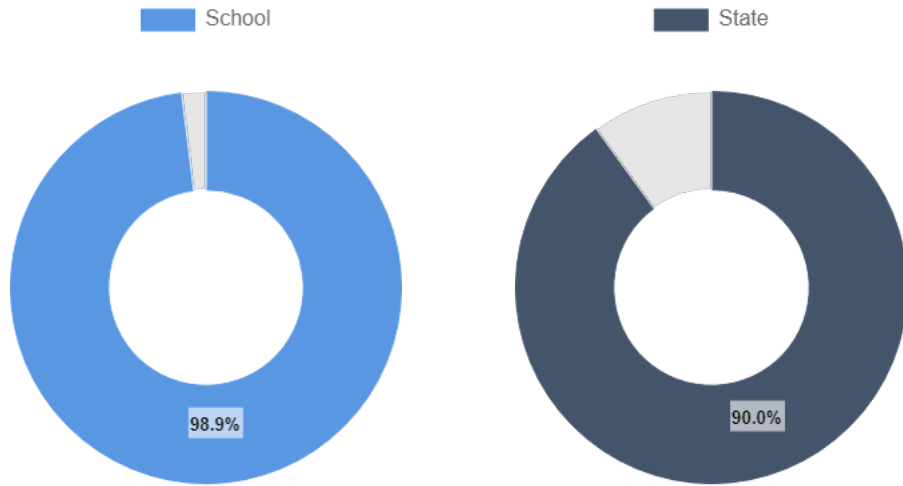

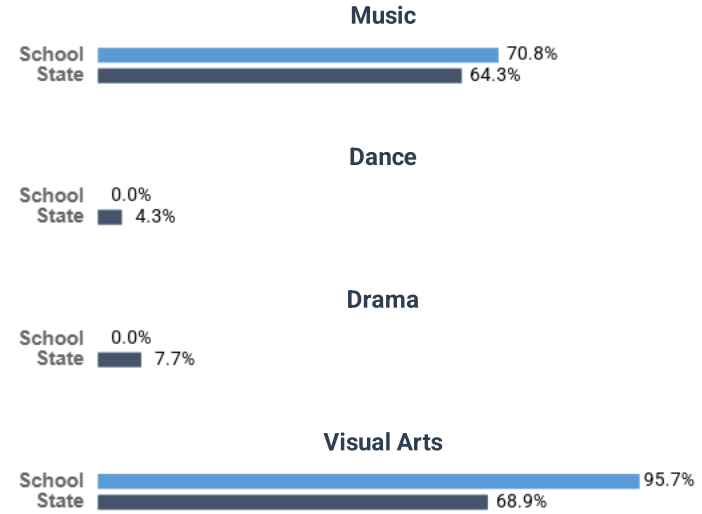

Students enrolled in one or more classes by discipline:



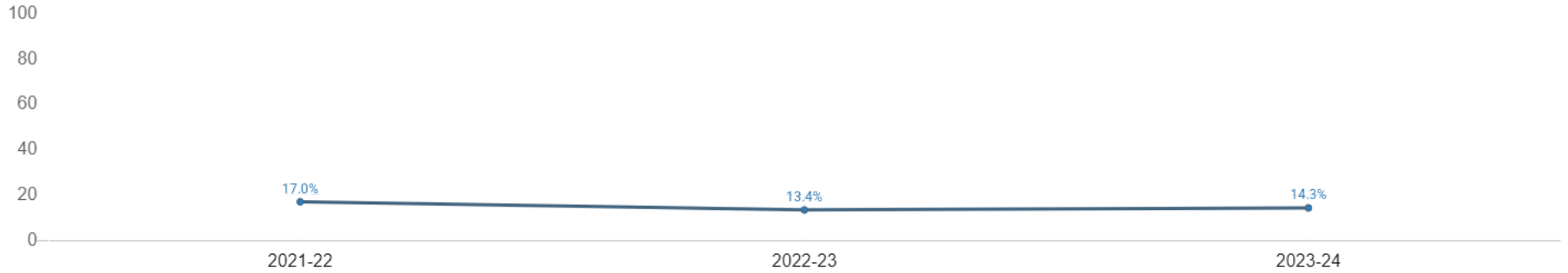

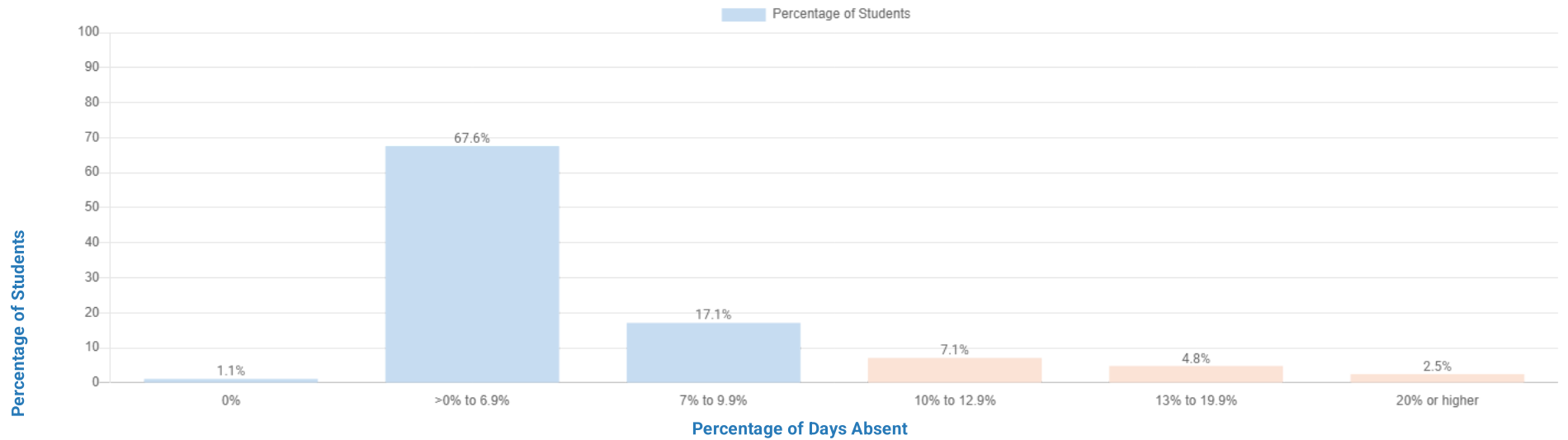

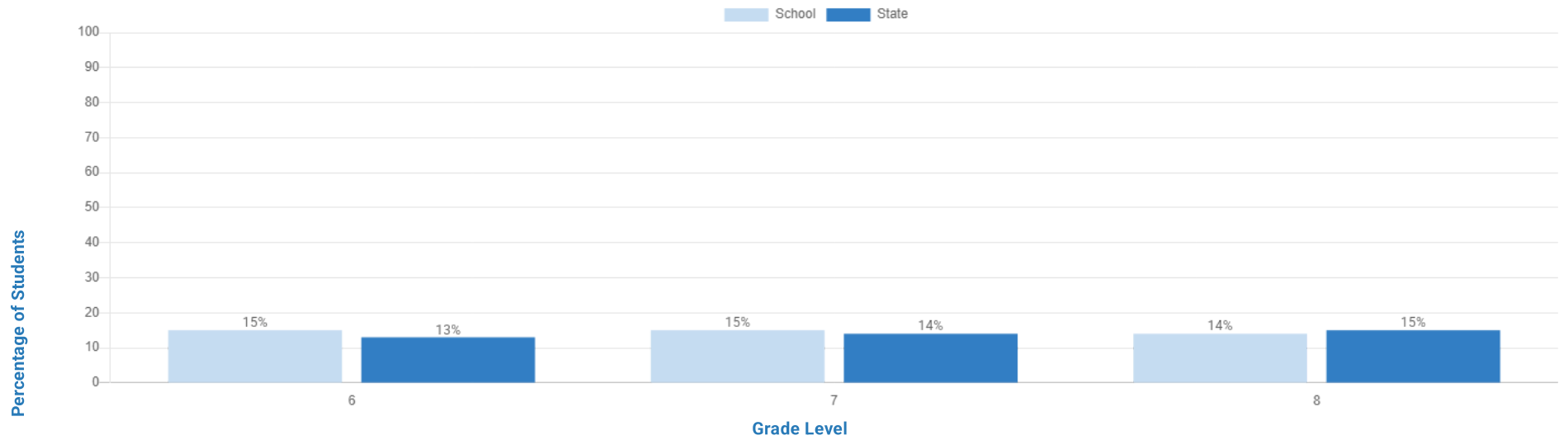

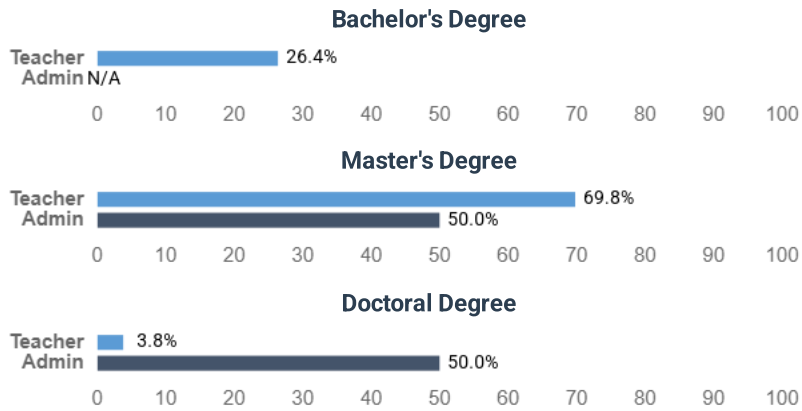

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Students may explore the arts, athletics, and clubs through after-school activities and the 21st Century Community Learning Center. Middle school is truly an exciting time for the developing pre-teen/teen and we are privileged to help guide students toward achieving each student's academic and emotional potential not only for success at GM but to become responsible, independent, & respectful citizens.

Courses, Curriculum, Instruction:

GMMS offers Language Arts, Math, Science, Social Studies, Spanish, Technology, Health/Physical Education, and Visual and Performing Arts. We use LinkIt! for progress monitoring and to help teachers with lesson planning that will support all learners. Our Foundation, Innovations and Creations classes round out the curriculum by allowing students to think creatively, explore ideas, and solve problems individually and collaboratively.



Sports and Athletics:

Sports Offered: Basketball (Boys & Girls), Cross Country (Coed), Field Hockey (Girls), Skiing (Boys & Girls), Track and Field - Spring (Boys & Girls)
Many athletic programs are available to Glen Meadow Middle School students. In addition, our physical education department exposes our students to skills, athletics, and programs that will instill a commitment to lifelong physical fitness. Our Physical Education teachers organize the annual volleyball tournament after school, which raises money for Harvest House and collects non-perishable food items for our local food pantries. Students, faculty and community members understand the importance of community building at Glen Meadow Middle School.



Clubs and Activities:

The Middle School Musical, Jazz Band, Band, Orchestra, Chorus & 21st CCLC Talent Show provide students with the opportunity to showcase their remarkable talents. Groups such as Vernon Volunteers, STEM Club, National Junior Honor Society, Student Council and Yearbook Club provide students with the opportunity to develop new friendships and learn important character-building leadership skills. The ongoing partnership with The Center for Prevention and Counseling keeps our students informed about the dangers of drugs and alcohol.

Before and After School Programs:

The 21st CCLC is an after school program available to all 6, 7 & 8th grade students, staffed by GMMS teachers and paraprofessionals. This program supports academic endeavors and personal interests in STEM, Visual, Performing & Culinary Arts. Teachers often volunteer their time after school to work with students who need individual assistance to experience success or have missed an assessment. These tutorial sessions provide students with the opportunity to feel a sense of belonging and to better enjoy their educational experience at the middle school level. On a weekly basis, students work with The Center for Prevention and Counseling as they participate in activities to promote healthy lifestyles.



Staff and Professional Learning:

The educators at Glen Meadow Middle School have built-in common planning time in their schedules. CPT is a process of school improvement that brings coherence to the work of educators by connecting standards, student learning, assessment, professional learning and educator effectiveness. It works to create conversations between educators which are both meaningful and purposeful and adhere to best practices.



Student Supports and Services:

Non-English speaking students are provided with opportunities to work with an MLL (Multi-Language Learners) teacher to strengthen their language acquisition skills. Students with identified disabilities are assisted by placement in appropriate classroom settings and have the opportunity to work with speech, physical and occupational therapists as per their IEPs. RTI/MTSS provides struggling learners with the supports necessary to enhance their learning. Our RTI coordinator has developed a tiered response program for Math and Language Arts. Data is kept on all students to monitor progress.

Student Health and Wellness:

Each school day begins with the opportunity for students to receive a breakfast, allowing them to get a nutritional start before classroom learning begins. In addition, a nutritious lunch helps students to be better prepared for the afternoon. All students are provided with either a physical education or health class on a daily basis. In addition, approximately 20 minutes of recess before or after lunch gives students the chance to socialize indoors, outdoors, or walk the front school grounds with friends. Our school nurse conducts various routine health checks such as height/weight & vision screening. GMMS brings the Mobile Dentist on campus for students who qualify.



Parent and Community Involvement:

The GMMS School and Community Association (SCA) enhances student life by supporting and funding programs for the students of Glen Meadow Middle School. By working together, the home and school greatly enhance the students' educational and social experience in this middle school setting. The SCA's "Giving Tree" program encourages giving rather than receiving during the holiday season and provides gifts and/or gift certificates to families in need of assistance throughout the district.

Facilities:

At Glen Meadow, every academic classroom is air conditioned to afford an optimal environment for learning. Our media center provides options that allow students to read, create, and research in an educationally-rich environment. New technology includes tablets and a self check out program. A state-of-the-art band room allows all three grade levels to perform together. A well-equipped art room provides students with the room to create their masterpieces. Well-maintained fields allow for outside physical education classes whenever the weather permits. An outdoor classroom has been created thanks to a \$25,000 HIPP grant that our art teacher, Mrs. Hirkaler, received from NJEA.



School Safety:

The Vernon Police Department has a School Resource Officer assigned to all schools and a Memorandum of Agreement is in place. GMMS has two armed, retired police officers assigned when school is in session. GMMS has a 24-hour camera system which records the interior and exterior of the school and the cameras archive video for 30 days. GMMS has 2 layers of security at their entrances with all doors locked and monitored. Raptor Visitor Management software and hardware is utilized at GMMS to monitor visitor ingress and egress. GMMS conducts a minimum of one fire drill per month and one security drill per month. The security drills consist of the state standard for active shooters, non-fire evacuation, bomb threats, lock down and table top exercises. The Director of School Safety and Security attends security drills.



Technology and STEM:

GMMS schedules one marking period of technology education for all students annually. Students are scheduled for Coding Exploration, Engineering Design, and Design Innovations. GMMS also has numerous after-school activities through the 21st CCLC that promote STEAM. To support our technology and STEAM initiatives, GMMS has implemented a one-to-one Chromebook program for all students. We have provided professional development for our staff and continue technology integration with a district technology coach.

The professionals at Glen Meadow Middle School go above and beyond to ensure that every student experiences a successful middle school experience; this better prepares each of them for the opportunities that lie ahead when students enter high school. This year, Restorative Practices in Education continued to be implemented through a partnership with Kean University and NJDOE. The administration works collaboratively with the high school to ensure that every student and parent/guardian understands all that Vernon Township High School has to offer, while fully supporting those students who choose to attend other private or technical schools. Understanding the importance of technology in their students' future endeavors, Glen Meadow continues to provide the use of 1:1 Chromebooks for every student. All faculty work collaboratively during CPT and Monday Meeting Time, which in turn assists the adolescent middle school student with the support system needed to experience success. By providing Common Planning Time for each team and each department, GM's gifted educators plan together and share best-practice lessons and best practices that build a strong foundation for all future learning. By keeping the importance of communication at the forefront, all staff members are provided with a weekly and monthly communique so that everyone is better informed about upcoming events. Weekly and monthly information is disseminated to parents via the Smore newsletter and School Messenger. Parents/Guardians are also encouraged to review their children's academic progress by using the Genesis Parent Portal Program.
