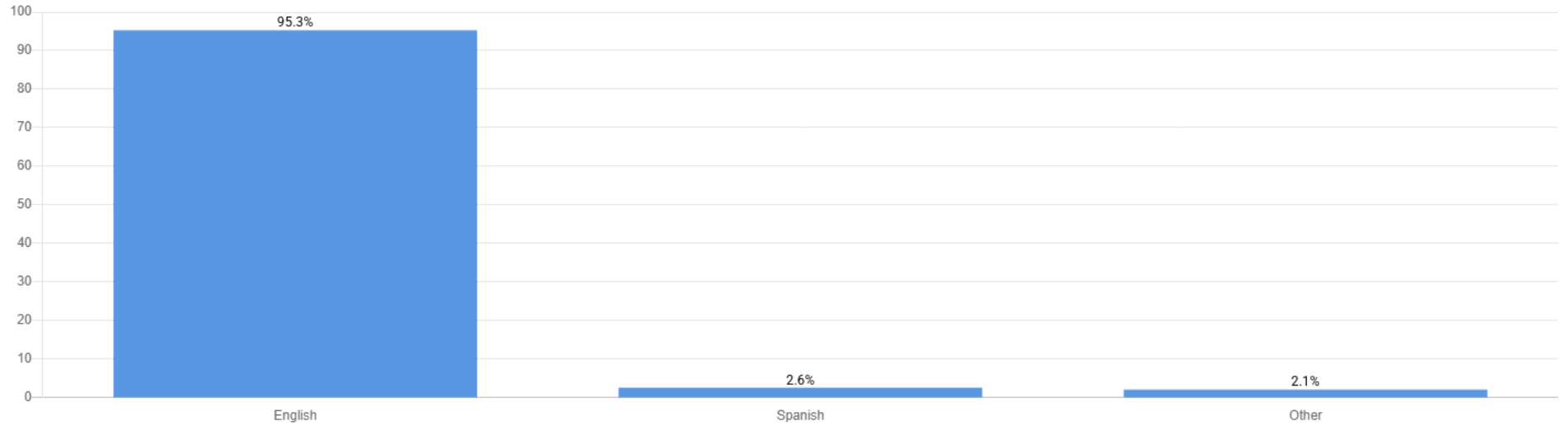

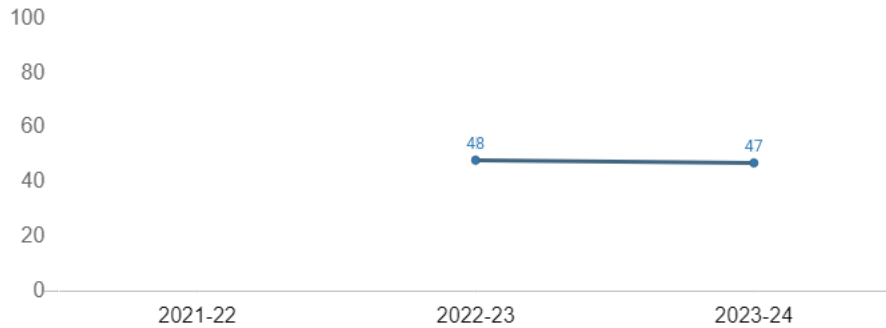

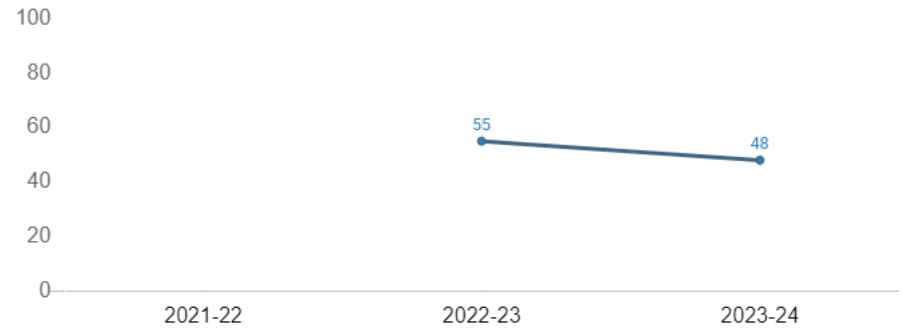

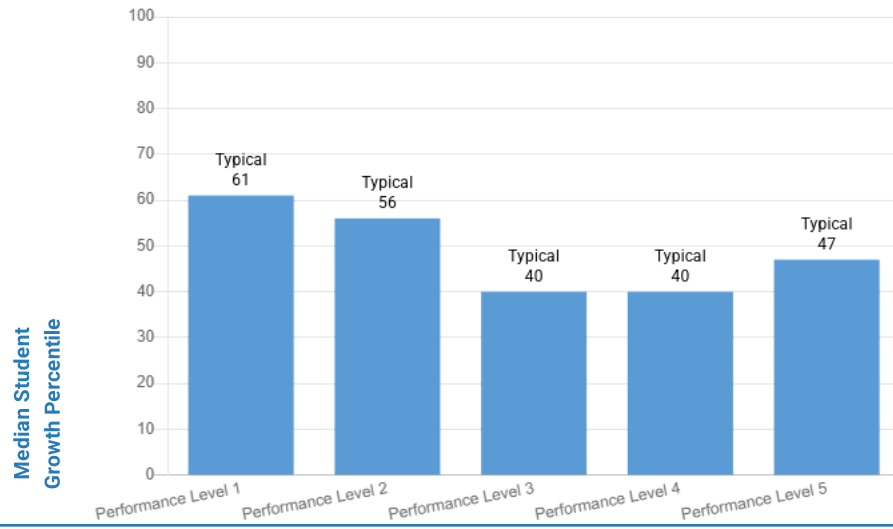

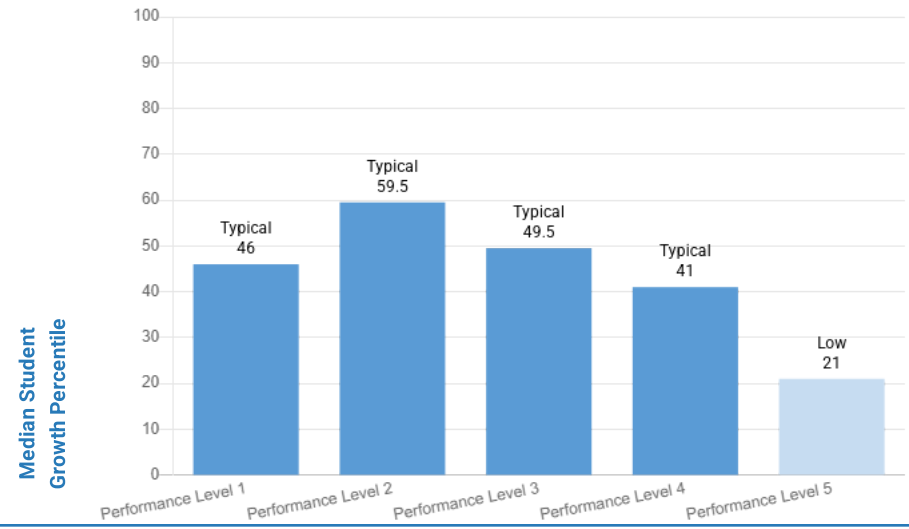

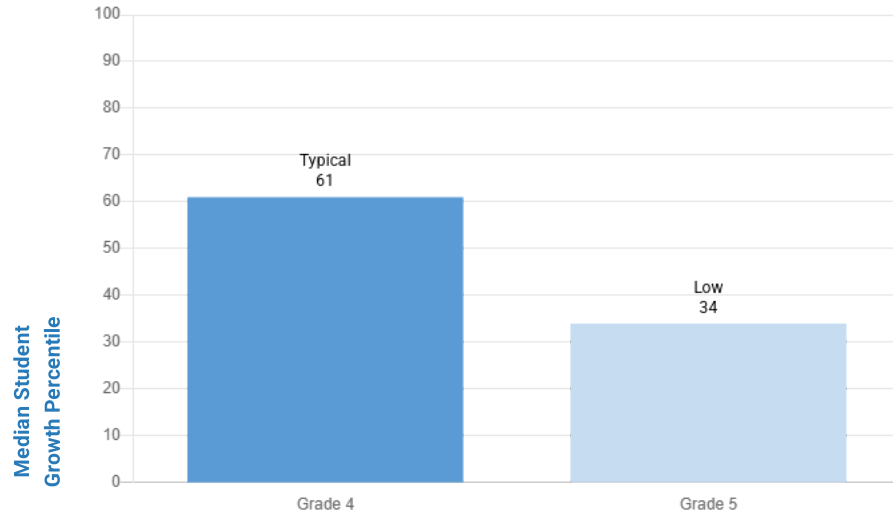

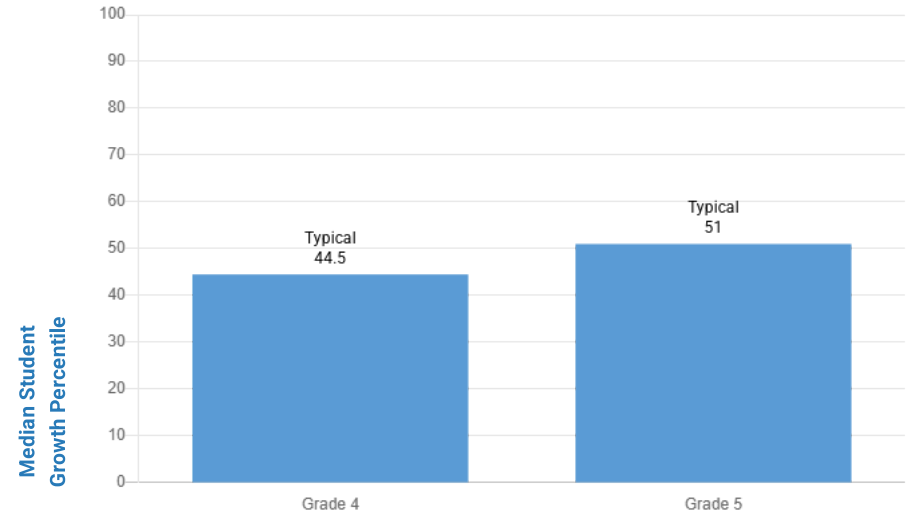

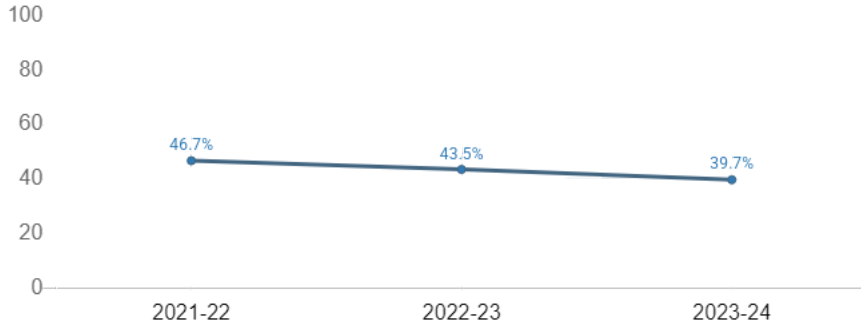

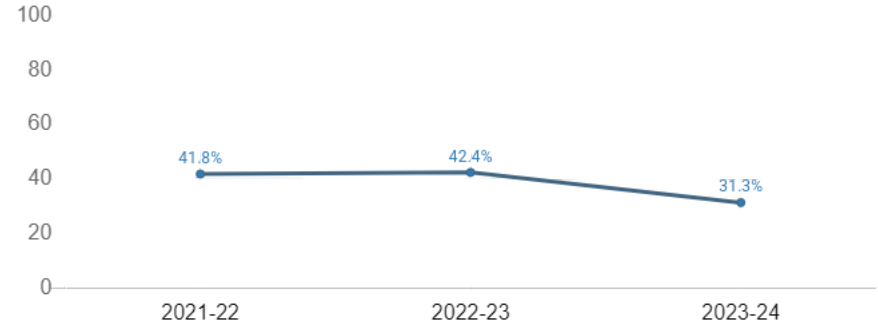
English Language Arts and Mathematics Performance Trends

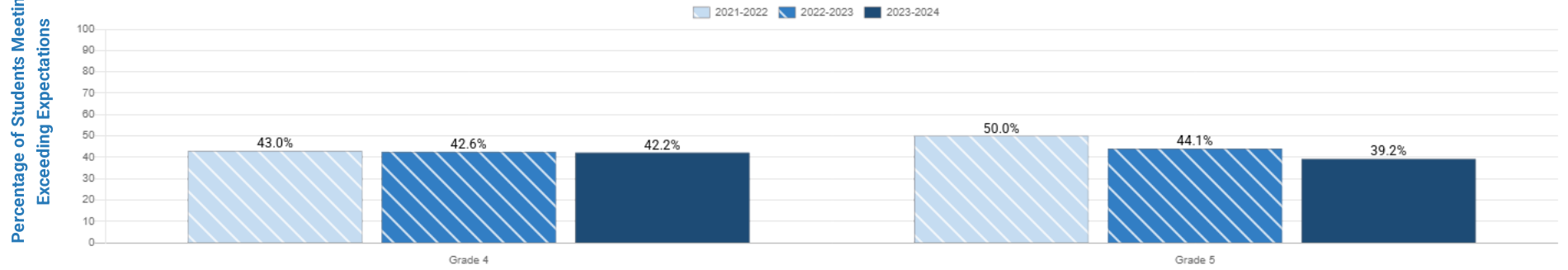

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 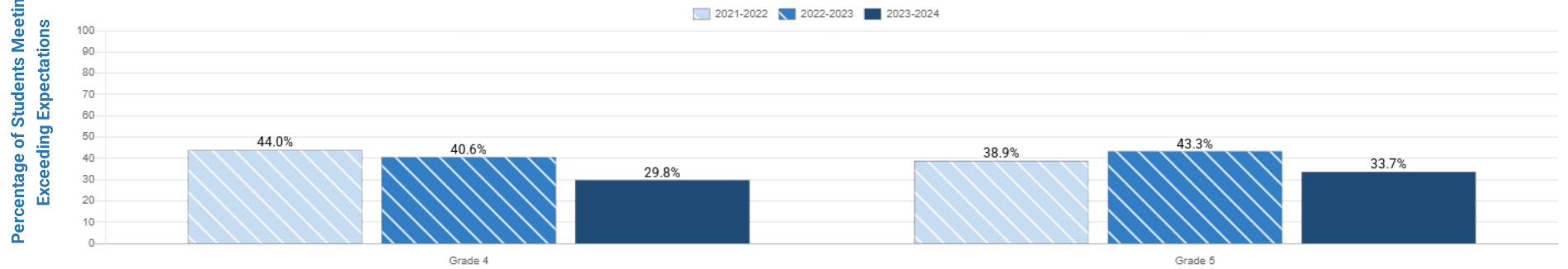

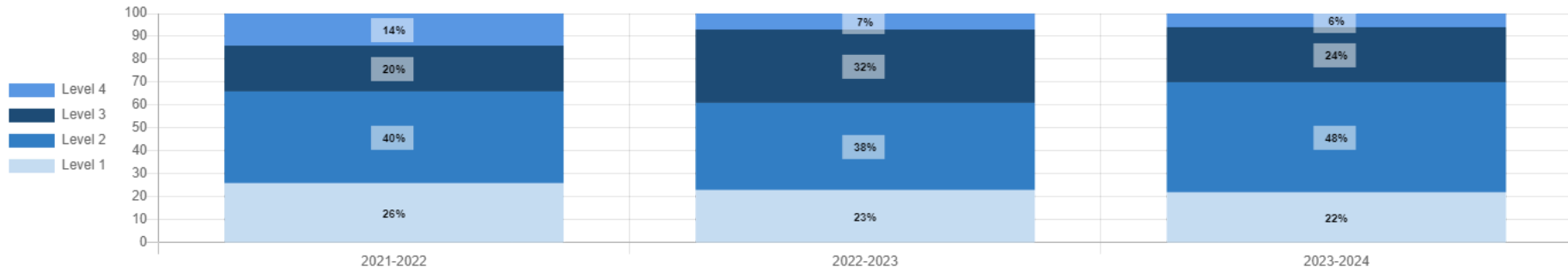

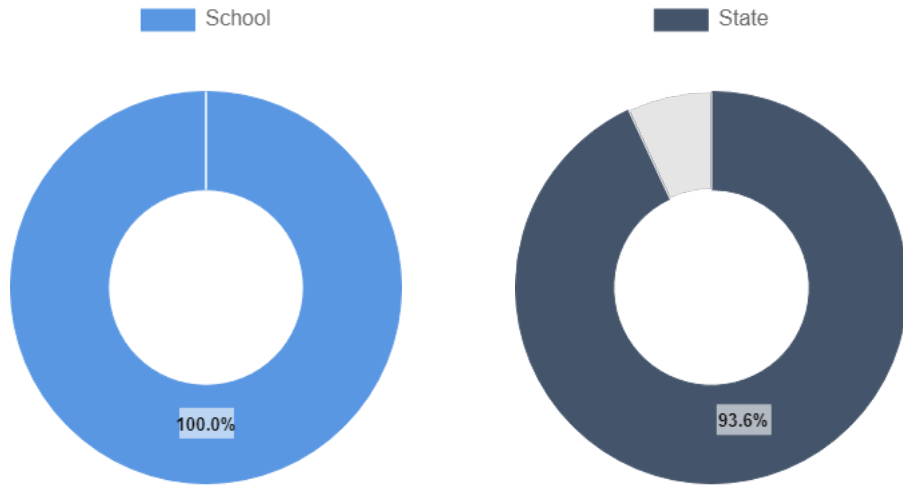

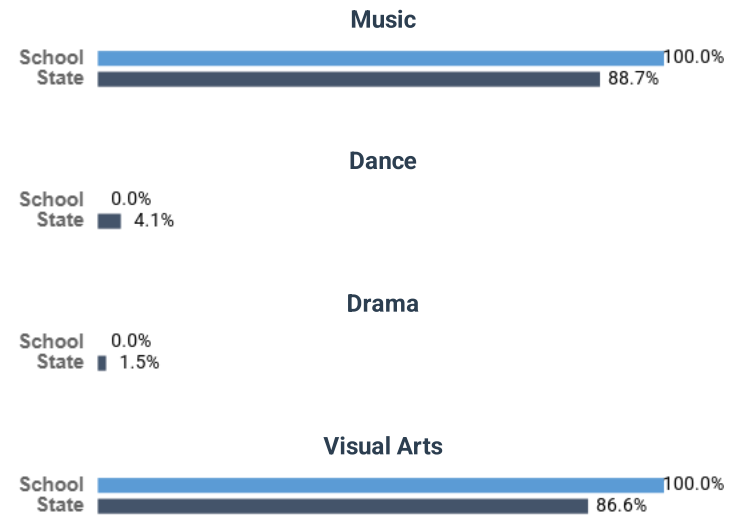

Students enrolled in one or more classes by discipline:



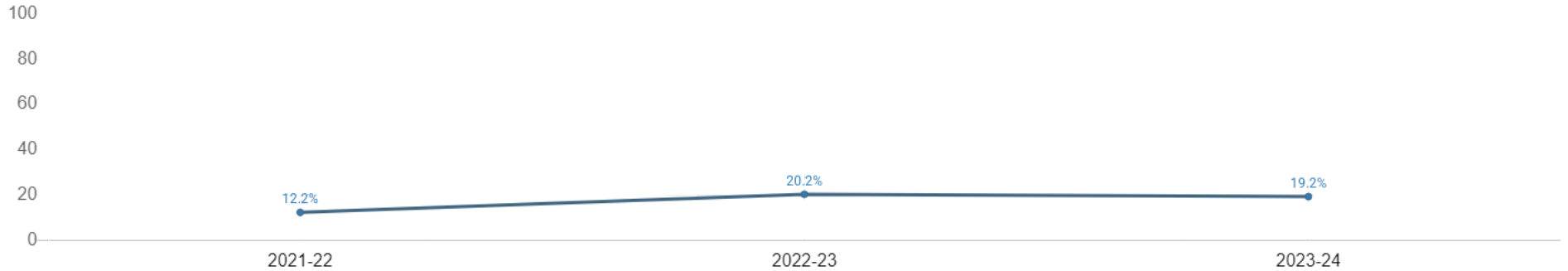

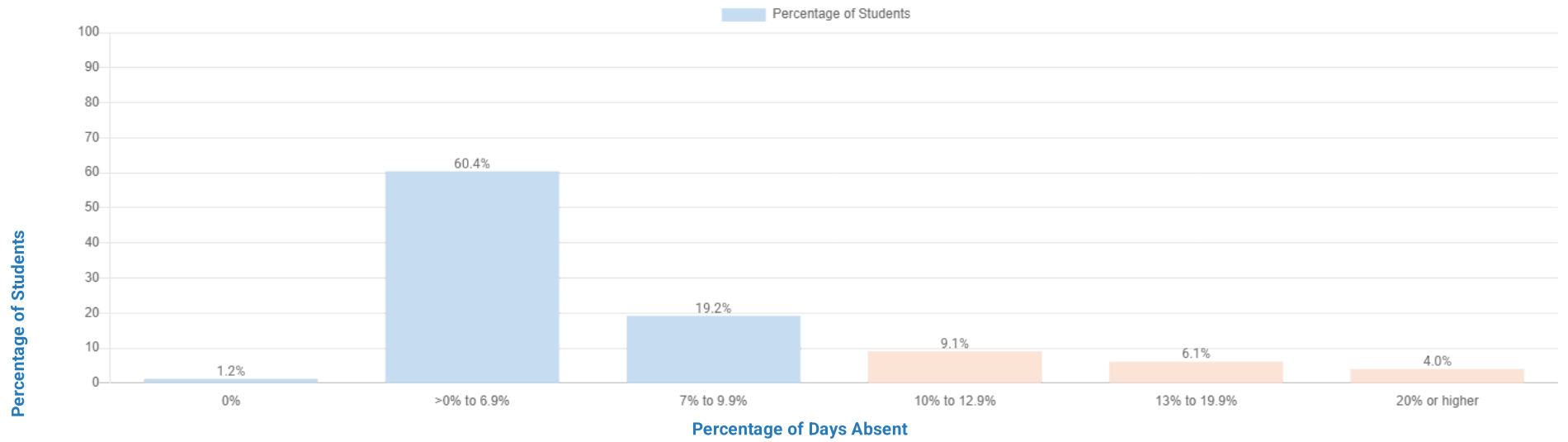

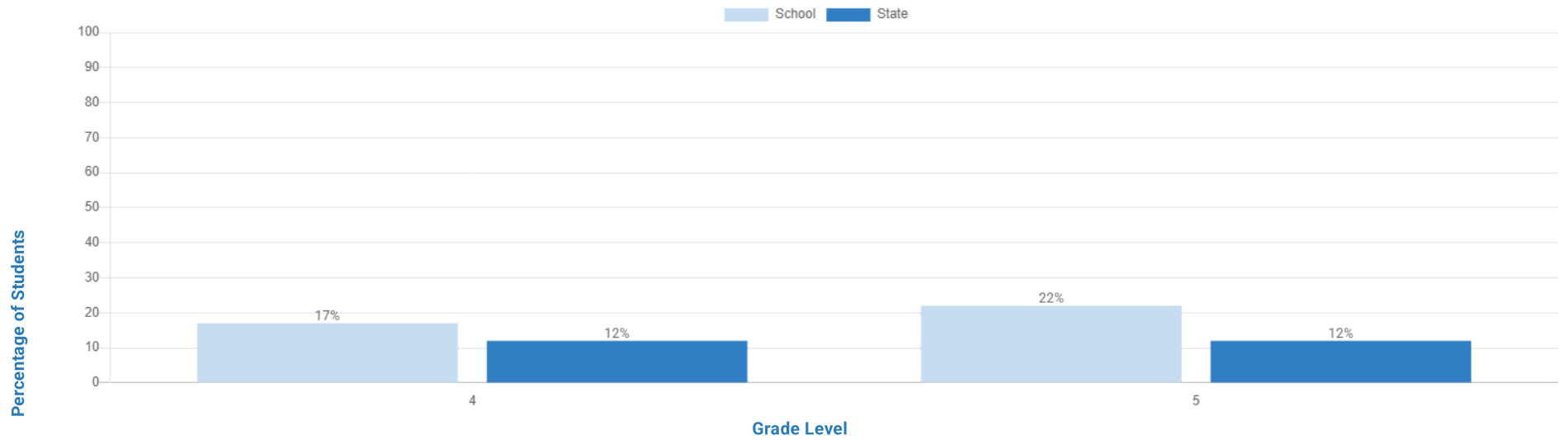

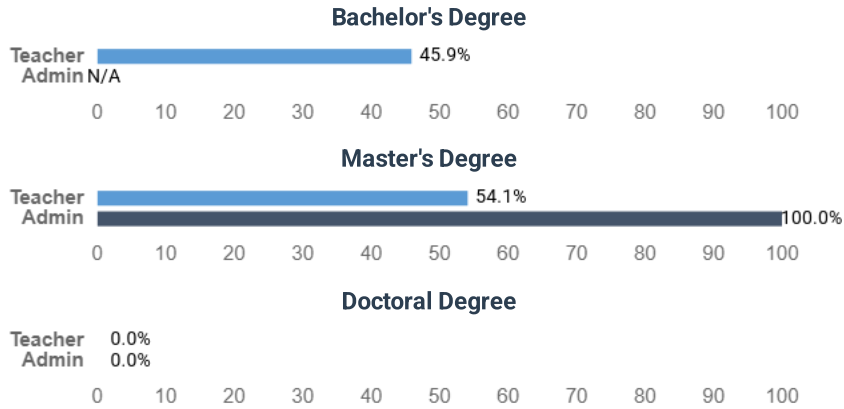

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers by Subject Area

This table shows the counts of teachers by subject area with gender breakdown, experience, and level of education. The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). Note that some teachers may teach in multiple subject areas and may be counted more than once in this table, or they may only be counted in their primary subject area. Additionally, in many elementary schools, teachers are not assigned to specific subject areas, so they will appear in the Elementary (Not Subject Specific) category and not in the other subject areas, but that does not mean those subjects are not being taught in the school. Special Education and Bilingual teachers are generally assigned to a subject area and also either special education or bilingual, so those teachers will be counted in multiple subject areas.

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. An awards program is held at the end of the year to recognize student achievements. This includes academic recognition, physical achievements and fine arts achievements. This year our school held a Veterans Appreciation Assembly in which we honored veterans with family members in our school. Students are recognized monthly with our Captains Awards for "being on board" with our core values of respect and responsibility. Our parents and staff member nominate and select our GEOY and our ESP each year.

LHS provides students with strong academic programs. Students benefit from differentiated learning opportunities in mathematics, language arts, science, social studies, Spanish, music, art, physical education and health. Language Arts curriculum is guided by the HMH program; Innovamat and Math in Focus is the primary math curriculum. A variety of activities beyond the traditional classroom are also offered, including Gifted and Talented programs.



Sports and Athletics:

The community PAL (Police Athletic Club) offers basketball, ski club, baseball, football, and other programs.



Clubs and Activities:

LHS utilizes outside agencies as part of our all school program. We partner with the Center for Prevention who provides a life skills program as part of our health instruction. Our SRO teaches LEAD classes to grade 5. Students and staff participate in Stuff the Stocking, a holiday toy drive with Project Self Sufficiency. All students participate in the What's Your Anti-Drug? contest as well.

Facilities:

Lounsberry Hollow School converted from a 5th and 6th grade campus to a 4th and 5th grade campus over the summer of 2017. The physical school has a full size gym, library, art and music rooms, conference rooms and two separate cafeterias . Outside there is a playground and athletic fields.

School Safety:

The Vernon Police Department has a School Resource Officer assigned to all schools and a Memorandum of Agreement is in place. LHS has an armed, retired police officers assigned when school is in session. LHS has a 24-hour camera system which records a large portion of both the interior and exterior of the school. LHS has a security vestibule at the entrances with all doors locked and monitored. Raptor Visitor Management software and hardware is utilized to monitor visitor ingress and egress. LHS conducts a minimum of one fire drill per month and one security drill per month. The security drills consist of the state standard for active shooters, non-fire evacuation, bomb threats, lock down and table top exercises. The Director of School Safety and Security attends security drills.



Technology and STEM:

LHS is reshaping the way the library/media center looks and functions. We are moving toward helping students research and present information that is in line with 21st century skills. We are shifting from a traditional library to a space where students can work on building the skills they need to complete in a global society.



Attendance:

LHS implemented interventions to support students' academic recovery, partnering with the New Jersey Tutoring Corps, Inc., through the High Impact Tutoring Grant. This program provided targeted tutoring to 4th graders near proficiency, helping them master grade-level concepts in ELA and Math. Sessions occurred three times a week for 40 minutes during Enrichment blocks, focusing on foundational math and reading skills impacted by remote learning. Mental health initiatives included school counselors, social workers, and clinicians offering essential support. Social-emotional learning (SEL) programs, introduced through assemblies and agencies like The Center for Prevention and Project Self-Sufficiency, promoted resilience, empathy, and communication. These comprehensive efforts addressed academic and emotional needs, fostering a supportive environment for students' overall well-being and success.
