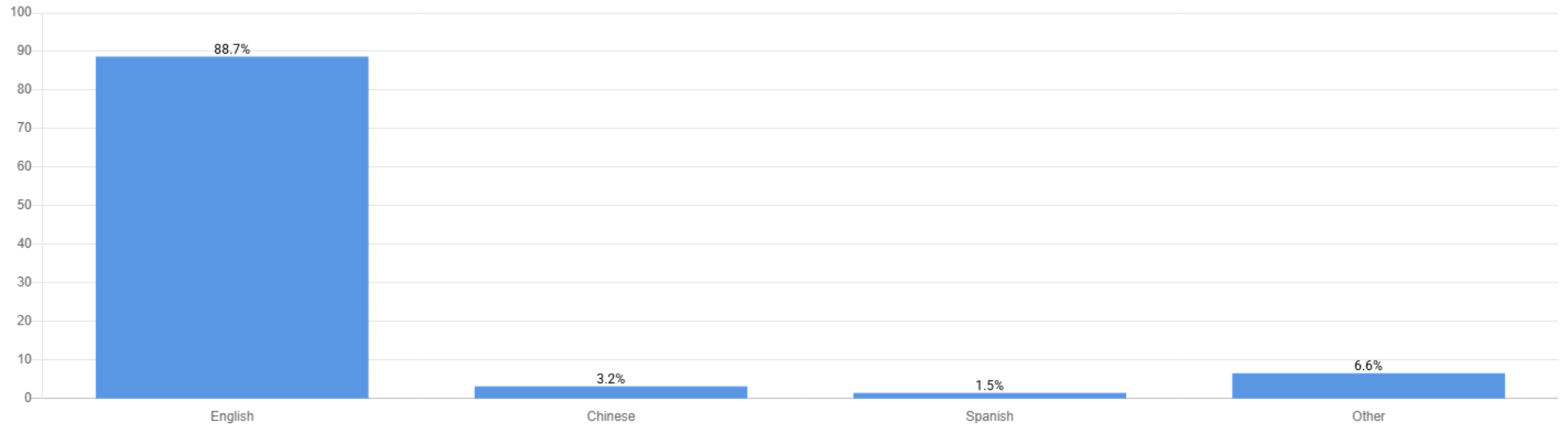

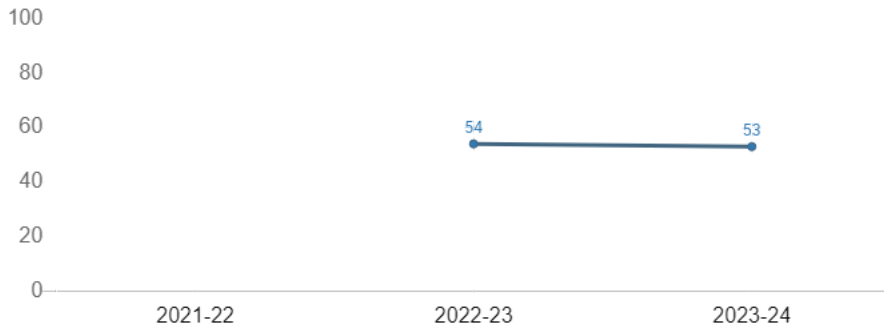

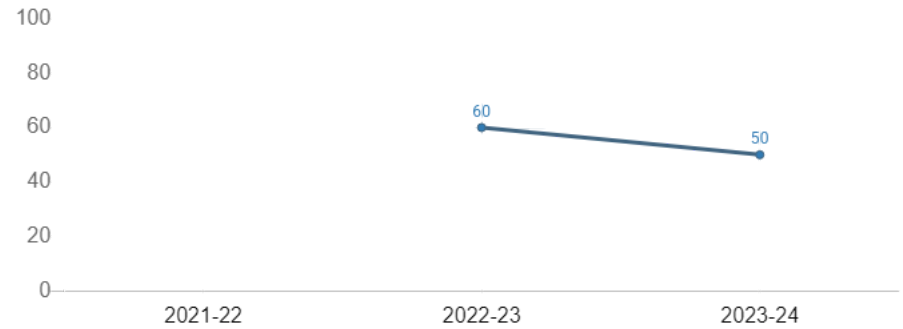

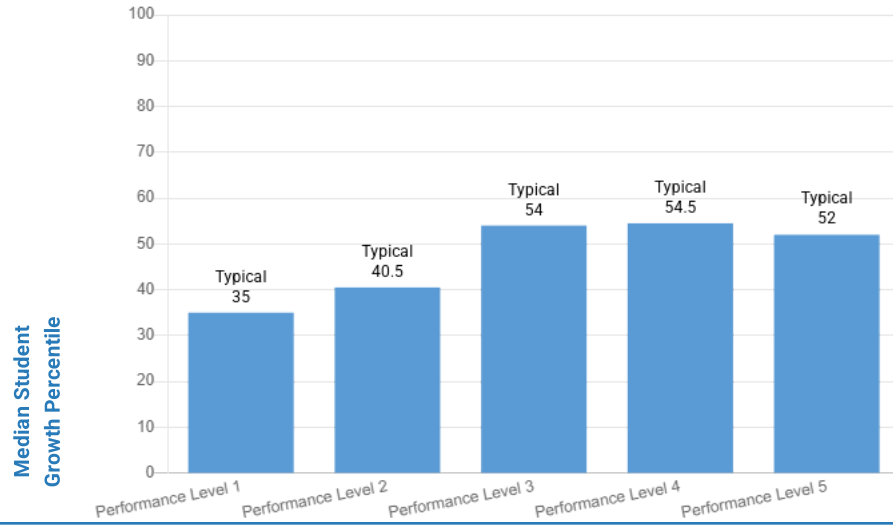

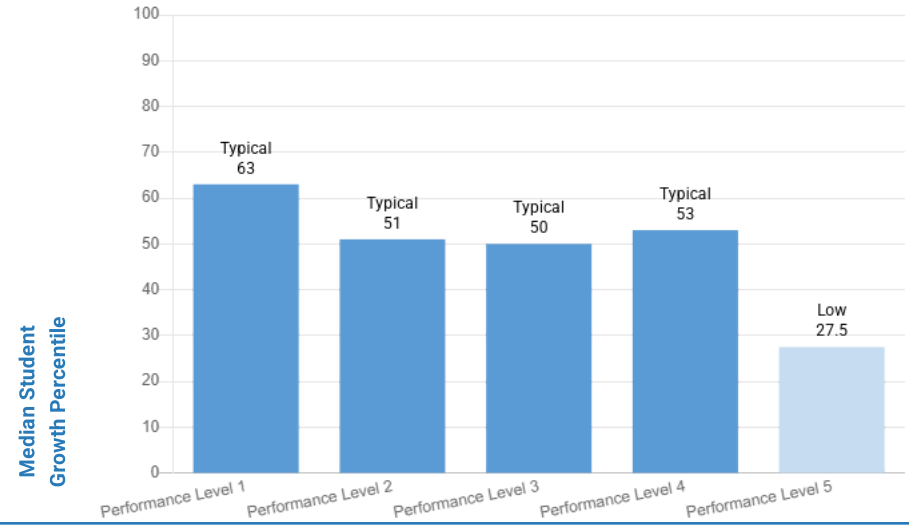

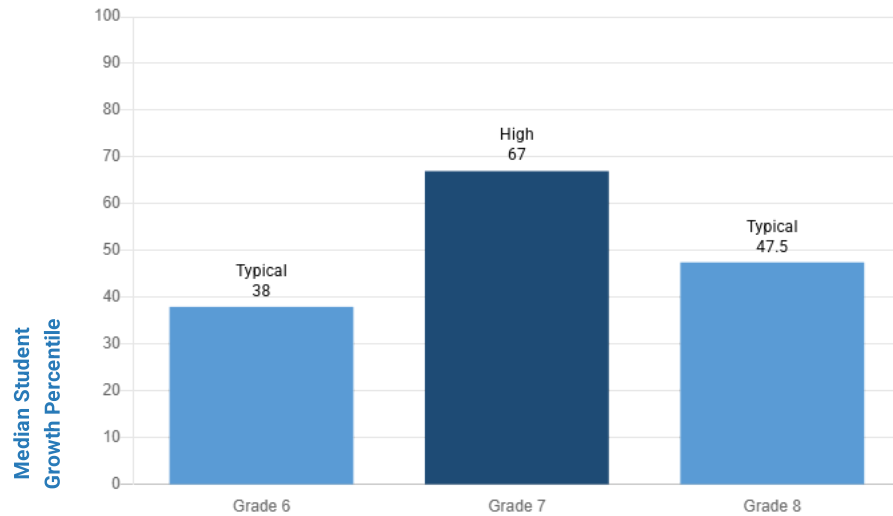

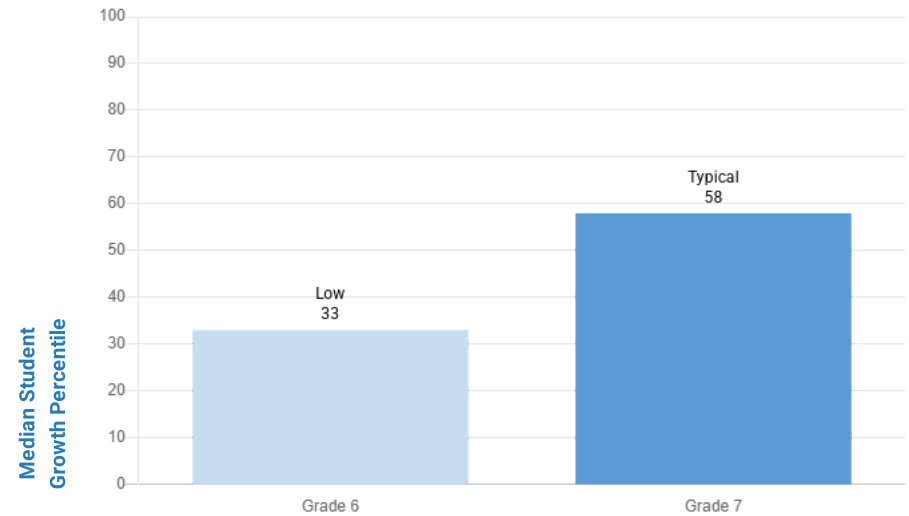

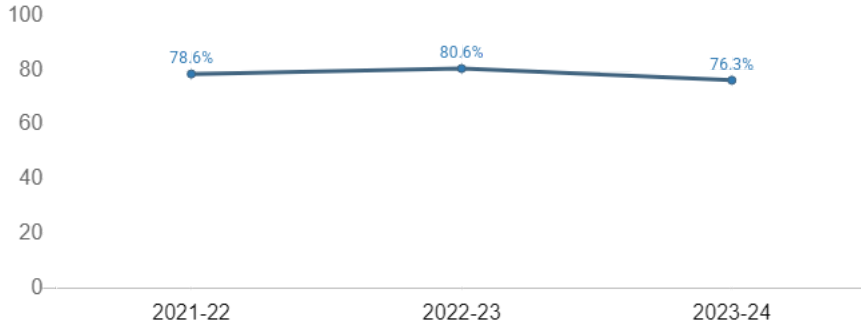

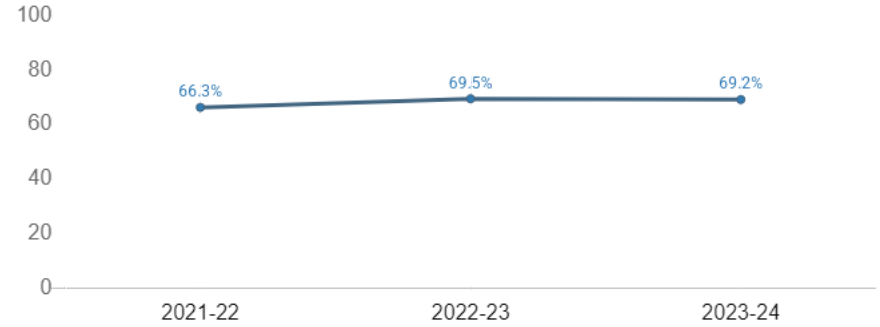
### English Language Arts and Mathematics Performance Trends

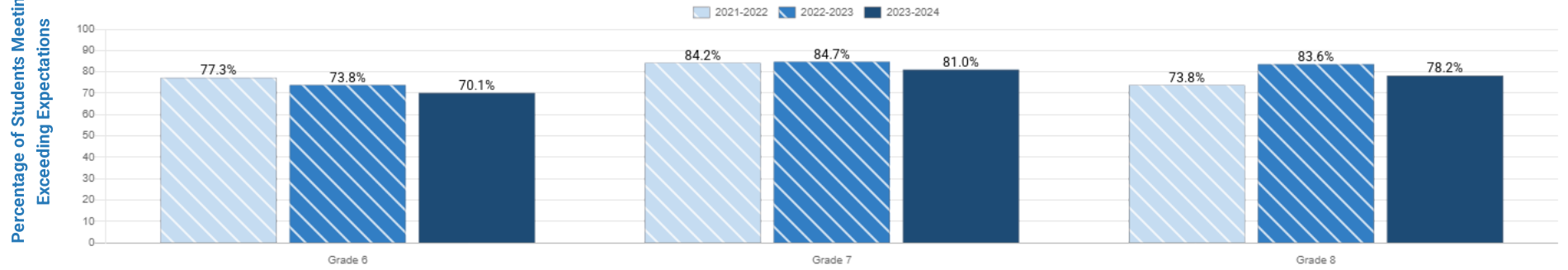

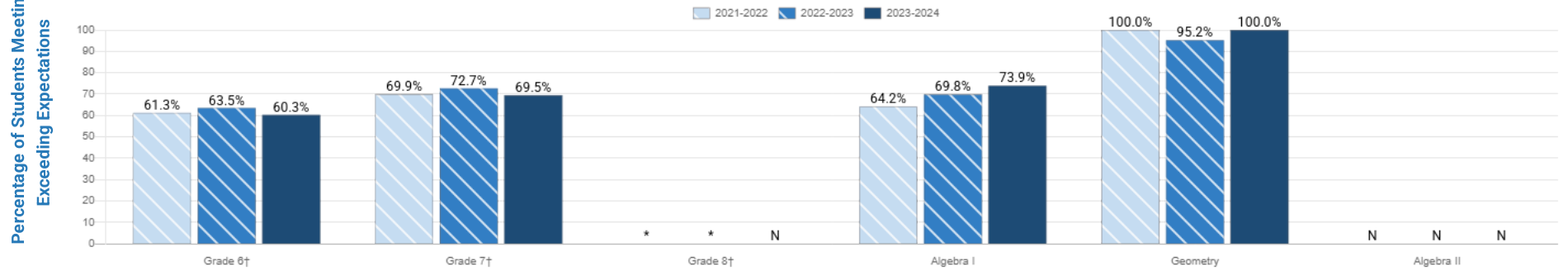

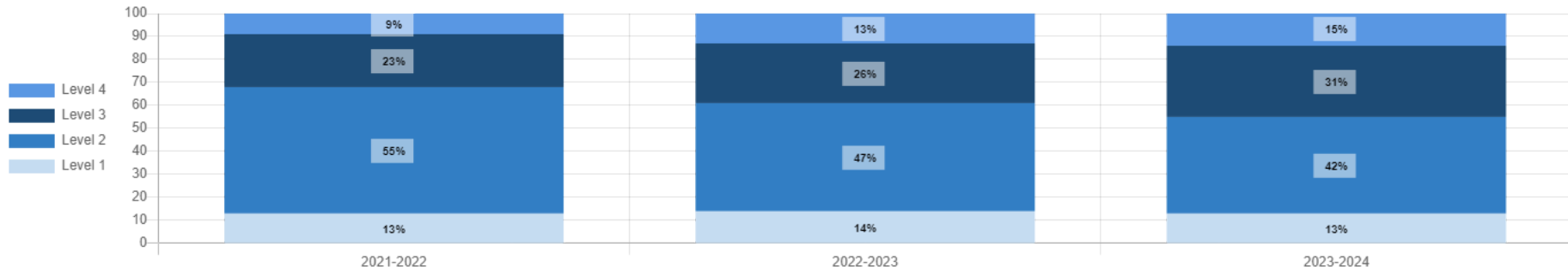

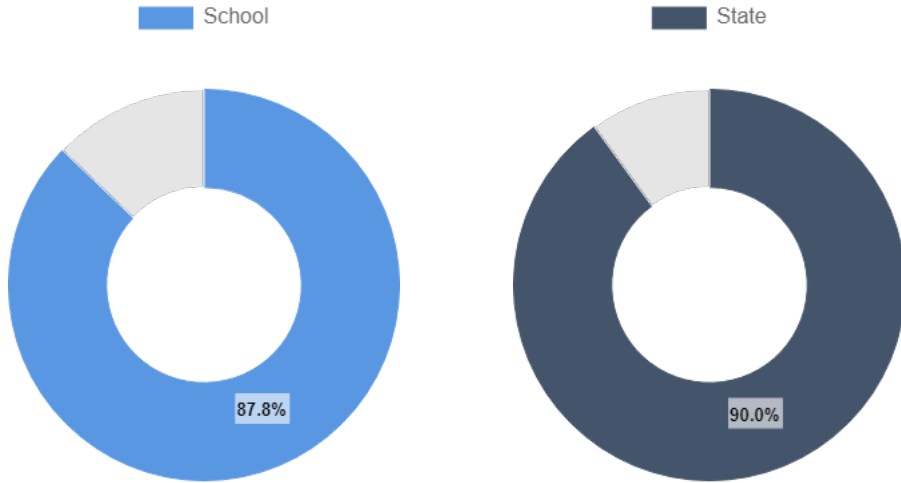

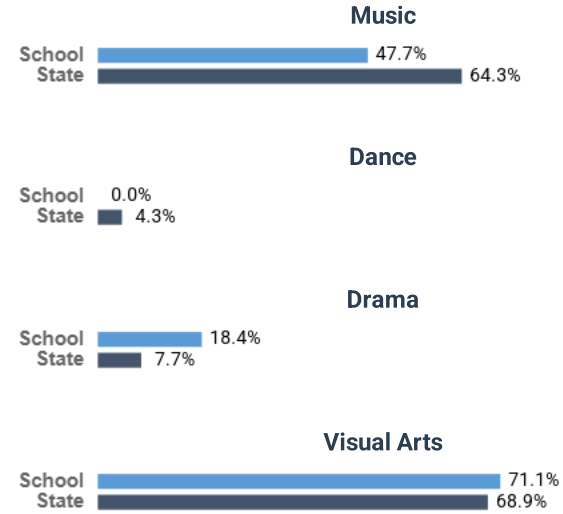

**Students enrolled in one or more classes by discipline:**



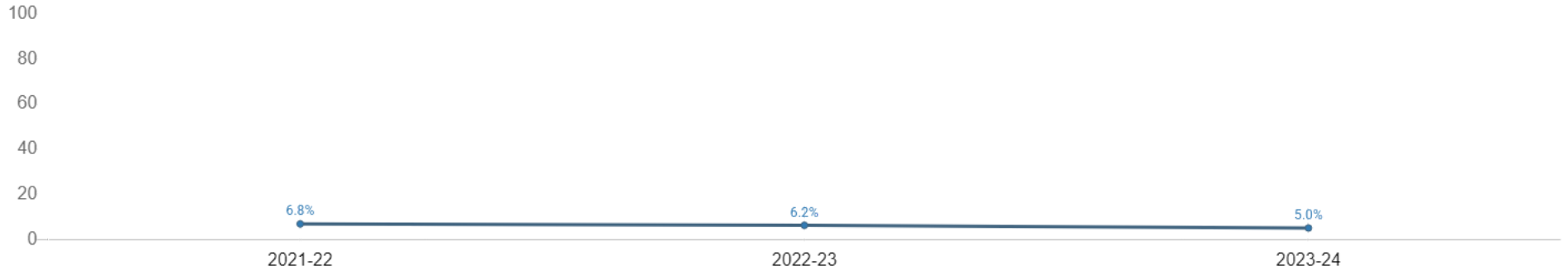

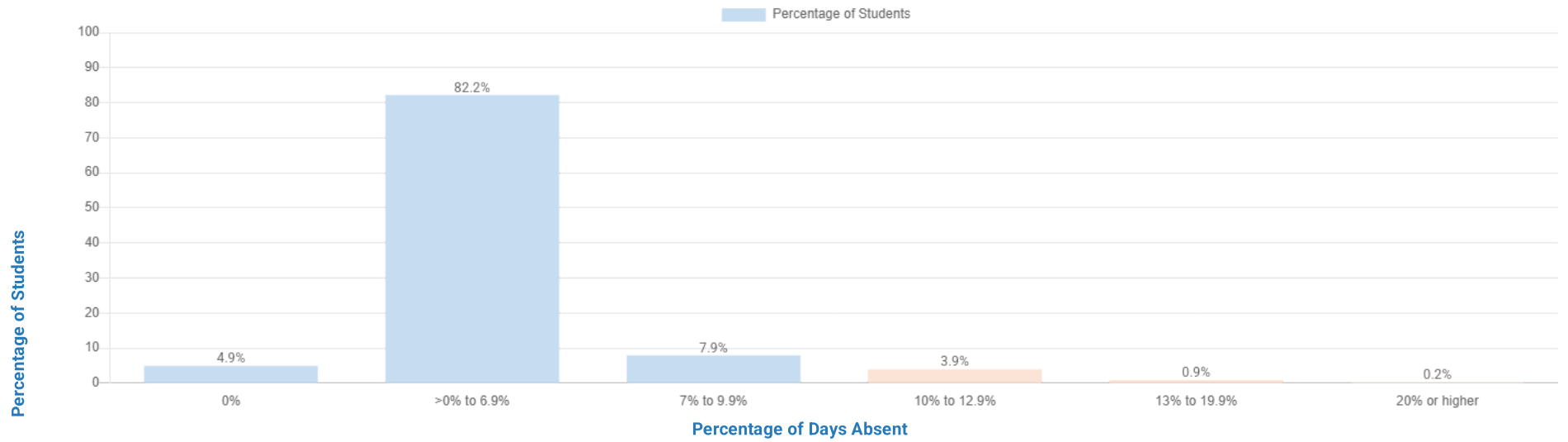

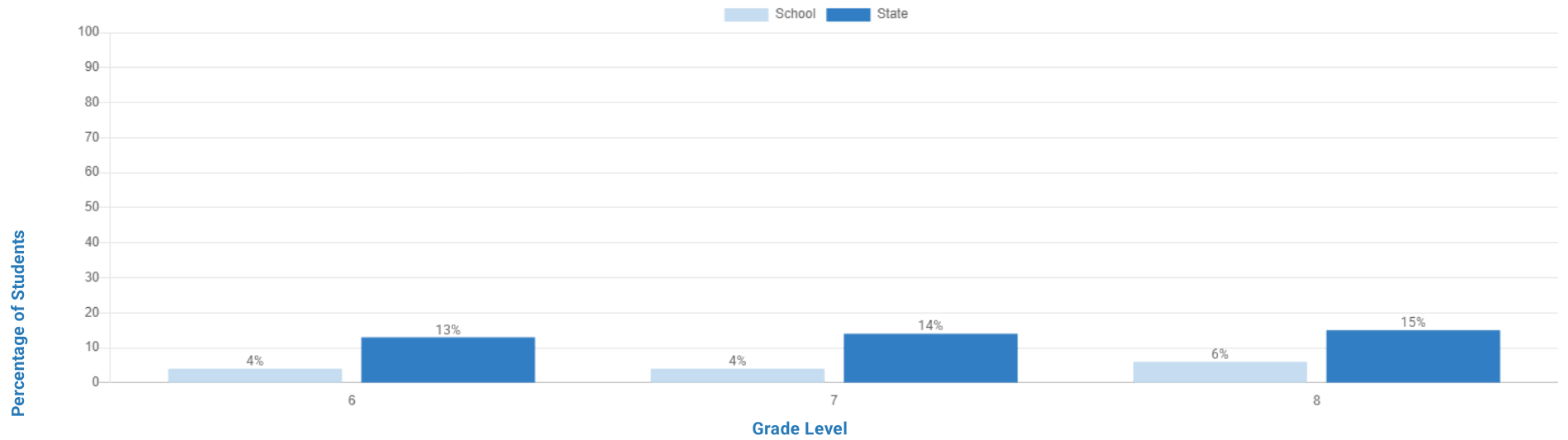

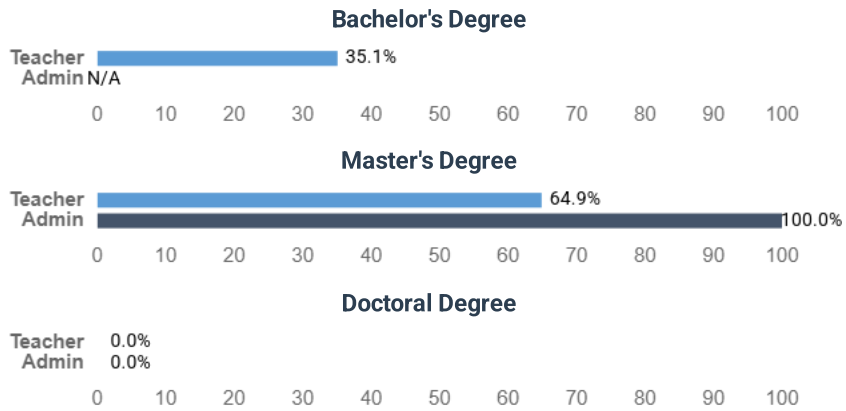

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. The middle school curriculum offers challenging opportunities to all students who have an equal opportunity for success. A unique "rotate and drop" schedule provides ample time for a rigorous core program in Language Arts, Mathematics, Science, and Social Studies. The schedule includes an Enrichment Period which allows students access to the school clubs, to meet with teachers, or schedule peer groups for study or leadership. Additionally, throughout the year, students meet frequently in a Student Advisory Period which offers team-building opportunities, Social Emotional Learning lessons, and executive functioning lessons.

### Staff and Professional Learning:

The Berkeley Heights School District offers a plethora of professional development for all staff in order to keep up with the latest technology and changes in curriculum. Advanced district technology (1:1 Chromebook environment) keeps students and teachers connected through the use of Google Classroom. Common planning time and grade level Team Planning allows for collaboration among staff members to share new ideas and learning on a regular basis, discuss student progress, and devise interdisciplinary lessons and activities.



### Student Supports and Services:

Our Special Education program is highly recognized for its Consultative Model of Instruction. Our Child Study Team includes grade-level counselors, a Reading Specialist, a Learning Disabilities Teacher-Consultant, and two School Psychologists. Support for the individual child, which includes Intervention and Referral Services, is augmented by separate support classes in Math and Reading. Special Education is fully inclusive, wherein special education teachers are paired with assistants to move from room to room in a consultative model that allows for smaller groupings and the use of an "ALL Room," where teachers work with individuals or small groups in an informal atmosphere. Enrichment opportunities and advanced placement courses provide for the needs of the twenty-first-century student. Additionally, students have Extra Period during lunchtime. This class allows students to get a jumpstart on homework, get extra help from teachers, collaborate in group work, and meet with clubs.



### Student Health and Wellness:

All students participate in district-wide SEL & DEI precepts that align with student and staff health and wellness. These precepts incorporate cross-curricular education on topics including but not limited to: Community/Connection, Self-Love, Kindness, Resilience/Growth Mindset, and Diversity. At Columbia Middle School these topics are shared through lesson integration, Student Advisory, Community celebrations, JDEI club activities, and guest speakers. The Student Assistance Counselor and School Counselors within the middle school meet with students in individual, small group, and classroom settings for support in meeting their health and wellness needs.
