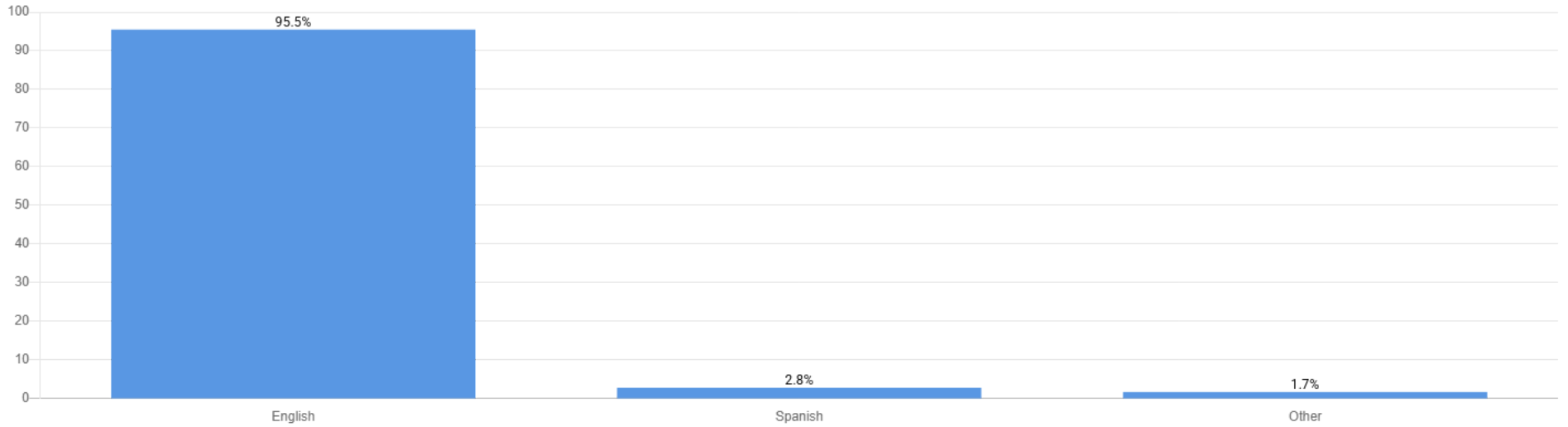

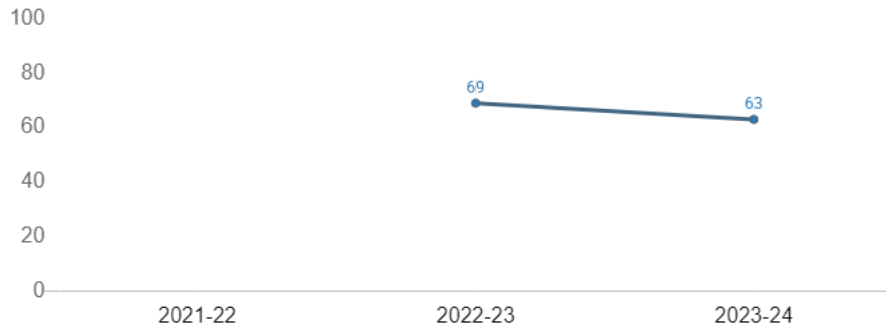

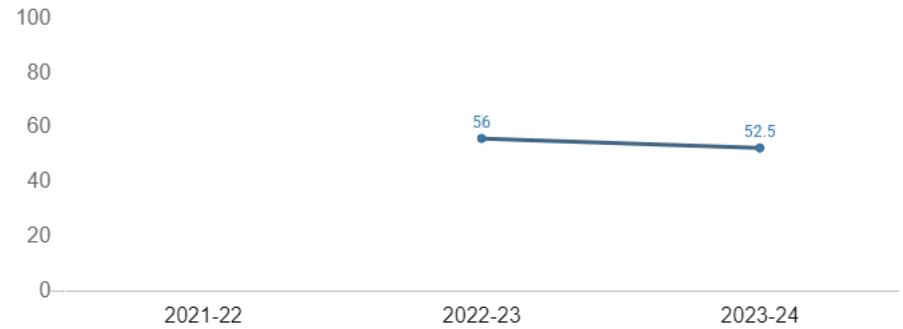

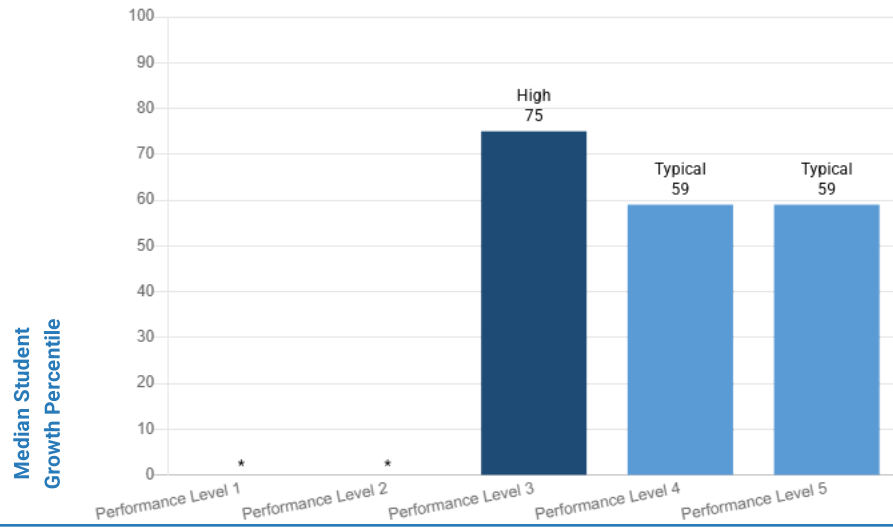

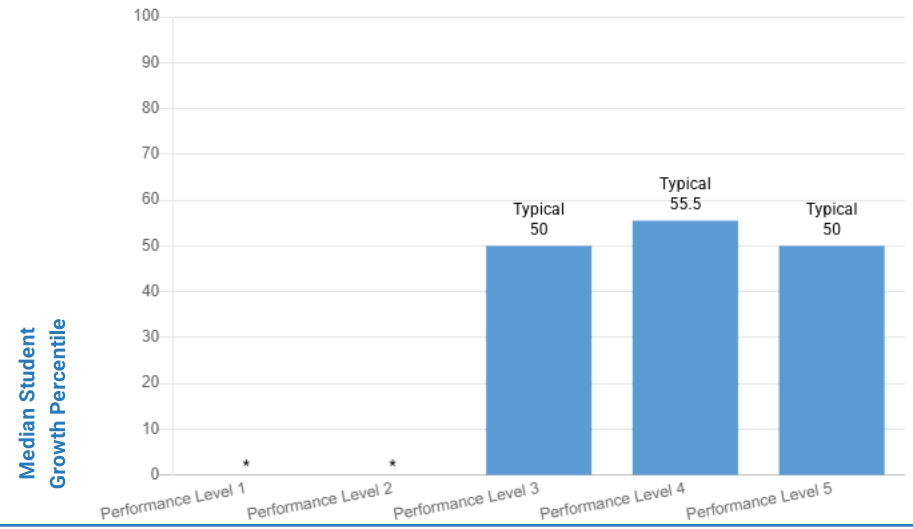

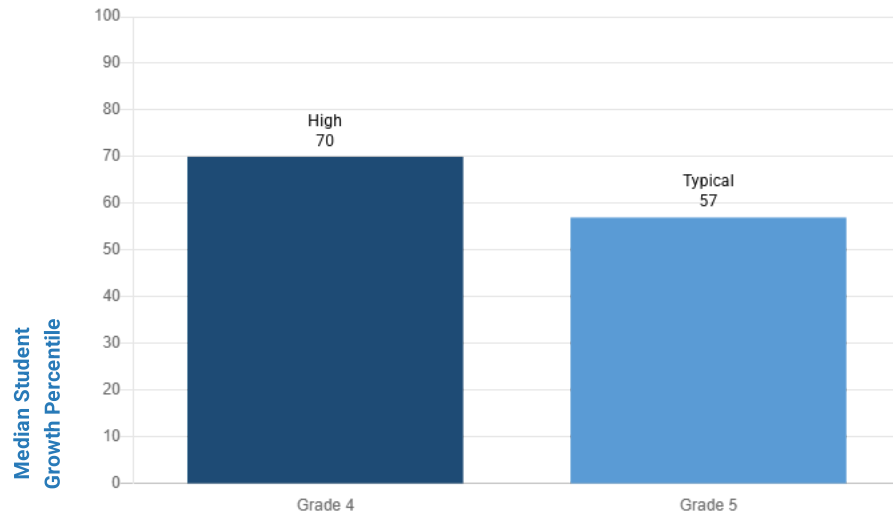

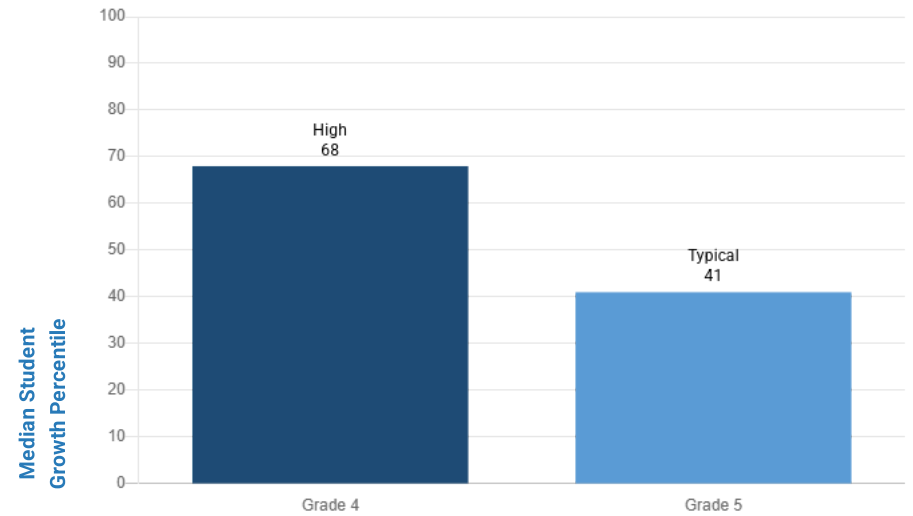

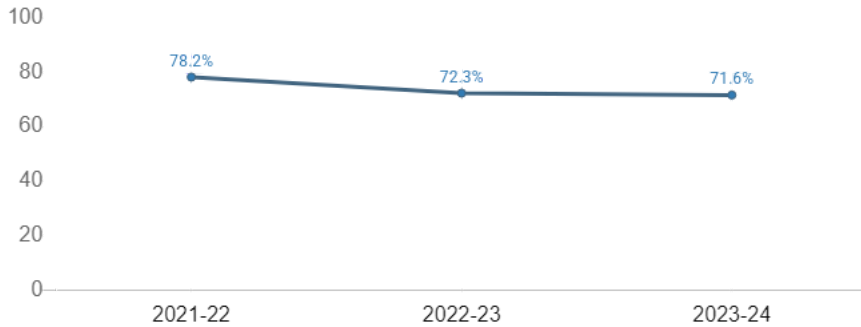

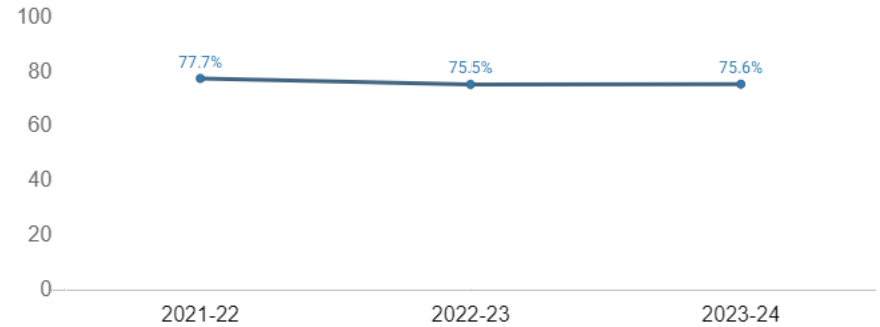
English Language Arts and Mathematics Performance Trends

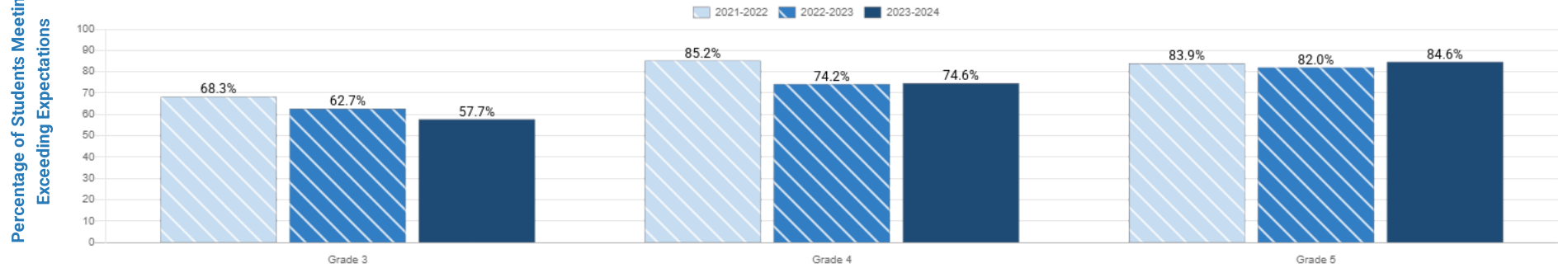

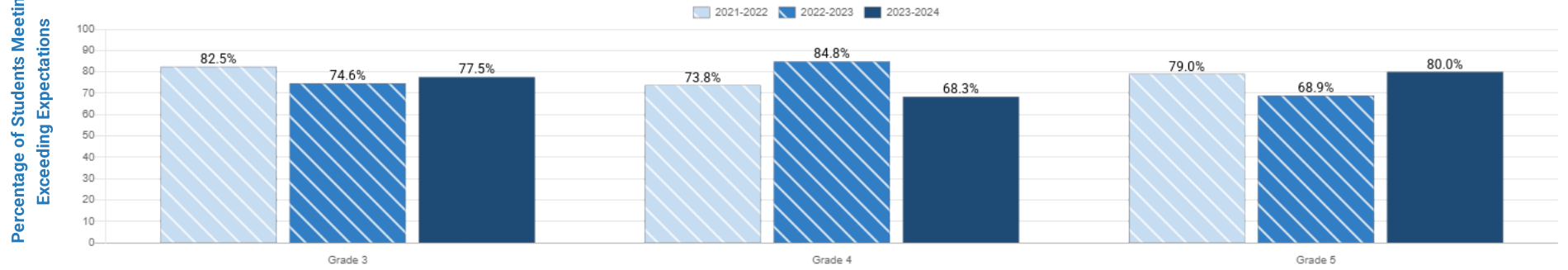

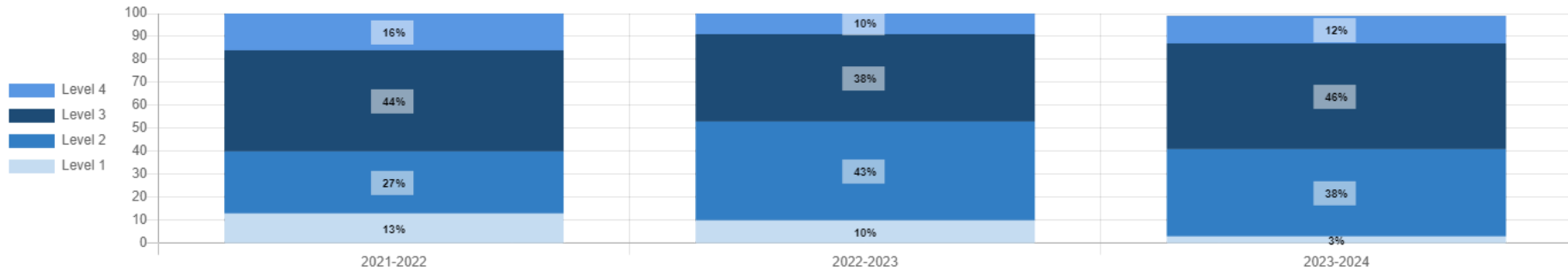

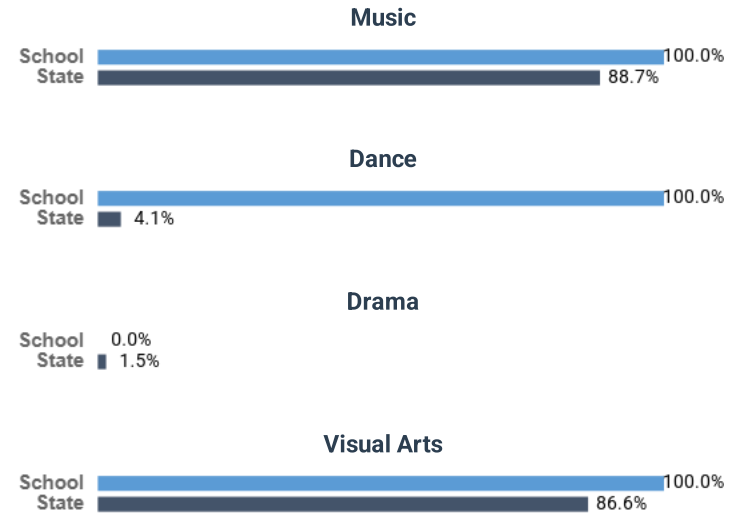

Students enrolled in one or more classes by discipline:



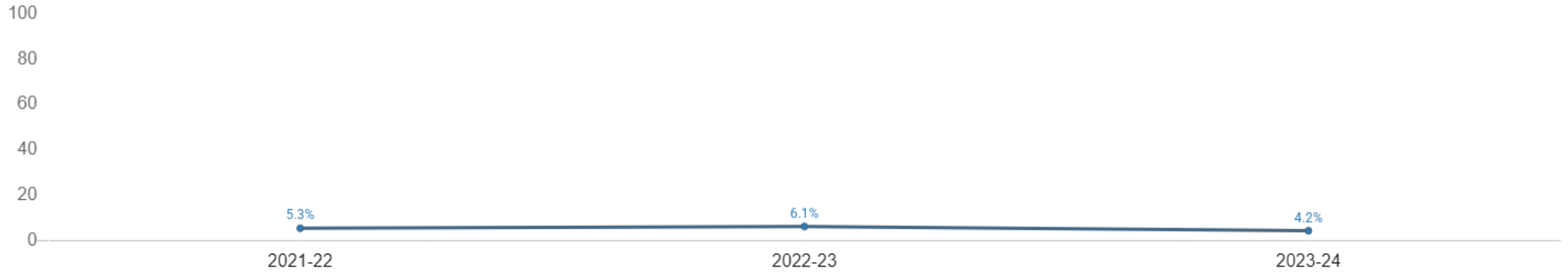

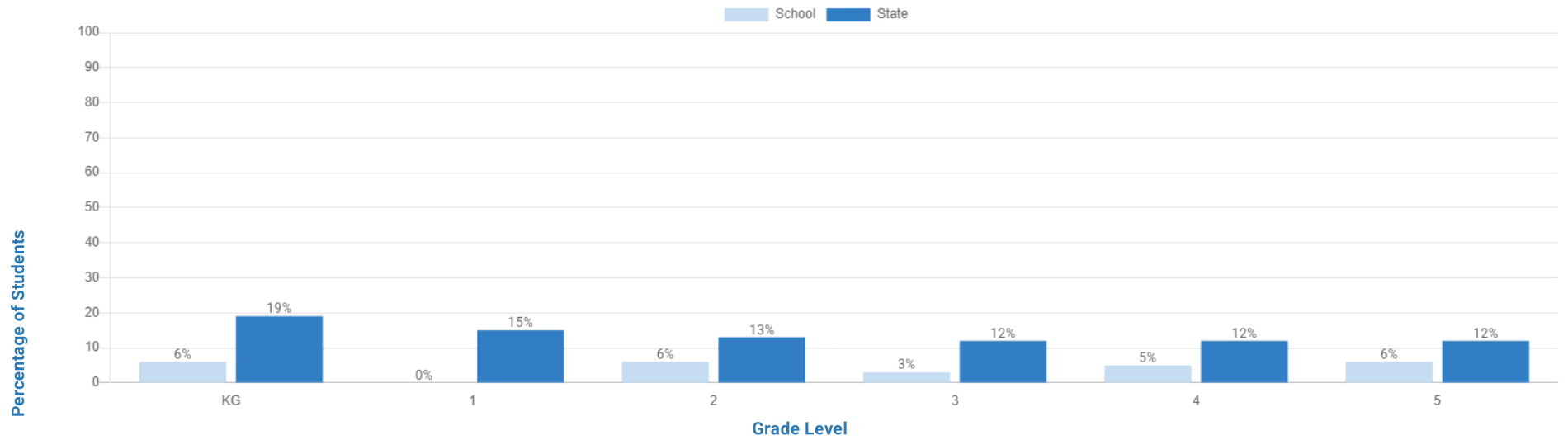

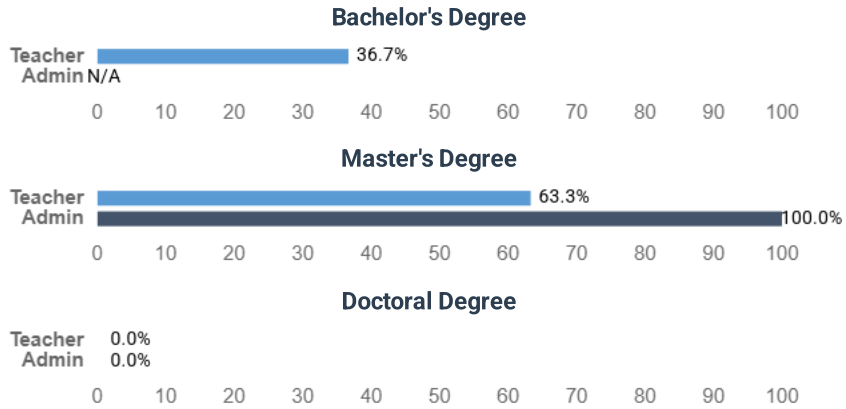

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

In the area of language arts literacy, the workshop model of instruction has steadily increased the level of student choice while promoting critical thinking. The iReady Math series guides our instruction helping students understand number concepts, calculations and more abstract mathematical ideas. The science program is delivered through the use of the FOSS kits and includes many hands-on learning opportunities. The newly approved and adopted Teacher Curriculum Institute (TCI) resources in the area of social studies in Grades 3-5 were introduced with an emphasis on relevance and connections. This includes exploring our community, state, country and world.



Sports and Athletics:

As a kindergarten through grade 5 elementary school, Brookside Place School does not have school-affiliated sports programs. However, many students take advantage of recreation and club sports. Annually, the school holds the BPS Olympics. This is a field-day event with mixed-grade teams which is often cited as a student favorite. Students are assigned to "countries" and the day is complete with customized t-shirts, musical fanfare and an awards ceremony.



Clubs and Activities:

Students enjoy many opportunities for enrichment. Chorus, orchestra, and band rehearse weekly and perform winter and spring concerts. The Student Council plans and executes school-wide initiatives such as spirit week and a canned goods drive. An integral part of Brookside Place School's program is a continued emphasis on the health and wellness of its students and staff. Health records are carefully maintained by the school nurse. The New Jersey Department of Education requirements for physical fitness are reached through student participation in physical education classes and daily recess time.

Facilities:

In addition to sixteen to eighteen regular education classrooms, there is a multi-purpose room for assemblies, physical education and lunch. The art room has a kiln and the media center / library has a robust offering of books, magazines and maker space activities. The 2021-2022 school year marked the return of special subject instruction in their dedicated spaces instead of special subject teachers visiting individual homerooms. Other available spaces include areas for speech/occupational therapy and counseling services. The grounds include two playgrounds and a large blacktop area for outdoor play during recess. There is also a butterfly garden and reading garden.



School Safety:

A School Safety and Climate Committee meets three to four times per year to discuss topics related to the physical and emotional safety of the students and staff. The committee includes the principal, staff members, and parent/guardian representation.



Technology and STEM:

Mostly through the Media Center, students engage in several activities throughout the year that highlight learning in the area of STEM. There are also two evening STEM events planned. One is funded by the BPS PTA and the other is coordinated by the Student Council.

Other Information:

The Brookside Place School day begins at 8:42 a.m. with a half hour lunch period and a half hour for recess. Dismissal is at 2:55 p.m. In addition to the study of academic subjects (math, social studies, science and language arts), students in grades kindergarten through grade 5 attend classes in art, music, Spanish, physical education and library/media center. A robust professional development program for teachers and staff helps our educators explore, practice and implement best practices. Technology skills are woven into all areas of study. Laptops and Chromebooks are available for student use. Students in the upper grades use the Google Classroom platform for many areas of study and each classroom is equipped with a moveable Smart Panel for enhanced learning opportunities. Safety is a core value at Brookside Place School. In addition to monthly security and fire drills, the school enjoys a strong and supportive relationship with the Cranford Police Department. A full-time nurse provides excellent care to students and staff. At Brookside Place School a strong home-to-school connection provides an excellent foundation for learning. This begins at Back to School Night and continues throughout the year through many avenues: parent/guardian and teacher conferences, Sunday emails to the community from the principal, BPS web page updates, timely reminders and more. We are also fortunate to have a very active and supportive Parent Teacher Association. This group plans many fun and educational student activities. The PTA also supports in-class education initiatives through its Teacher Mini-Grant program. Year in and year out, Brookside Place School proves itself to be an exceptional community of learners.
