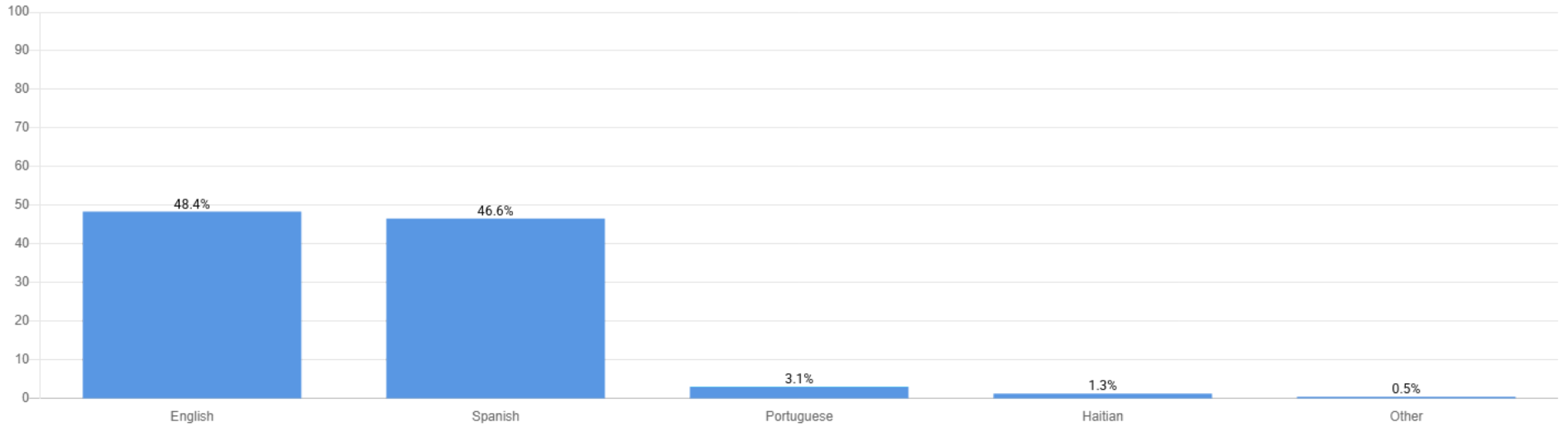

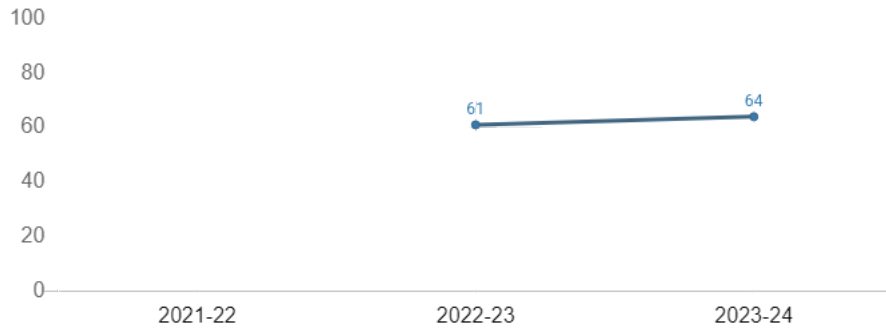

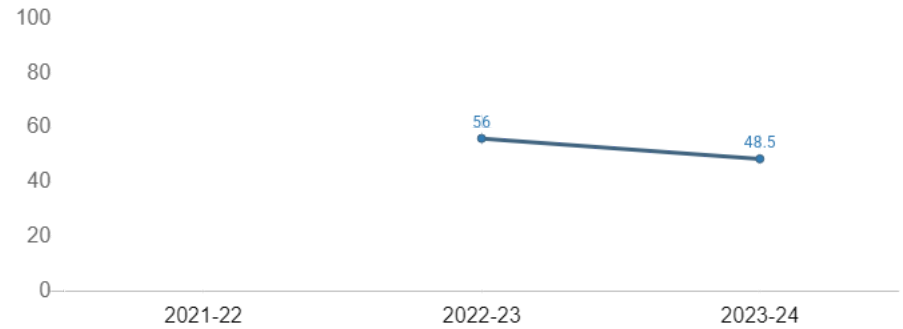

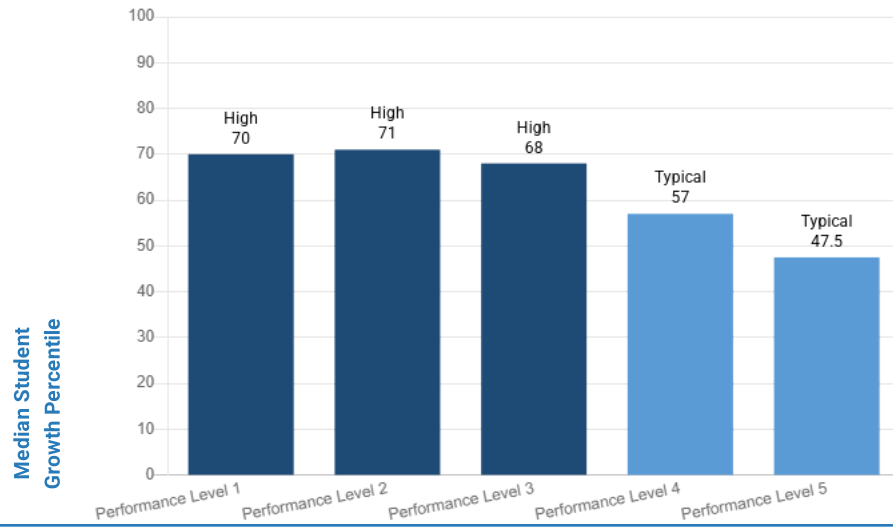

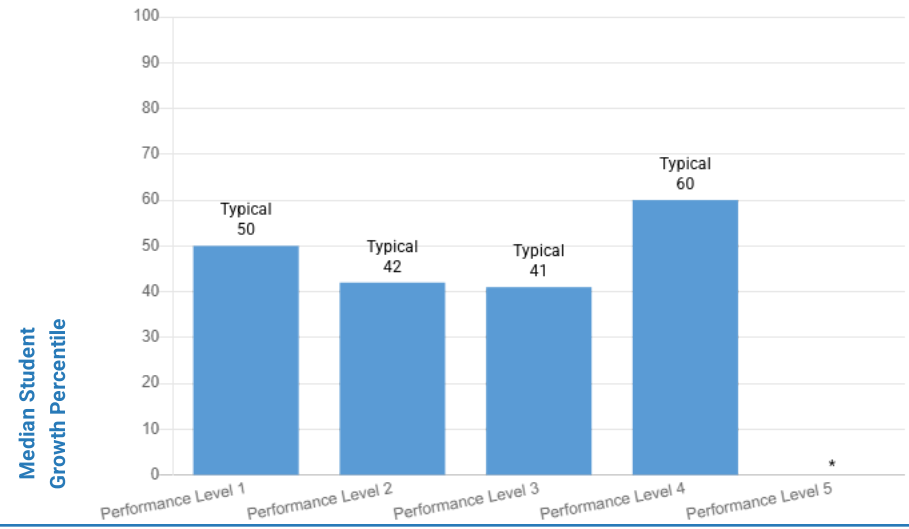

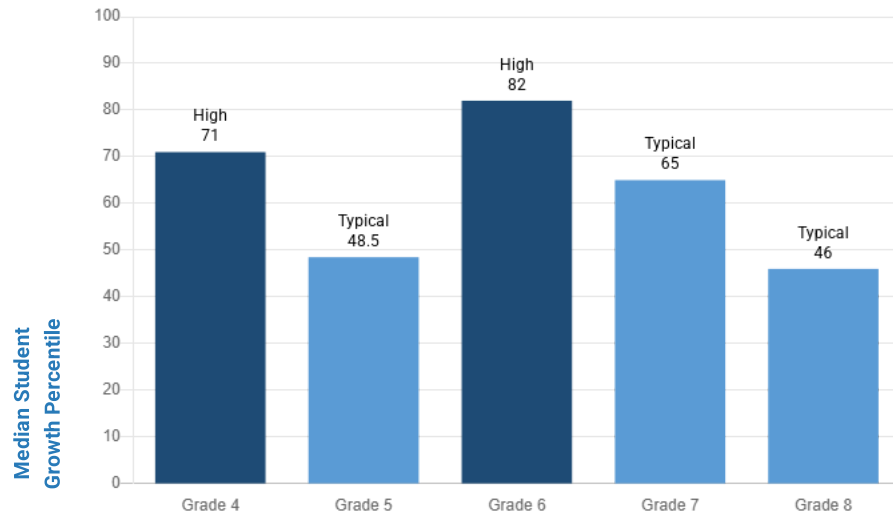

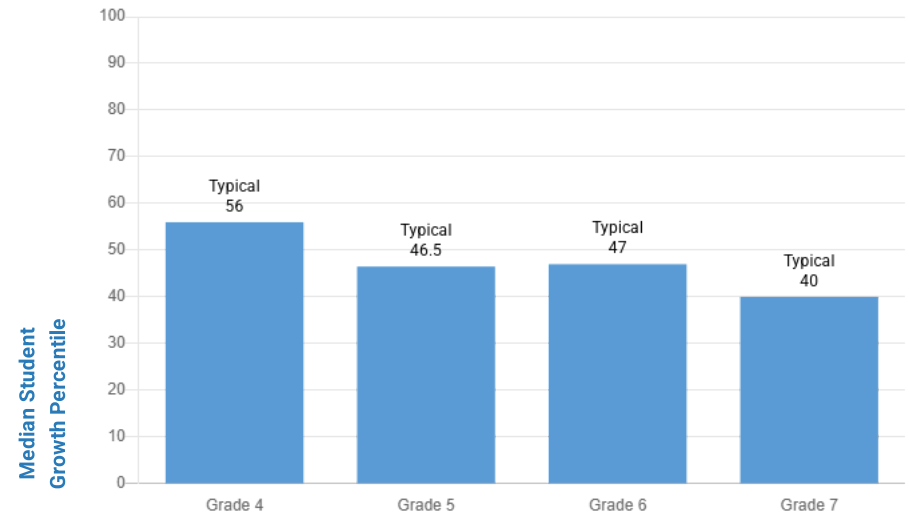

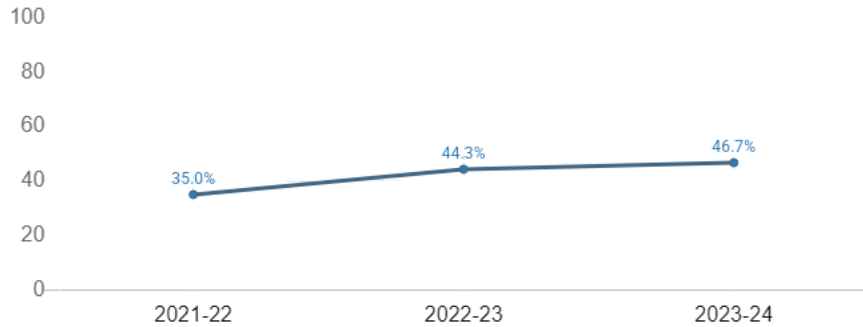

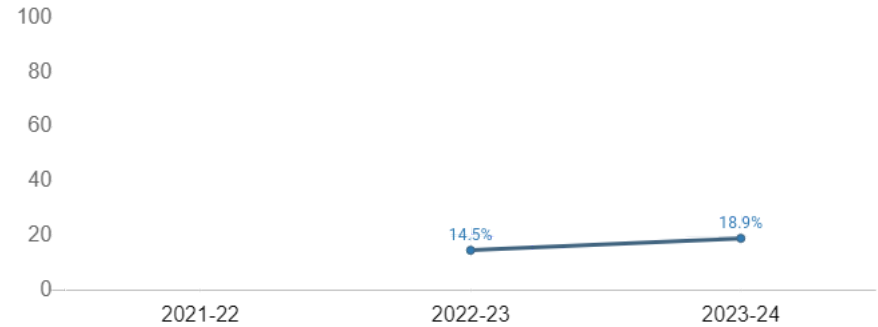
### English Language Arts and Mathematics Performance Trends

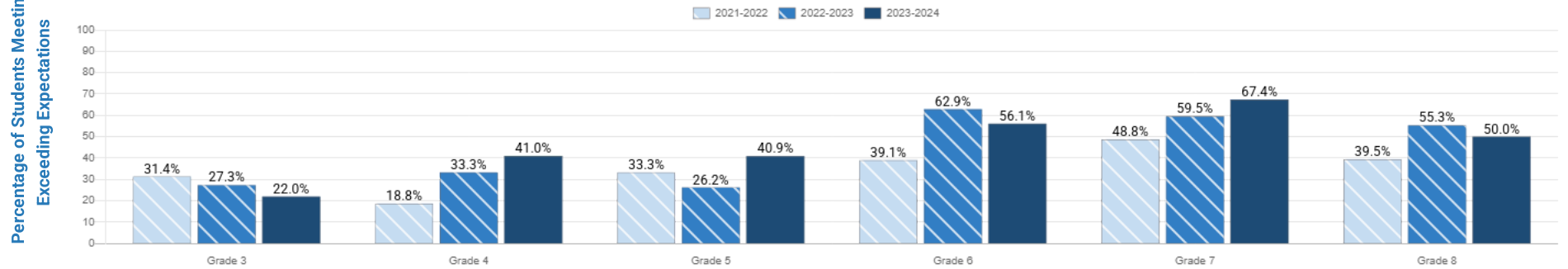

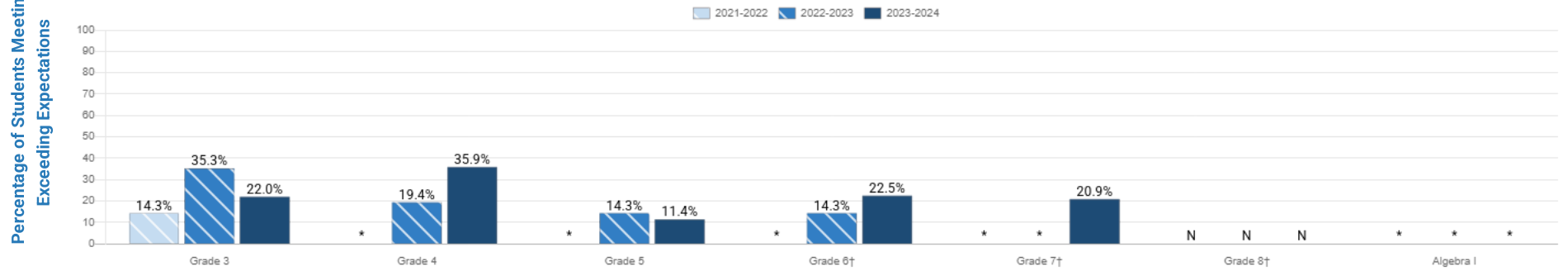

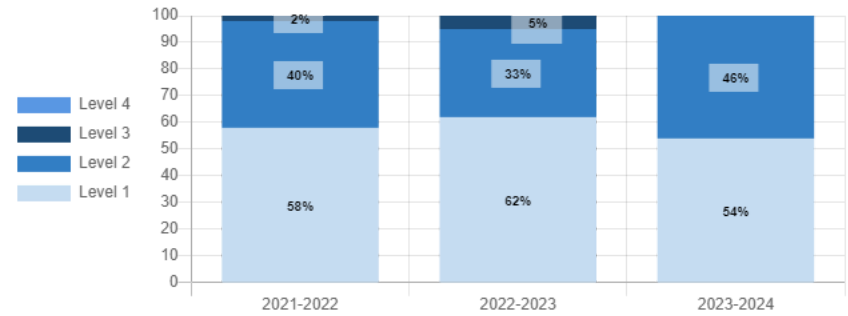

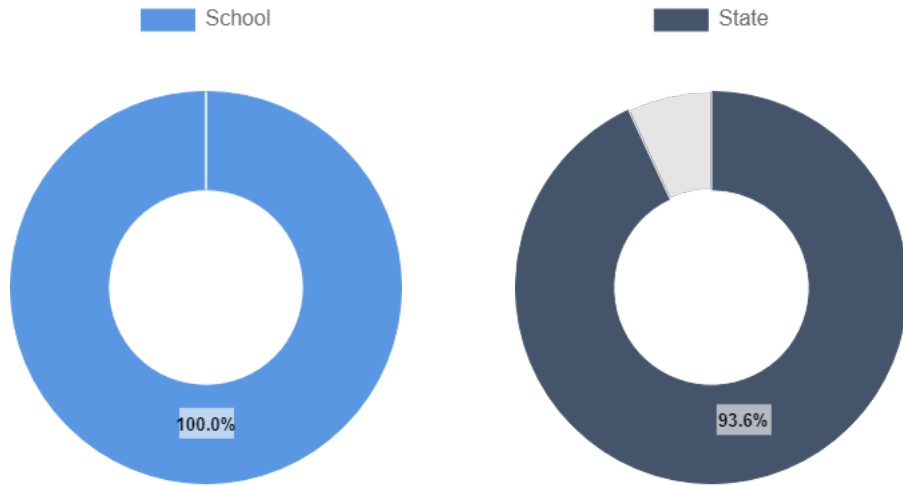

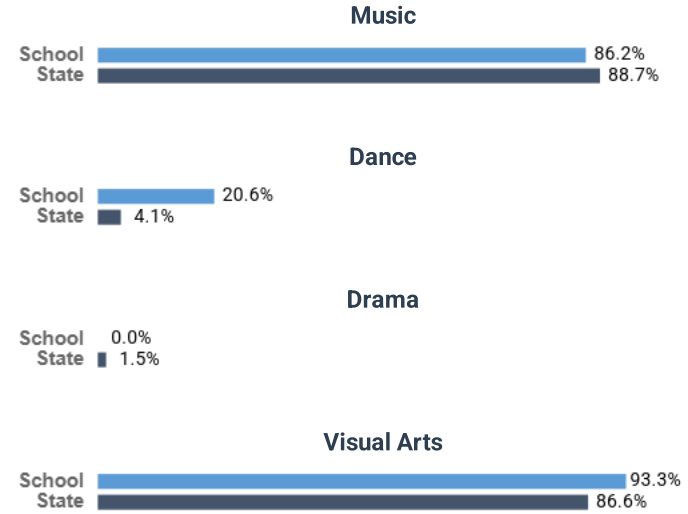

**Students enrolled in one or more classes by discipline:**



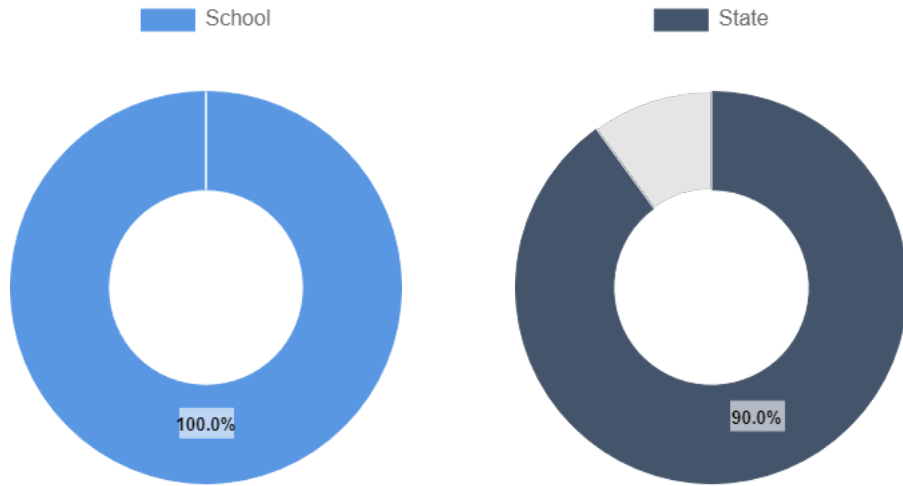

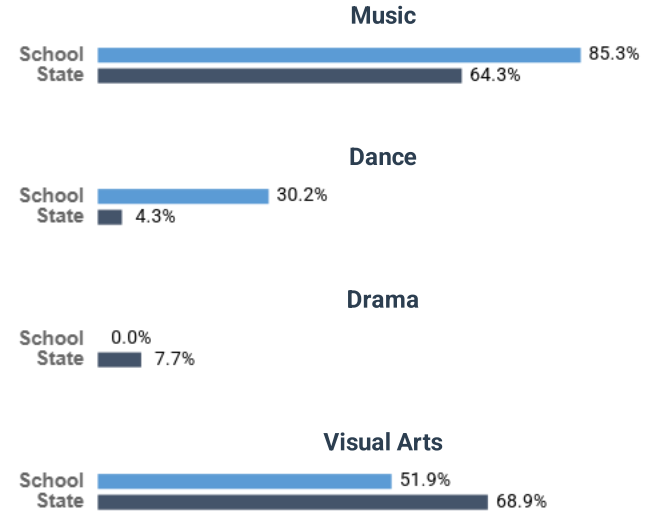

**Students enrolled in one or more classes by discipline:**



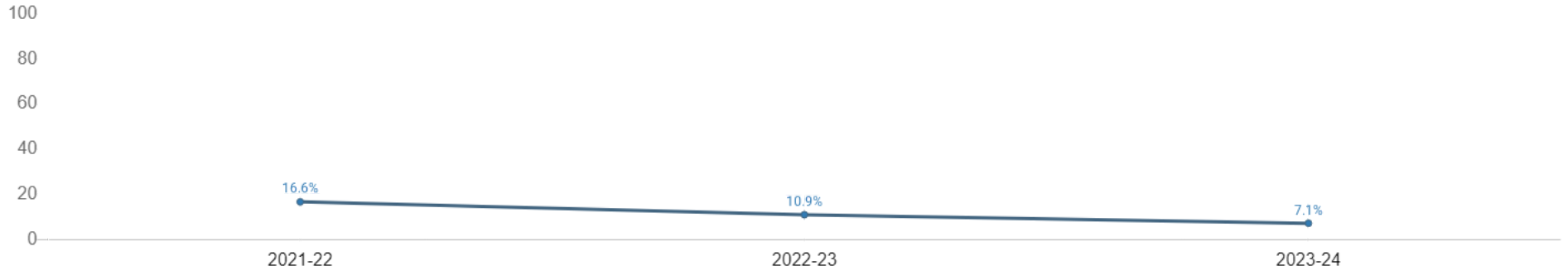

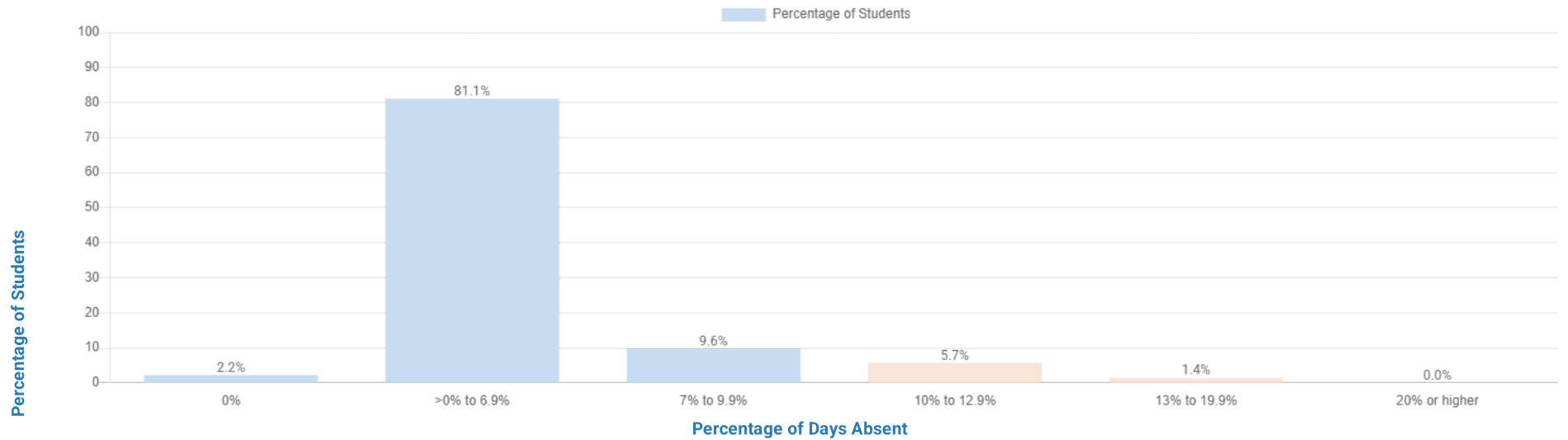

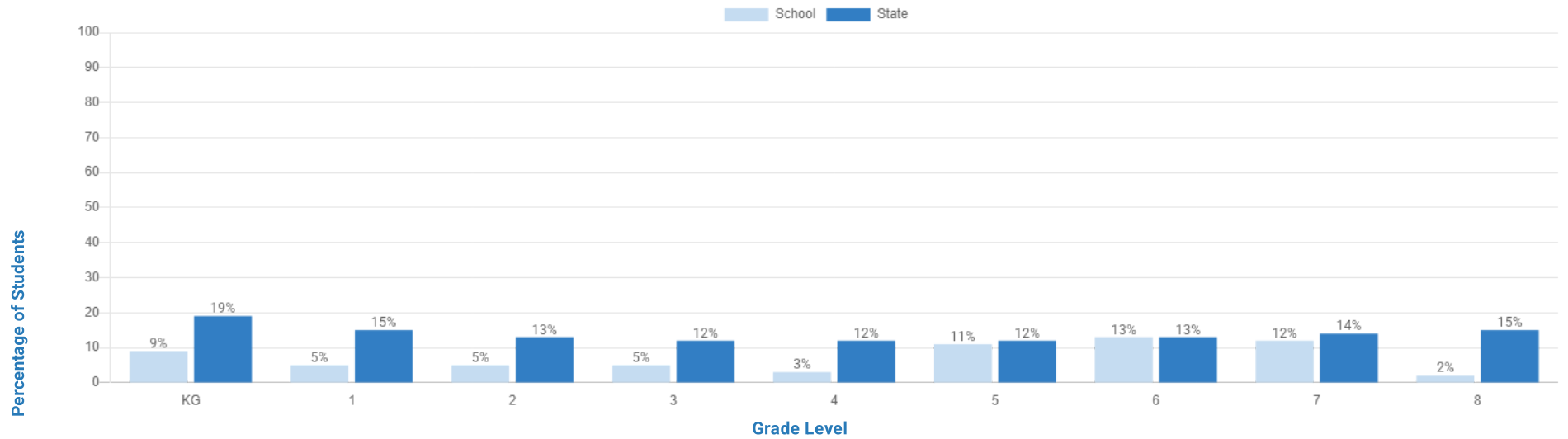

## Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

**Key terms for staff data:**

**Teachers:** All classroom teachers

**Administrators:** Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

**Experience:** Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

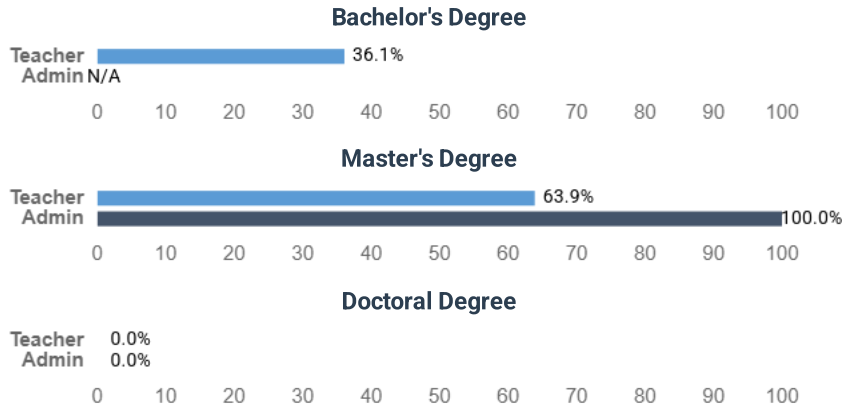

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

"iPrep Academy is a magnet lottery school that is part of the Elizabeth Public Schools. Every student in the district in grades K-8 has the opportunity to apply. The school utilizes a One-to-One blended learning environment where every student has either an HP tablet or laptop. We incorporate Unified Classrooms by posting class content and lesson plans on it so that it is available to students and parents 24/7. School No 8 is an AVID (Advancement Via Individual Determination)Elementary (AE) Certified school. AVID Elementary classes focus on WICOR, W-Writing to learn, I-Inquiry, C-Collaboration, O-Organization, and R-Reading to learn. Students focus on organization by using binders and note taking by using either 2-column, 3-column or Cornell Notes. High order questioning is a priority with AE which includes the way teachers and students create highly skilled questions and the way in which they are answered. AE is based on 4 essentials; Instruction, Culture, Leadership and Systems. iPrep Academy partnered with Future City Elizabeth in Estuary Day, 5th Grade Drug Abuse Resistance Education Program (DARE) with the Elizabeth Police Department. Our students participate in Honor Roll/Scholars celebrations, Read Across America, American Education Week, Multicultural Parade and Door decorating contests, Fall Harvest Celebration, Poetry and Research Presentations, School Wide Gallery Walks, Food and Coat drives, and the Union County Teen Arts program.
