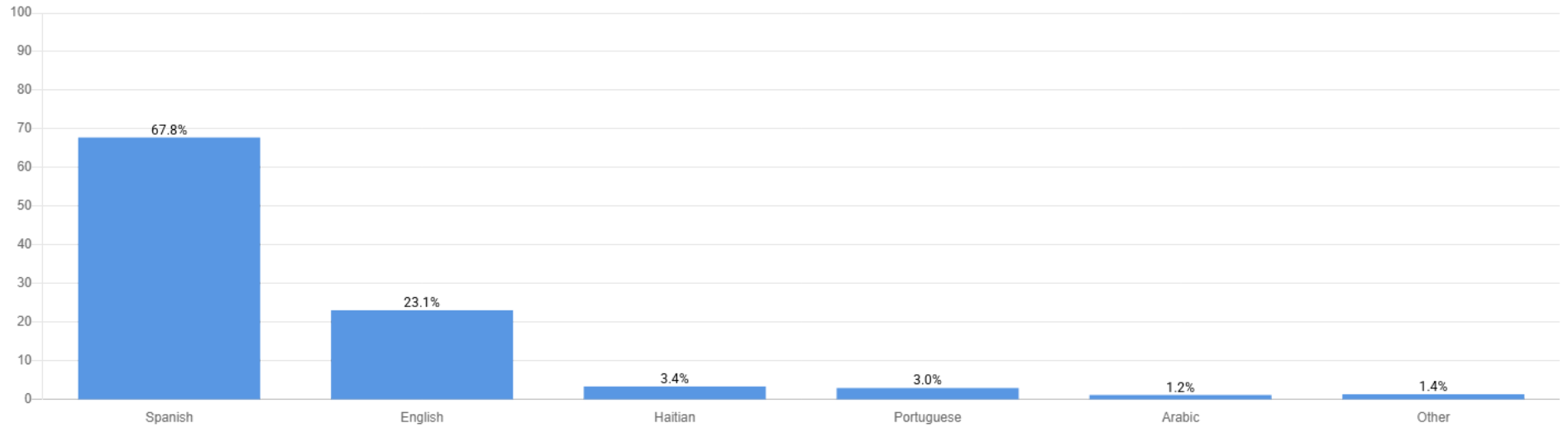

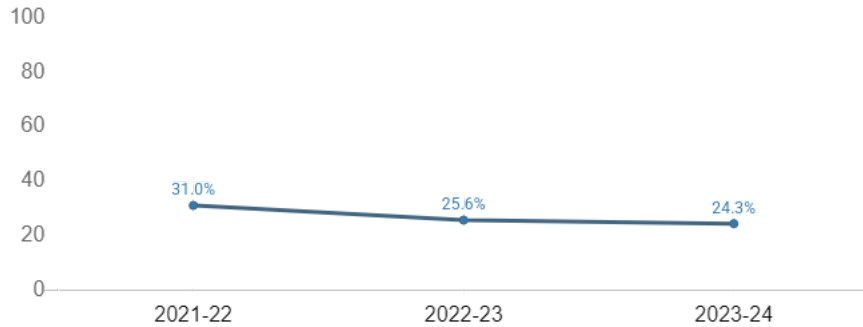

### English Language Arts and Mathematics Performance Trends

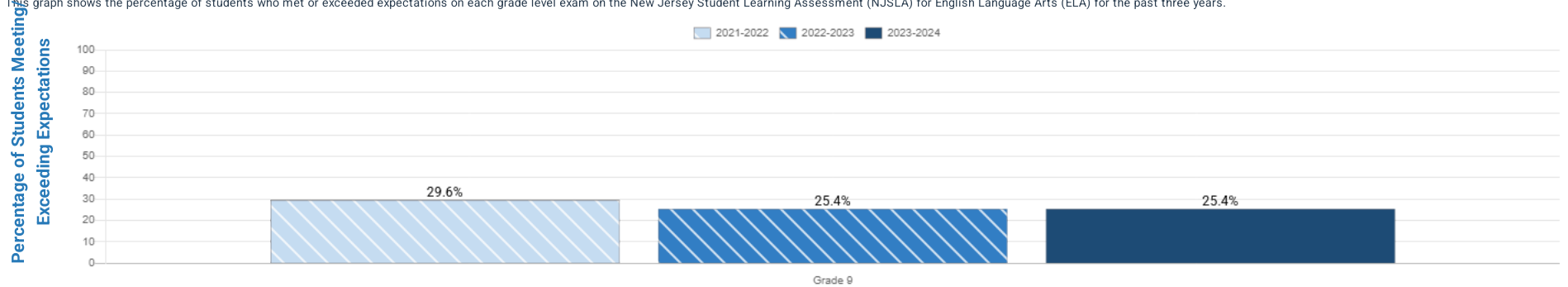

High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 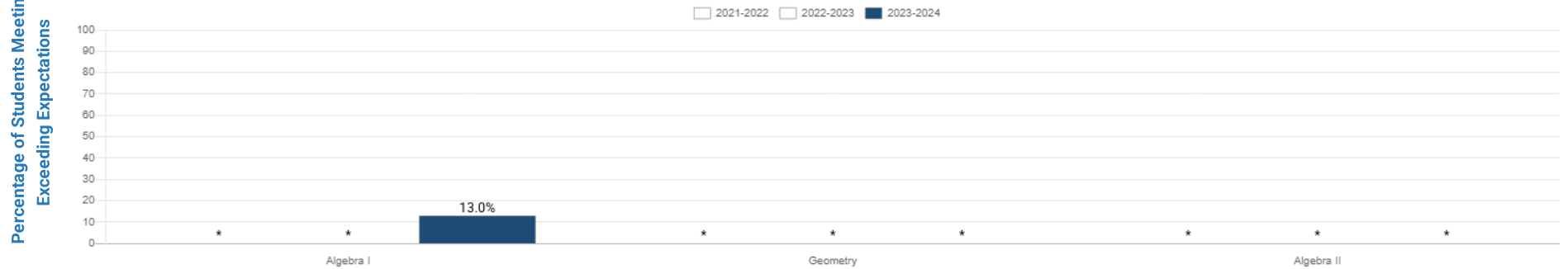

The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

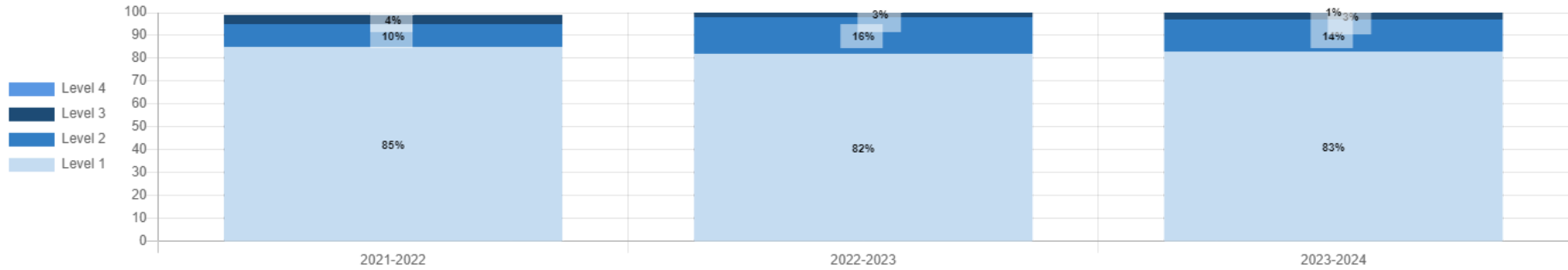

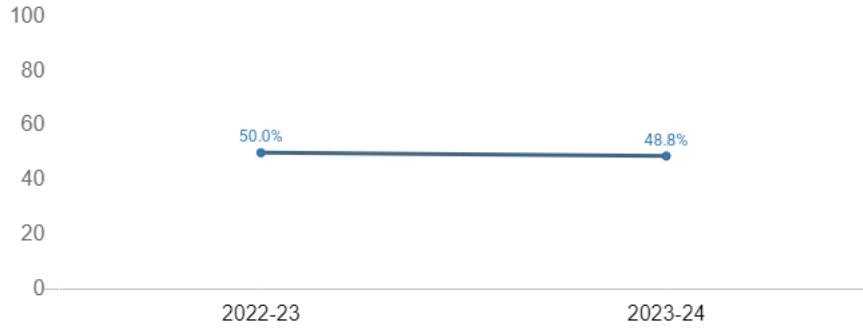

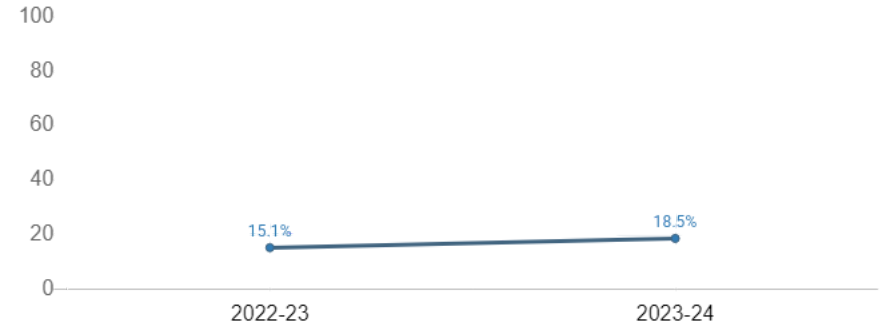

#### Students taking one or more AP or IB exam

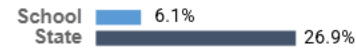


#### Students with one or more exams with a score of at least 3 on AP exams or 4 on IB exam

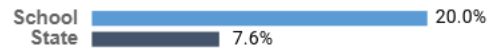

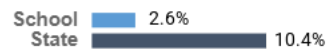

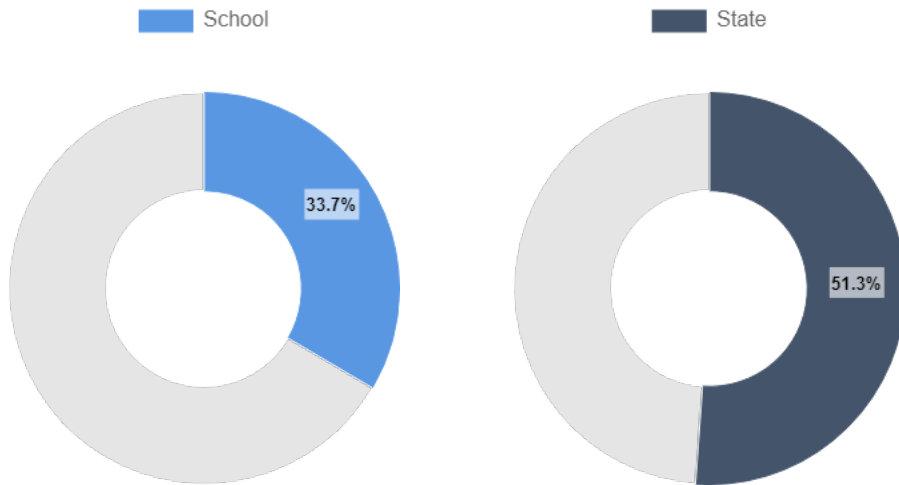

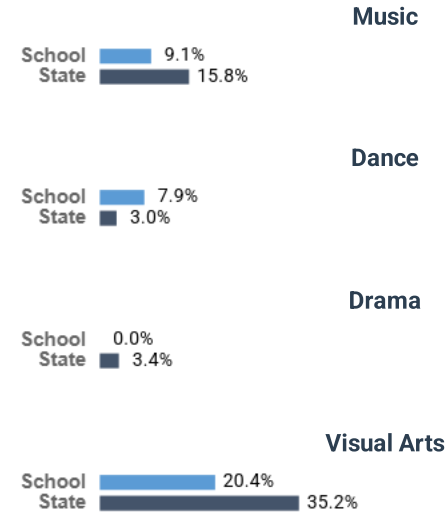

## Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

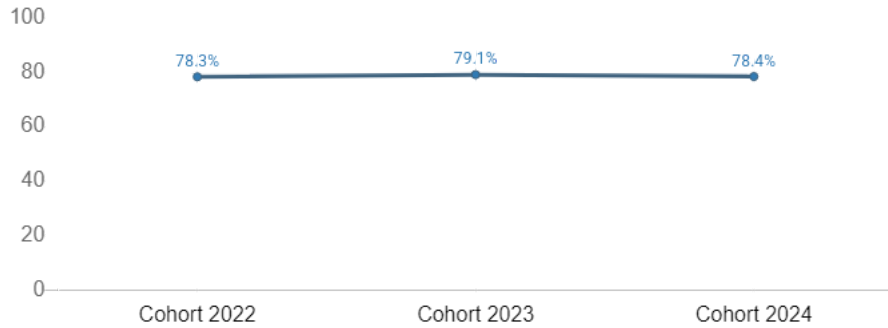
To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. The Federal Graduation Rates and Accountability Graduation Rates tables reflect the "federal version" of the graduation rate. 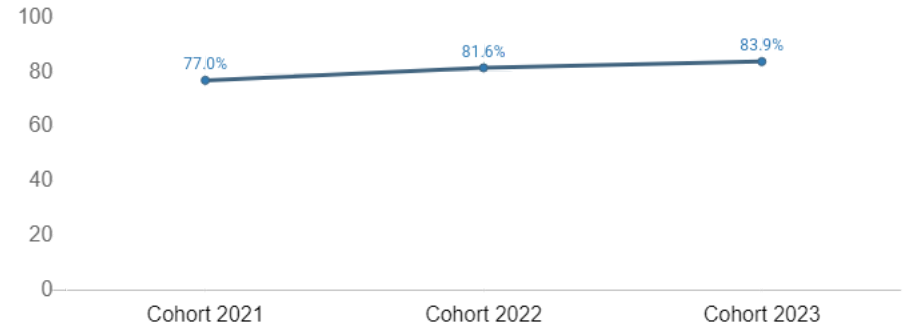

## Graduation/ Postsecondary

Graduation rates are calculated based on the adjusted cohort graduation rate calculation. Beginning in the 2020-2021 school year, the NJDOE was required to make changes to the methodology used to calculate the adjusted cohort graduation rate for federal reporting and accountability purposes. The United States Department of Education (USED) determined that the NJDOE must only include students who receive a diploma that is fully aligned with the state's standards, meaning they have met the state's graduation assessment requirements, course requirements, and local attendance requirements. This means that students with disabilities who did not meet some or all graduation requirements because of a modifications or exemption in their Individualized Education Program (IEP) may not be counted as graduates in the calculation of the adjusted cohort graduation rate used for federal reporting and accountability purposes. It is important to note that this was only a change to how graduation rates are calculated for federal reporting. It does not affect requirements to earn a diploma or the type of diploma that the state awards to students with disabilities.

As a result of these changes, the NJDOE began calculating two versions of the adjusted cohort graduation rate starting with 2021 graduation rates. The "federal version" aligns with ESSA requirements and USED guidance and is used for federal reporting and ESSA school accountability only. The "state version" continues to use the same methodology used prior to 2021 and reflects all students who received a state-endorsed diploma.

To be included as a graduate in the federal version of the graduation rate, students must have met state course requirements and local attendance requirements for graduation. Additionally, students must meet the graduation assessment requirements in place based on the year they are graduating, regardless of their graduation cohort. The graduation assessment requirements for the classes of 2022 through 2024 have differed as a result of executive orders in response to the pandemic and new legislation. As a result, the calculation of the federal version of the graduation rate has also changed.

In this section of the reports, the Graduation Rate Trends and Progress charts and Graduation Cohort Profiles (4-Year, 5-Year, and 6-Year), as well as the graduation rates reported in the Summary Reports, reflect the "state version" of the graduation rate. The Federal Graduation Rates and Accountability Graduation Rates tables reflect the "federal version" of the graduation rate. ## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

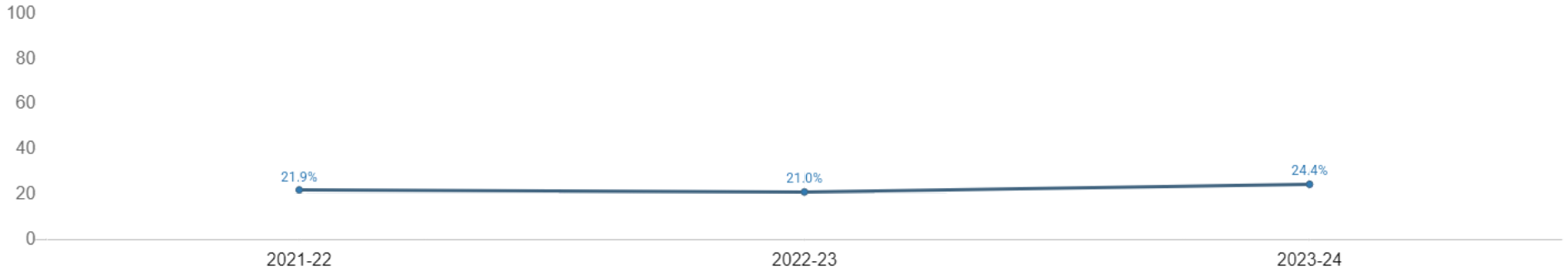

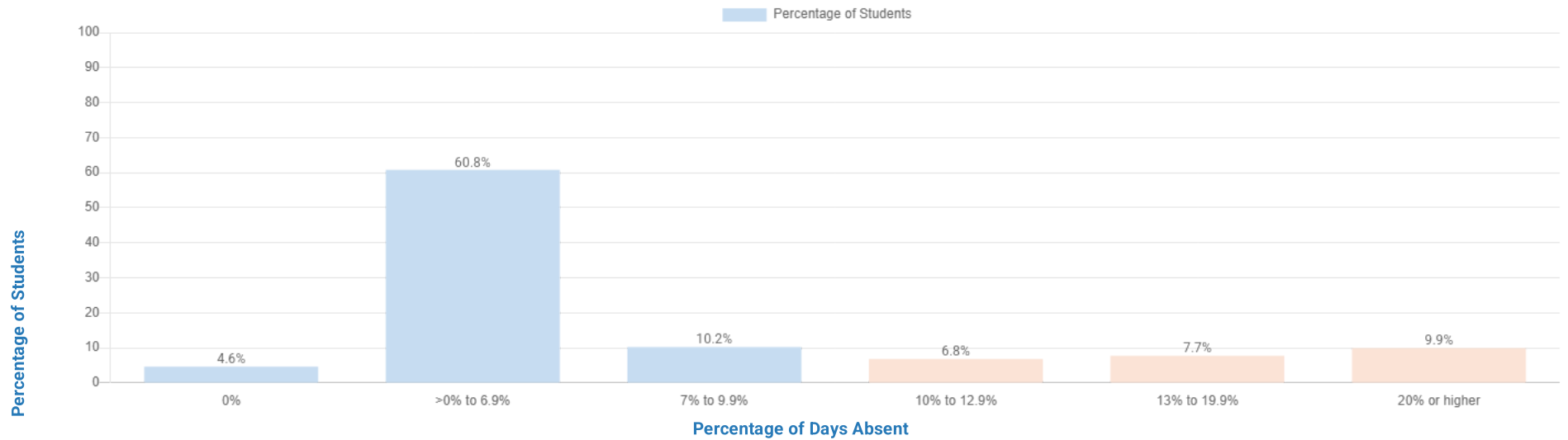

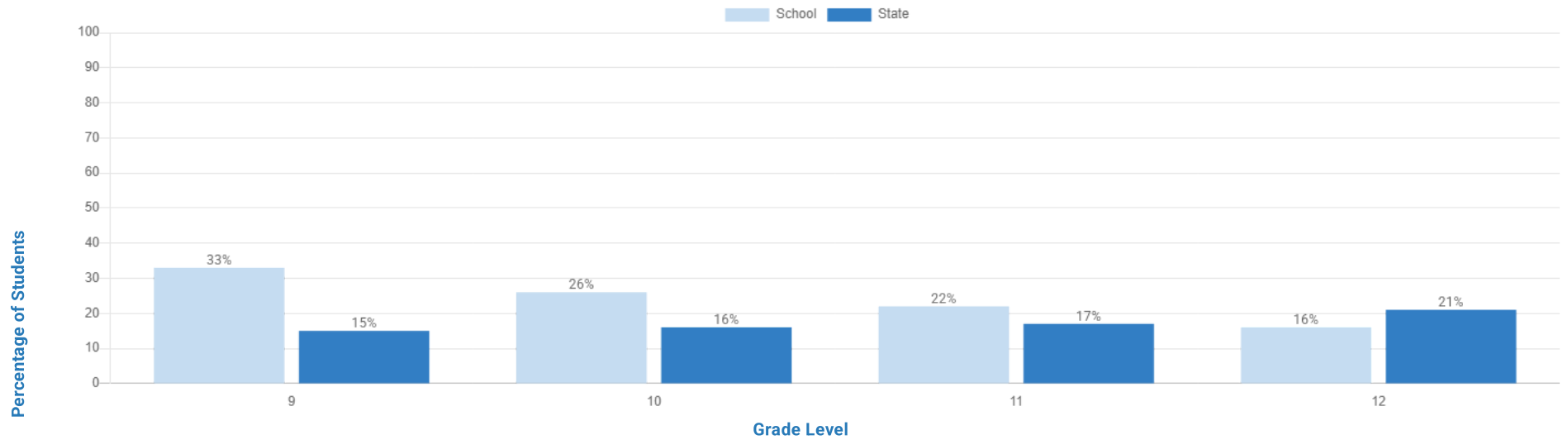

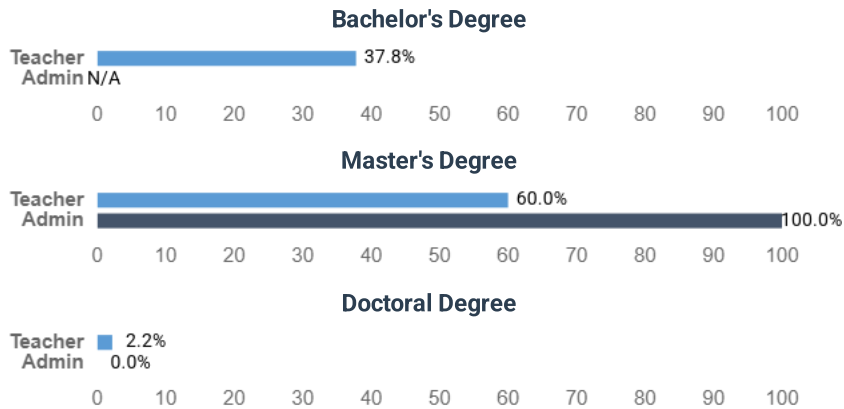

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. ### Before and After School Programs:

Halsey offers after school tutoring in all core subject areas as well as a Bilingual Enrichment and Support program (BASP) and the APEX Online credit recovery and accrual course.



### Staff and Professional Learning:

Halsey Academy teachers meet weekly in Professional Learning Communities and Common Planning Time. All teachers participate in these weekly meetings, that address all aspects of school performance, from instruction to climate and culture. Topics discussed on these days relate to lesson planning, classroom management, classroom rigor ideas, RTI/I&RS, student conferences, testing, reducing chronic absenteeism, using data to drive instruction. Our School Improvement Panel (SciP) team meets once a month as well to discuss areas where our school can improve and put action steps in place to accomplish them.



### Postsecondary Information:

All students are required to take the SAT as a graduation requirement, and 2 school day administrations are scheduled. An after school SAT program is available to our students. The district also sponsors a college fair, open to all students. Specific programs offering support to complete the FAFSA are provided after school hours. Our AVID program provides additional support through college visitations, study and coursework support and help with the application process.

### Student Supports and Services:

Through a grant, Trinitas hospital provides on site support services within Halsey Academy. Our RISE initiative trains teachers in utilizing positive behavior supports. Halsey supports a bilingual program, with courses in both French-Creole and Spanish. Halsey offers a multitude of services for students with special needs, from in-class support, to a specialized program for moderate cognitive students. After school tutoring is open to all students. A Bilingual after school support program (BASP) is also available to ML students.



### Student Health and Wellness:

Youth Enrichment Services (YES) through Trinitas staffs social workers whom students can schedule individual meetings to discuss their issues. A dedicated full time Social Worker and Climate and Culture Coach assist with the SEL needs of our students.



### Parent and Community Involvement:

As part of our Career Pathways Grant, an advisory board of business and industry partners, post-secondary institutions, educators, parents, and administrators continues to meet twice yearly. Our Administrators are also members of the Gateway Chamber of Commerce Education Workforce Committee, attending monthly meetings on student career readiness and businesses knowledge. Select Halsey students participated in the Future Cities, Inc. Leadership series including trips for Estuary Day and Environmental Day.

Halsey utilized the Panorama school climate survey in 2023-24, administering the survey to parents, students and staff, in the fall and spring. Results of the survey were shared with students during grade level assemblies, with staff in PLC meetings and with parents via various communications. Survey results indicate that the school's climate and culture continues to improve and students and staff feel more safe.



### Facilities:

Halsey shares its location with another Dwyer Academy campus. However, each campus maintains its individual space but share a gymnasium and a few specialized classrooms. Since Halsey Academy renovated its Media Center, it has enhanced the available technology for students and staff. The annex academy building provided our 9th grader students with a more personalized learning environment. New lockers and bathrooms have been added to the annex campus.

Students enrolled Halsey Academy complete a rigorous and engaging college preparatory program, and also participate in exciting programs, electives, classes, and activities focusing on the development of each student into a strong, ethical, and skillful person. Halsey Academy's programs emphasize rigorous academic instruction, peer leadership, community service, and student government activities. Honors and AP classes are available to all eligible students. All Halsey Academy students are expected to comply with the rules, regulations, and policies of the Academy including the mandatory school uniform. The PBSIS implementation continues to grow in Halsey. Data on office conduct referrals, suspensions and attendance is analyzed and shared with the staff in order to develop interventions and improve graduation rates. RISE also seeks to impact overall school climate and culture through a reinforcement of positive behaviors and promoting the RISE elements: Respect, Integrity, Safety and Empathy. Monthly drawings, raffles, staff luncheons, and student activities such as field day, fun day and other activities are used to create a welcoming and friendly atmosphere for students, staff and visitors. Halsey Academy continued moving forward in utilizing our One-to-One laptop initiative. Using online tools, teachers were able to connect to students during the school day, as well as at home and when abroad. Students at Halsey have access to mass media equipment and are involved in creating, editing, and producing videos to highlight successes and show our strengths. The ability to personalize the student's experience continues to drive instruction and has changed how our students learn and grow. Real time data allows all teachers and staff to have instant access for use in interventions, enrichment, and parent conferences.
