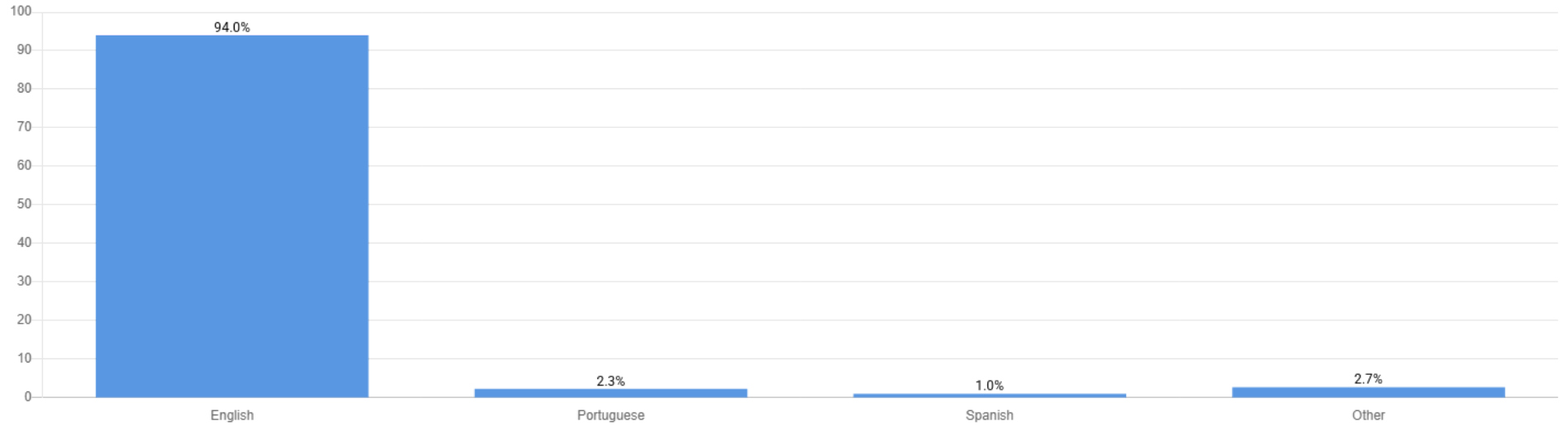

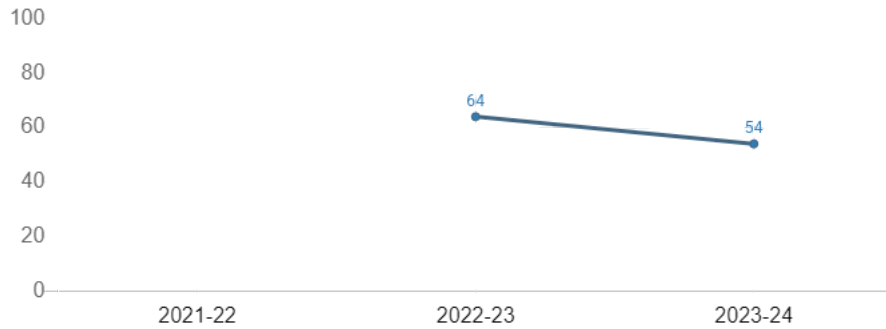

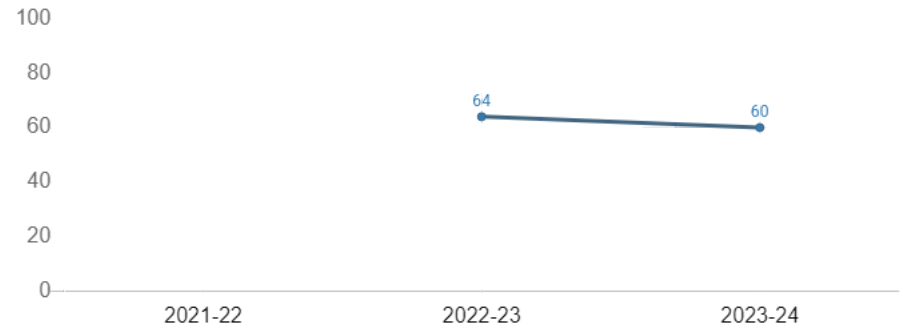

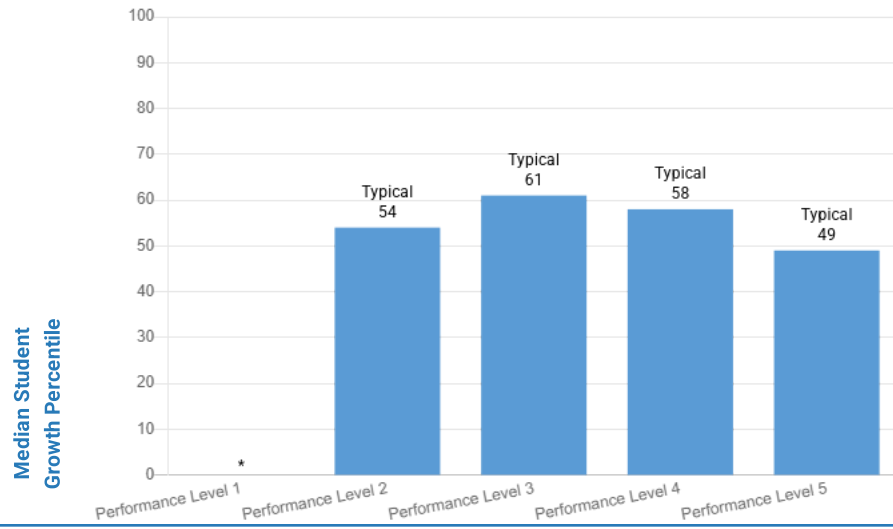

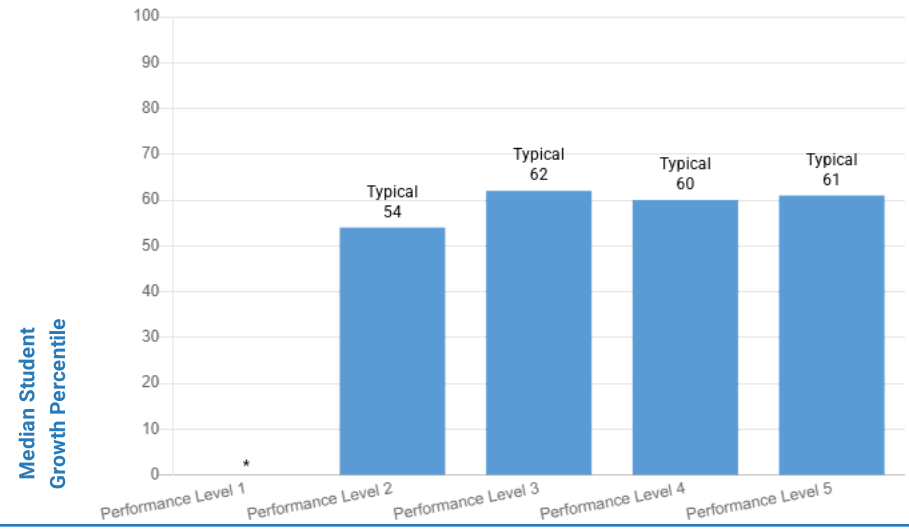

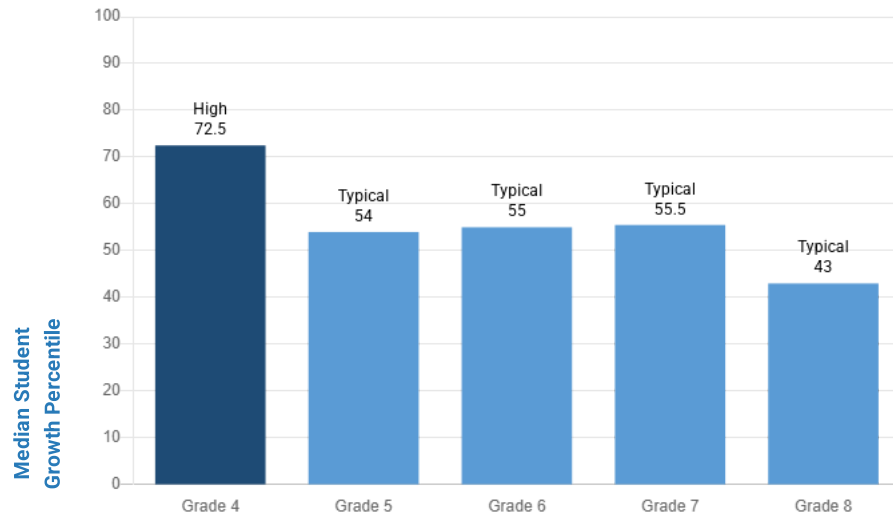

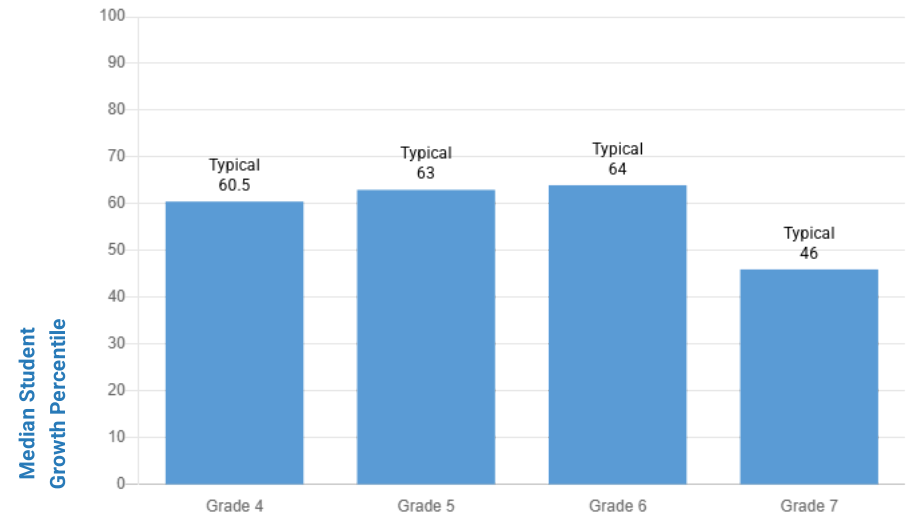

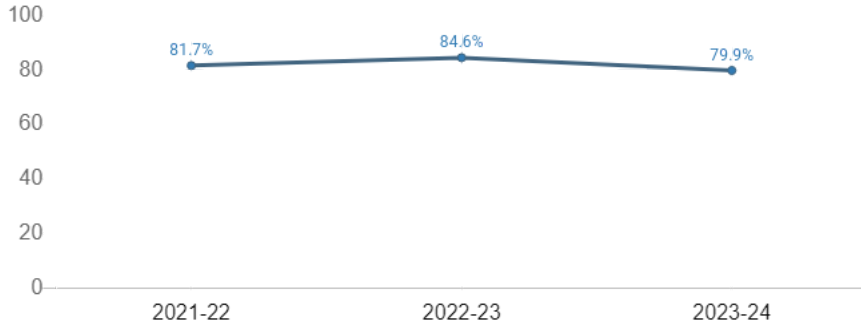

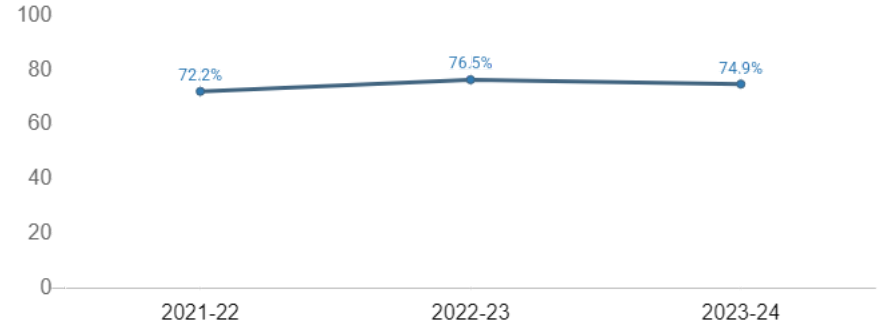
English Language Arts and Mathematics Performance Trends

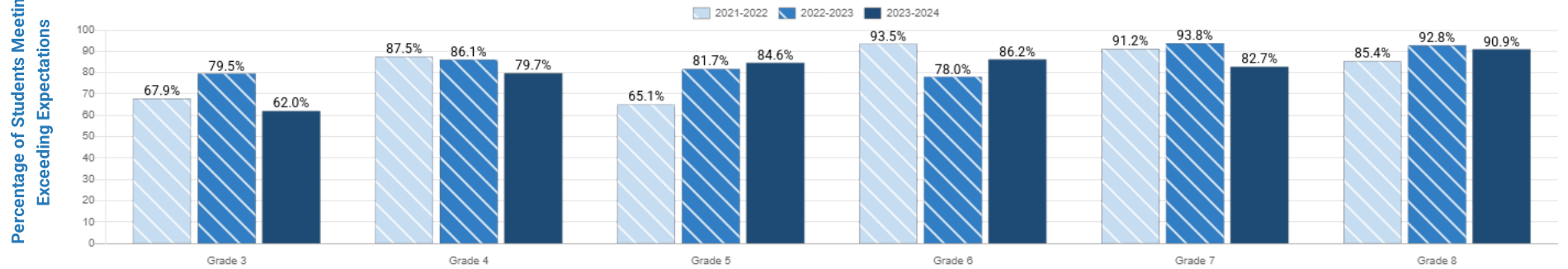

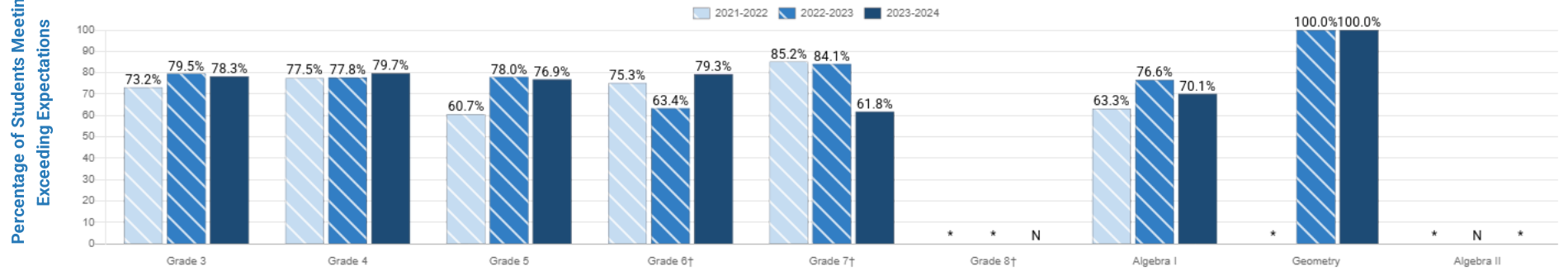

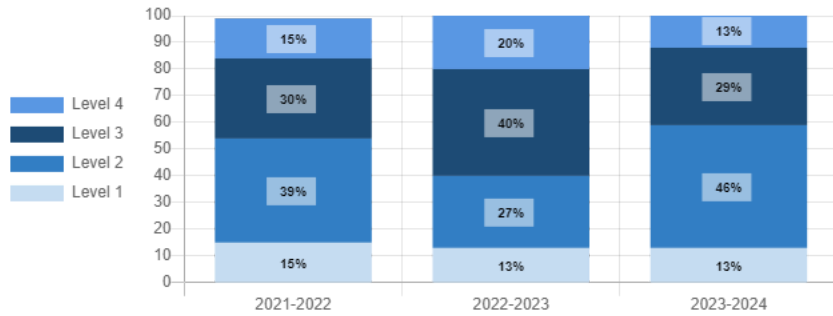

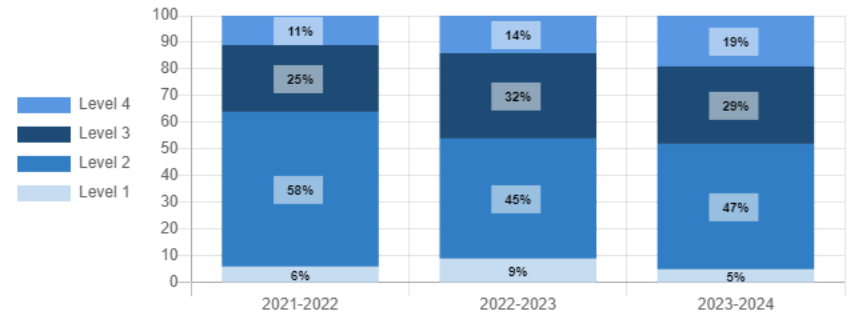
NJSLA Science Assessment: Grade 5 Summary

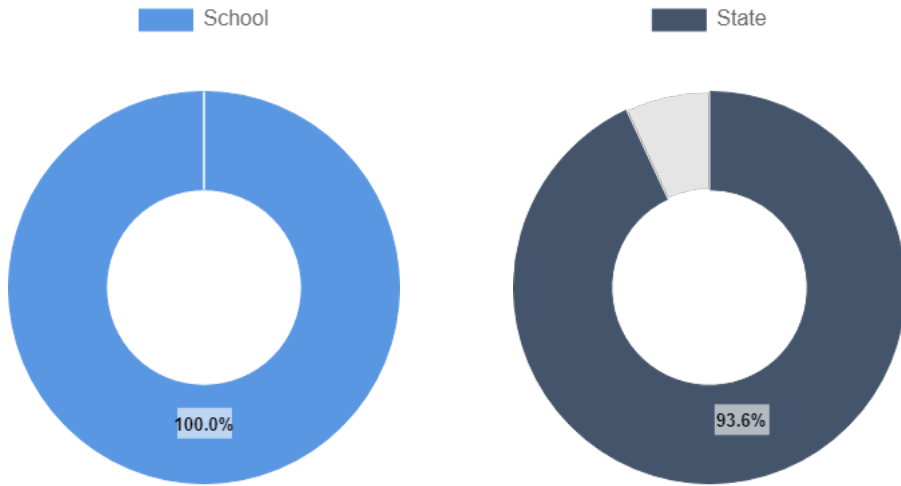

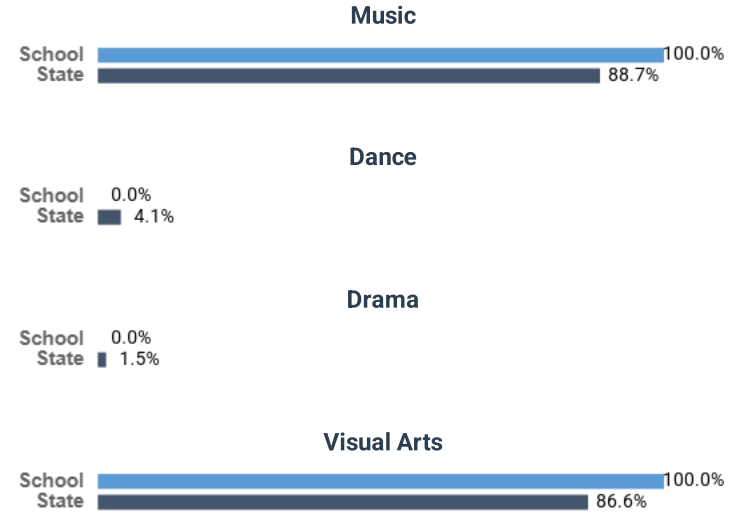

Students enrolled in one or more classes by discipline:



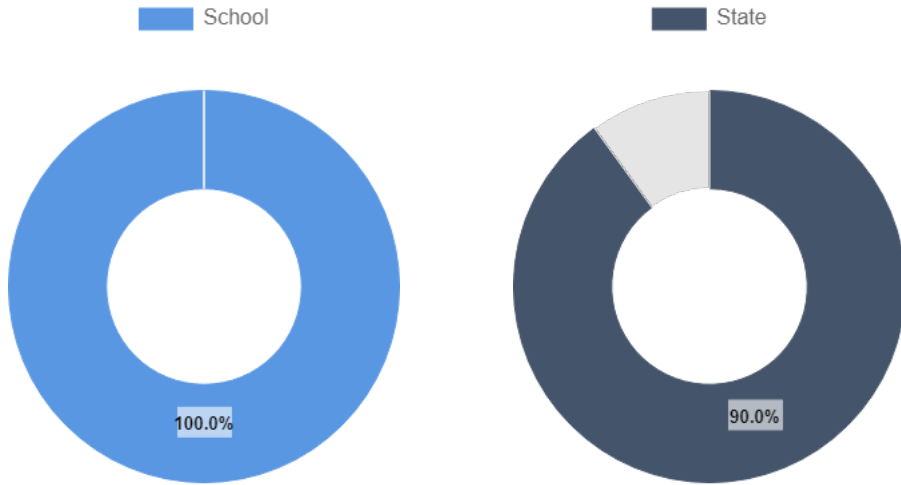

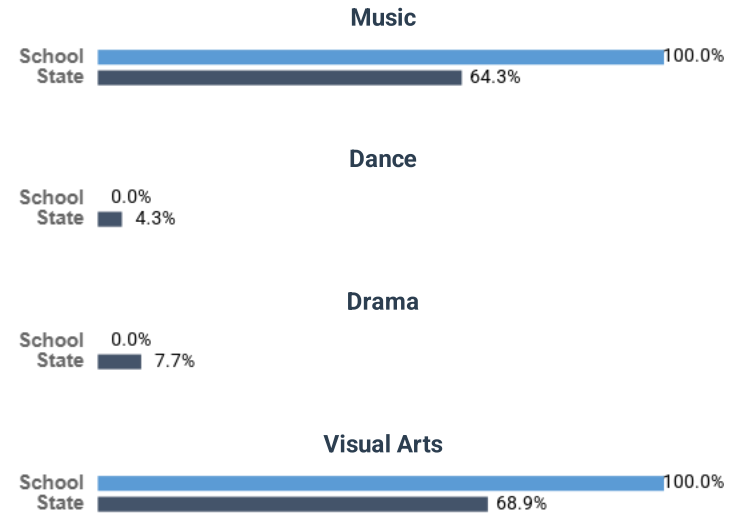

Students enrolled in one or more classes by discipline:



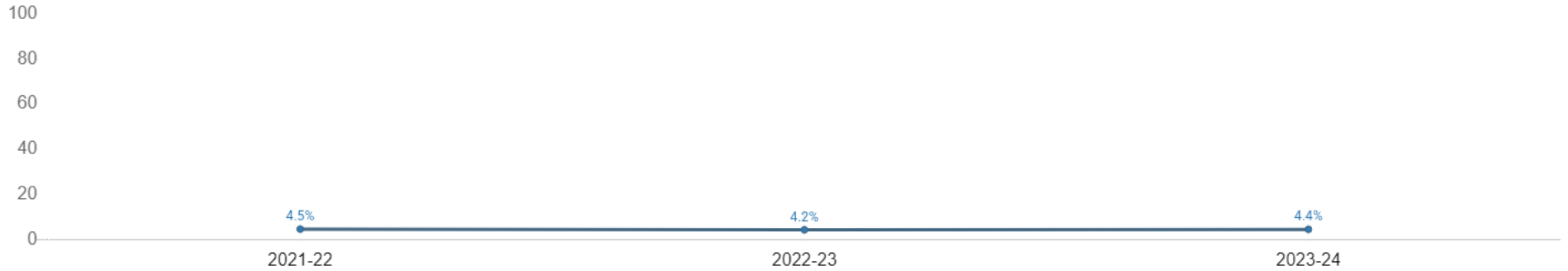

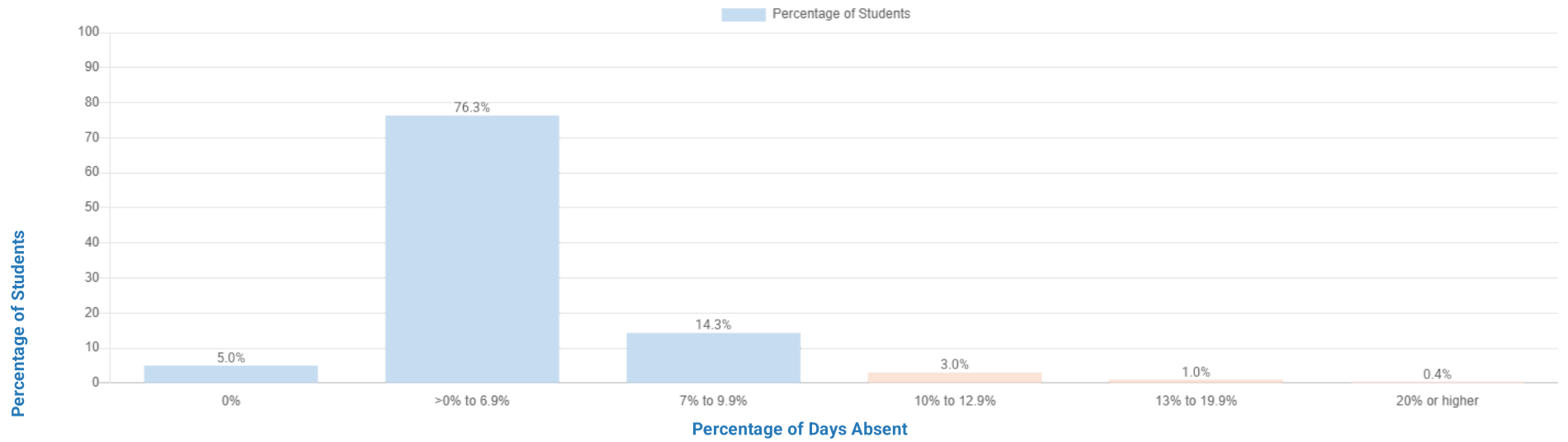

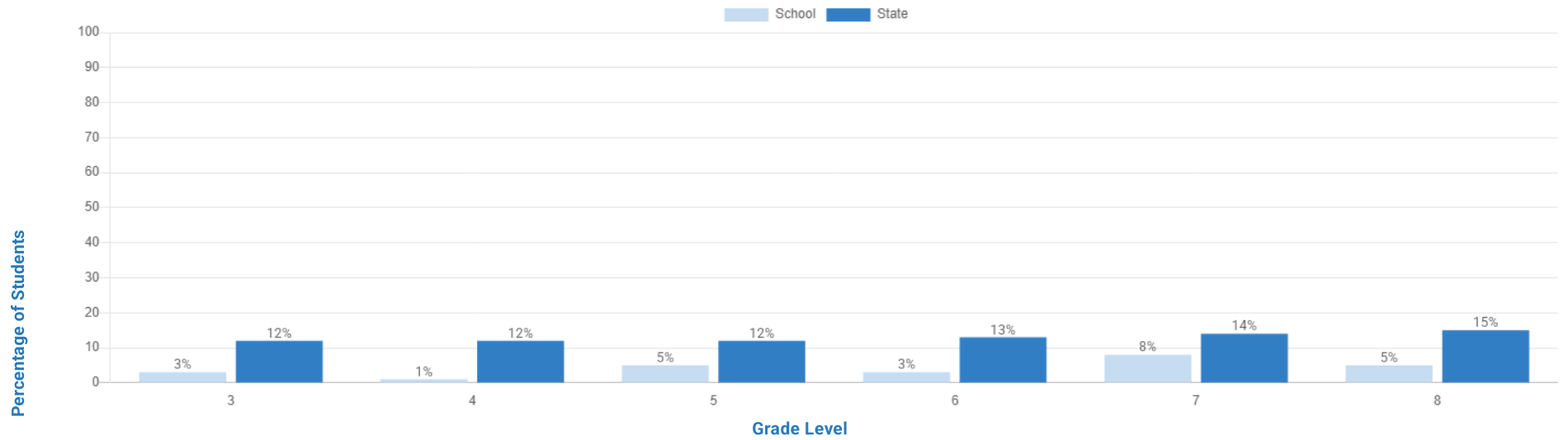

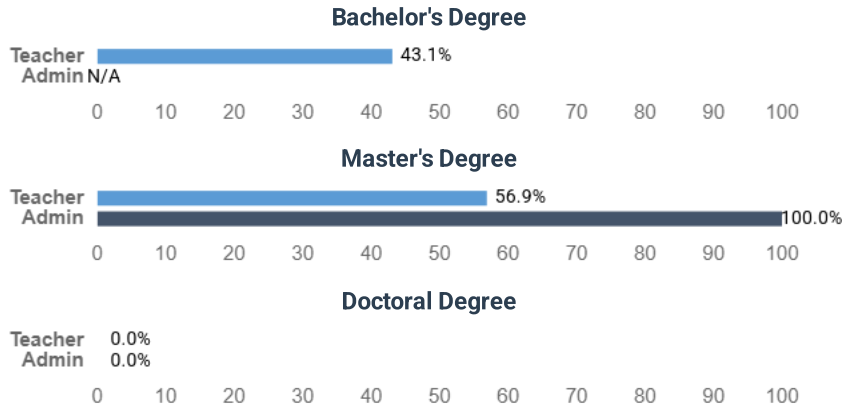

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Staff and Professional Learning:

Teachers and administrators take part in in-district and out-of-district professional development on a regular basis. Administrators and teachers participated in workshops at the MUJC. Many teachers are enrolled in graduate study programs. Weekly grade-level team meetings address the implementation of plans for students to achieve learning standards, crafting of standard-based assessments and grading rubrics, analysis of student data to form instruction, and planning of differentiated instruction.



Student Supports and Services:

The AIM Coordinators - Reading Specialist and Math Specialist - assist with addressing academic needs and implementing AIM (Academic Intervention for Mastery): push-in and pull-out support in language arts and math for Grades 3-8. The RTI Committee meets monthly to craft and implement action plans for at-risk students. The Special Services team (social worker, LDTC, school psychologist) evaluates and determines eligibility for students with disabilities and education plans in the least restrictive environment and supplemental services (speech, OT, and PT). POR and ICR are available for Grades 3-8 in language arts and math. ICR is available in Grades 3-8 for science and social studies. The 504 Coordinator determines eligibility and implements and monitors plans for students in grades 3-8. ML services are provided both in-class and pull-out for students who qualify in grades 3-8.

The school nurse works closely with the PTO to monitor the safety and health of the students during classroom celebrations.

Our parent and community groups are extremely supportive and raise money to provide enrichment activities and grants for our students. In particular, we are grateful to our PTO and the Watts Foundation for funding many school projects. Parent communication is a priority and is encouraged through technology apps such as Genesis Parent Portal, Google Classroom, teacher websites, and Smore weekly newsletters. Parents and the community are invited throughout the year to participate in events to meet the faculty and see first-hand student performances: Back to School Night, Sports Events, Winter and Spring Band and Chorus Concerts, and spring play performances.

With the passage of a previous referendum we were able to update Deerfield School with a new roof, new heating & air conditioning systems, new phone & security systems, upgraded technology infrastructure along with new windows & doors, hallways, floors, lighting, and a new media center.



School Safety:

All safety and health protocols and have been a focus of our Deerfield School Community. In collaboration with our Nurses and Administration, many new protocols and safety measures have been added. We have continued coordination of safety with the Mountainside Police Department through the use of our School Resource Officer and a Class II officer. Drop-off and pick-up procedures, safety drills and procedures, and visitor protocols are continuously reviewed and modified to ensure the safety and well-being of our students.



Technology and STEM:

Mountainside School District utilizes a secure wifi environment. Chromebooks, projectors, and document cameras are utilized on a daily basis at all grade levels to enhance instruction and student learning. Students in grades 3-8 are provided with 1:1 Chromebooks. Deerfield School has a dedicated STEAM lab which includes 3D printers, robotics equipment, and video editing equipment. Students in grades 3-5 have the option to participate in a Makerspace lab during library class, while students in grades 6-8 can participate during their Media Literacy elective. Students in grades 3-5 participate in STEAM weekly. Students in grades 6-8 participate in STEAM as a cycle elective. Additionally, all students in grades 6-8 participated in an after-school Robotics Club

Mountainside School District utilizes evidence-based practices to improve student attendance and maintain a chronic absenteeism rate below 10%. Attendance is closely monitored and brought to parents' attention when exceeding certain thresholds. A meeting with parents and school administration is set up to develop a plan for improved attendance should a student exceed 10 absences. The attendance policy is shared with all parents and reviewed within the context of how chronic absenteeism can negatively impact student growth and development. Community education and communication efforts include discussion at Parent meetings, Back-To-School night presentations, school newsletters, and individually for families exceeding thresholds set by district policy.
