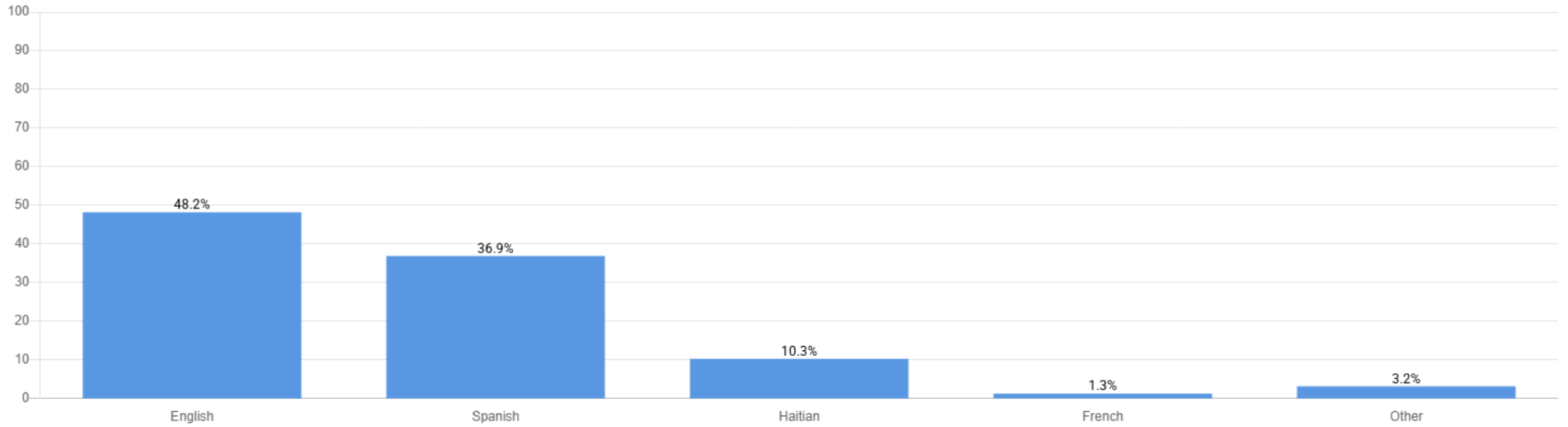

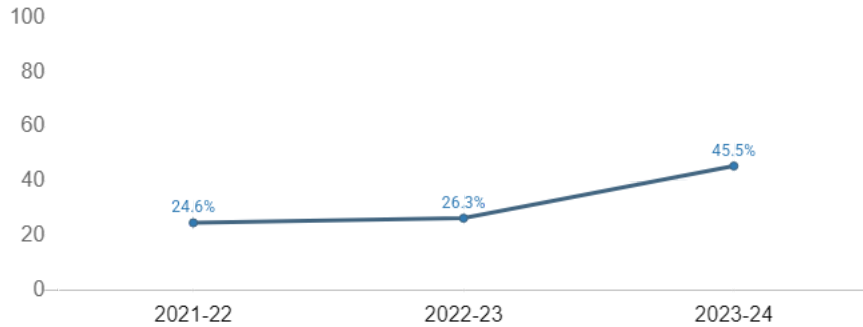

### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 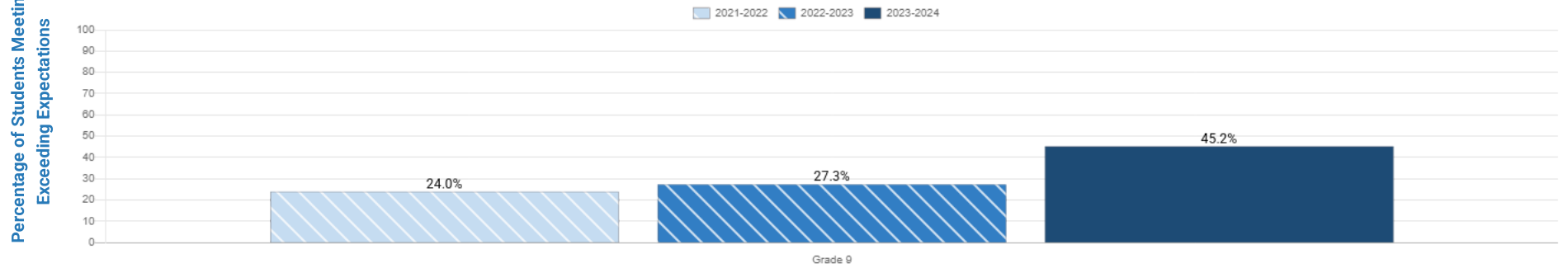

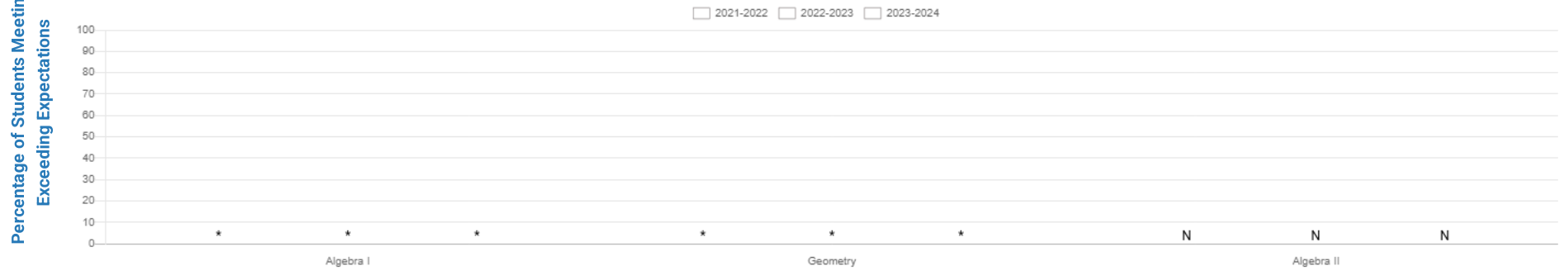

The results of their Algebra I assessment are not included in these results but will be reported when the student is in grade 9.

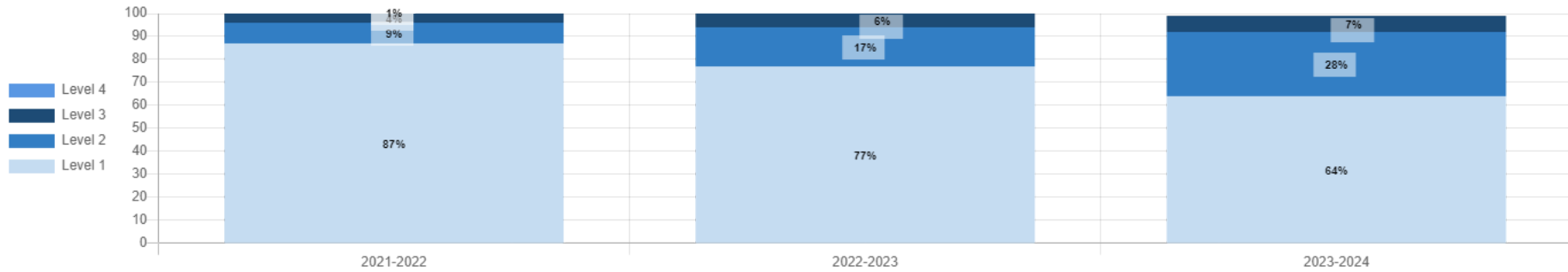

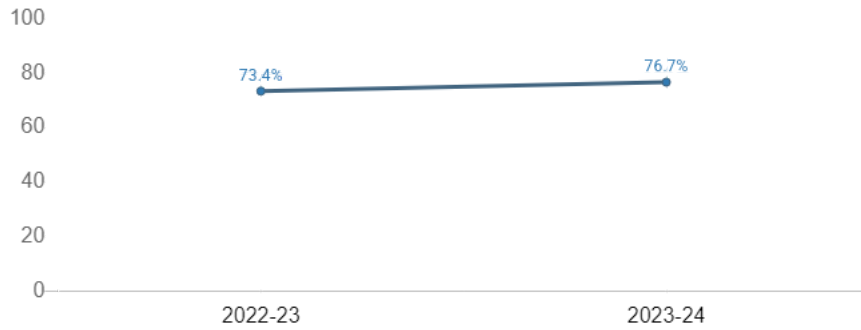

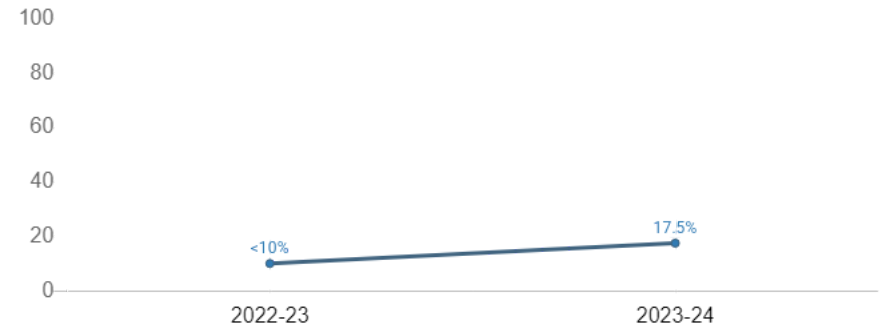

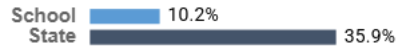

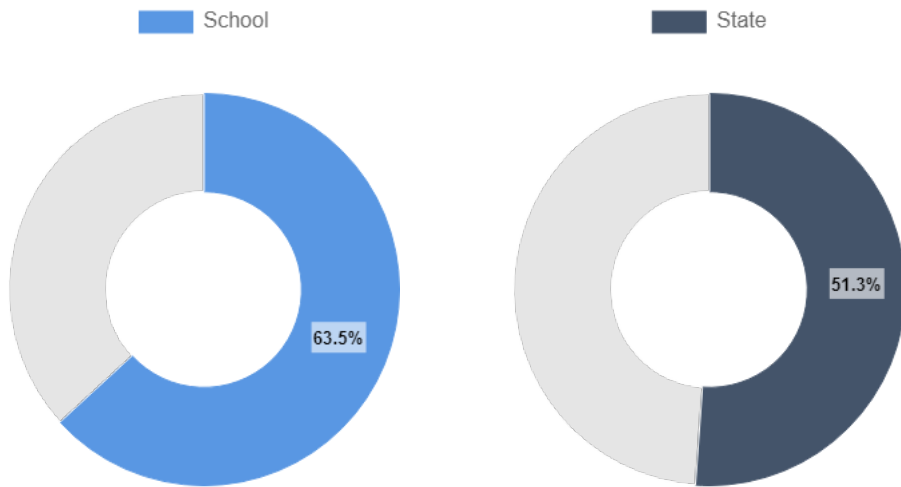

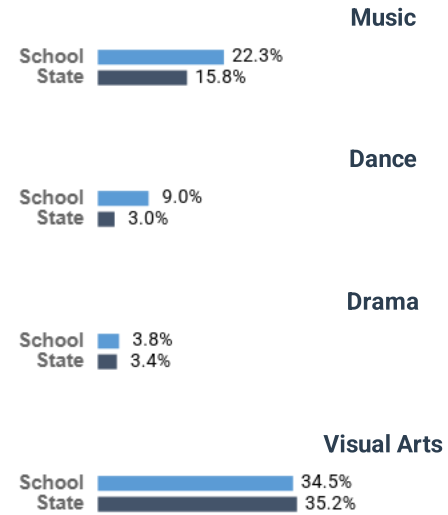

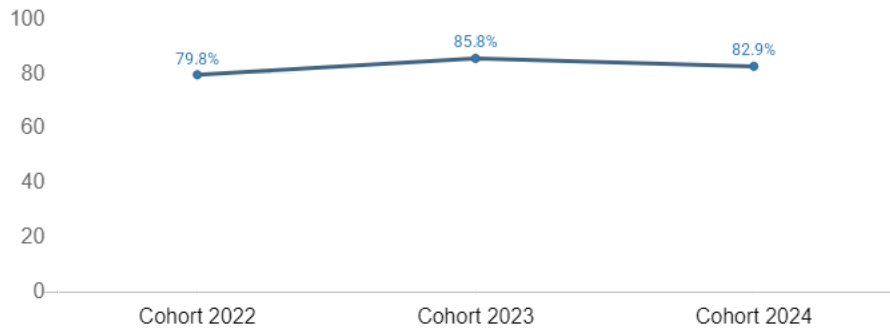

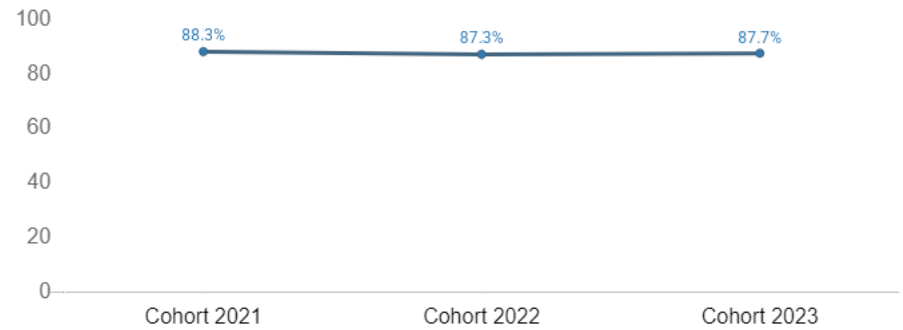

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

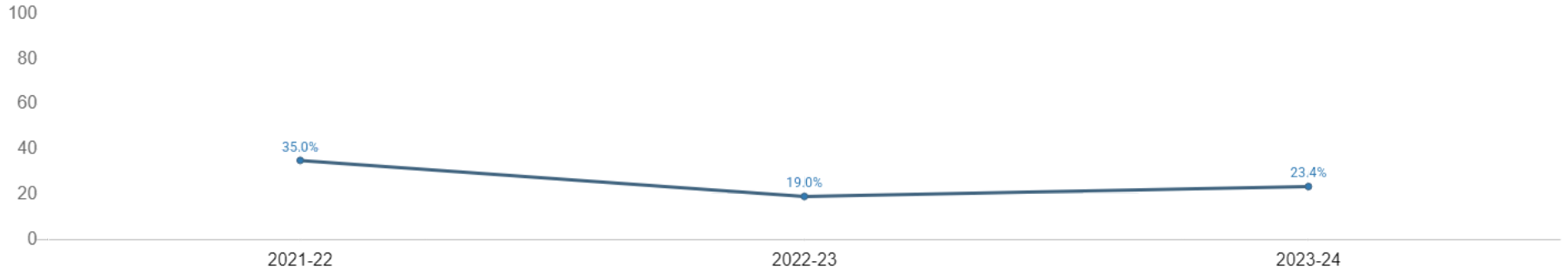

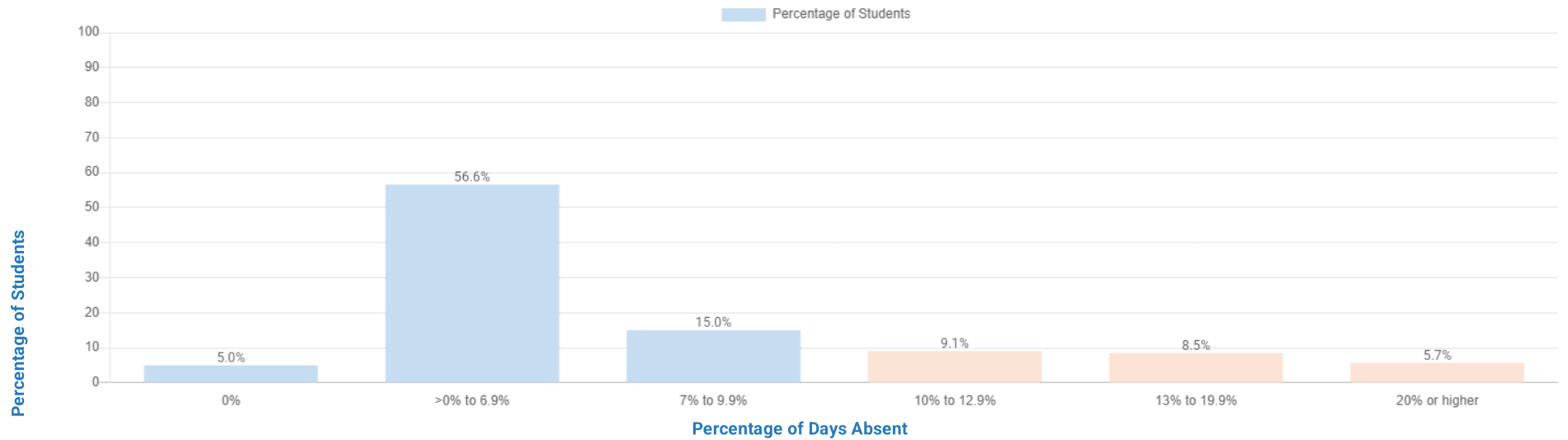

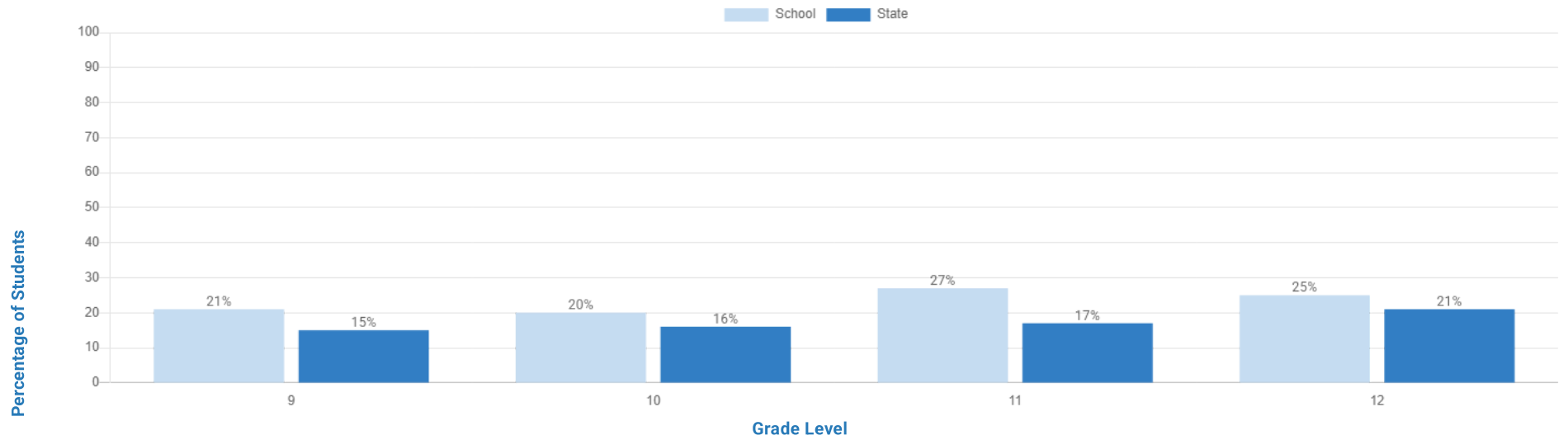

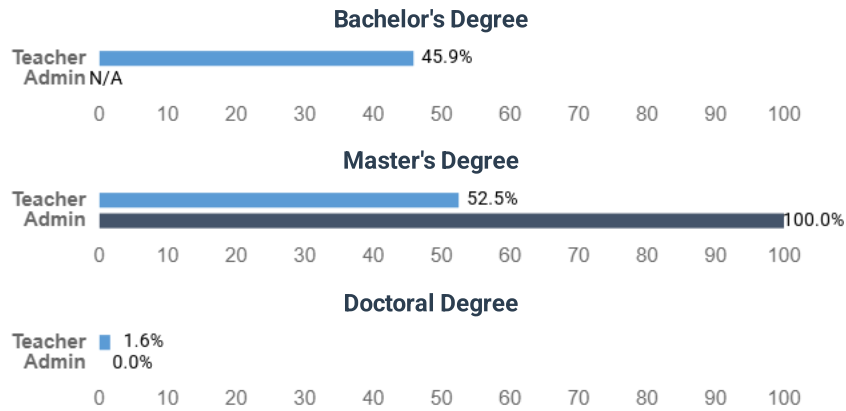

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. ### Before and After School Programs:

Abraham Clark High School offers after school tutoring programs to students enrolled in general education classes and advanced placement courses. These tutoring sessions, offered through the school's Title I Program, focus on English, Math, Science, ELL, and History. The Title I Department also offers a summer program that provides academic assistance to ACHS students in the areas of language arts and math. Title III offers a before/after the bell program in language arts and math in addition to a summer program providing assistance to ESL students. Students Taking Alternate Route to Success (STARS) is our alternative program geared towards meeting equity, state graduation requirements through small group and individualized instruction by certified teachers. Students are assigned to the program through choice, home instruction and disciplinary process.



### Staff and Professional Learning:

All staff members are Highly Qualified and certificated in their area of expertise. There is ongoing support to build teacher capacity and to collaborate on best practices through professional learning communities, common planning, workshops, and seminars/webinars.



### Postsecondary Information:

ACHS is a member of the Kean Scholars Academy wherein students can earn up to 60 college credits through dual enrollment. We also offer several Advance Placement (AP) courses in English, U.S. History, Calculus, Computer Science, Biology, Chemistry, French & Spanish to boost students GPA and an opportunity to obtain college credit if they score 3 or better on the AP Exam. Students are also participated in Blended Learning to obtain credits for graduation. In addition, teachers and students utilize the ReThoughted platform for Social and Emotional Learning. ACHS Intervention and Referral Services utilizes Link-it data to offer strategies and support for students in need of behavioral and/or academic interventions.



### Student Health and Wellness:

Students receive nutritional meals through participation in the national food lunch and breakfast program, which provides nutritionally balanced, low-cost, or free meals to children each day. Students engage in a physical education program that incorporates a health curriculum and are serviced by an onsite school nurse. Students participate in a Rethinked pre and post survey to identify their levels (low, average, & high) on the 5 SEL competencies. School counselors plan & implement monthly thematic lessons & programs for all students & staff.
