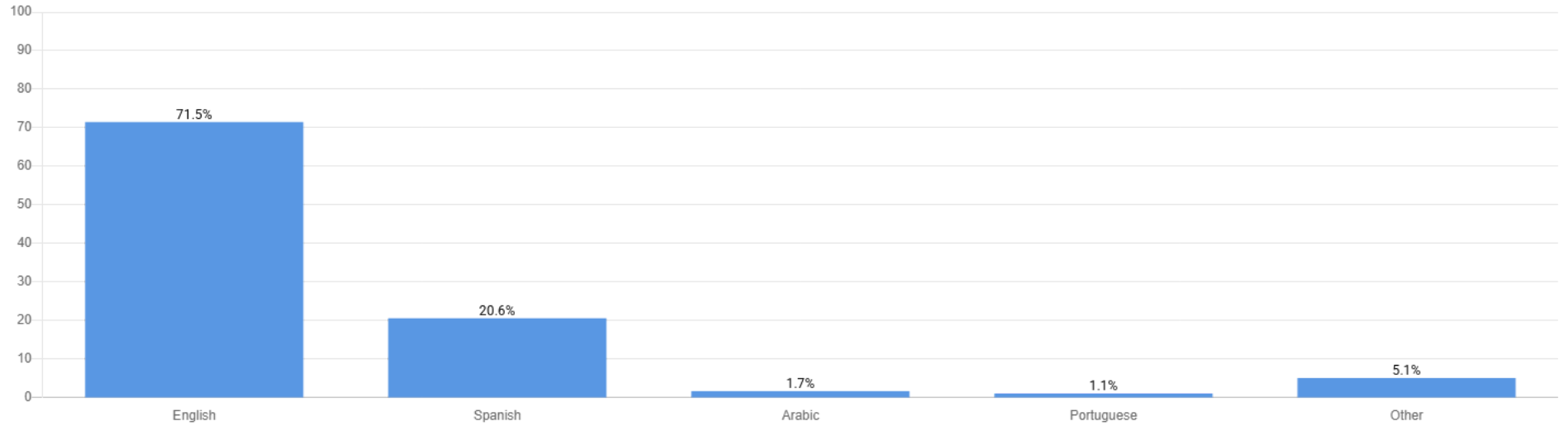

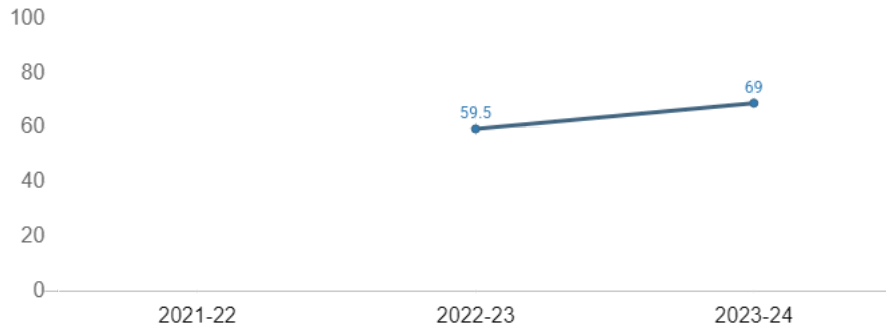

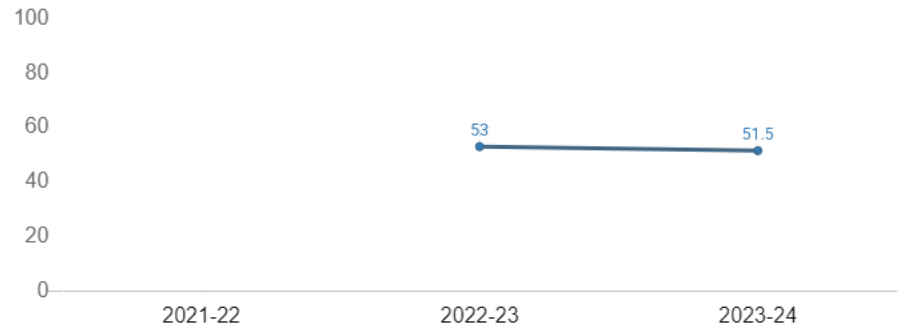

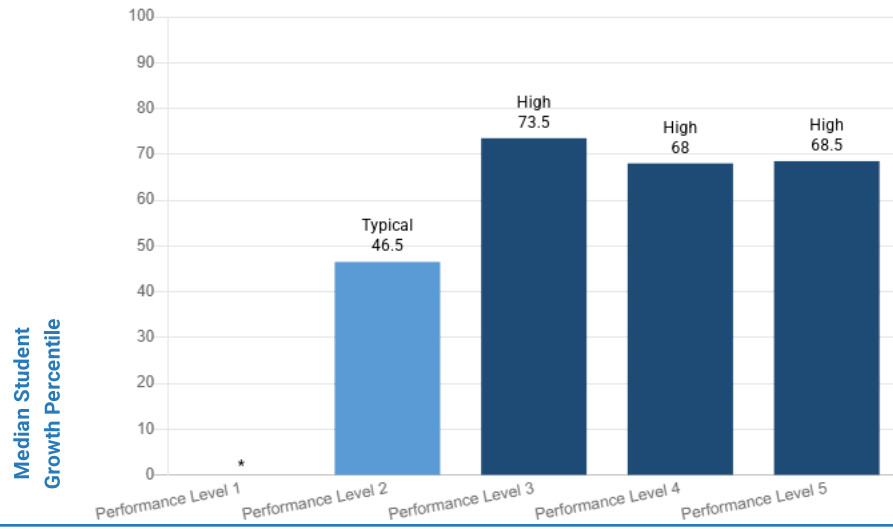

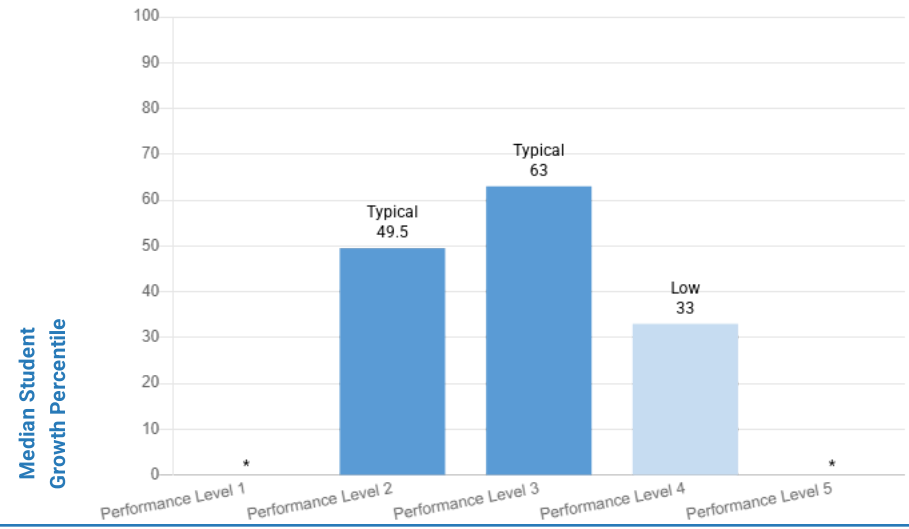

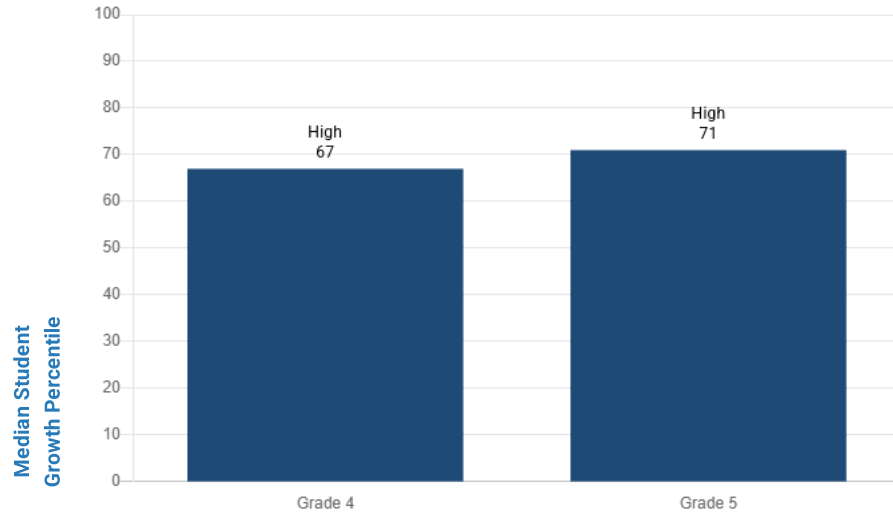

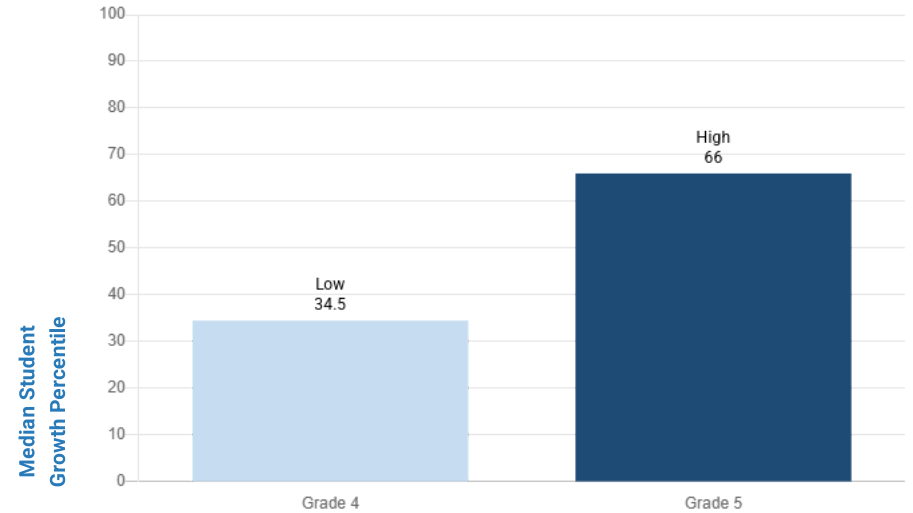

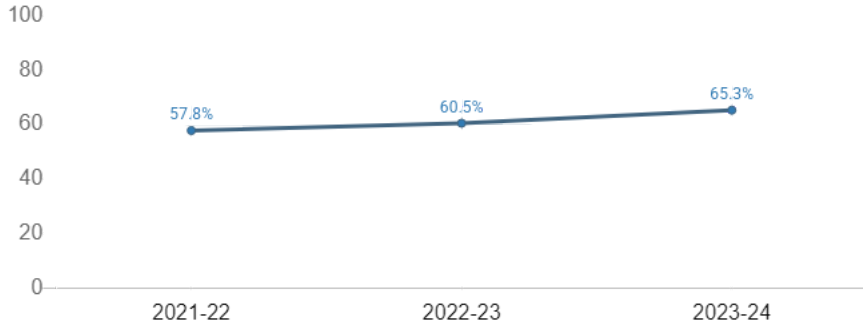

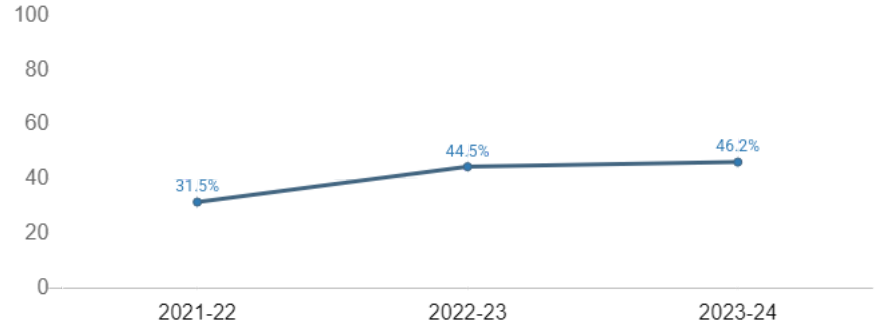
### English Language Arts and Mathematics Performance Trends

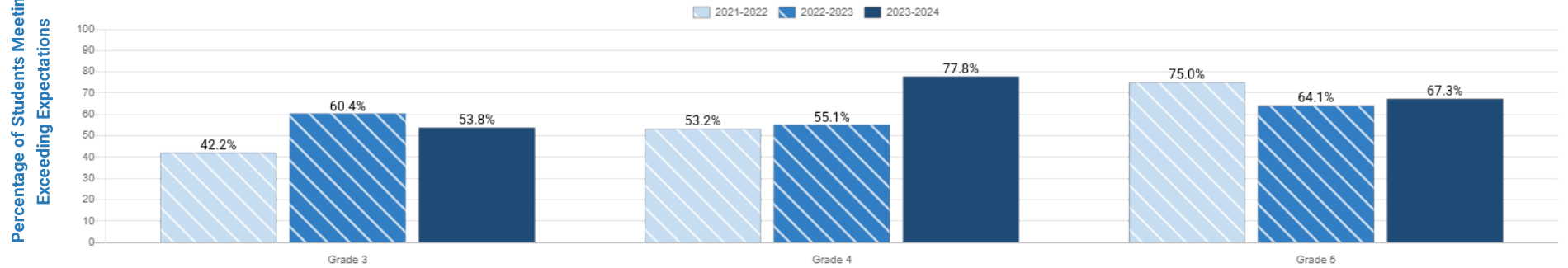

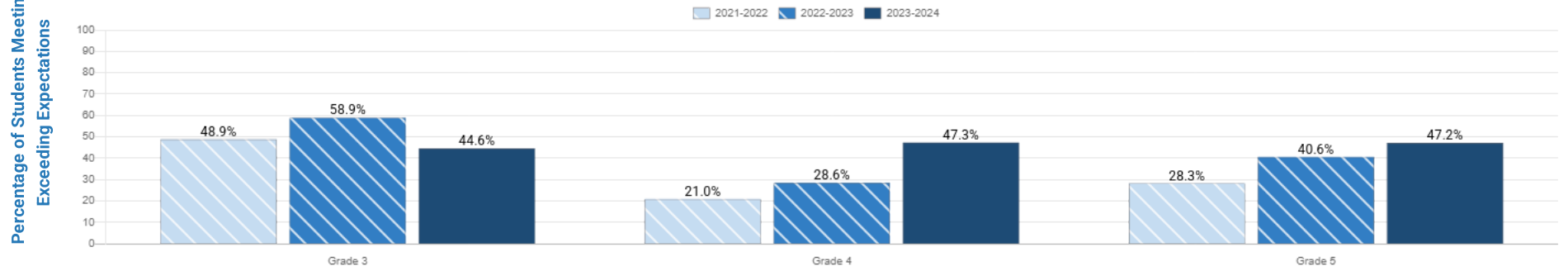

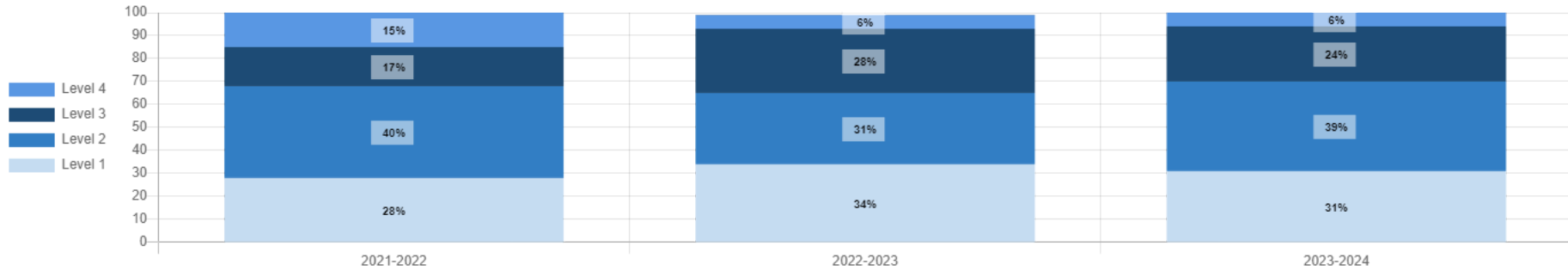

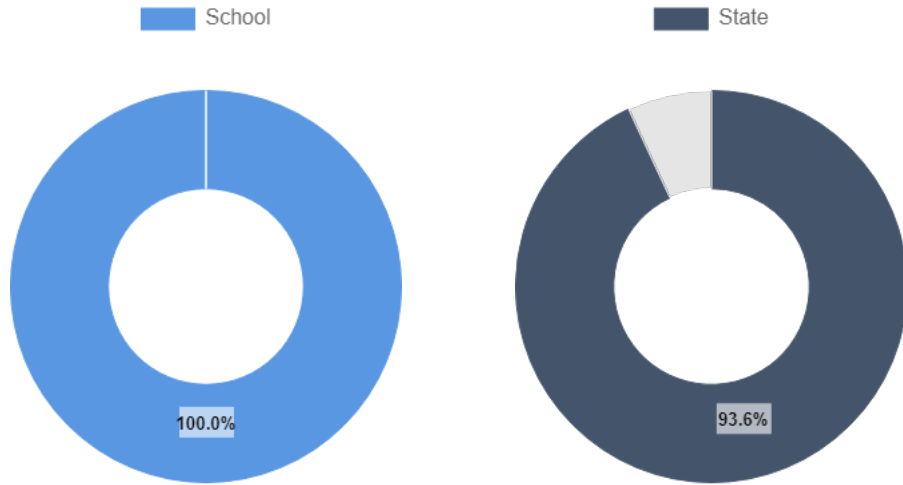

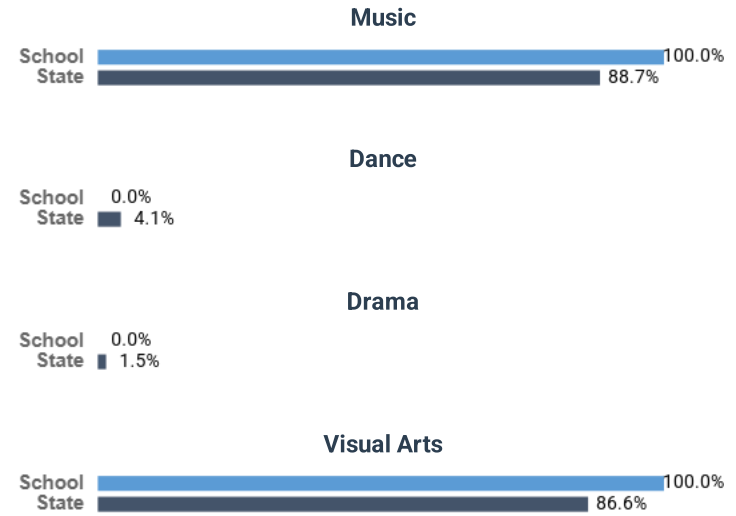

**Students enrolled in one or more classes by discipline:**



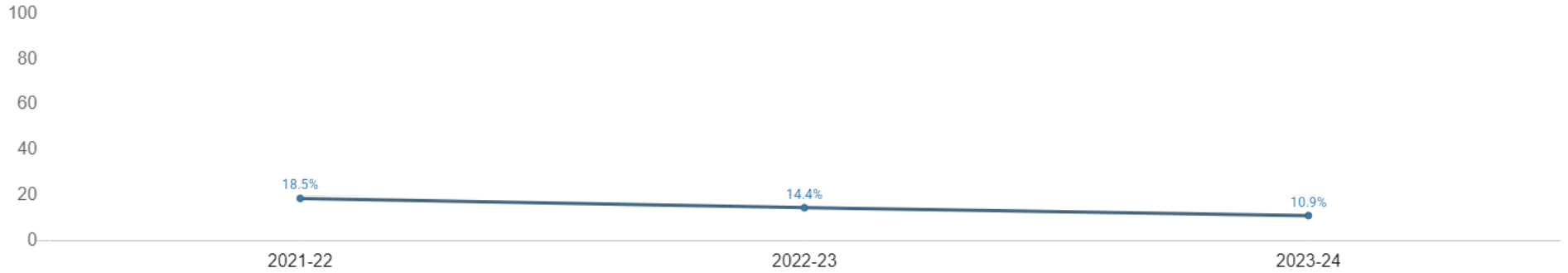
## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 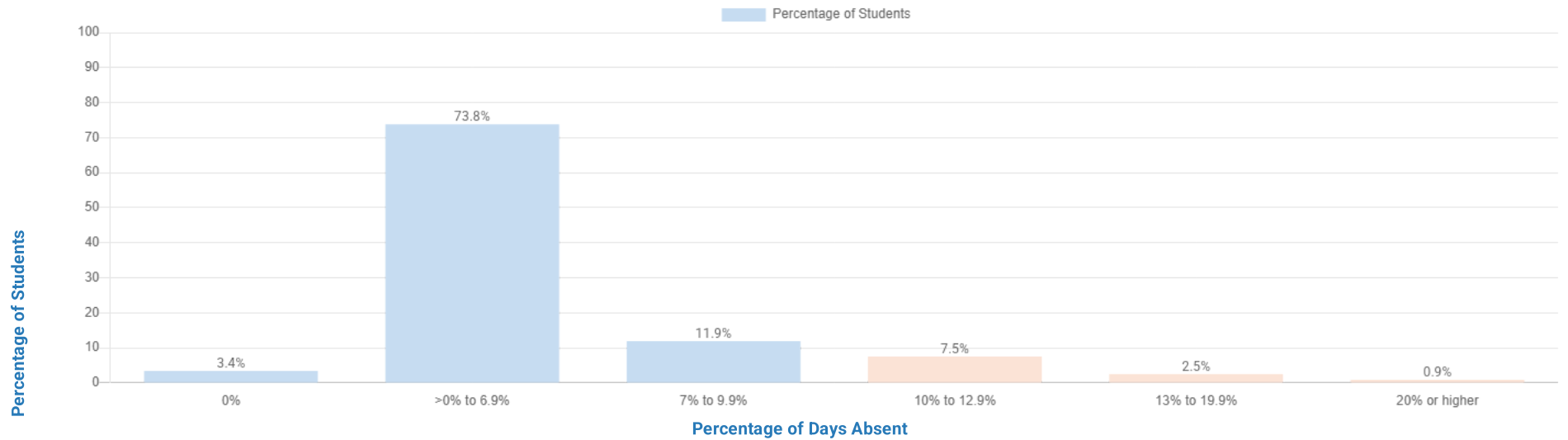

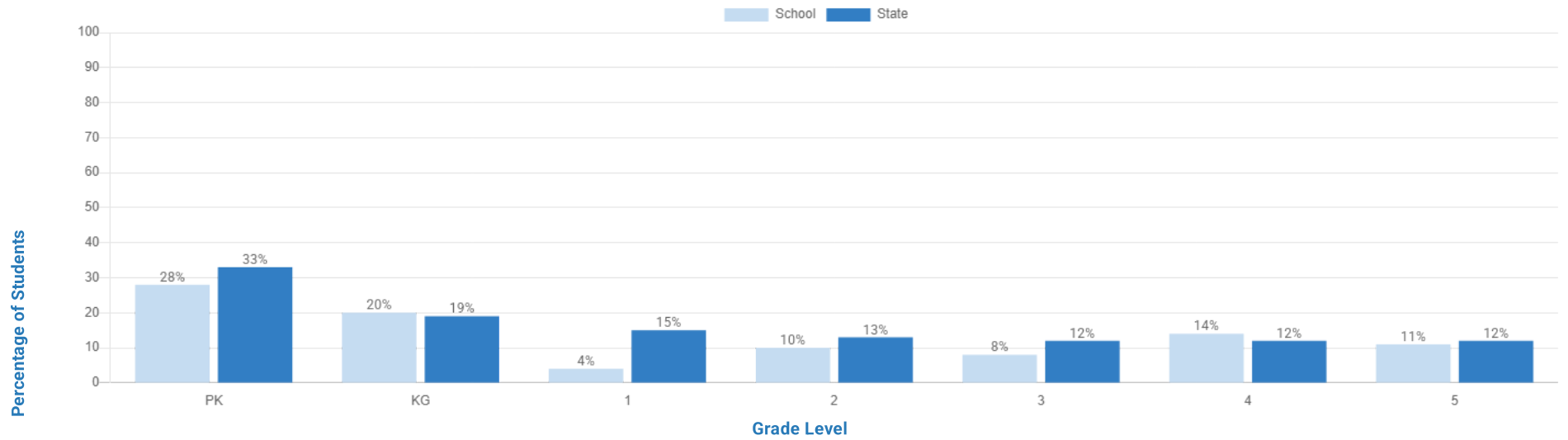

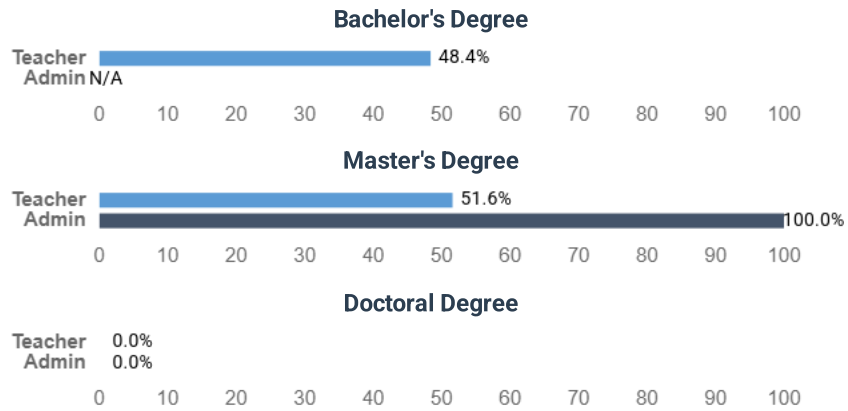

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. ### Staff and Professional Learning:

Roselle Park's Professional Development Program plays a significant role in the outstanding accomplishments of our district. One of the cornerstones of the program is the belief that the professional development of teachers is the key to an excellent instructional program. Professional Learning opportunities include weekly professional learning communities, monthly vertical and horizontal articulation, professional development by the district, and monthly faculty meetings.

### School Safety:

Sherman School uses a variety of practices and procedures to promote the safety of students, staff, and faculty. The school is a closed school at all times, with all visitors requiring an appointment at least 15 minutes prior and approved identification upon being buzzed into the building. All staff and faculty are required to have proper identification. There is a written plan of all school safety and security measures for various scenarios. Drills in school security and fire drills are conducted at least twice monthly. Health and safety drills are conducted by team members once a month.



### Technology and STEM:

Technology is incorporated into the curriculum throughout all subjects. All classrooms are equipped with Smartboards, and students in grades Kindergarten through Grade 5 have 1:1 devices. The Talented & Gifted Program incorporates STEM into lessons at all levels.



### Early Childhood Education:

Roselle Park is committed to celebrating our diverse community, and we value family and community partnerships. The mission of the Pre-School program is to provide students a learning environment that focuses on what children can do and reflects the children's interests. Our curriculum is aligned to the Preschool Teaching and Learning Standards, is evidence-based, and comprehensive to meet the needs of all of our learners. Sherman School offers a full day preschool classroom. The program is for three and four-year olds and includes integrated speech, occupational and physical therapy. Students have access to music, Spanish, physical education or art lessons.
