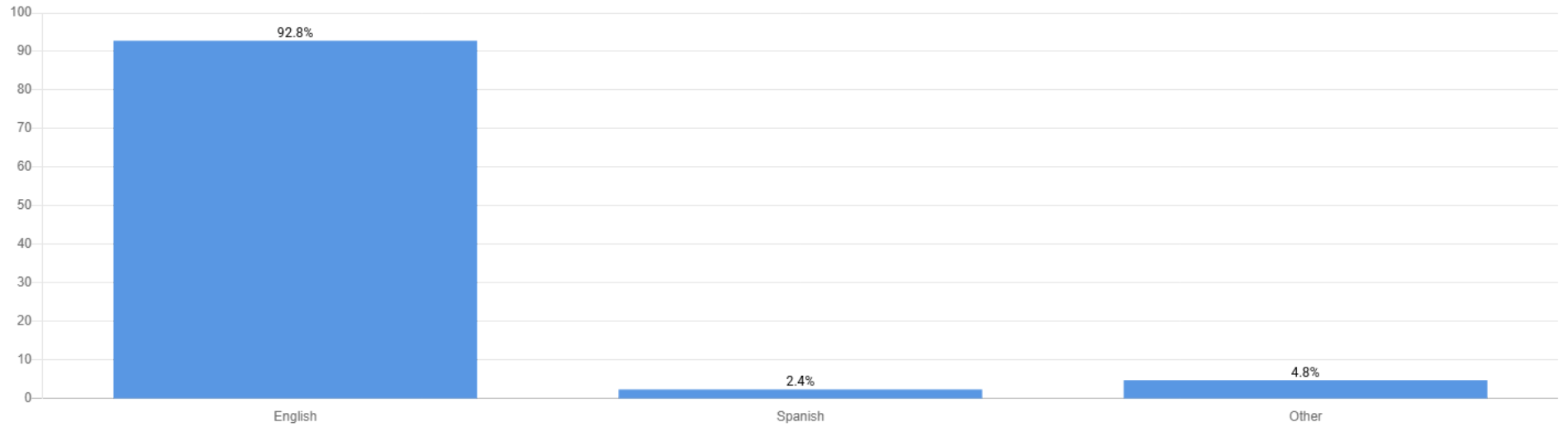

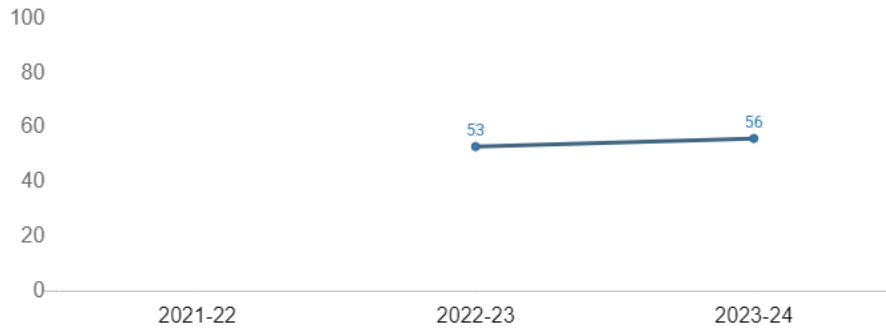

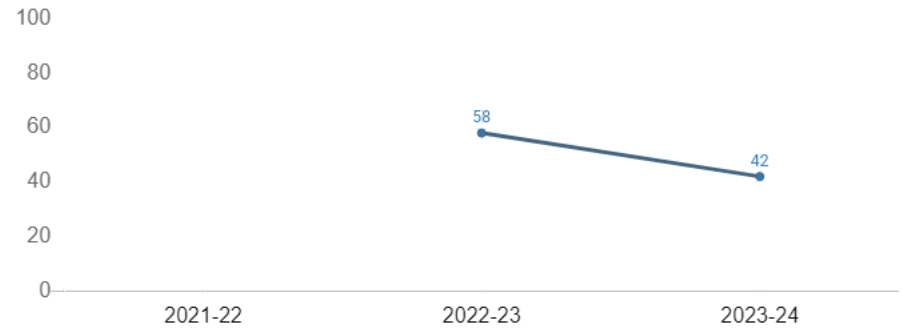

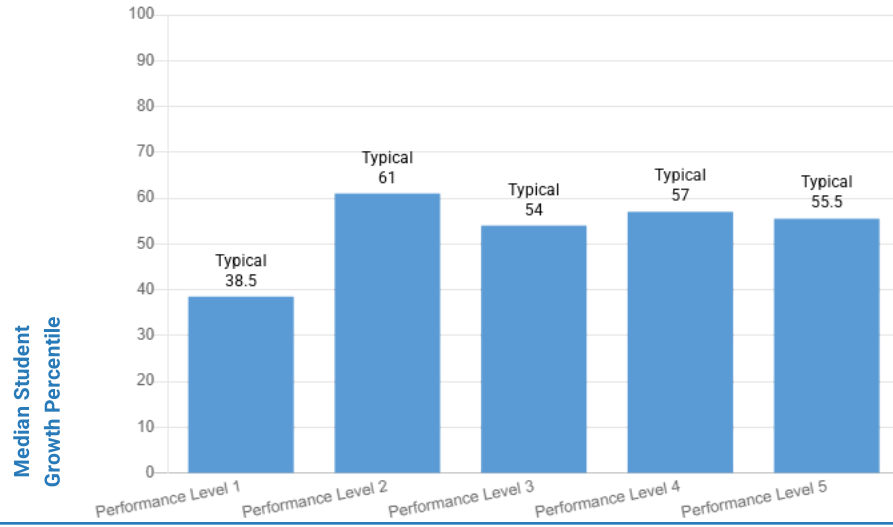

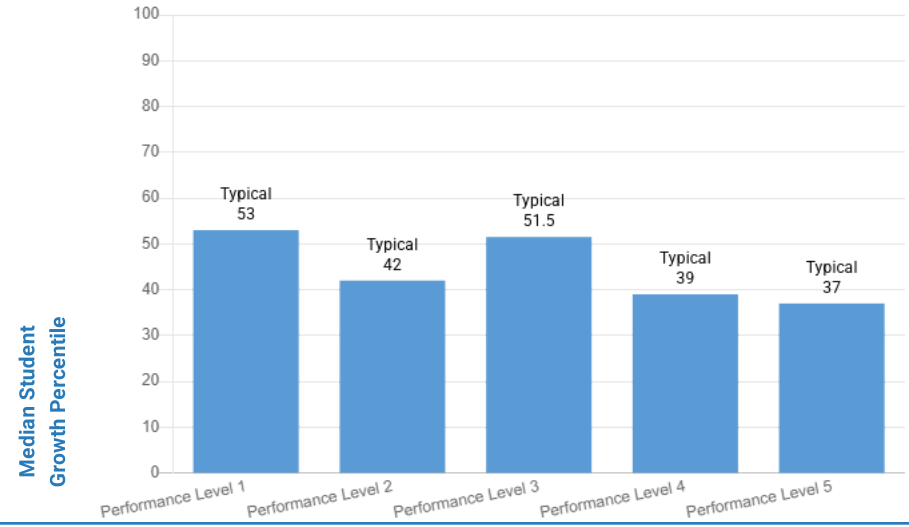

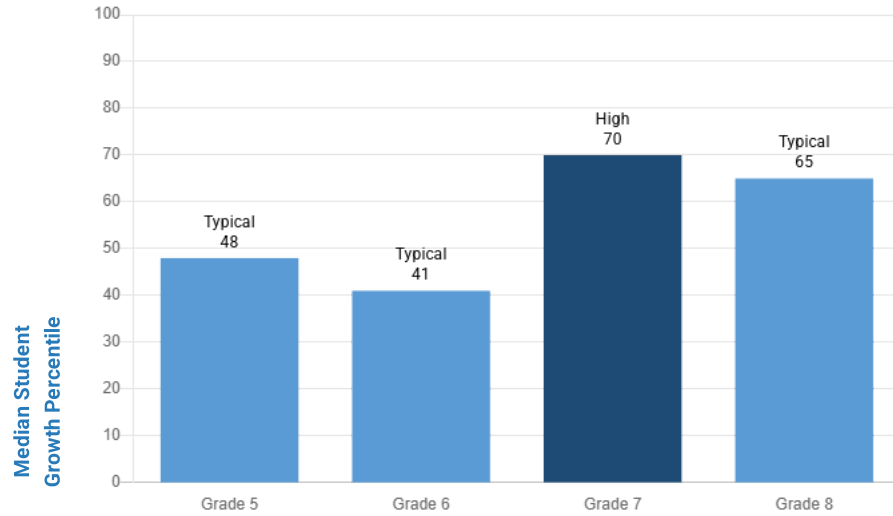

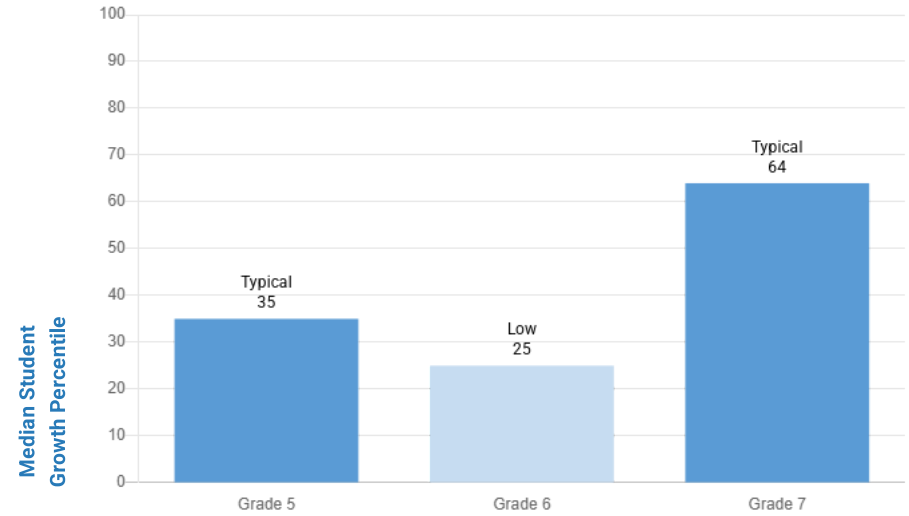

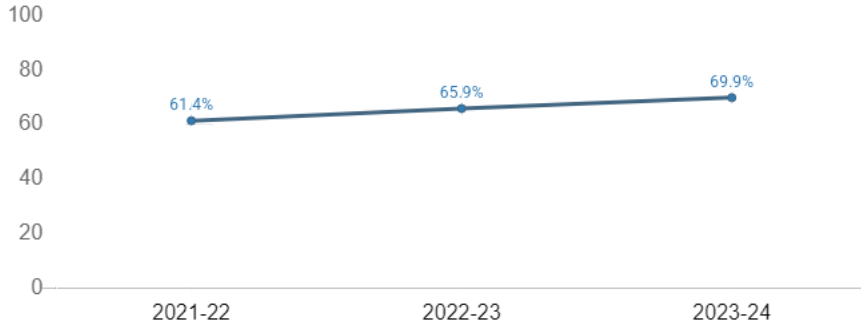

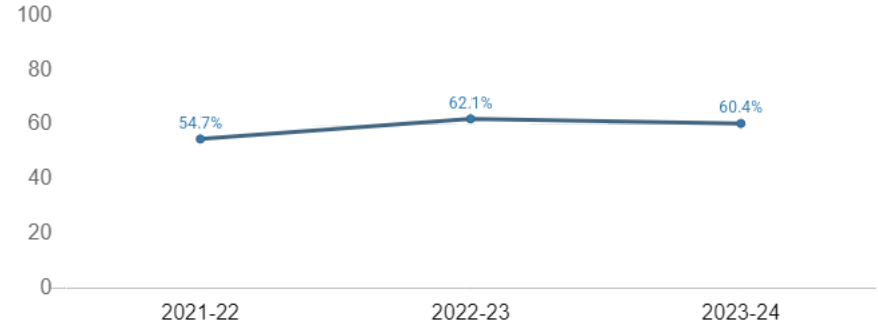
English Language Arts and Mathematics Performance Trends

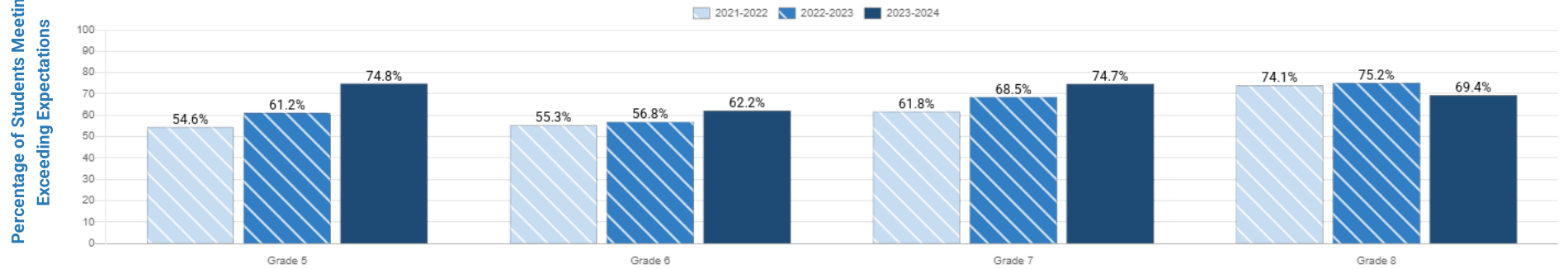

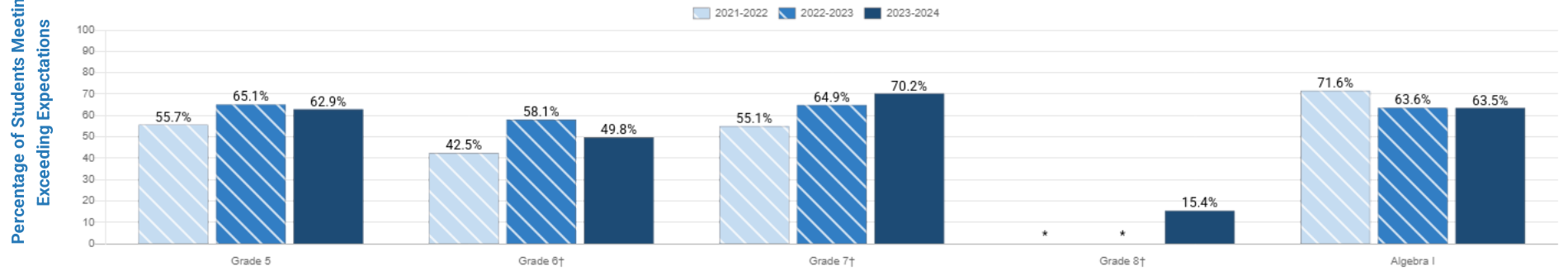

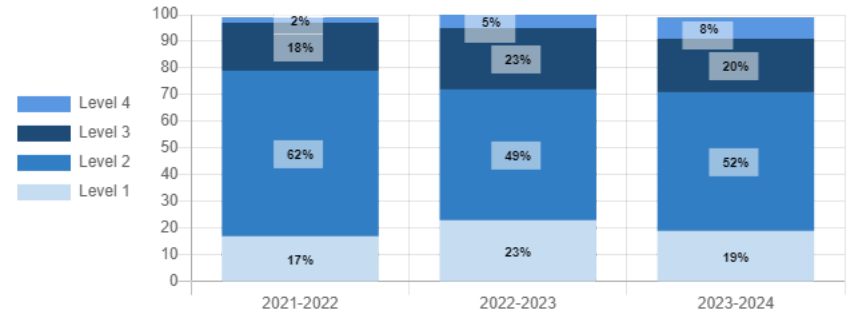

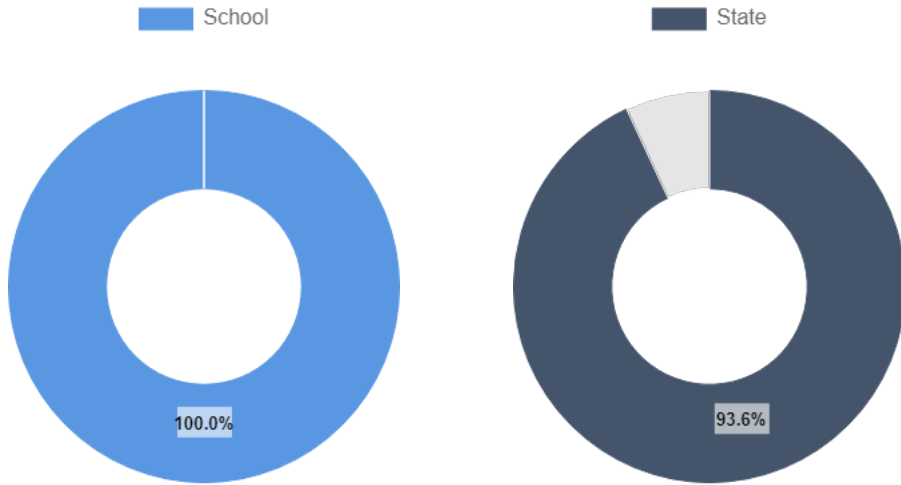

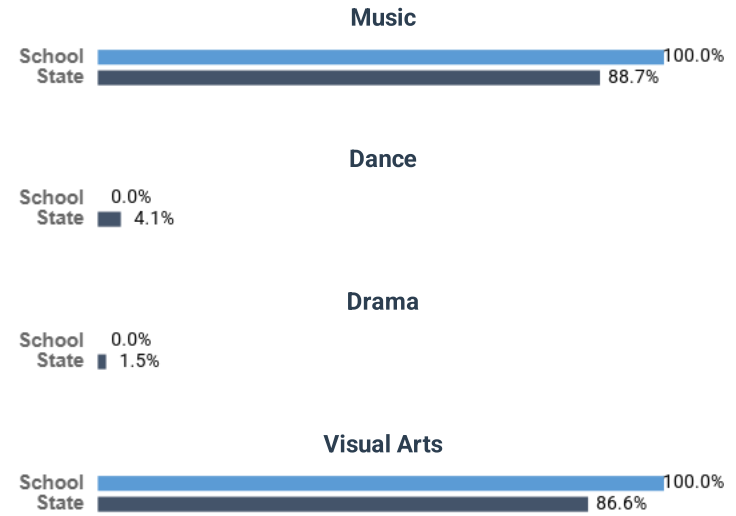

Students enrolled in one or more classes by discipline:



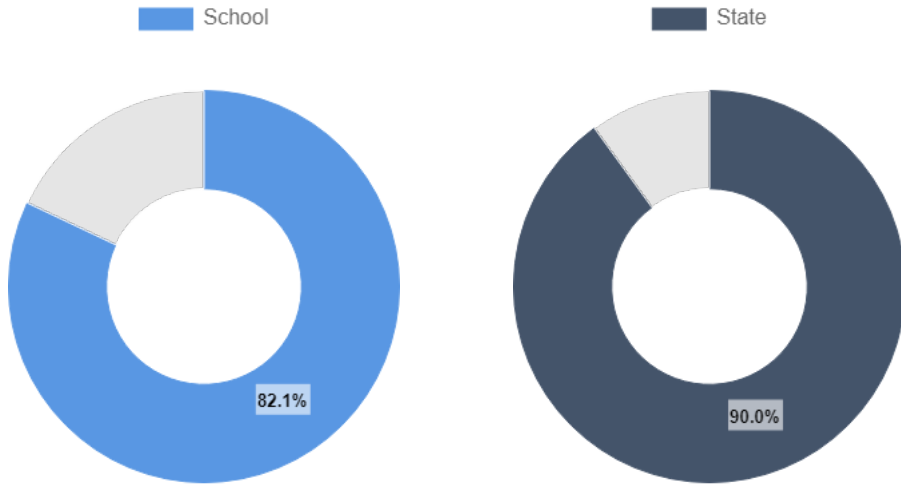

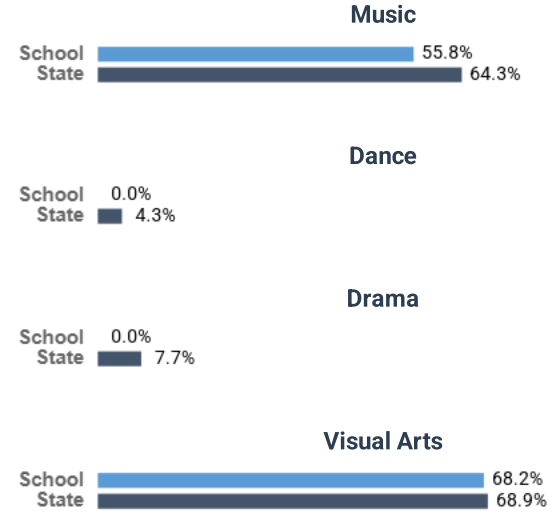

Students enrolled in one or more classes by discipline:



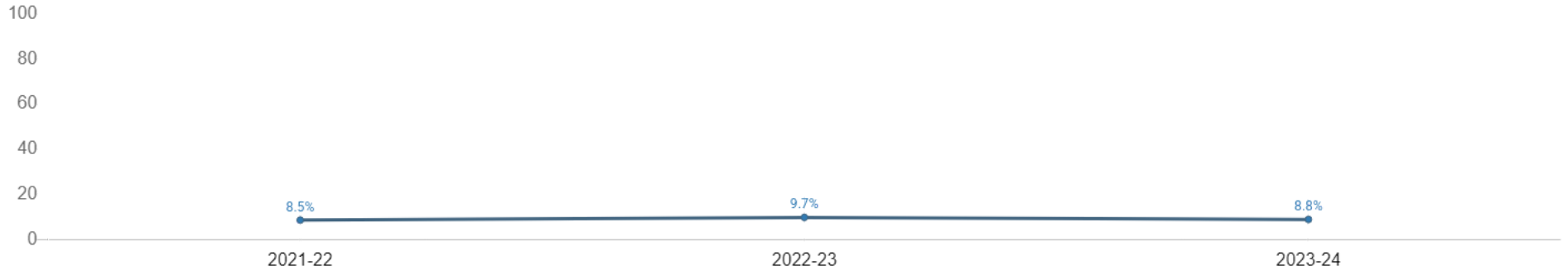

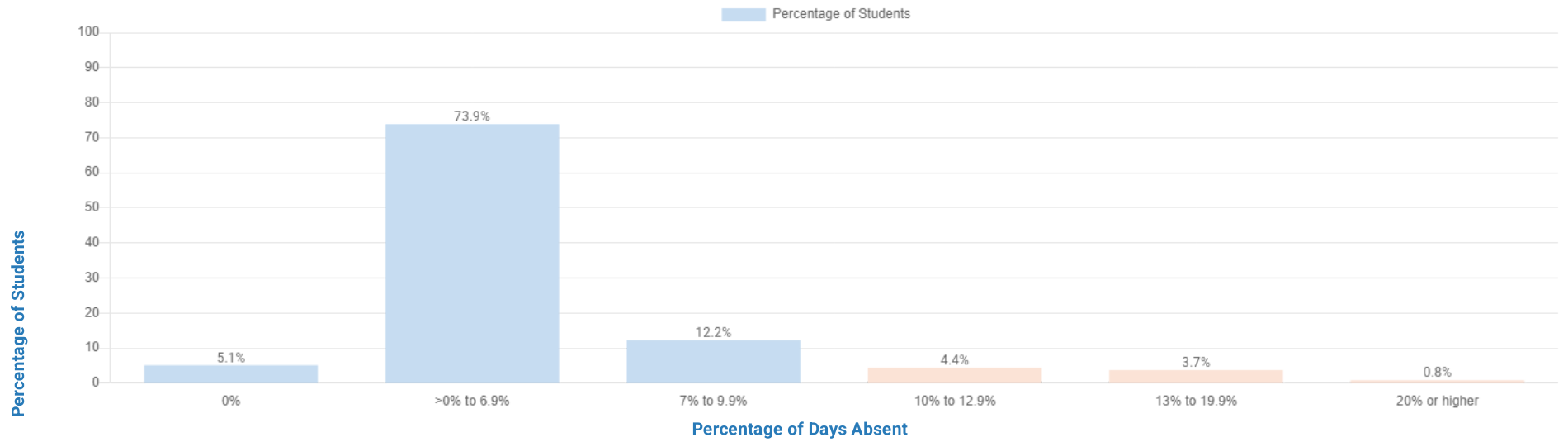

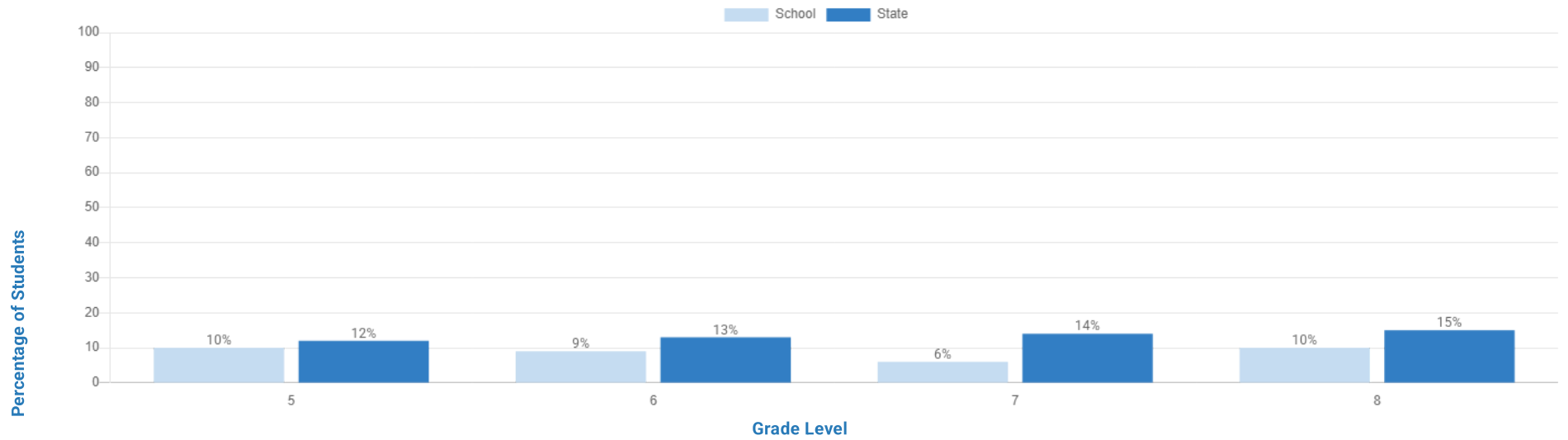

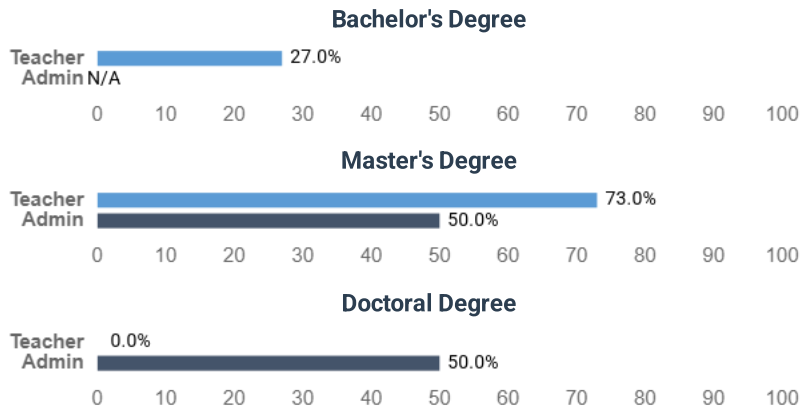

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Clubs and Activities:

Terrill Middle School provides a wide variety of after-school activities to support students' interests and talents. Students can participate in clubs and groups like Model UN, select choir, jazz band, newspaper, art club, Enchanted Engineers, a school musical production, robotics club, homework club, film and media production club, PALS (Peer Leadership and Support), student council, yearbook club, and a Dungeons and Dragons Club. These activities offer students a chance to explore new skills, make friends, and deepen their engagement with the school community beyond the classroom.



Before and After School Programs:

The district currently partners with Right At School to offer an after care program for middle school students.



Staff and Professional Learning:

All staff members participate in bi-monthly professional learning communities at their school and with their content area colleagues across the district. The district also offers optional professional development sessions on a variety of topics throughout the year. These offerings are in addition to the district-wide professional development days where teacher leaders spearhead the sessions.

Student Supports and Services:

Experiences for academically talented children in grades five through eight are offered through the QUEST (Question, Understand, Explore, Seek, Think) Program. The district also offers three distinct course placements for special education students. These include in-class support, resource room, and self-contained classes. Additionally, the school has an active Intervention and Referral Services Committee to identify and support students who may struggle. Likewise, supports are also provided for our English language learners. Our 5th graders who are identified as needing additional support in Language Arts and Mathematics participate in our basic skills program.



Parent and Community Involvement:

Terrill Middle has an active PTA that helps sponsor a variety of events like our assemblies, author visits, and the Book Fair. We utilize PowerSchool as our student information system providing students and parents with instant feedback. Terrill also collaborates with its Municipal Alliance and the Educational Enrichment Foundation of Scotch Plains-Fanwood, a local educational foundation that awards grants.



Climate Surveys:

Is a Climate Survey Used: No; Who is surveyed: Students. At Terrill Middle School, understanding student experiences is key to fostering a supportive learning environment. Twice a year, a culture and climate survey is implemented to explore students' emotional and social experiences, including belonging, safety, academic engagement, and peer relationships. Anonymous responses encourage honest feedback, which the School Safety Team (SST) analyzes to identify patterns, address concerns, and guide proactive interventions. Insights from the survey inform programs like social-emotional learning and peer mentorship, aiming to build a robust support system that empowers students academically, socially, and emotionally. This data-driven approach also addresses social isolation, develops anti-bullying strategies, and fosters inclusivity. Terrill Middle School's commitment to listening and adapting underscores its dedication to creating a safe and dynamic learning environment.

Each marking period, the administration and counseling department evaluates attendance records. We then communicate with families directly when concerns arise. We do this through formal letters, team meetings, counseling meetings, and administrative meetings. We provide both consequences and remediations to help support students and families in timely arrival to school and overall absences. As a second tier of support, we offer a school based counseling intervention and provide external therapeutic services for students who might be experiencing school avoidance.

Other Information:

The fifth grade instructional program is primarily a self-contained environment with a strong emphasis on mathematics, language arts literacy, science, and social studies. In addition to these core subjects, students experience three world languages, fine arts and physical education/health. Understanding the importance and effectiveness of small learning communities, the departmentalized sixth, seventh, and eighth grade instructional programs are structured on a team concept. Students engage in classes in language arts, writing workshop, mathematics (Connected Math), science, social studies and world language (selecting from Spanish, French, and Italian) as well as physical education and health. Art is taught in grades six and eight and digital arts education takes place in grade seven. All students can elect to take band with supportive small group lessons and/or chorus. The elective options have been bolstered for students in grades 7 and 8 to include: Making Money Moves; The Magic of Movies, and Digital Game Design. Recognizing the importance of the social and emotional growth of students, the middle school program incorporates a student-centered advisory program, entitled S.T.A.R. (Students Taking Academic Responsibility), for students in grades six through eight. Students participate in interactive modules that afford them the opportunity to forge stronger relationships with teachers, develop stronger interpersonal skills, and expand their understanding of specific topics of interest to middle school students. Additionally, the S.T.A.R. program is designed to enhance students' citizenship, while bolstering a positive school climate through a variety of character education experiences.
