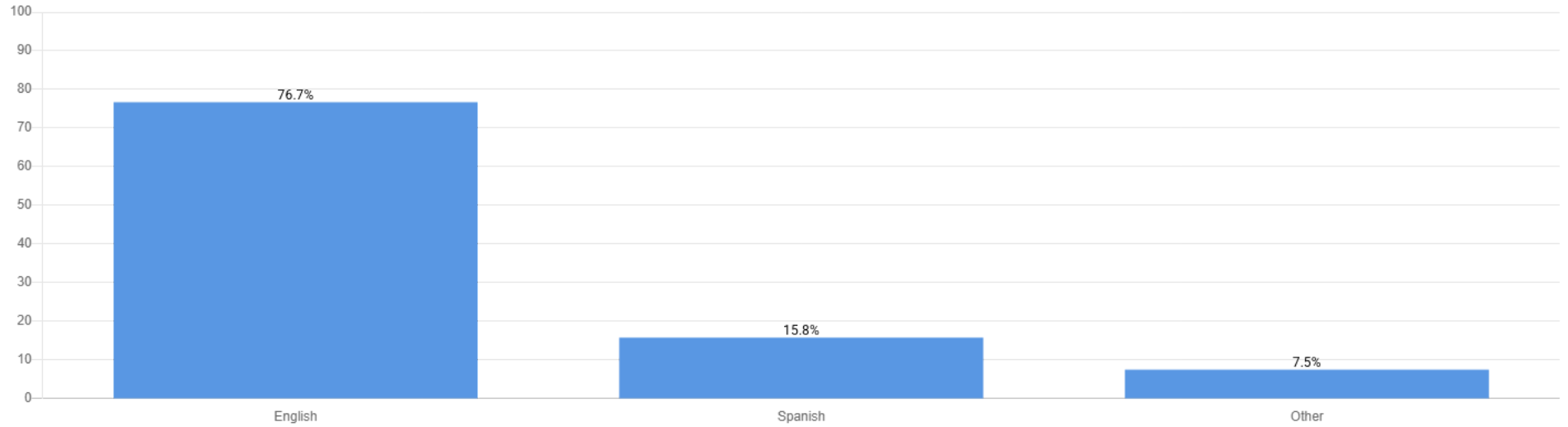

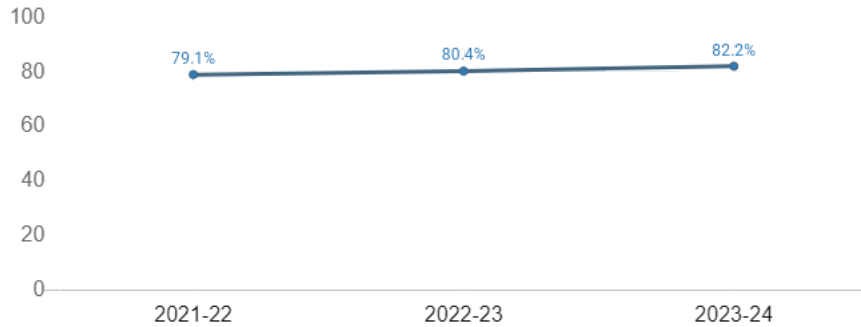

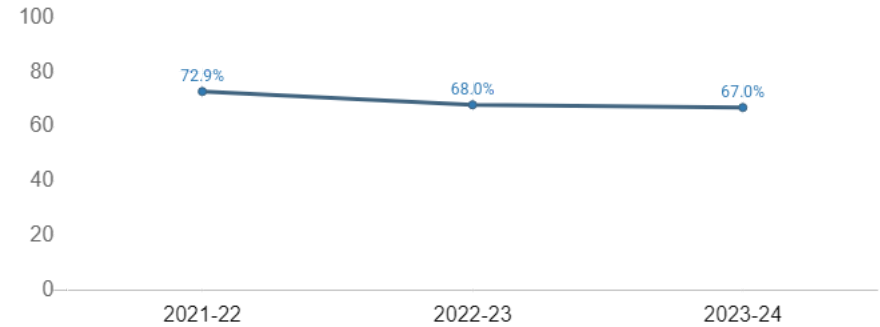
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 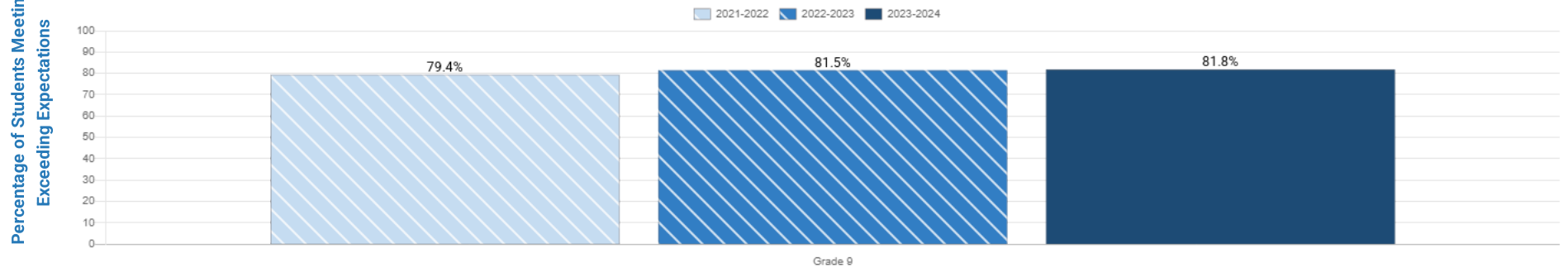

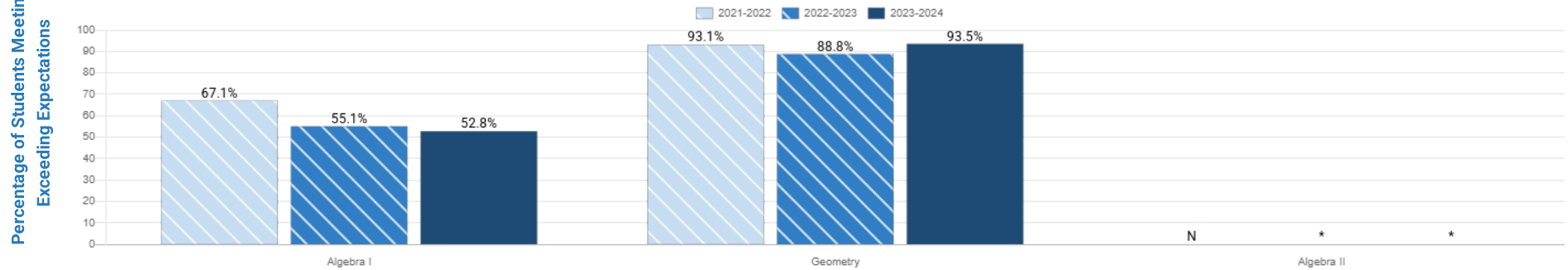

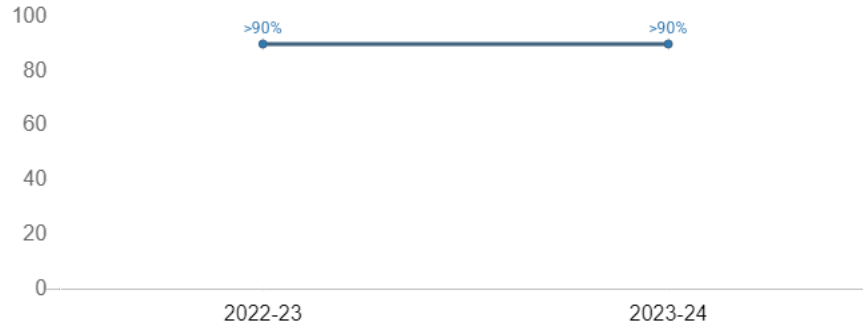

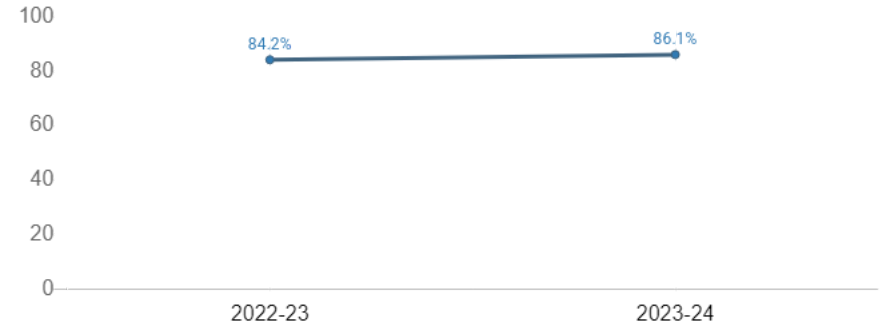

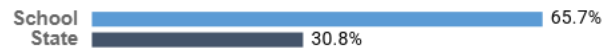

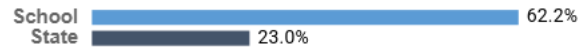
Students enrolled in one or more AP or IB course

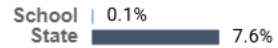

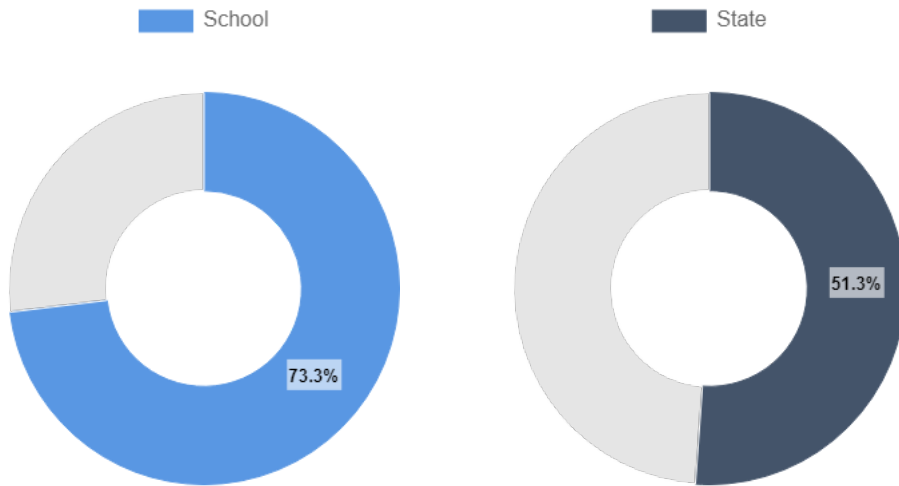

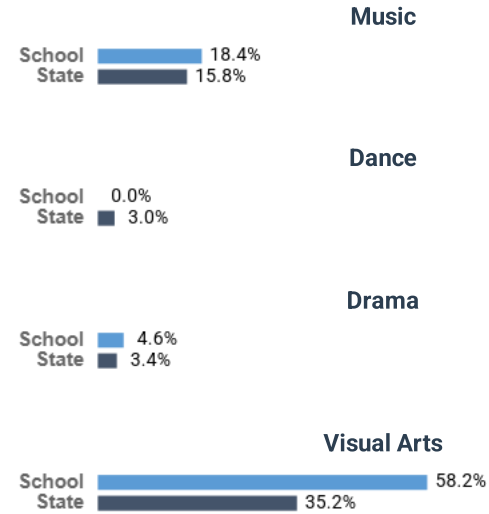

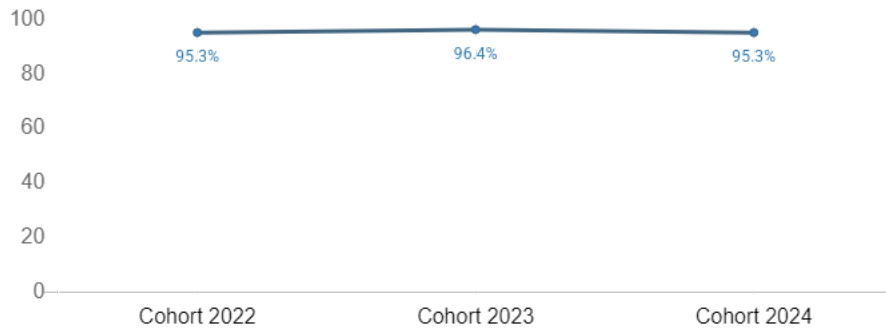

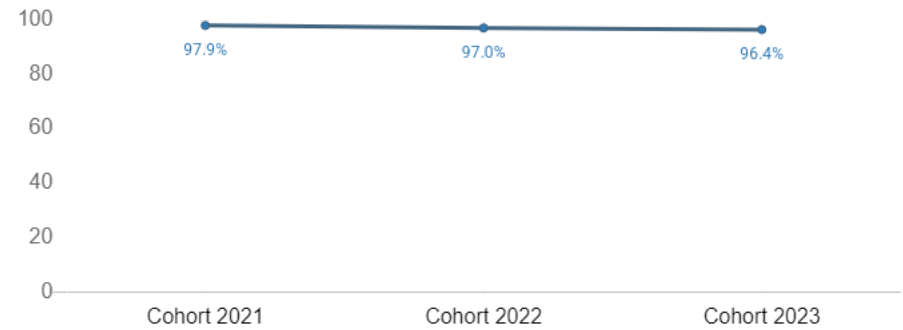

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

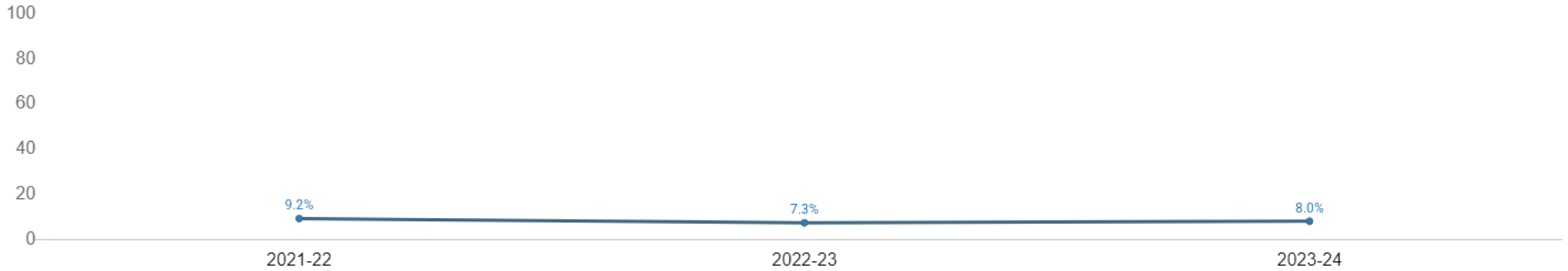

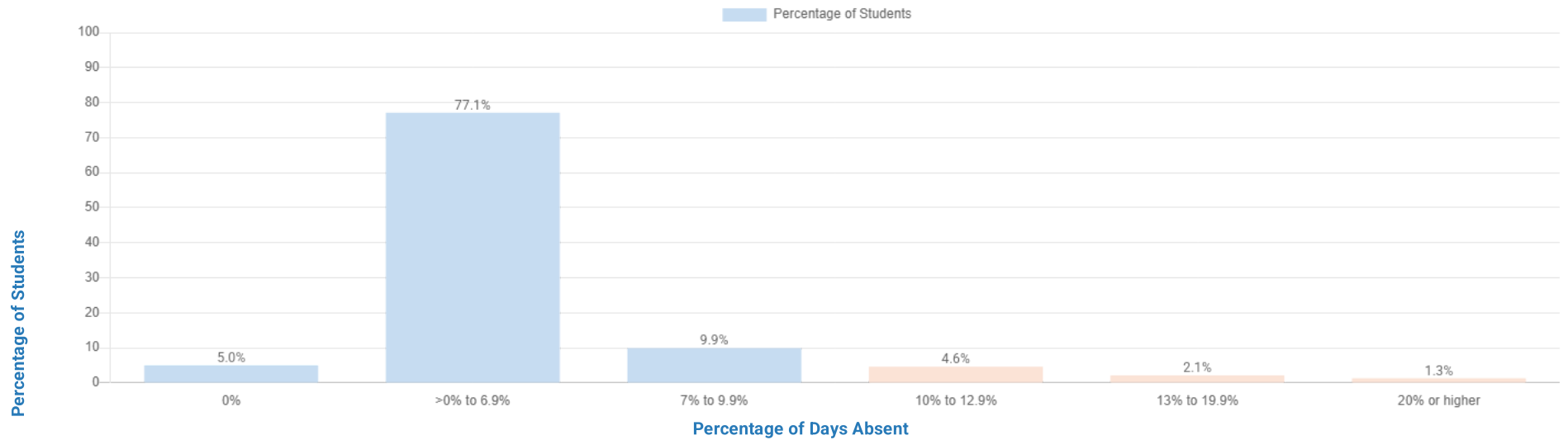

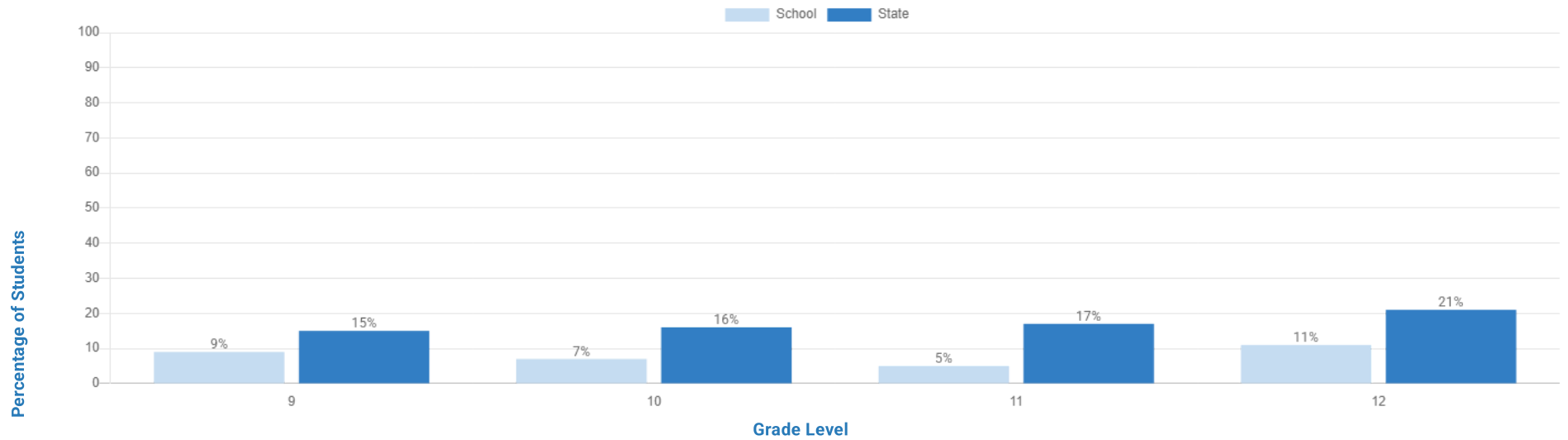

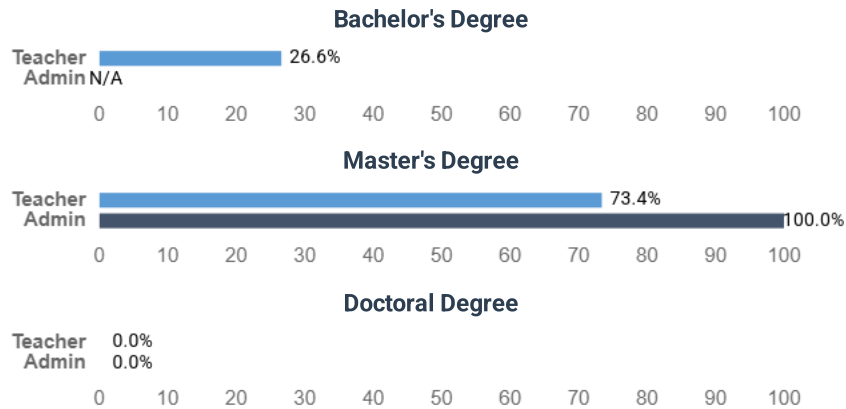

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

- Summit High School educating students in grades 9 - 12 has an enrollment of approximately 1,200 students.
- Summit High School prepares students for their postsecondary experiences. In the Class of 2024, 94.1% of the students pursued higher education directly after graduating from Summit High School.



Mission, Vision, Theme:

Summit High School, in partnership with the Summit Board of Education and the Summit community, believes that education in a democracy should provide the opportunity and the stimulus for maximum personal growth and self-fulfillment, and it should ensure that all students are prepared for responsible citizenship, further learning, and productive employment in a rapidly changing society and world. To this end, Summit High School will provide learning that engages all students in compelling work; educates them to their highest intellectual, creative, and individual potential; promotes pride in diversity; and results in responsible and productive citizens.



Awards, Recognition, Accomplishments:

Summit High School is among the top high schools in the country, ranking high among other high schools across the state in many rankings. Summit High School was ranked as #29 in New Jersey in the U.S. News and World Report high school rankings (2024), recognized as one of the 500 top STEM high schools in the country according to Newsweek, and 22nd in New Jersey (Niche, 2024). Summit High School was also recognized as the #1 public high school in Union County (Niche, 2024). The Summit High School Class of 2024 has 25 National Merit Scholar Commended students, 16 students receiving honors from a National Recognition Program, 3 National Merit Scholar semi-finalists, and 3 Finalists. Summit High School earned a Silver Award on the AP School Honor Roll. In 2021 and 2022, Summit High School earned College Board's AP Computer Science Female Diversity Award for expanding young women's access to AP Computer Science A.

Courses, Curriculum, Instruction:

Courses are offered in both college preparatory and non-college preparatory subjects. Enrollment in Advanced Placement and Honors courses is by application and faculty recommendation. SHS offers 27 AP courses and 19 Honors courses. Besides meeting prerequisites, there is no limit to the number of AP classes a student can take per year. Six-year World Language programs (beginning in 6th grade) are offered in Latin, Spanish, French, and Mandarin. Vocational programs are available through the Union County Vocational Technical School shared-time program. Students are required to carry seven subjects each semester and may elect an eighth course or a study period.



Sports and Athletics:

Sports Offered: Baseball (Coed), Basketball (Boys & Girls), Cheerleading (Coed), Cross Country (Boys & Girls), Field Hockey (Girls), Football (Coed), Golf (Coed), Gymnastics (Girls), Ice Hockey (Boys & Girls), Lacrosse (Boys & Girls), Soccer (Boys & Girls), Softball (Girls), Swimming (Boys & Girls), Tennis (Boys & Girls), Track and Field - Spring (Boys & Girls), Track and Field - Winter (Boys & Girls), Volleyball (Boys & Girls), Wrestling (Coed)

Summit High School offers 33 sports at 75 levels (freshman, JV, and Varsity) in which students can participate. New for the Spring of 2024, SHS offered Girls Flag Football. Approximately 75% of all Summit High School students are student-athletes with nearly 54% of them participating in more than one sport. In the last six year, there have been 14 State Champions, 22 Sectional Champions, 15 County Champions, and 22 League Champions in 19 sports. During that same timeframe we have 154 student-athletes from 24 sports commit to continuing their education and athletic participation in college. Summit High School, in conjunction with Special Olympics of New Jersey, also offers a unified sports program in soccer and basketball.



Clubs and Activities:

Summit High School offers a large of variety of over 75 extracurricular activities. These include opportunities for students to participate in clubs and activities related to student government, academic achievement and support, visual and performing arts, journalism and writing, service/community outreach, culture, wellness and leadership, debate and current events, and leisure and recreation. Summit High School has an award-winning theater program, musical performing groups, and Speech and Debate team.

Staff and Professional Learning:

Summit High School has over 150 full-time faculty members; more than 75% of whom have graduate degrees. The faculty is widely traveled and participates in professional development within and outside the district as a commitment to life-long learning. The teaching staff has the opportunity to work collaboratively with their colleagues to develop lessons and learning opportunities for their students. Staff members also meet to focus on using data to improve their instructional practices and to meet the needs of their students. In addition, all Summit High School staff members have been trained in Restorative Practices to improve the relationships between students and staff, and among the students for their use during the Advisory program.



Postsecondary Information:

The percentage of students from the Summit High School Class of 2024 continuing their education is 94.1%, with 87.8% attending four-year colleges/universities and 6.3% attending two-year colleges. The remaining SHS graduates are either attending Vocational/Technical schools (2.8%) or are pursuing other avenues such as the military, employment, or gap year experiences (3.2%). The SHS Counseling Department has developed grade-level programming to help students and parents plan for post-secondary experiences.



Parent and Community Involvement:

The Summit High School community is very supportive of the school and all of its activities. The Counseling Department hosts several evening events for students and parents to help students develop plans for their post-high school experiences. In addition, the school and district provide parents and guardians with workshops and wellness programs to help them address the social-emotional needs of their children. The Summit High School PTO offers staff the opportunity to apply for mini-grants to supplement innovative programming for students.

Facilities:

The school building opened in 1963. Since that opening there have been two major renovations which have added square footage to the space - one which was completed in 2001 and one that is currently ongoing and set to be completed in the Spring of 2025. Smaller renovation projects have been completed during the past twenty years including the addition of a TV studio, renovation of the culinary arts classroom, new gym bleachers, and updates to the auditorium. The building is meticulously maintained by the custodial and maintenance staff who have completed repairs, updates, and smaller renovations projects.



School Safety:

Summit High School has two full-time security guards, and a security person on duty each evening. We have protocols in place to ensure that all visitors to the building are checked in at the main office and escorted by a staff member when they are in the building.



Technology and STEM:

Summit High School offers a wide variety of Technology/STEM courses including but not limited to Computer Programming using Java, AP computer science classes, Architecture and CAD, Electronics and Introduction to STEM, Materials & Processes, Television Production, and Theatre Design & Technology. Students are issued a Chromebook during their freshman year and can use it throughout their time at Summit High School as teachers have integrated the use of technology into all classes. The Summit Public Schools has embarked on a large referendum project which includes a 2nd floor addition and remodel of the existing library that will include dedicated spaces for STEAM courses and programming.
